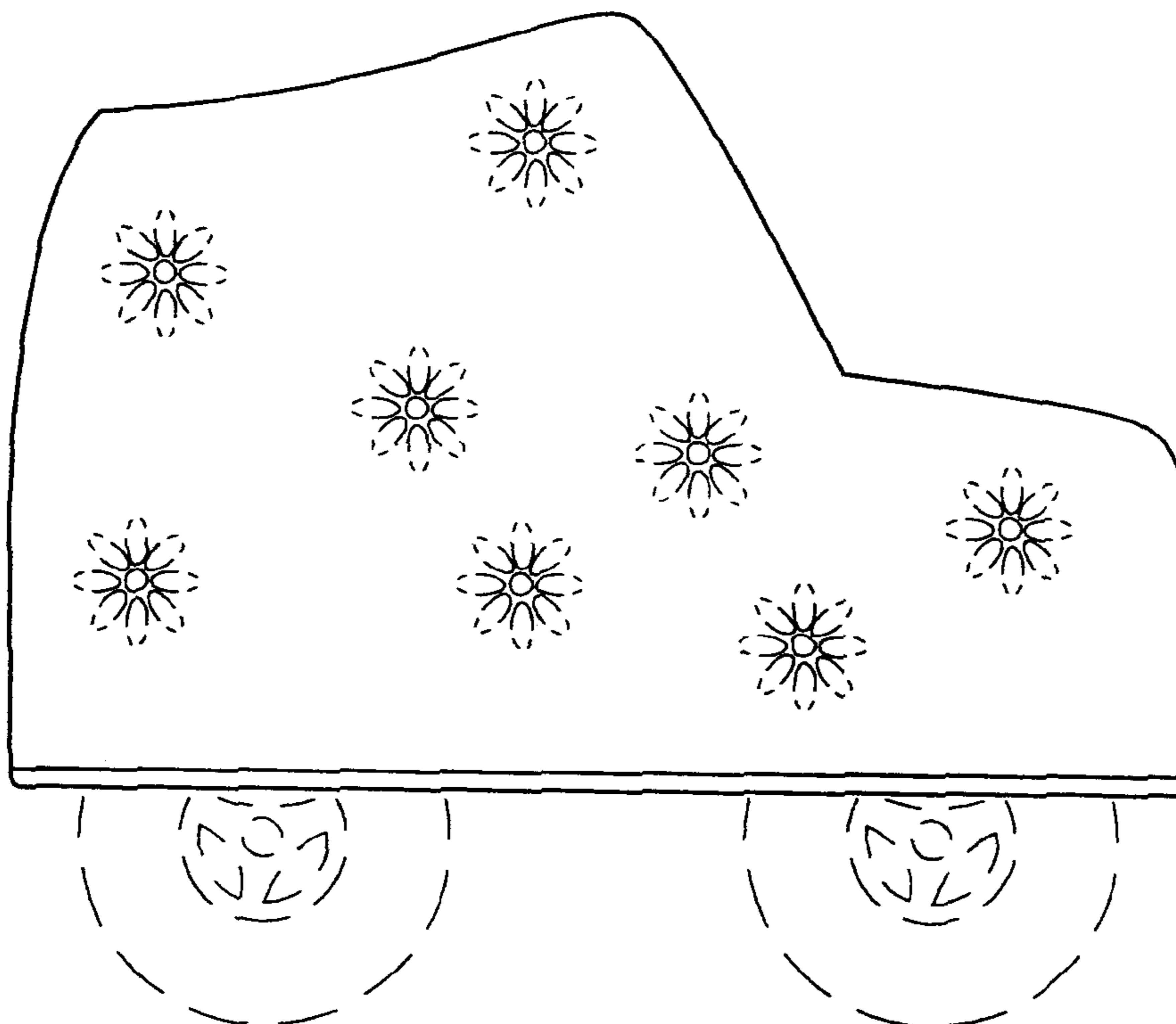
(57) **CLAIM**

The ornamental design for a weather-protective cover for children's toys, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view of a weather-protective cover for children's toys showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The broken lines are for illustrative purposes only and form no part of the claimed design.

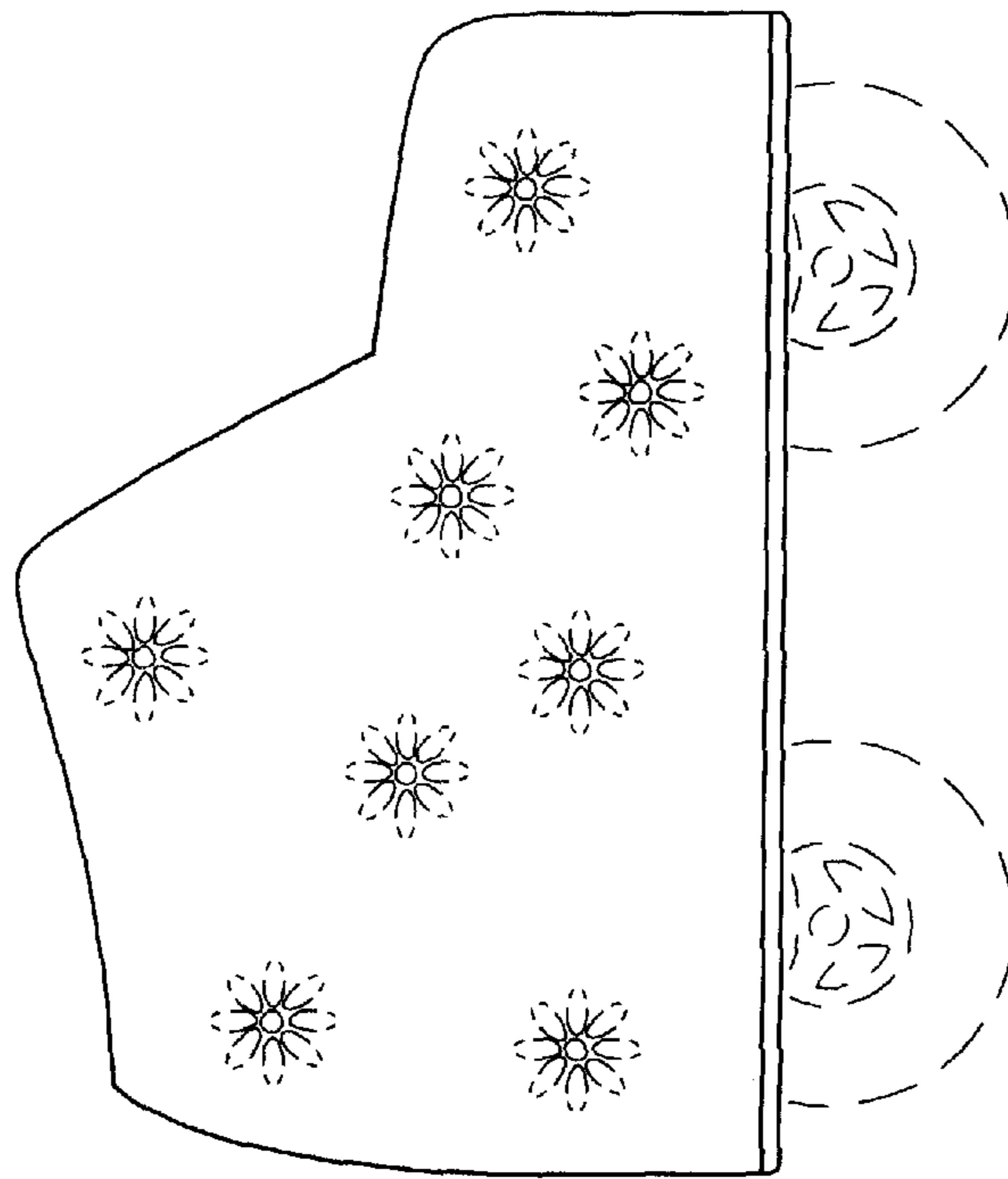

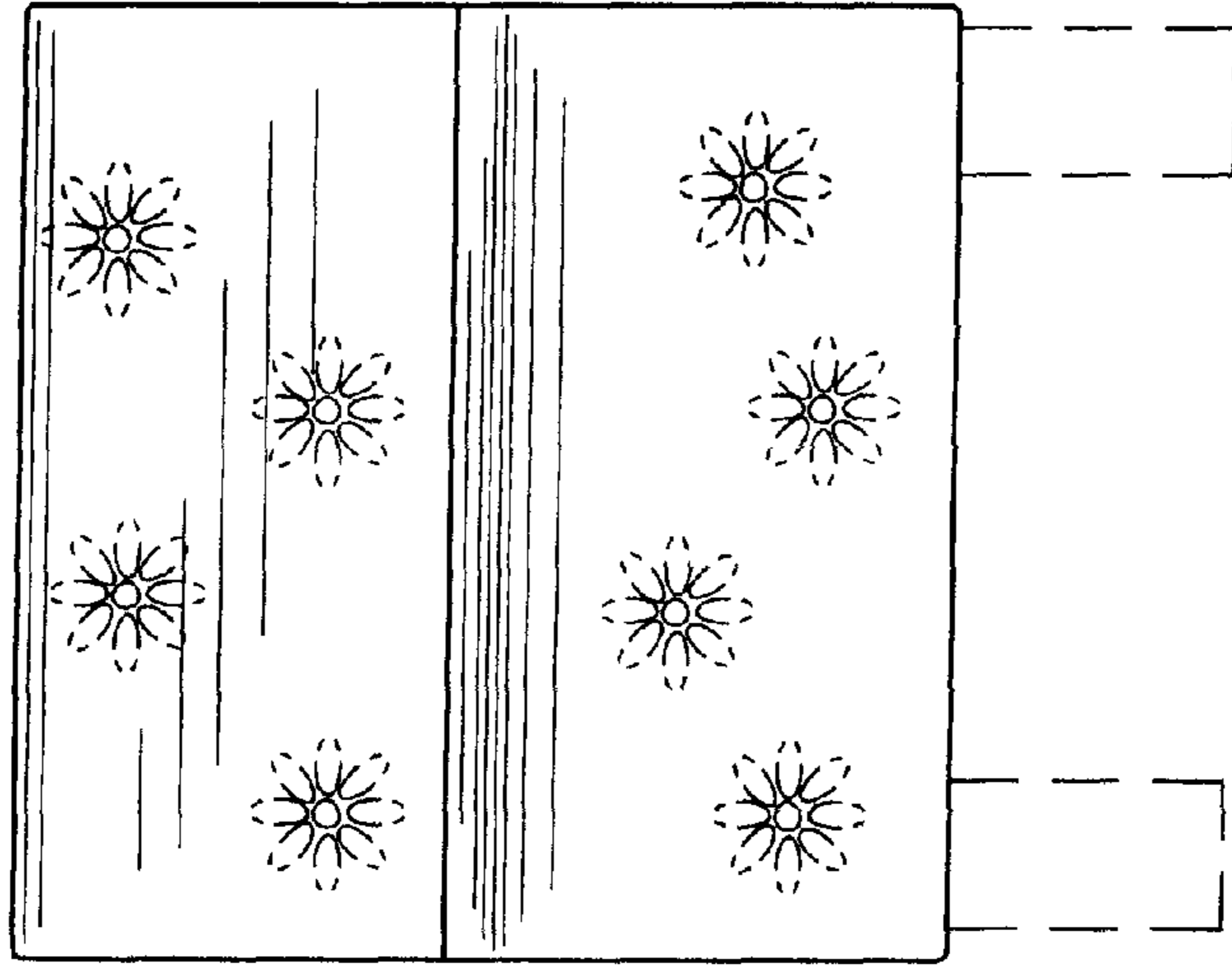

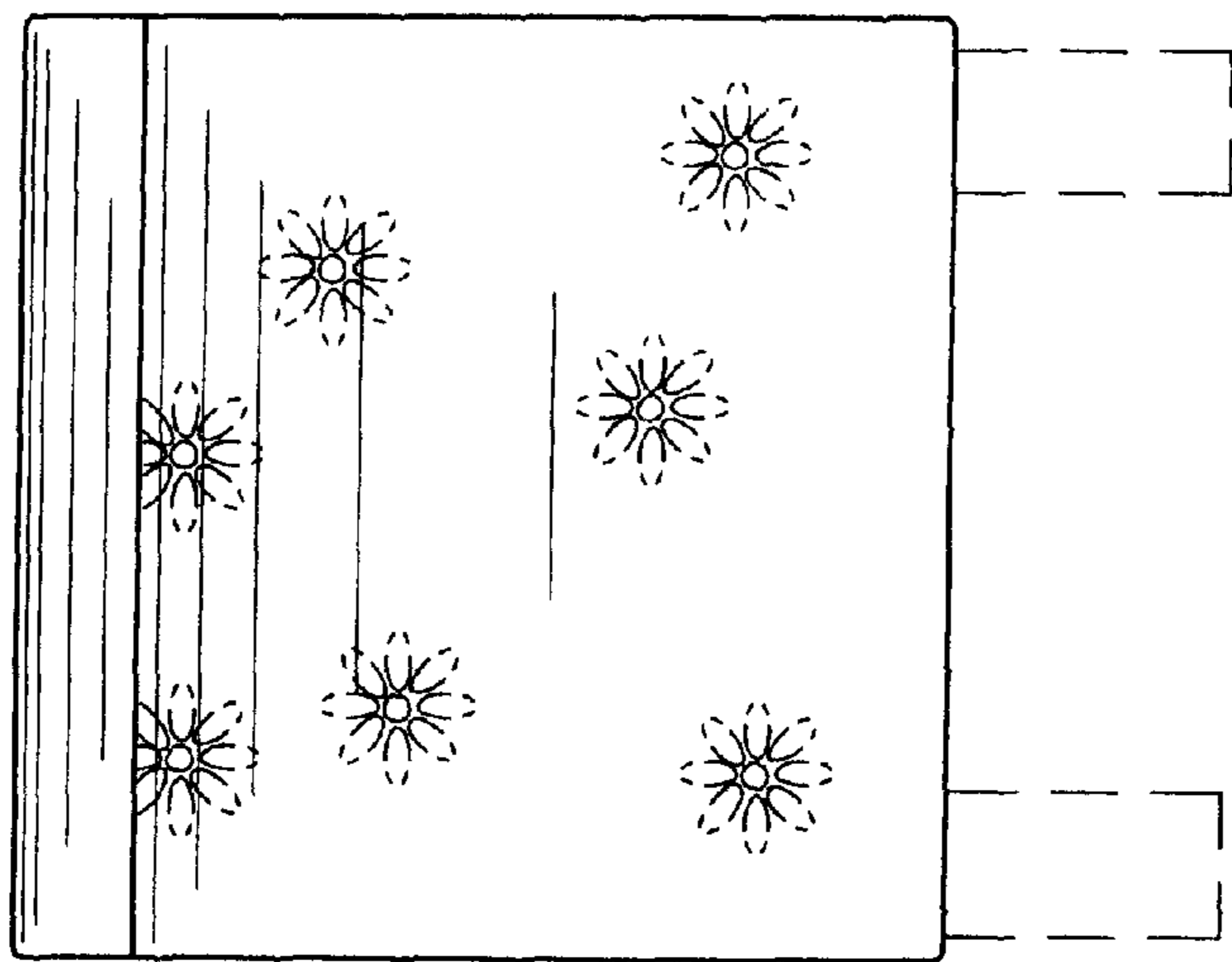

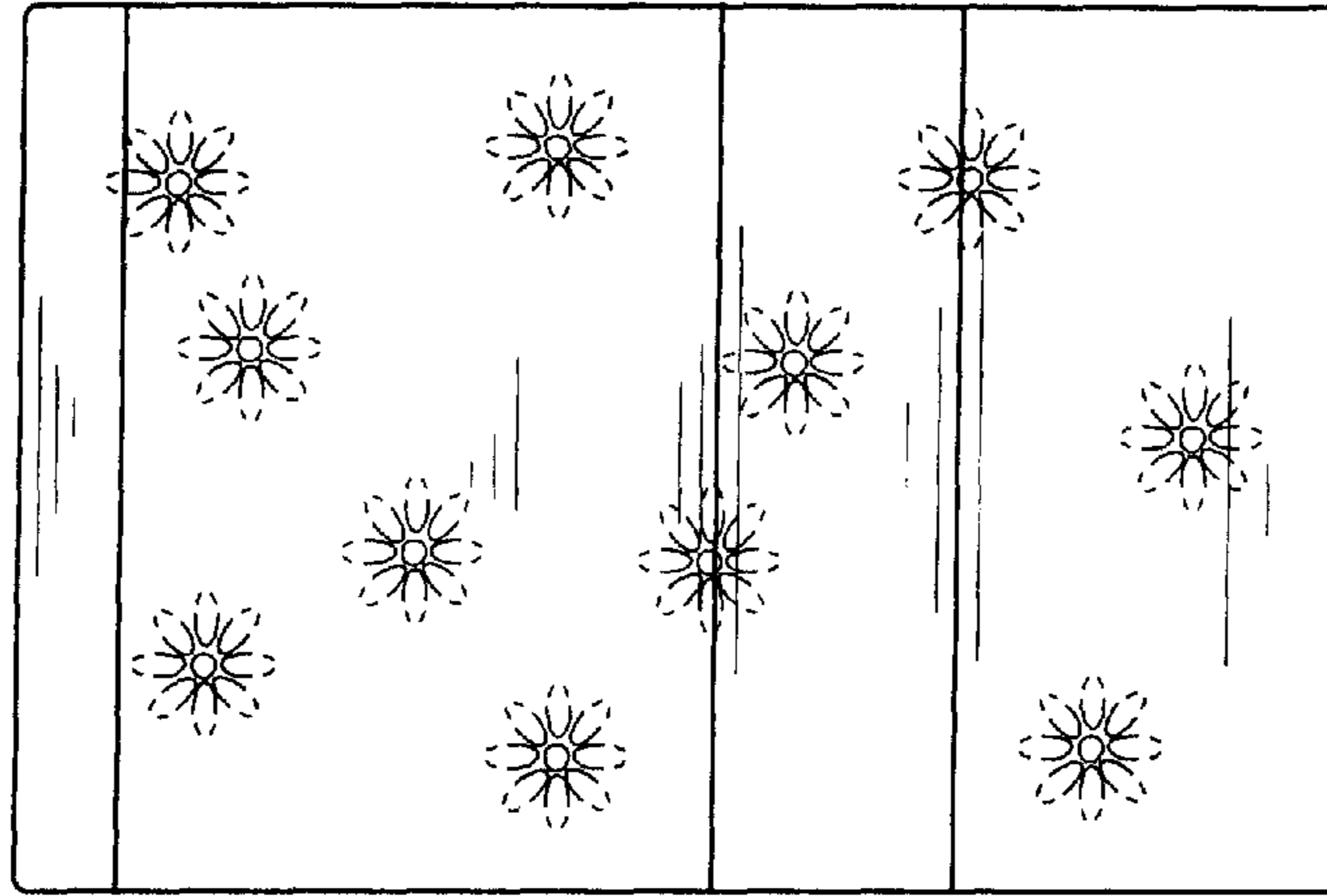

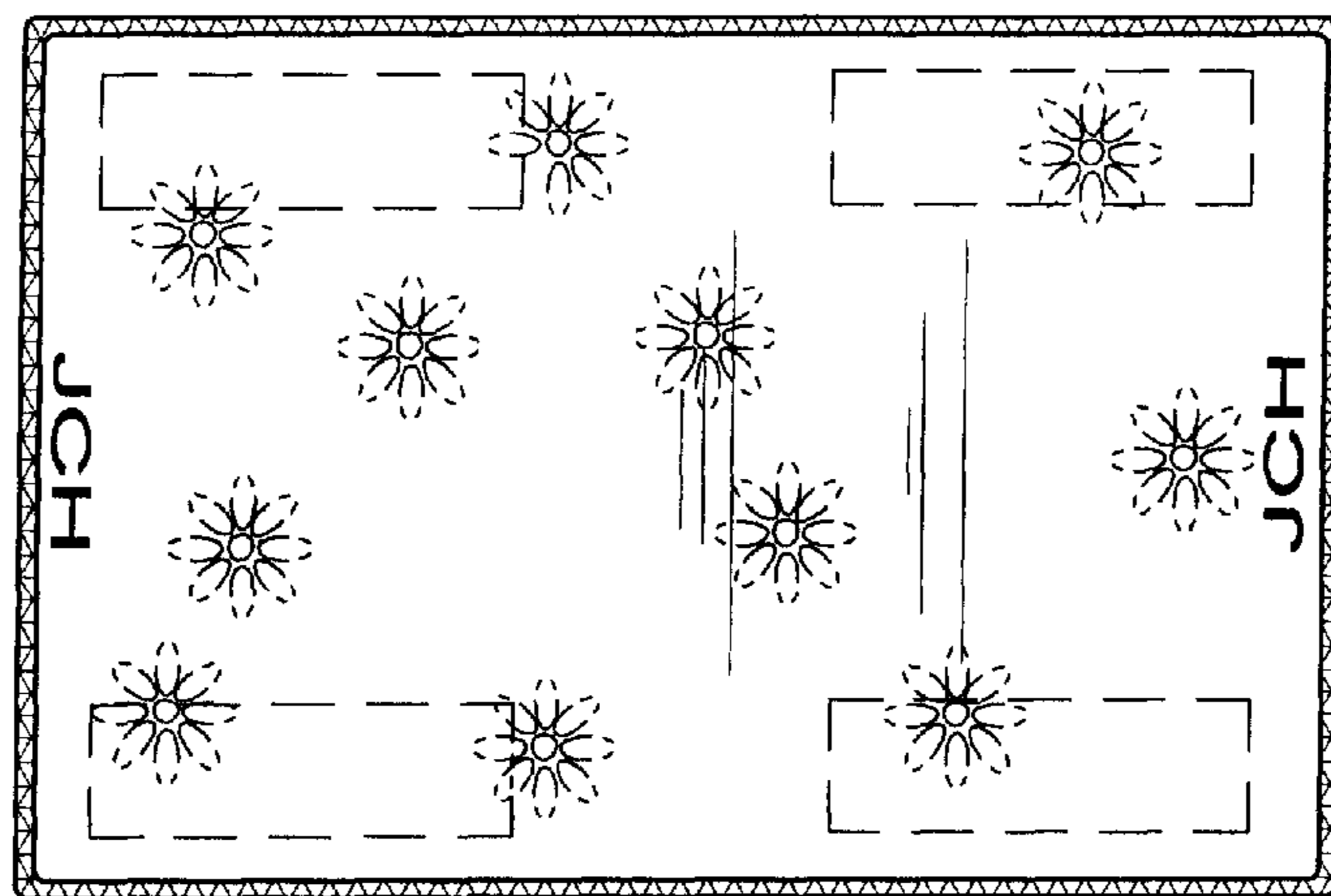
