The ornamental design for golf ball marking guide, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of golf ball marking guide according to our new design;
FIG. 2 is a right side elevation view thereof, the left side elevation view being a mirror image thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

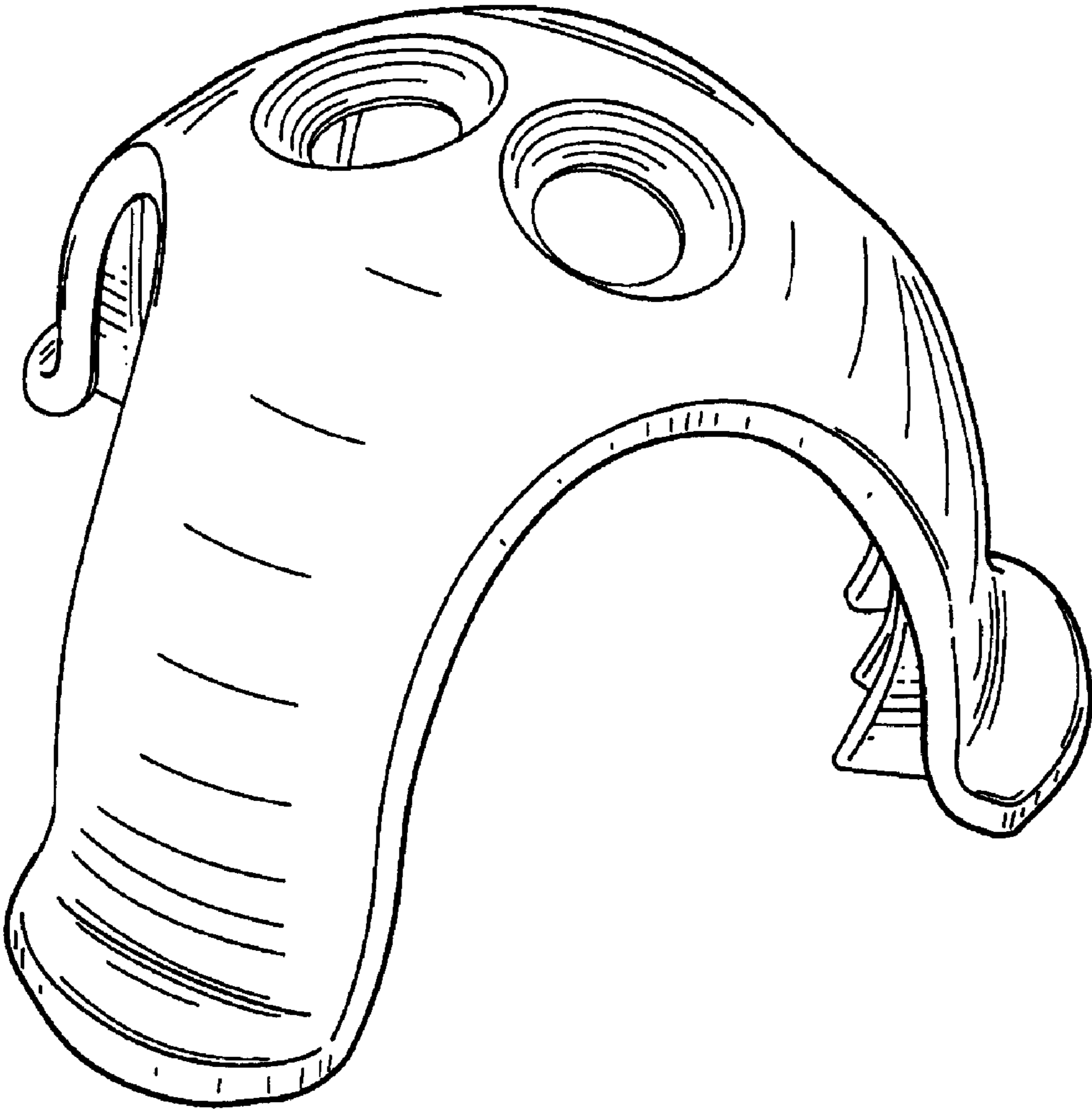

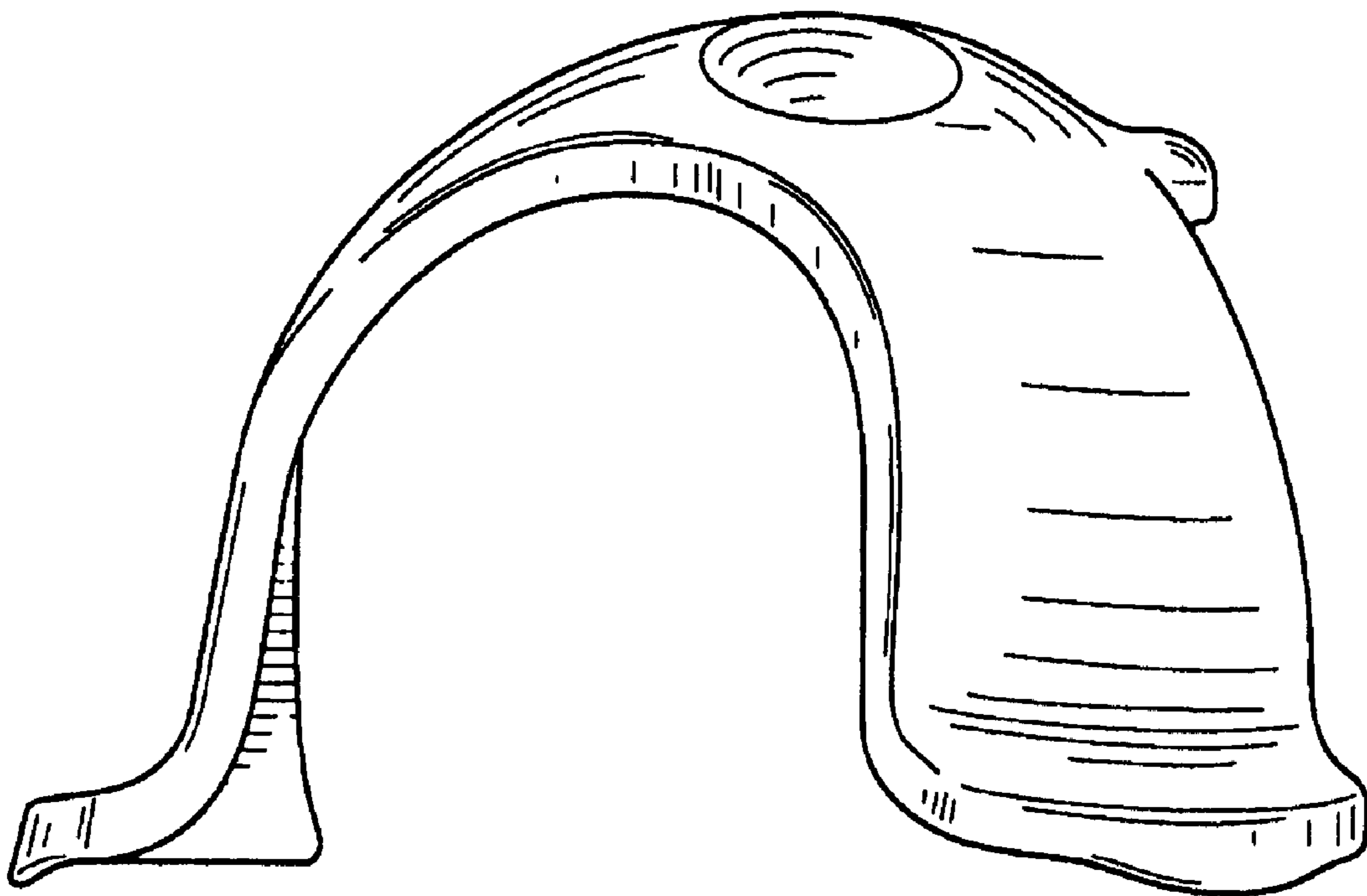

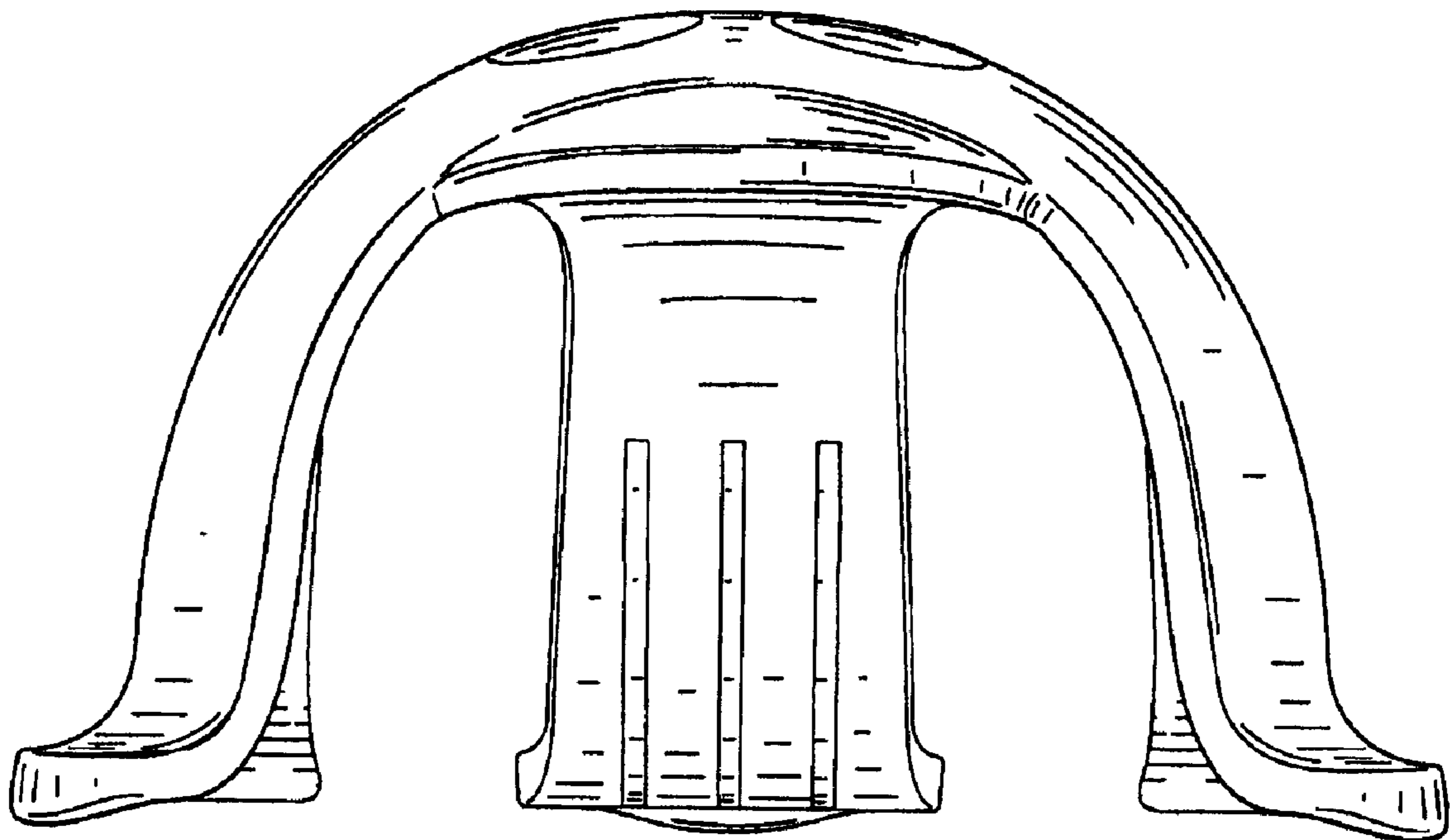

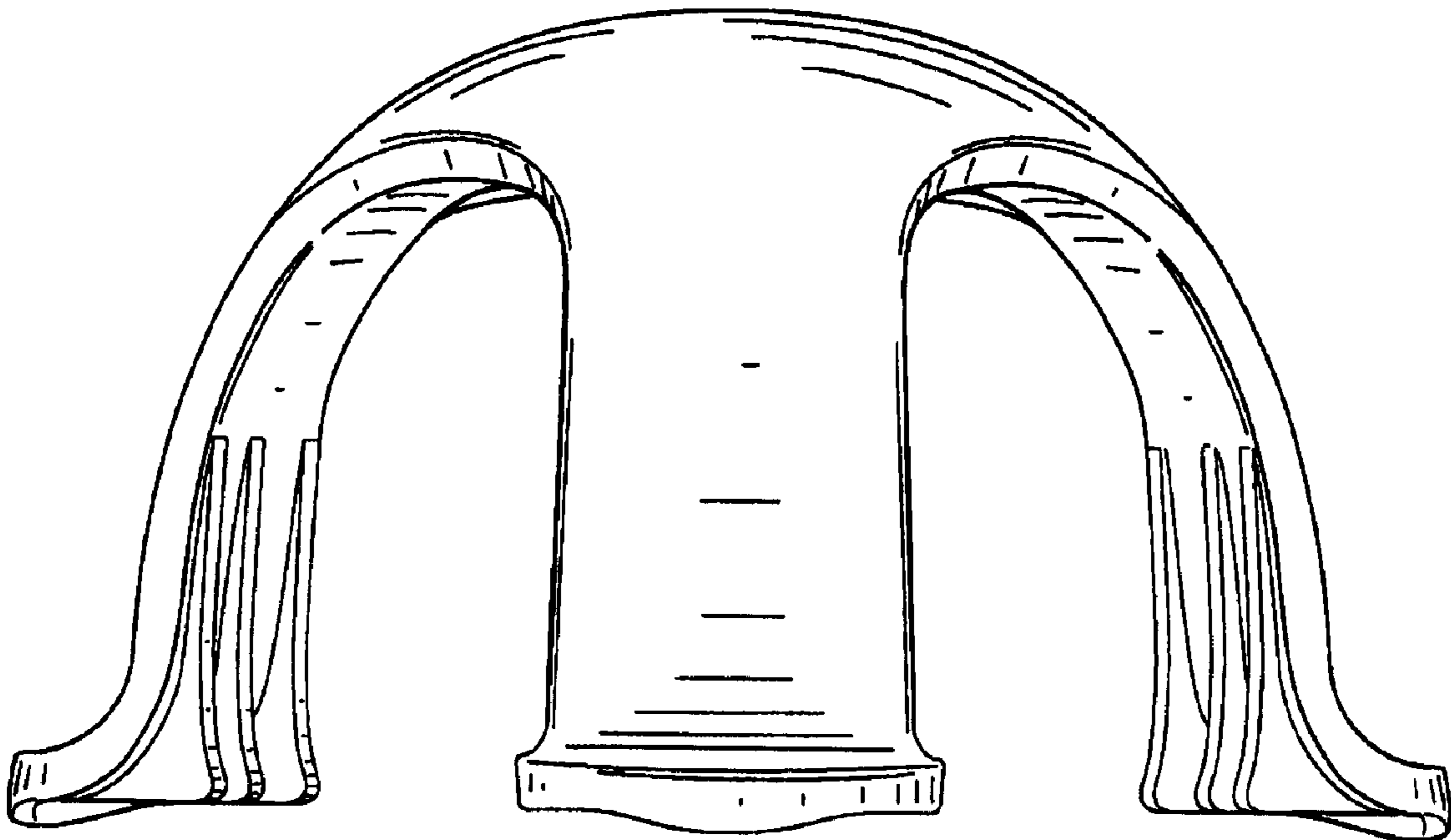

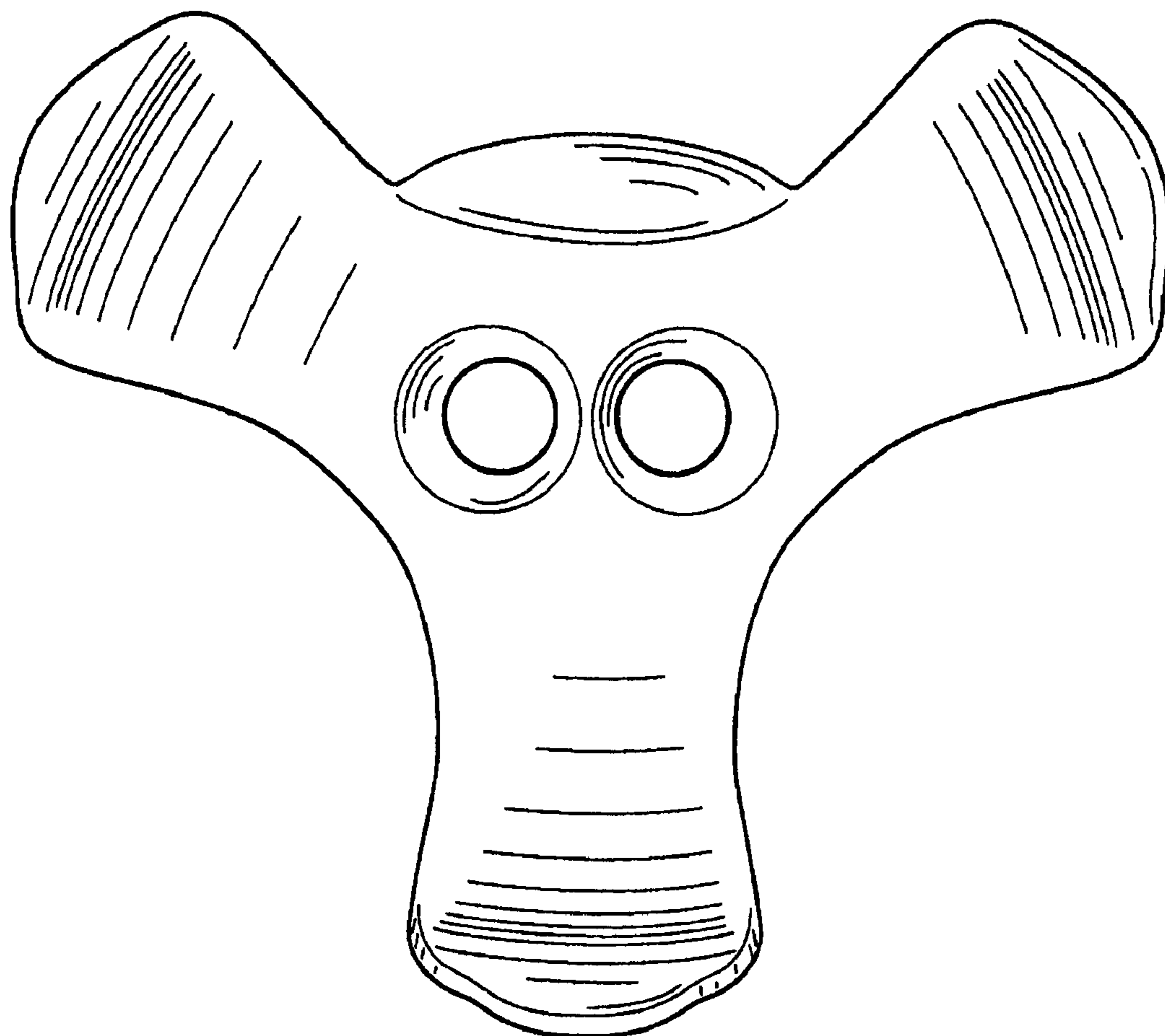

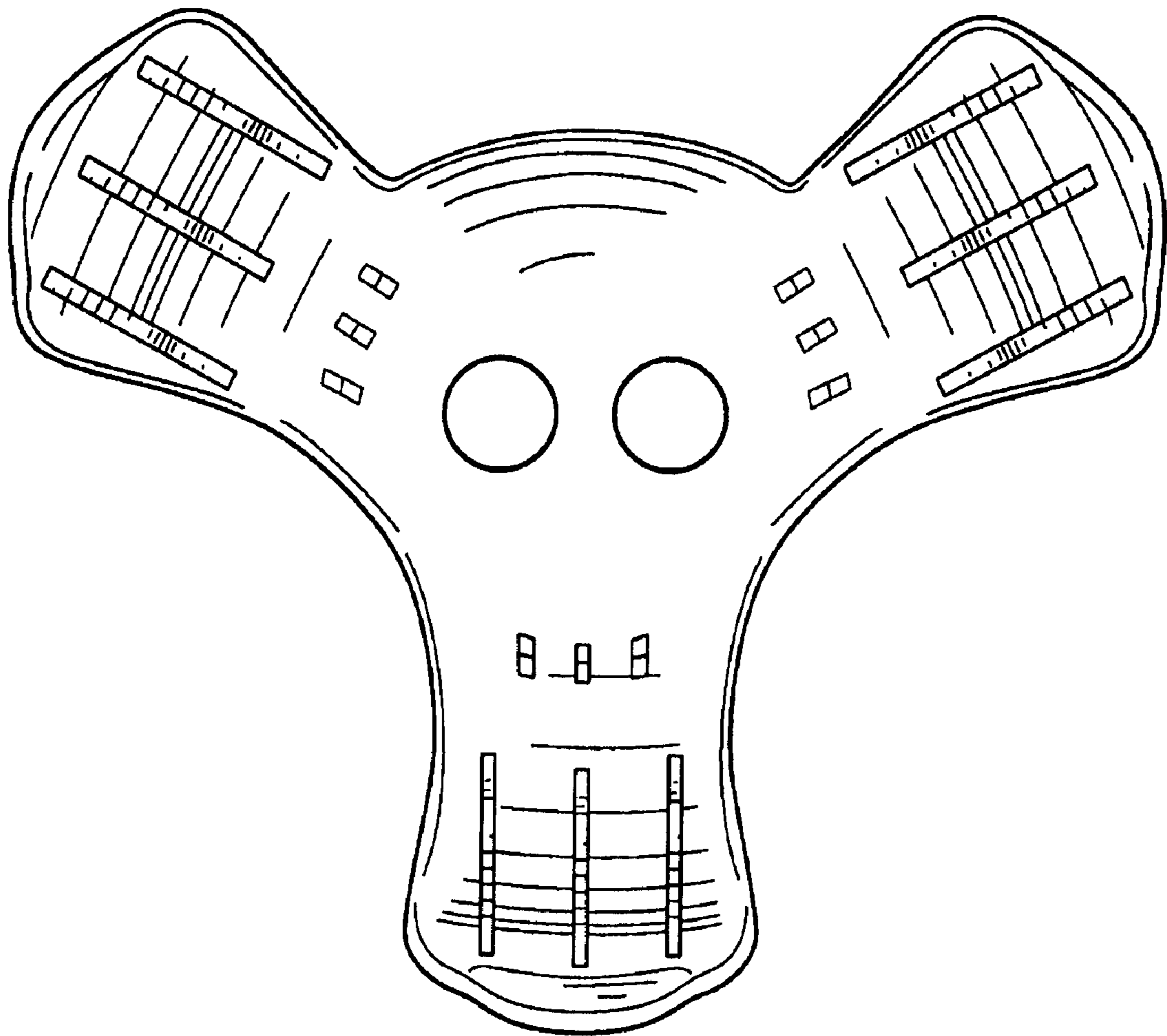
