(57) **CLAIM**

The ornamental appearance of a mask, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of a mask according to our design, with a patient shown in phantom and indicating the optimum positioning of the mask assembly on the patient; FIG. 2 is another perspective view of the mask shown in FIG. 1 in use on a patient;

FIG. 3 is a front view of the mask shown in FIG. 1, with the phantom air delivery tube and the phantom tube retainer shown removed for ease of illustration, and in a condition in which the positions of the swivel elbow and plug have been interchanged;

FIG. 4 is a rear view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

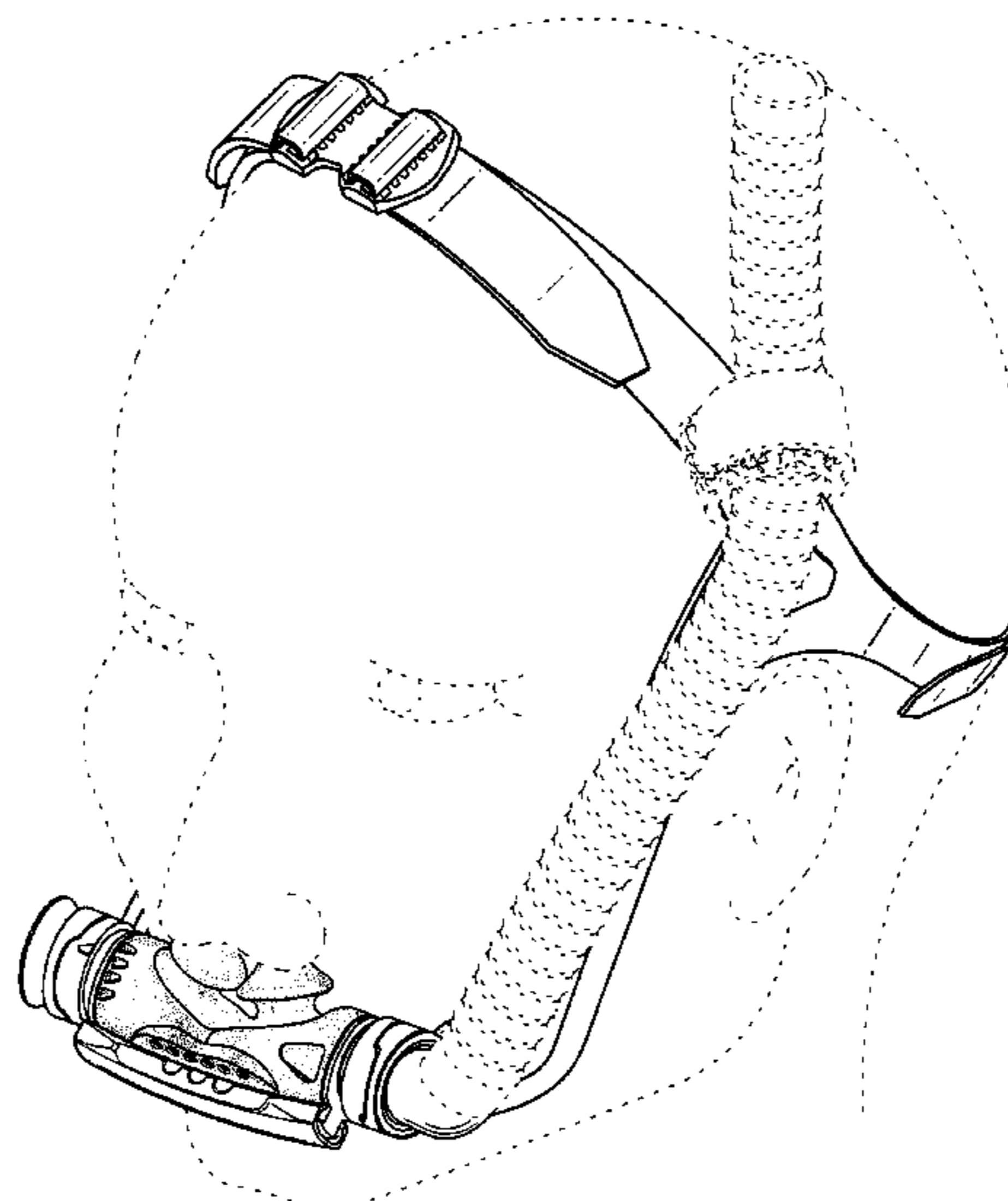
FIG. 7 is a top view thereof; and,

FIG. 8 is a bottom view thereof.

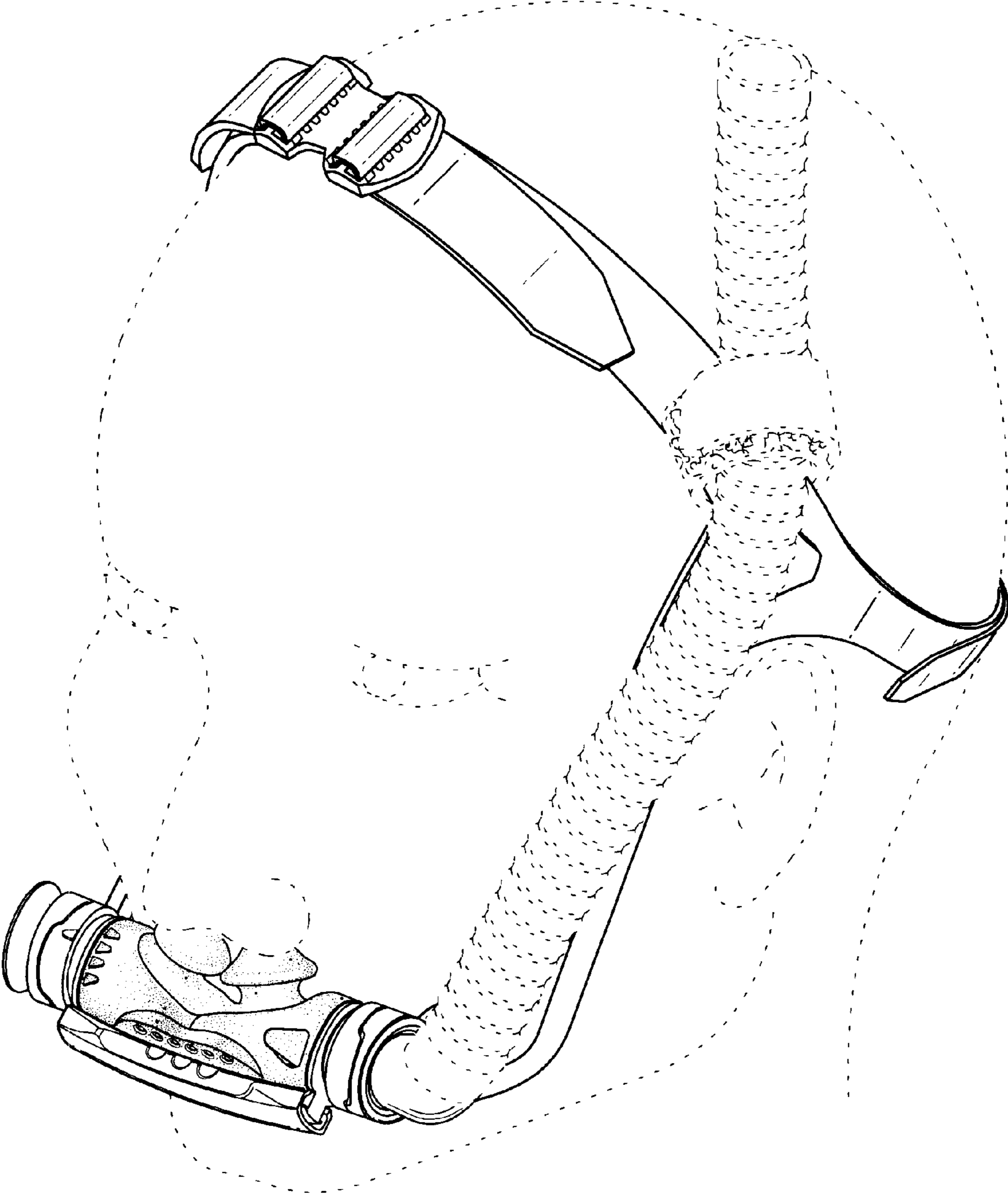

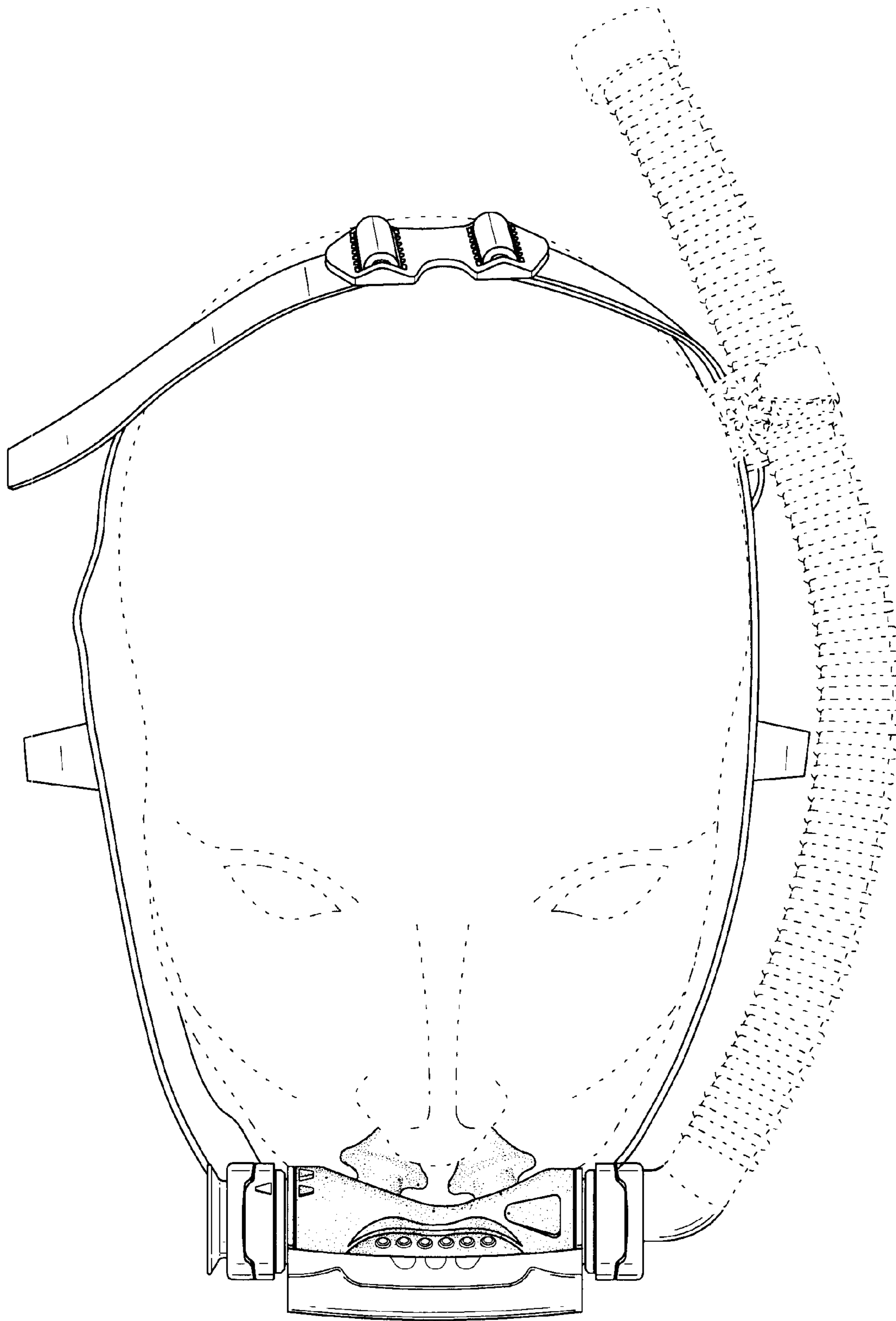

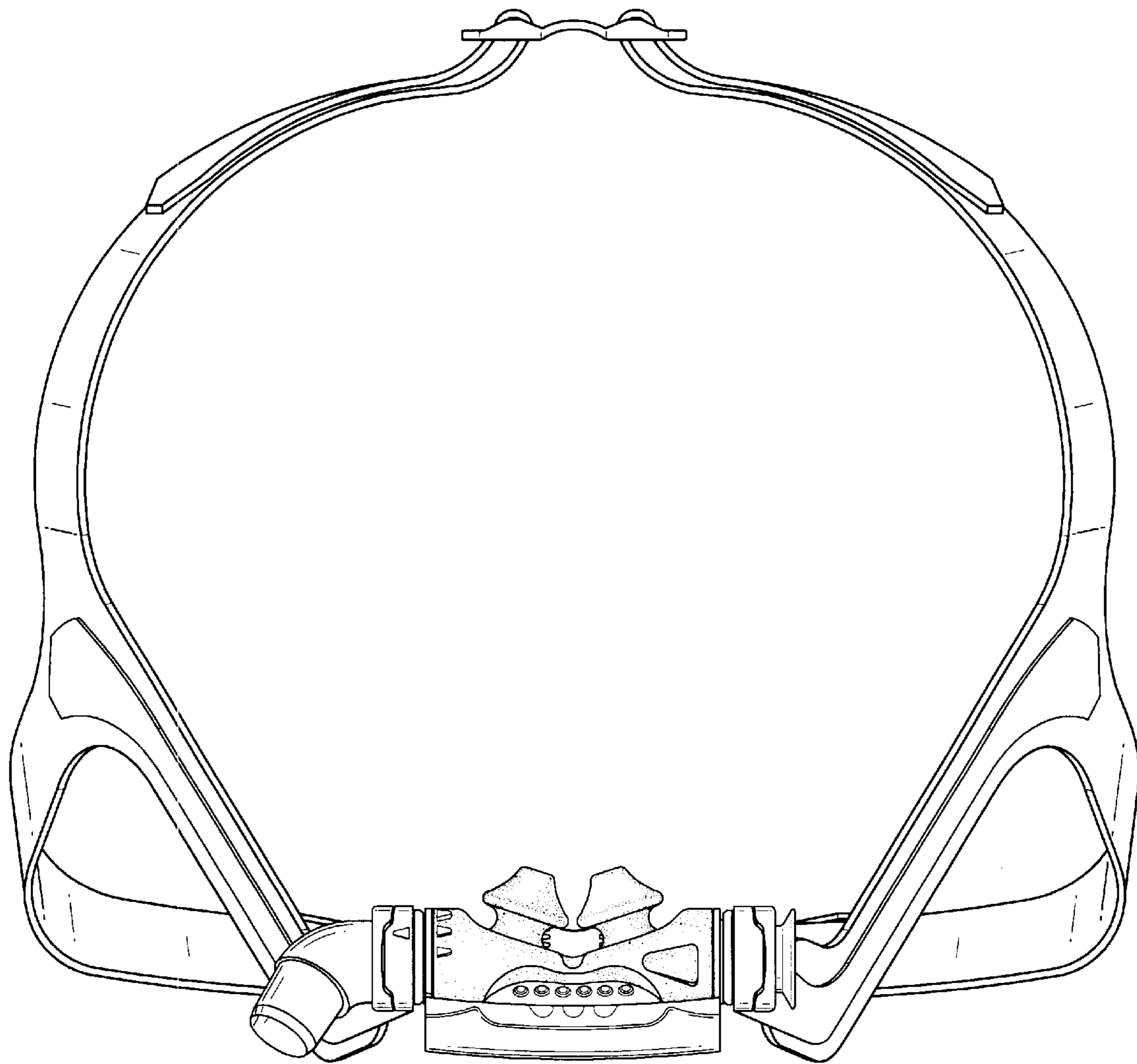

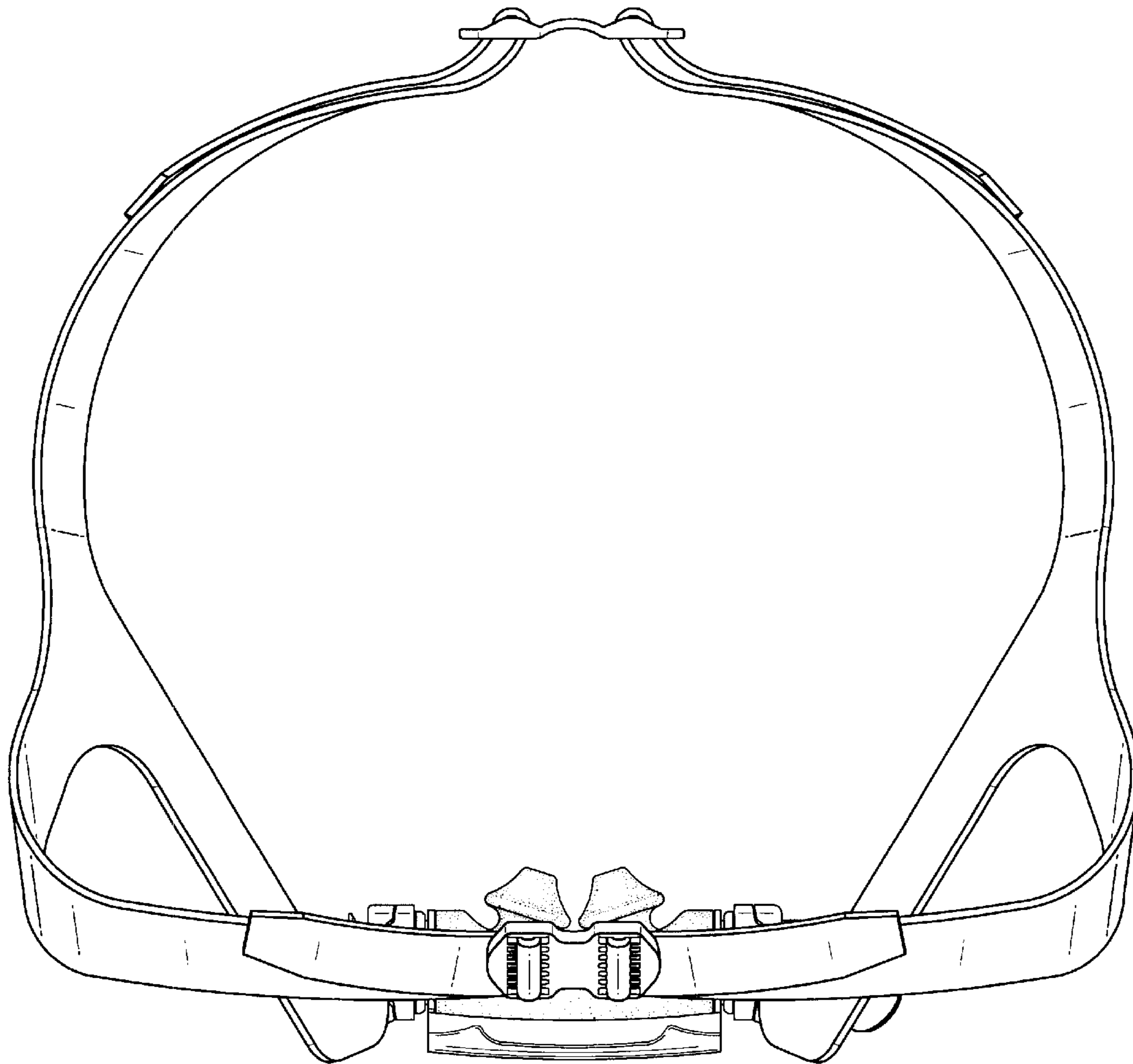

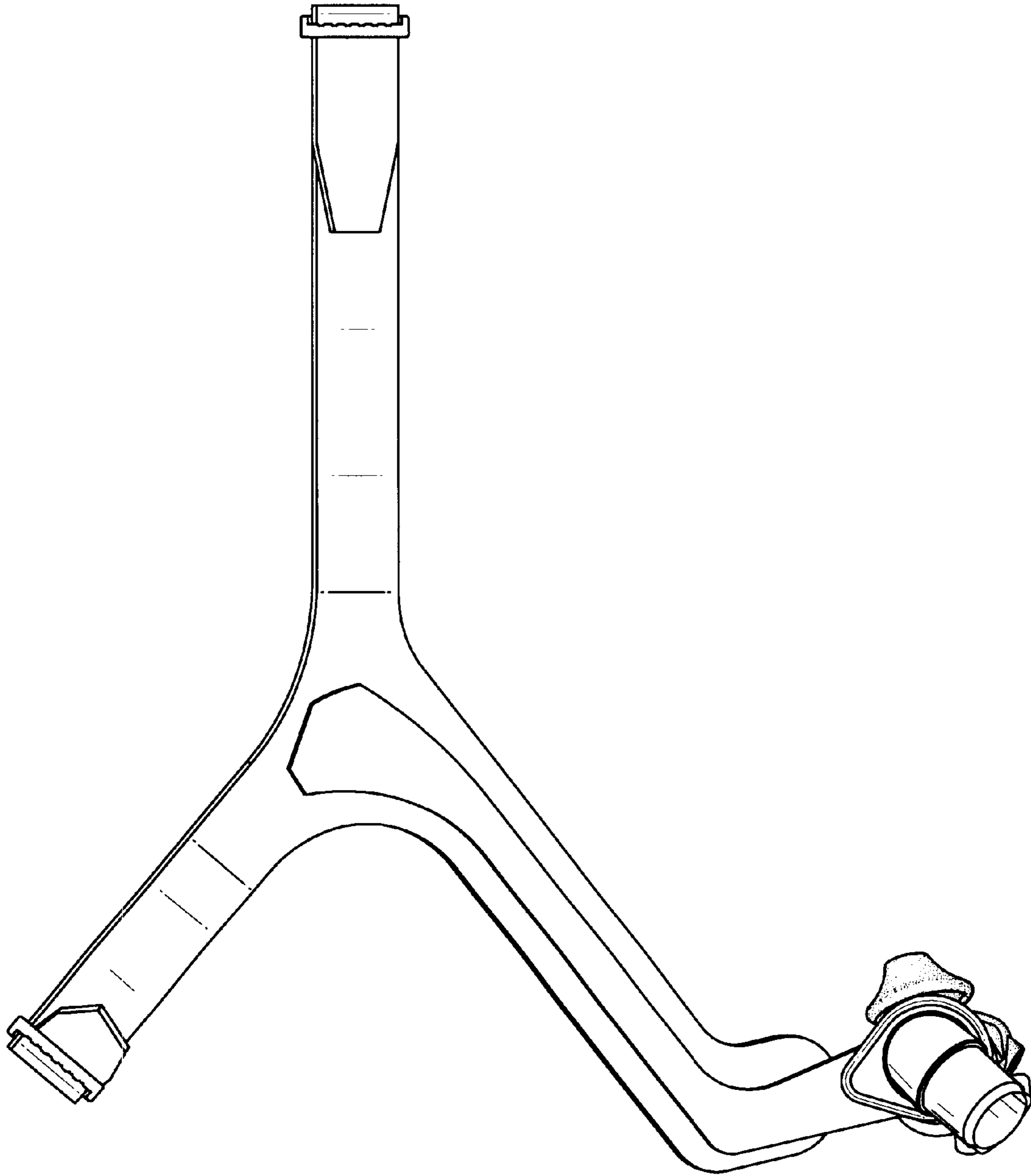

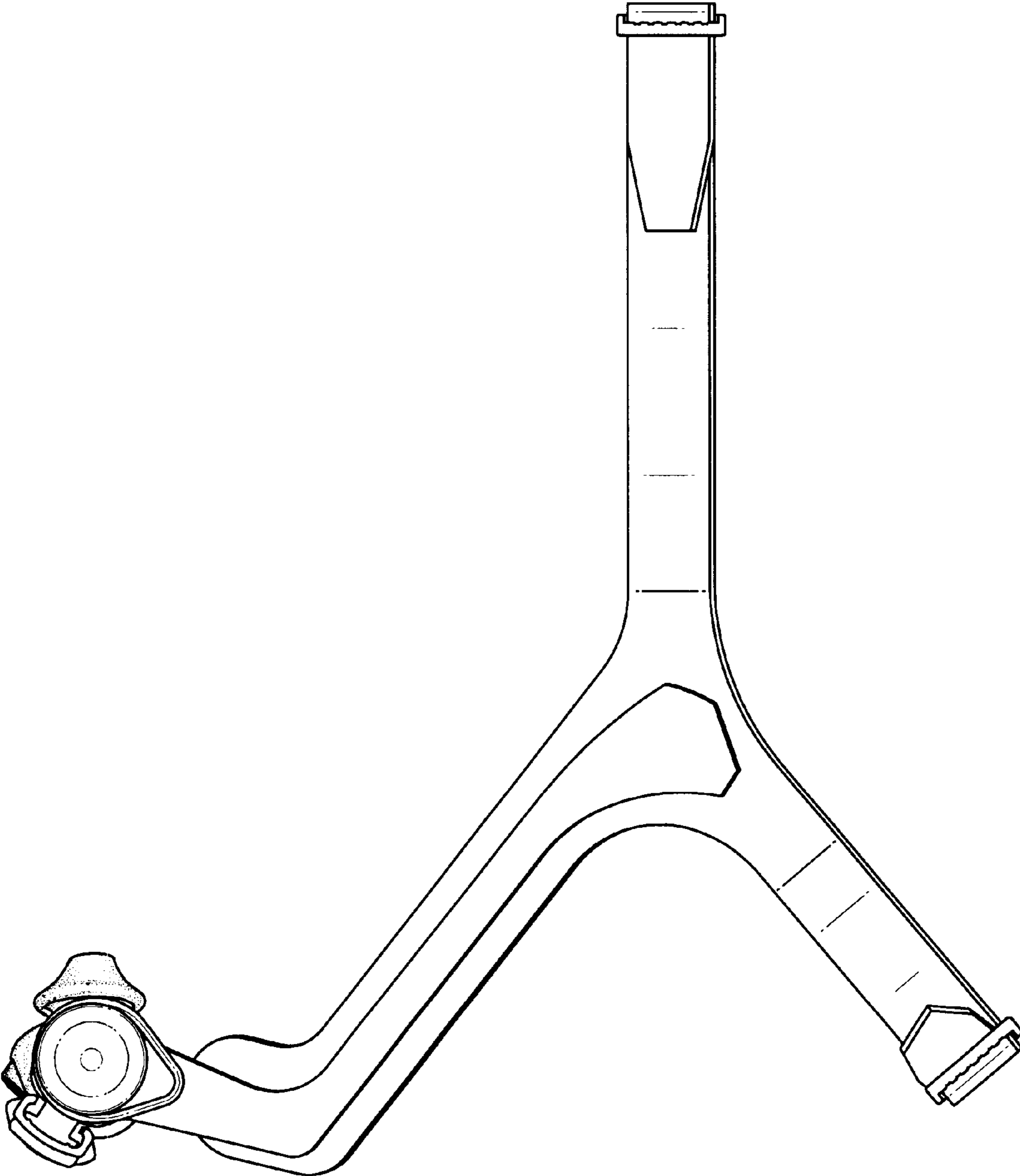

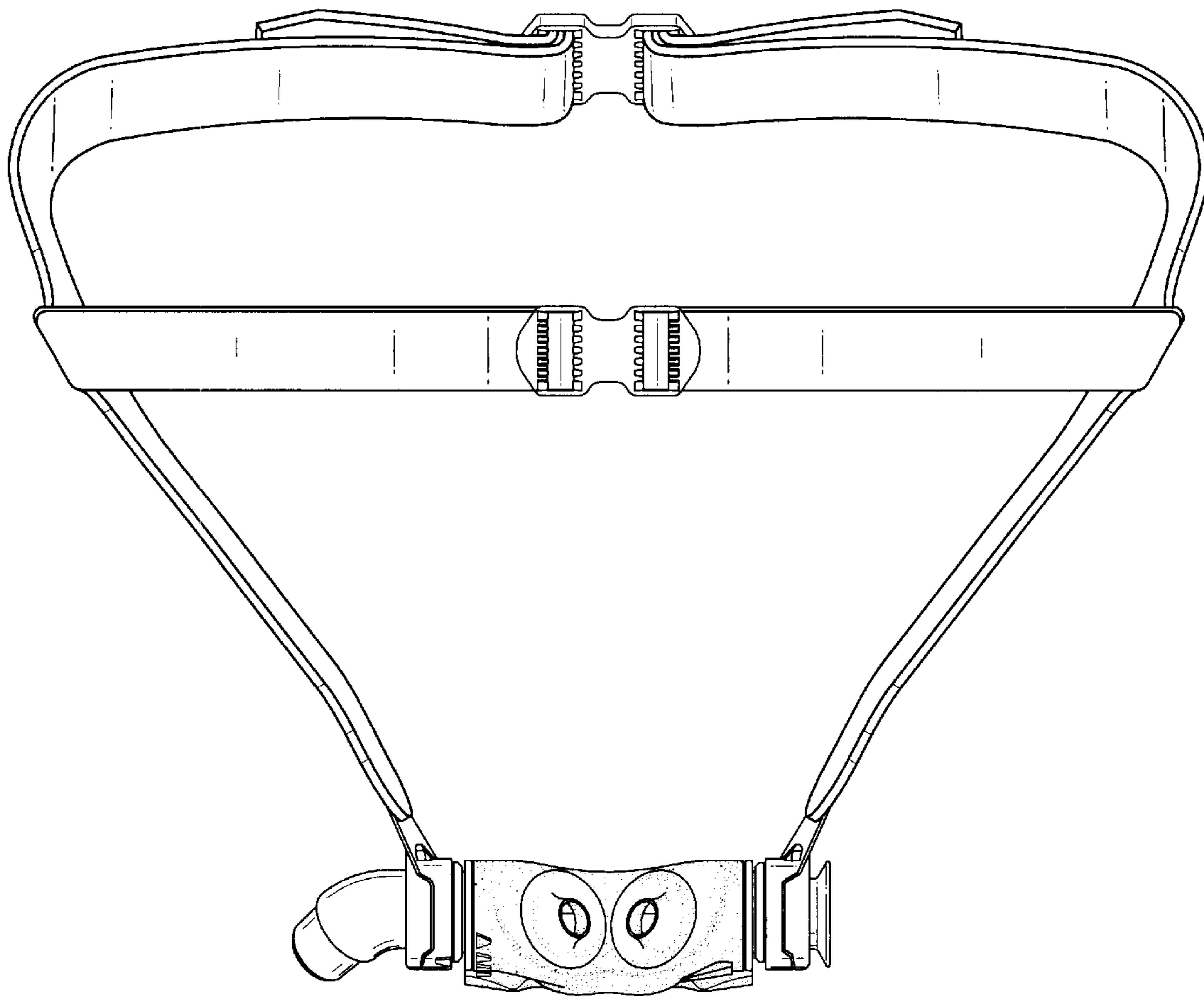

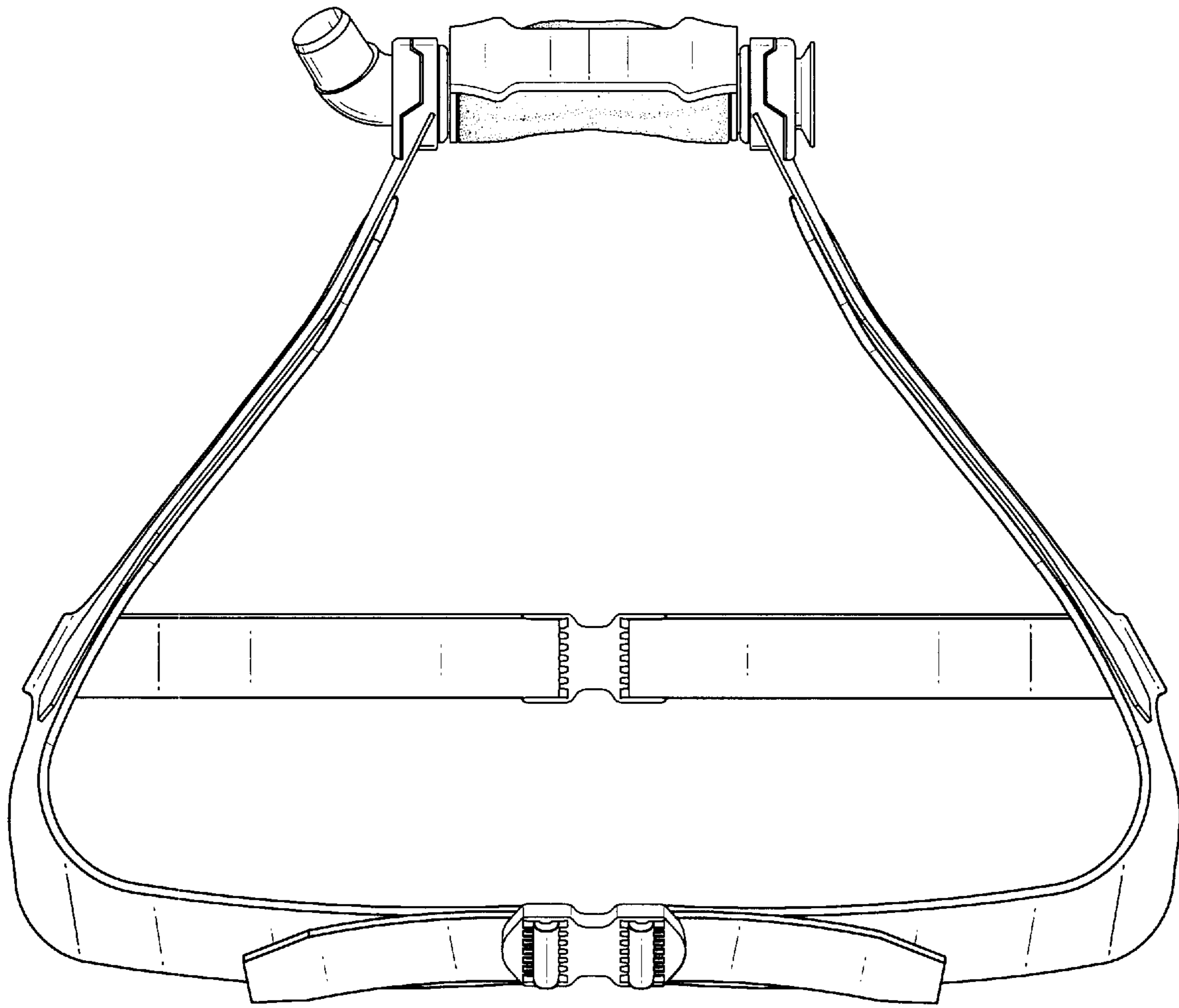
