FIG. 4 is a right side elevation view of the decorative hair accessory of the present invention;

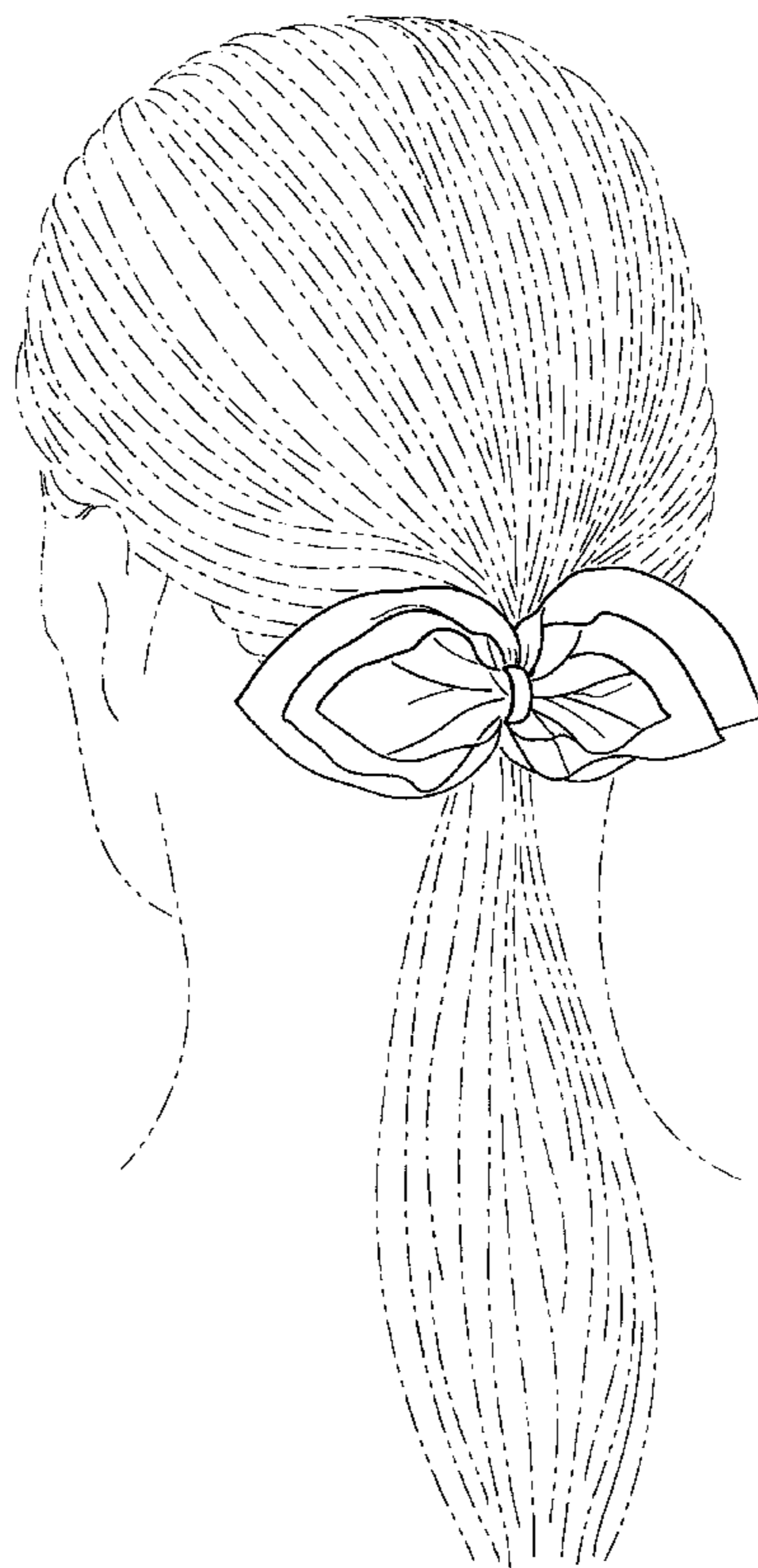
FIG. 5 is a bottom elevation view of the decorative hair accessory of the present invention;

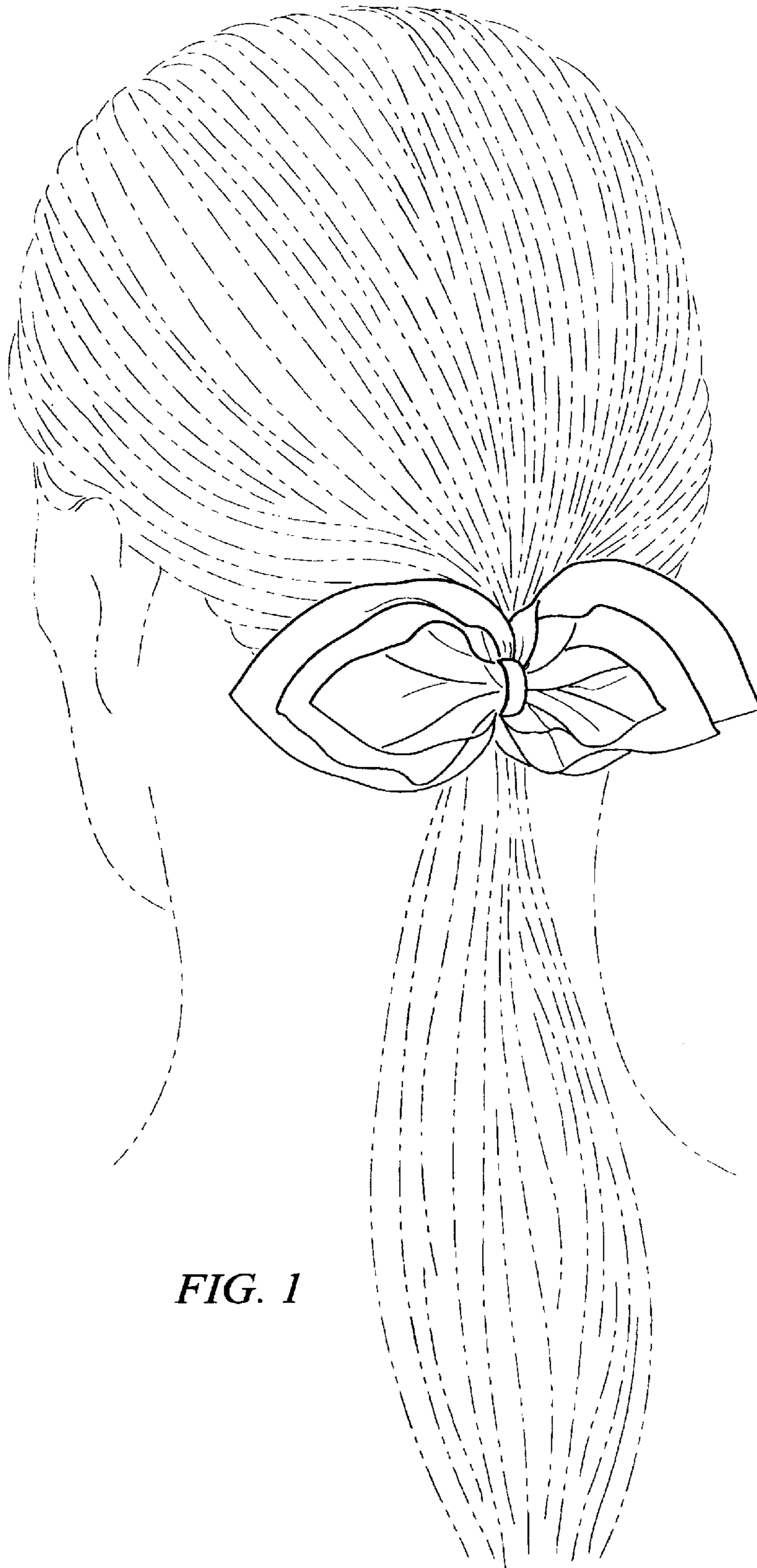
FIG. 6 is a front elevation view of the decorative hair accessory of the present invention; and,

FIG. 7 is a back elevation view of the decorative hair accessory of the present invention.

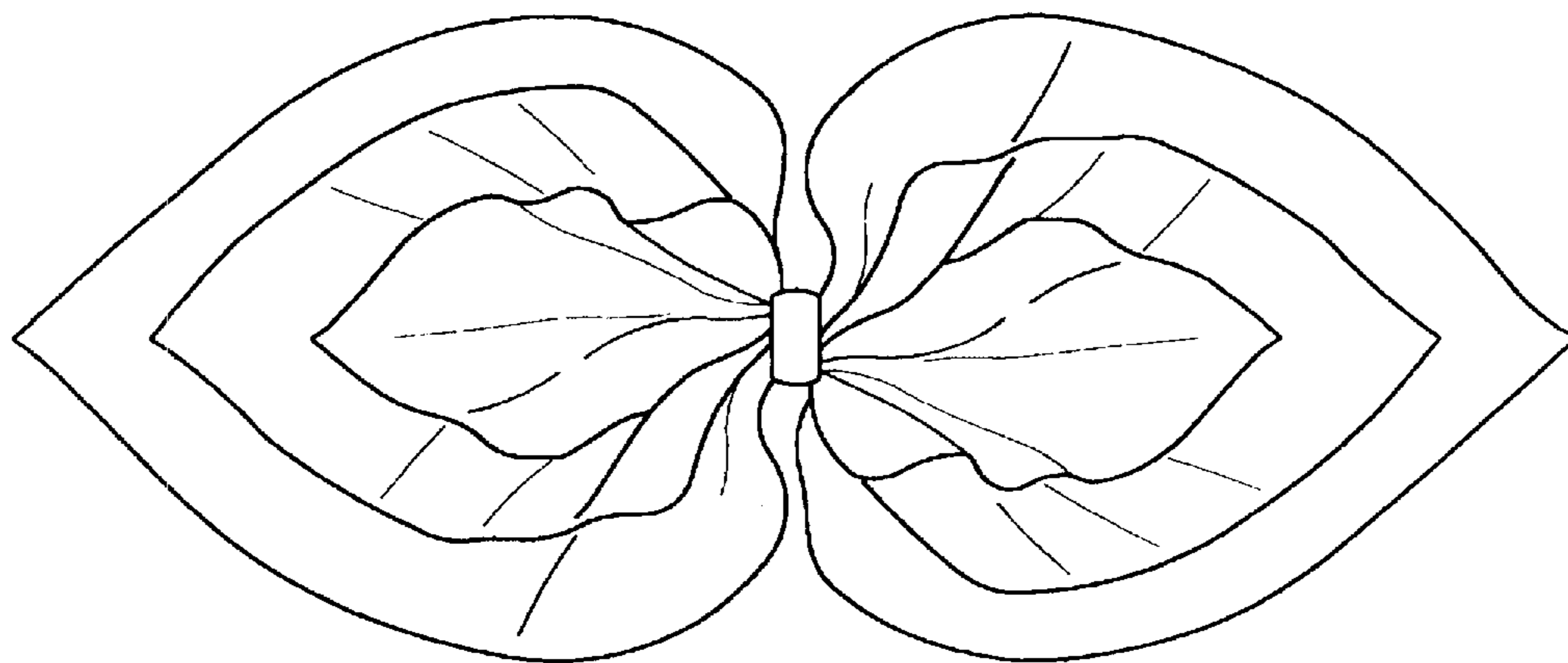

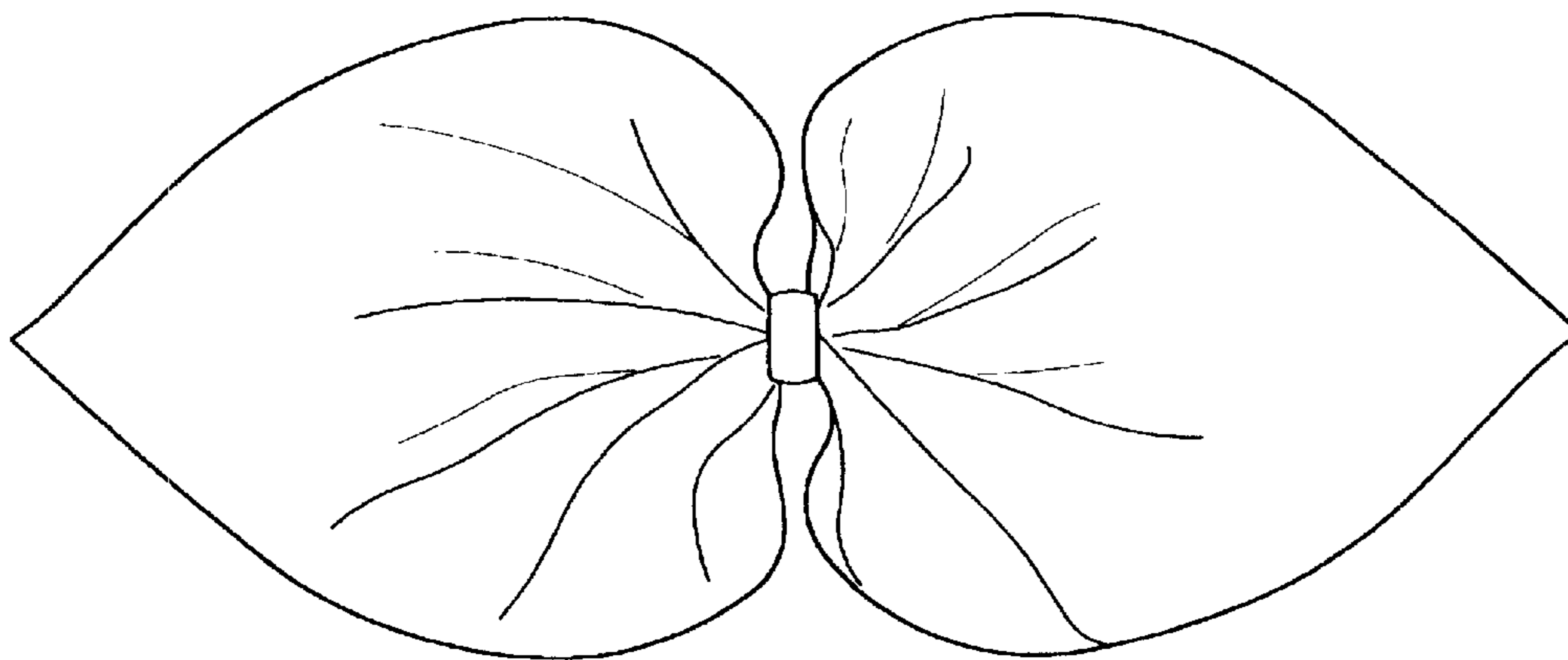
