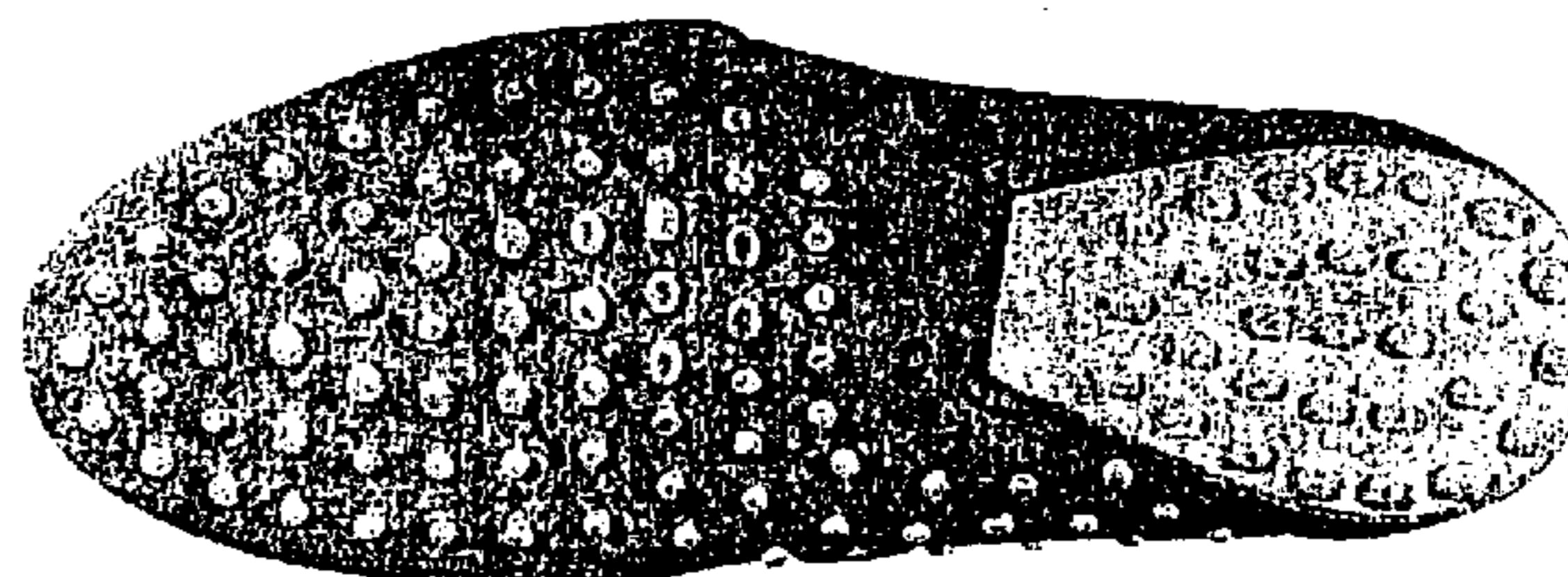
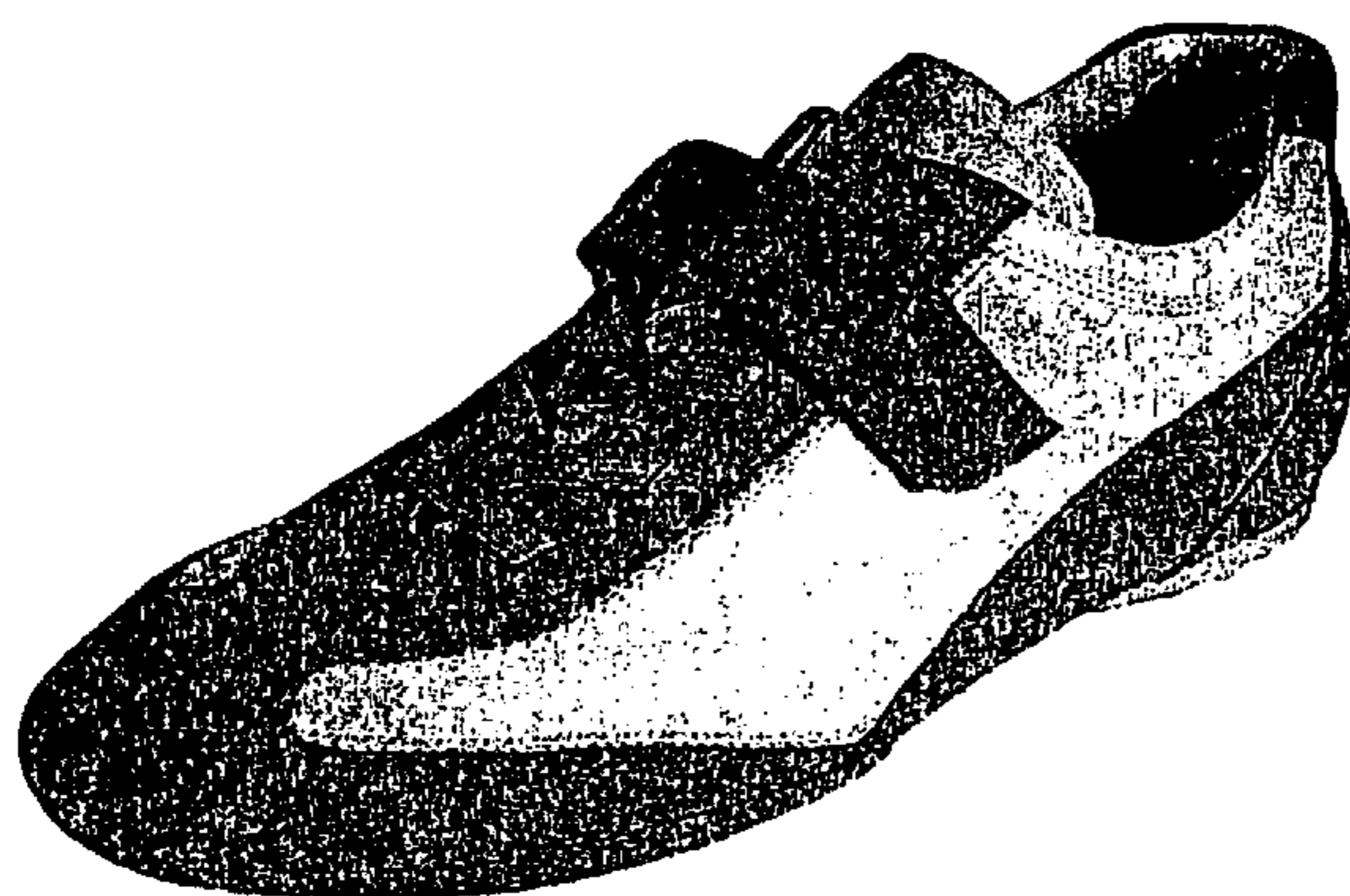
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a shoe showing my new design;

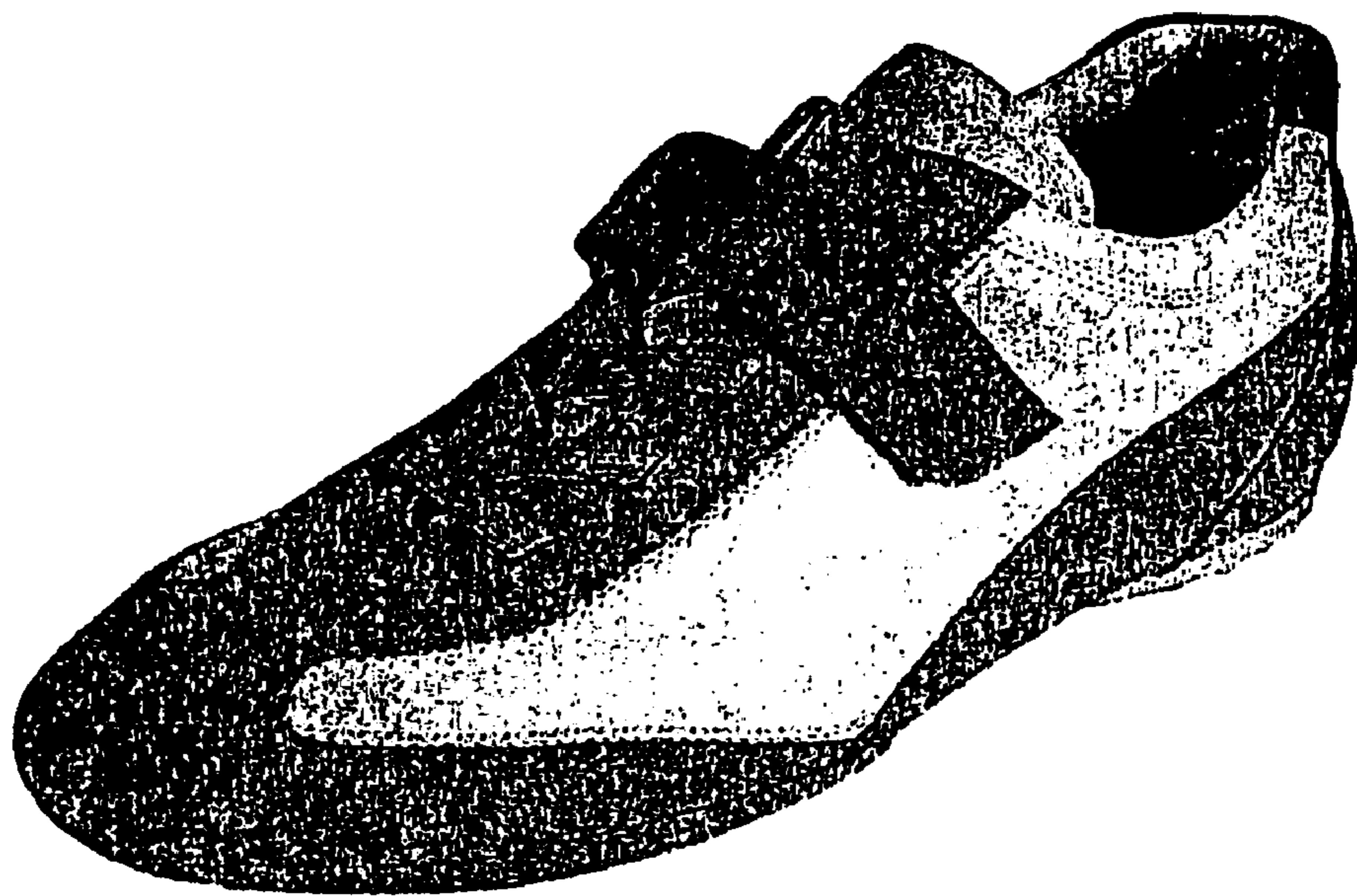

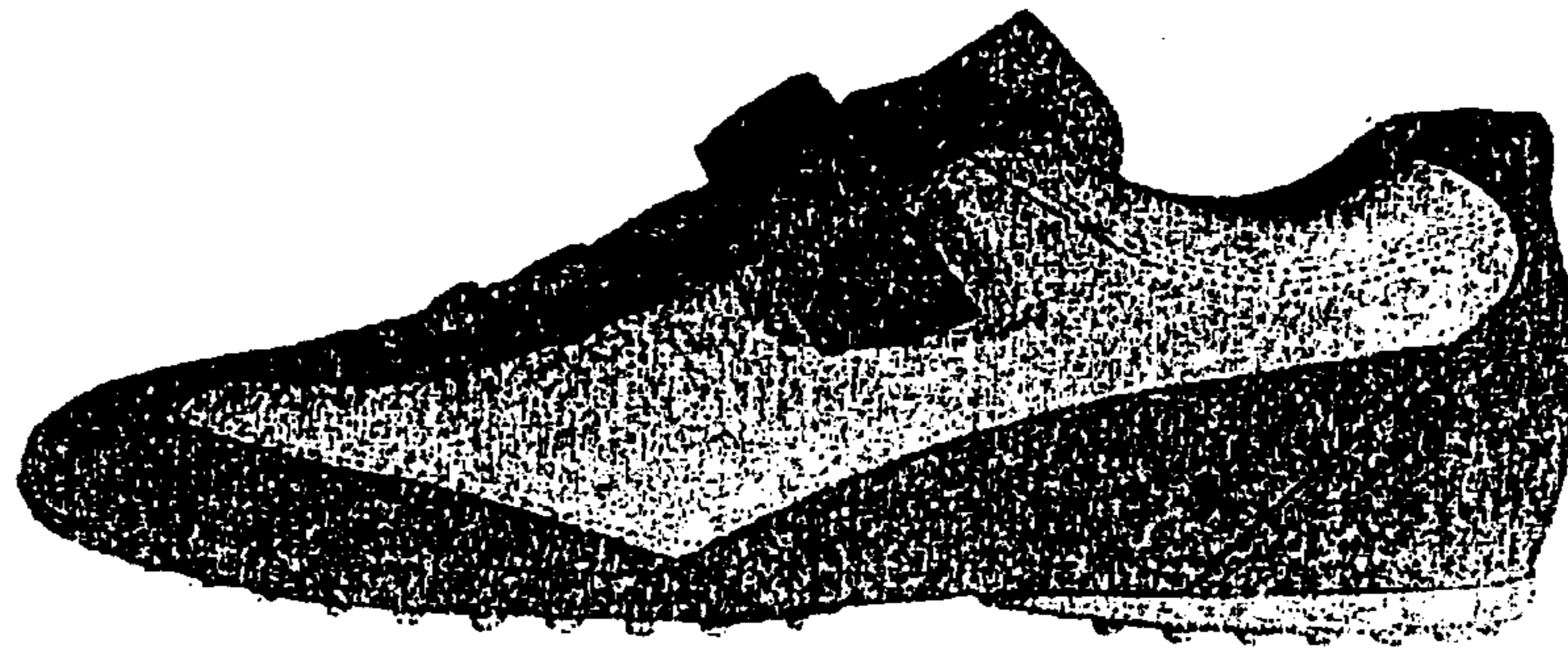

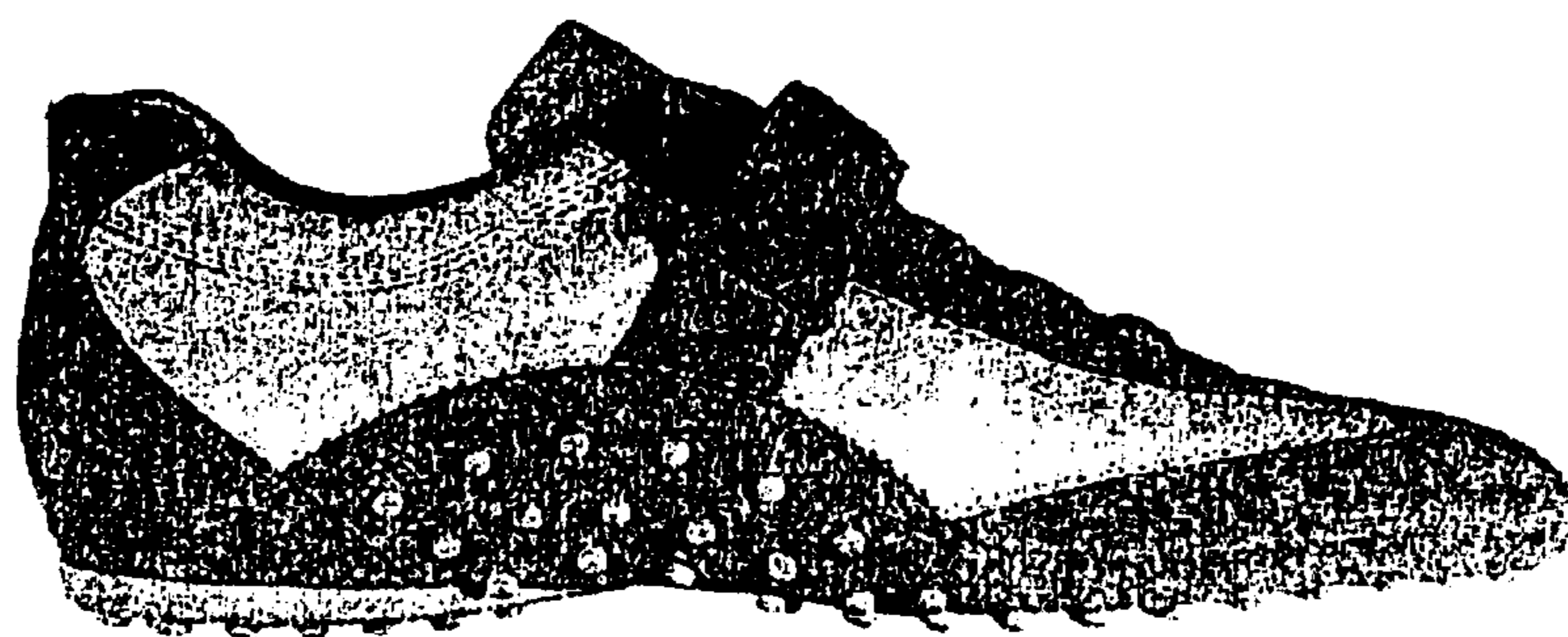

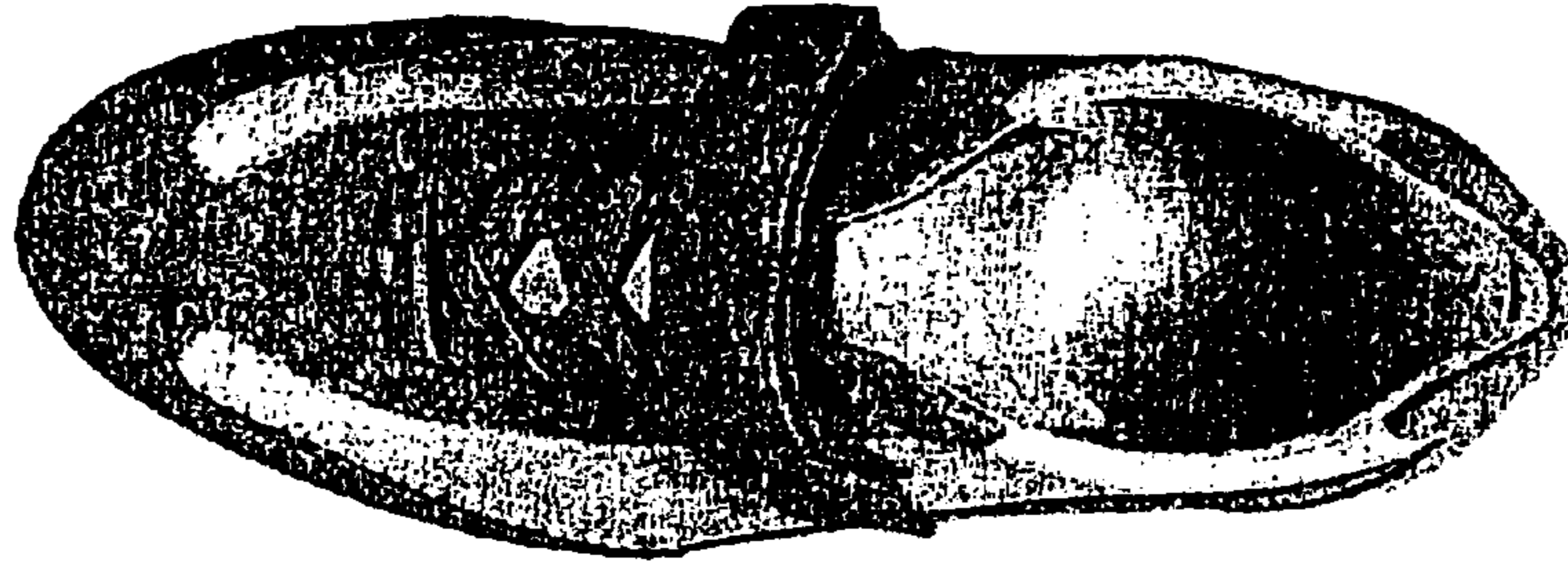

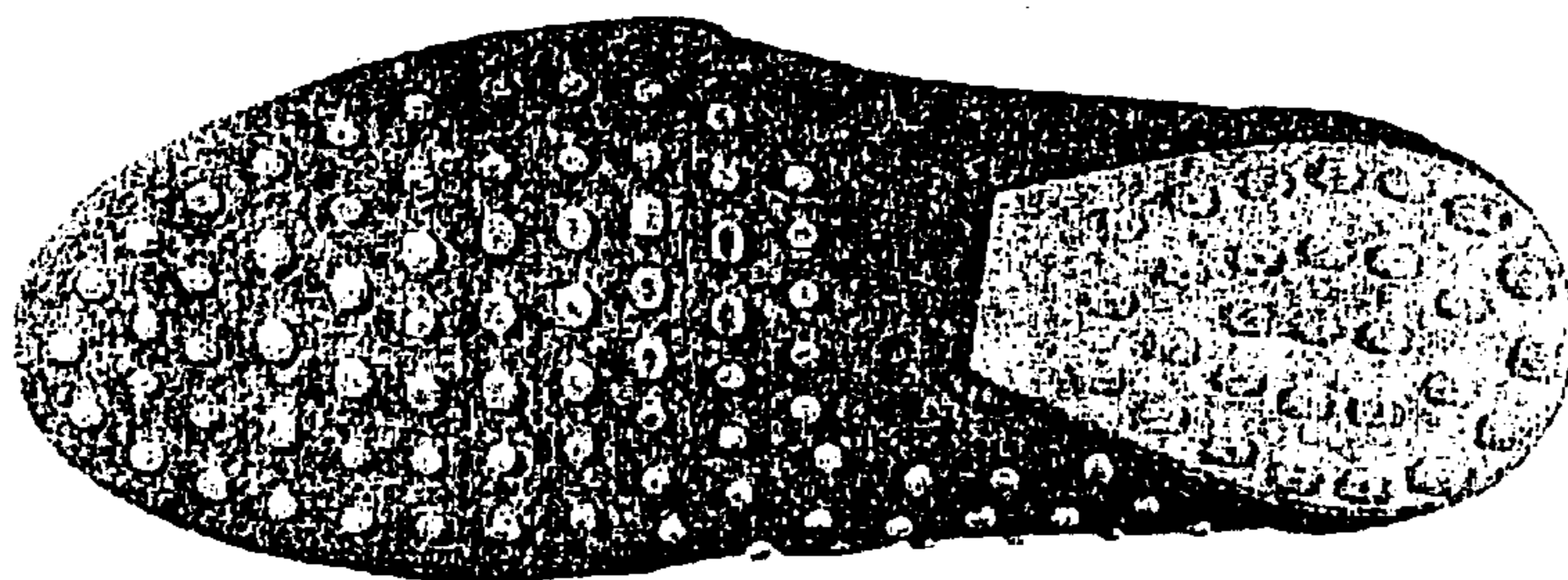
