DESCRIPTION

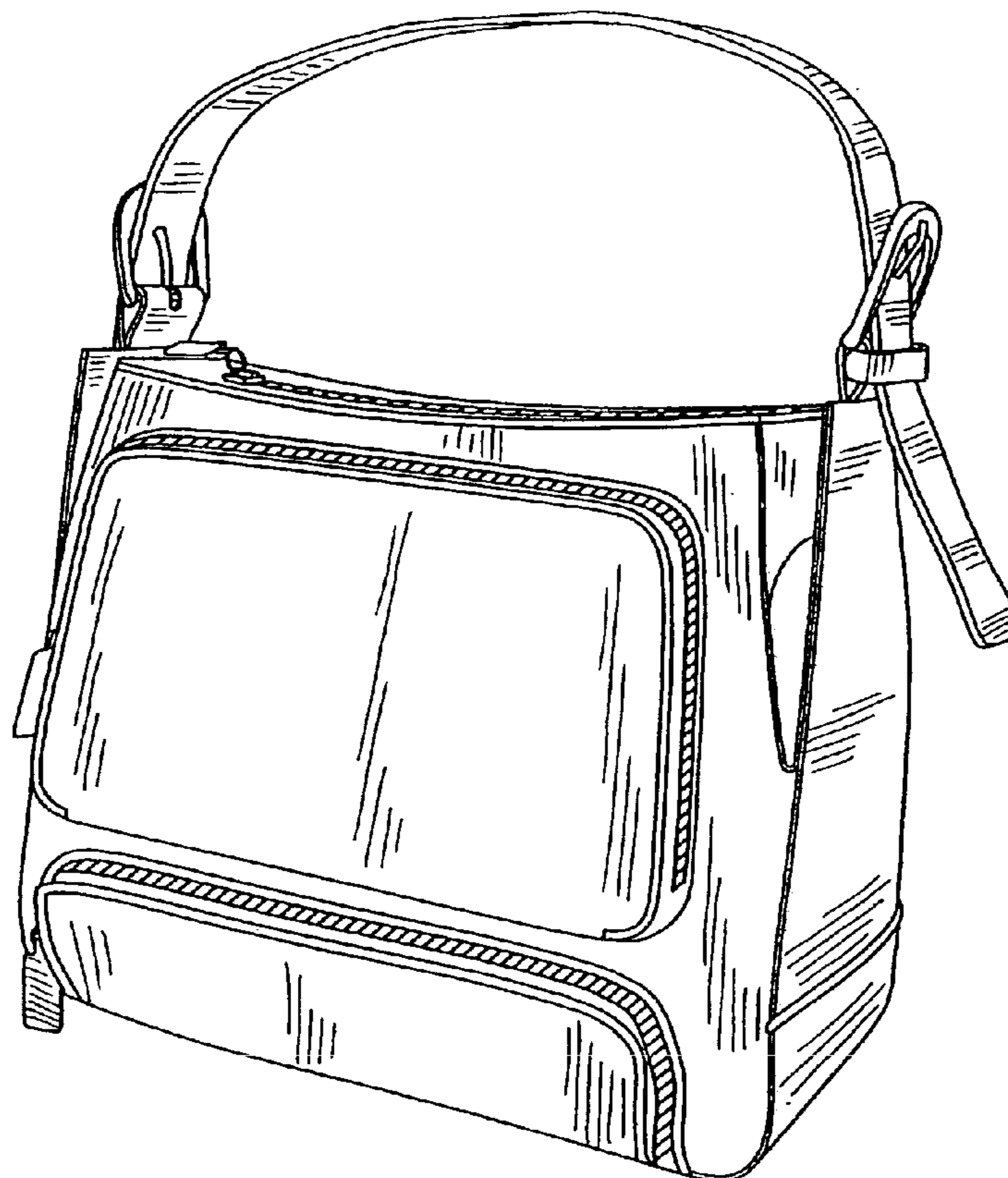
FIG. 1 is a front perspective view of a zippered carrying bag in a closed configuration embodying my new design; FIG. 2 is a rear perspective view of the zippered carrying bag in a closed configuration embodying my new design; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is an alternate front perspective view of the zippered carrying bag in an open configuration embodying my new design.

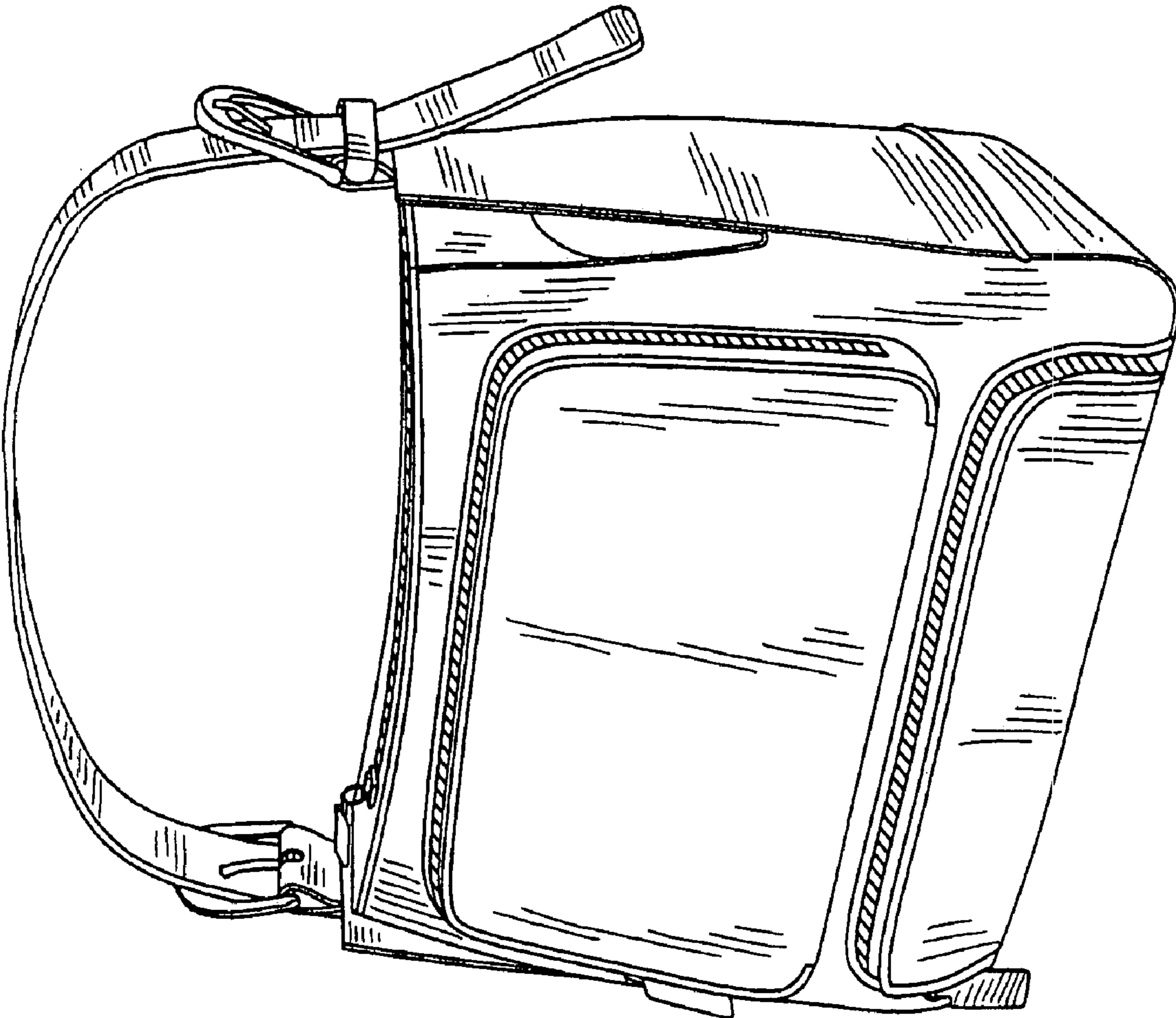

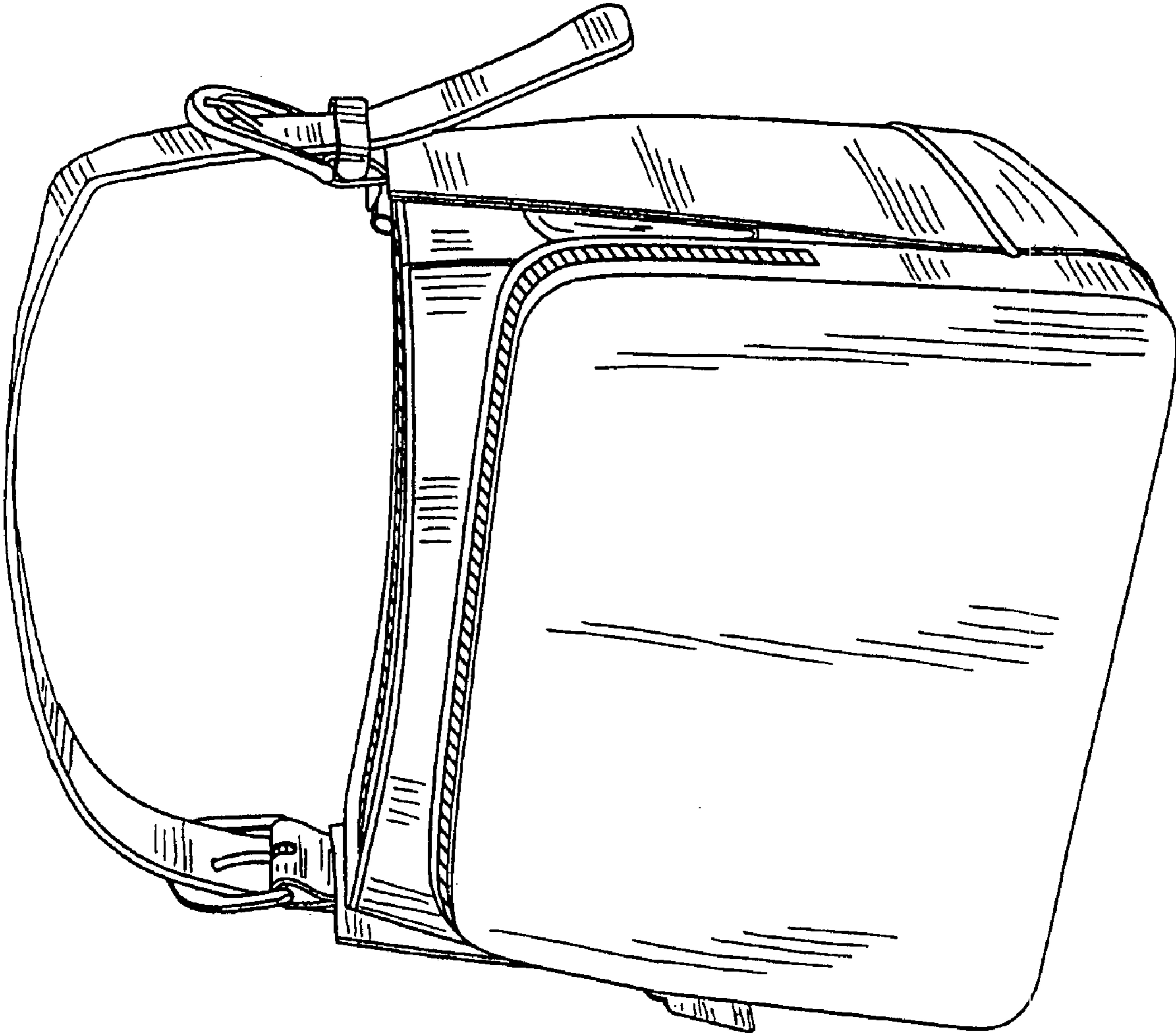

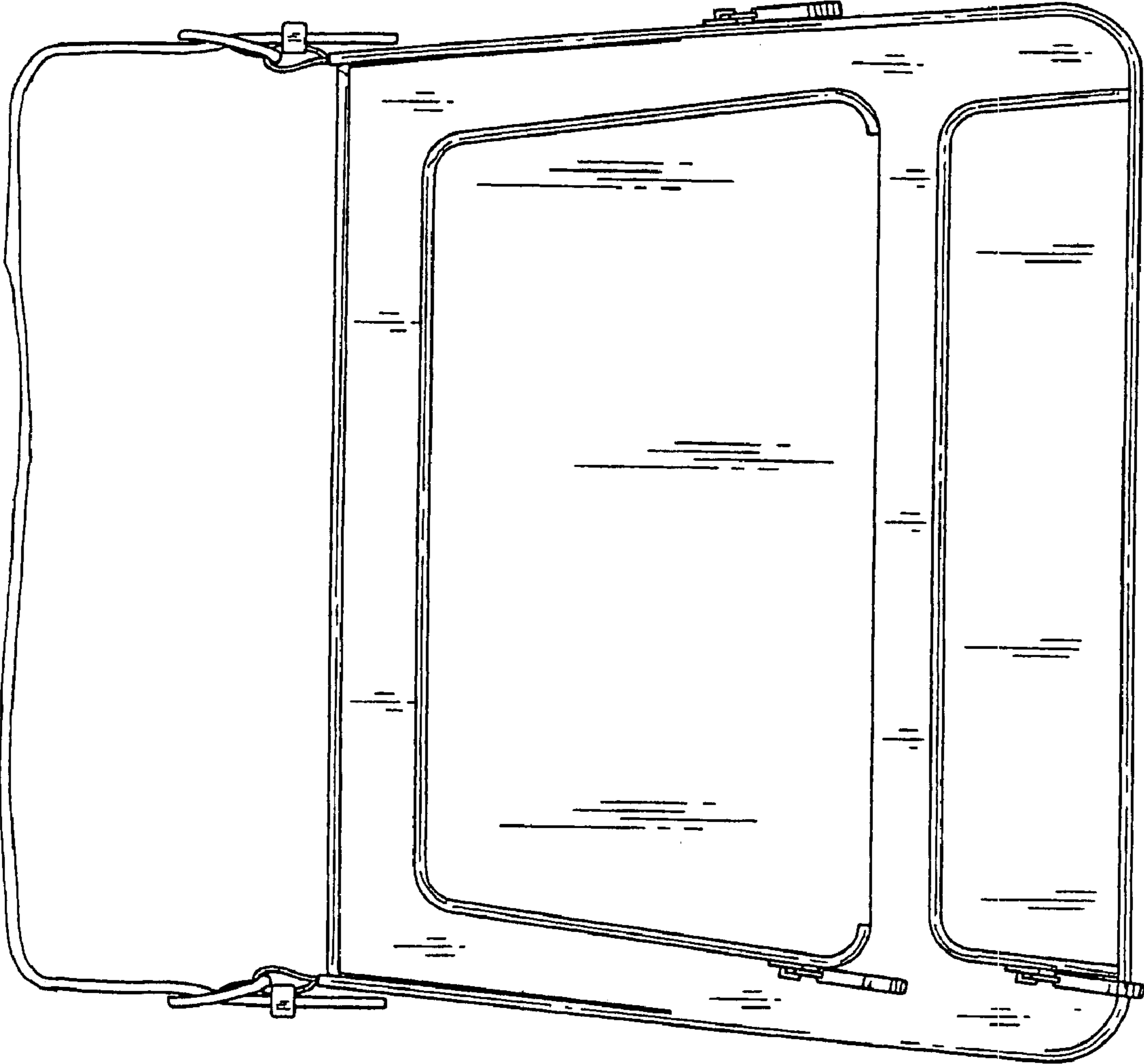

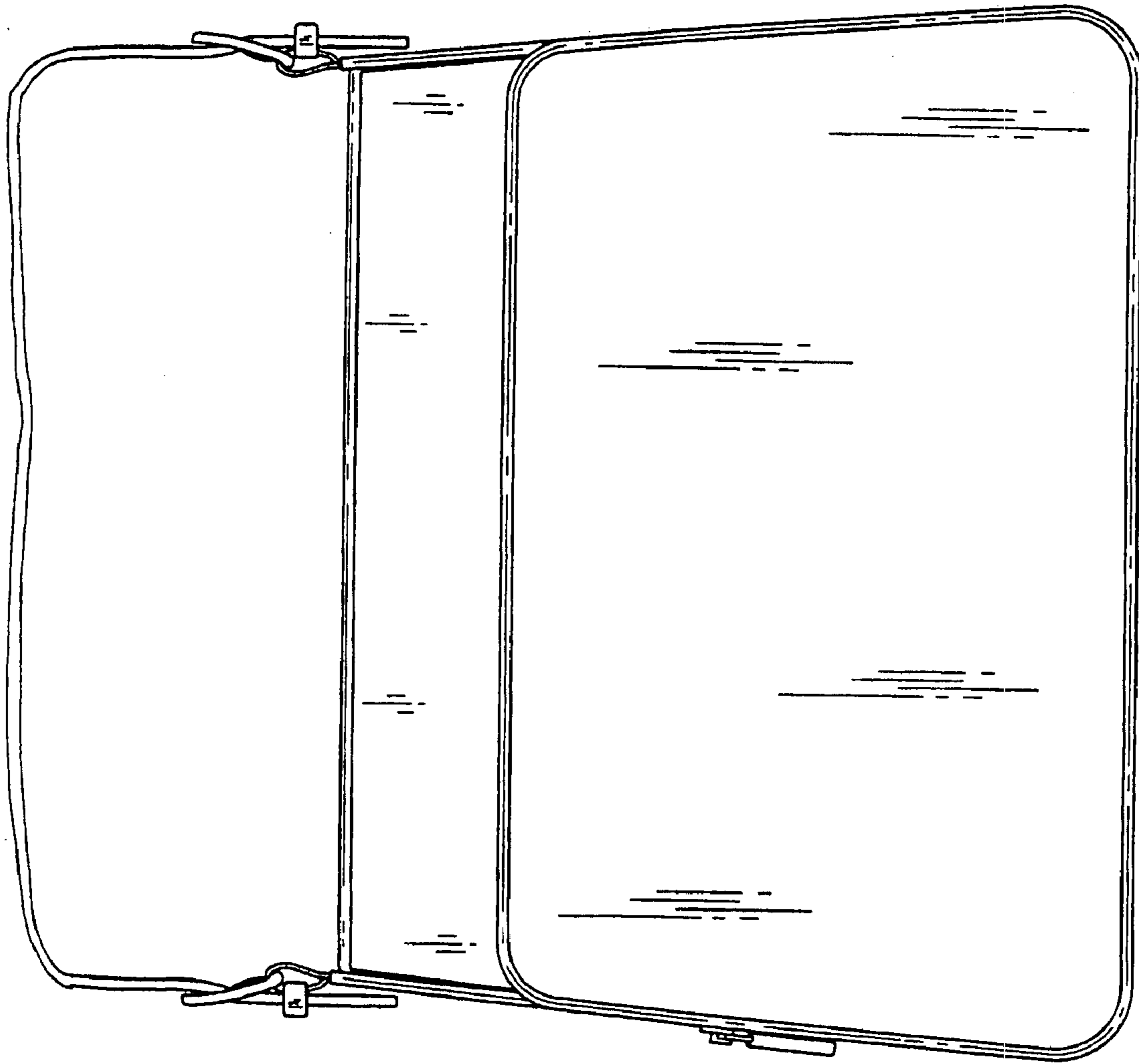

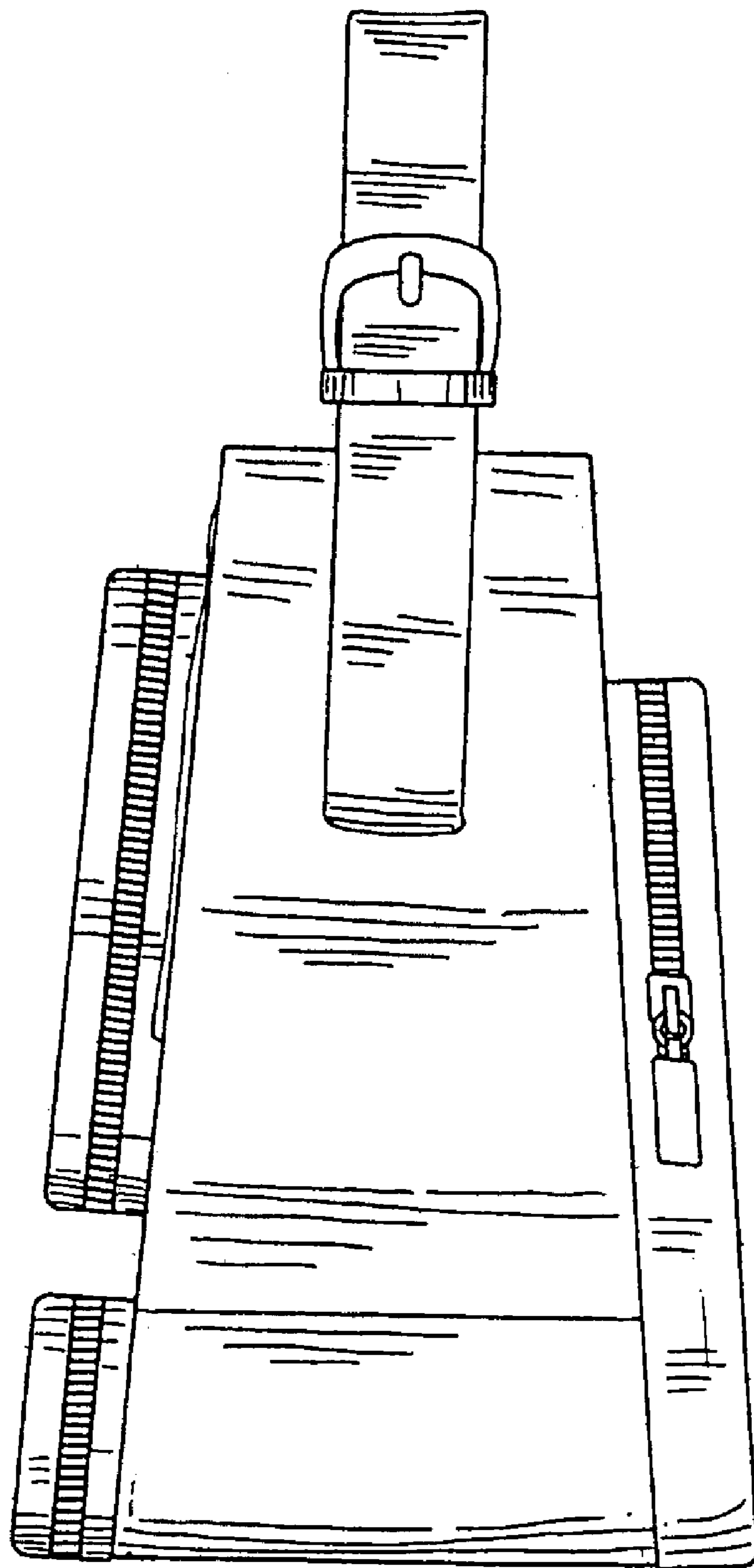

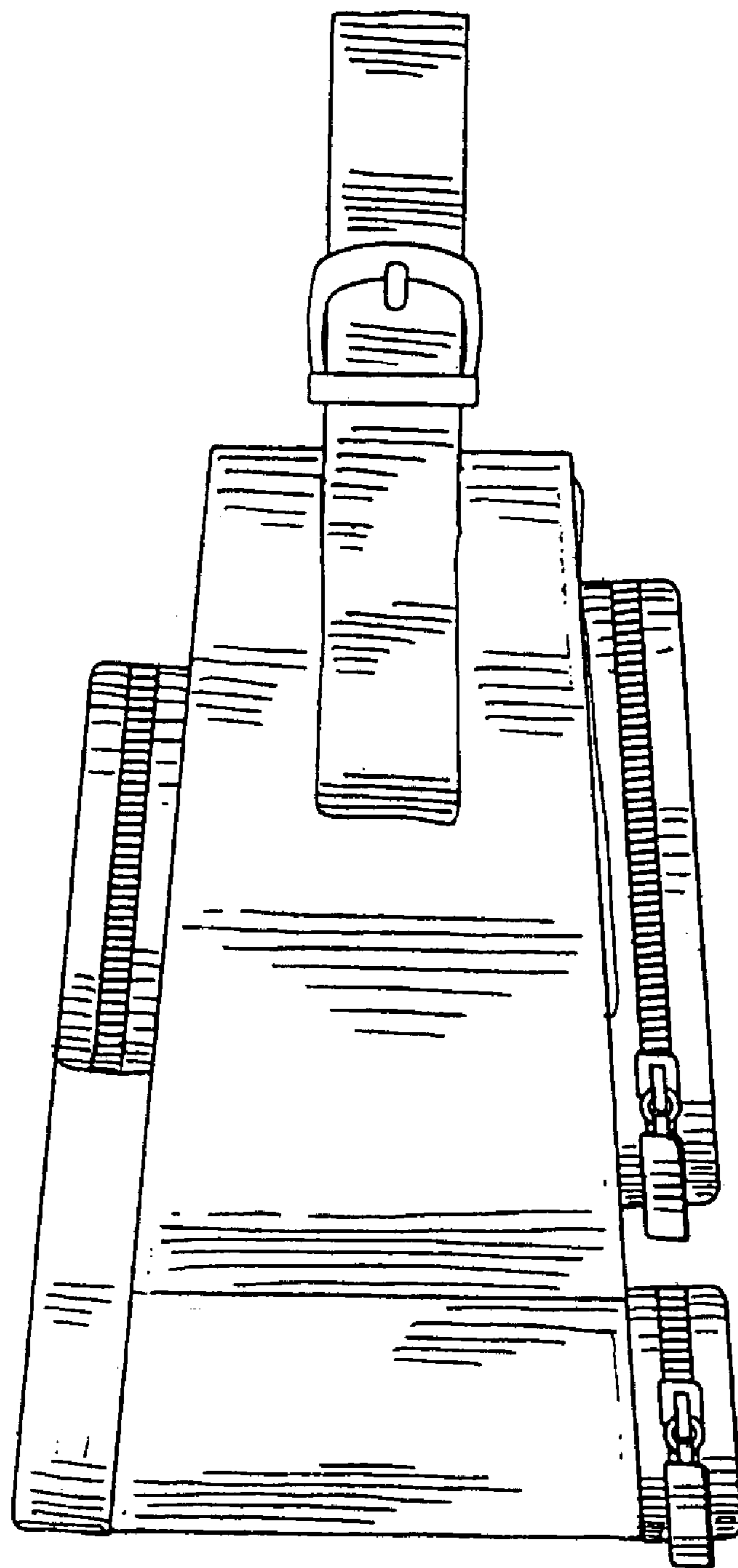

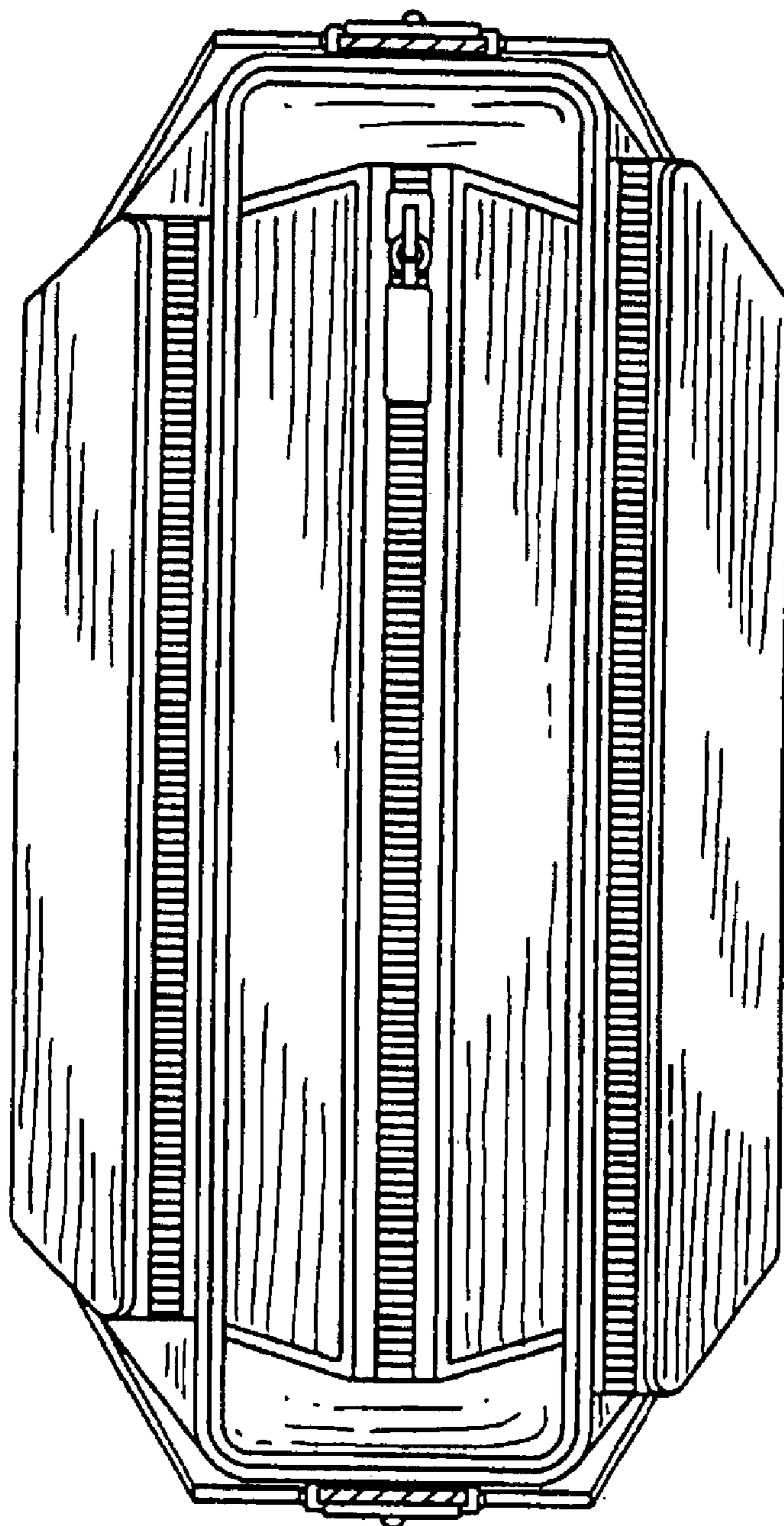

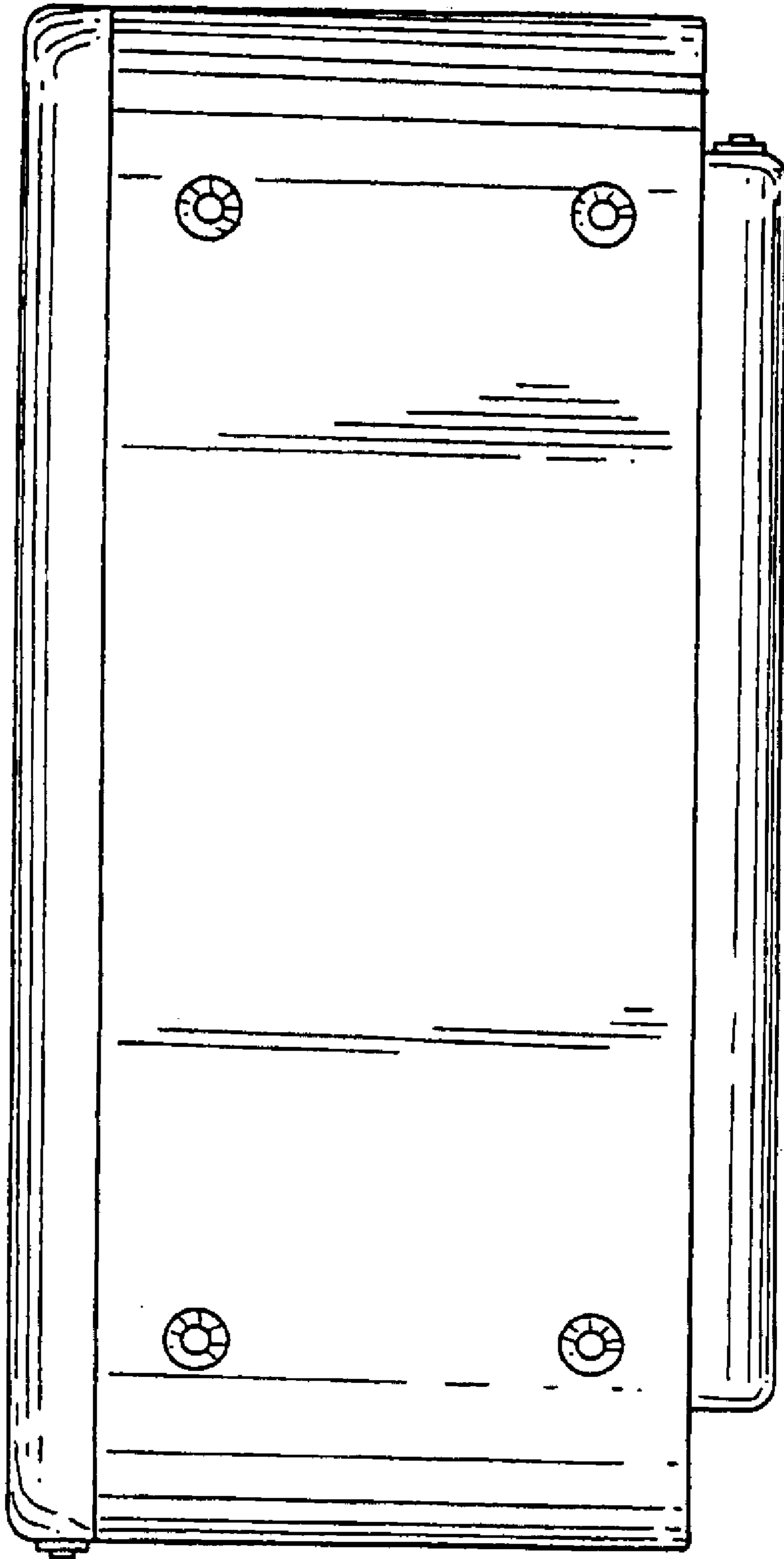

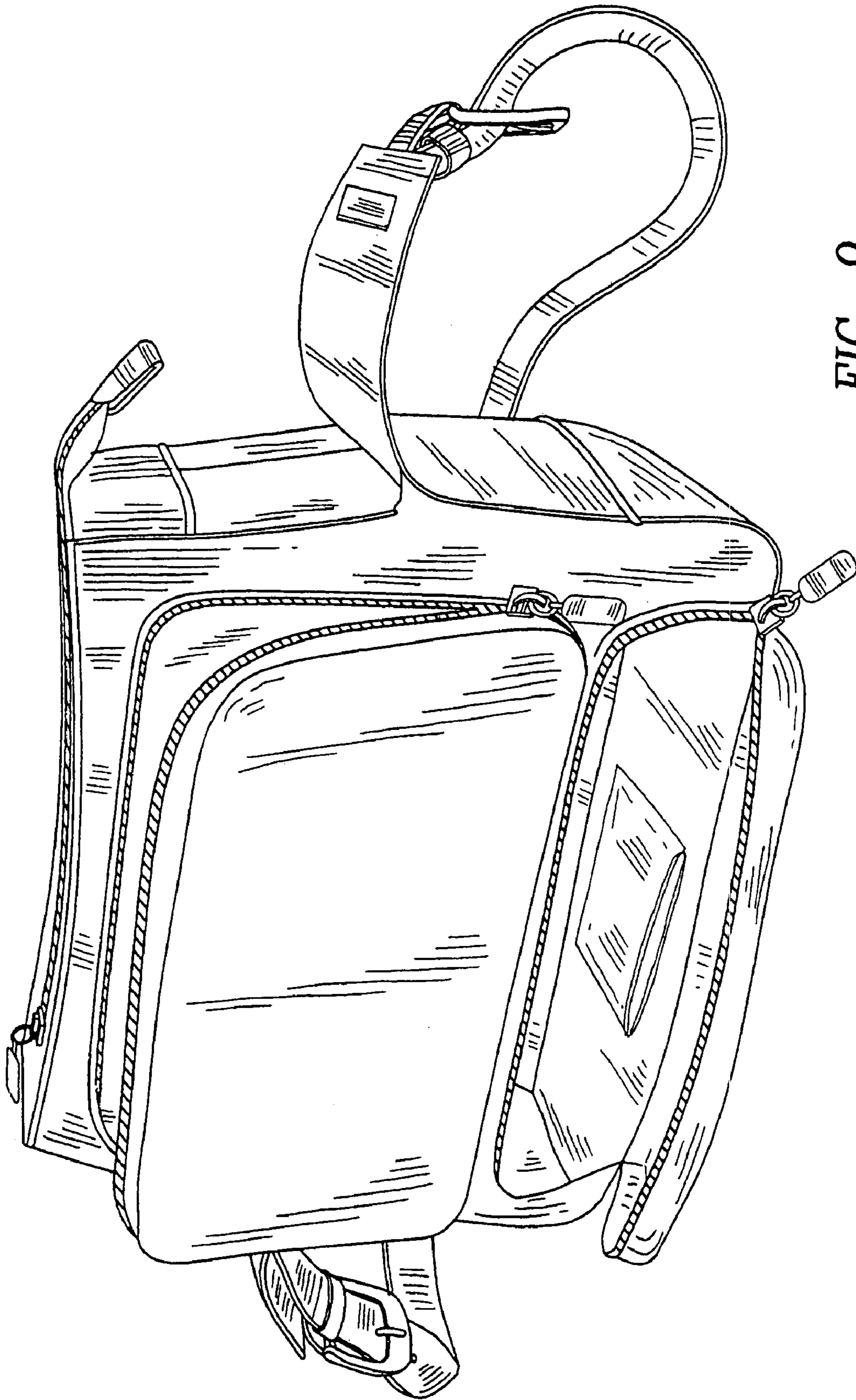
