FIG. 12 is a bottom plan view thereof.

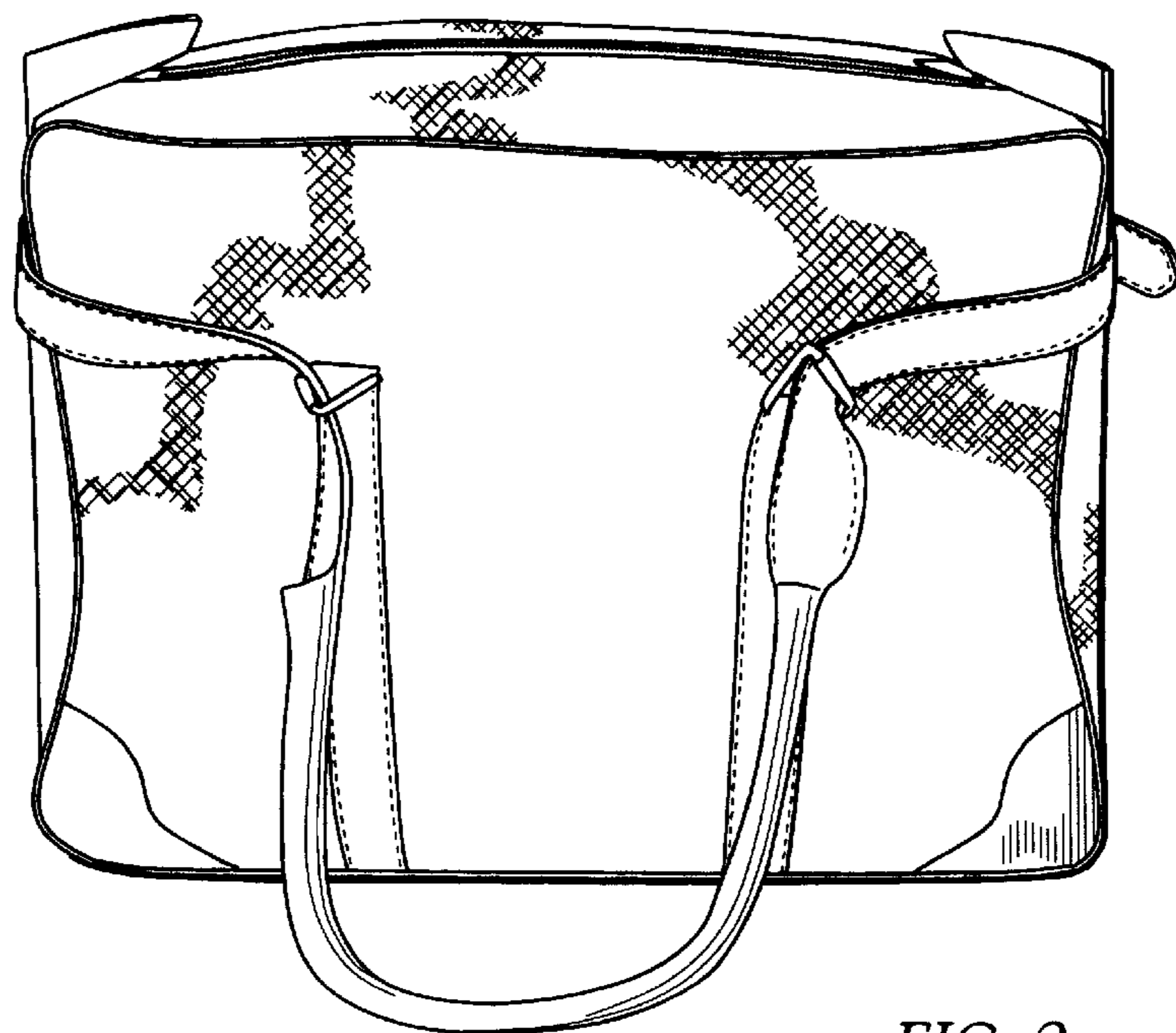
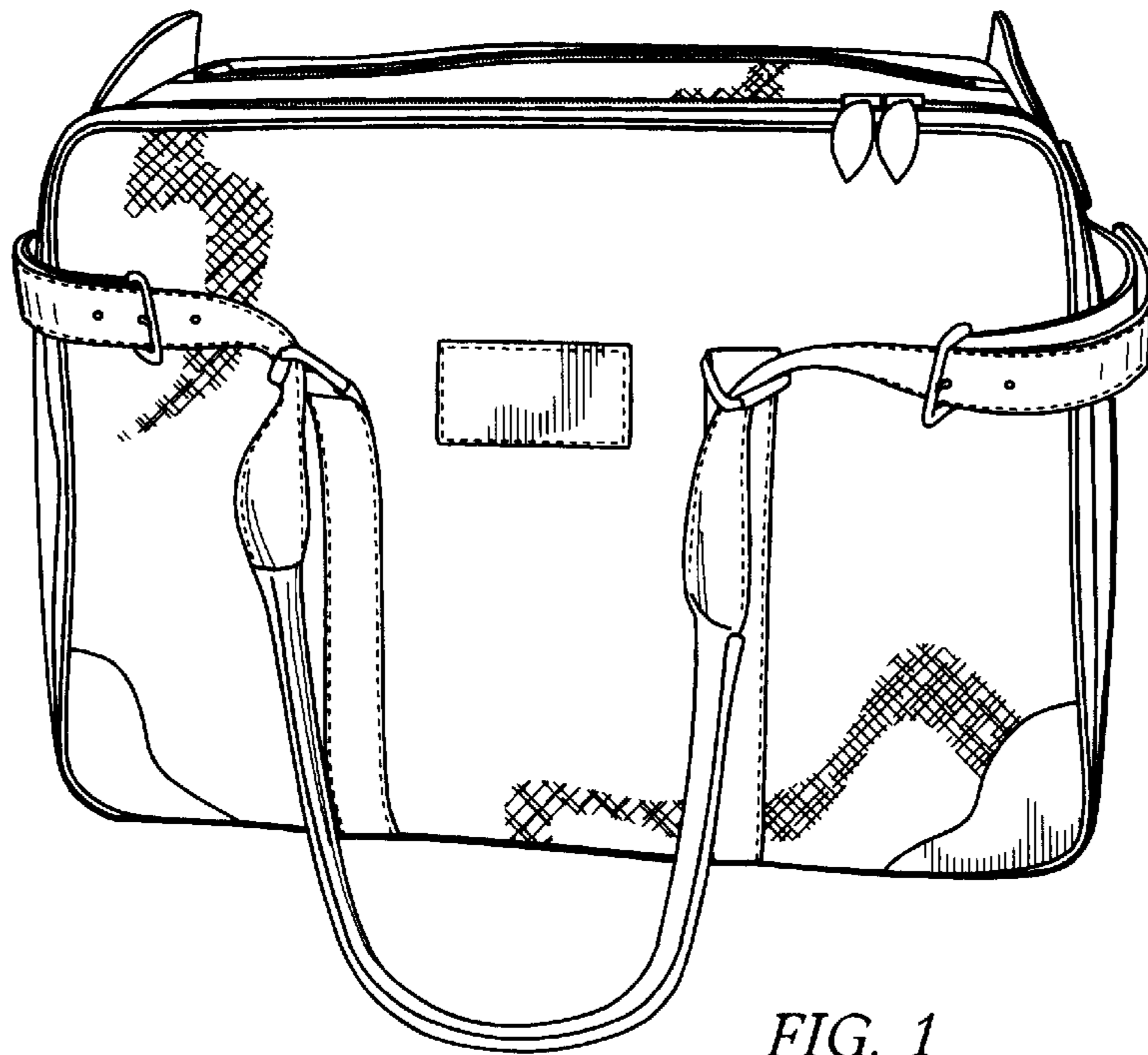

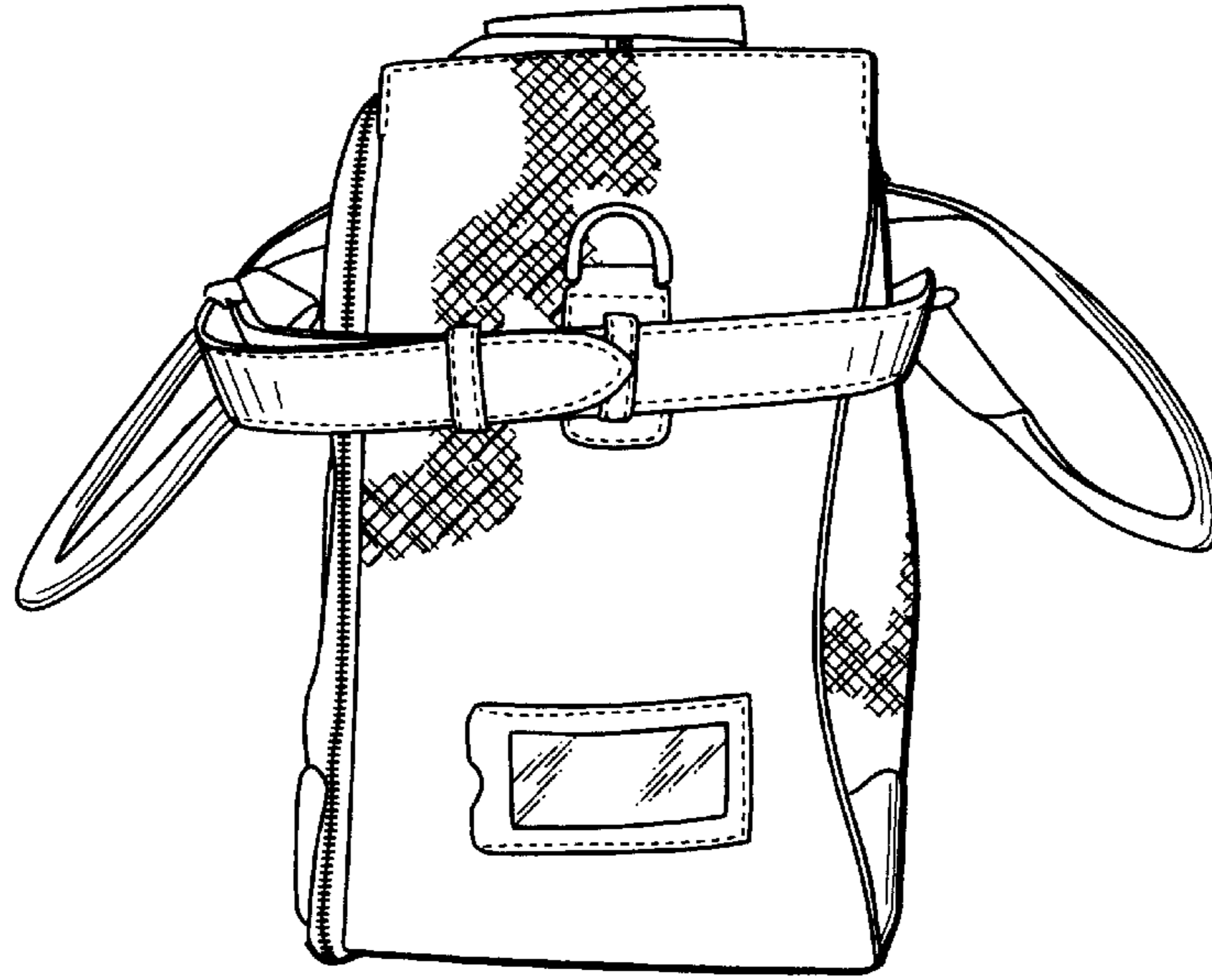

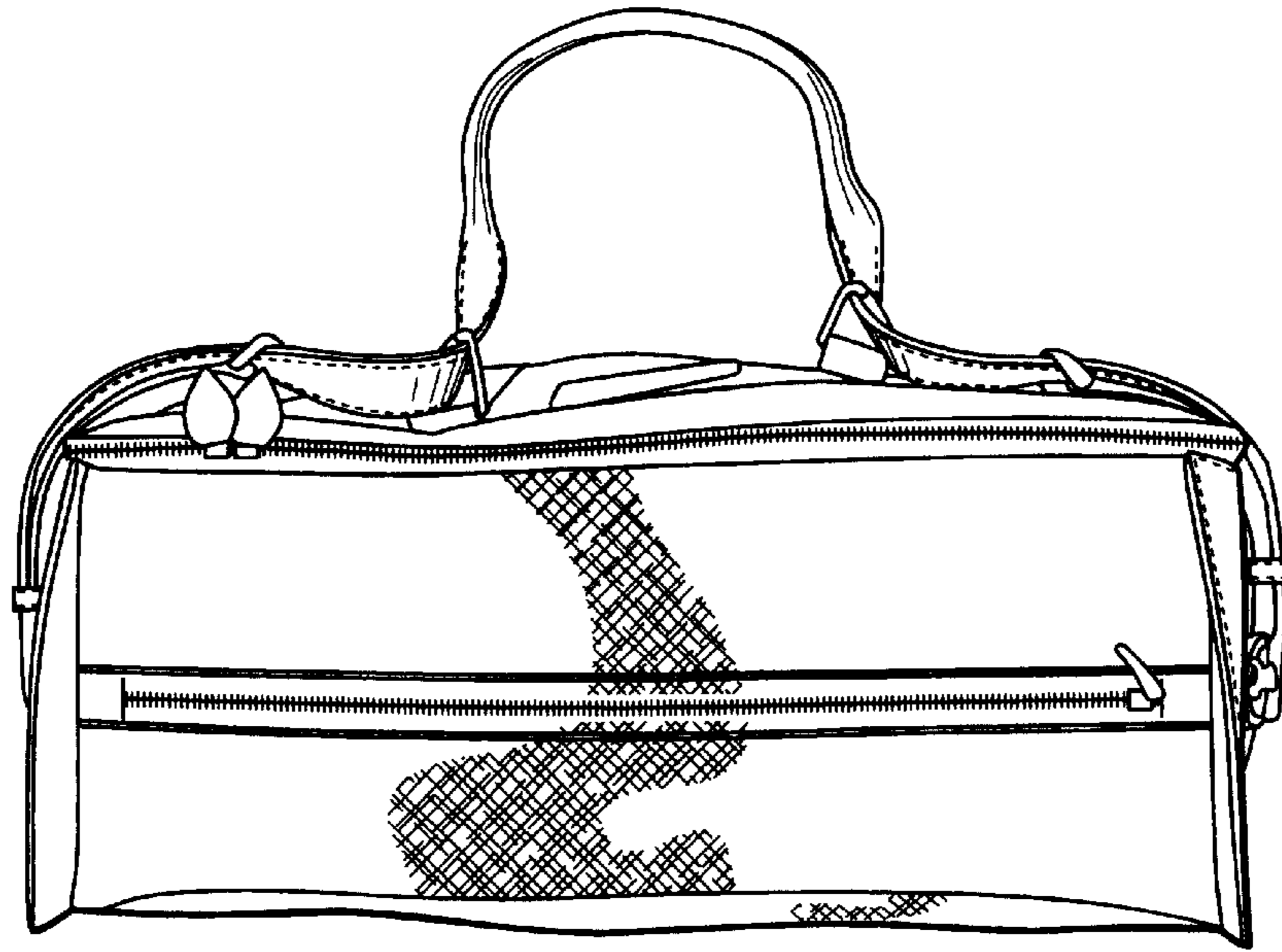

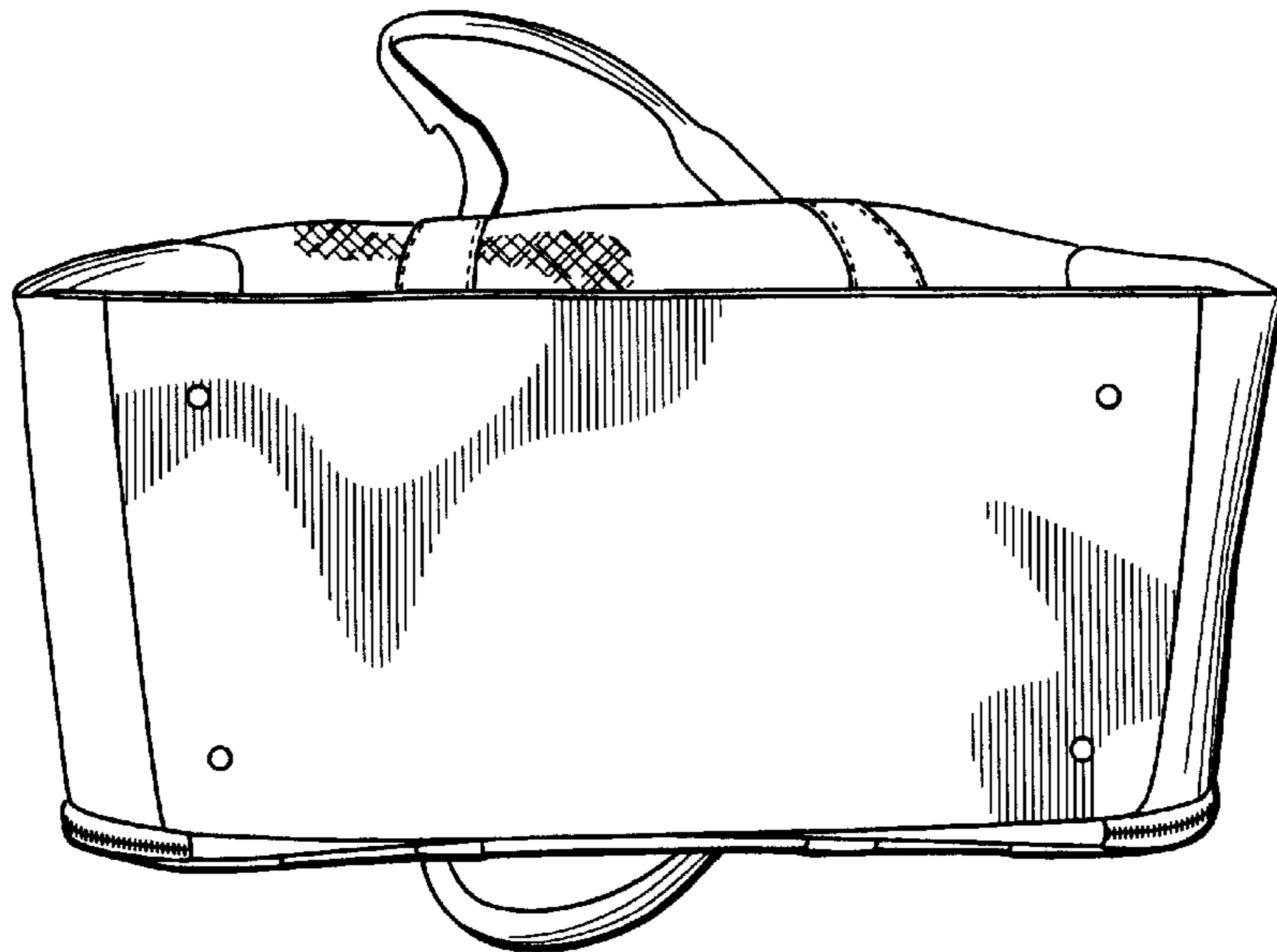

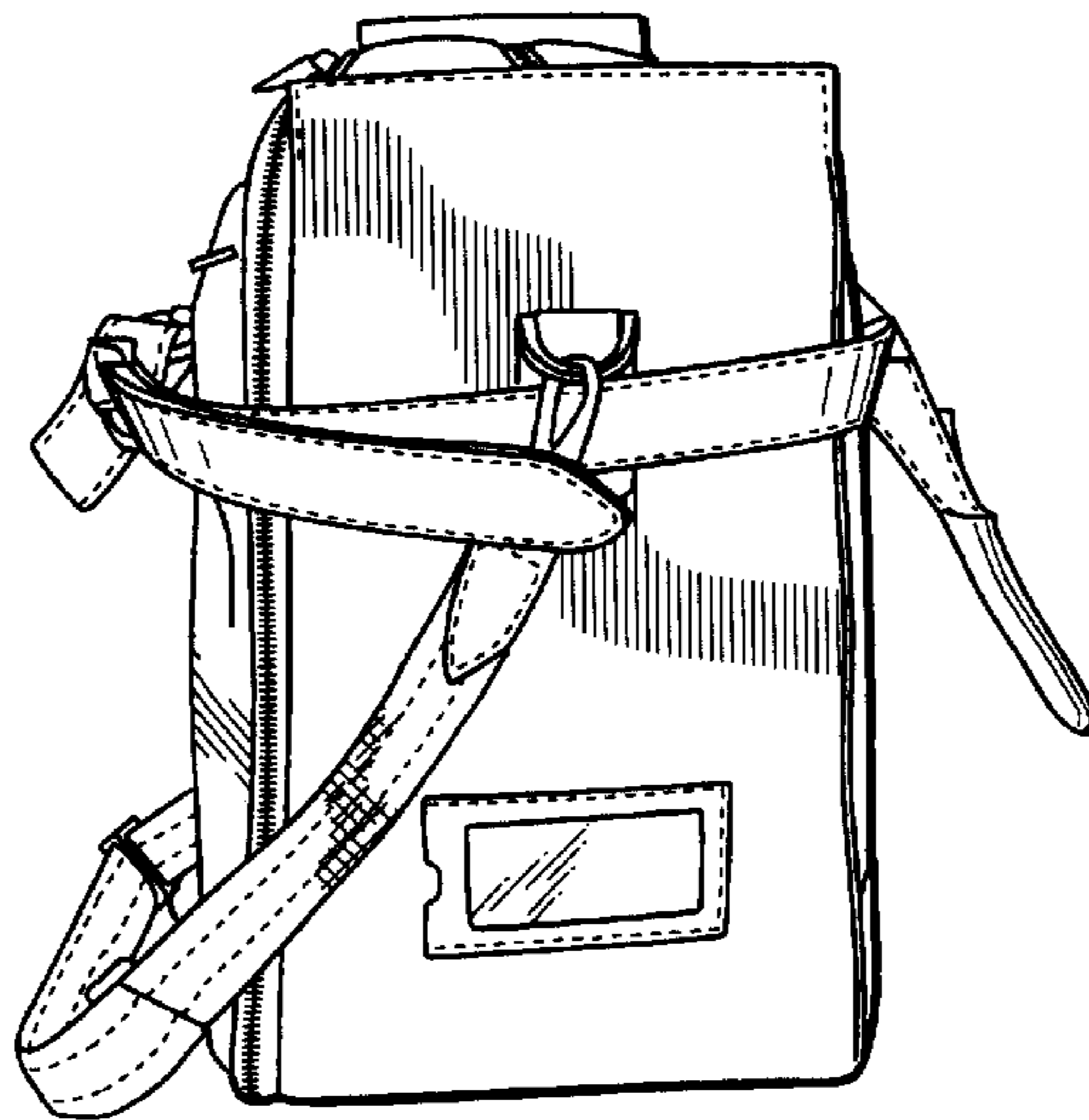

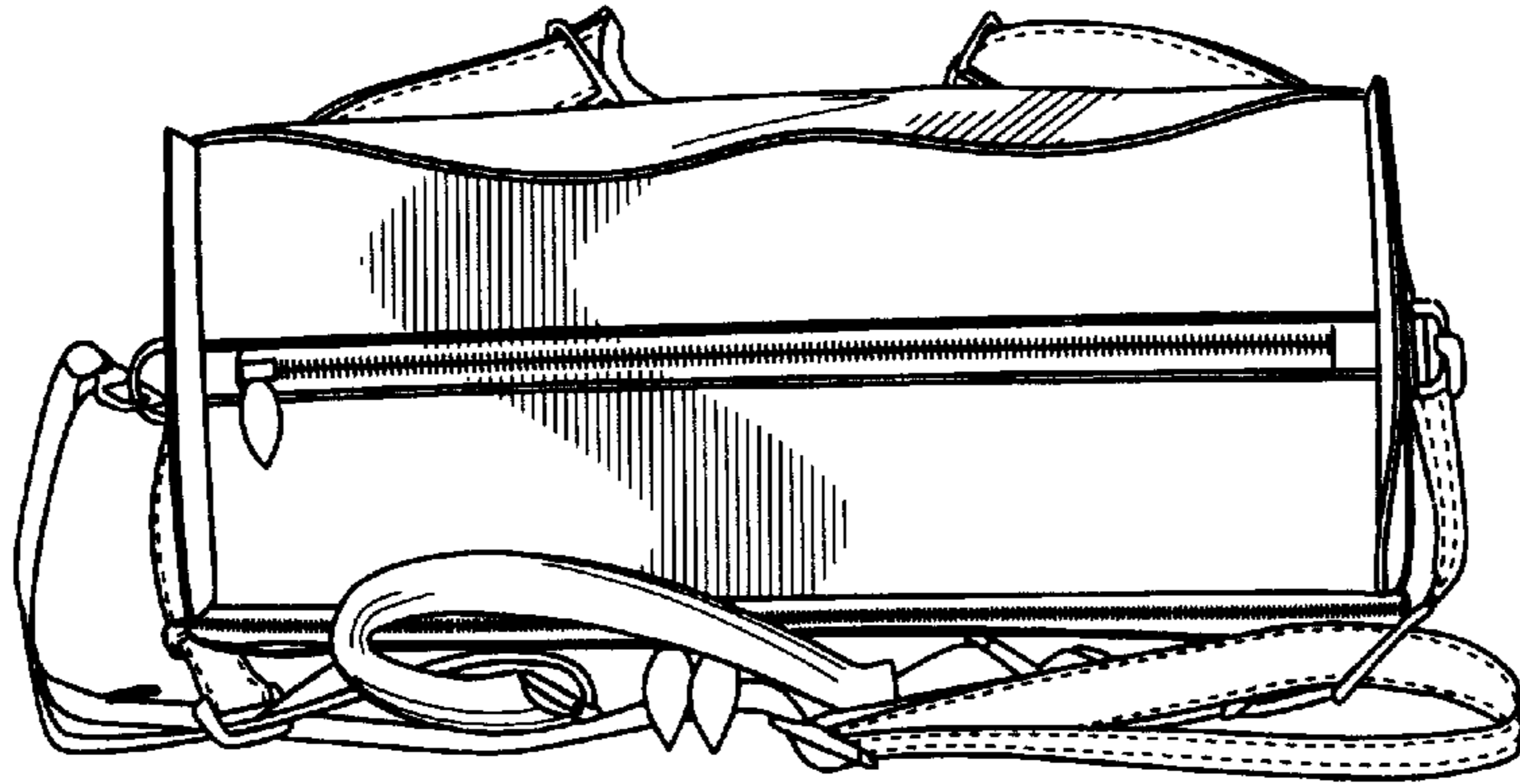

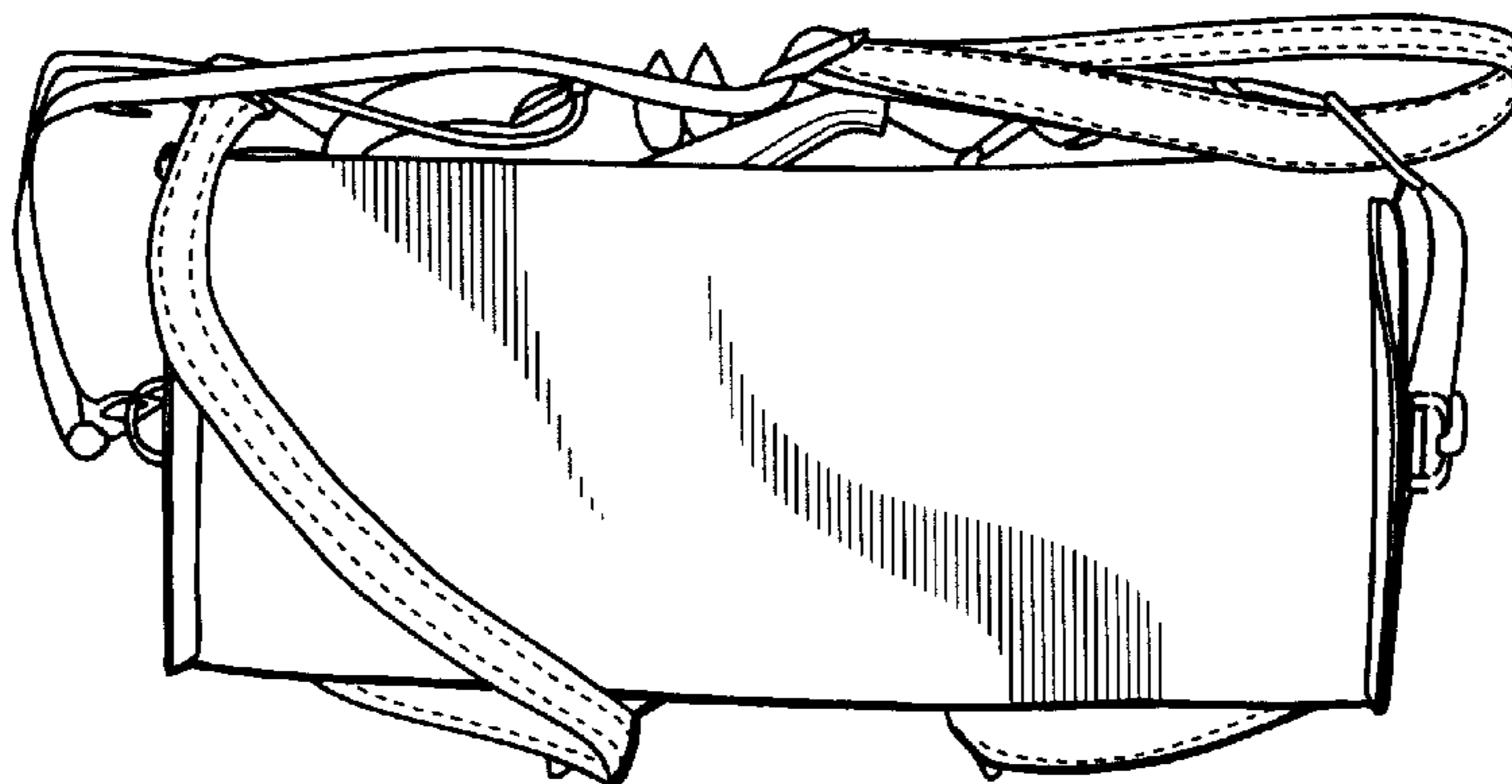
