FIG. 2 illustrates a top view thereof;

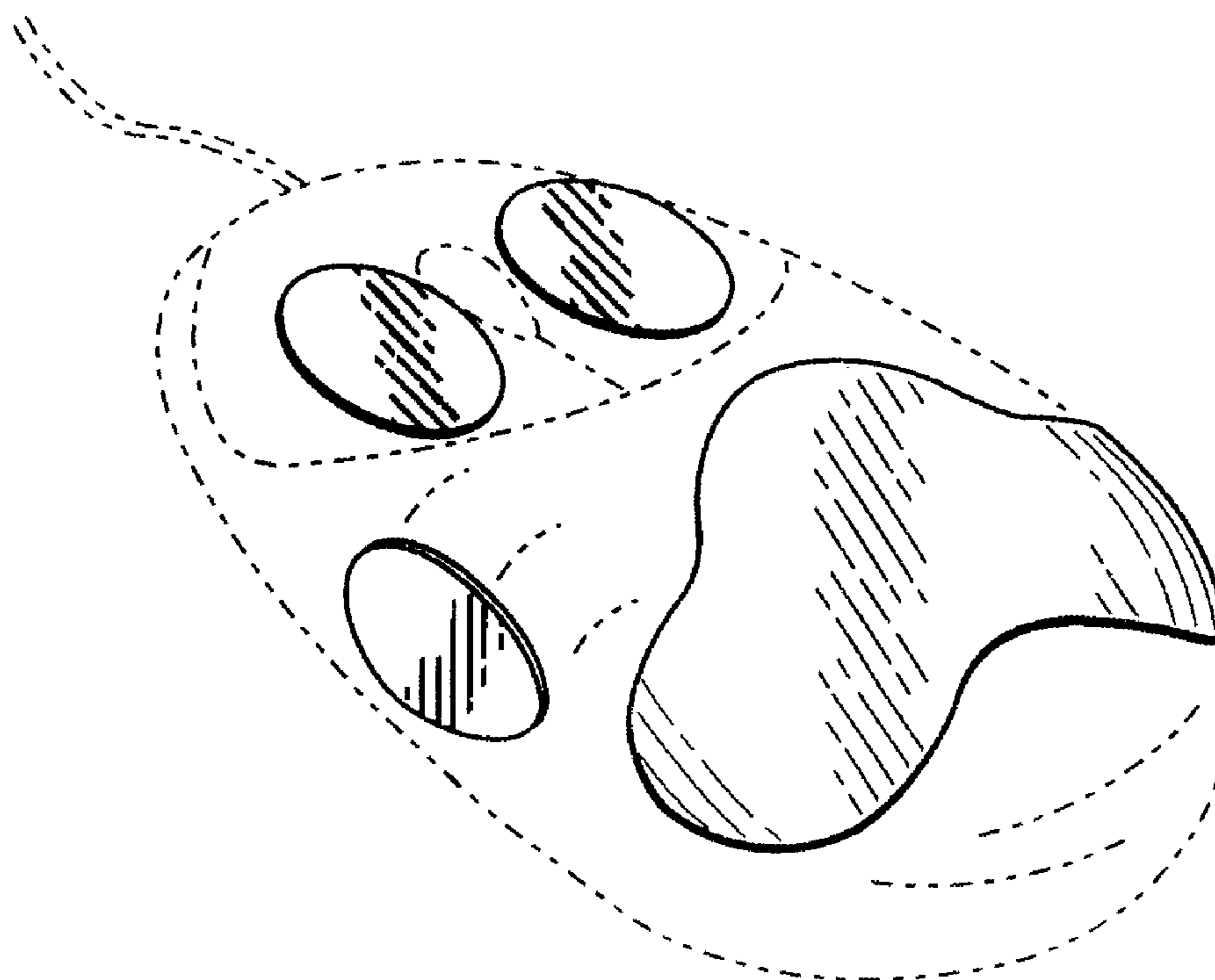
FIG. 3 illustrates a left side view thereof;

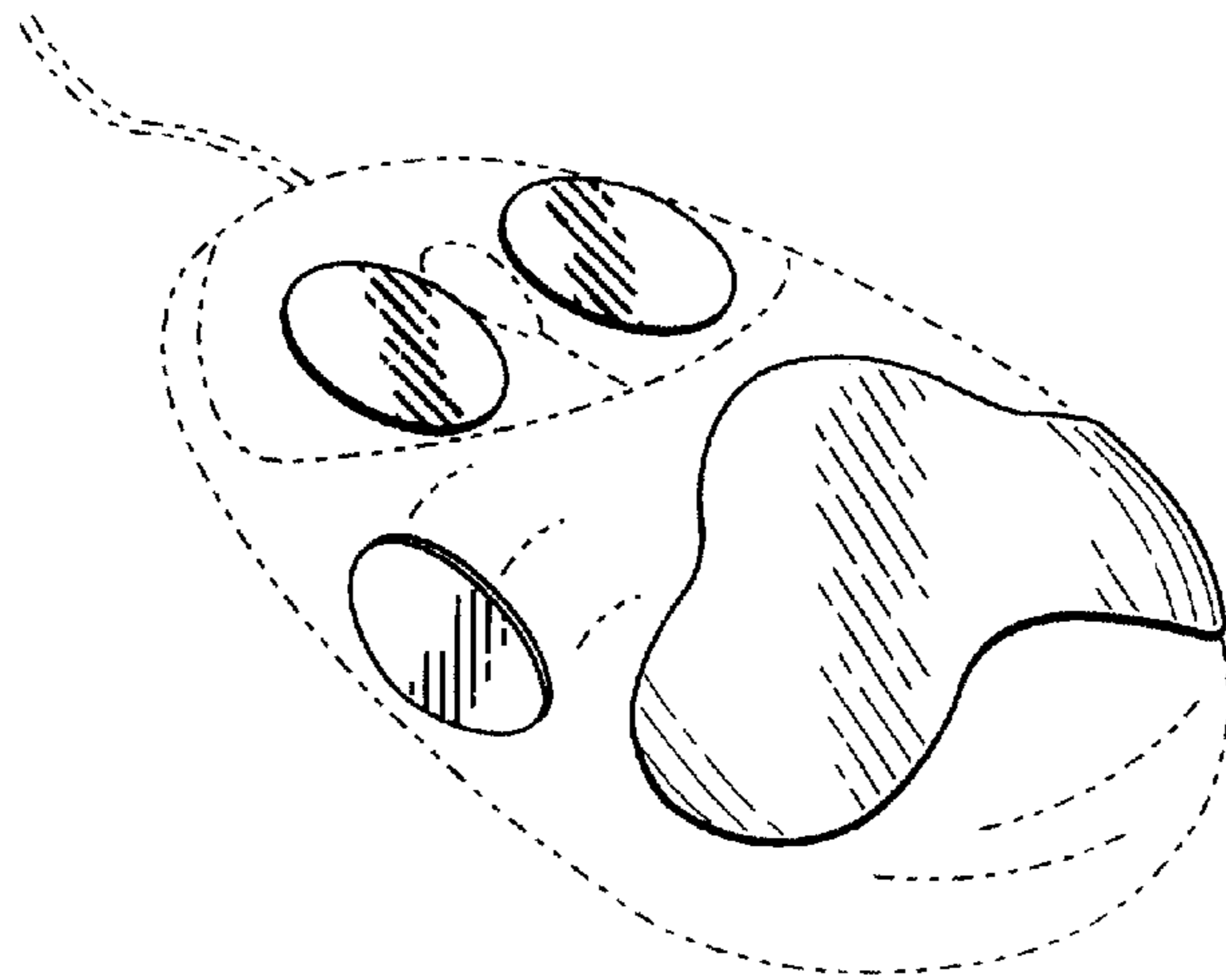

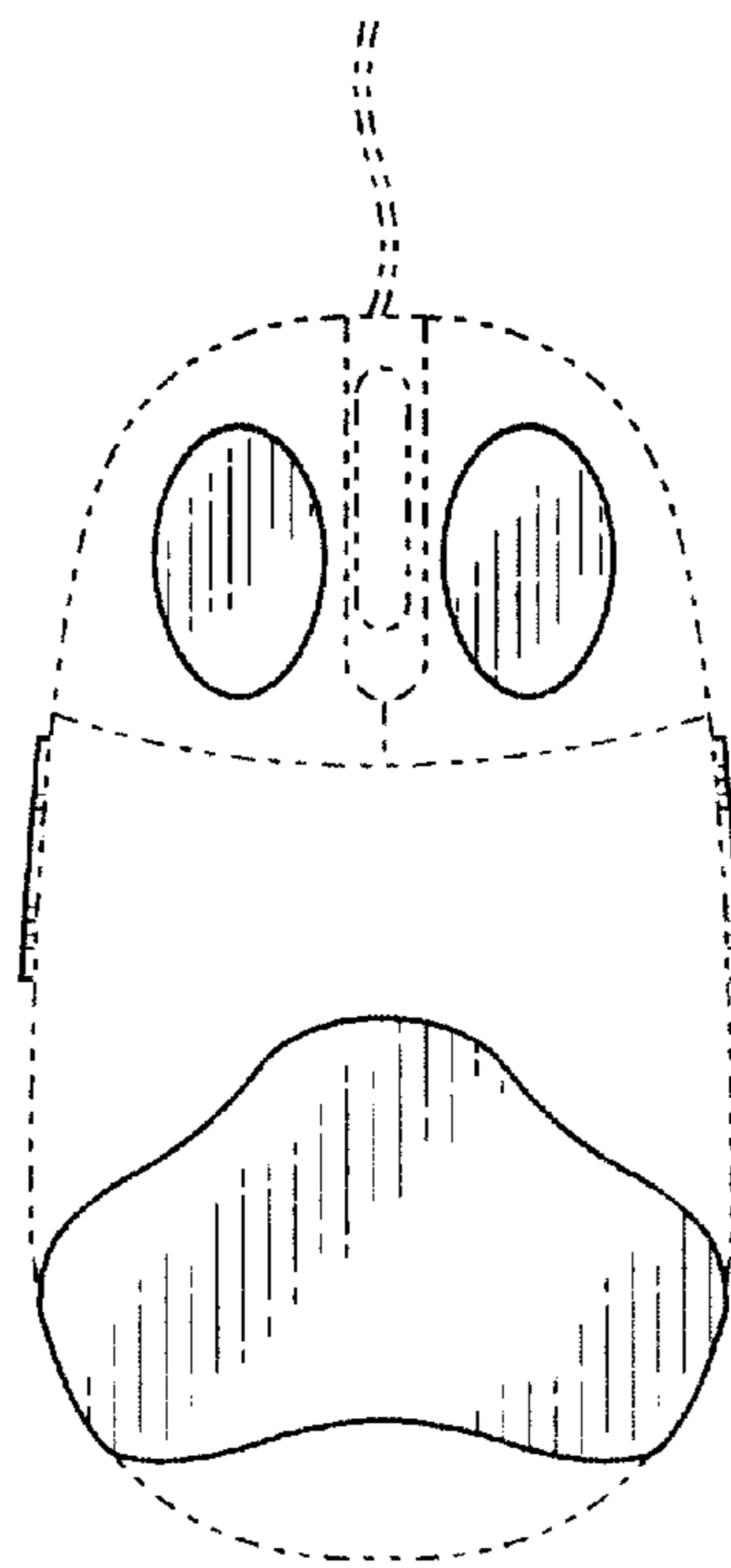

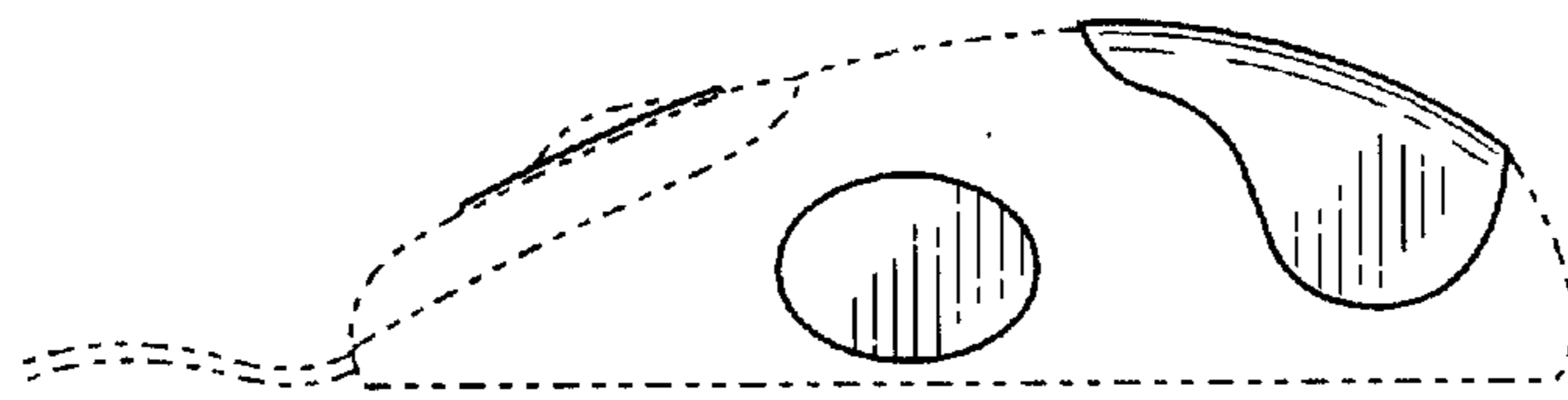

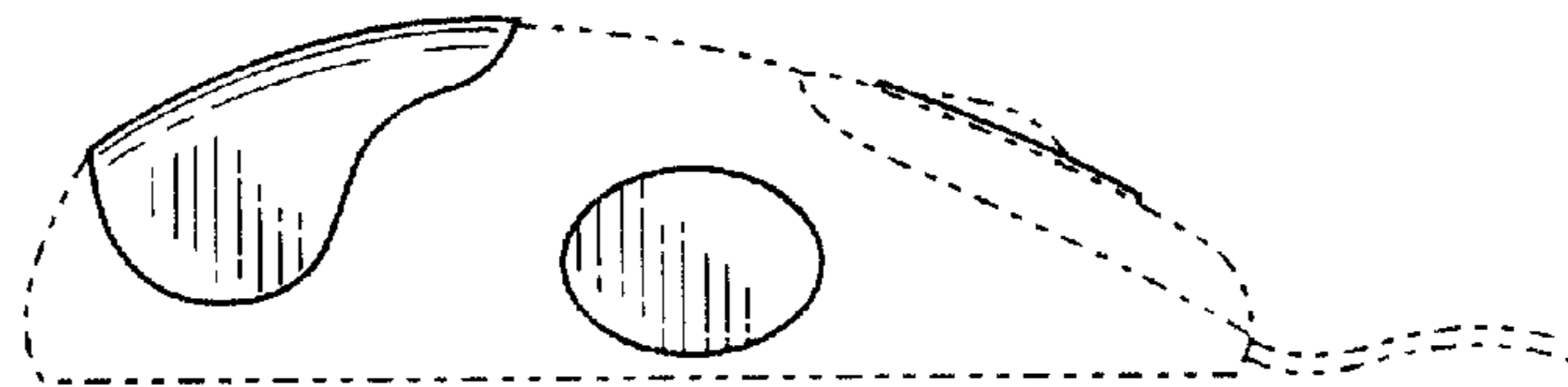

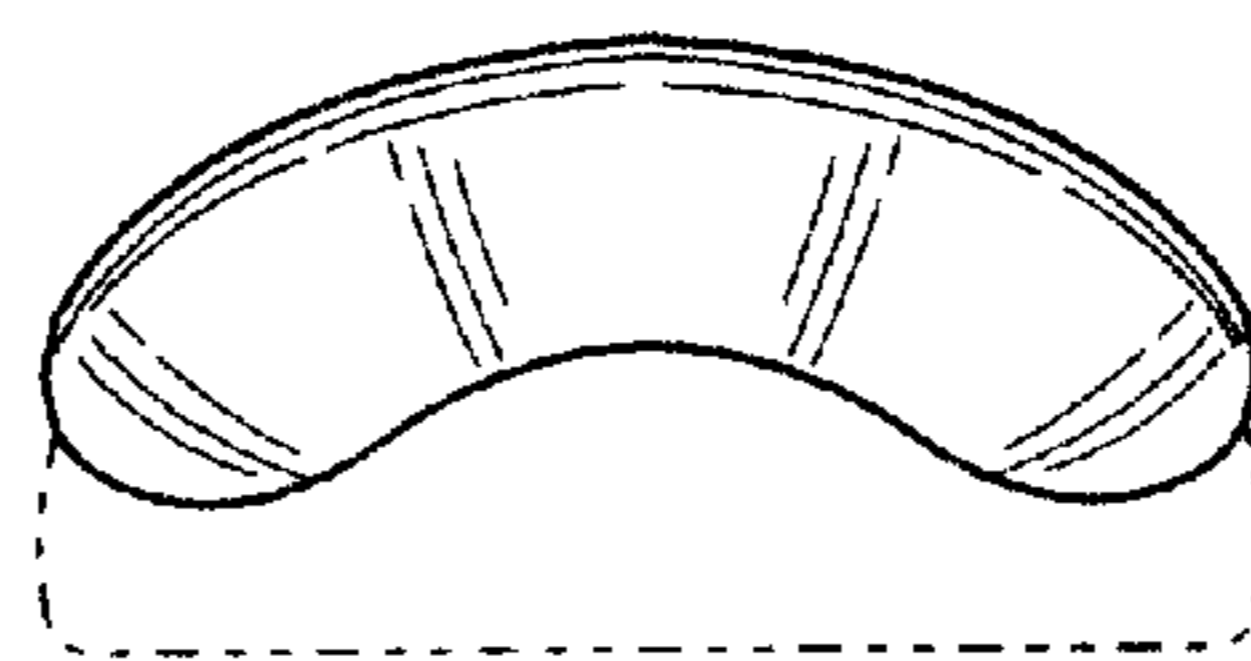

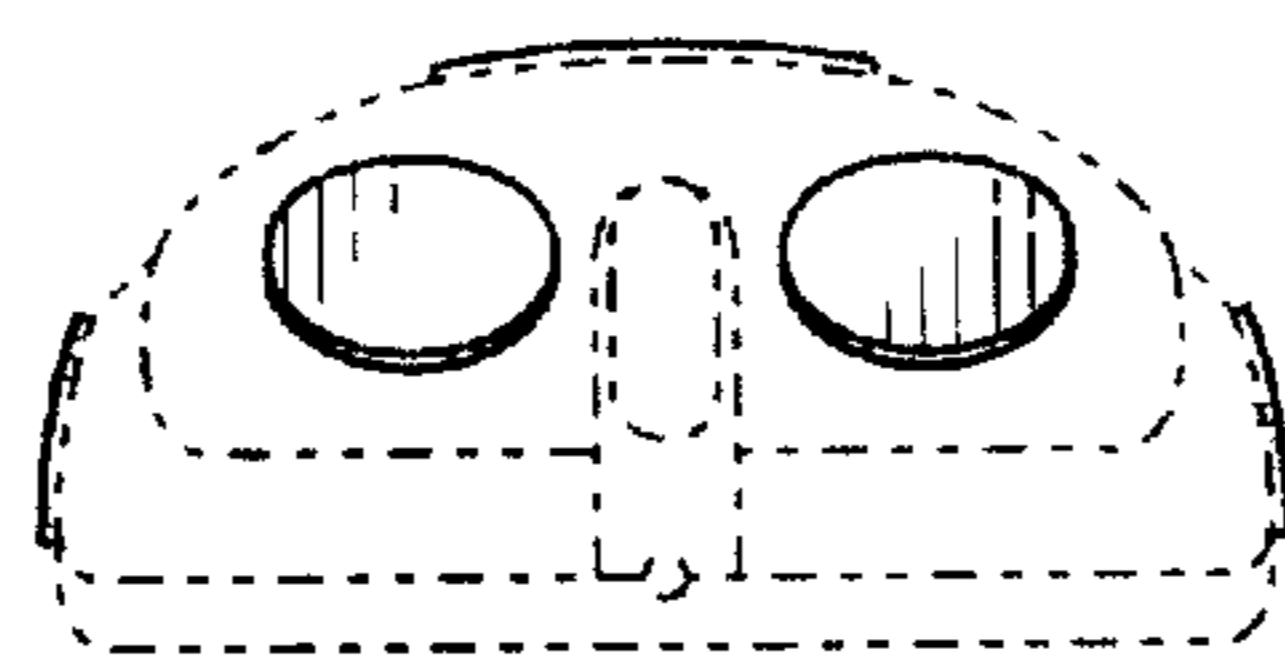
