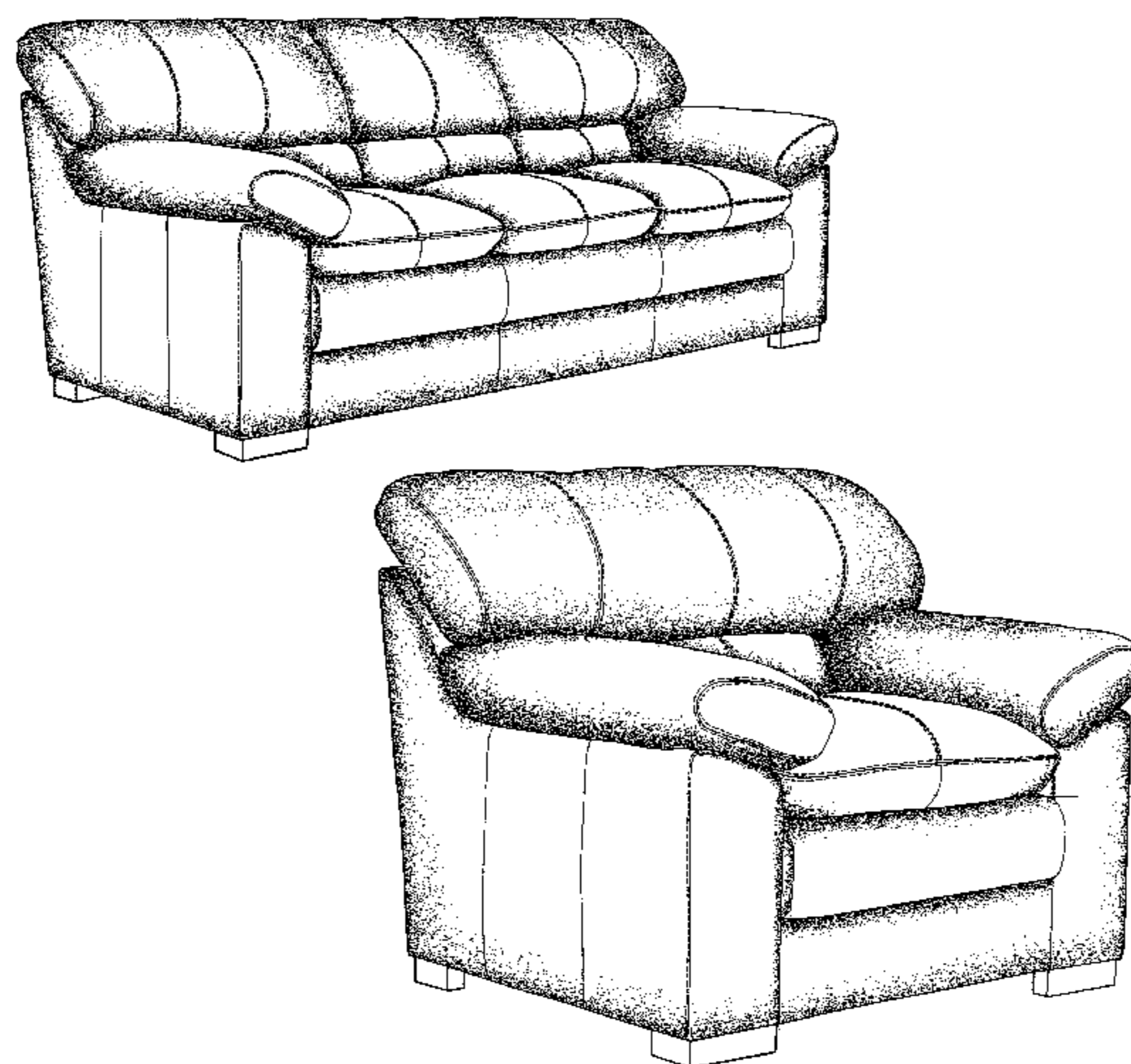
(57) **CLAIM**

I claim the ornamental design for a seat, as shown and described.

**DESCRIPTION**

FIG. 1 is a side elevation view of a first embodiment of my new seat design in the form of a sofa;  
FIG. 2 is a front perspective view thereof;  
FIG. 3 is an opposite side elevation view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a front elevation view of a second embodiment of the new seat design in the form of a chair;  
FIG. 8 is a rear elevation view thereof;  
FIG. 9 is a top plan view thereof;  
FIG. 10 is a side elevation view thereof;  
FIG. 11 is a front perspective view thereof; and,  
FIG. 12 is an opposite side elevation view thereof.

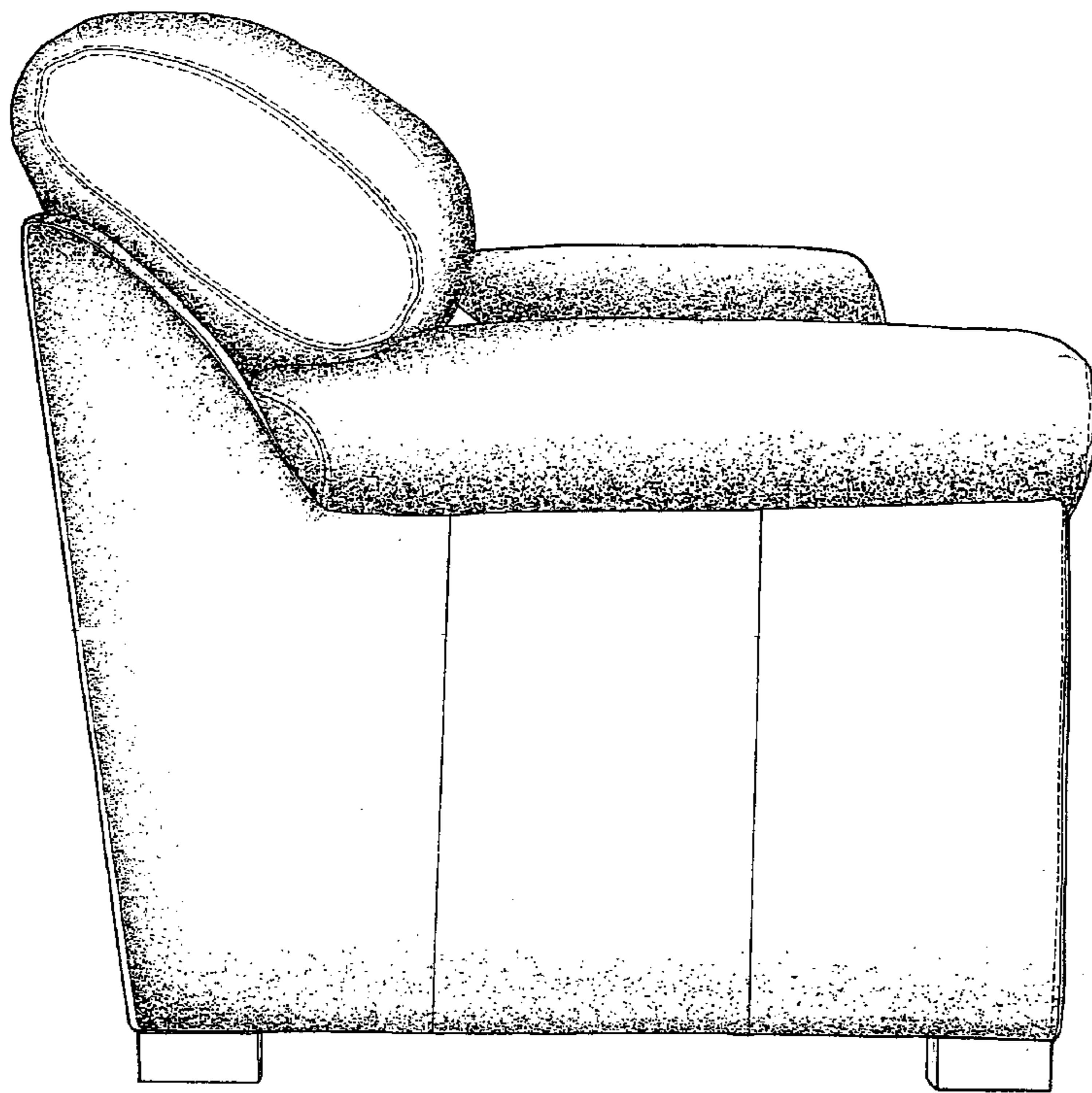

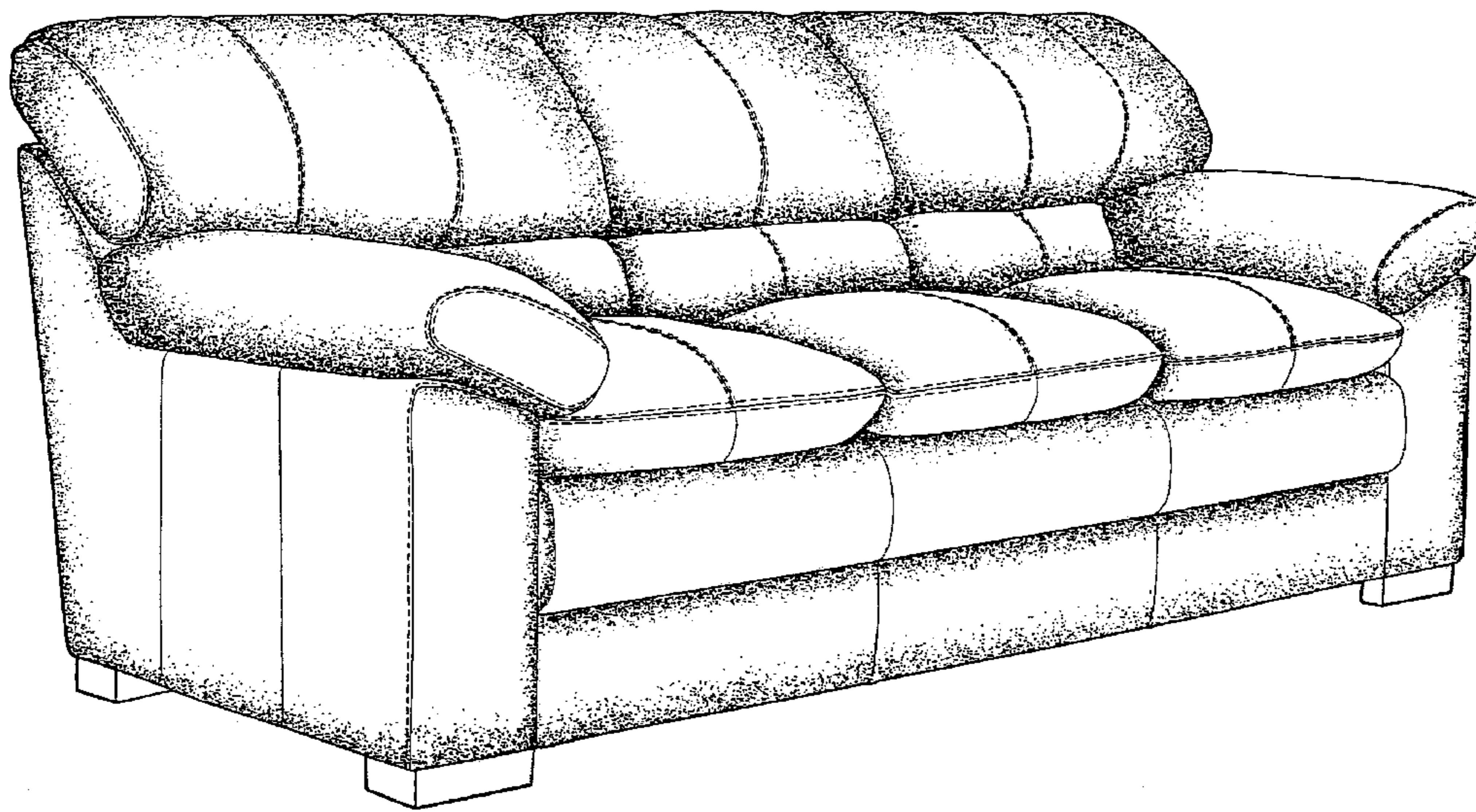

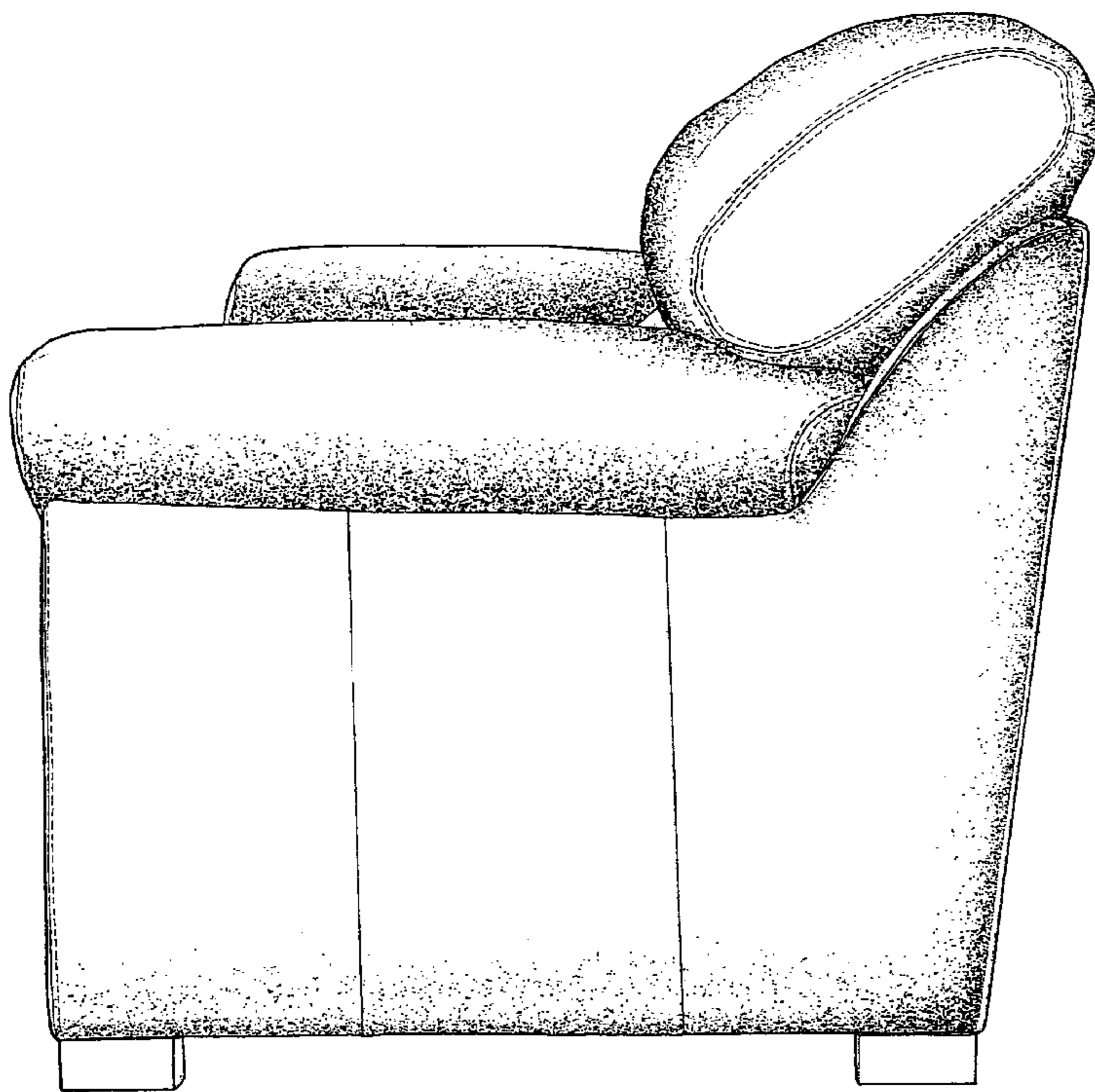

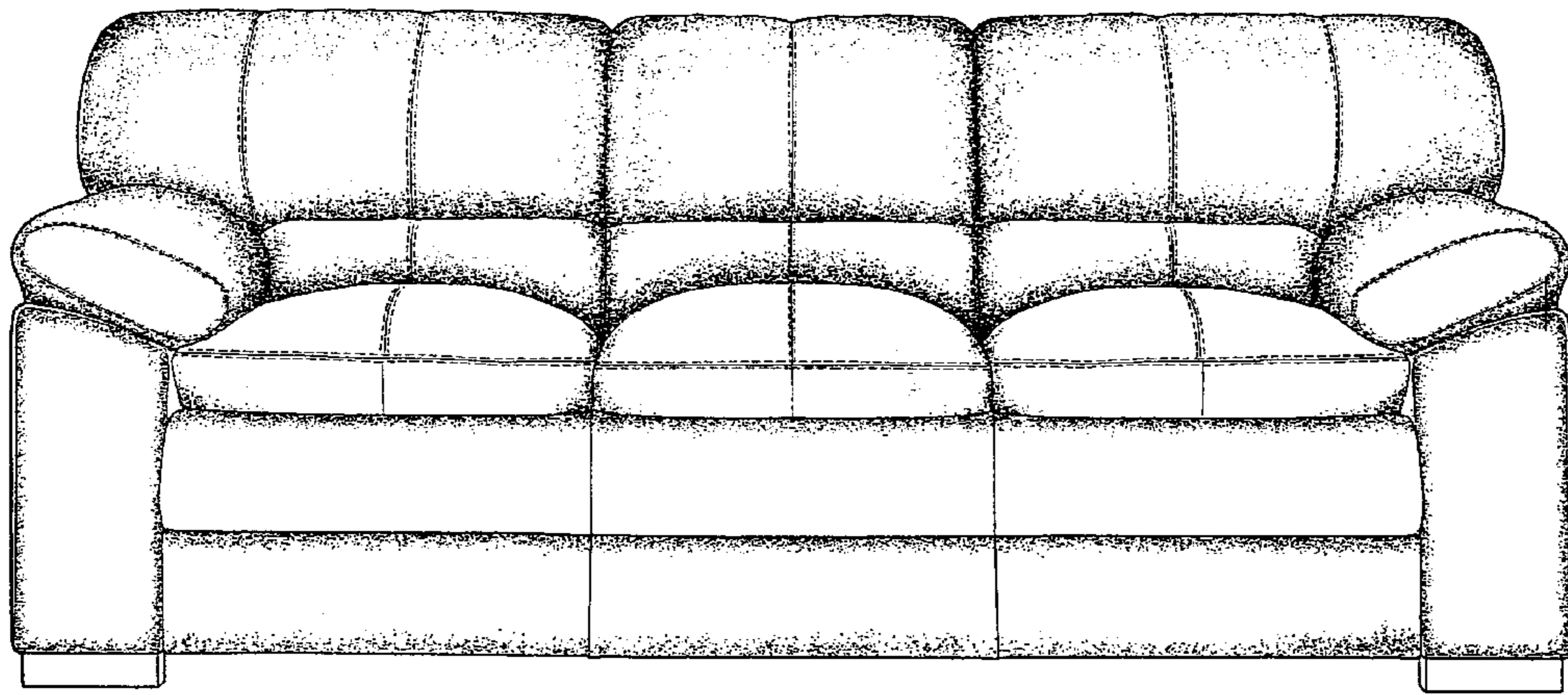

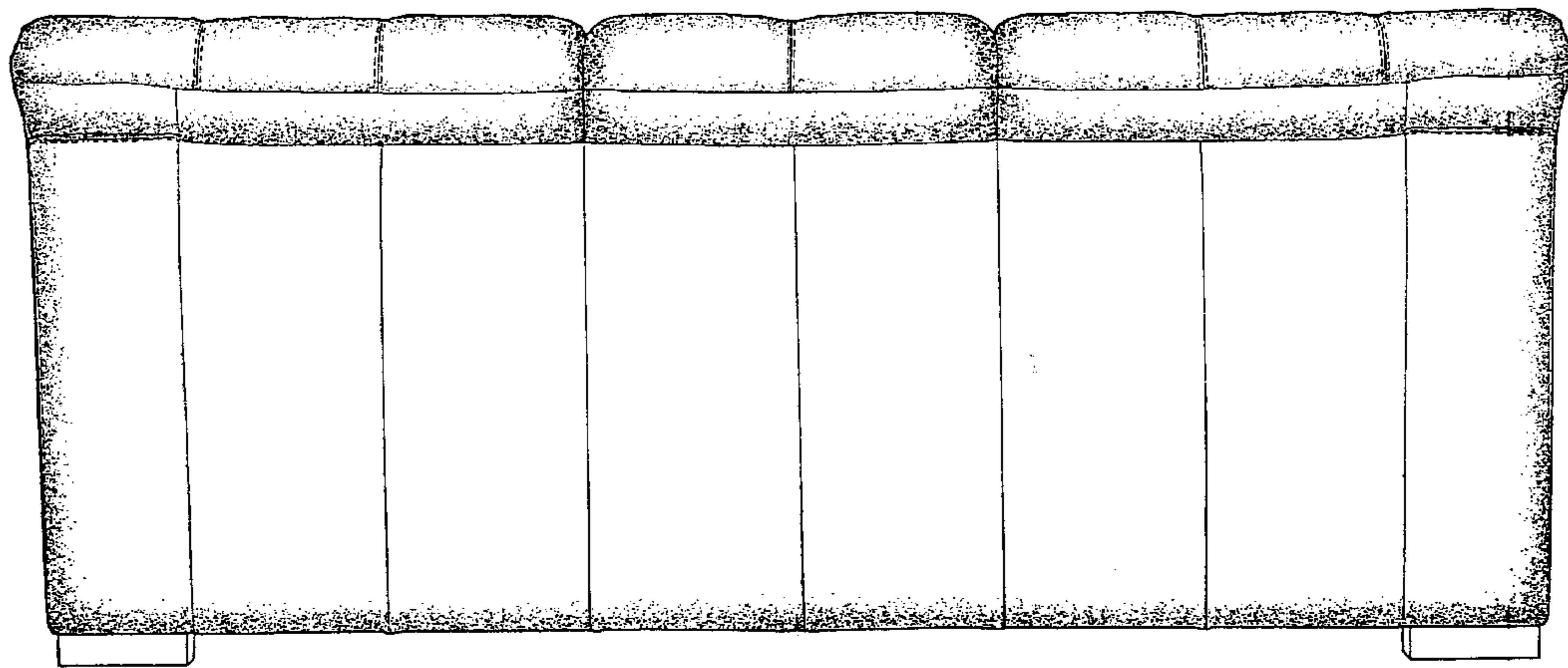

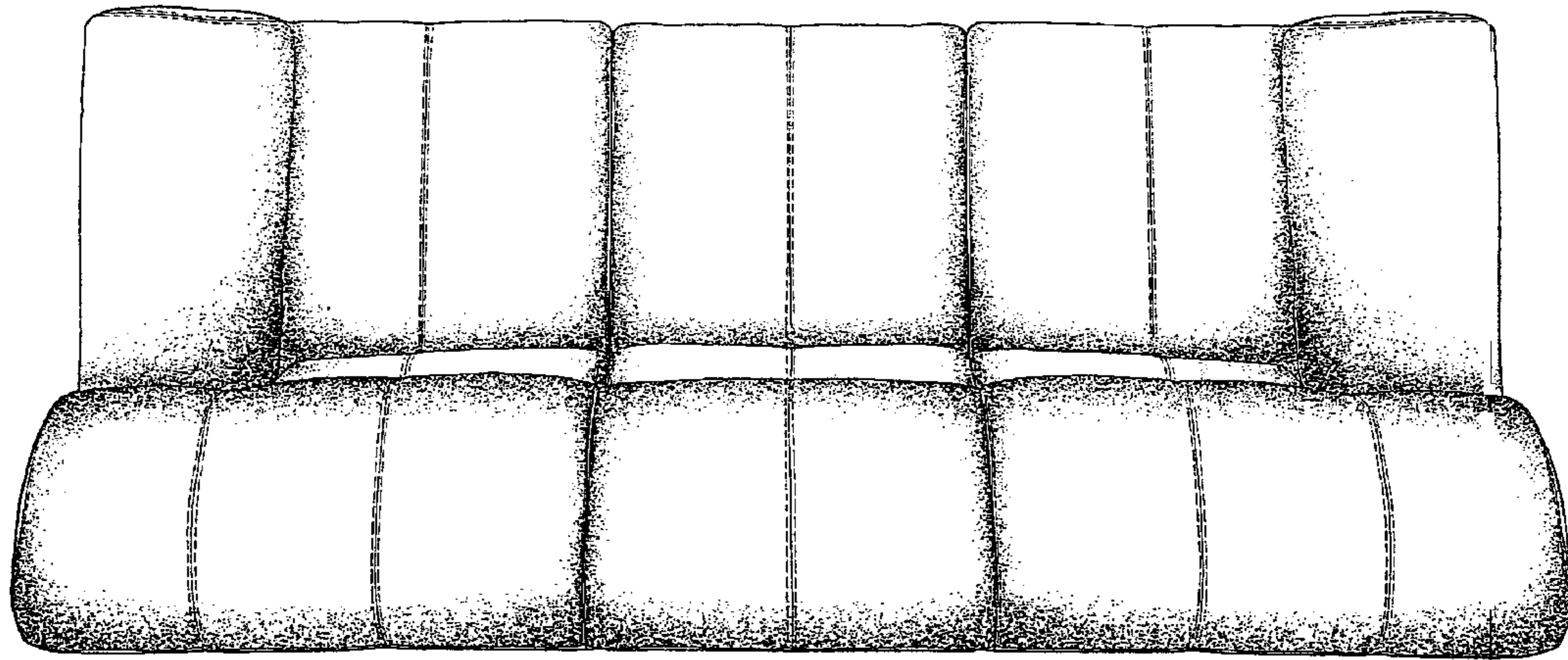

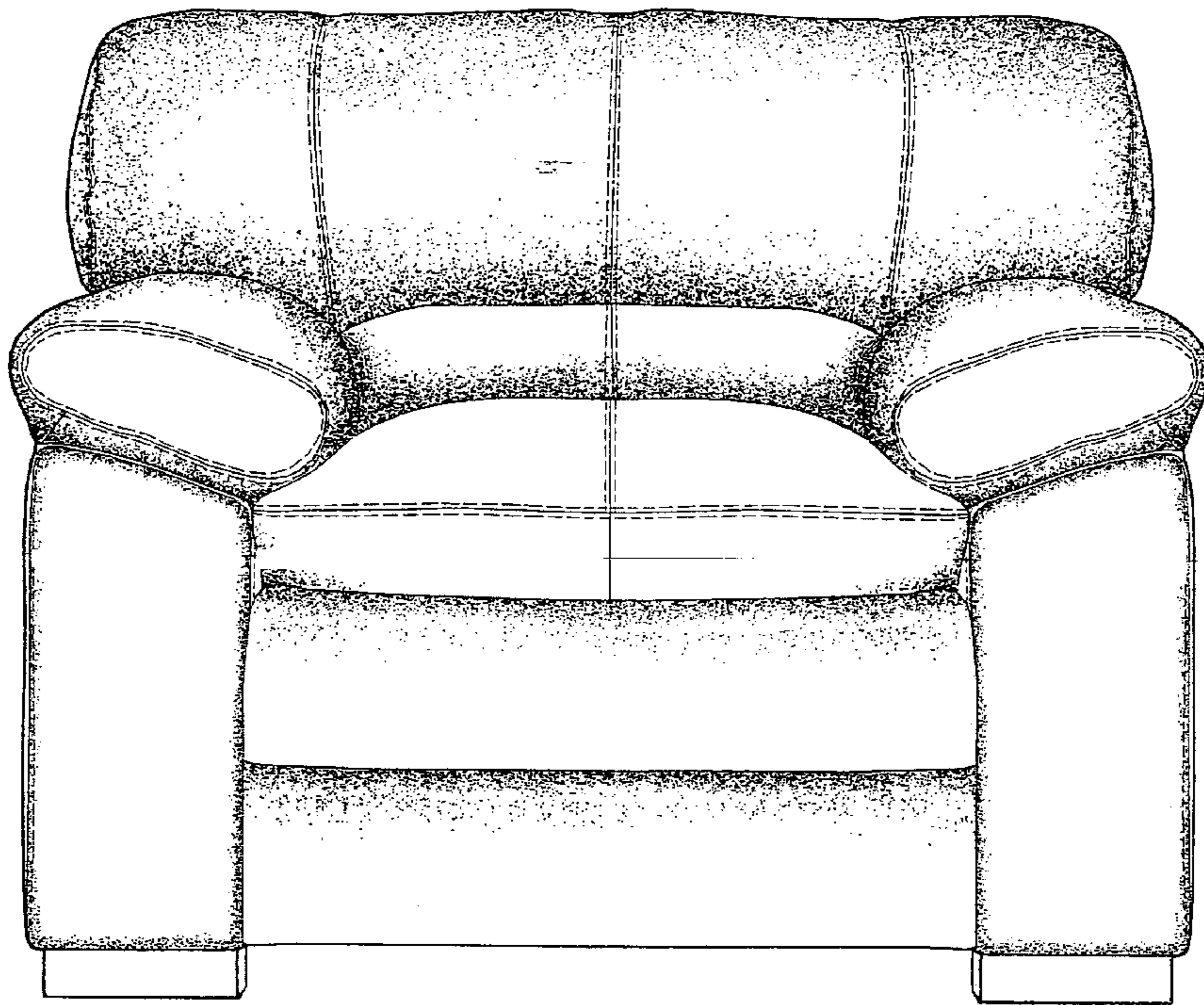

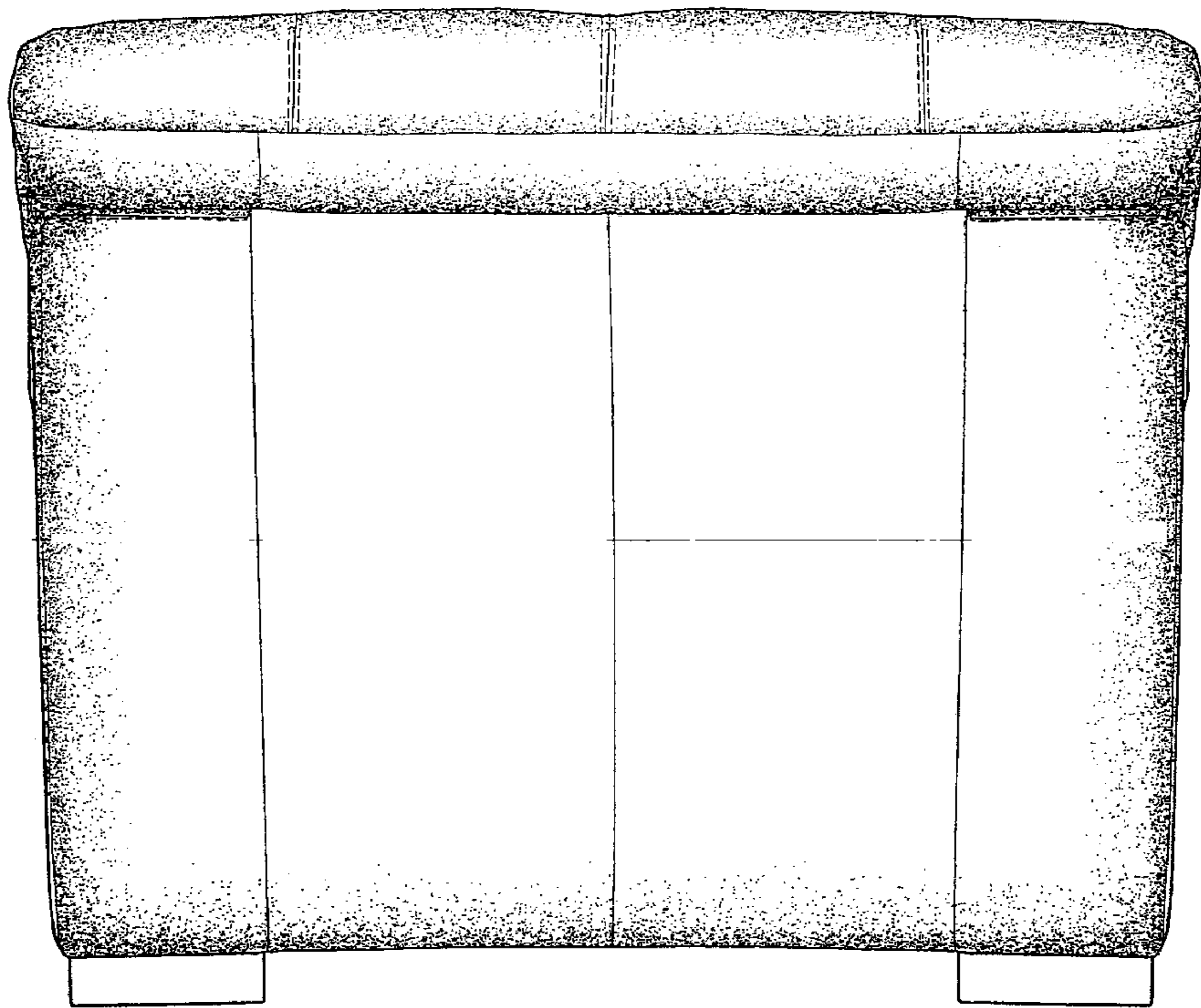

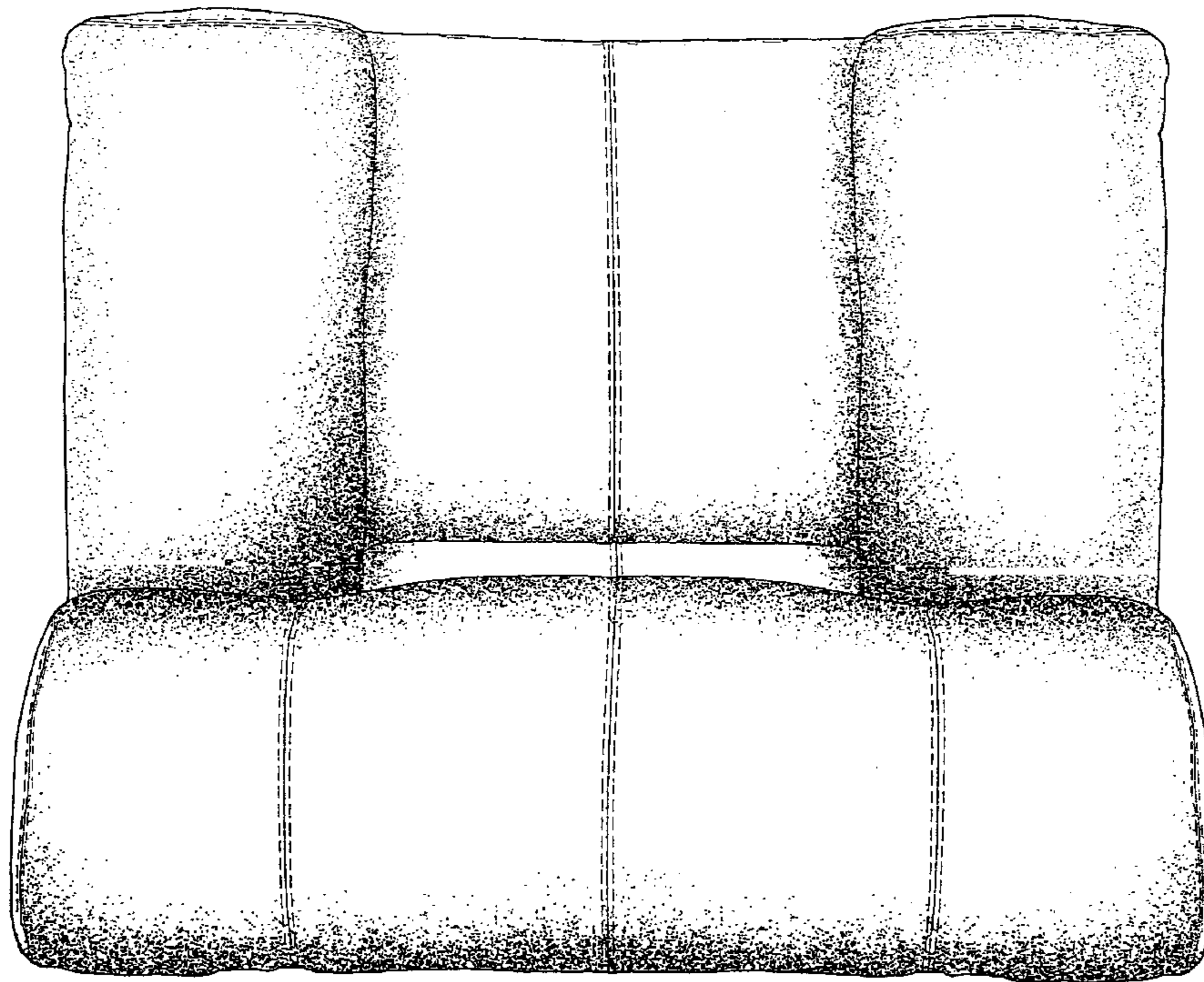

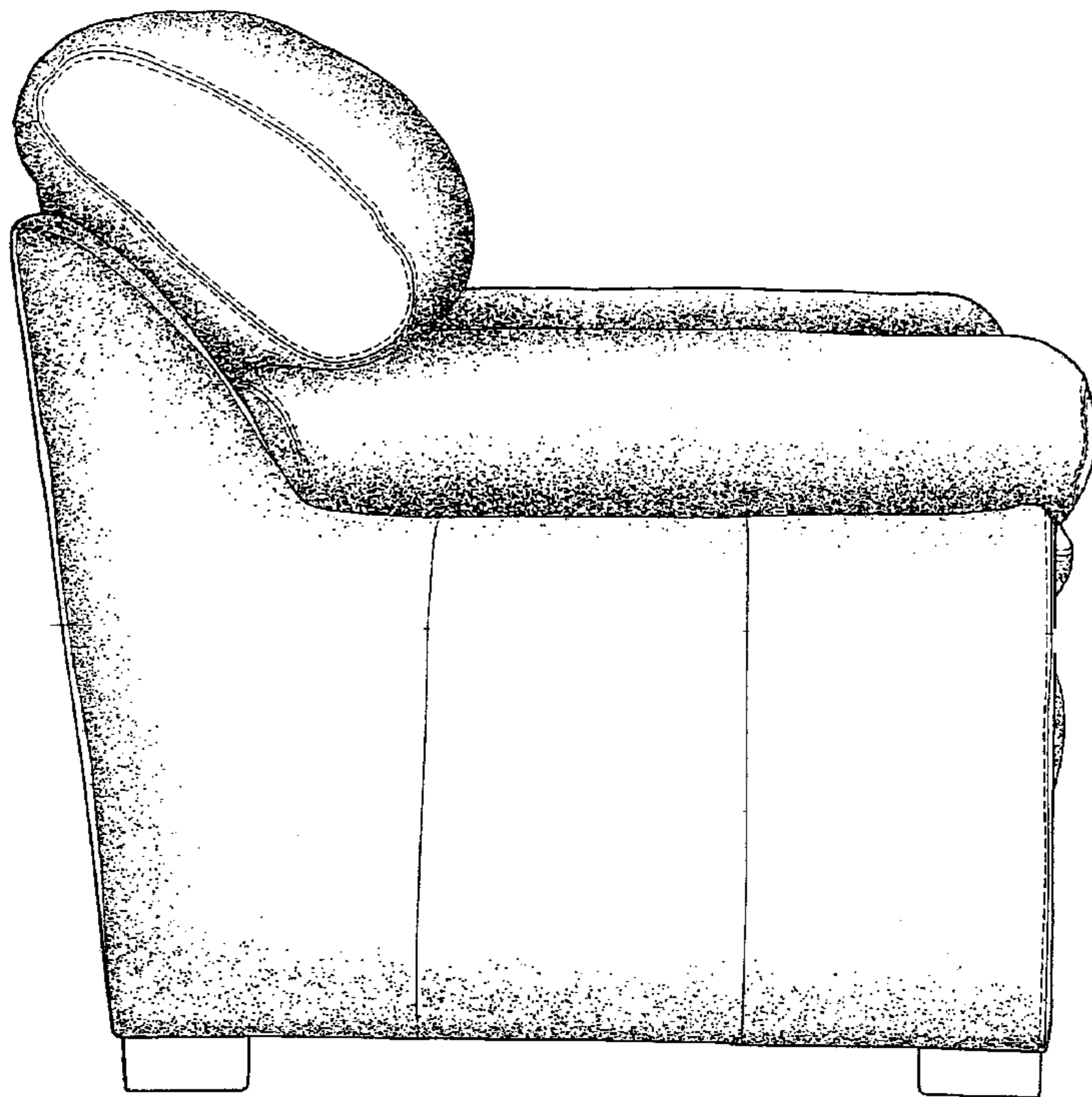

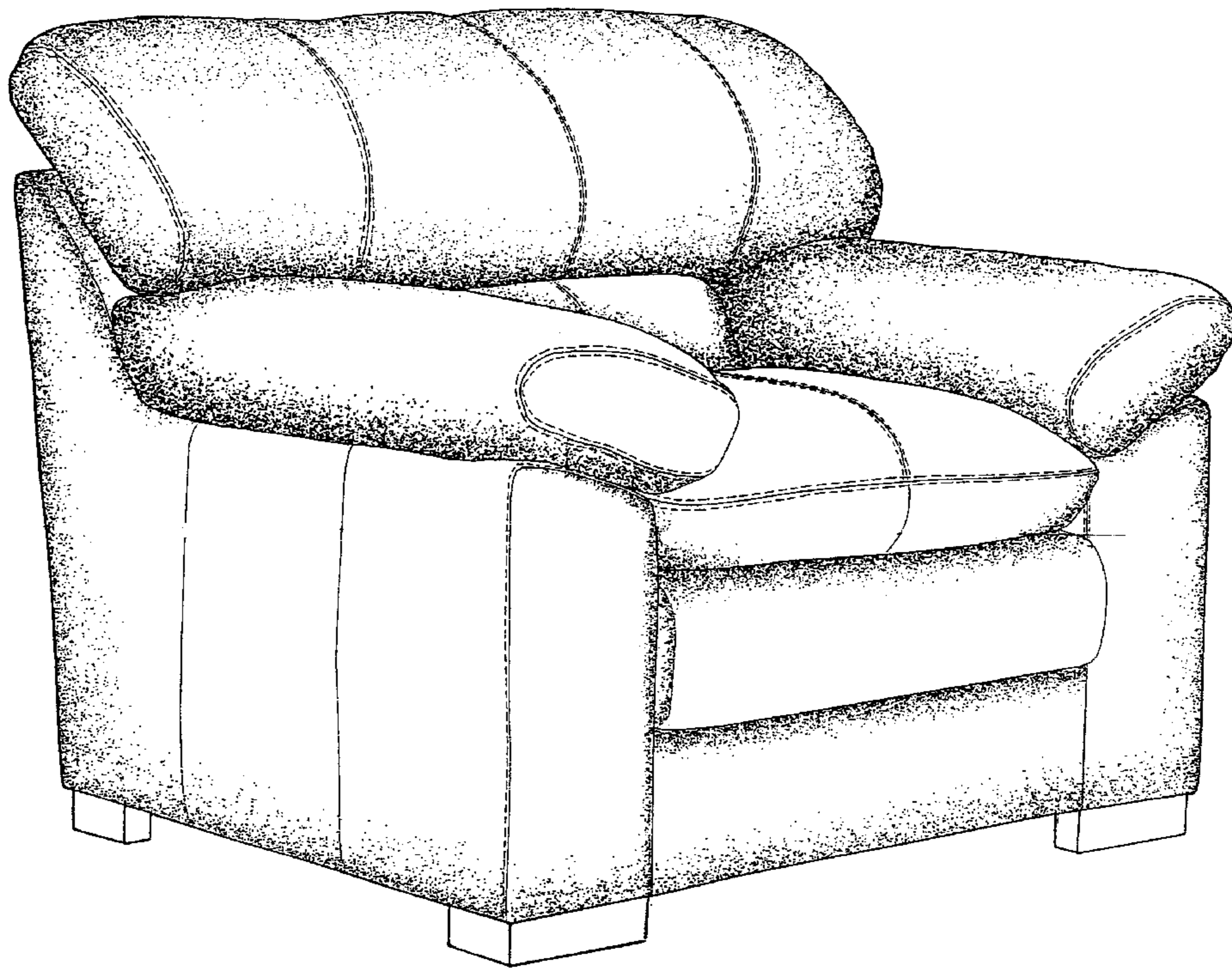

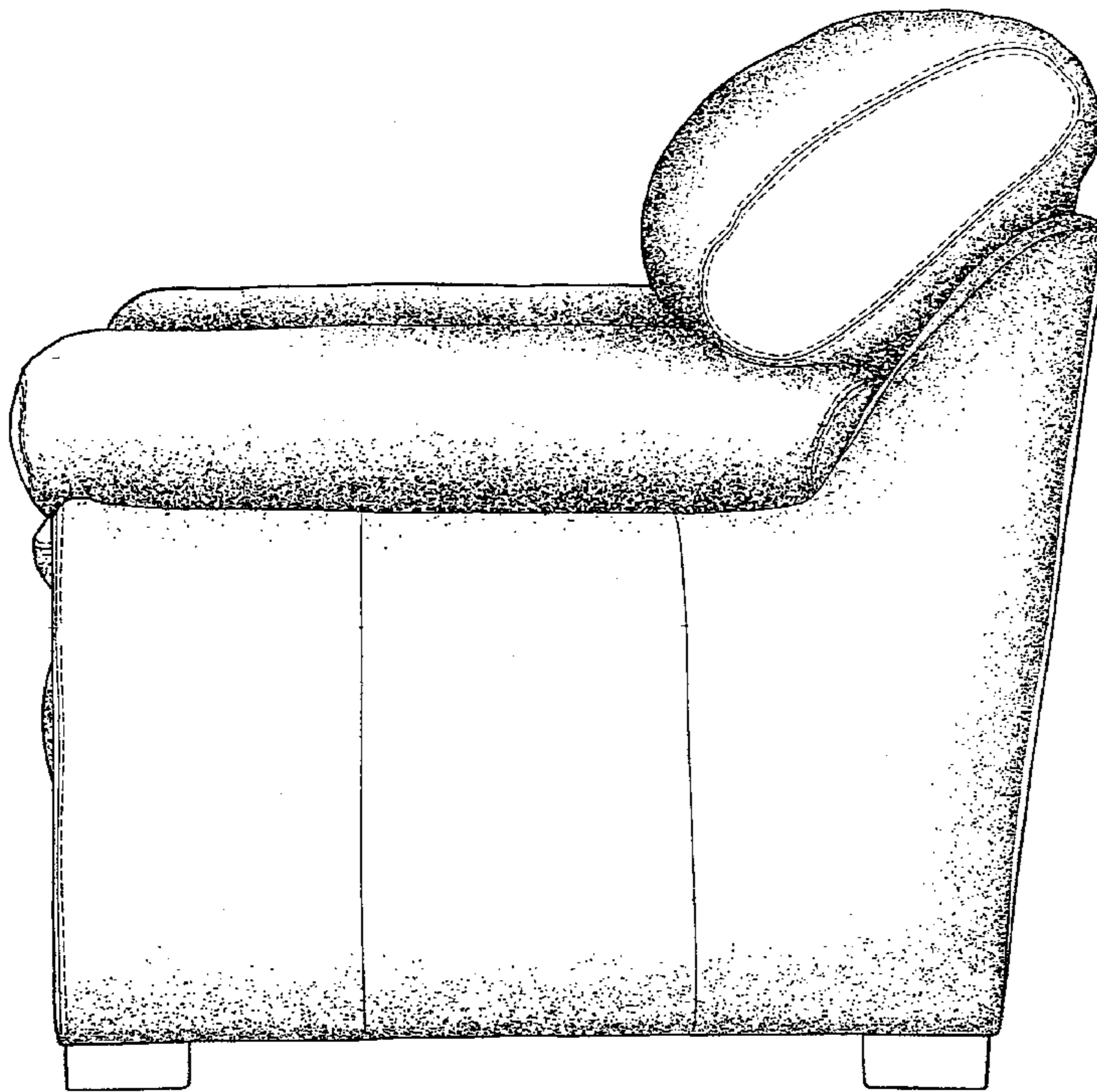
