The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of a seat showing my new design;

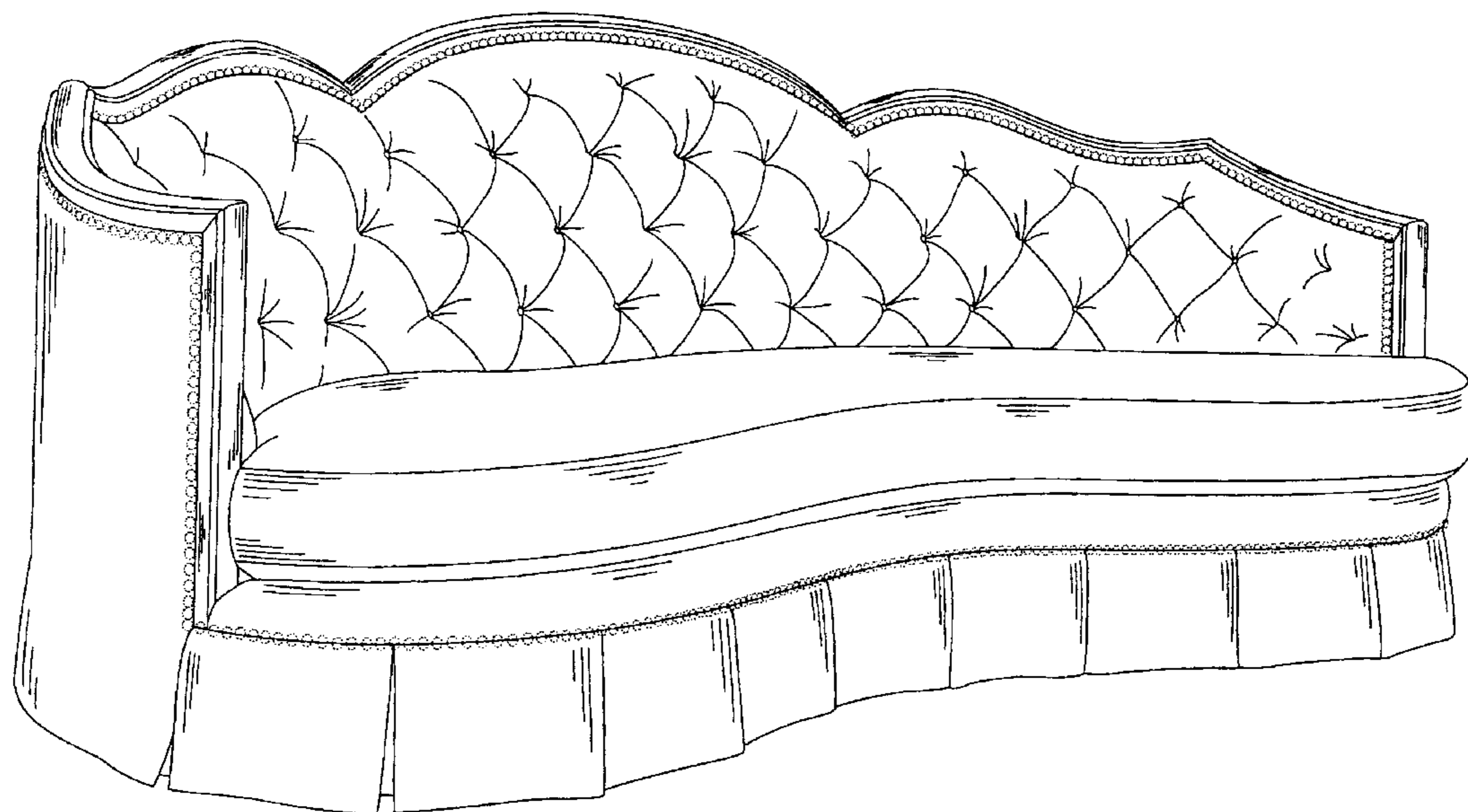
FIG. 2 is a front elevational view thereof;

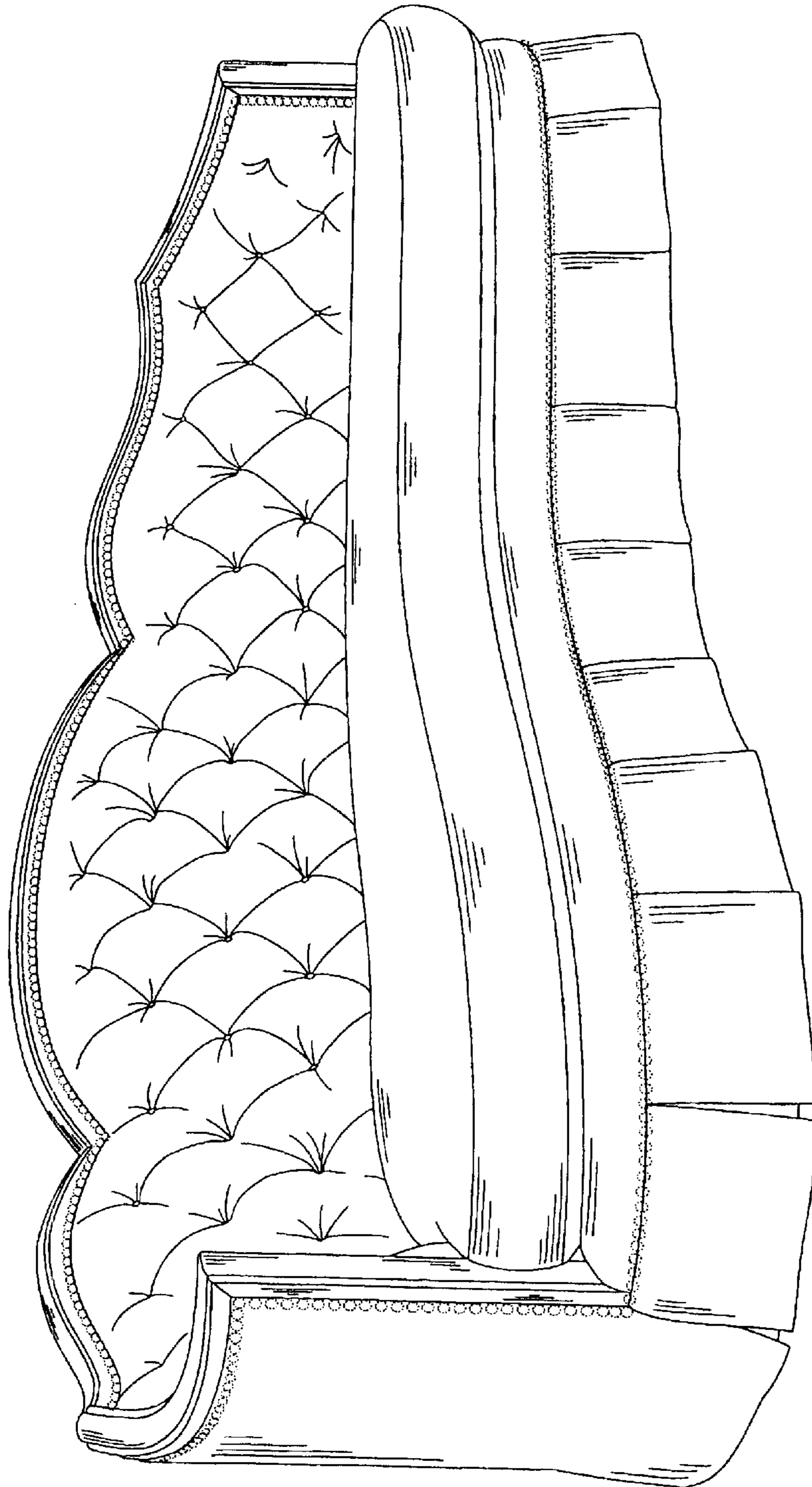

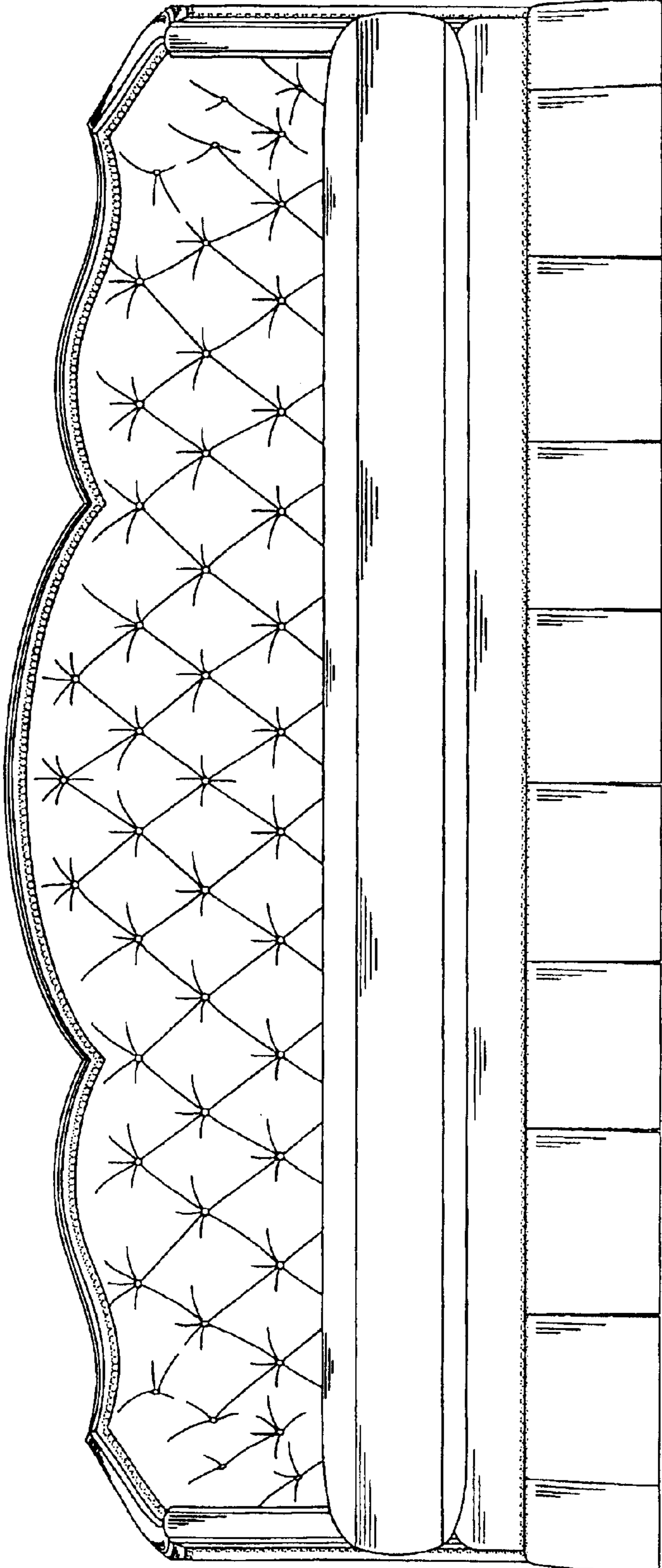

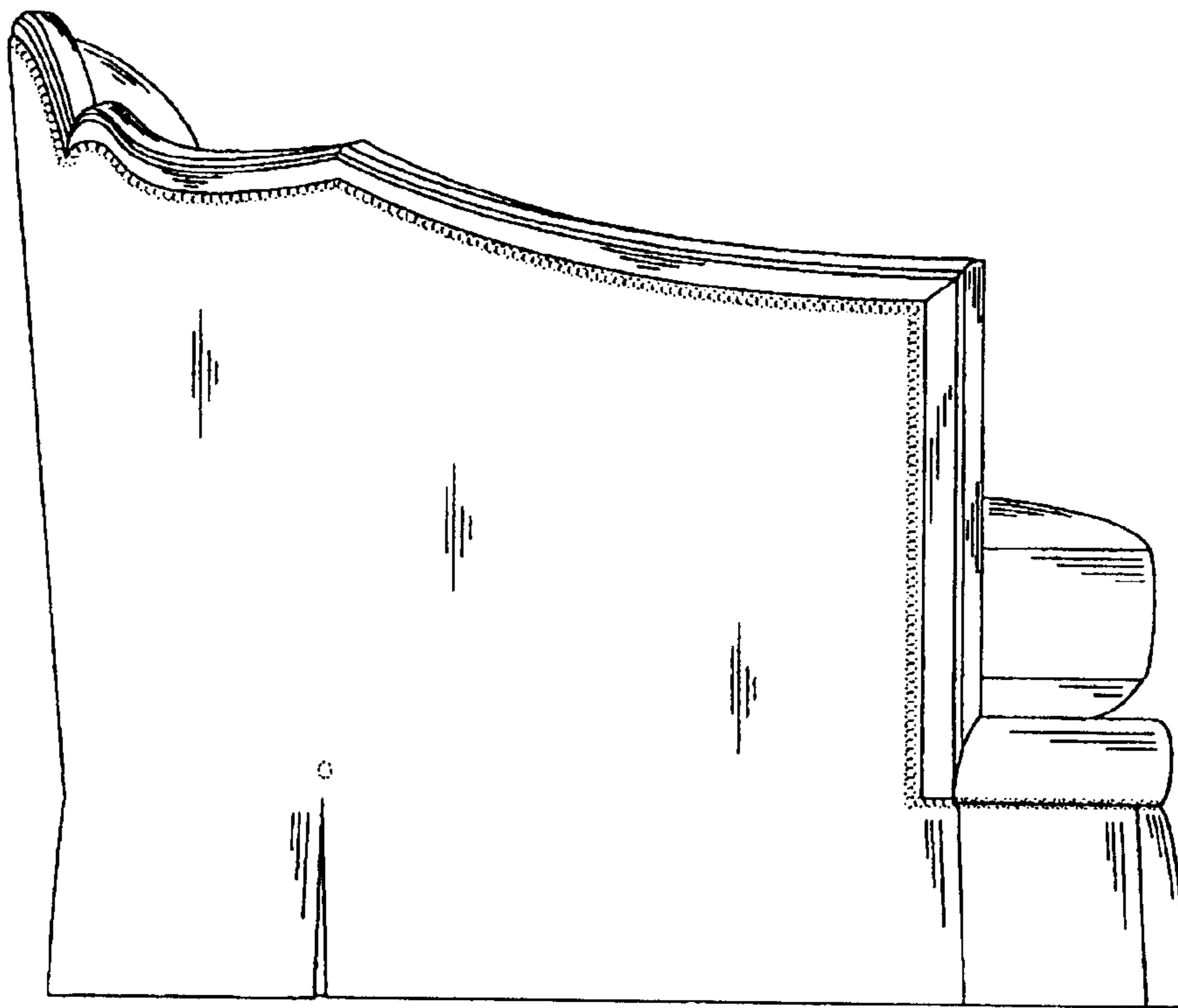

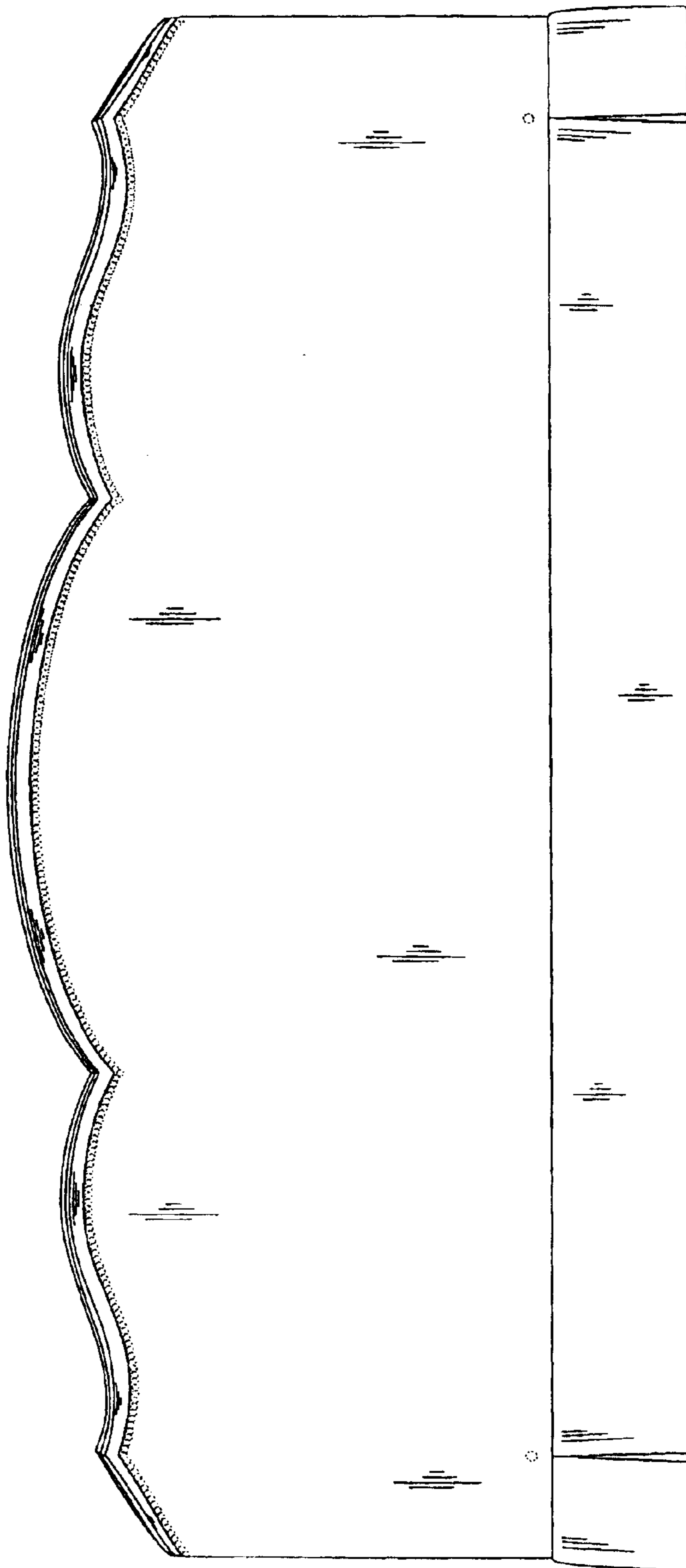
