The ornamental design for an over cabinet towel bar, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the over cabinet towel bar according to the invention;

FIG. 2 is a top view of the over cabinet towel bar as shown in FIG. 1;

FIG. 3 is a front view of the over cabinet towel bar as shown in FIG. 1;


FIG. 4 is a side view of the over cabinet towel bar as shown in FIG. 1;












