(57) **CLAIM**

The ornamental design for a “toilet base rug cover”, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the toilet base rug cover shown in condition of use, fastened around the base of a toilet, which has been depicted in phantom lines;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a top view thereof;

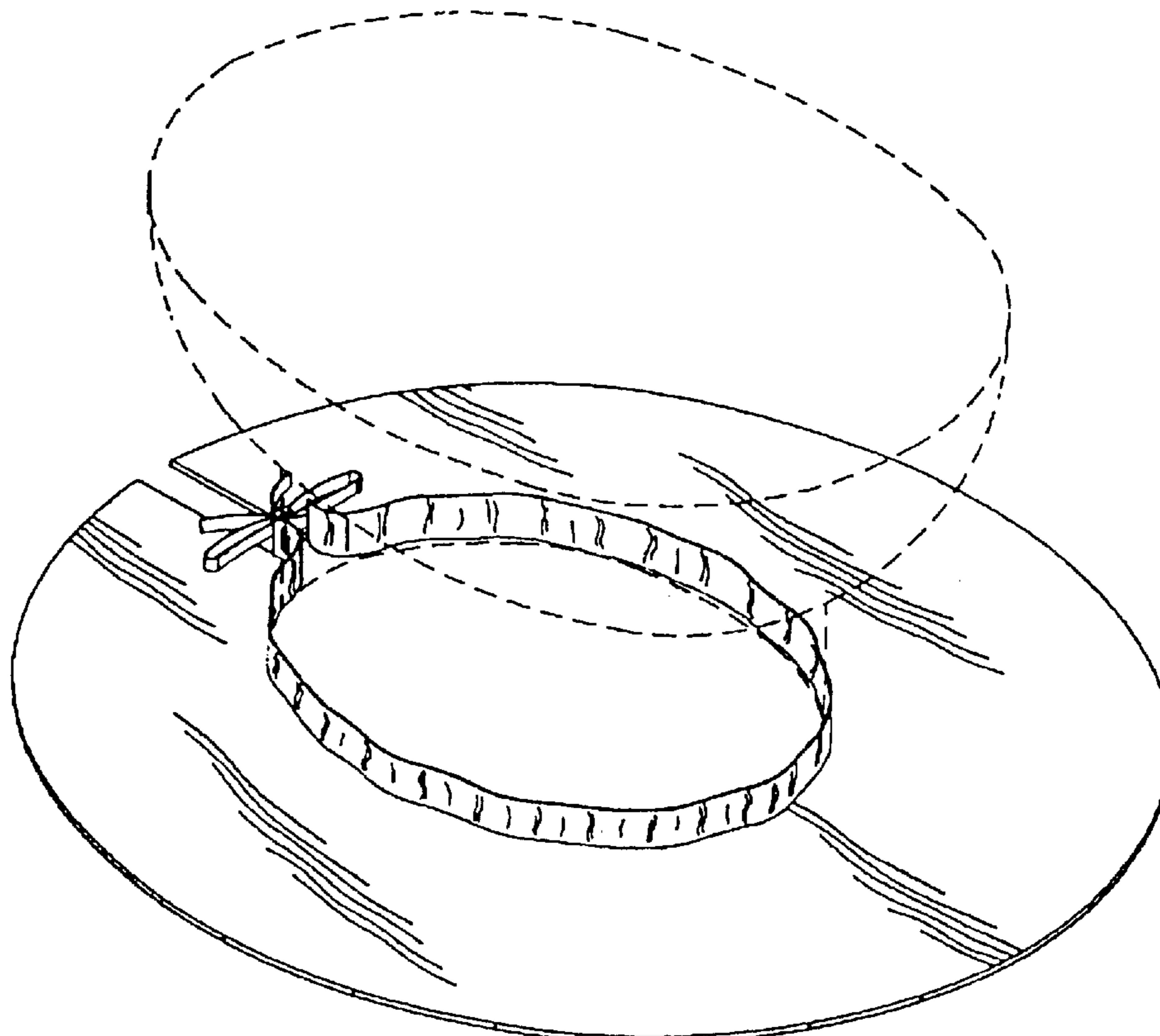
FIG. 4 is a right side view thereof, the left side view of the toilet base rug cover being a mirror image of the right side view;

FIG. 5 is a front view thereof; and,

FIG. 6 is a rear view thereof.

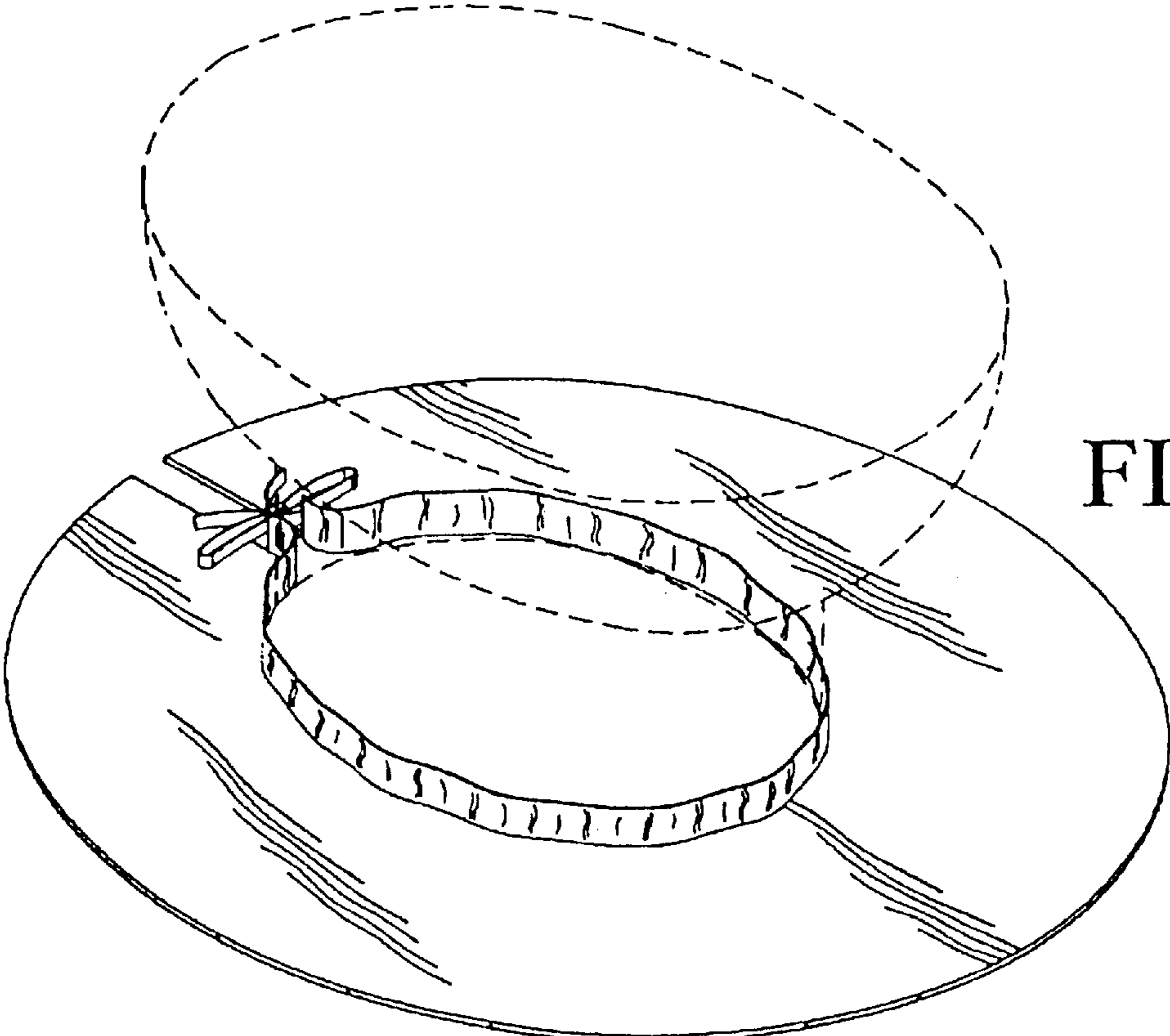

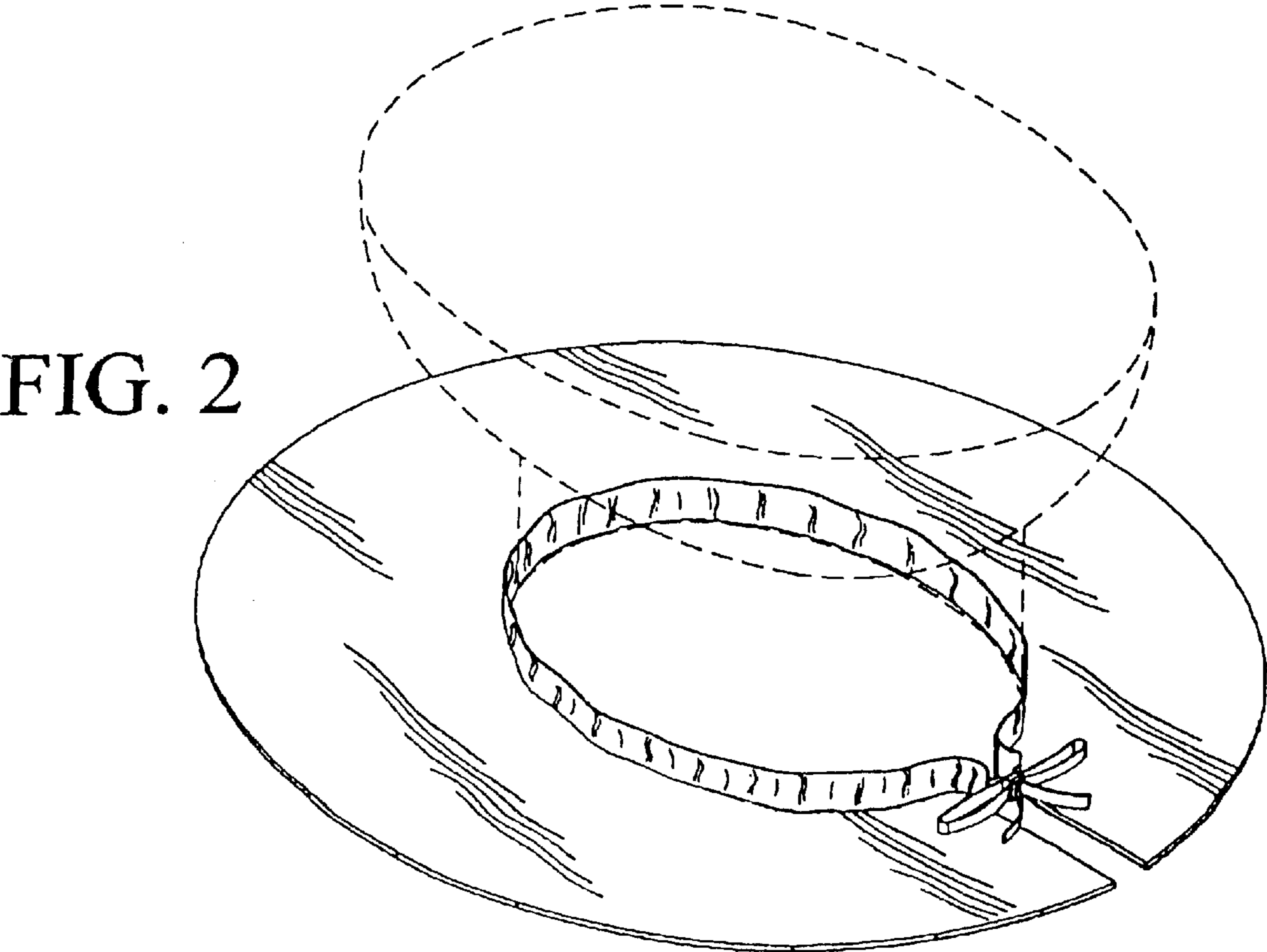

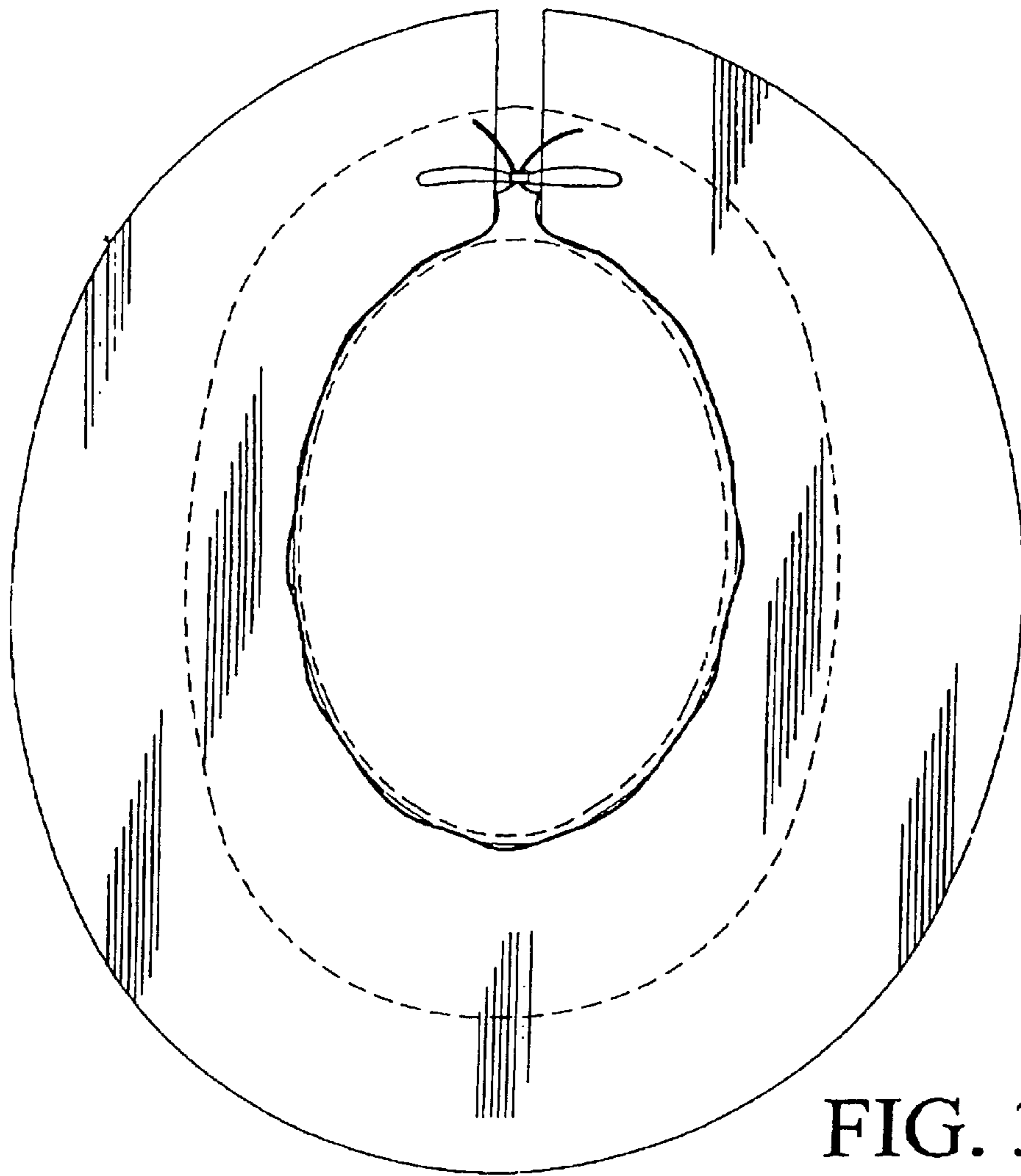

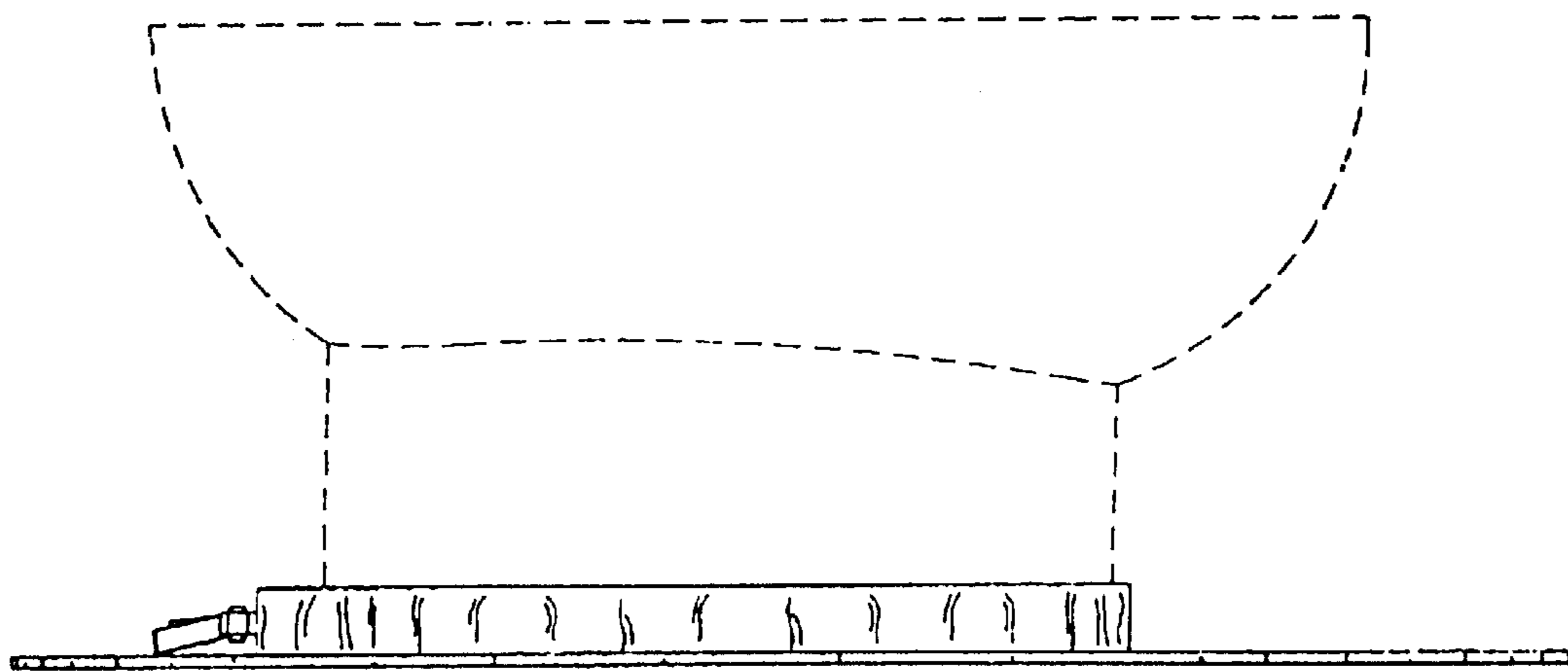

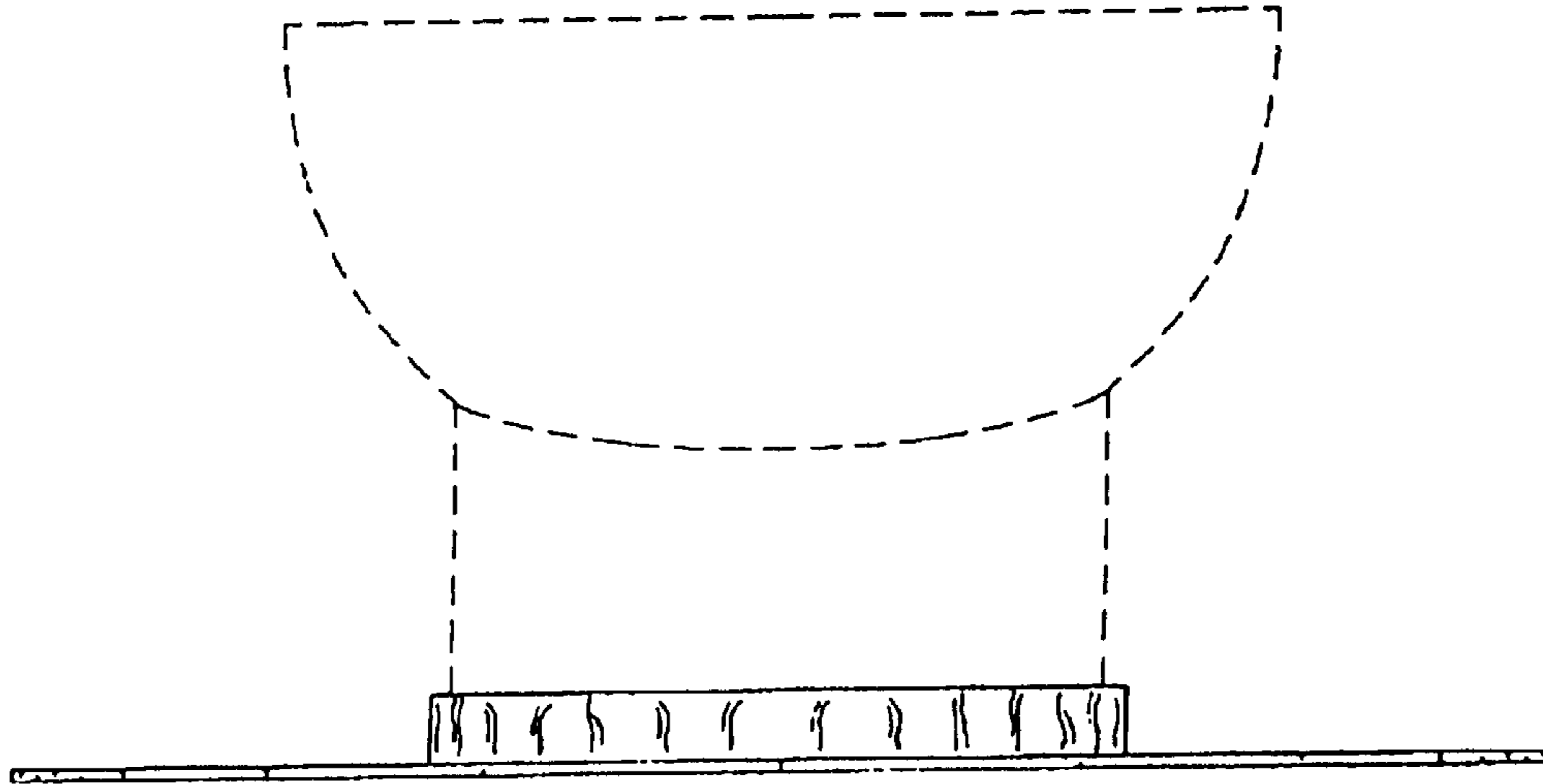

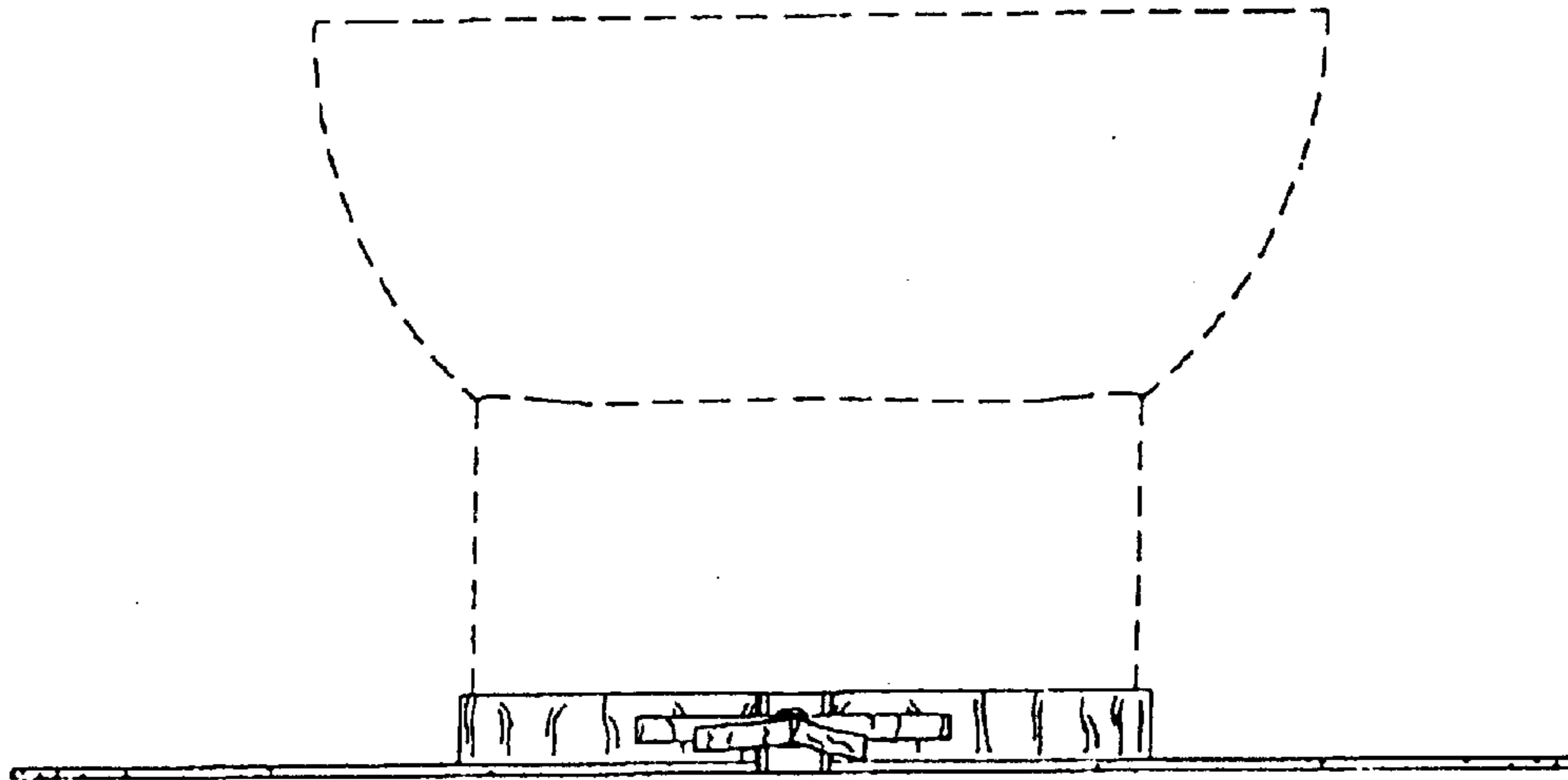
