(57) **CLAIM**

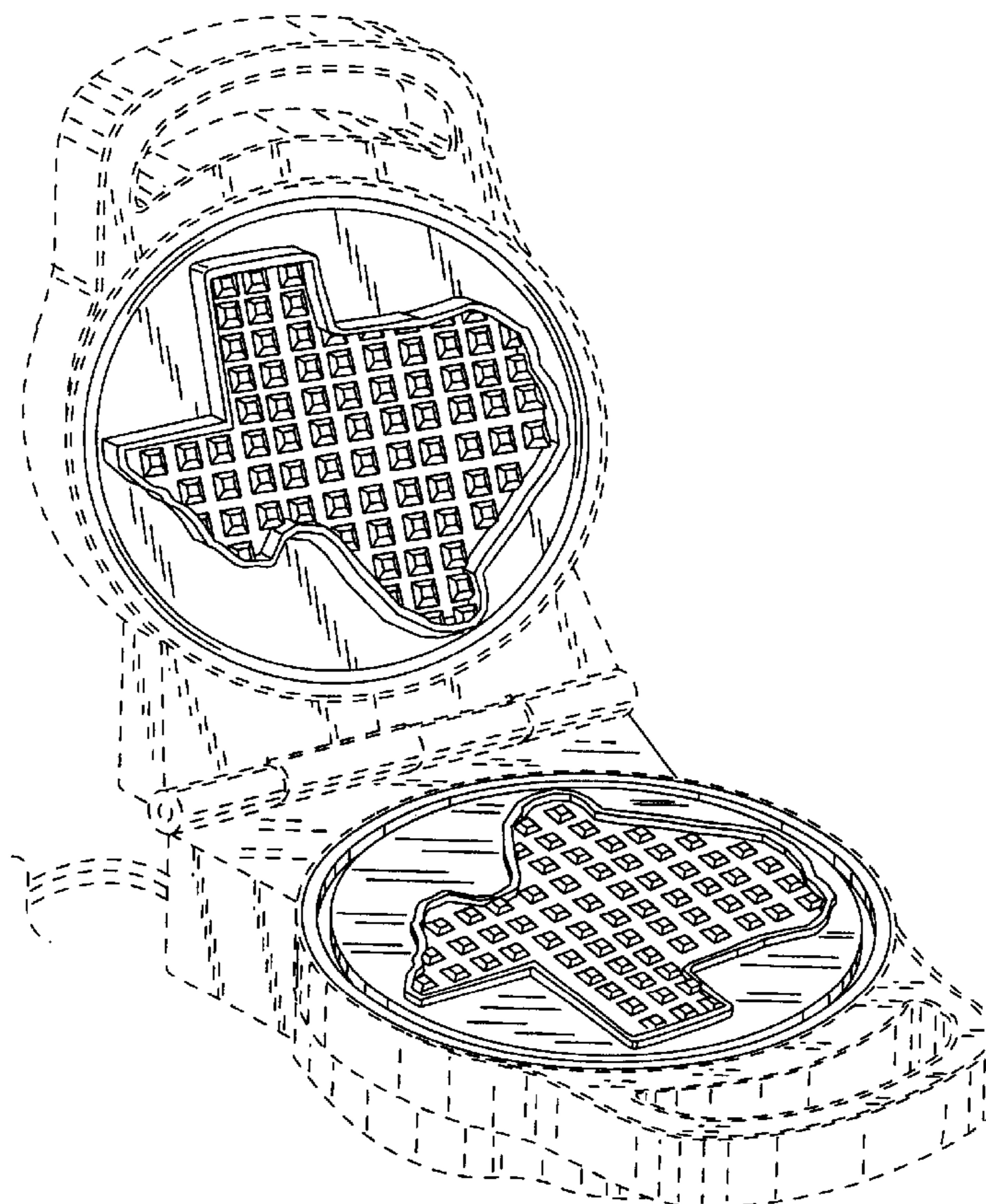
The ornamental design for a pair of Texas waffle iron molds, as shown and described.

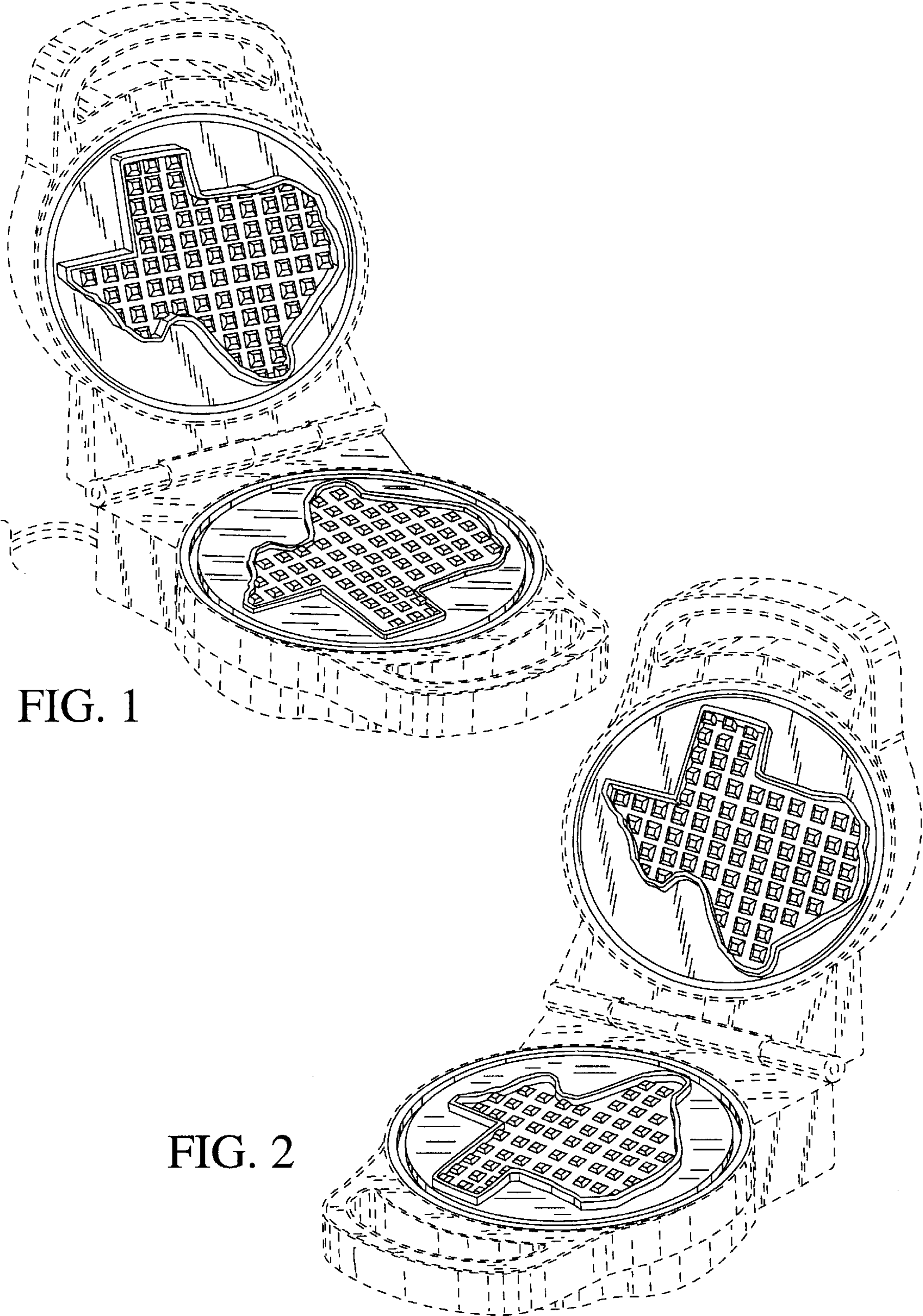
