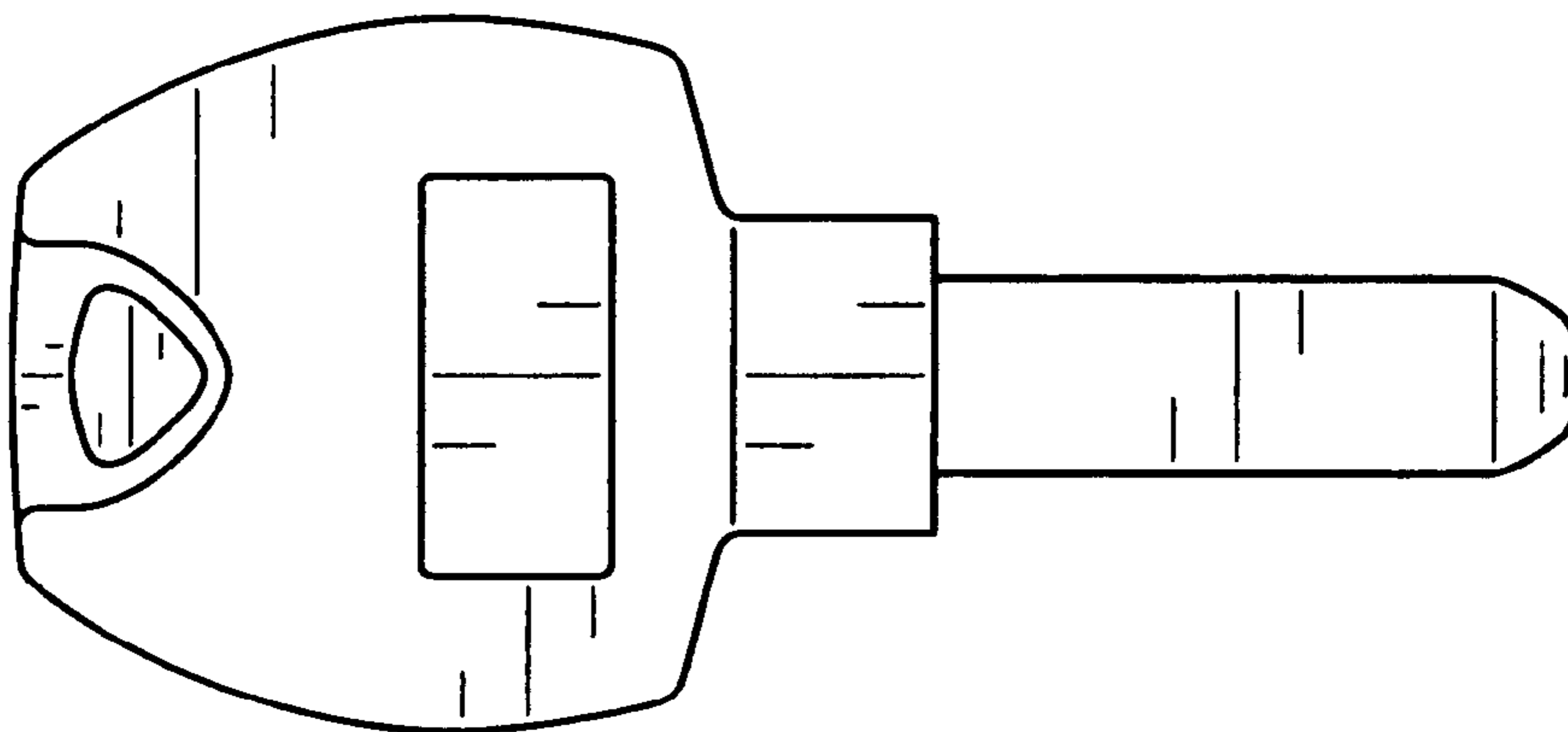
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of the combined security key and cap of our new design;
FIG. 2 is a side elevational view thereof;

FIG. 5 is the opposite end view of FIG. 4
FIG. 6 is a top view of the cap shown for clarity of illustration;

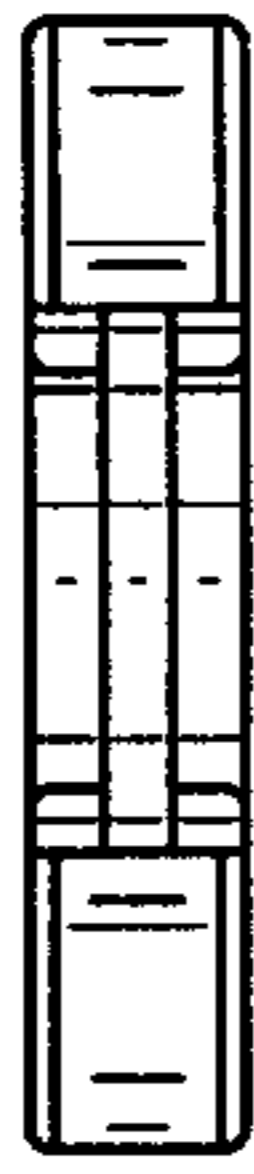

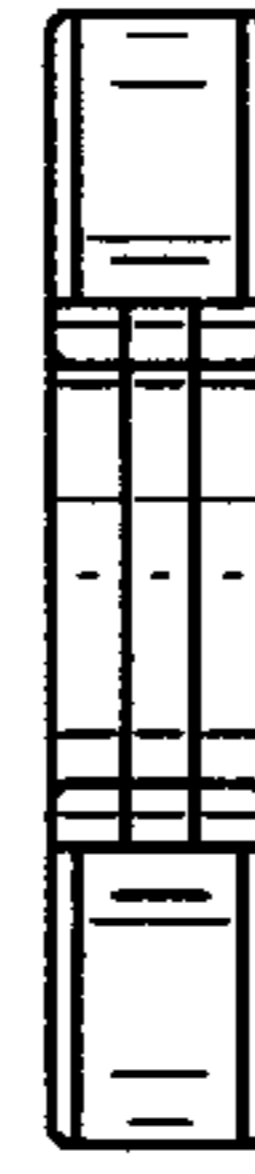

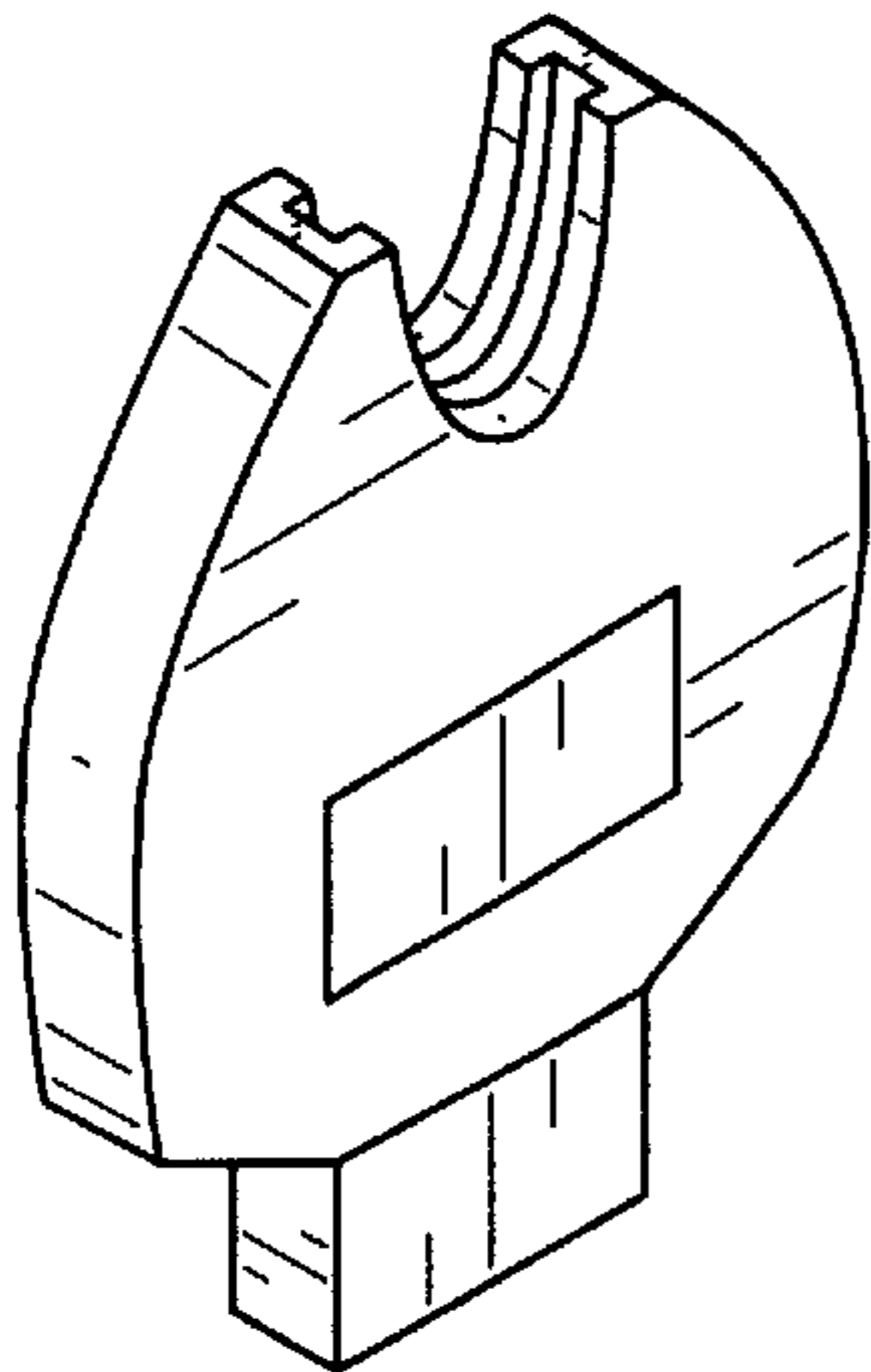

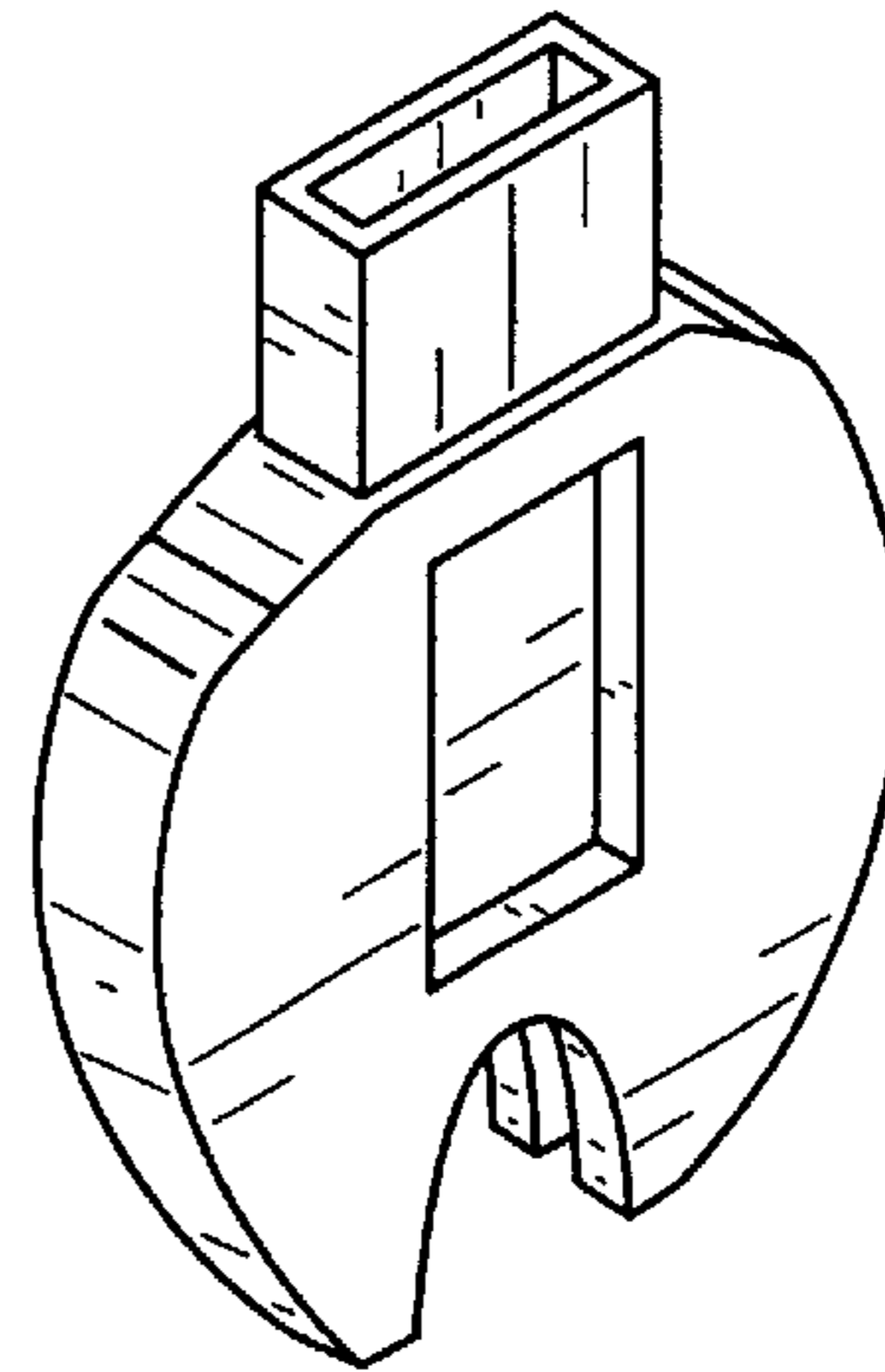

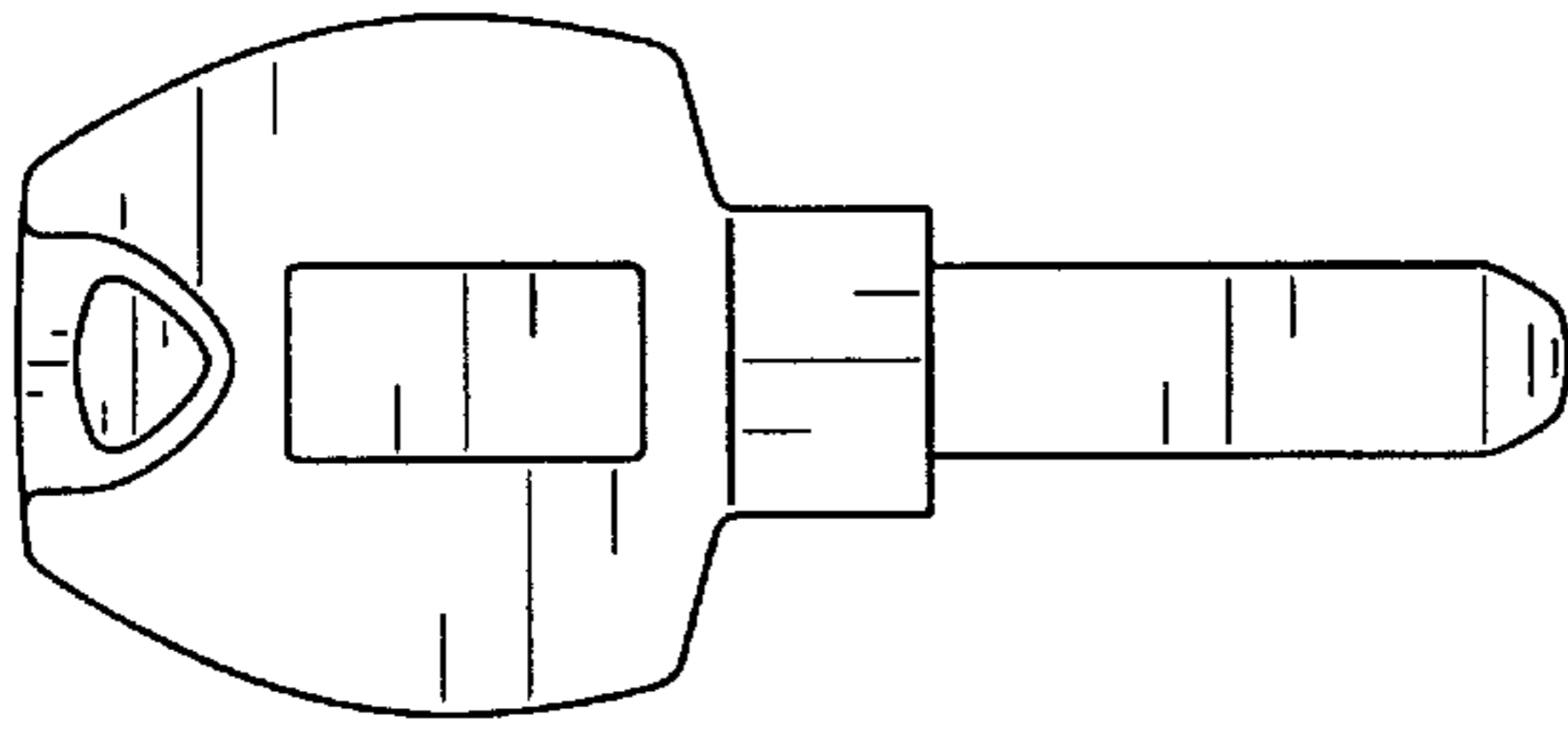

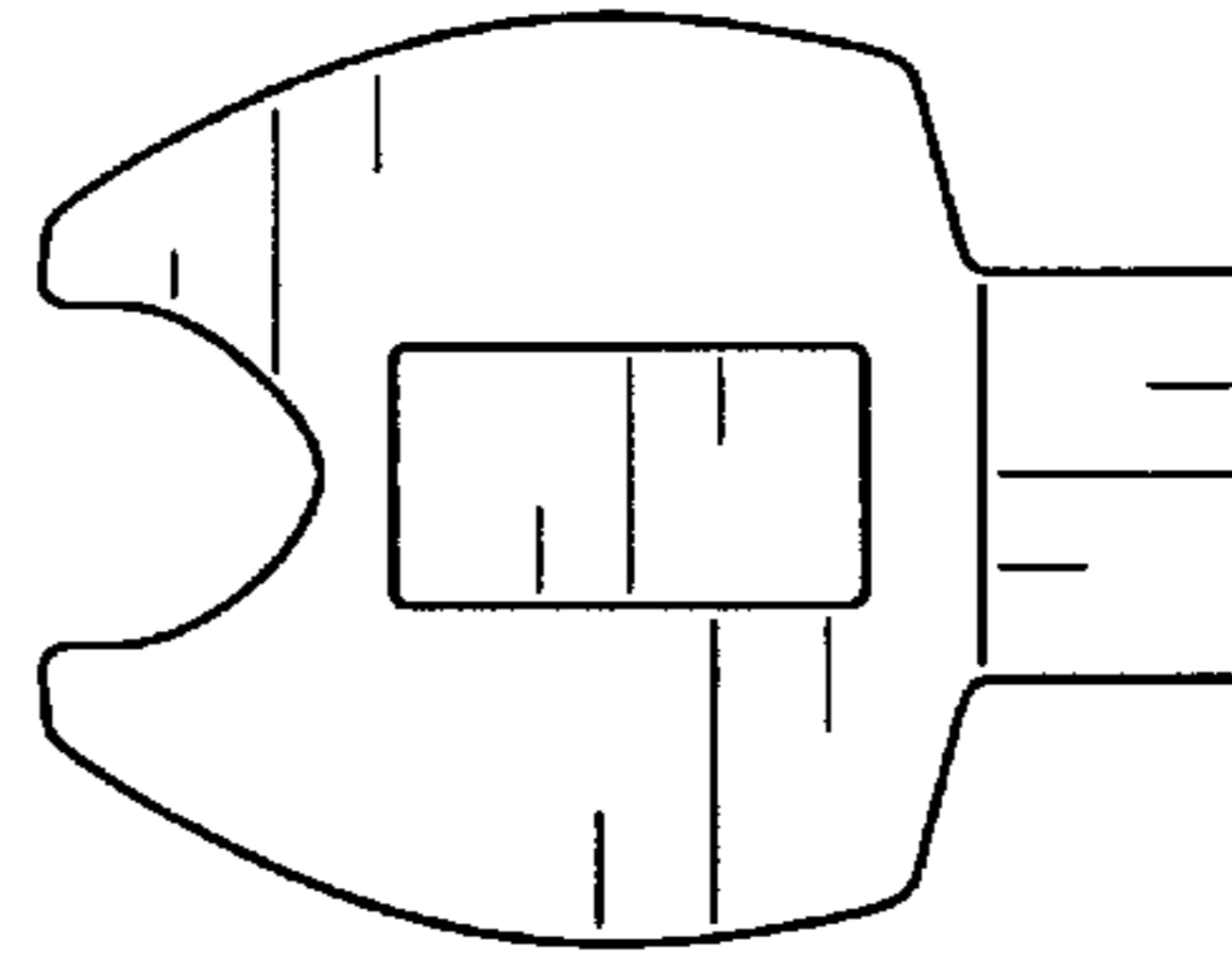

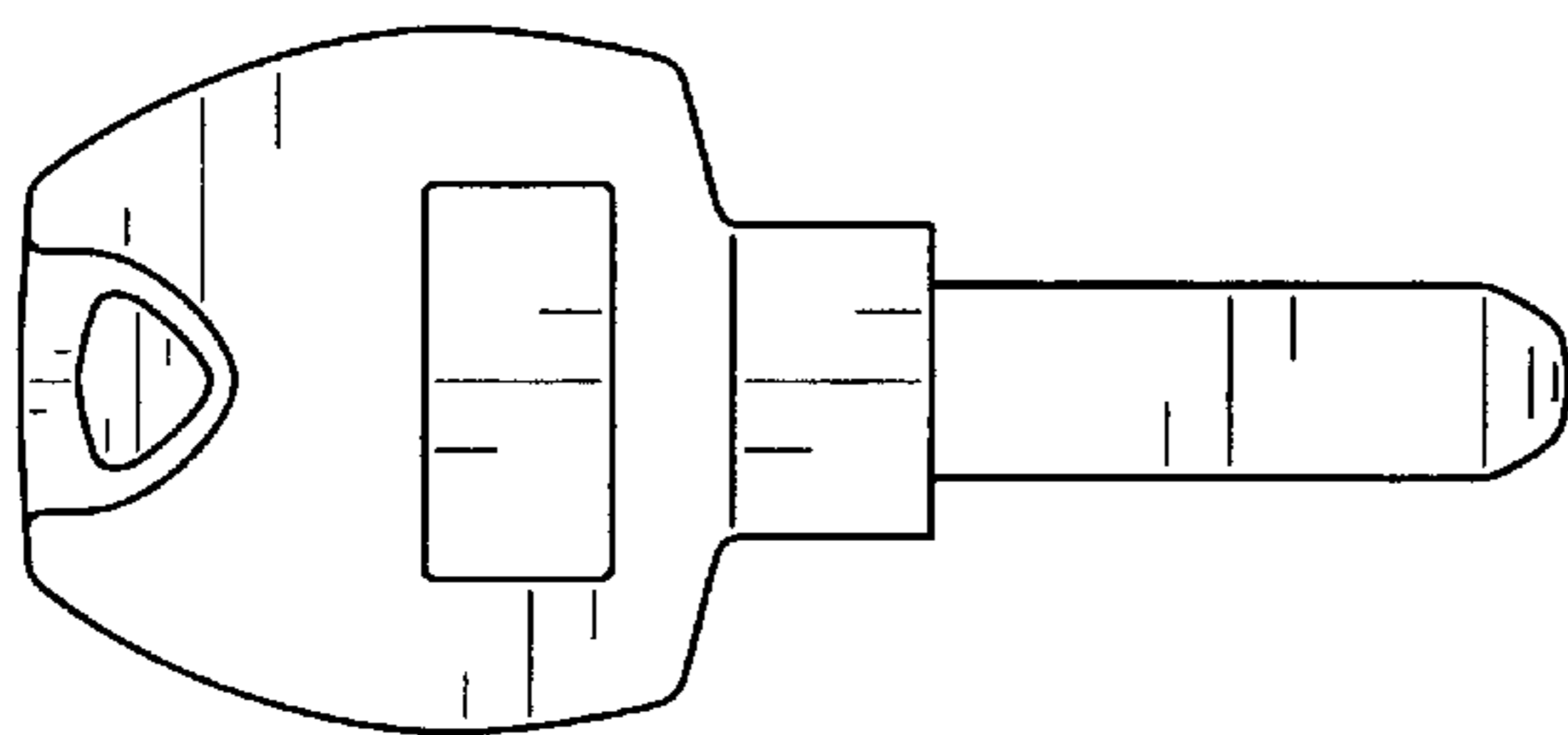

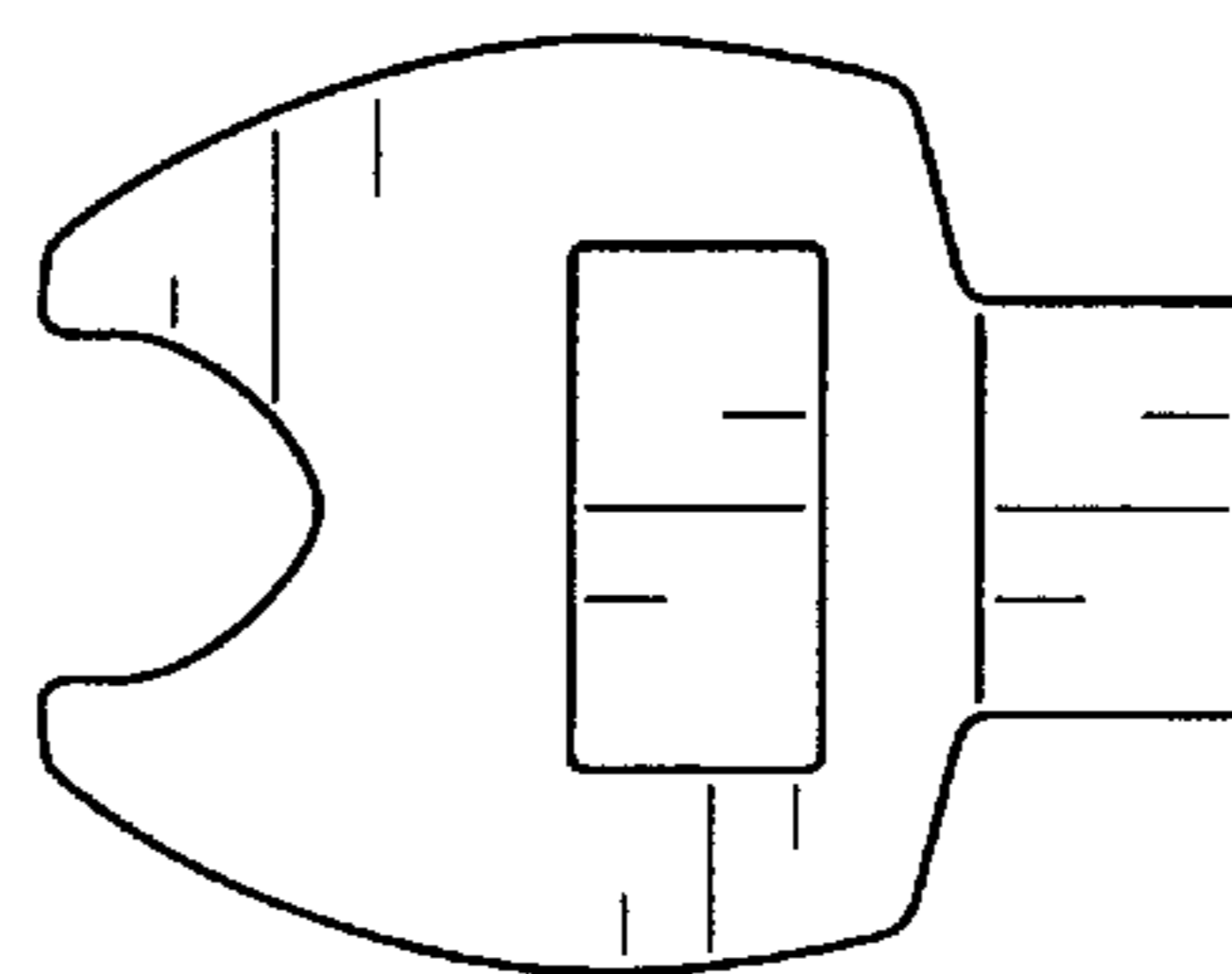
