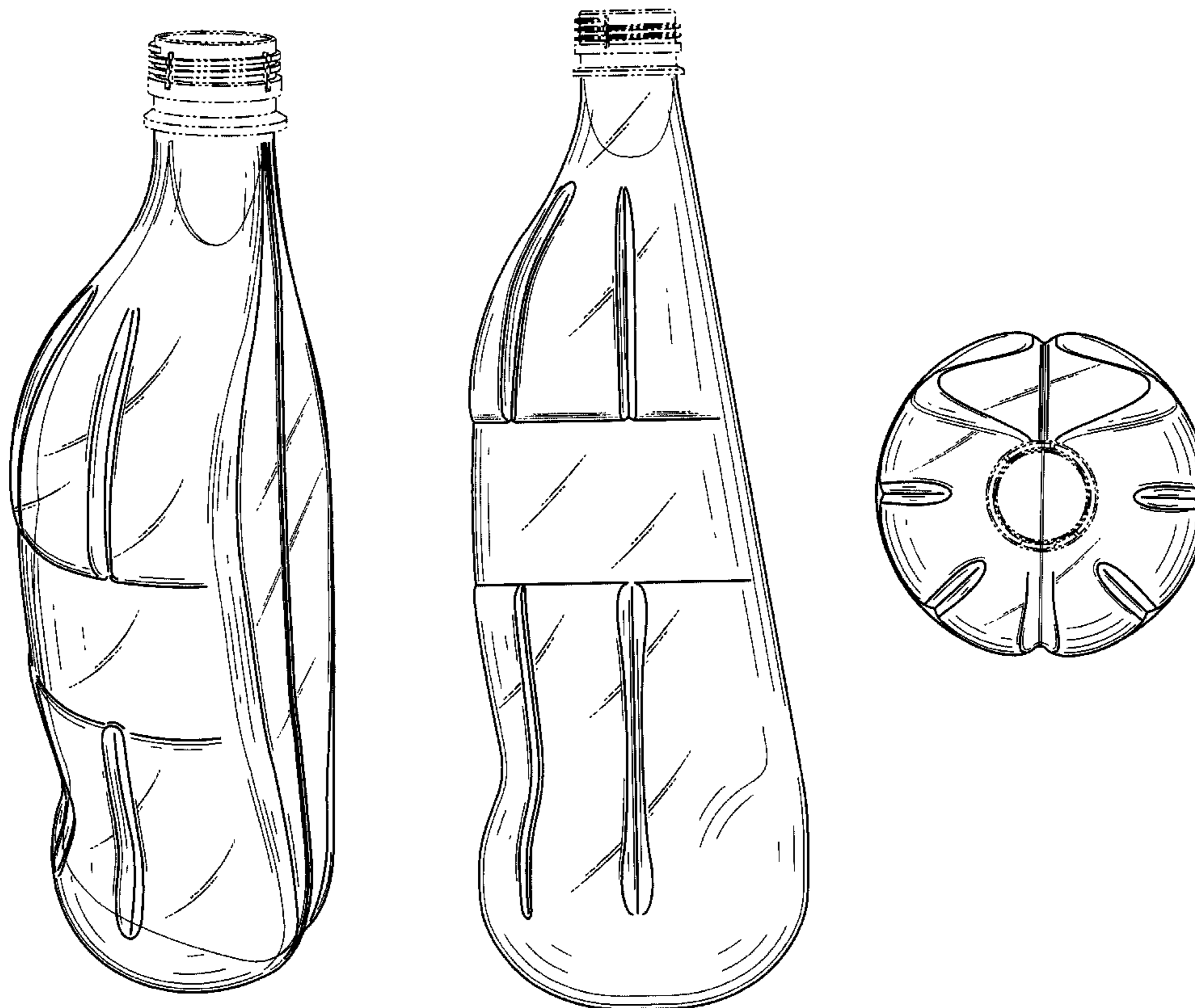

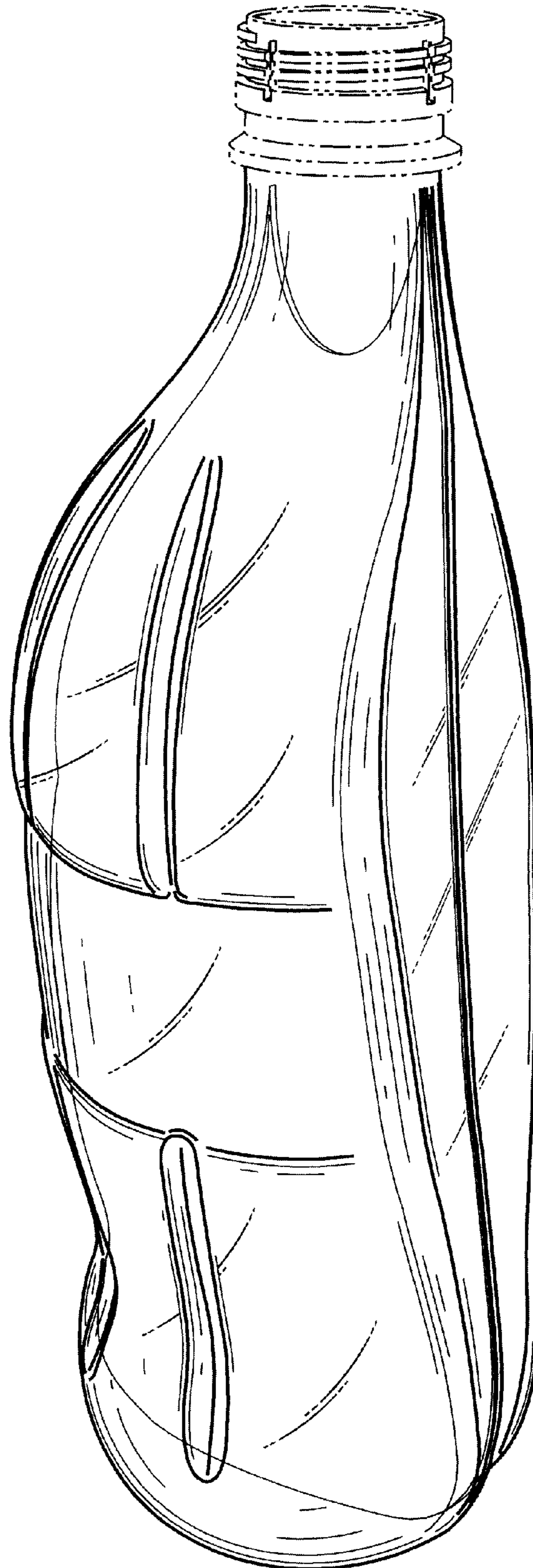
The ornamental design for a bottle, as shown.

**DESCRIPTION**

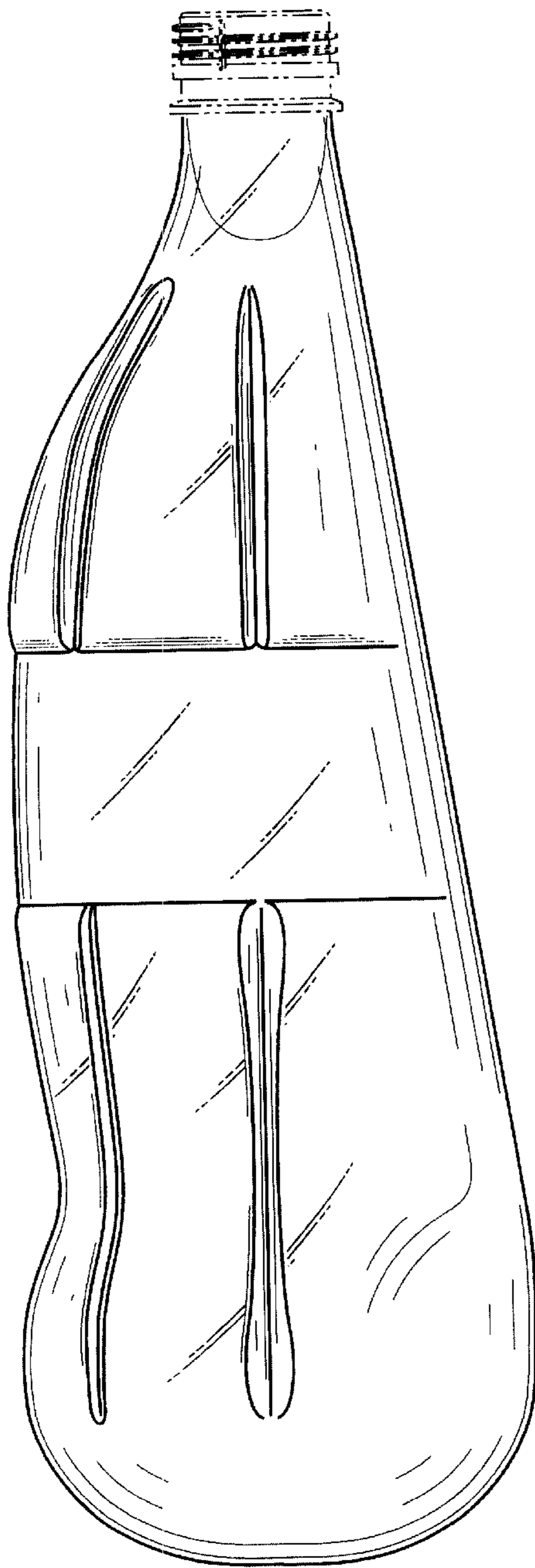

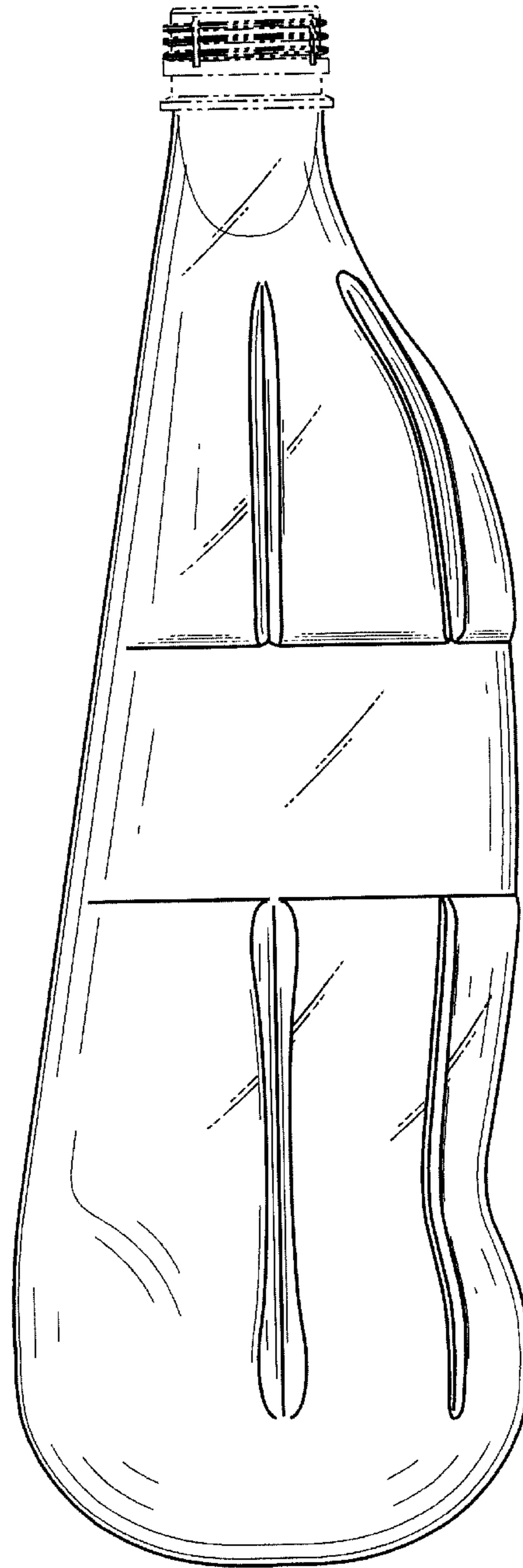




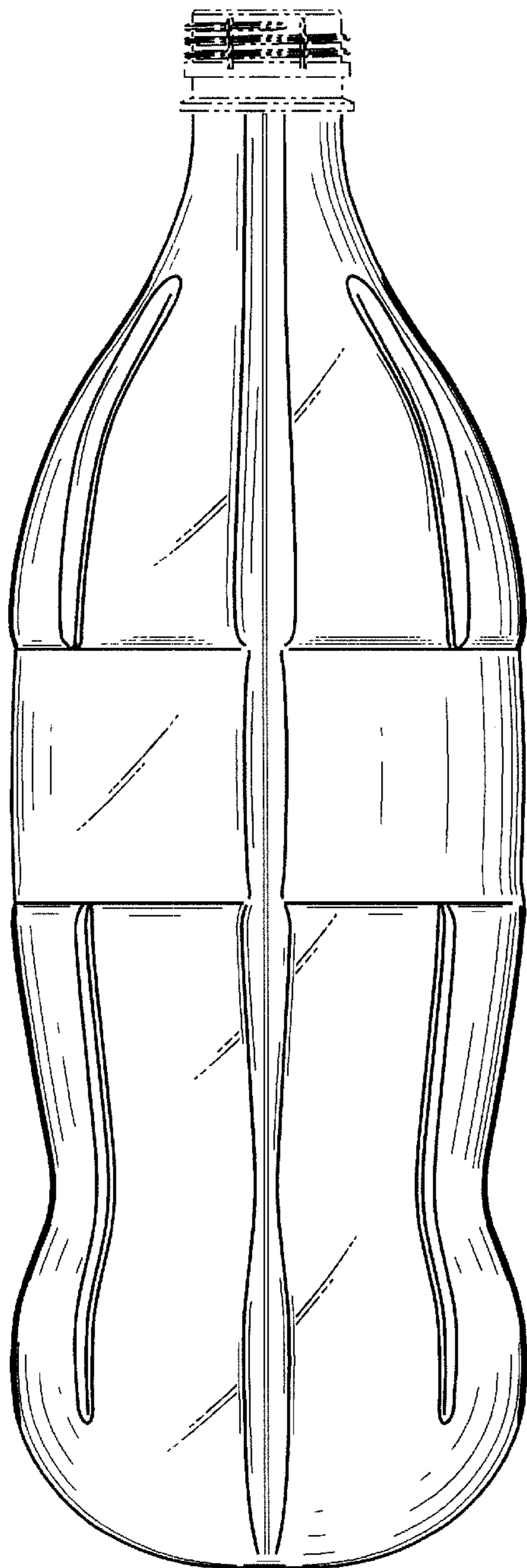

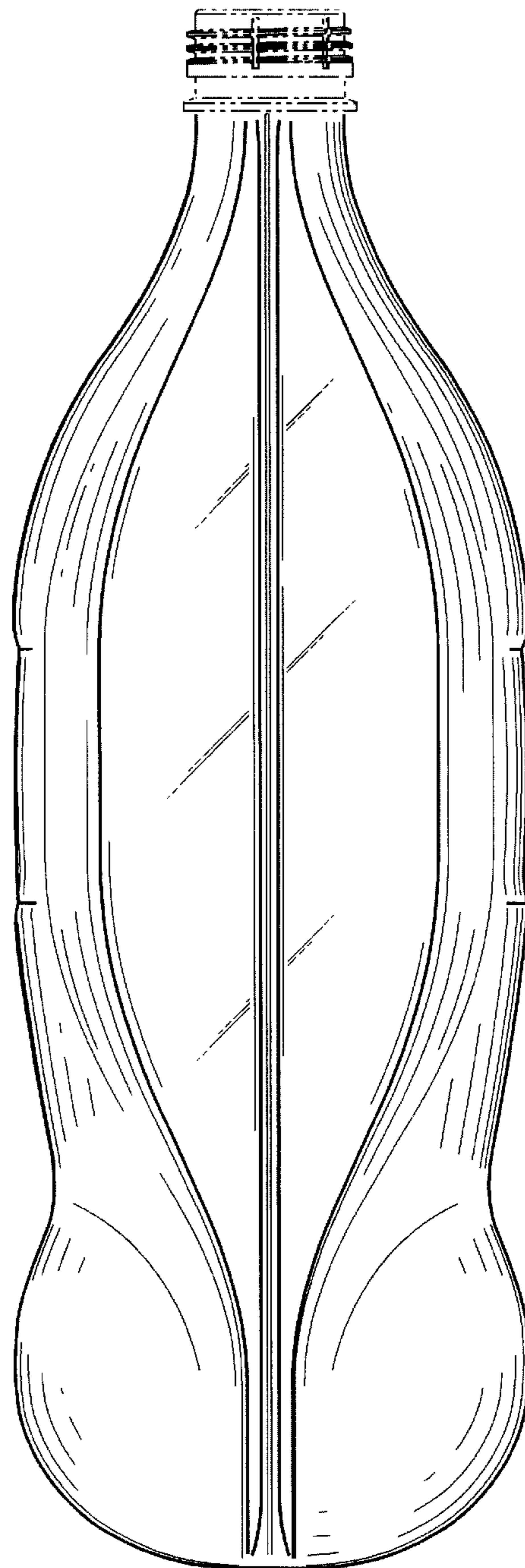

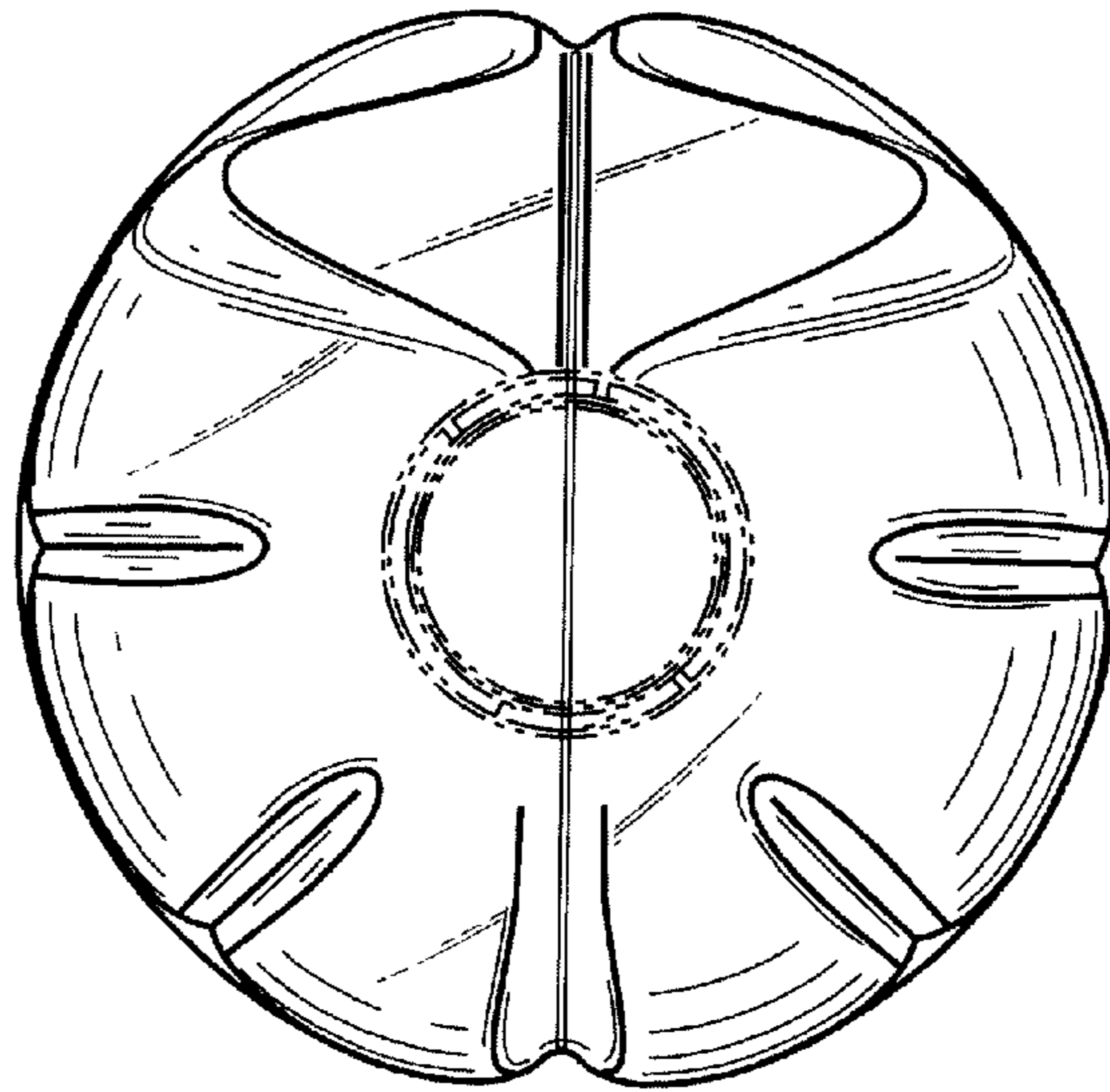
