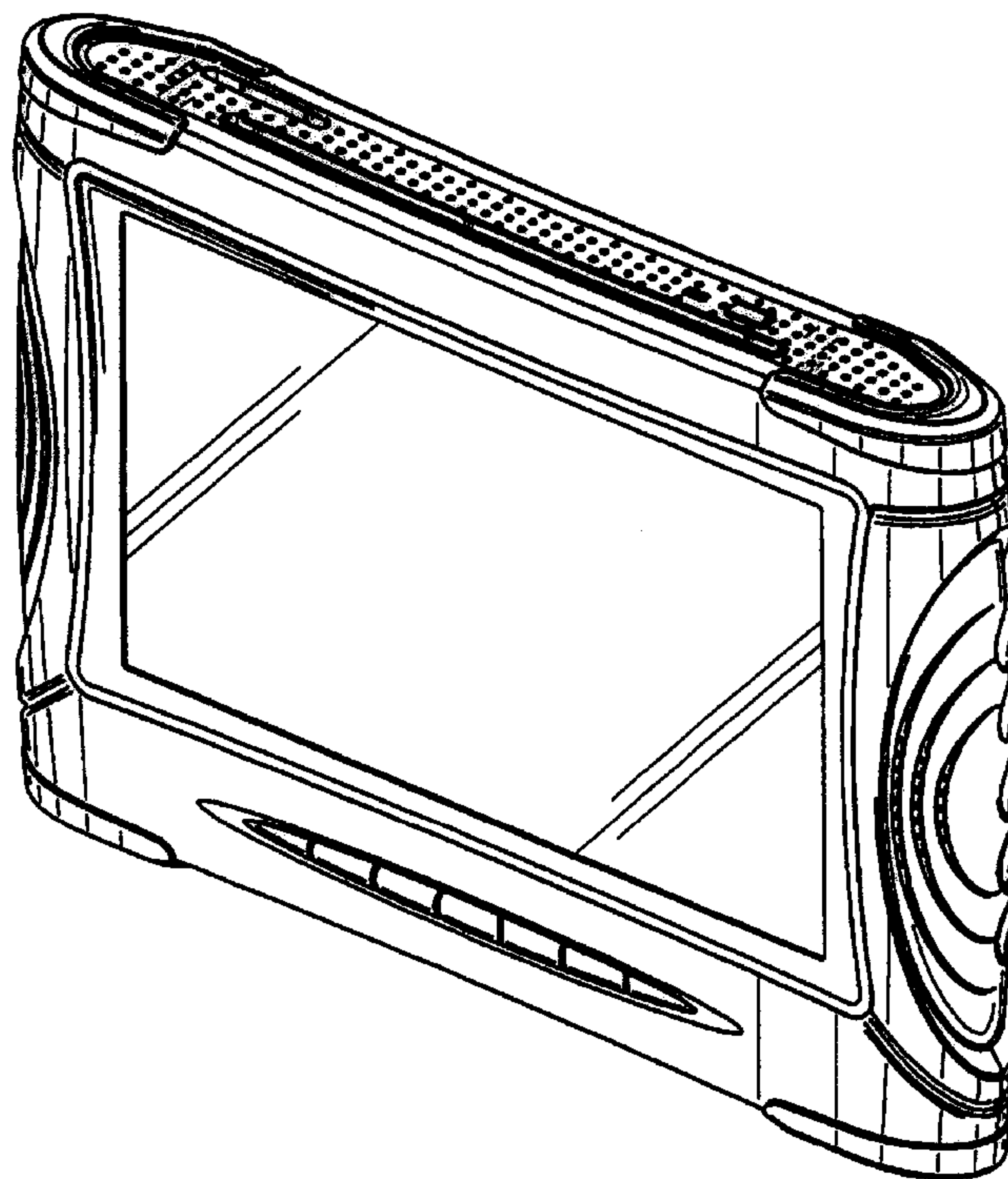
(57) **CLAIM**

I claim the ornamental design for a portable DVD player, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a preferred embodiment of the portable DVD player design of the present invention; FIG. 2 is a rear view thereof; FIG. 3 is a top view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view thereof; and, FIG. 8 is a perspective view thereof from a direction opposite to that of FIG. 7.

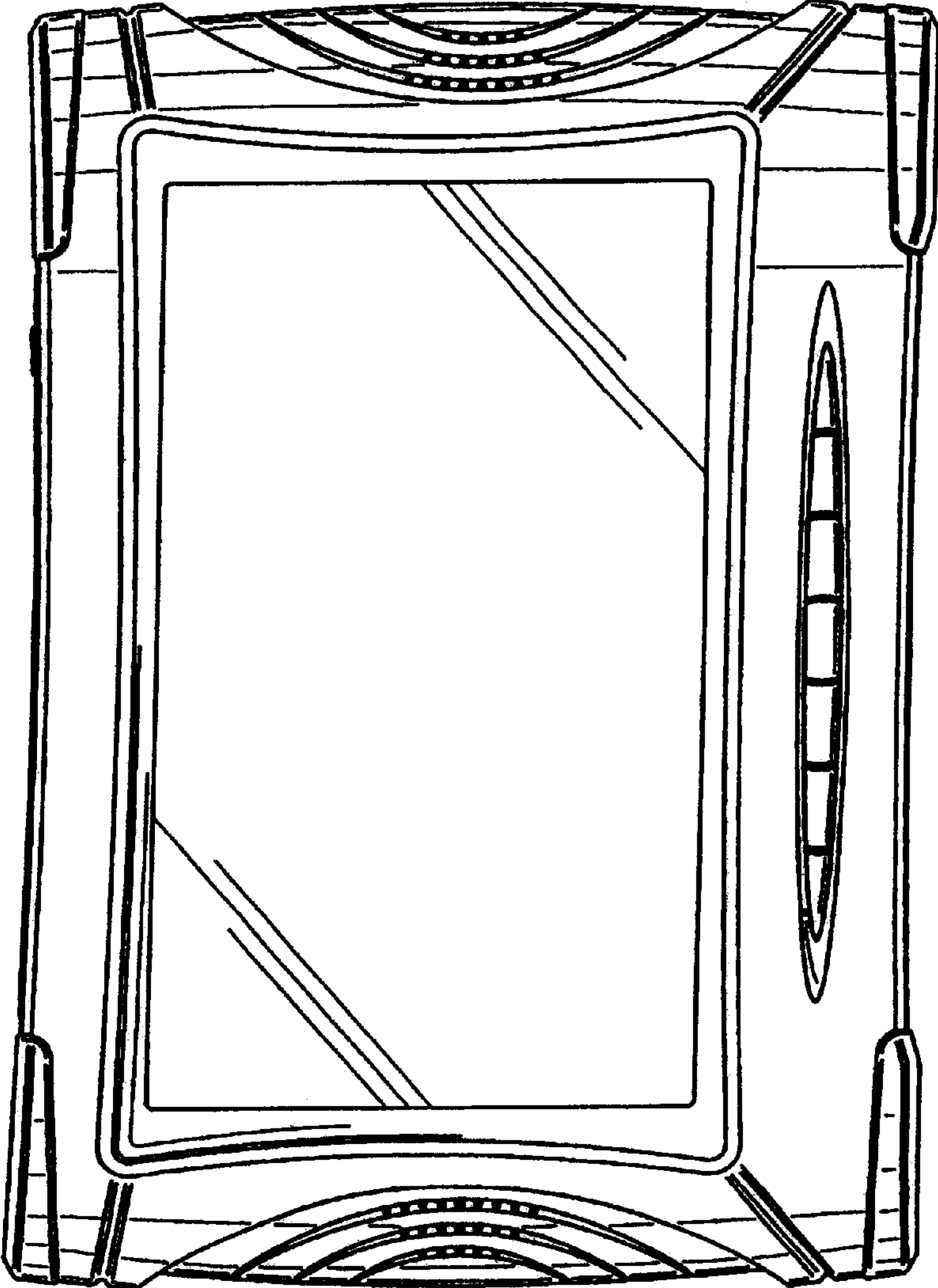

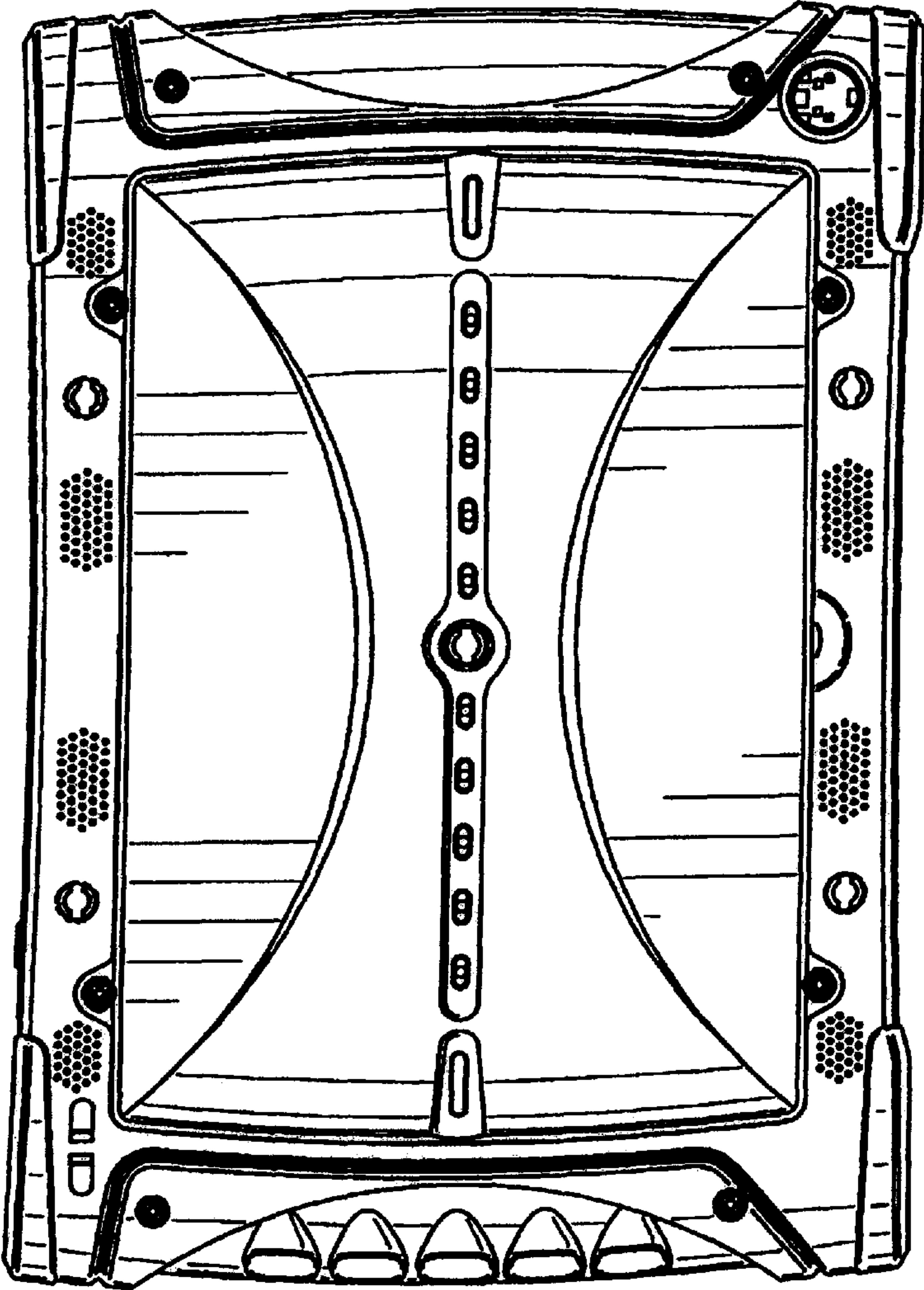

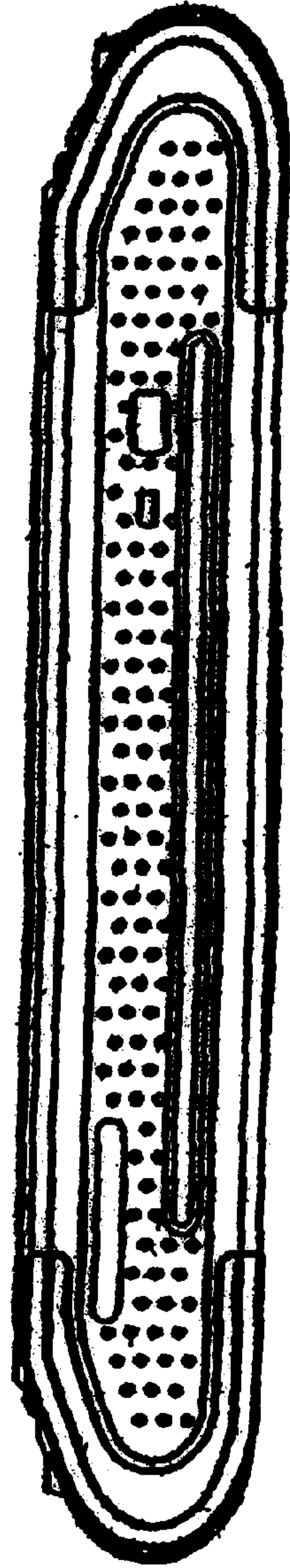

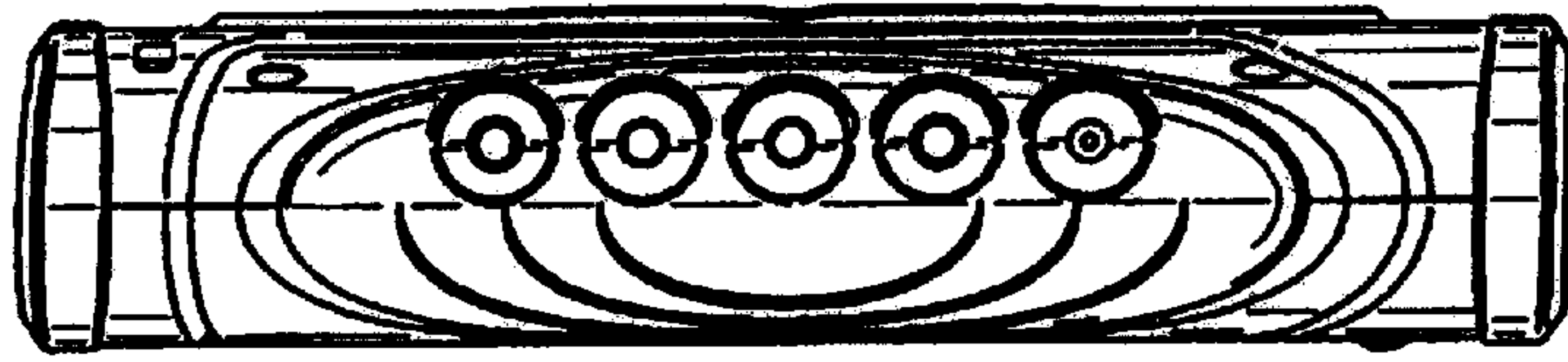

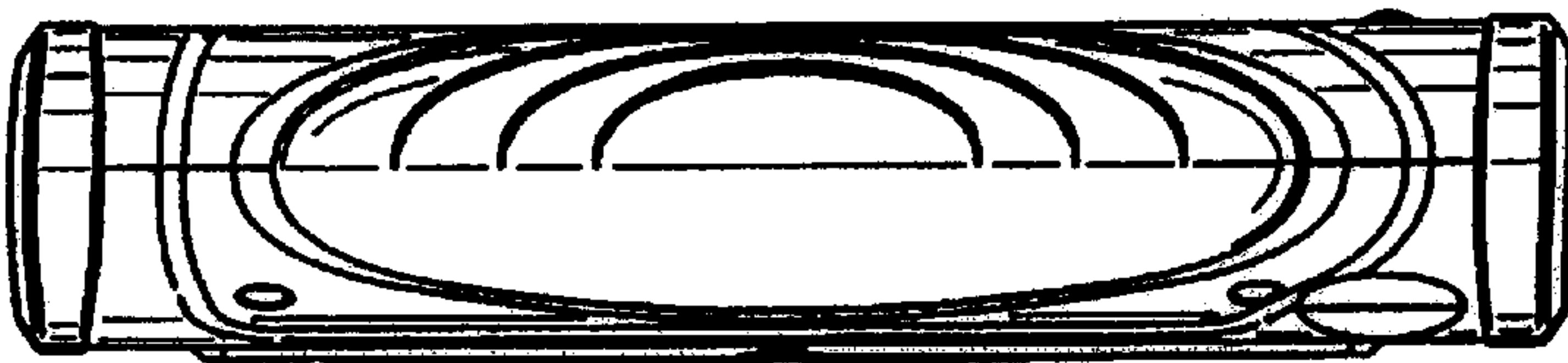

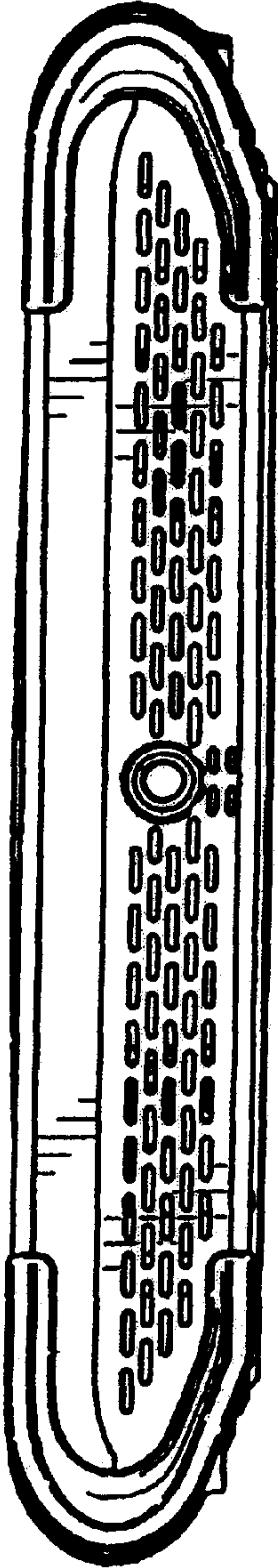

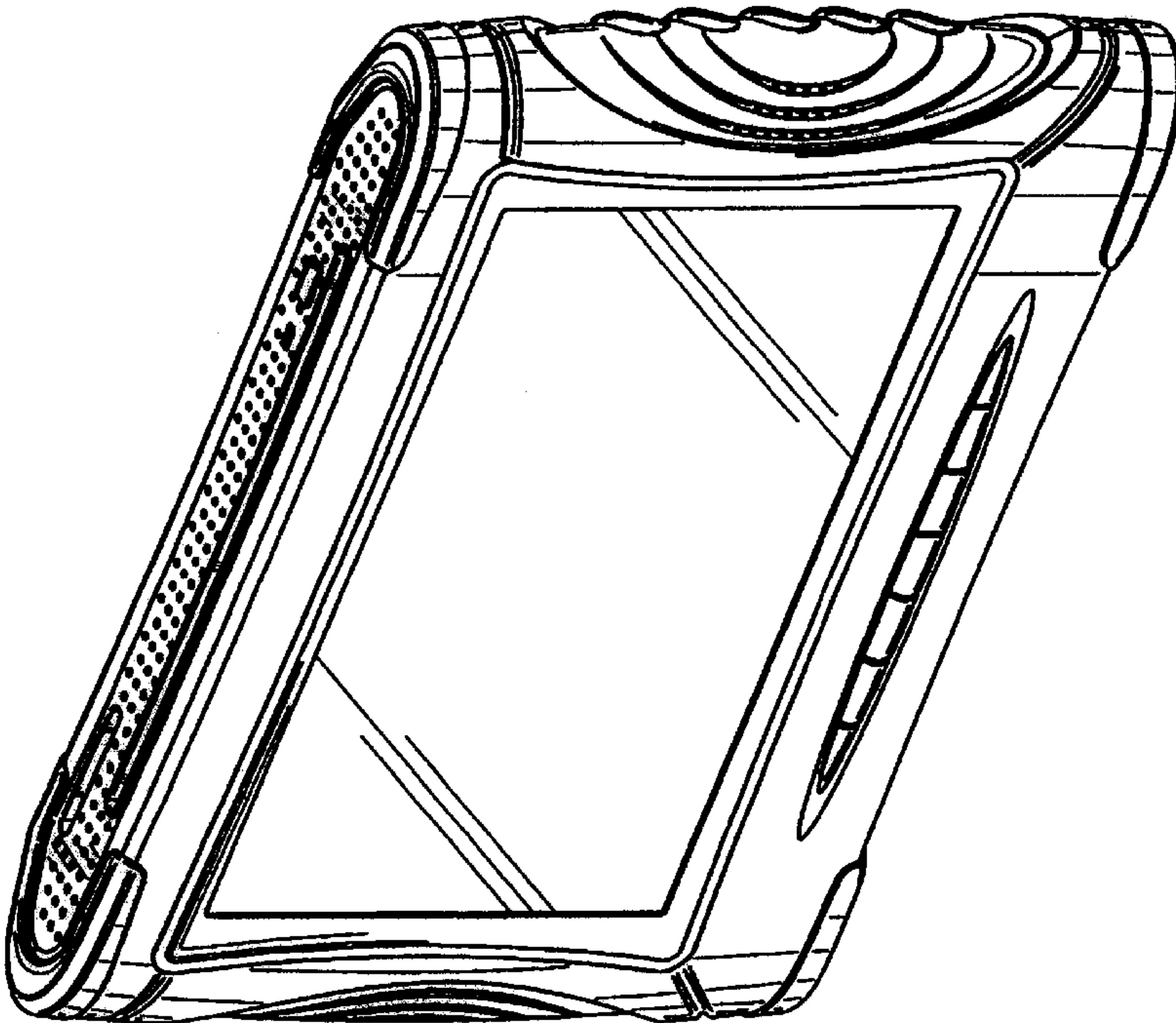

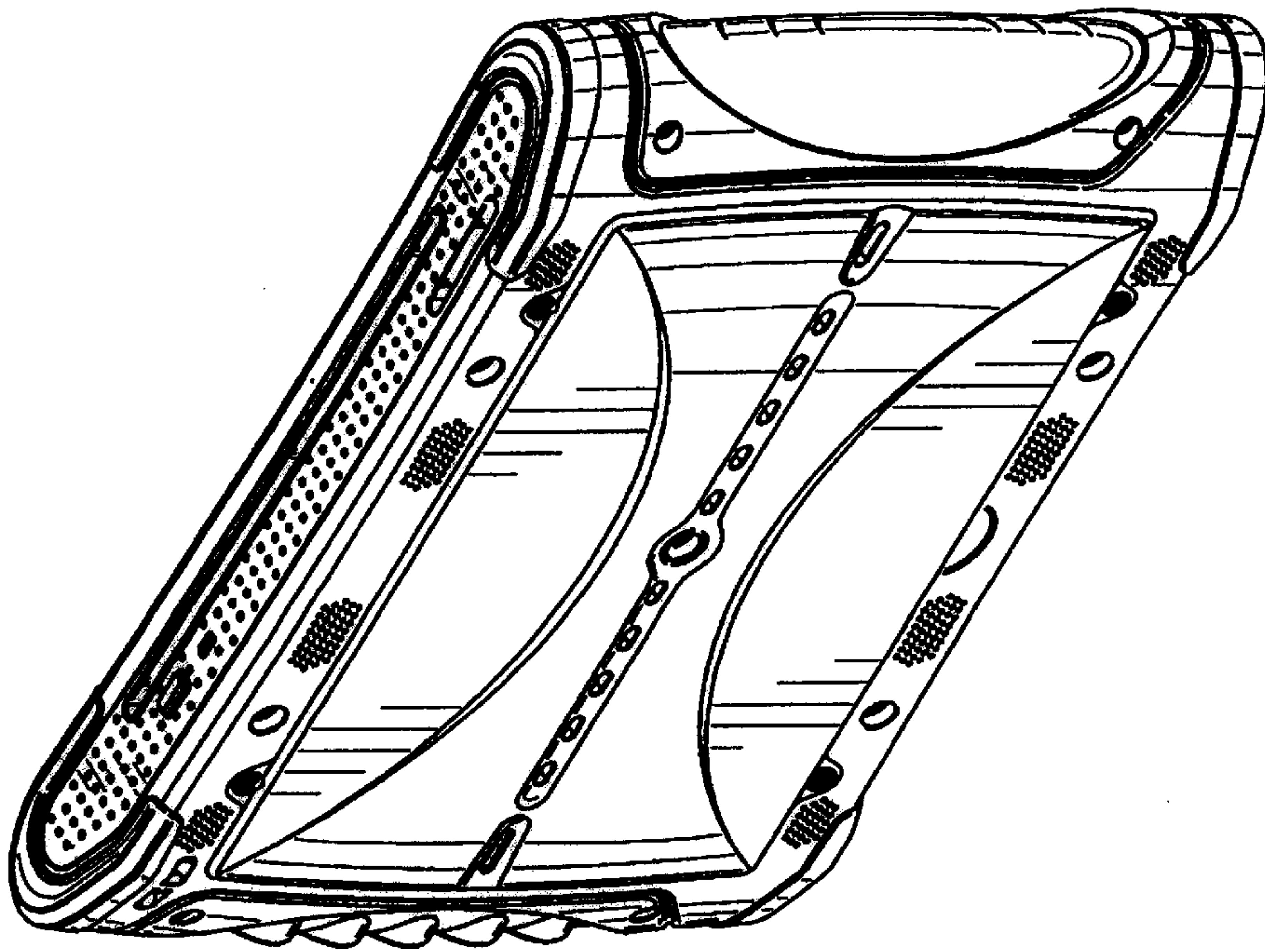
