The ornamental design for a portable terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front, left perspective view of the portable terminal showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a front view showing an open state thereof;
FIG. 9 is a right side view thereof which shows a handle in a first position; and,
FIG. 10 is a right side view thereof which shows the handle in a second position.

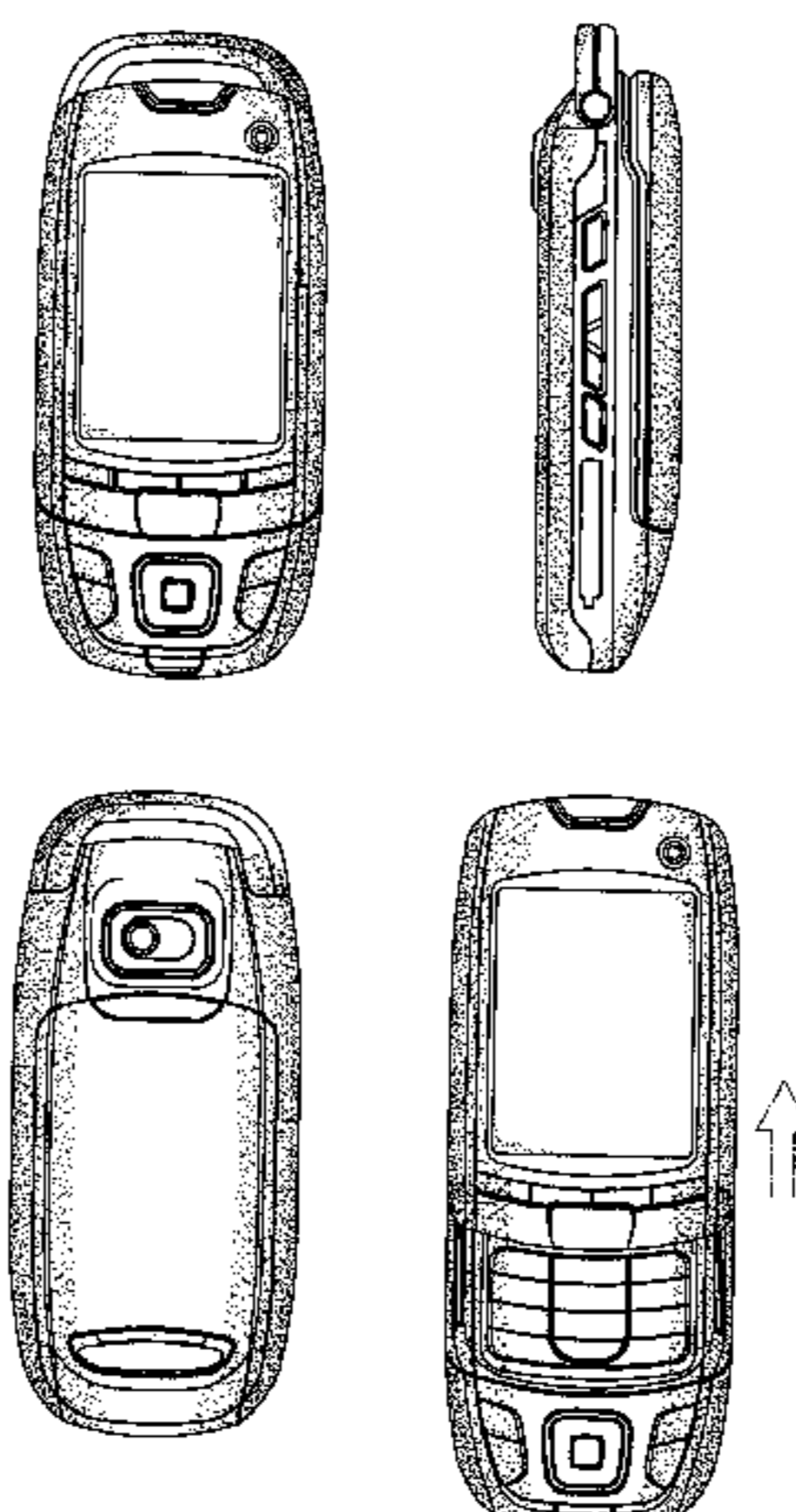

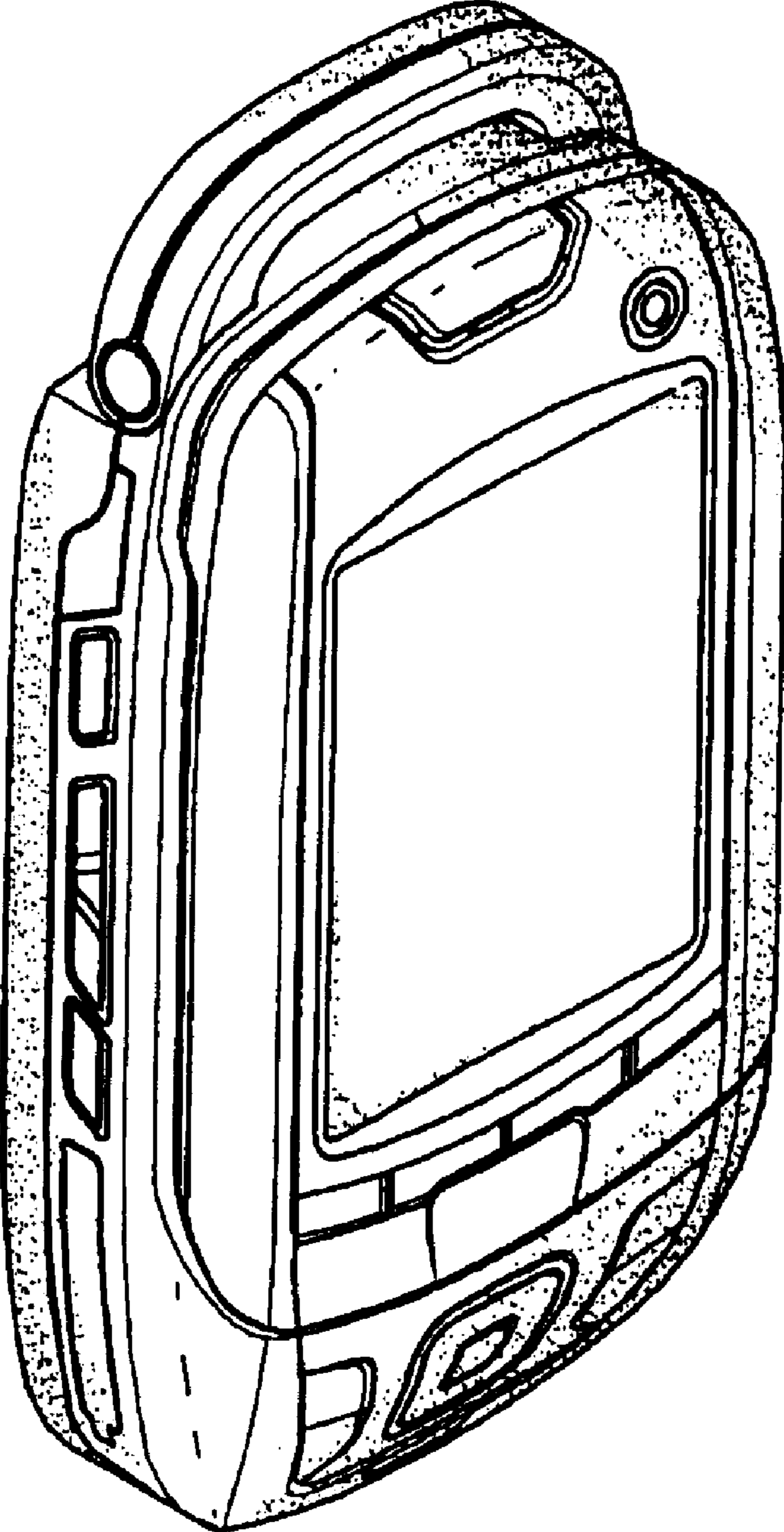

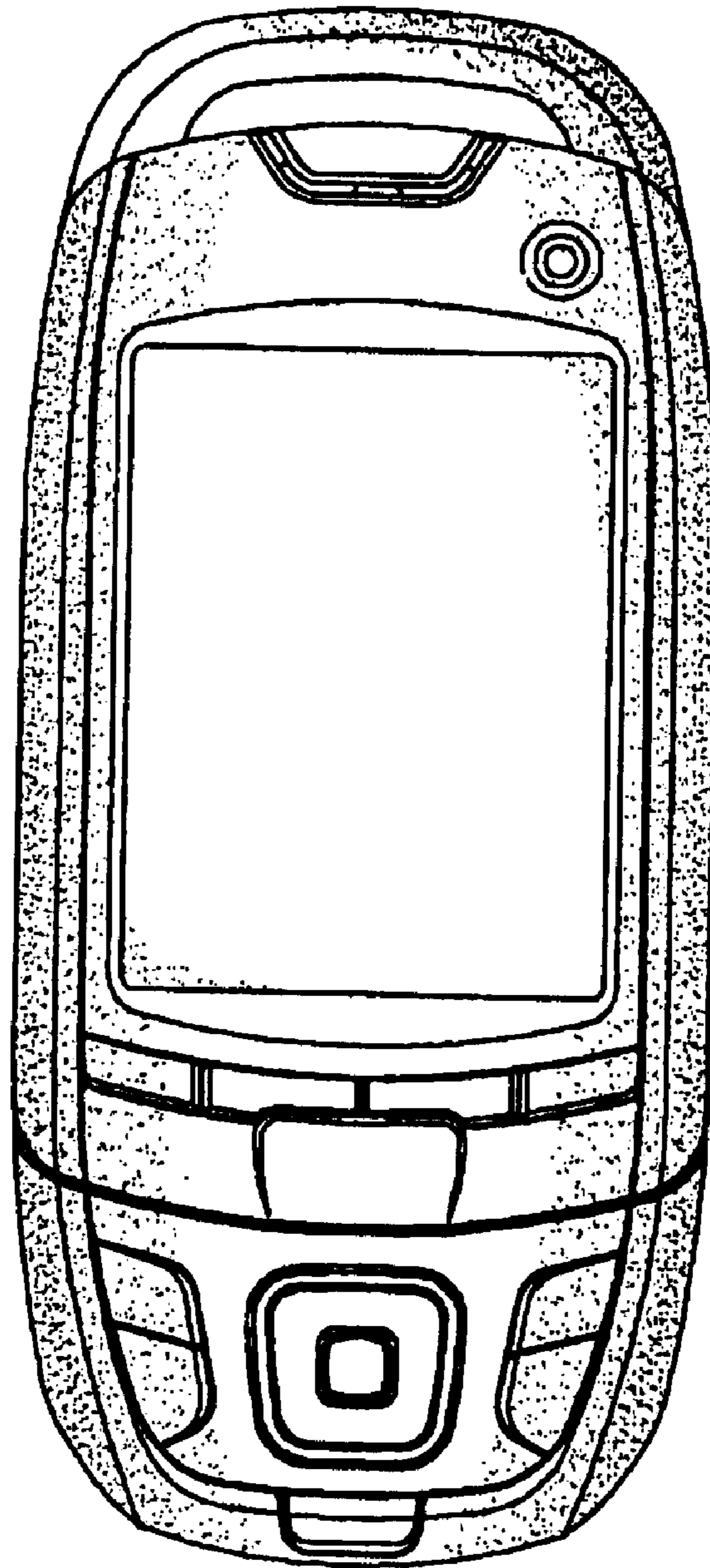

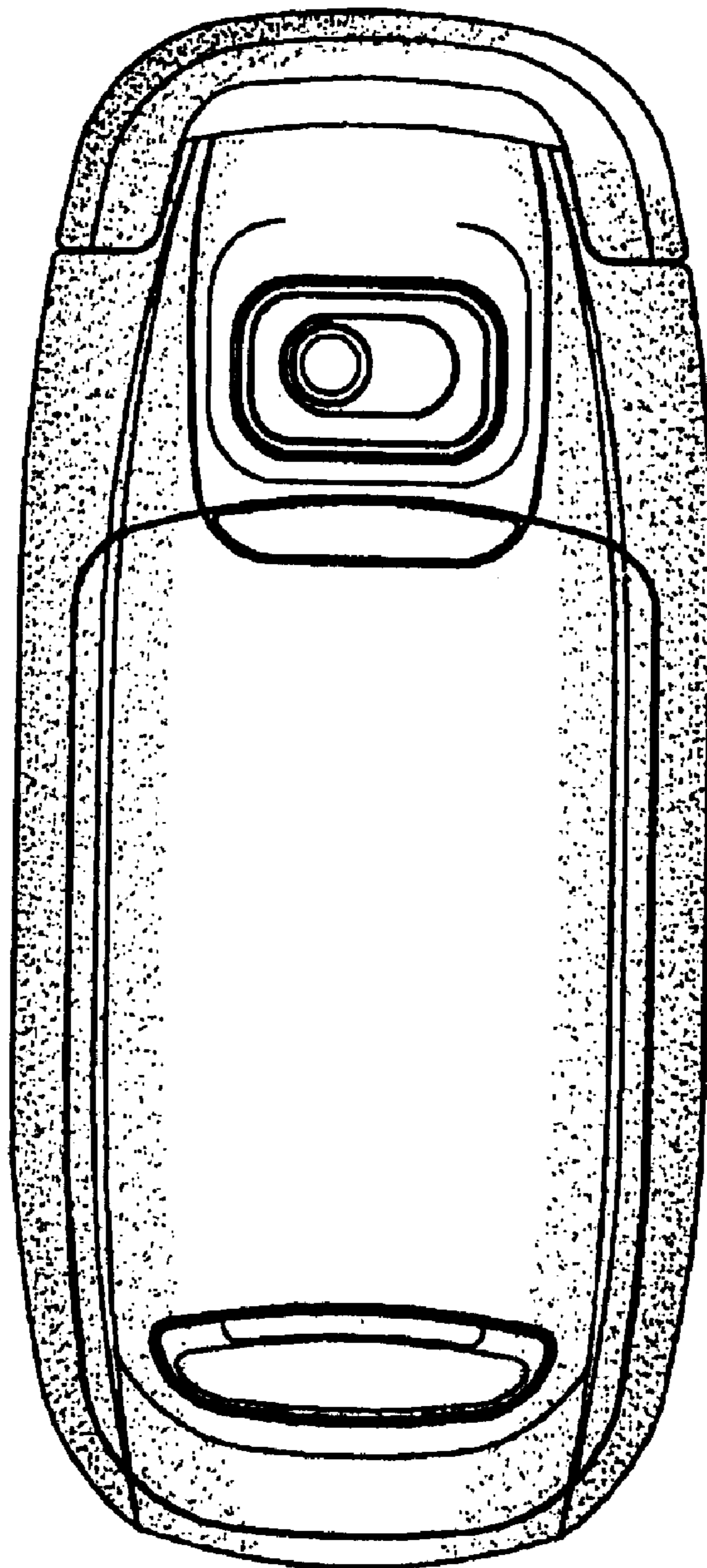

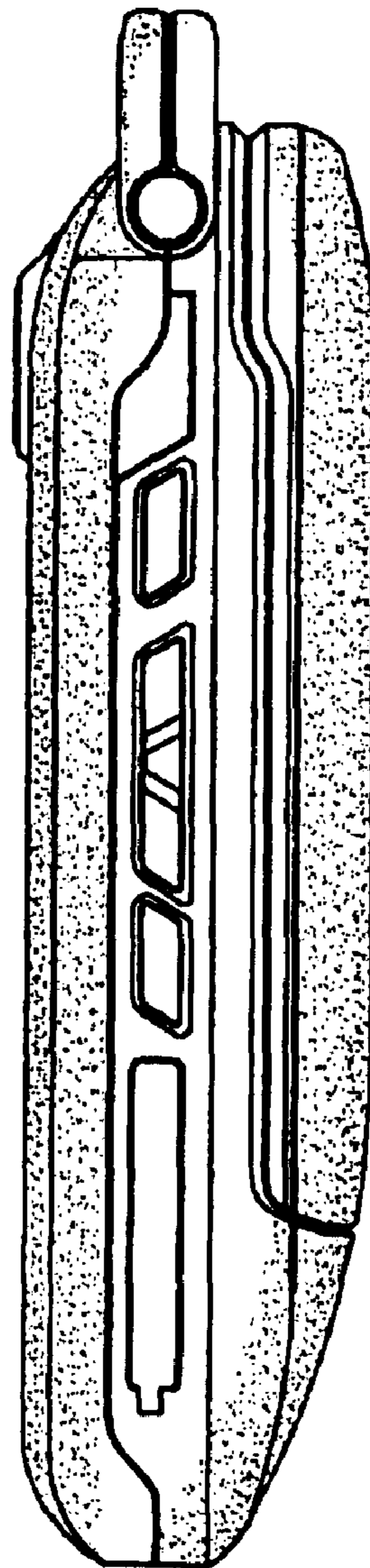

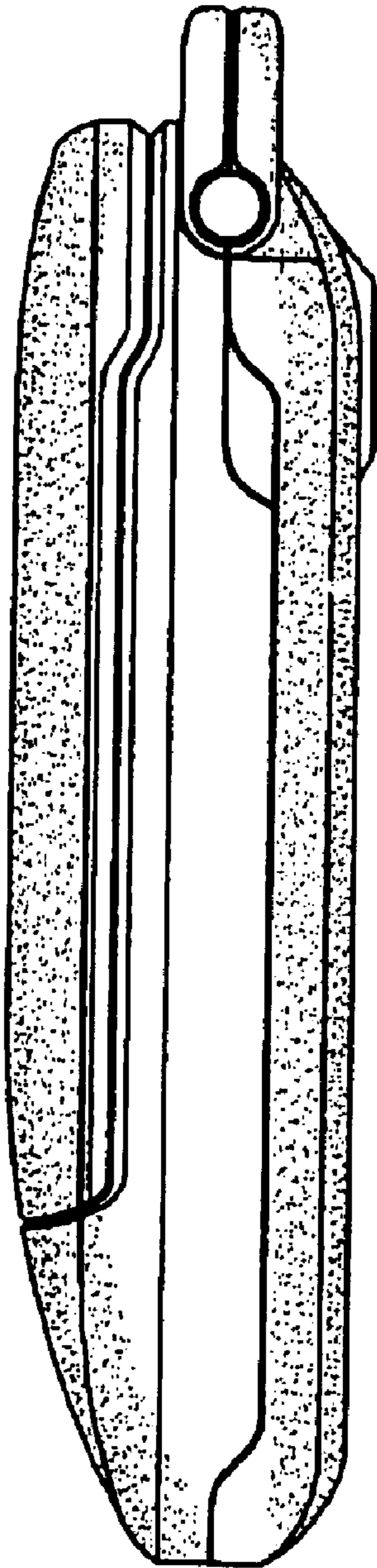

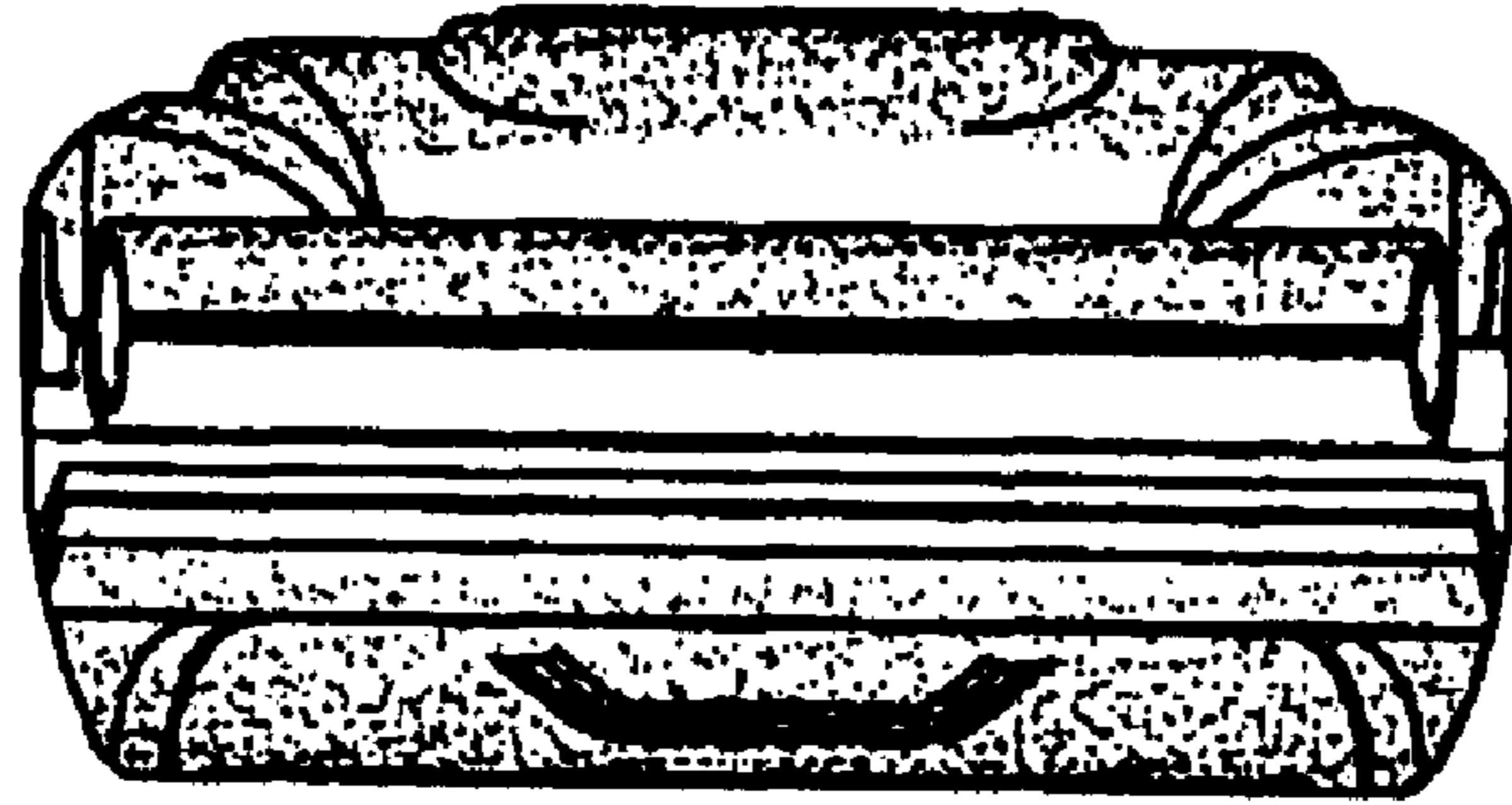

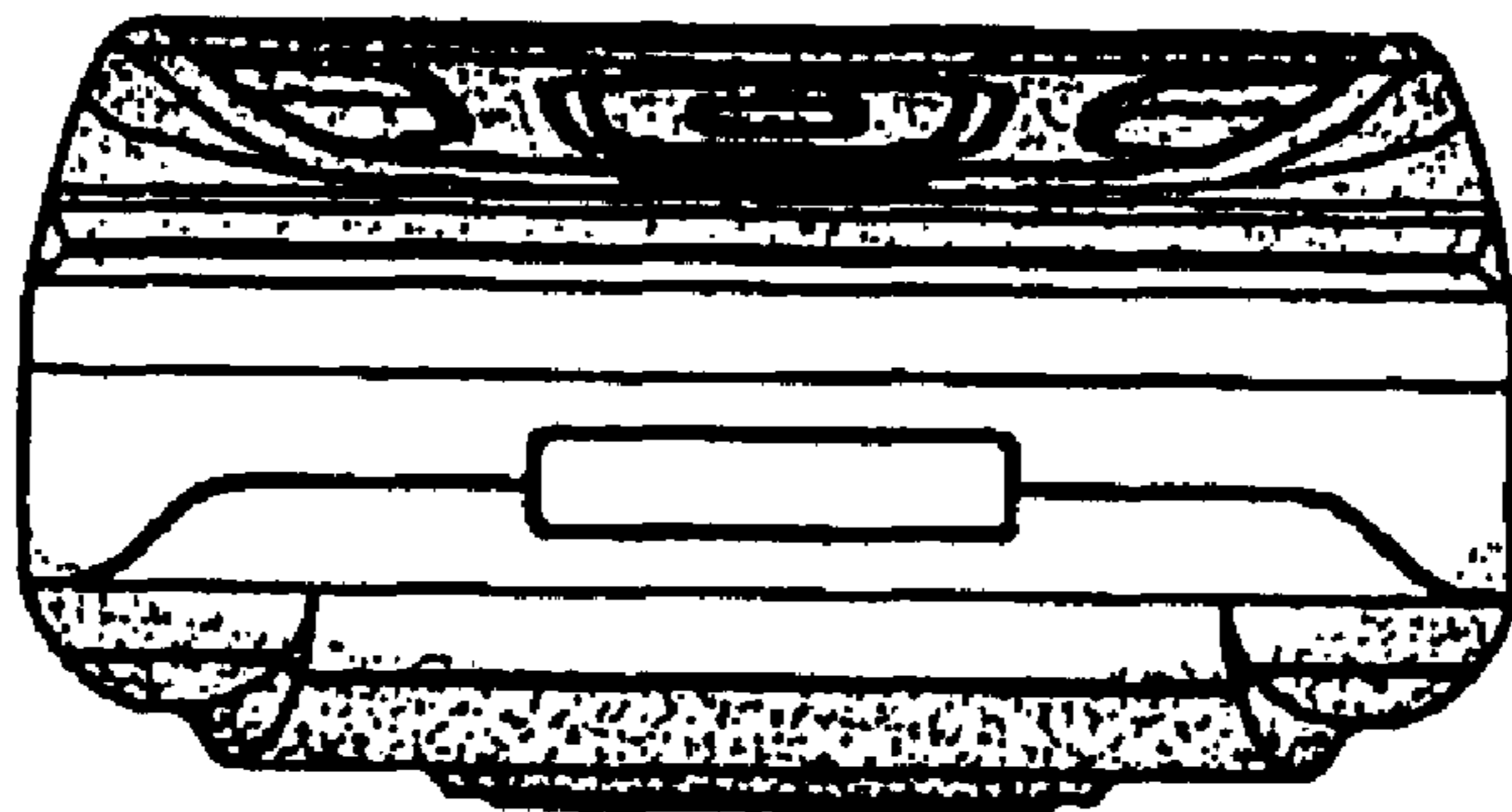

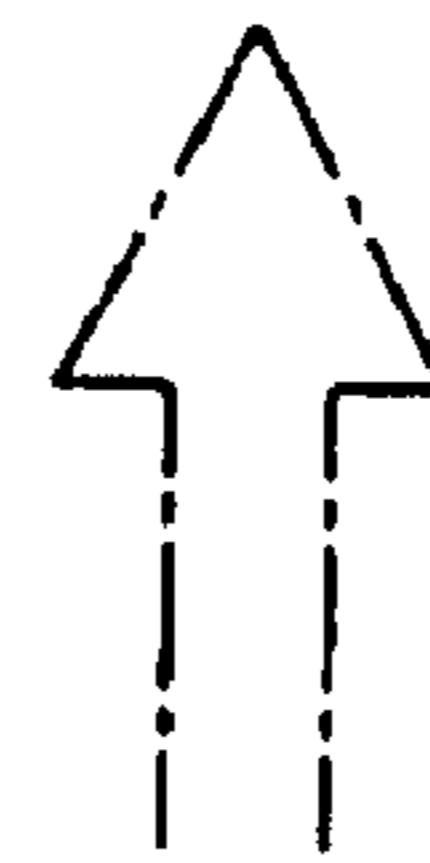
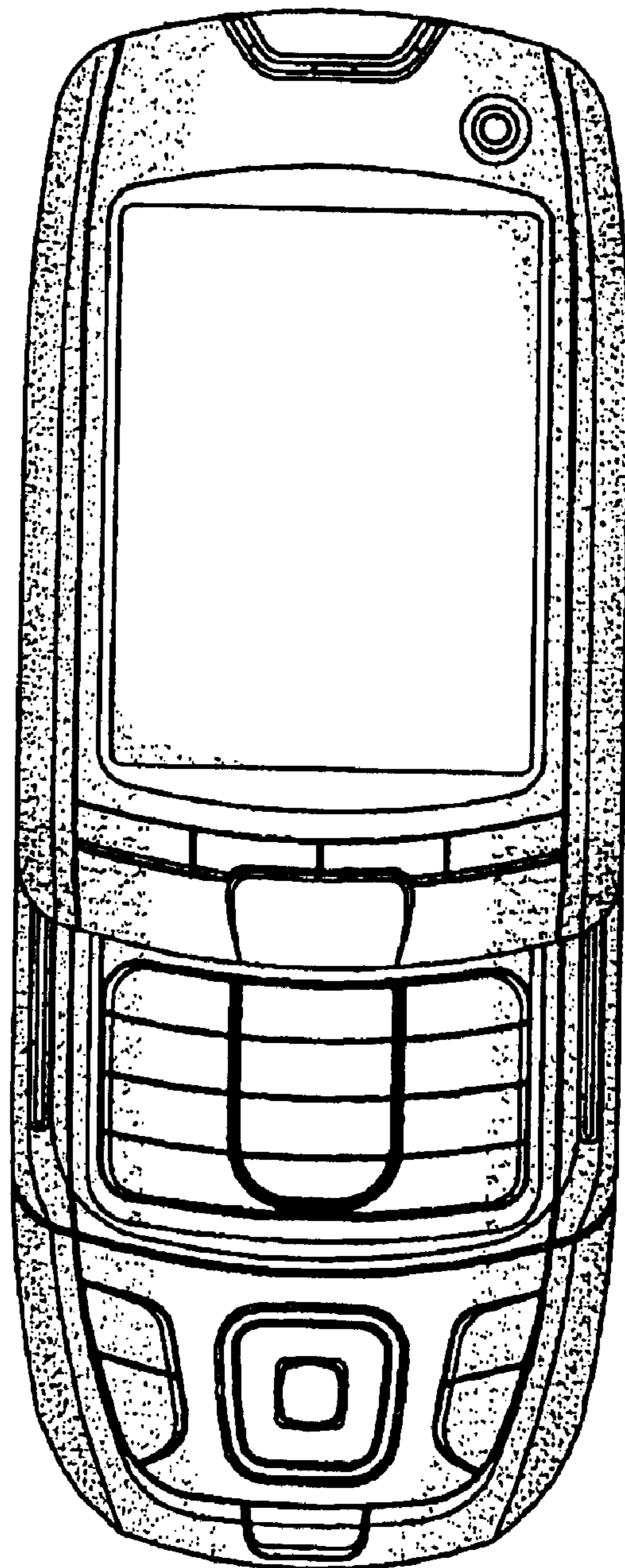

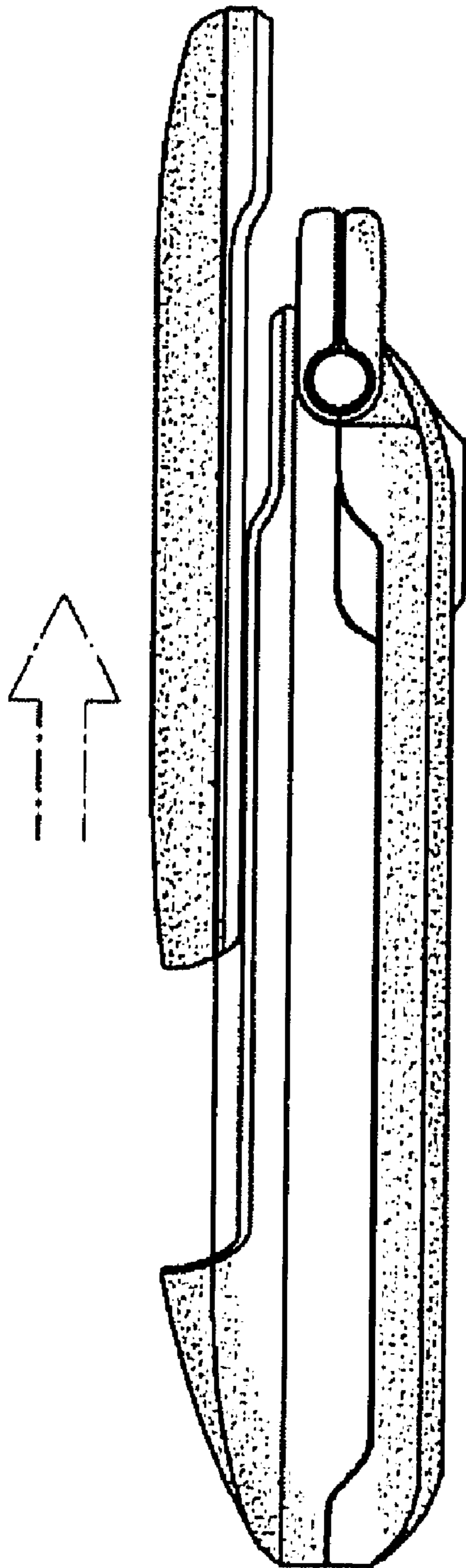
