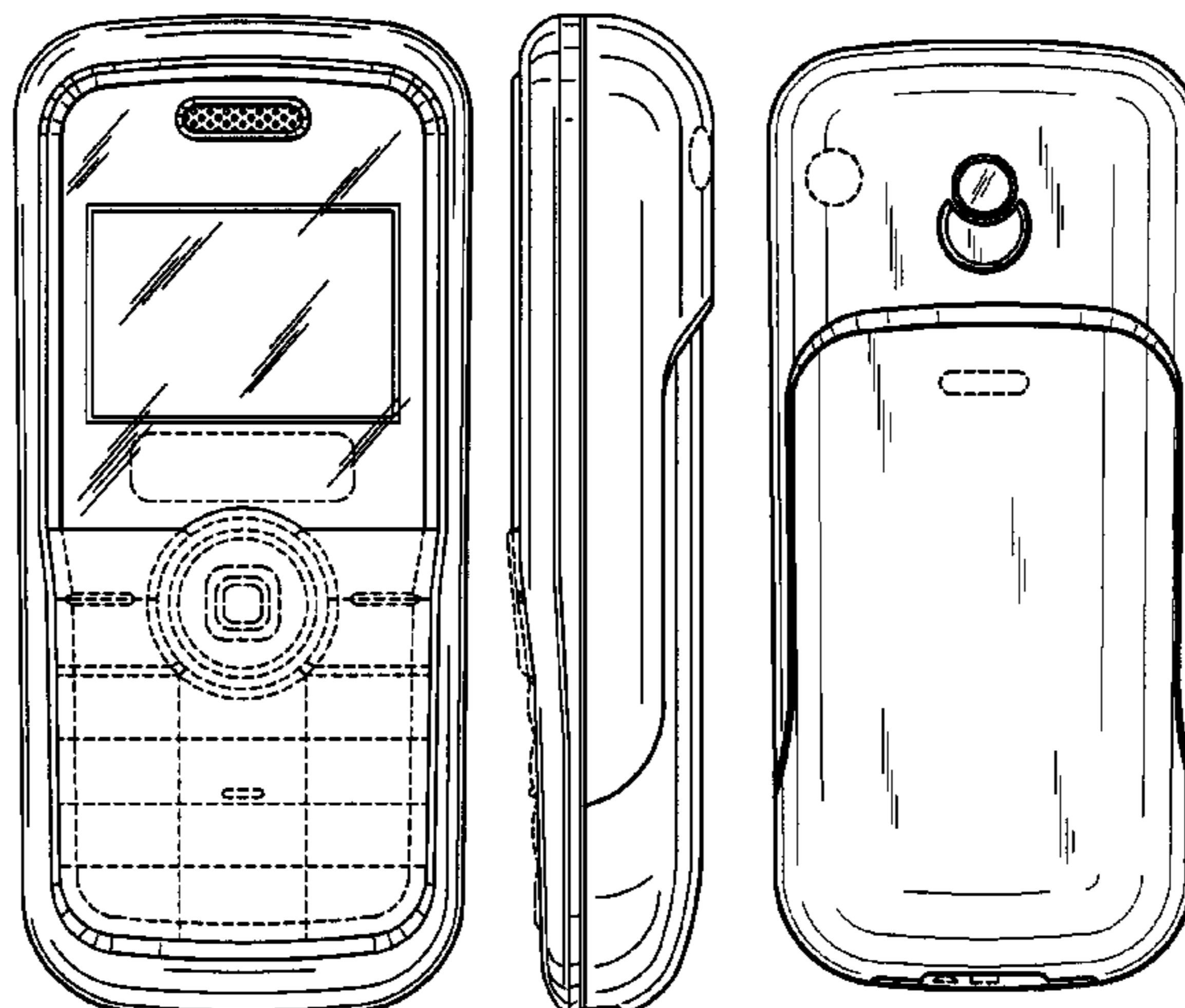
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a mobile communica-
tions device showing our design;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
The solid line immediately adjacent the unshaded area that
includes the broken line keypad, represent the boundary of
the claimed design. The broken lines are directed to envi-
ronment, and are for illustrative purposes only; The broken
lines form no part of the claimed design.

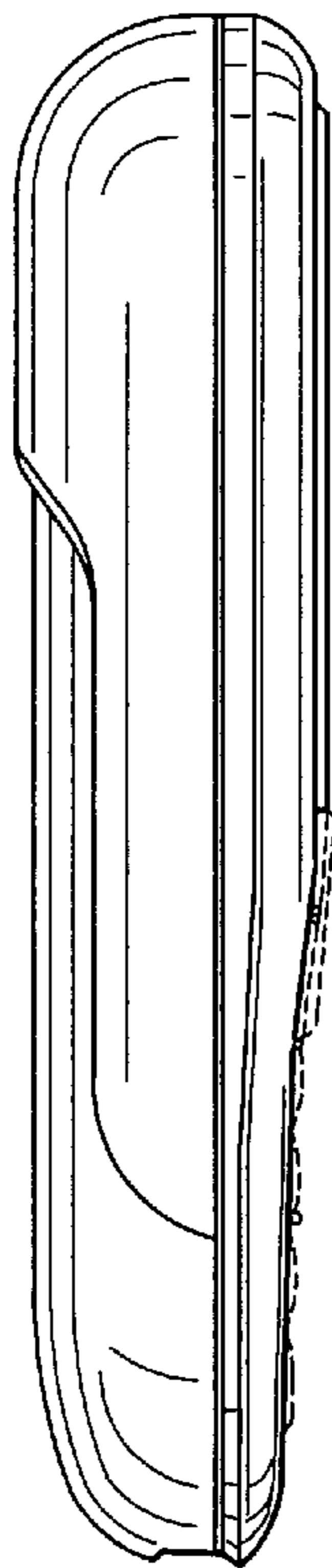
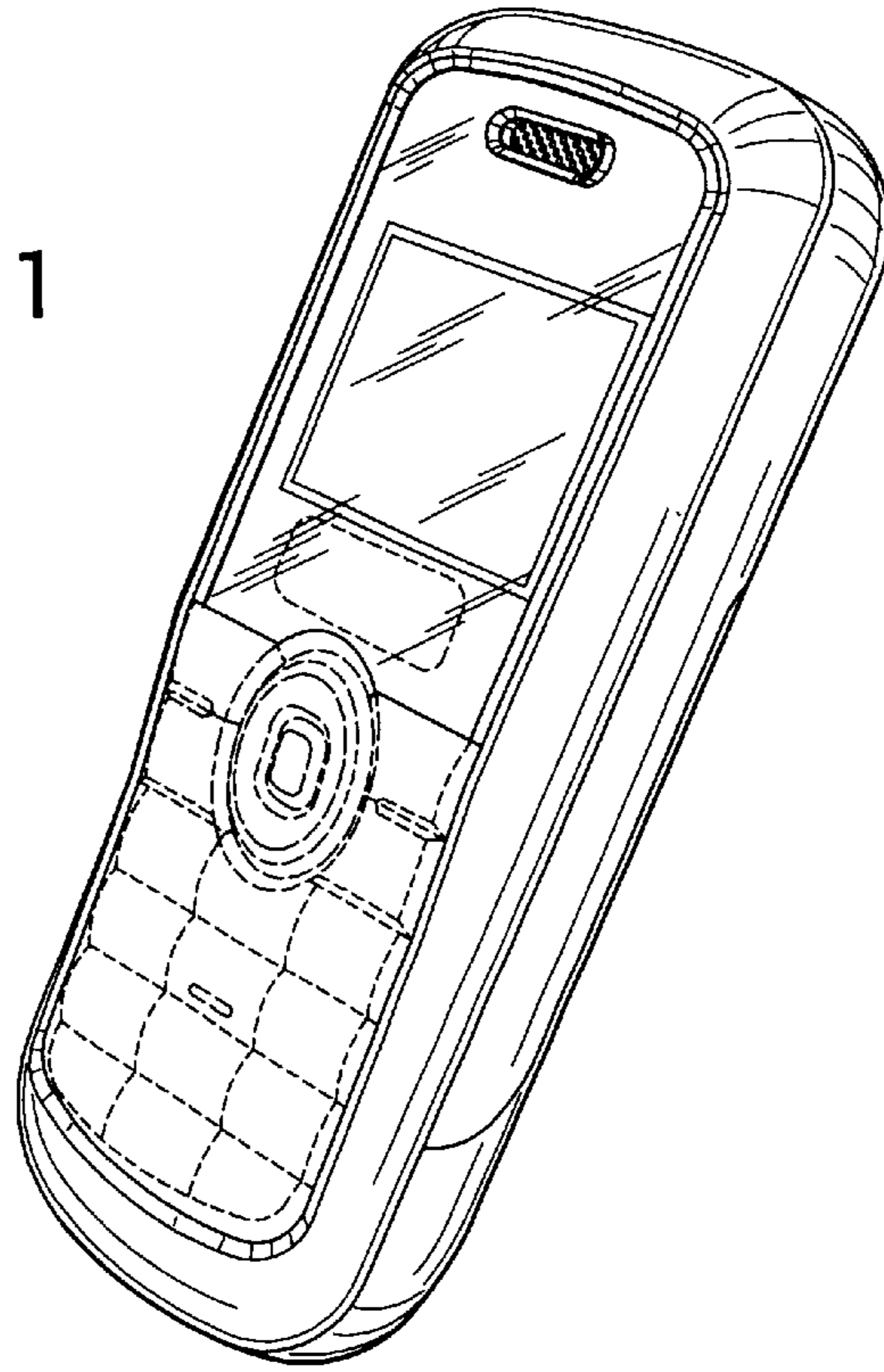

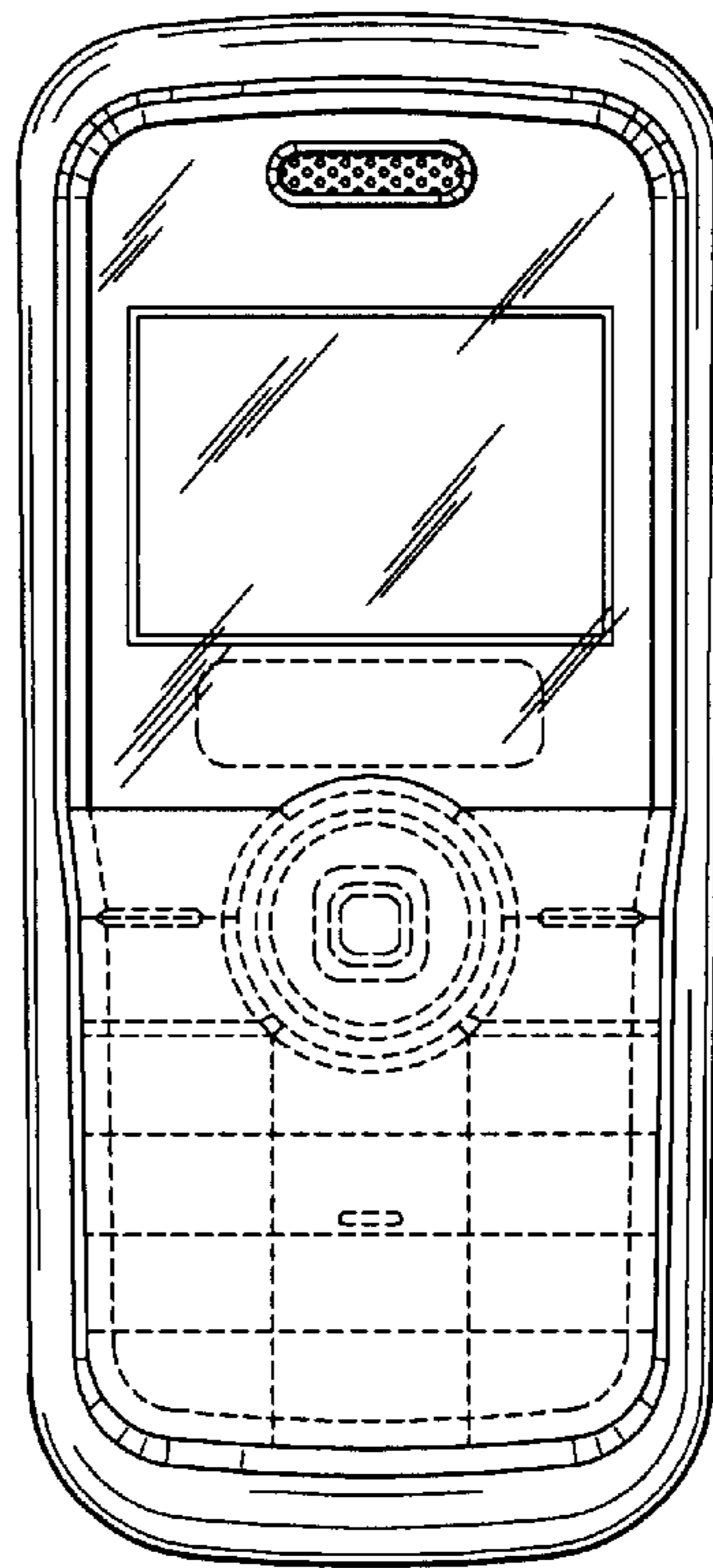

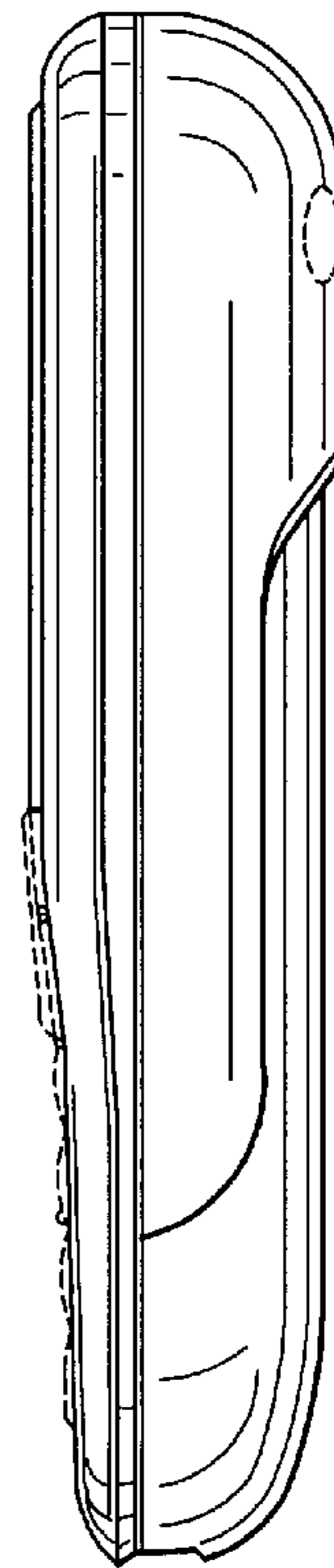

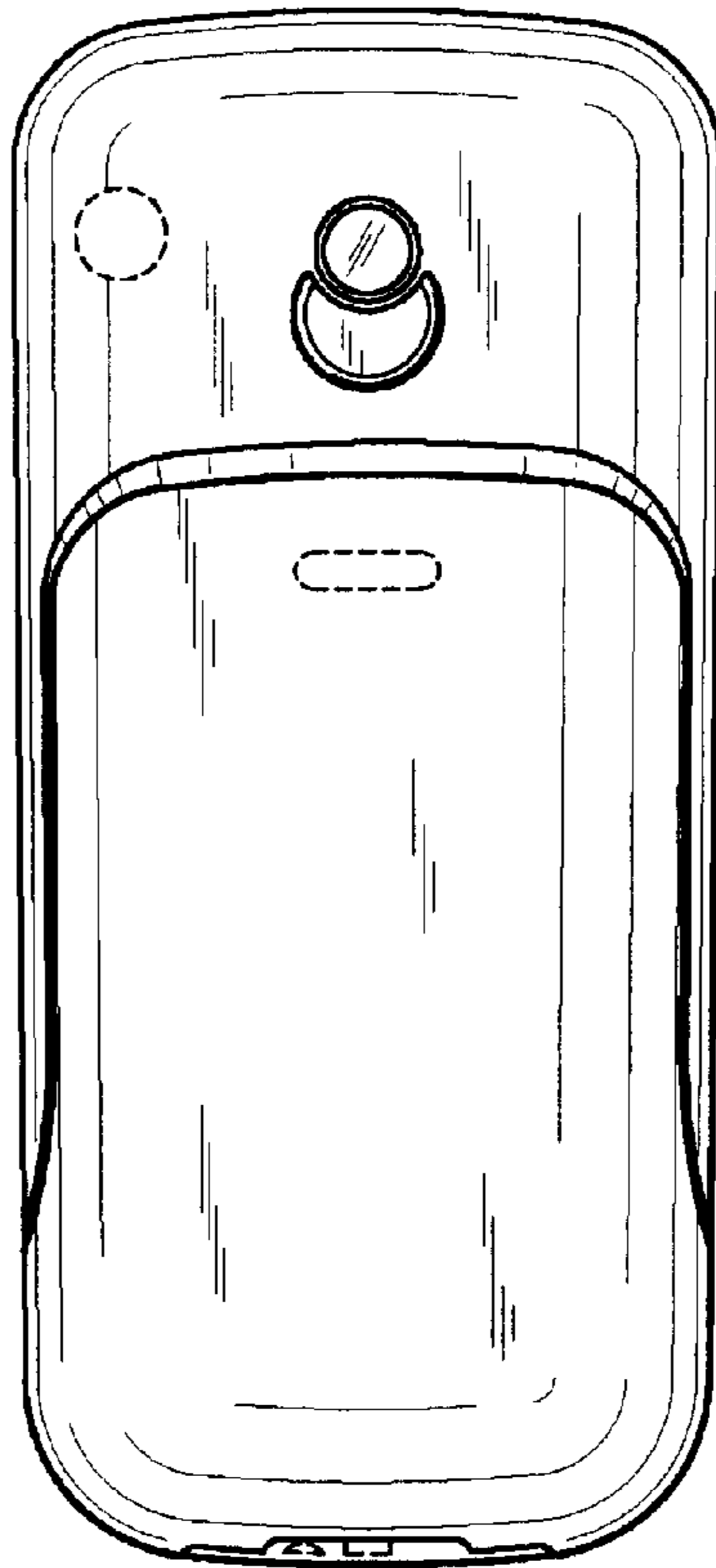

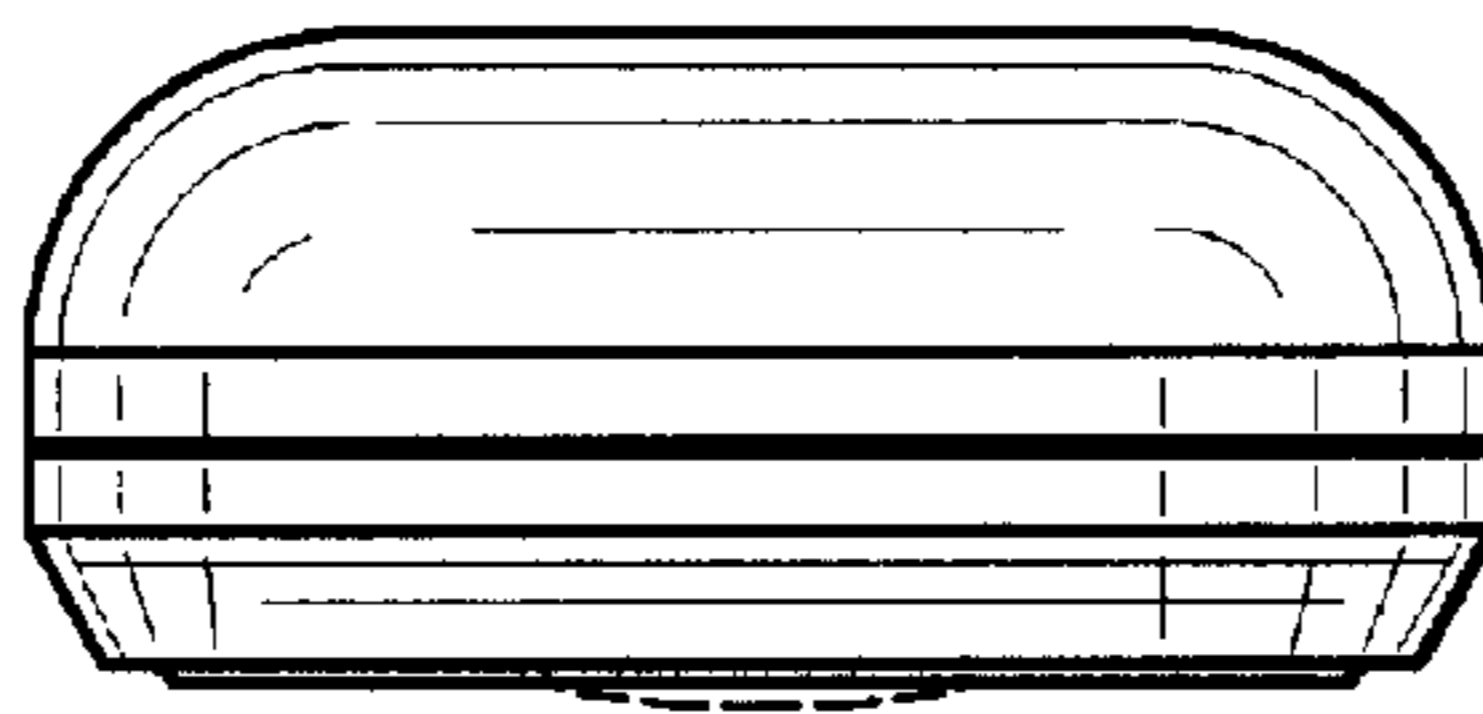

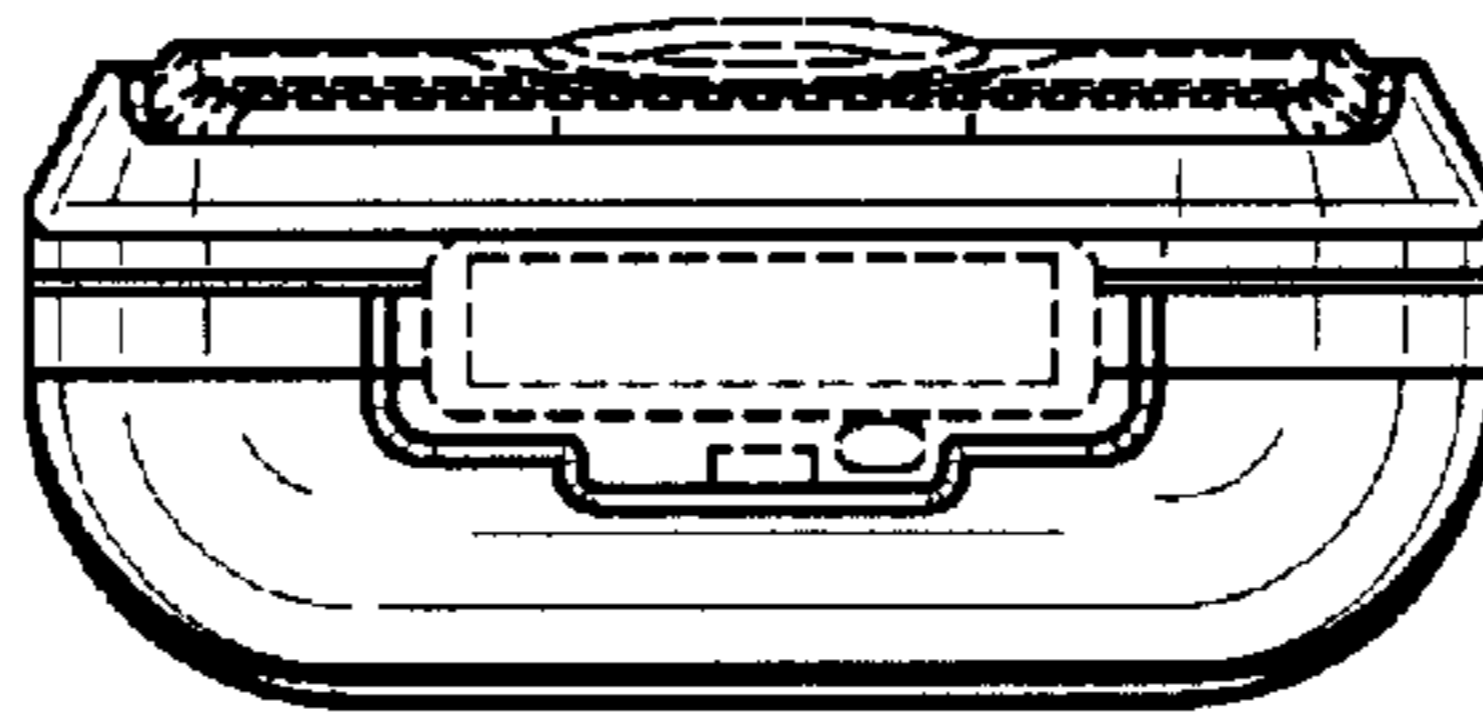
