(57) **CLAIM**

The ornamental design for front cover portion of a handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom view of a front cover portion of a handset showing my new design in isolation;

FIG. 9 is a front view thereof;

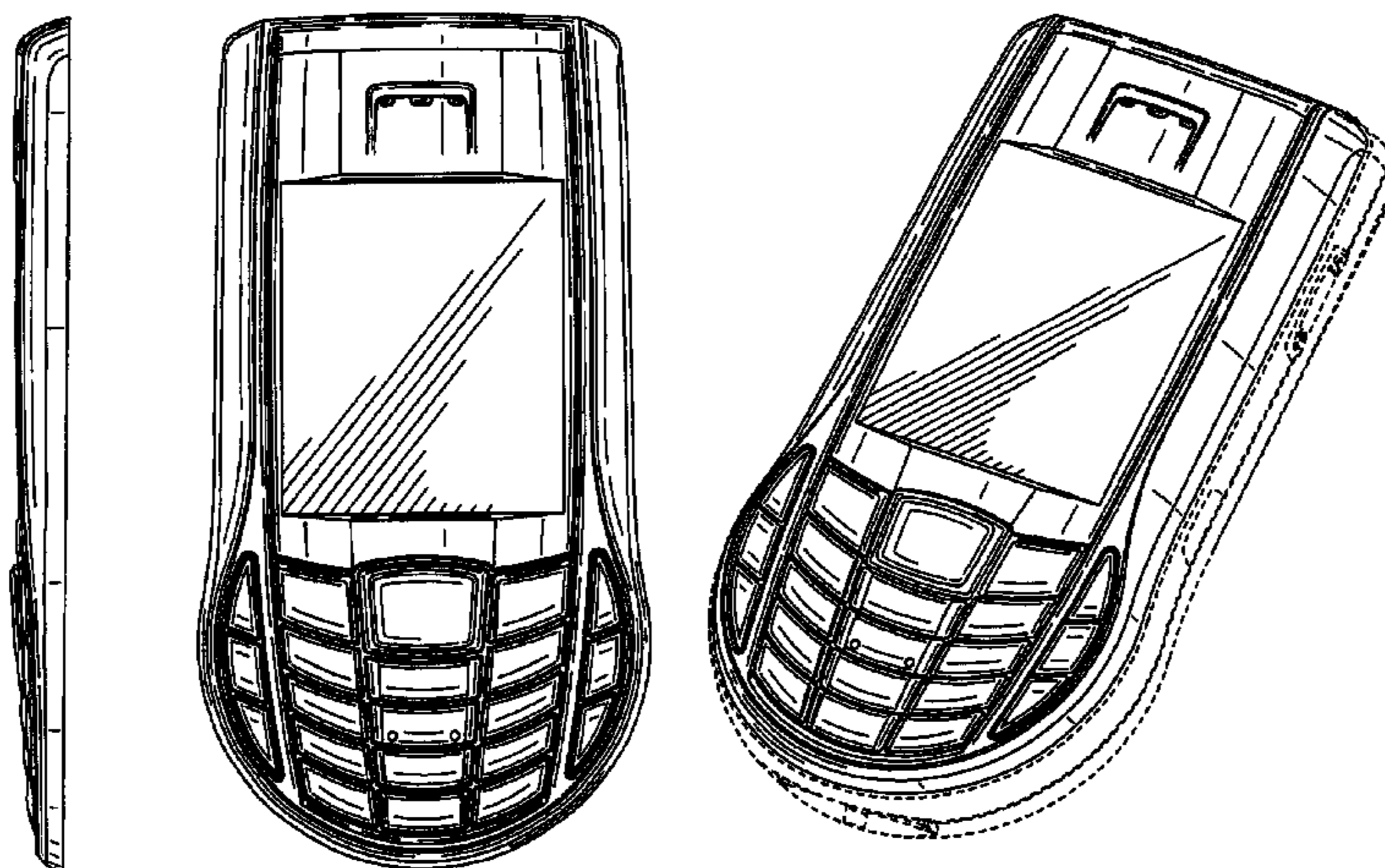
FIG. 10 is a left side view thereof;

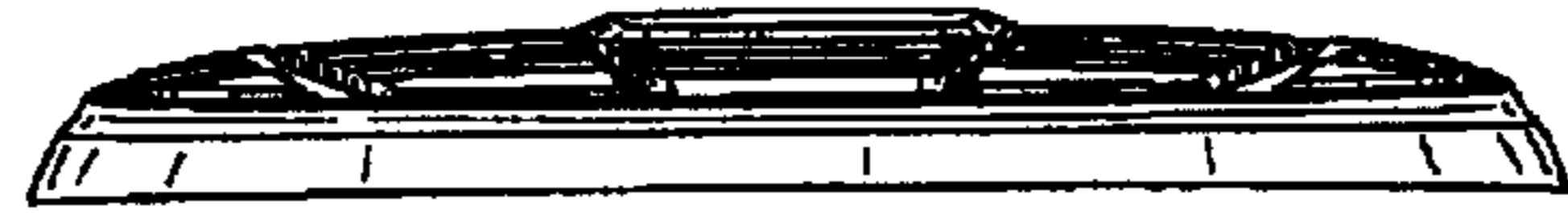

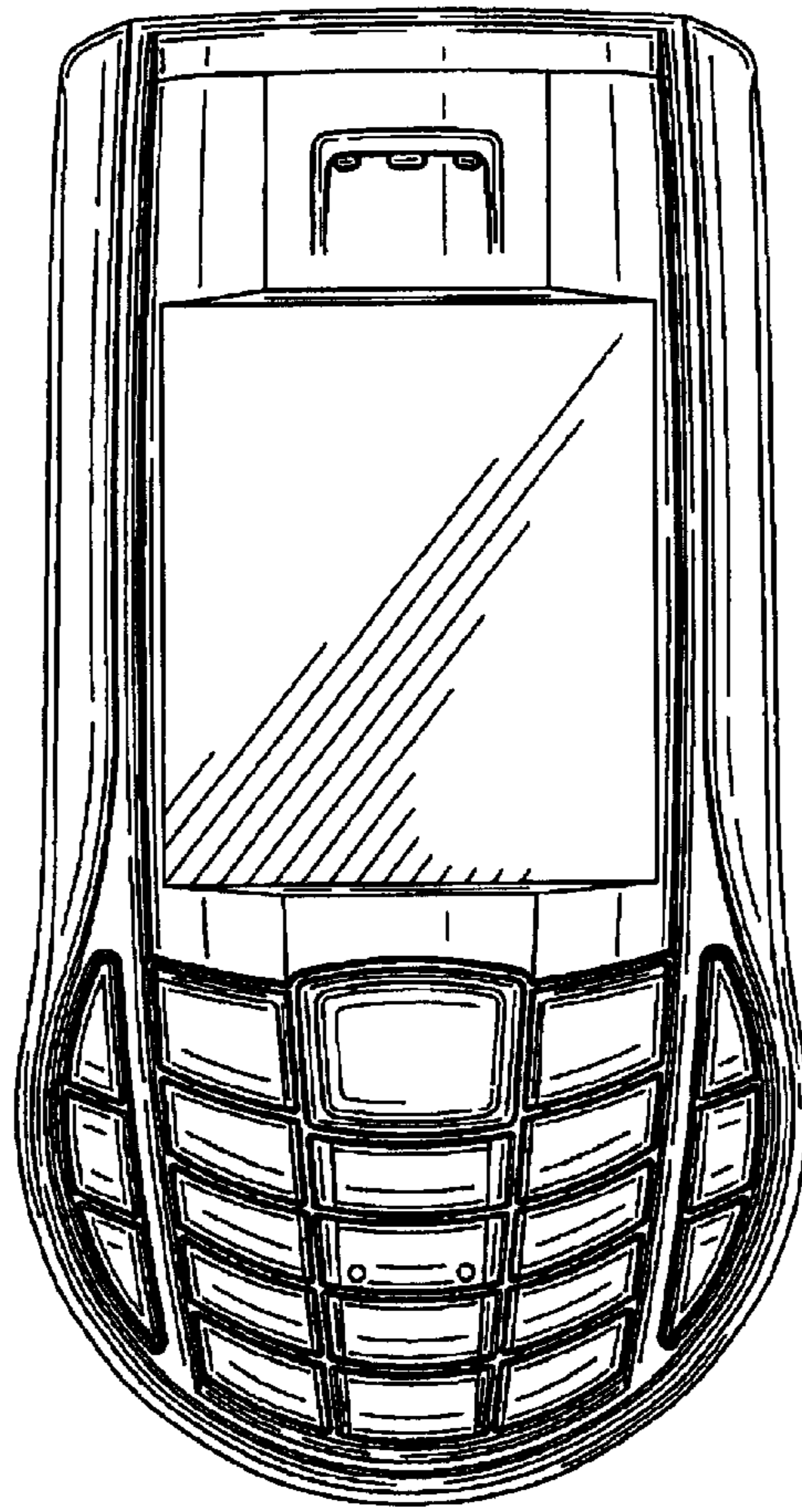

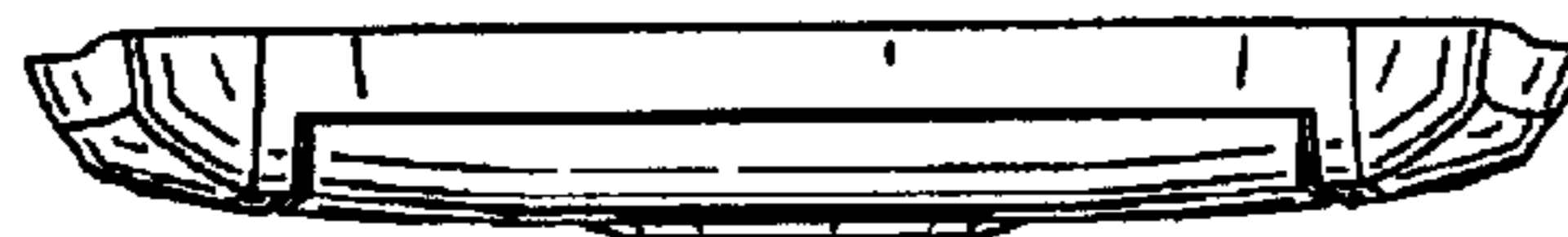

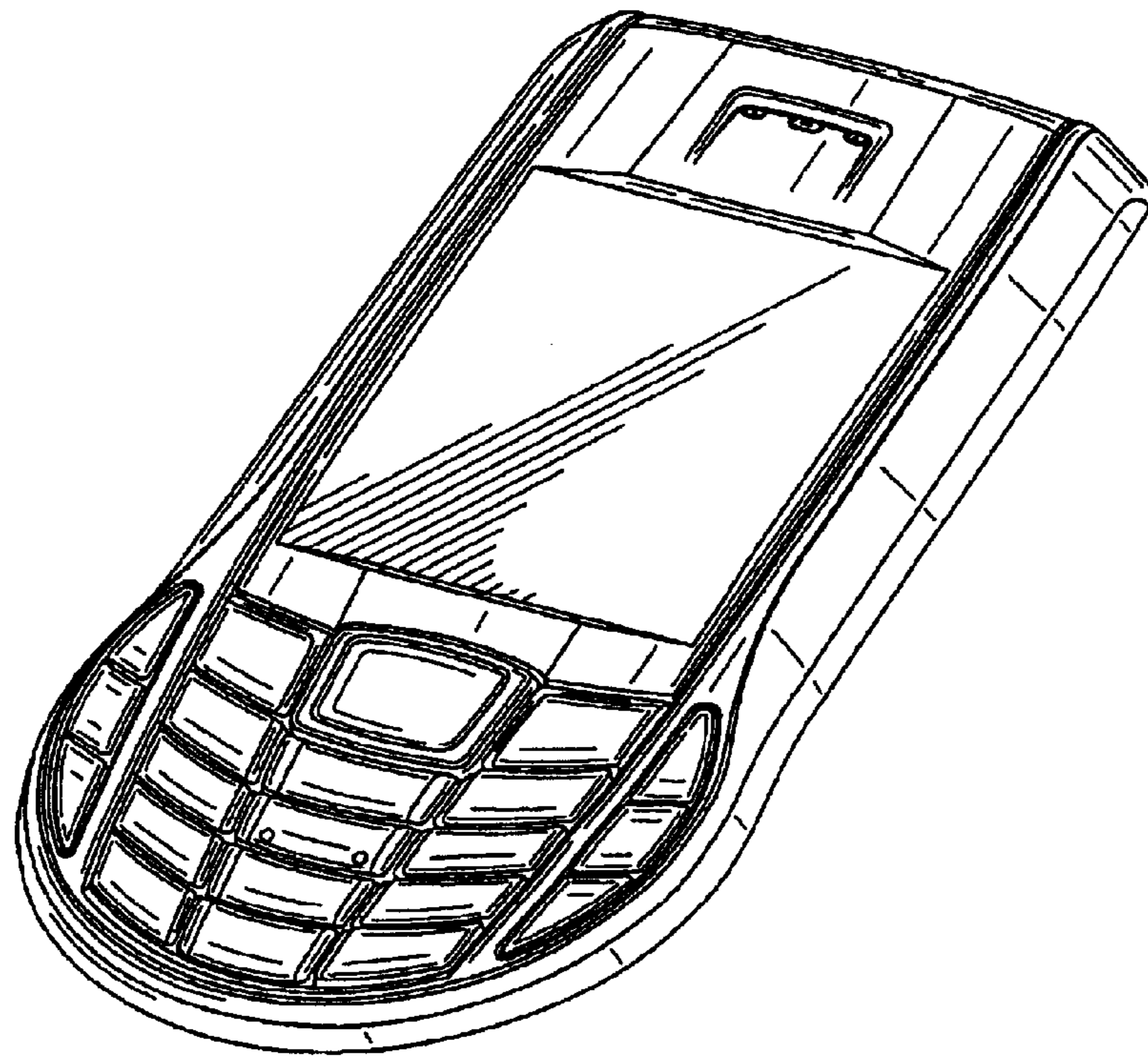

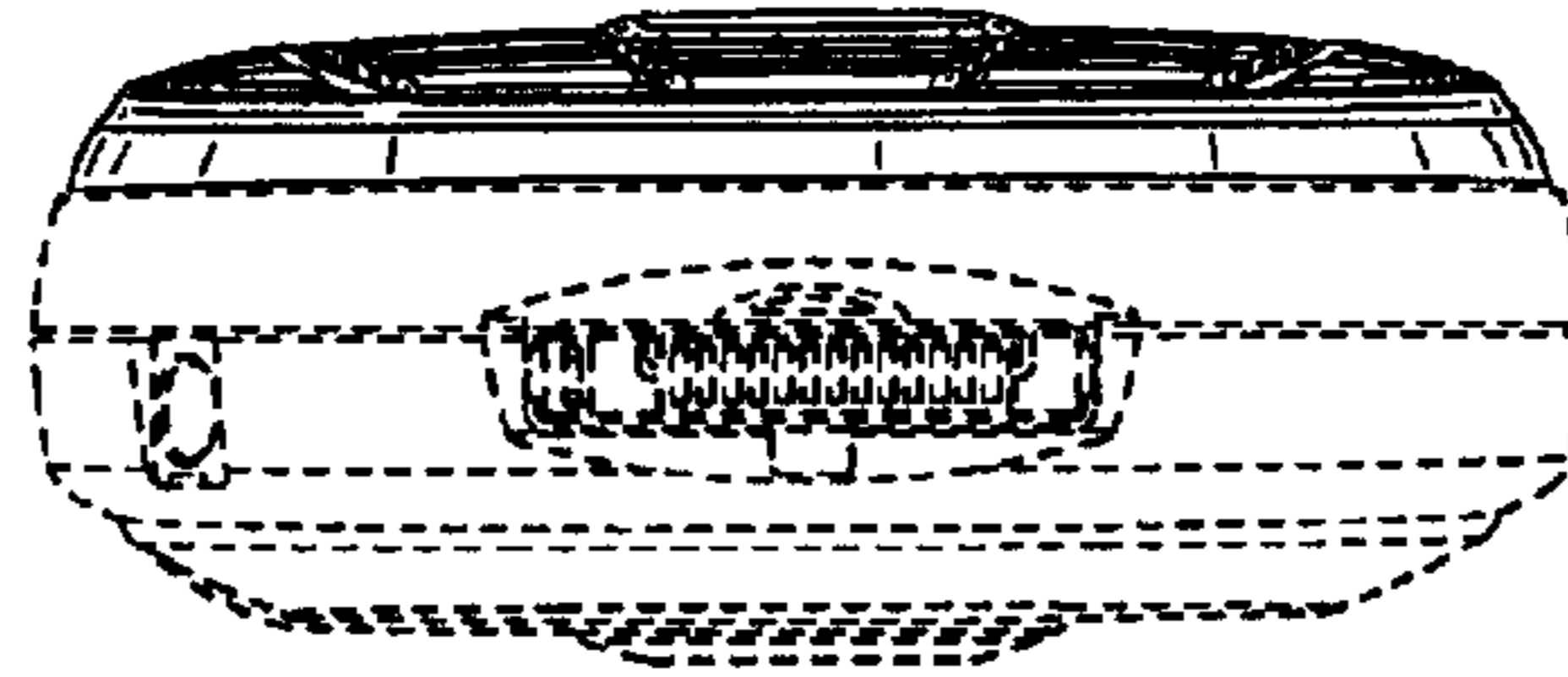

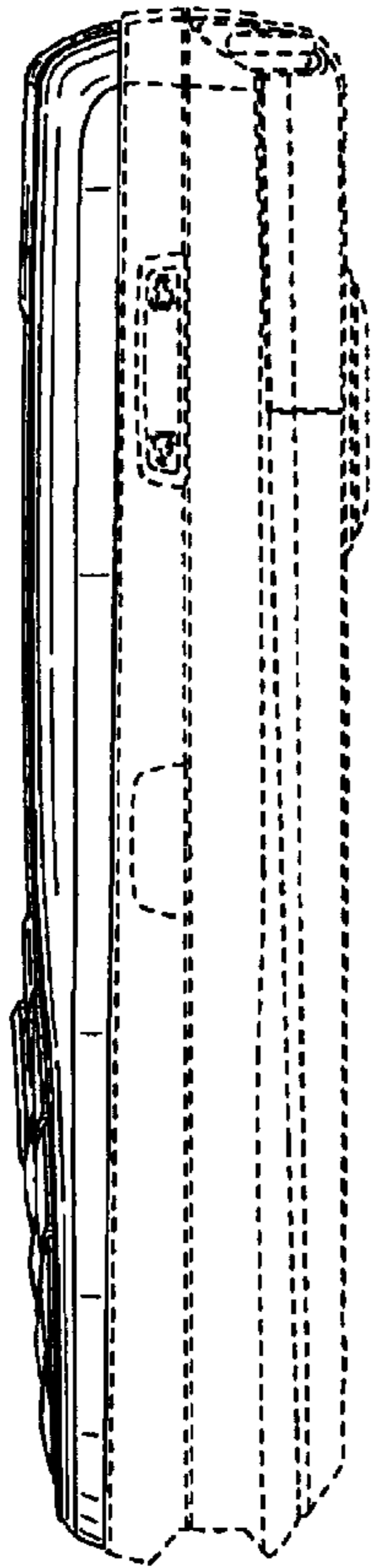

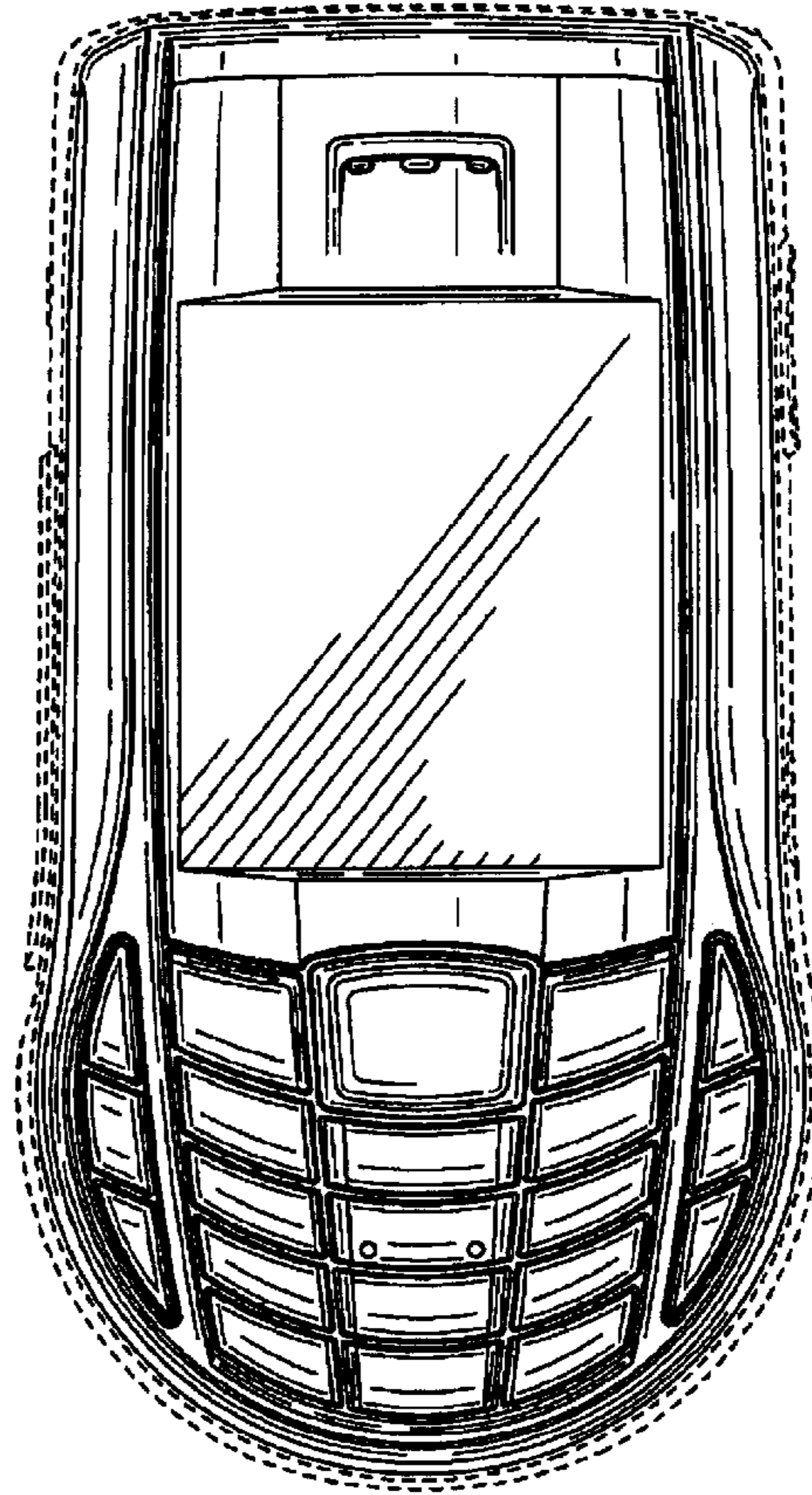

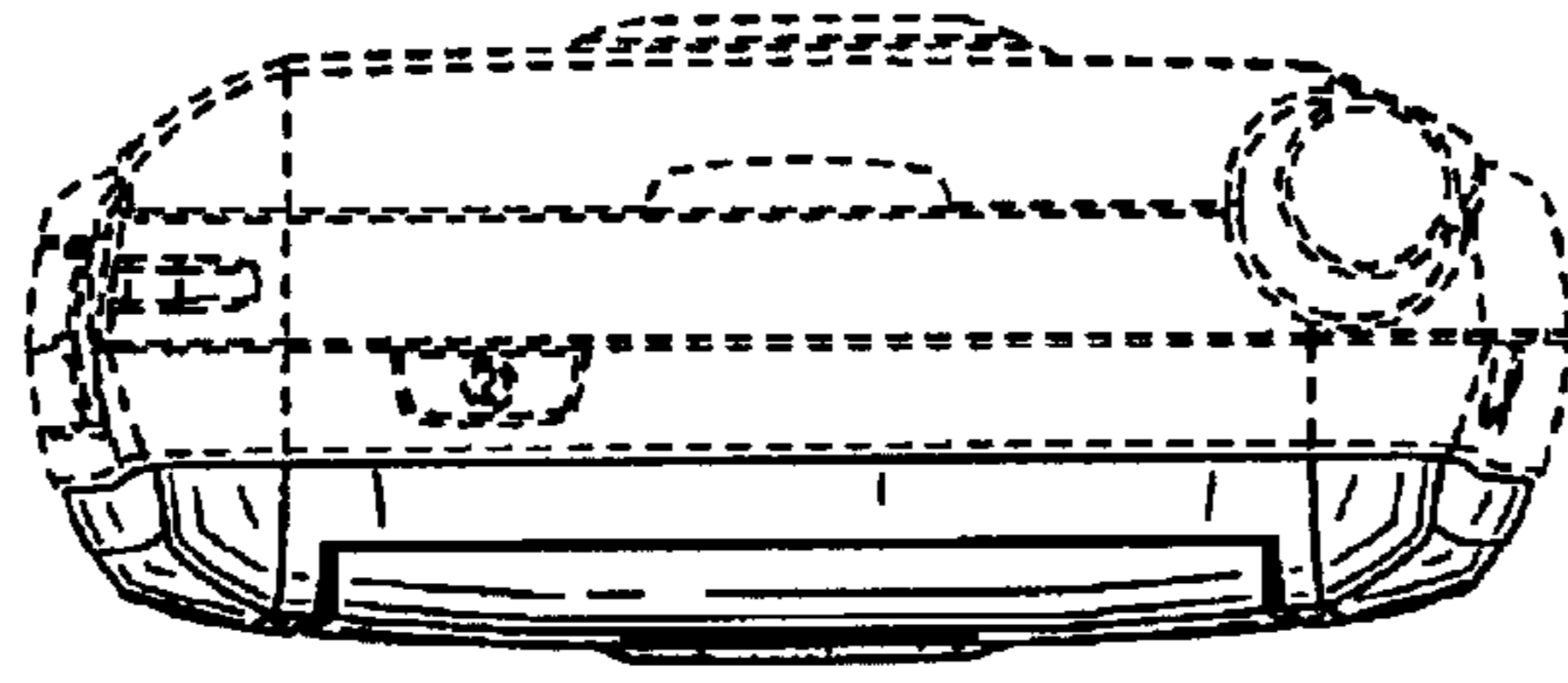

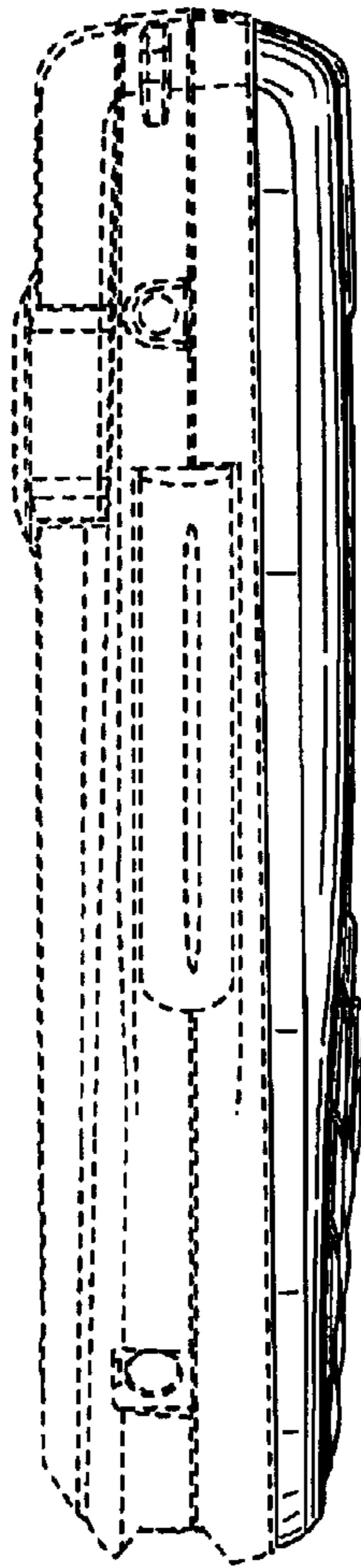

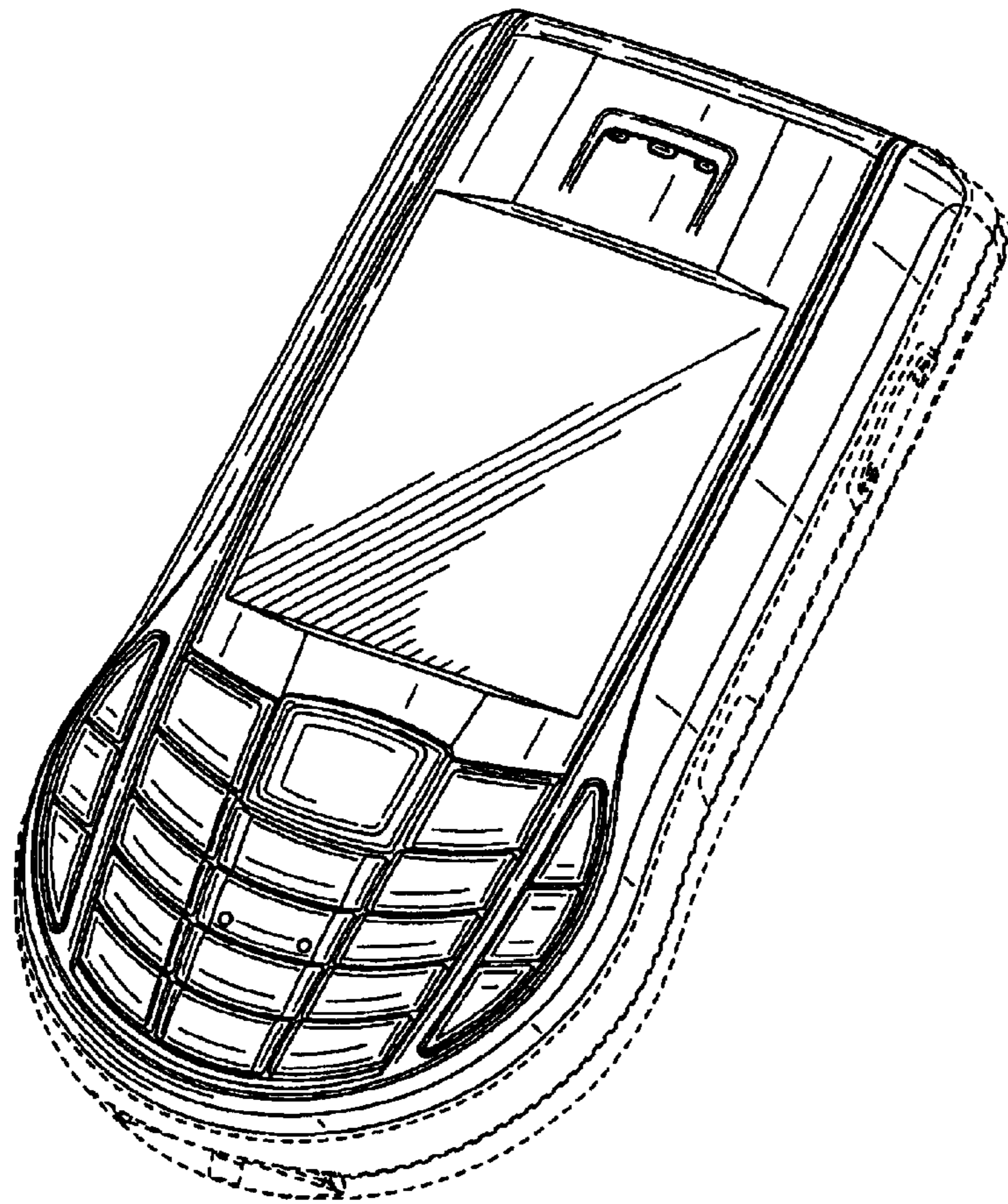
