The ornamental design for an automatic injector, as shown and described.

DESCRIPTION

FIG. 1 is a front, left, top, perspective view of an automatic injector, showing our new design;

FIG. 2 is a rear, right, bottom, perspective view thereof;

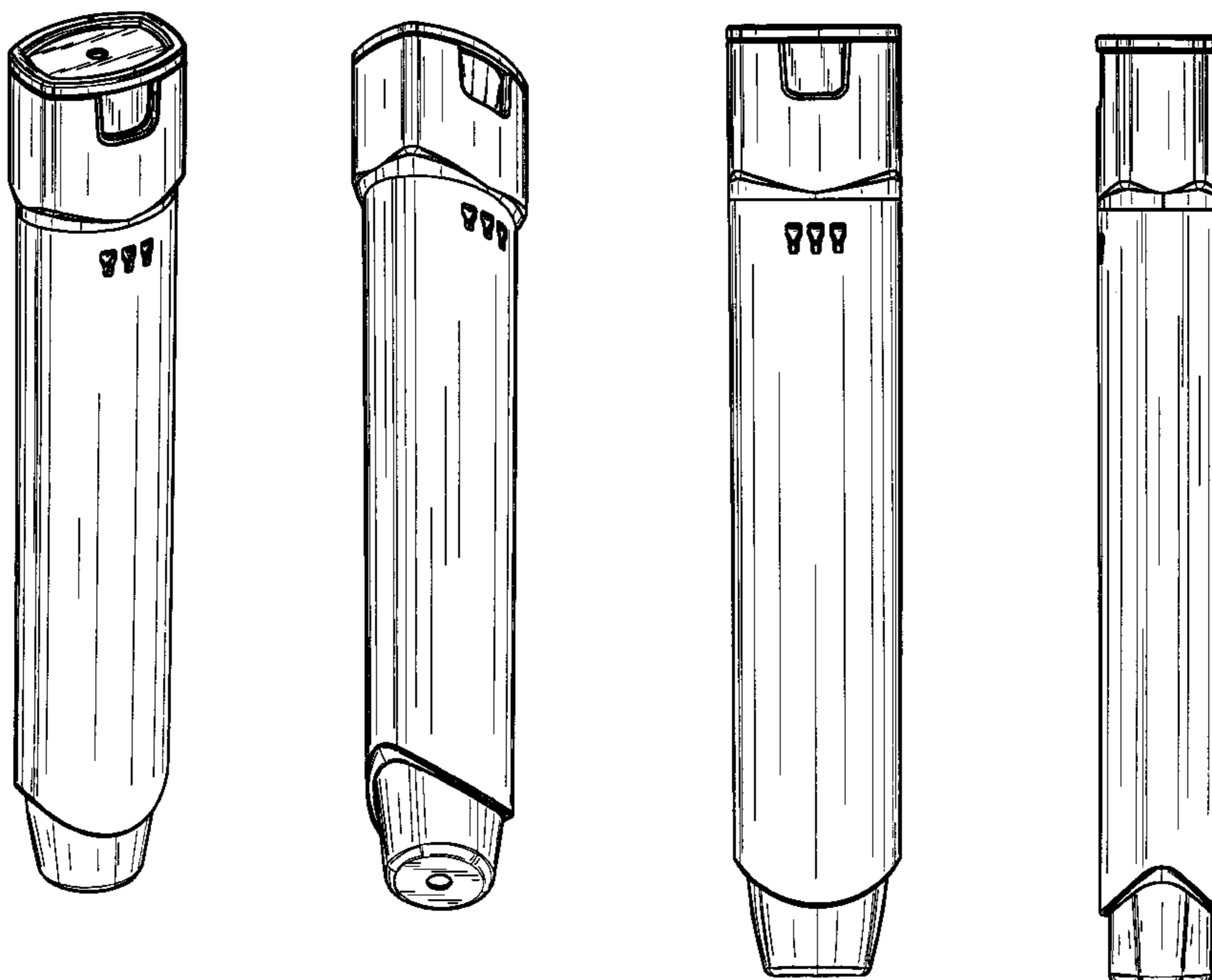
FIG. 3 is a front elevational view thereof, the rear elevational view being identical;

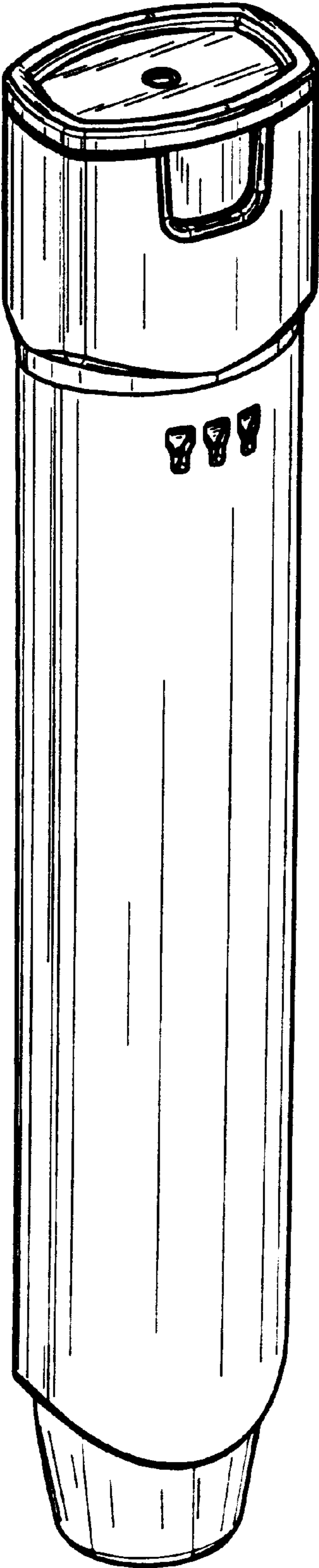

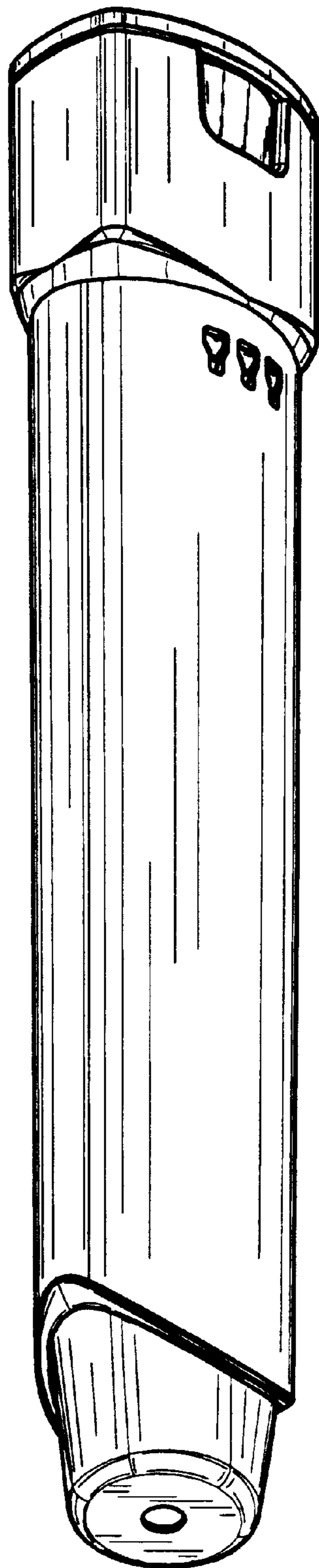

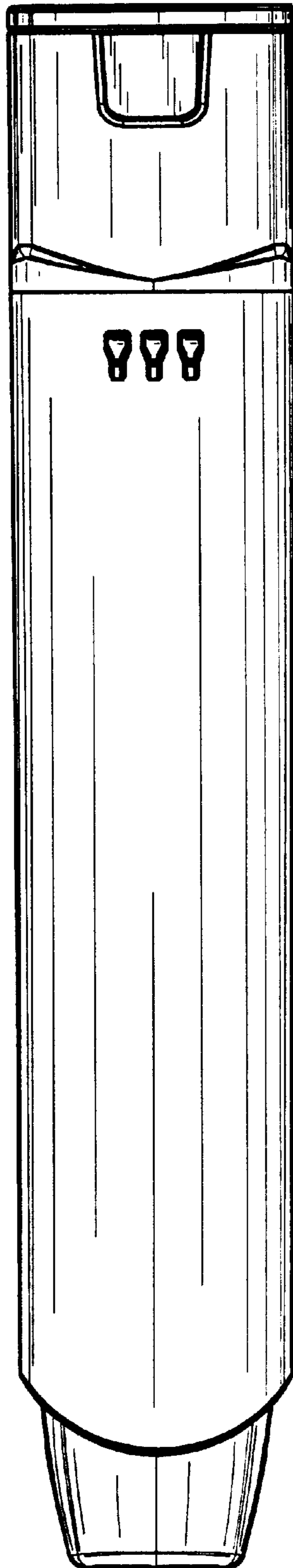

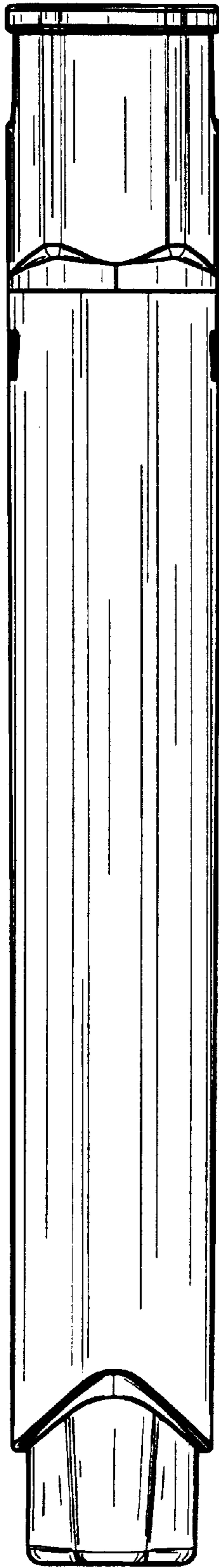

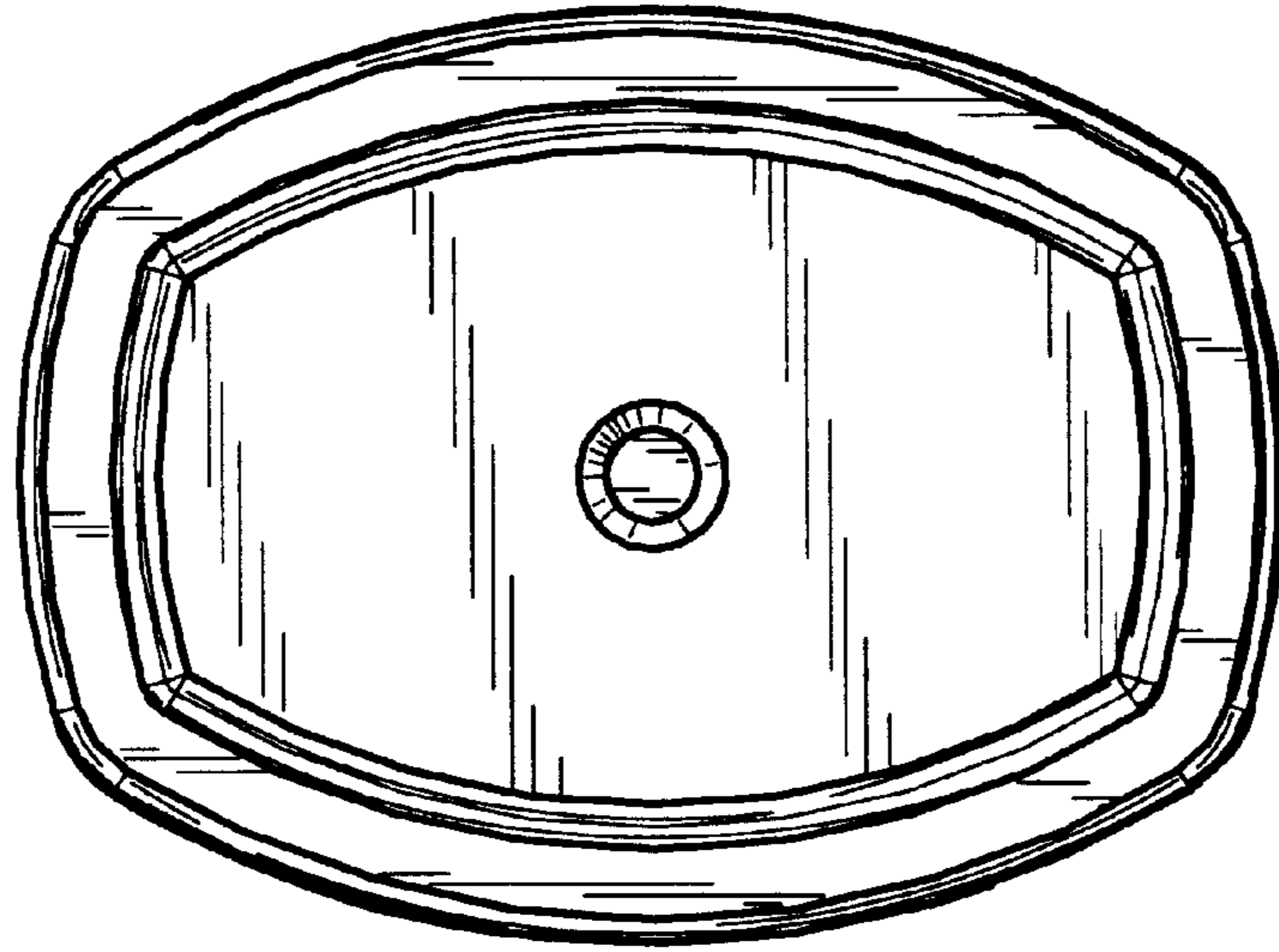

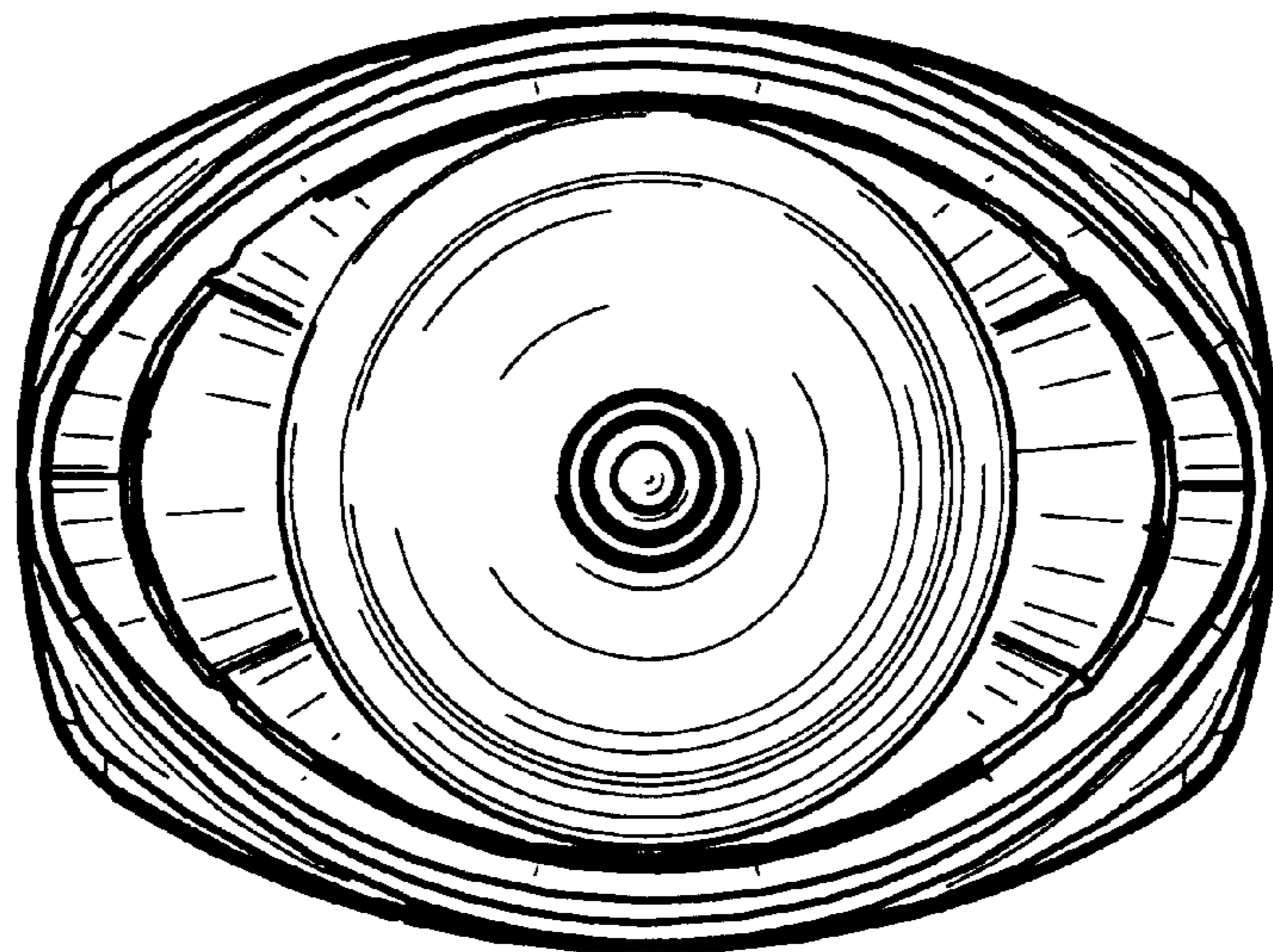
