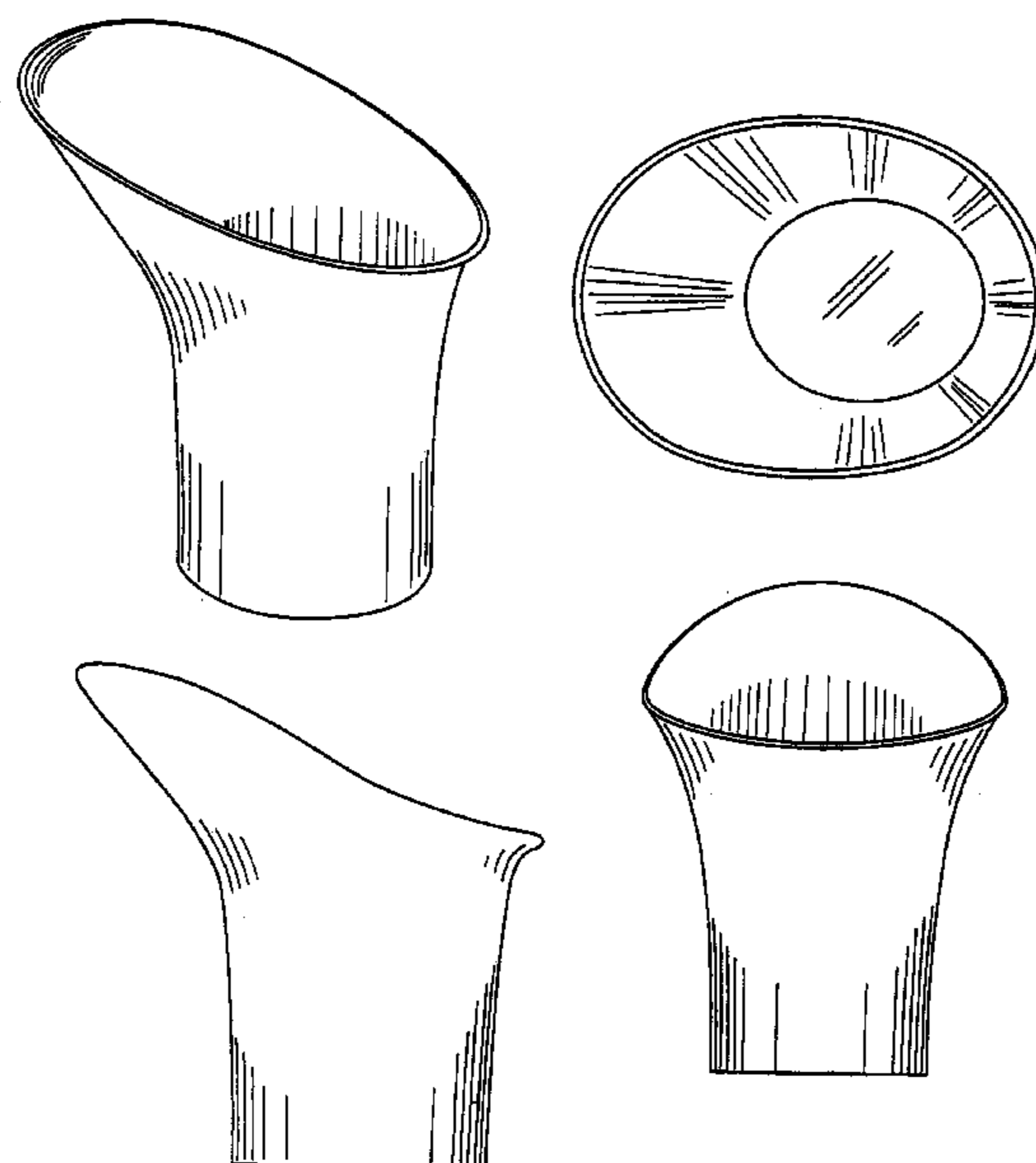
(57) **CLAIM**

The ornamental design for a urine sample collector for women, as shown and described.

**DESCRIPTION**

FIG. 1 is a front/right/top perspective view of a urine sample collector for women, showing my new design; FIG. 2 is a right side elevational view, the left side elevational view being a mirror image thereof; FIG. 3 is top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a right side elevational view of a plurality of stacked urine sample collectors.

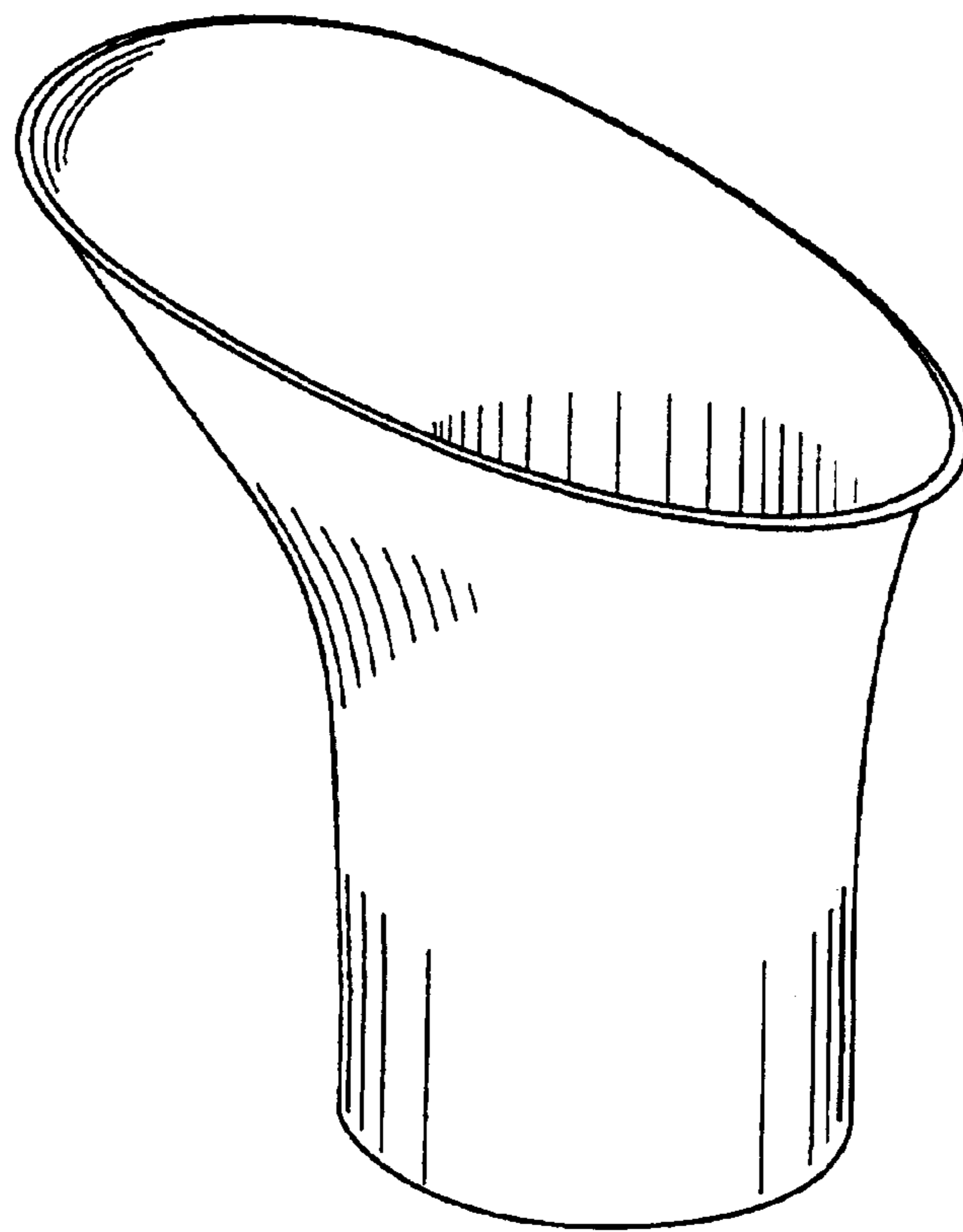

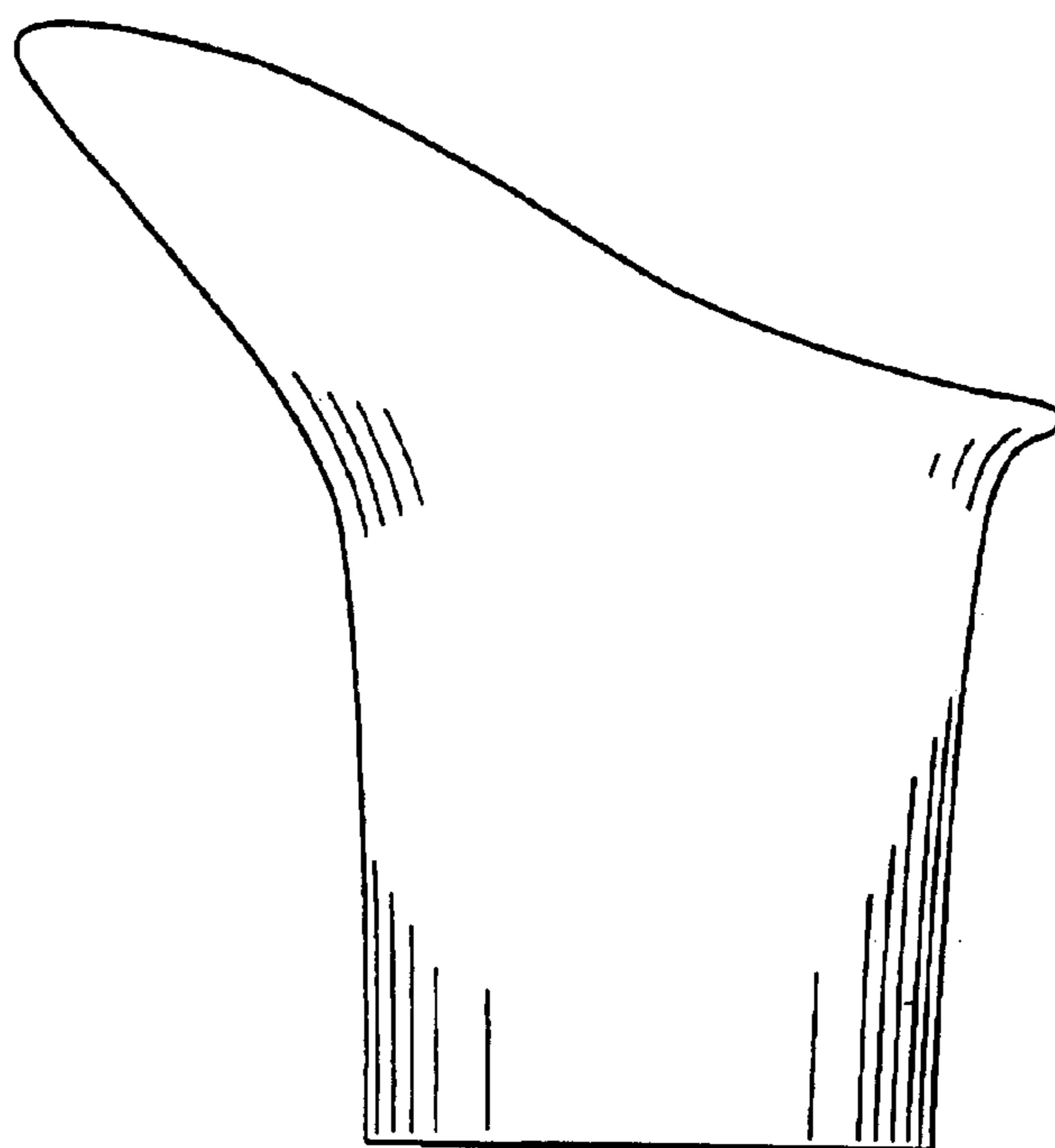

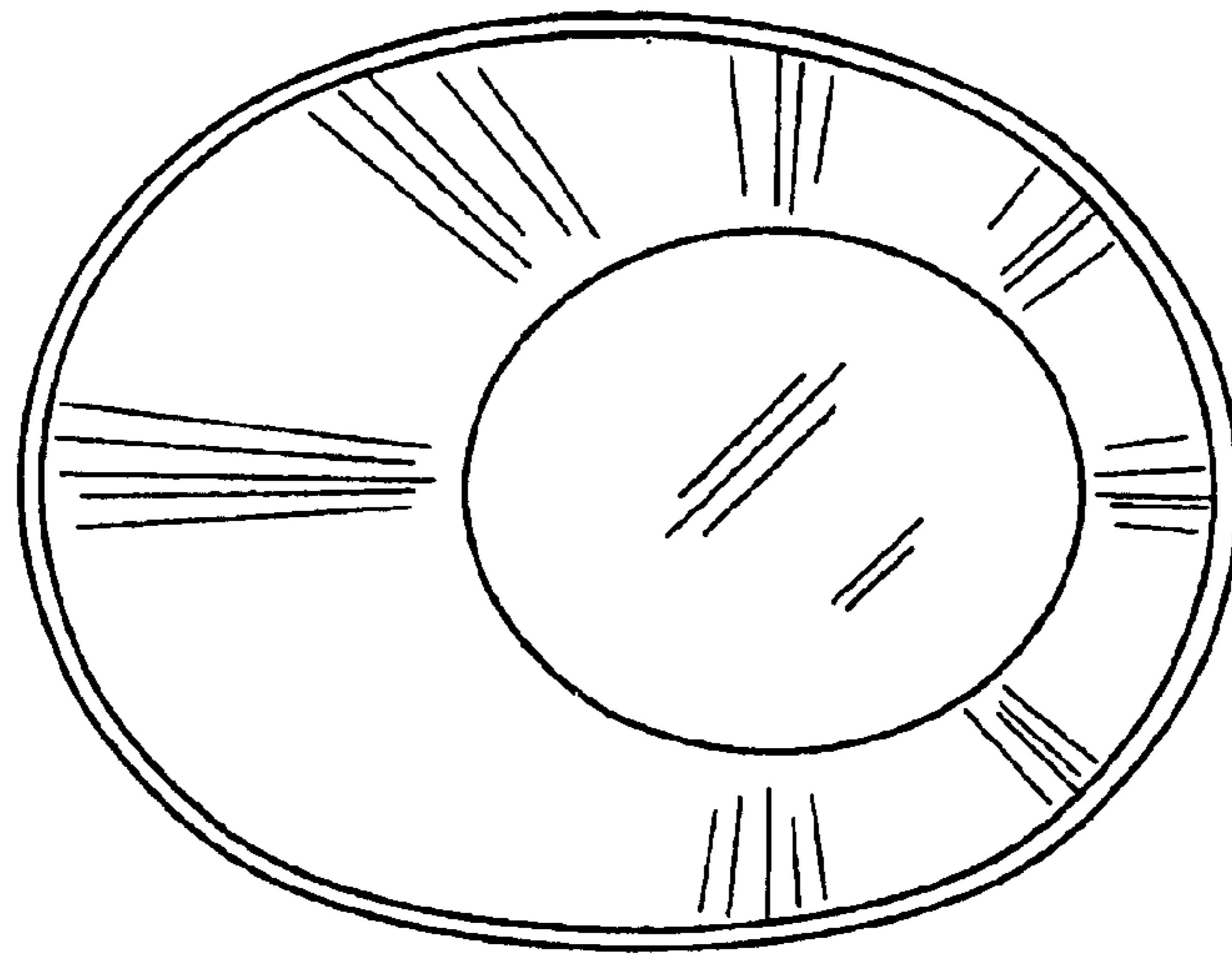

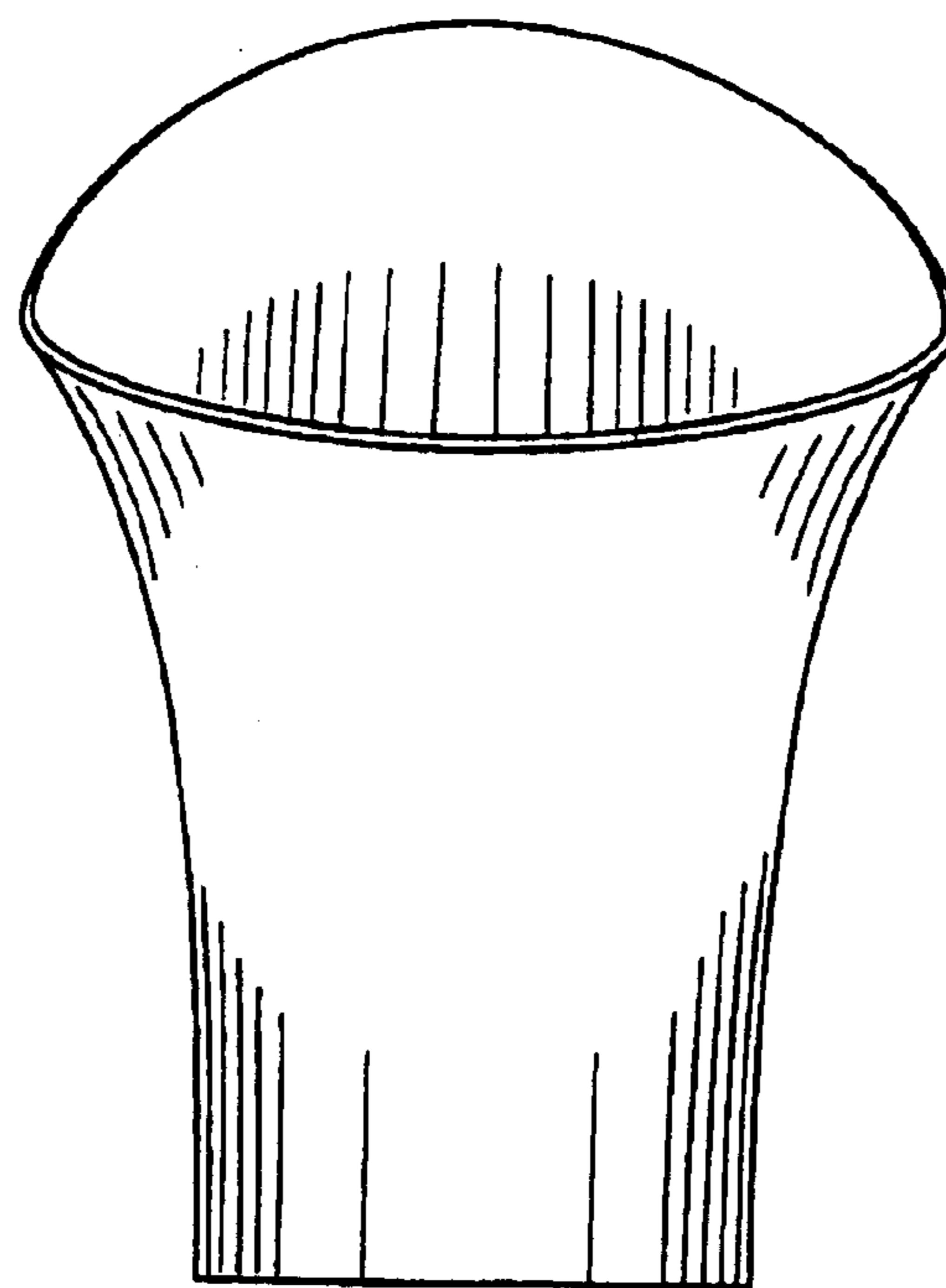

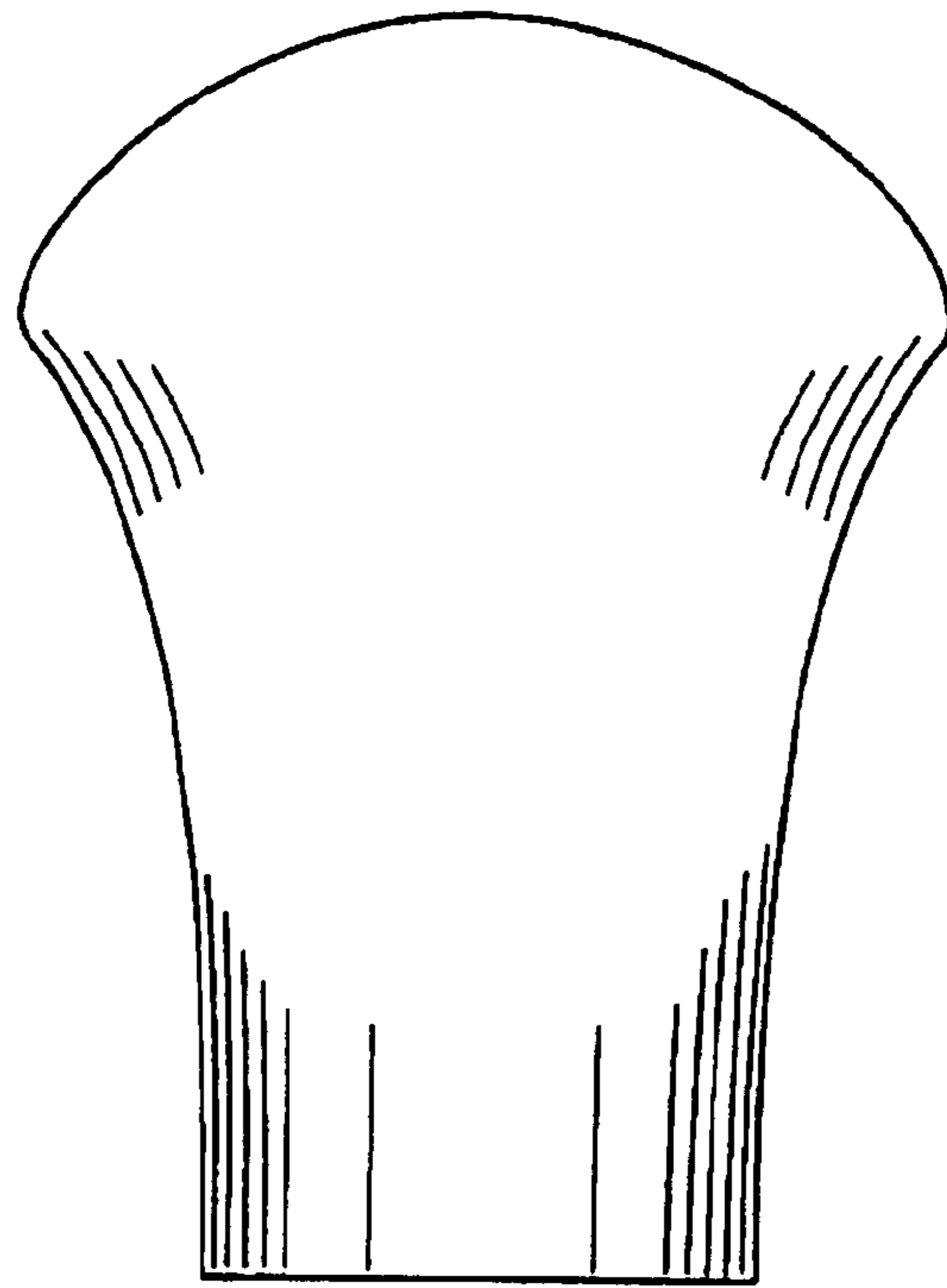

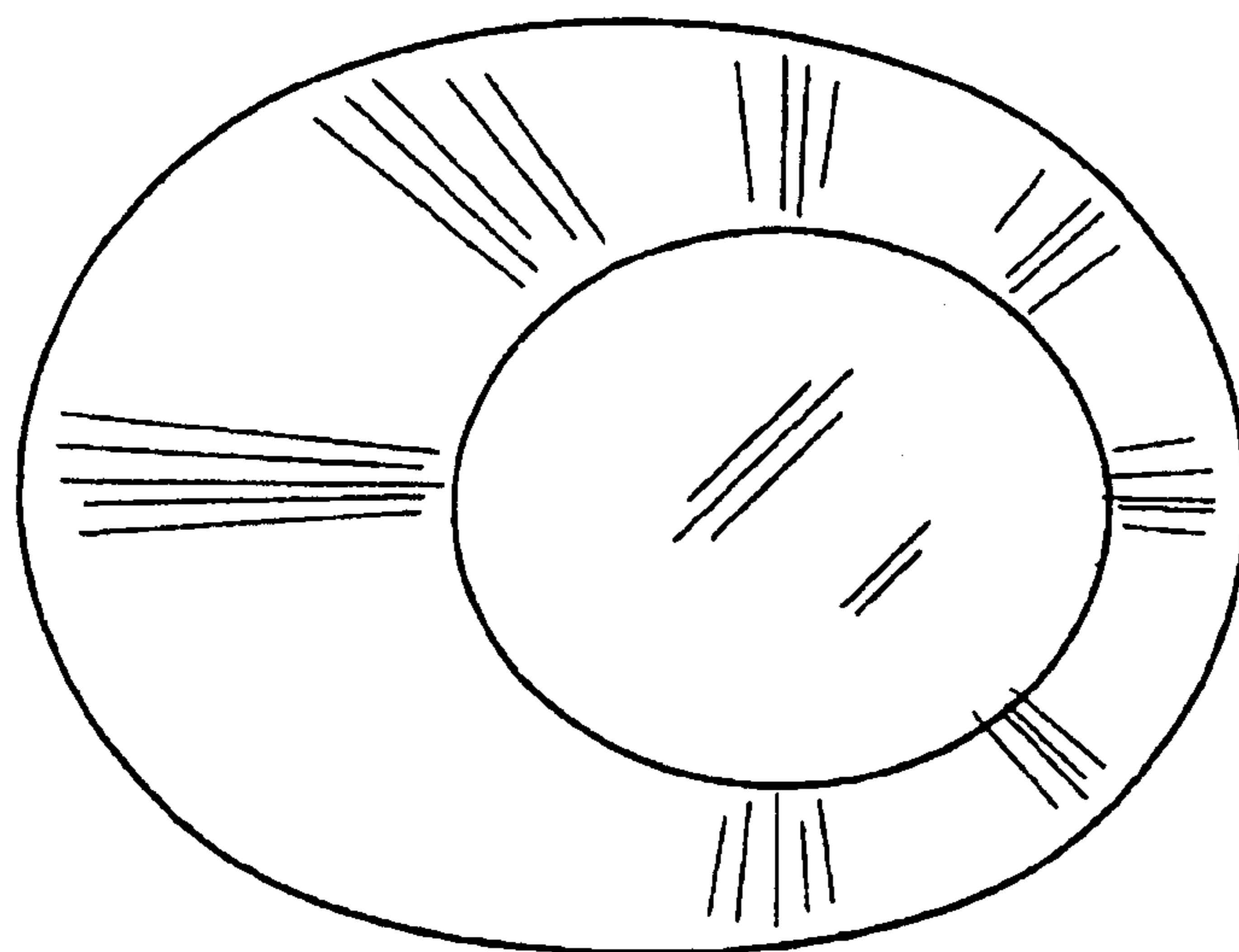

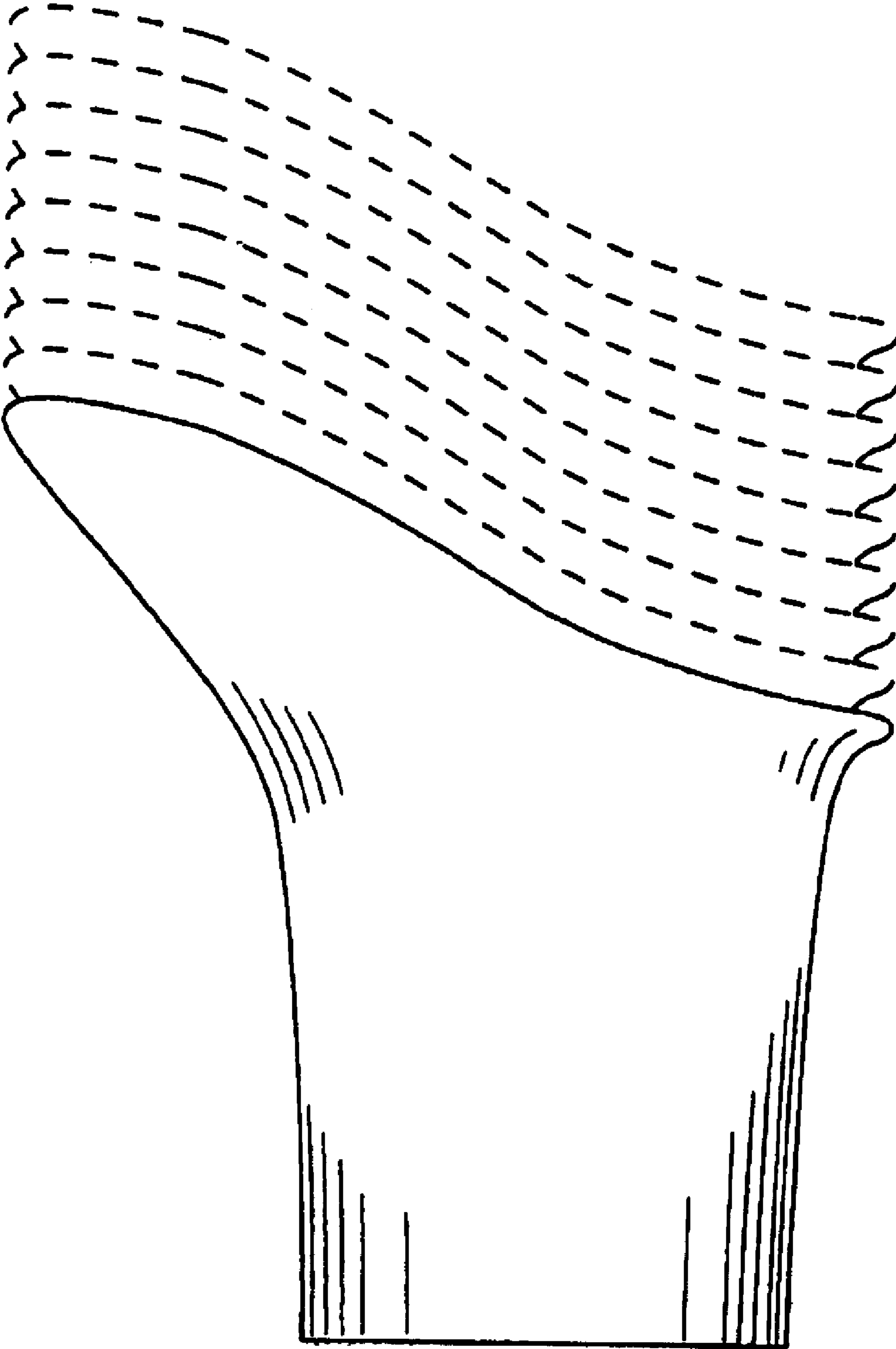
