FIG. 6 is a front view of the light fixture in accordance with the fourth embodiment of the invention.

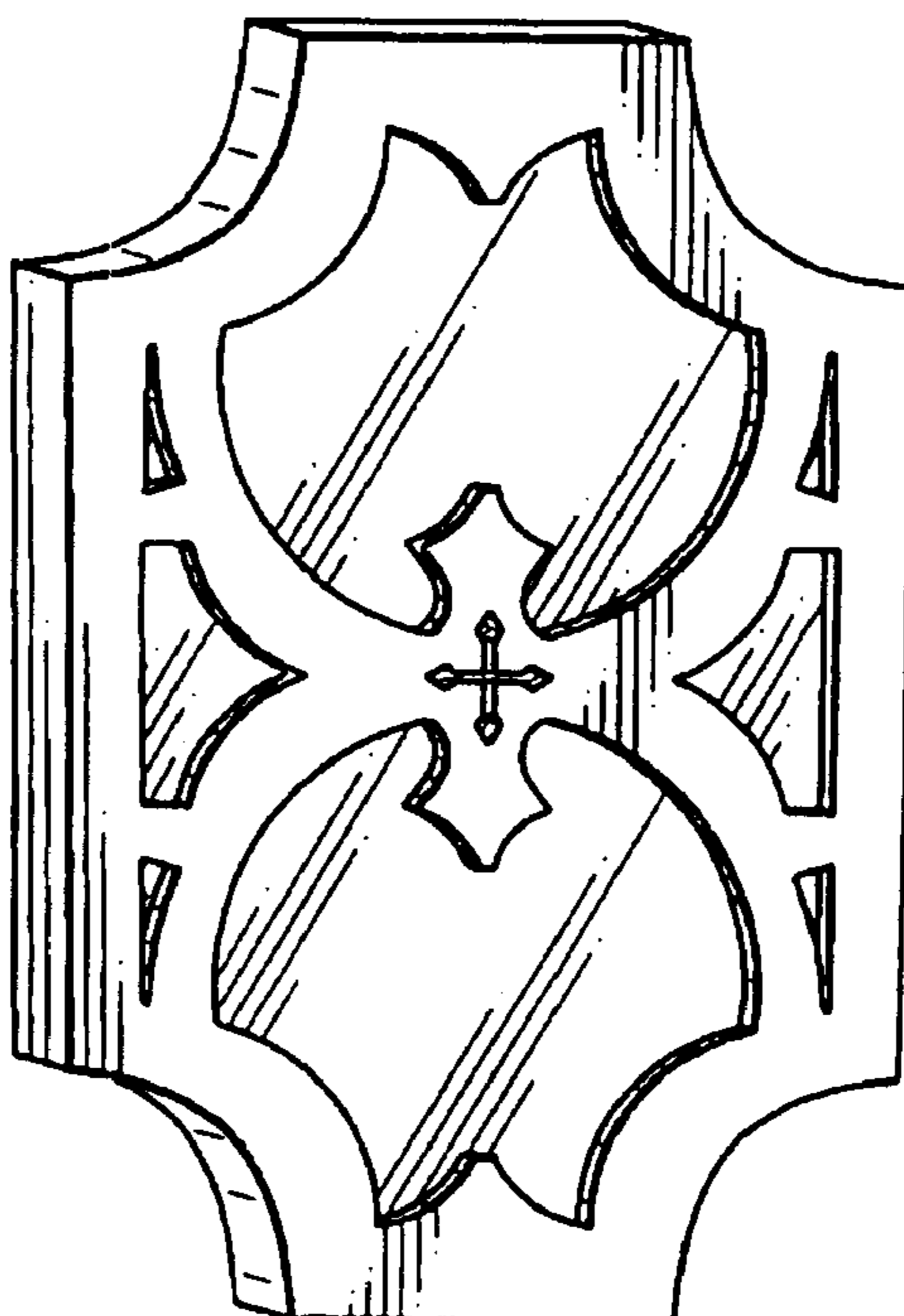

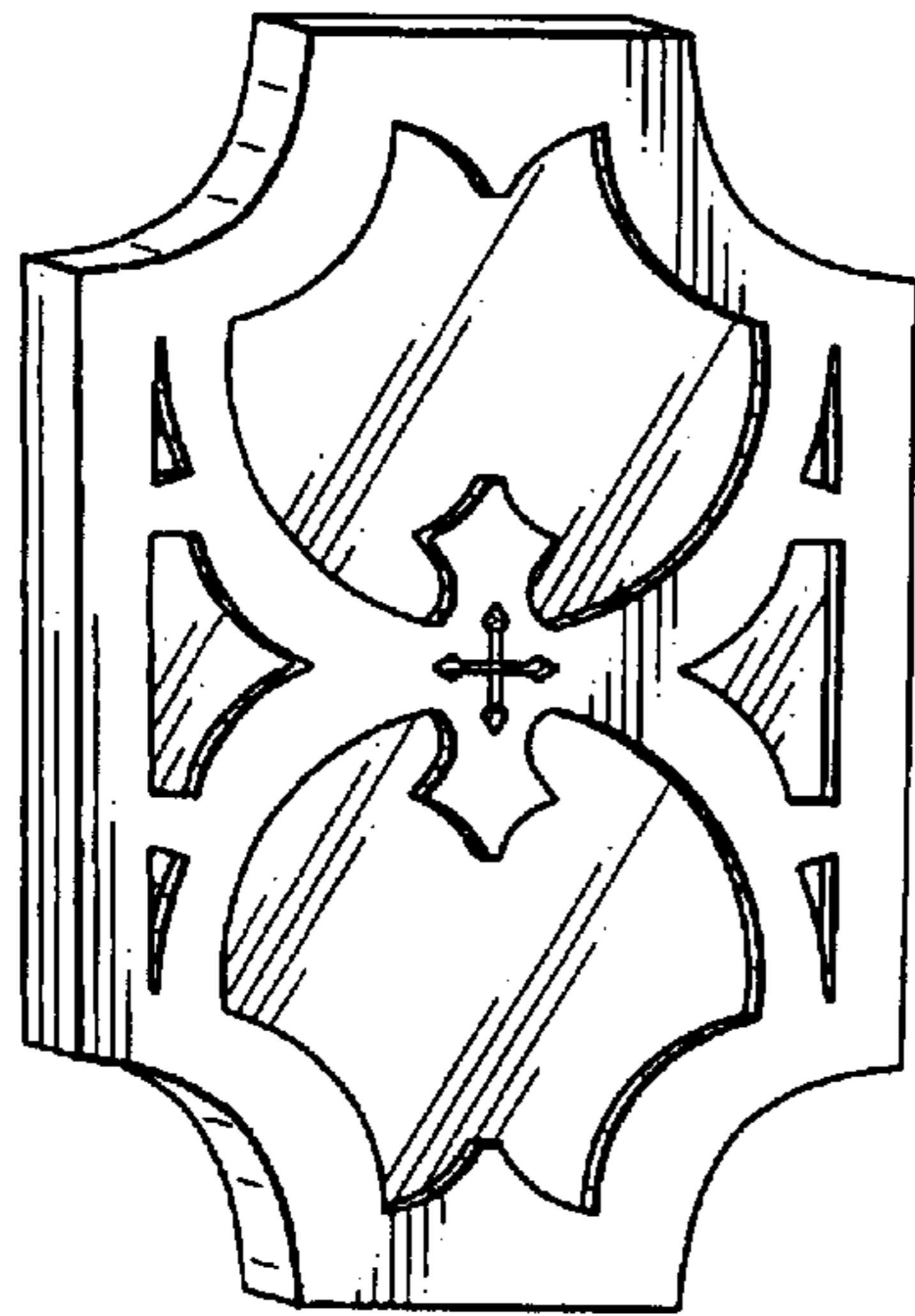

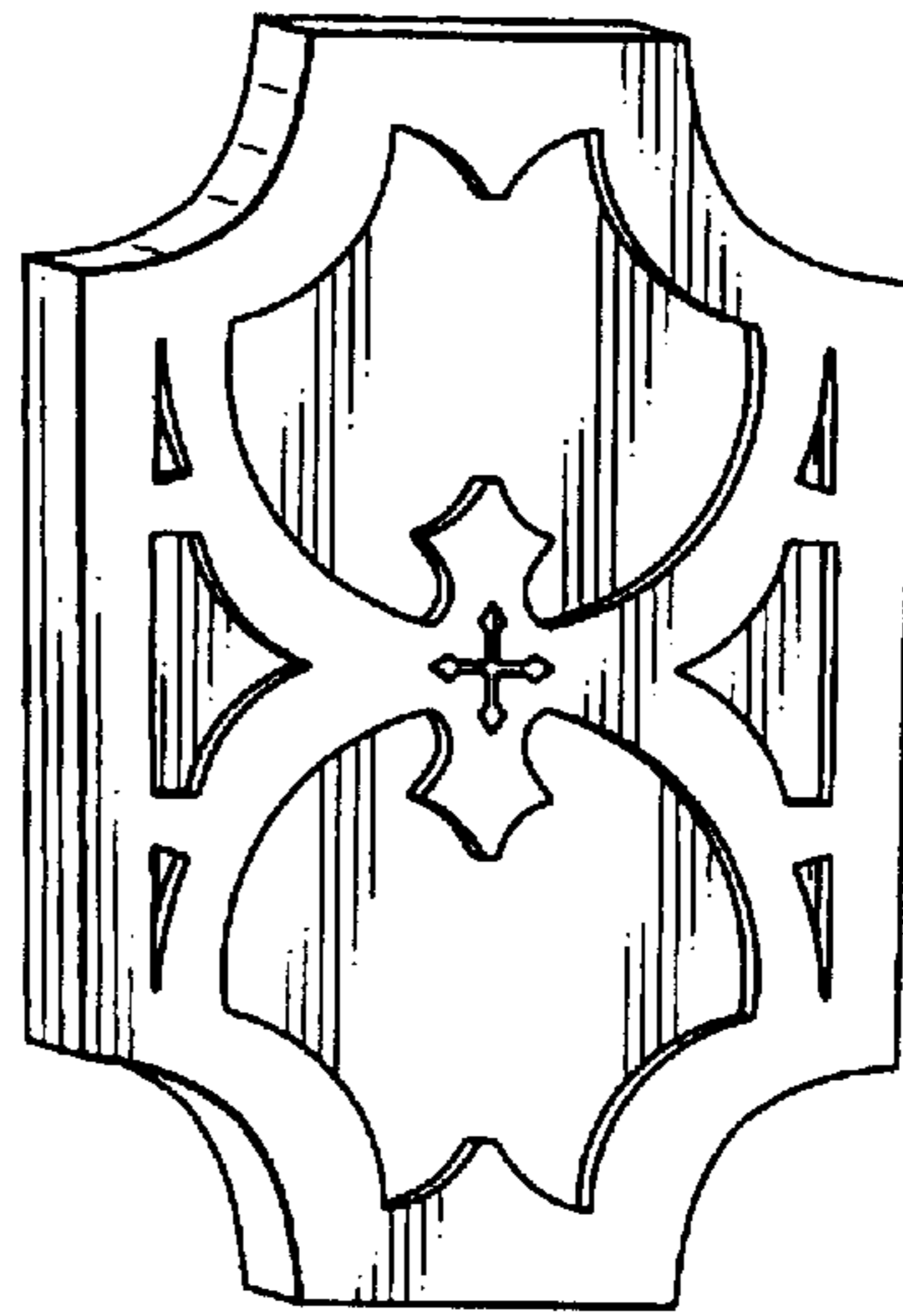

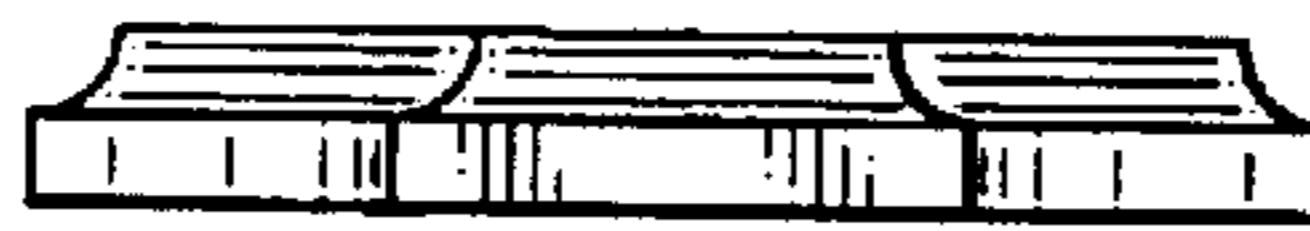

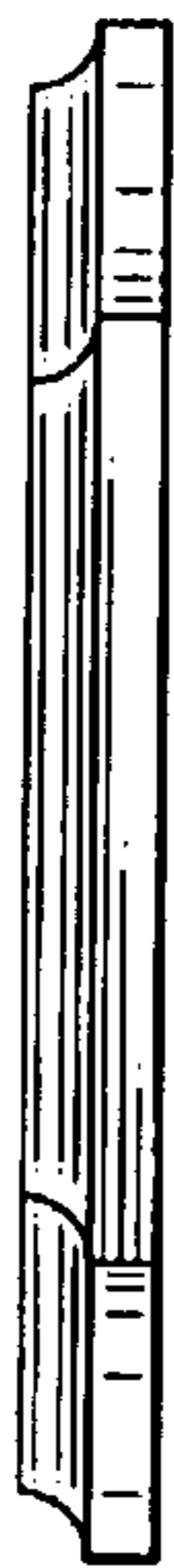

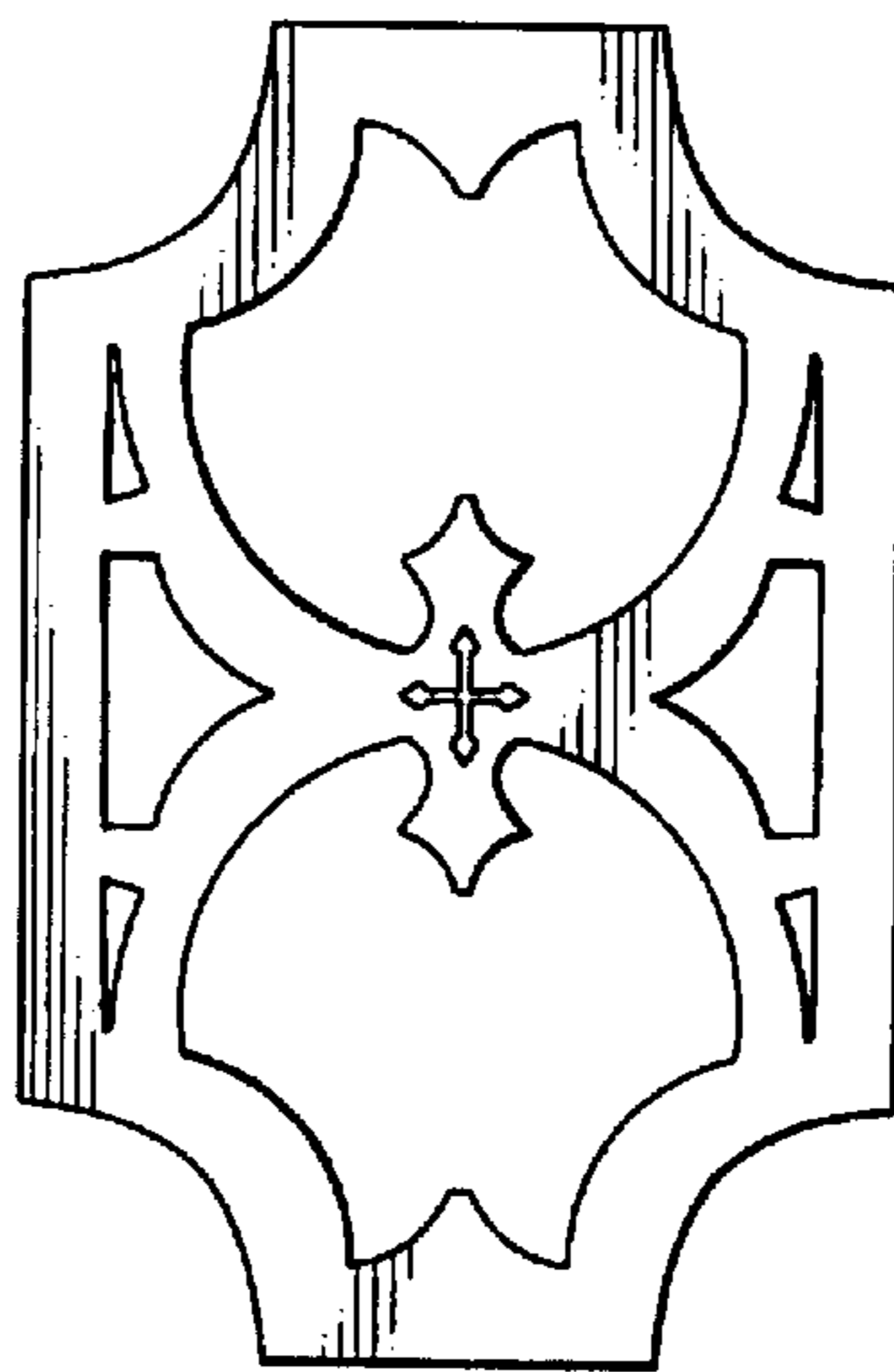

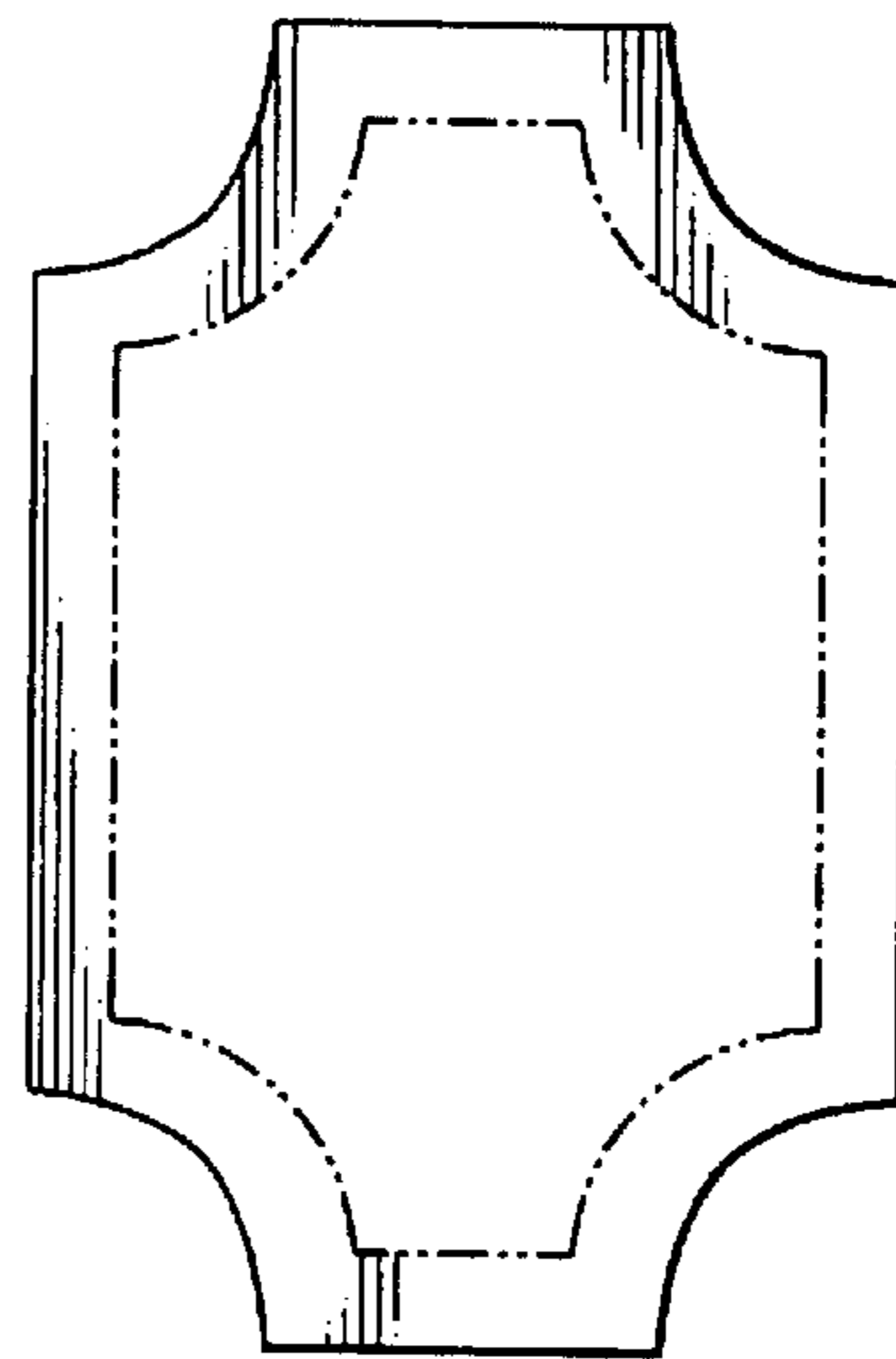
