(57) **CLAIM**

The ornamental design for a hand-held hair dryer, as shown and described.

**DESCRIPTION**

FIG. 1 is a left-hand side view of a hand-held hair dryer showing my new design, the opposite right-hand side being a mirror image of the left-hand side;

FIG. 2 is a top plan view thereof;

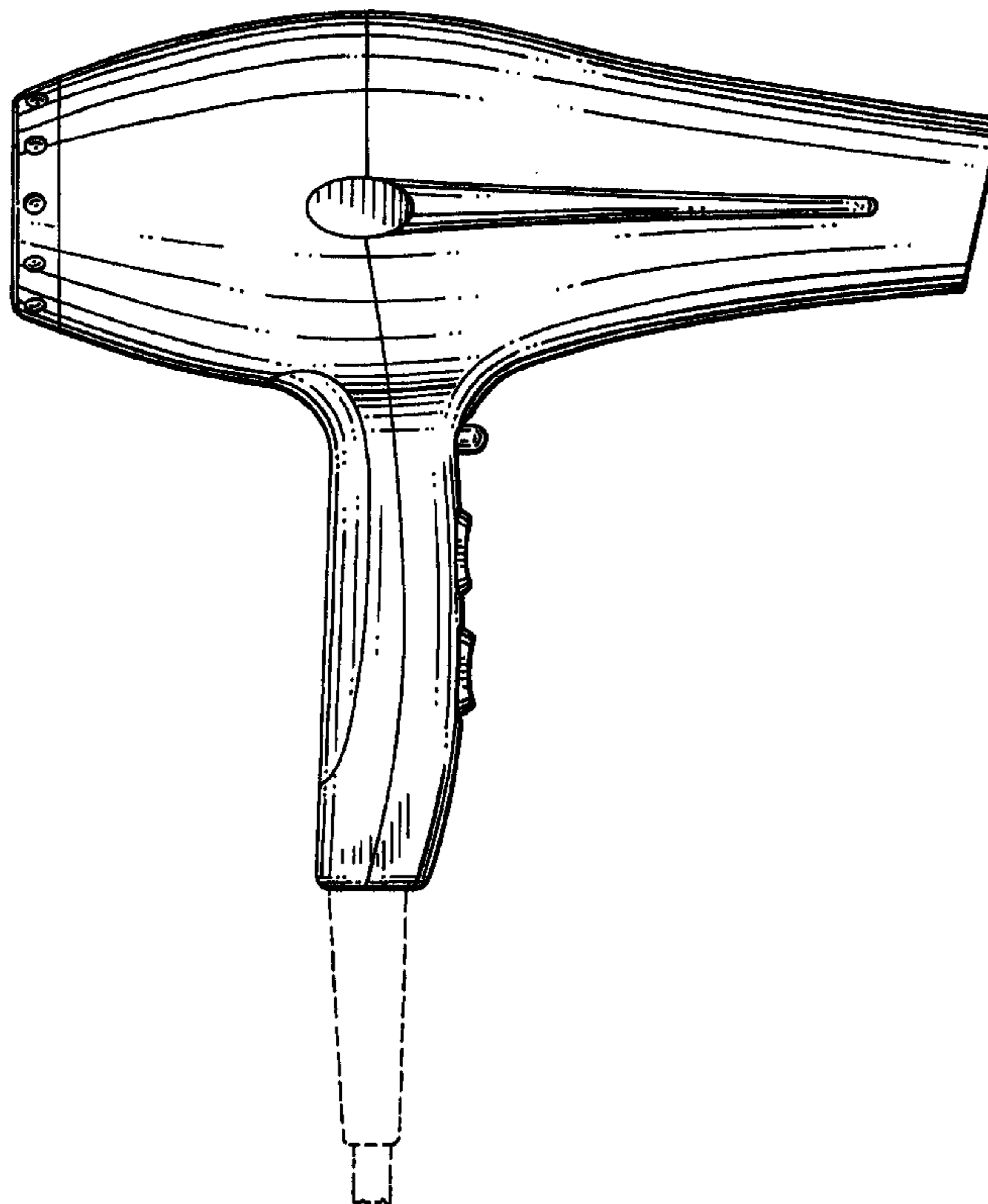
FIG. 3 is a back elevational view thereof;

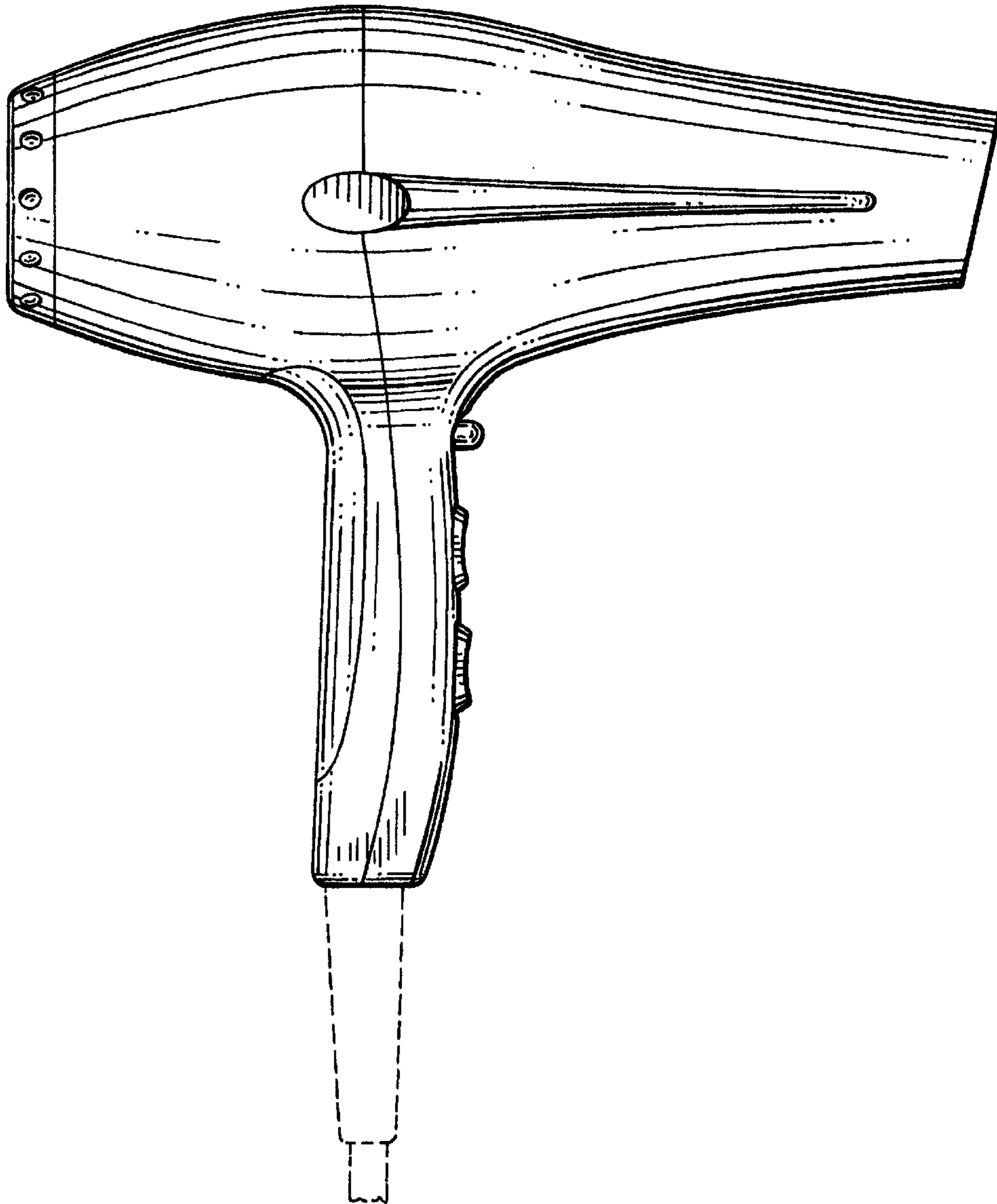

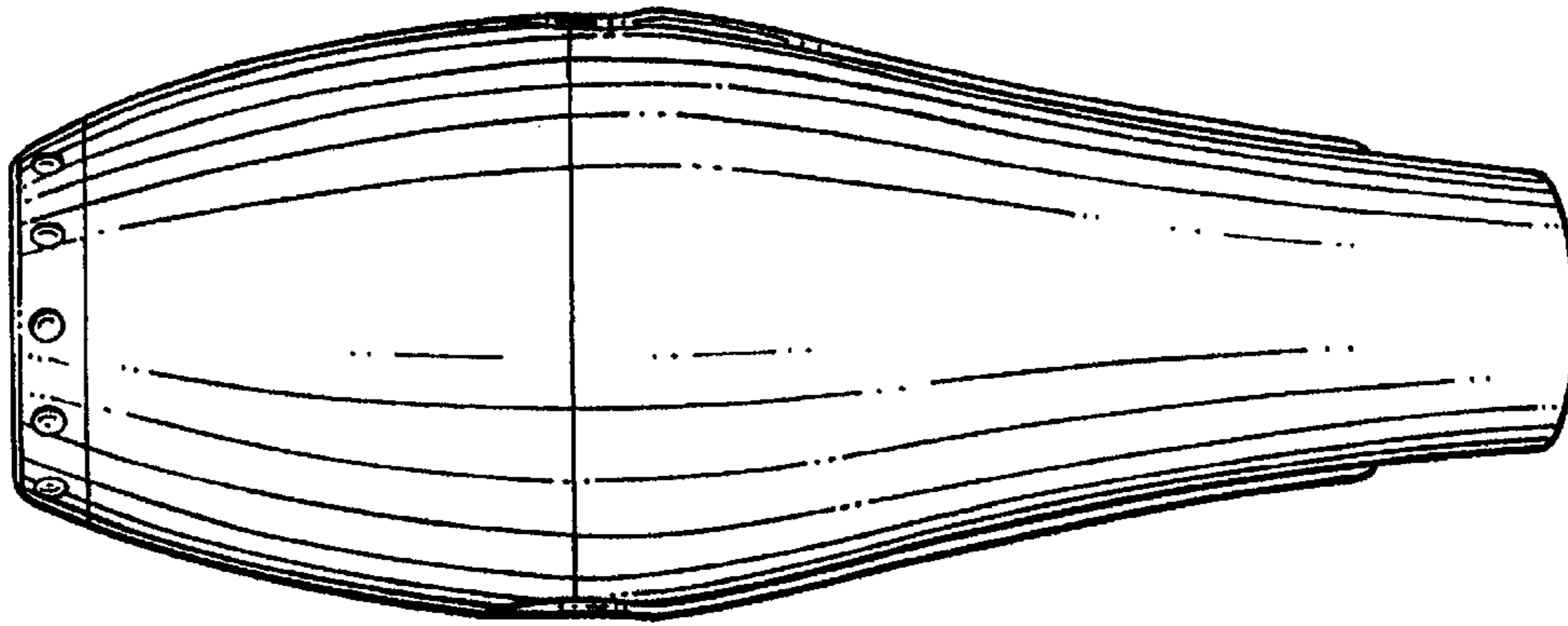

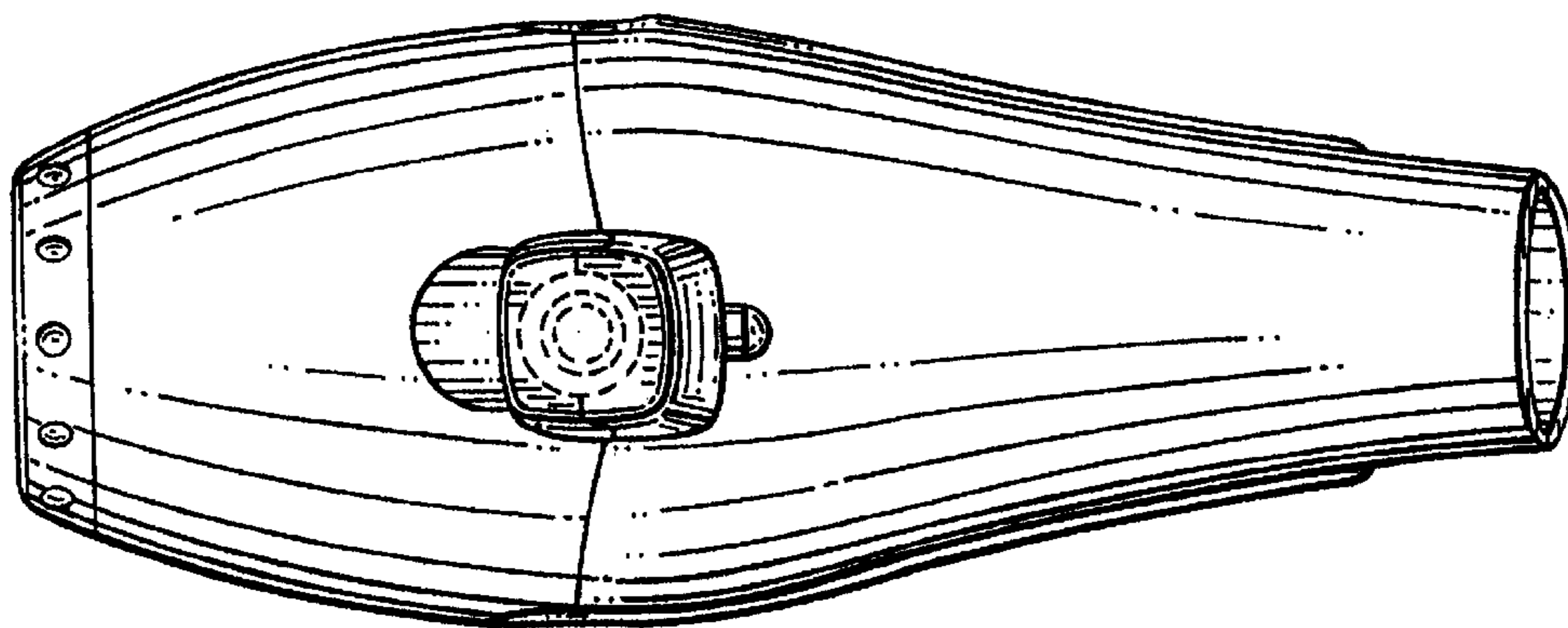

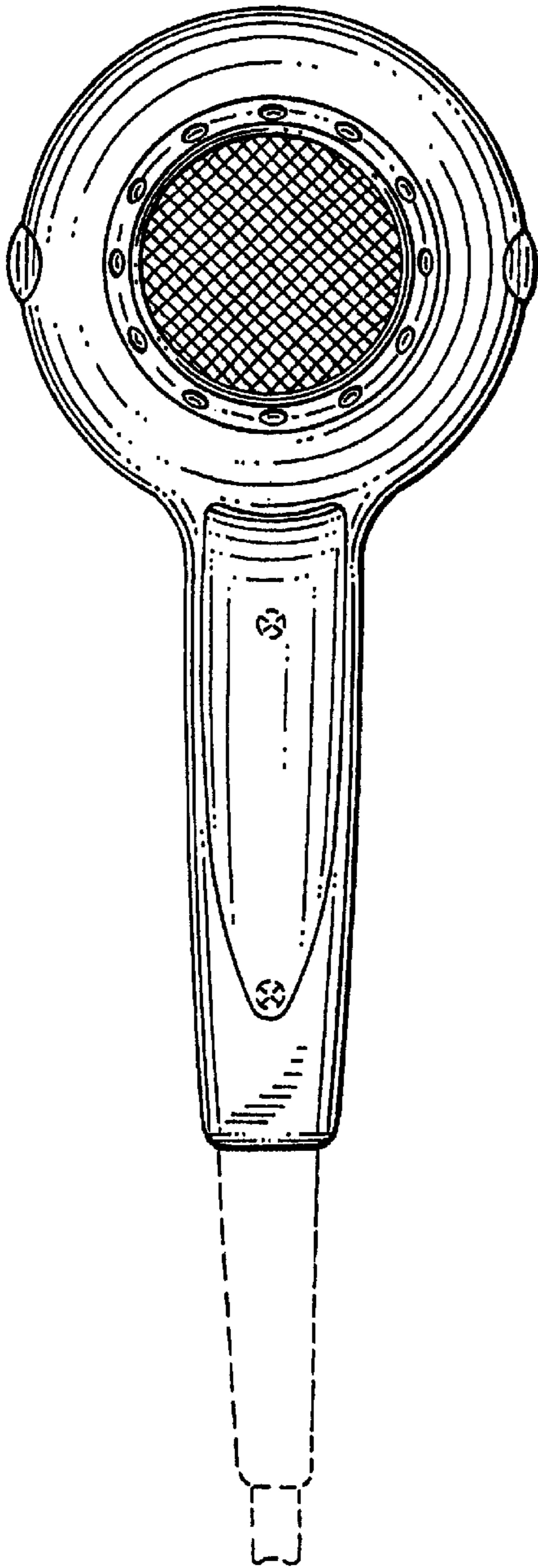

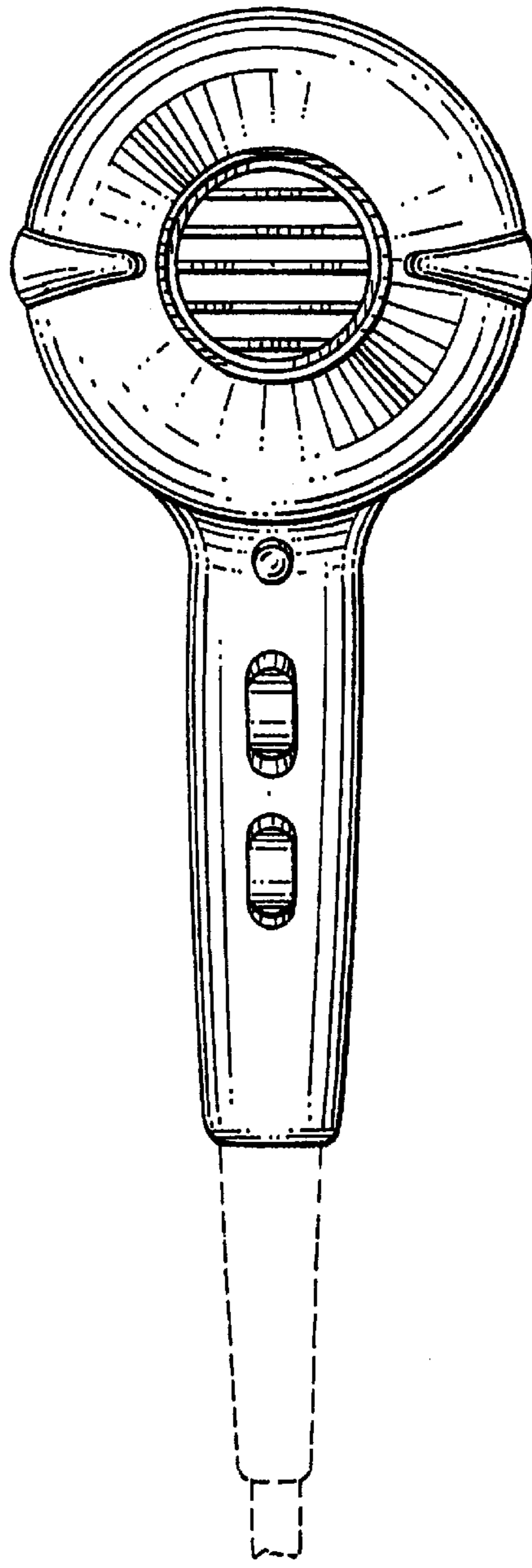
