(57) **CLAIM**

The ornamental design for an electronic part conveyor table, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electronic part conveyor table showing my novel design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; the opposite side view being the same; FIG. 6 is a cross-sectional view taken along line 6—6 in FIG. 3; and, FIG. 7 is a right side elevational view thereof, the opposite side view being the same.

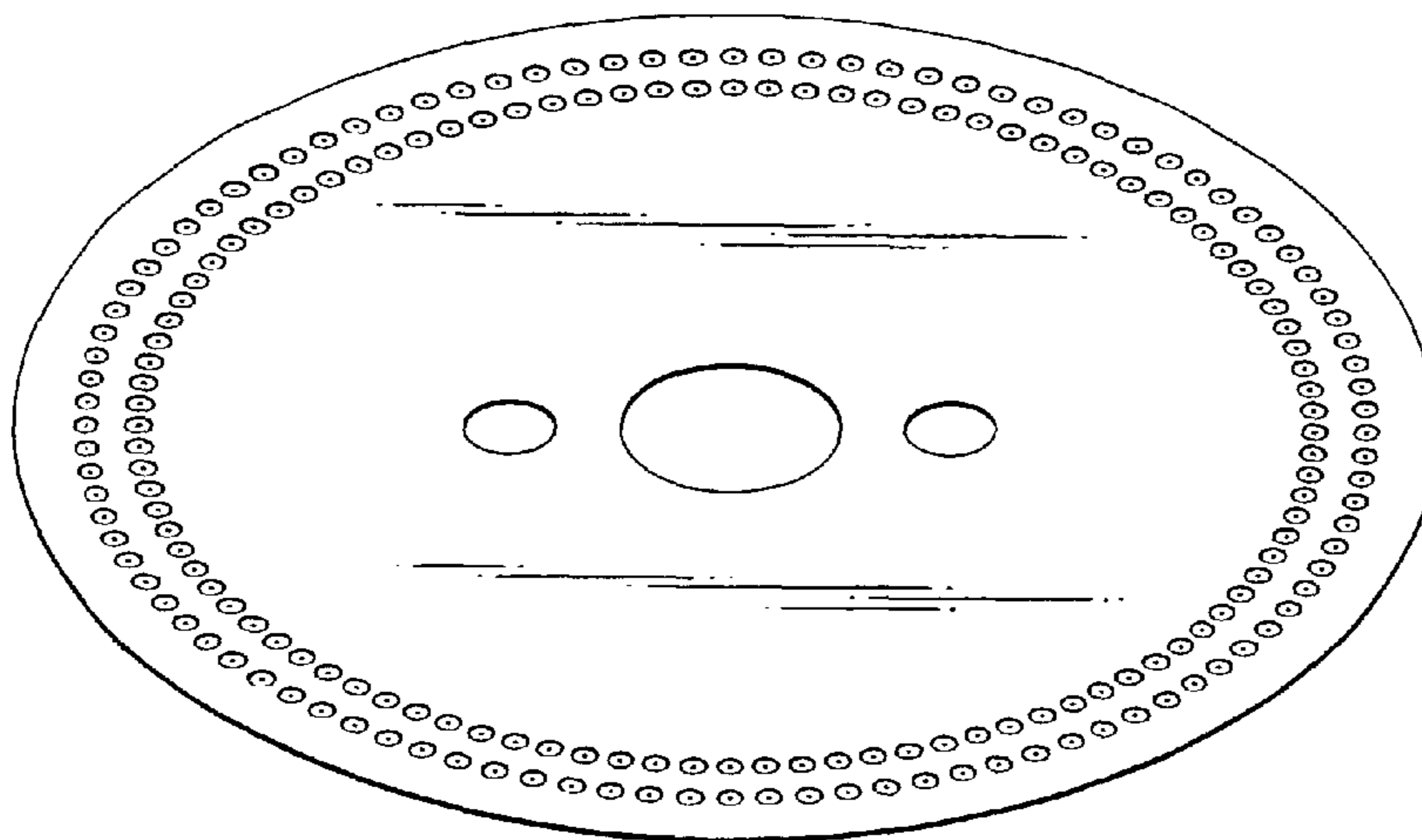

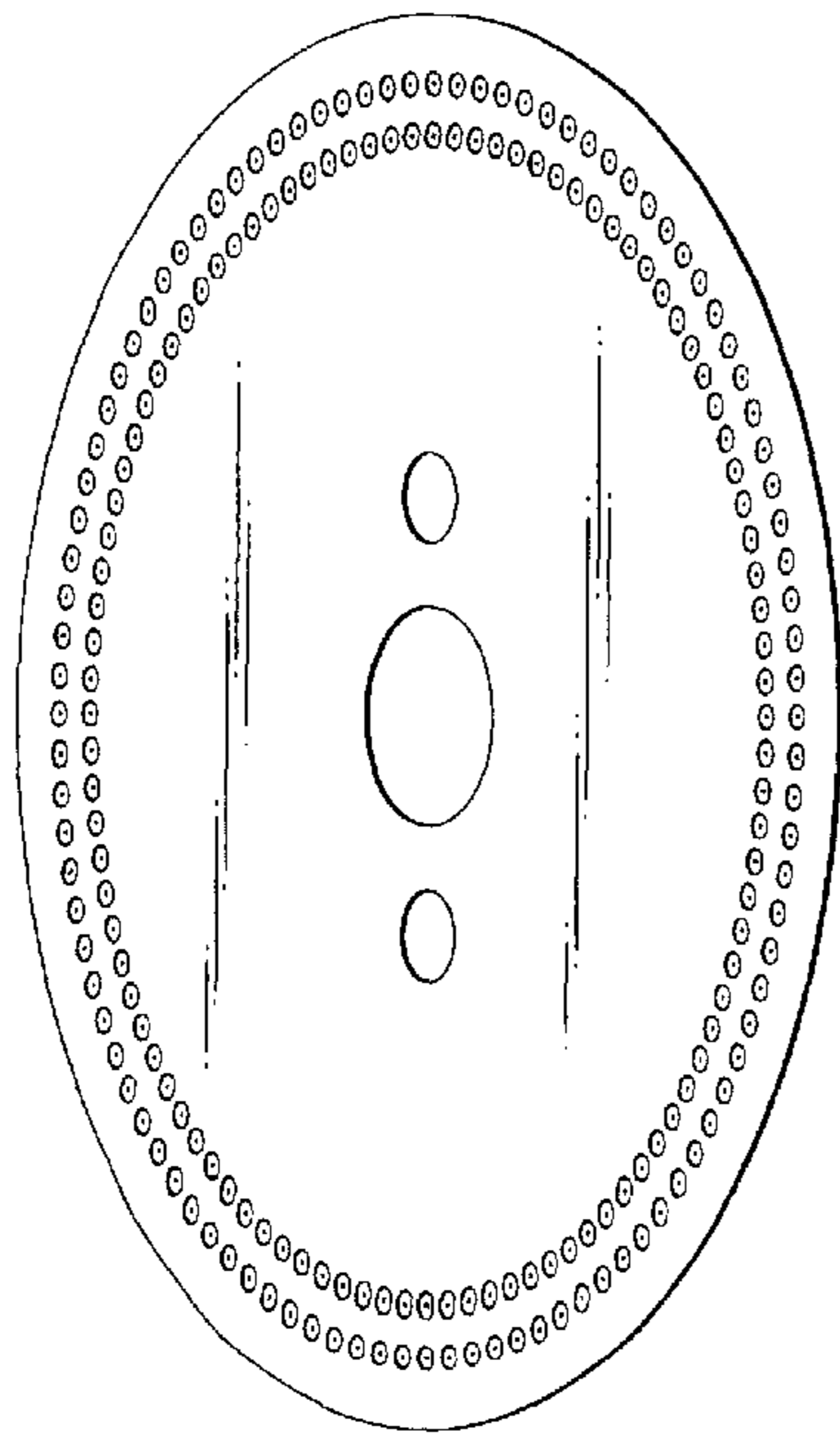

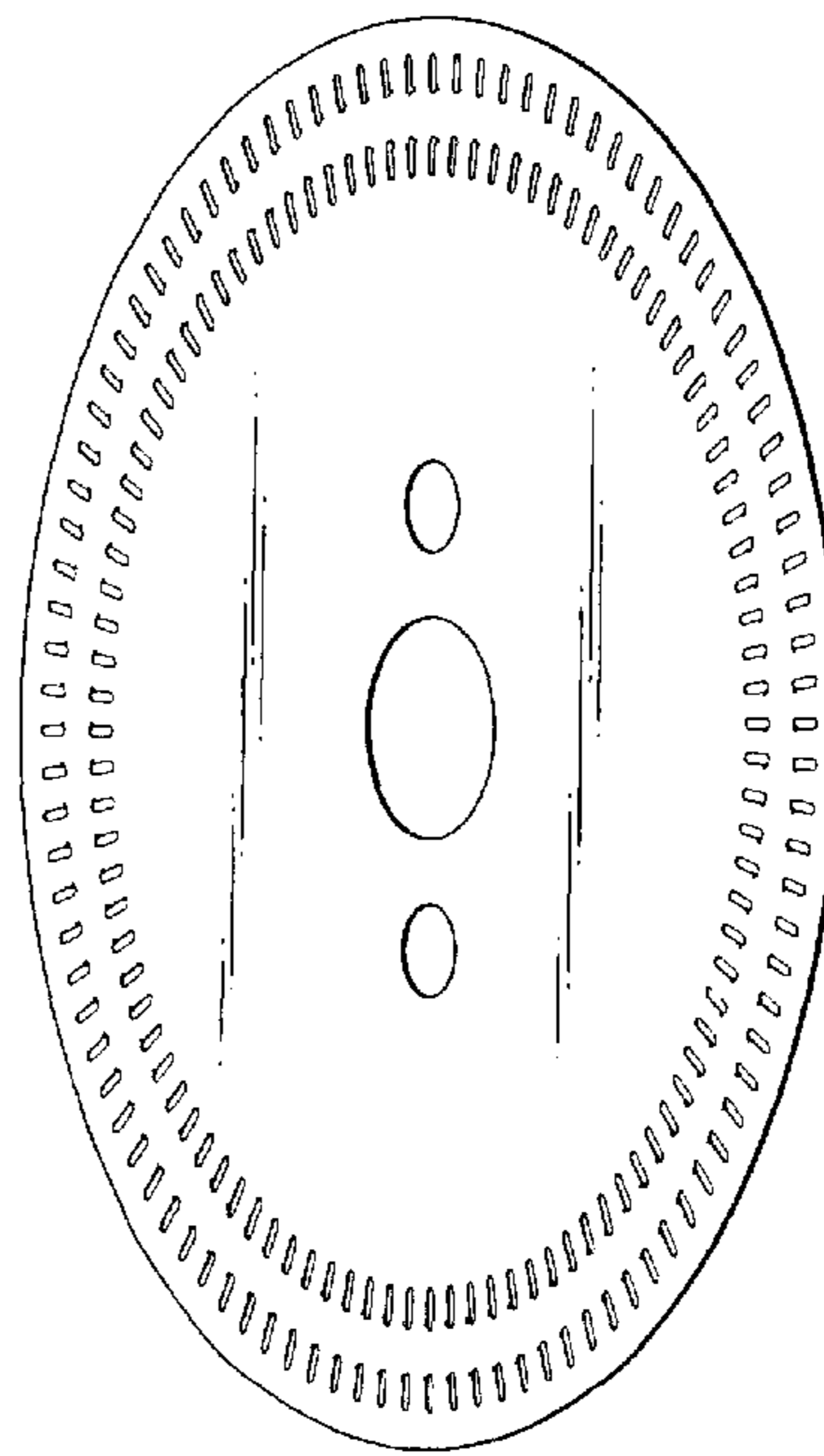

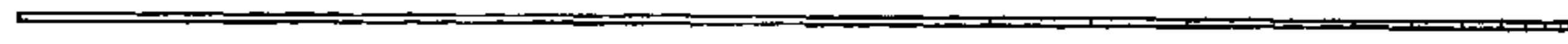

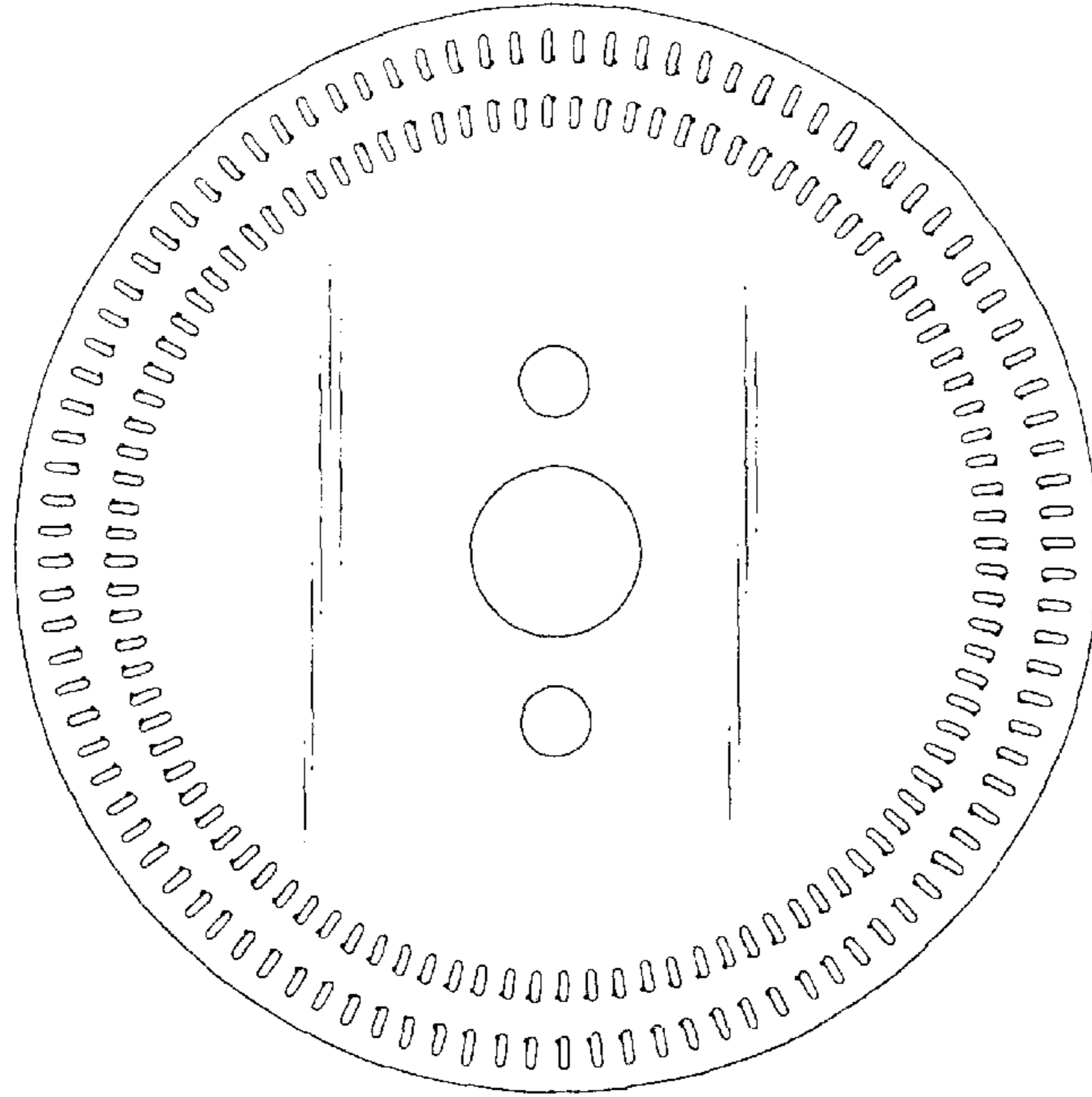

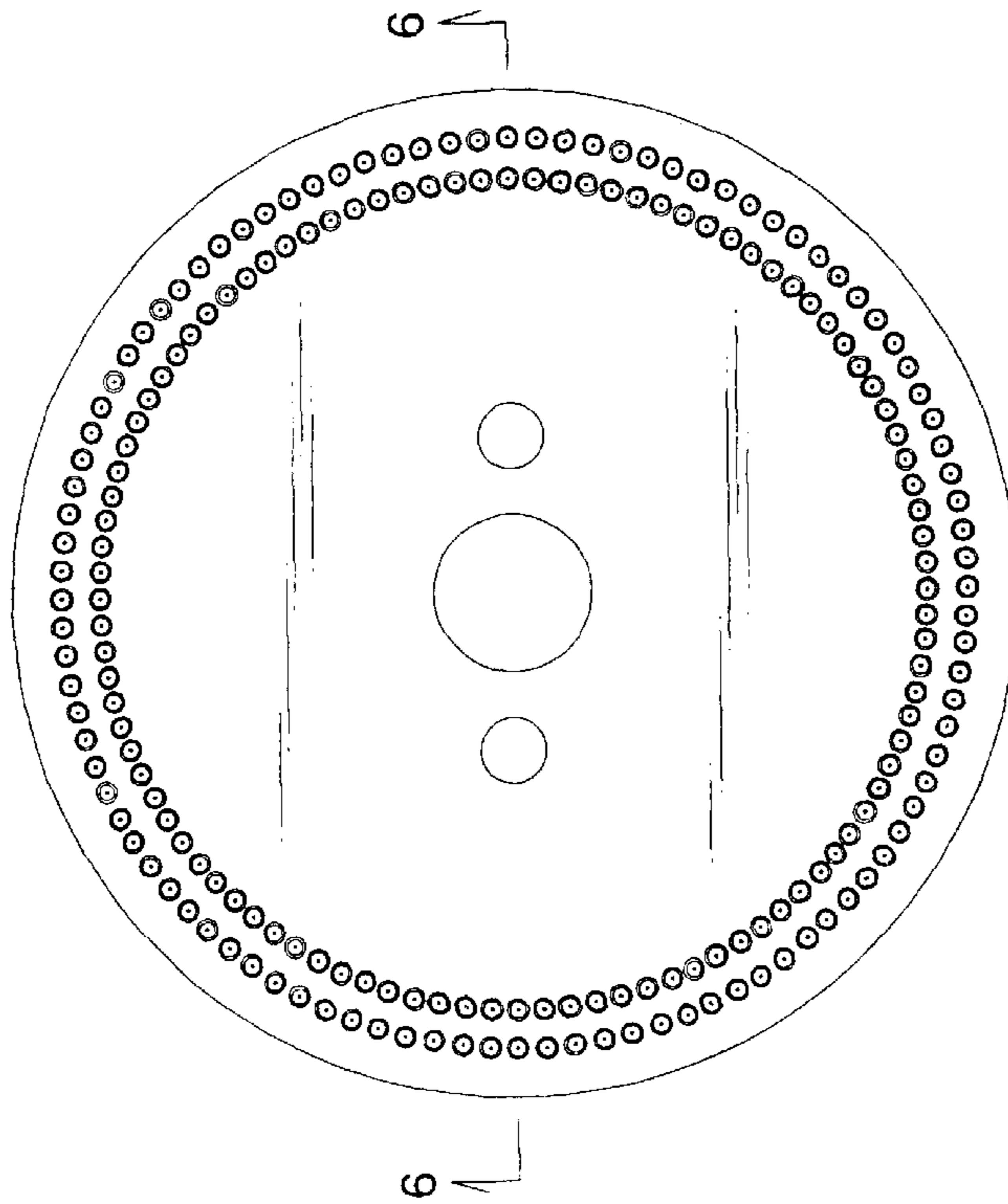
