(57) **CLAIM**

I claim the ornamental design for a drum case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a drum case showing my new design;

FIG. 2 is a right side elevational view thereof, the left side being a mirror image;

FIG. 3 is a top plan view thereof;

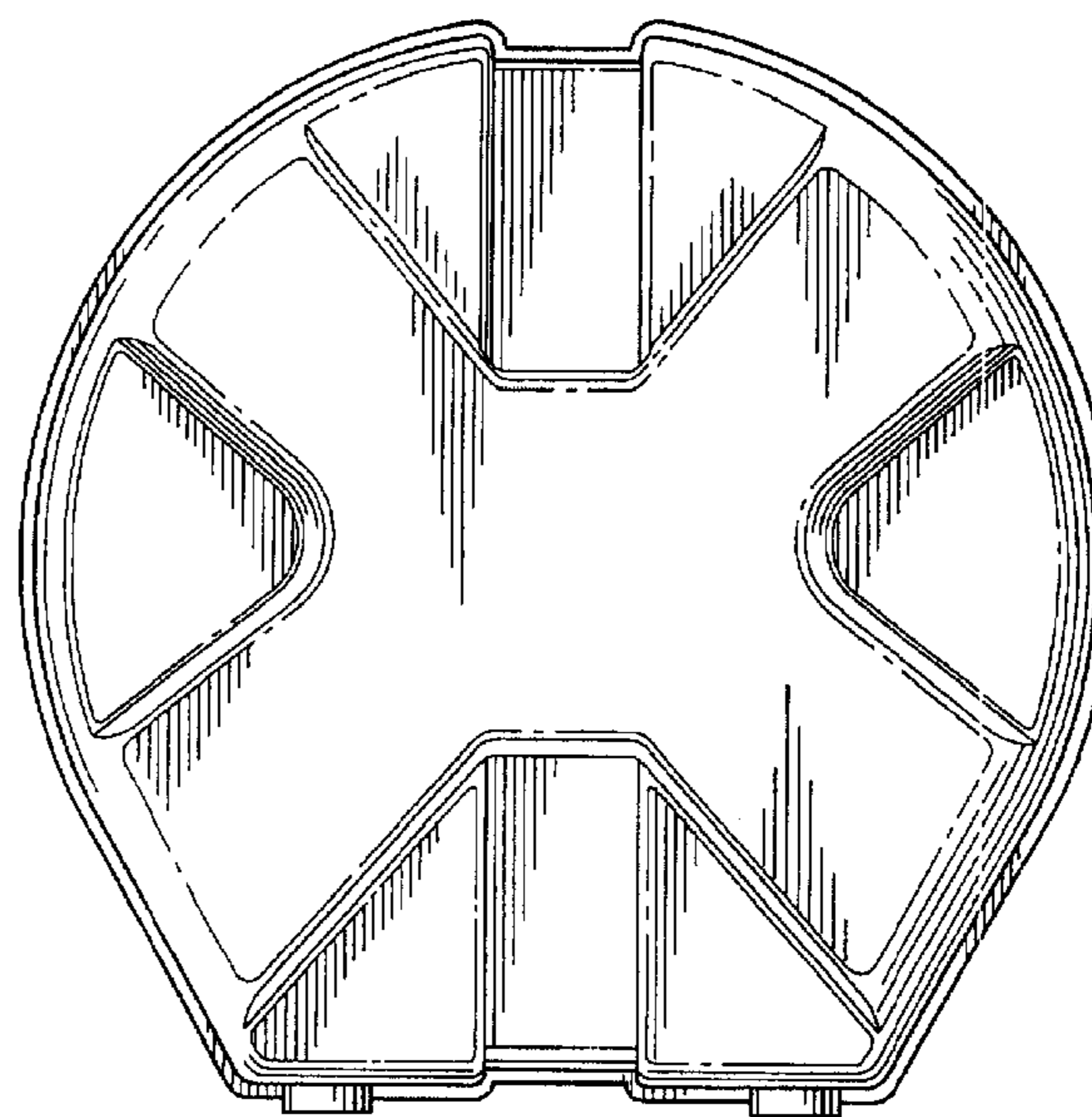
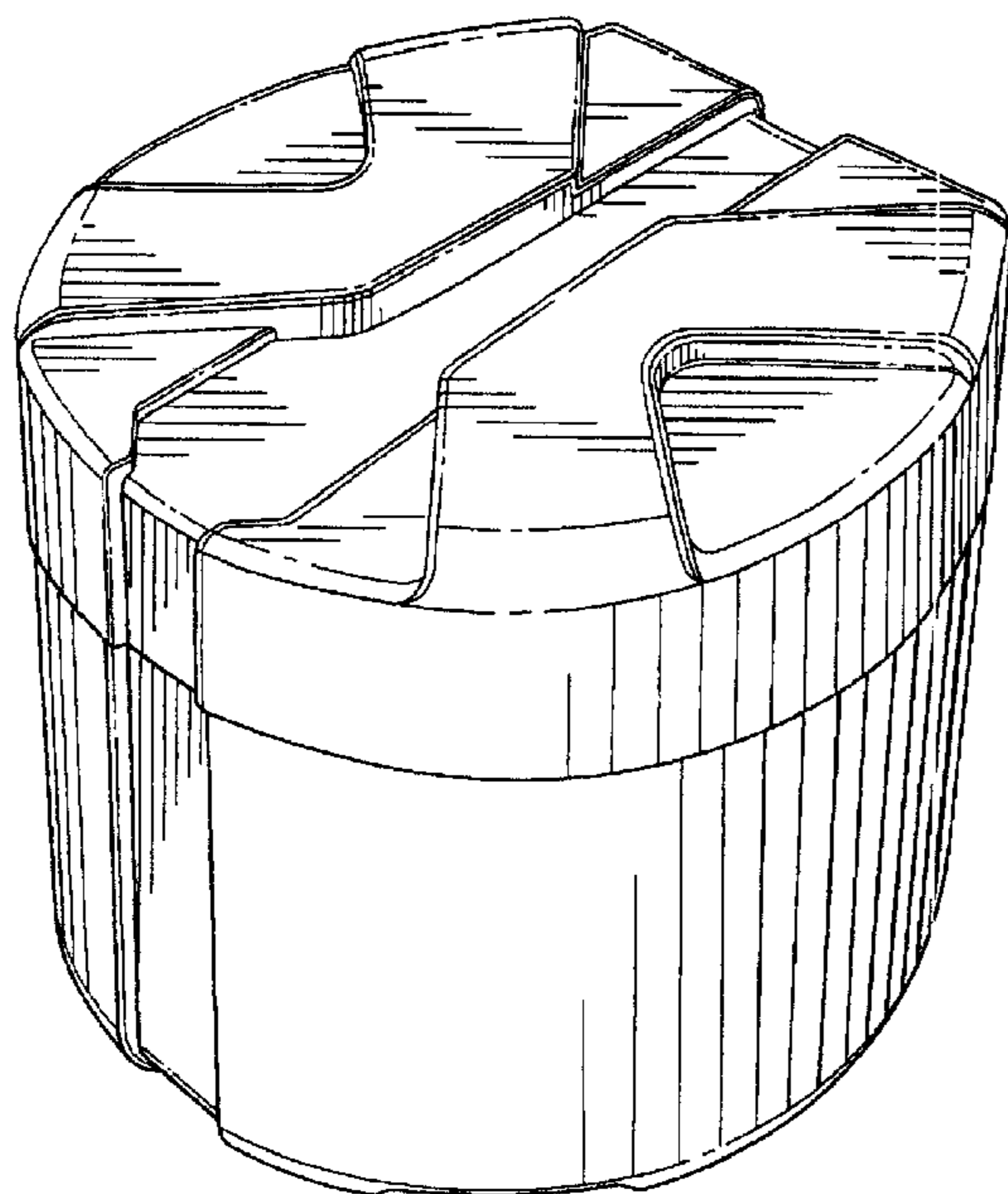
FIG. 4 is a bottom plan view thereof;

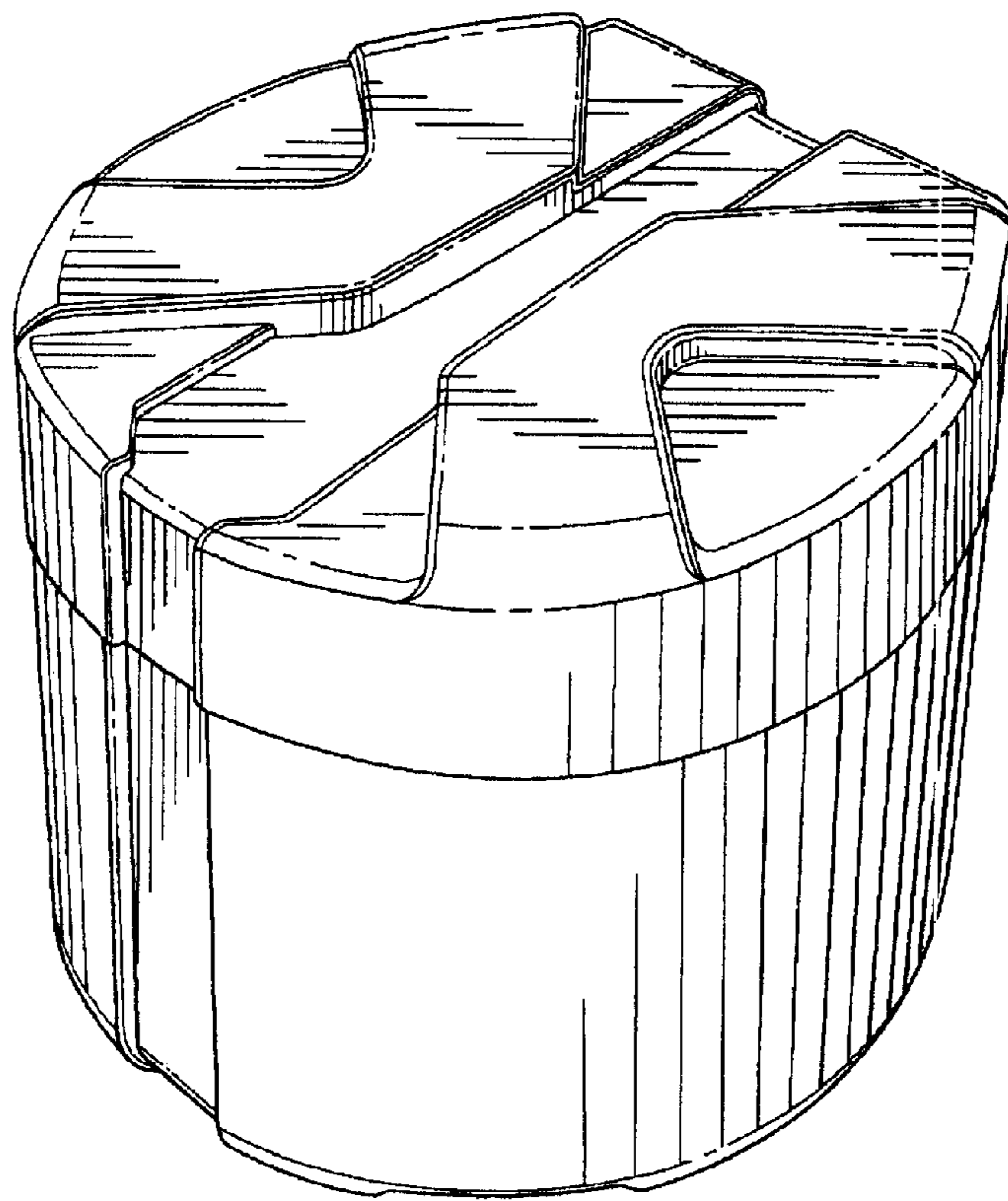

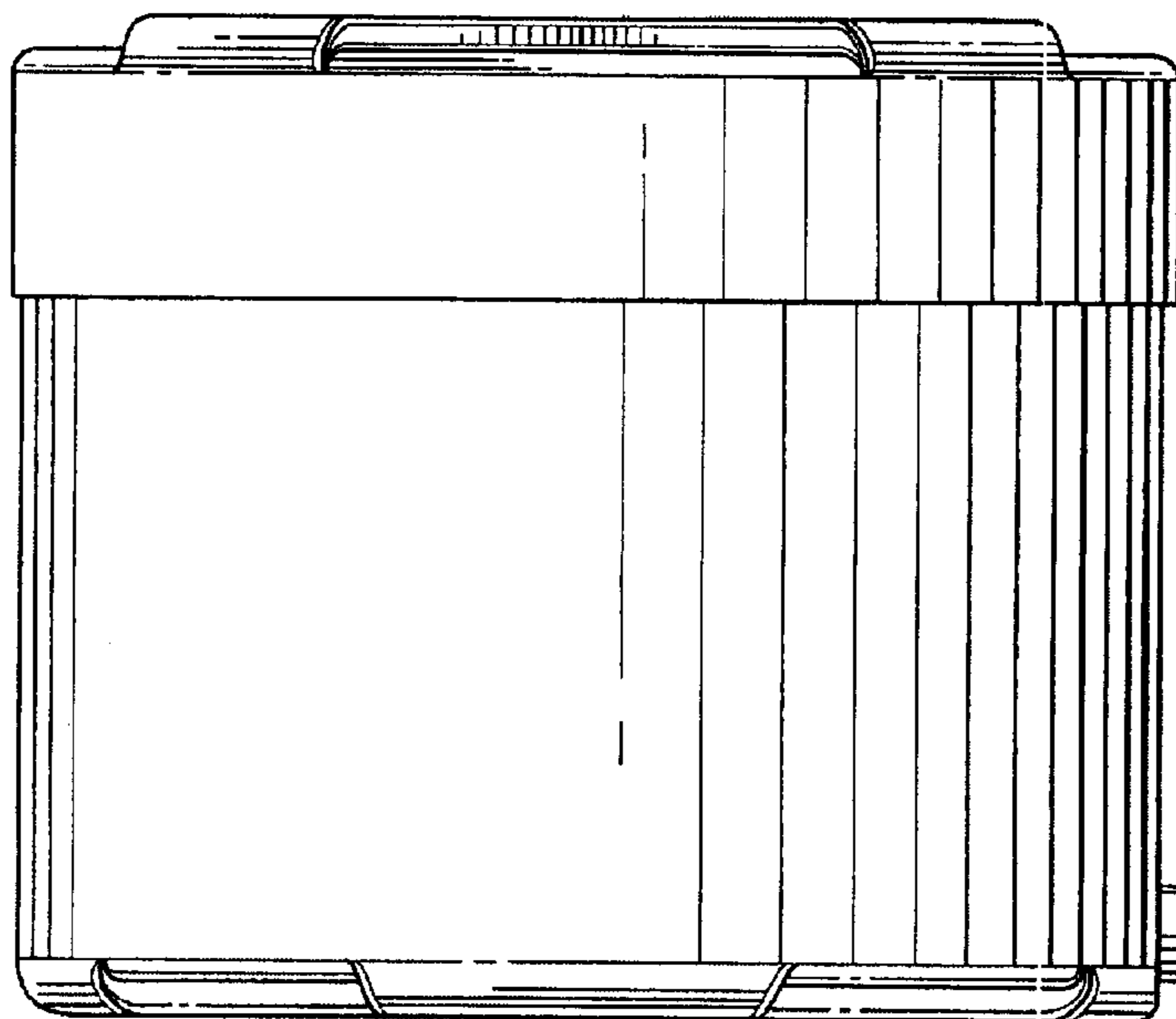

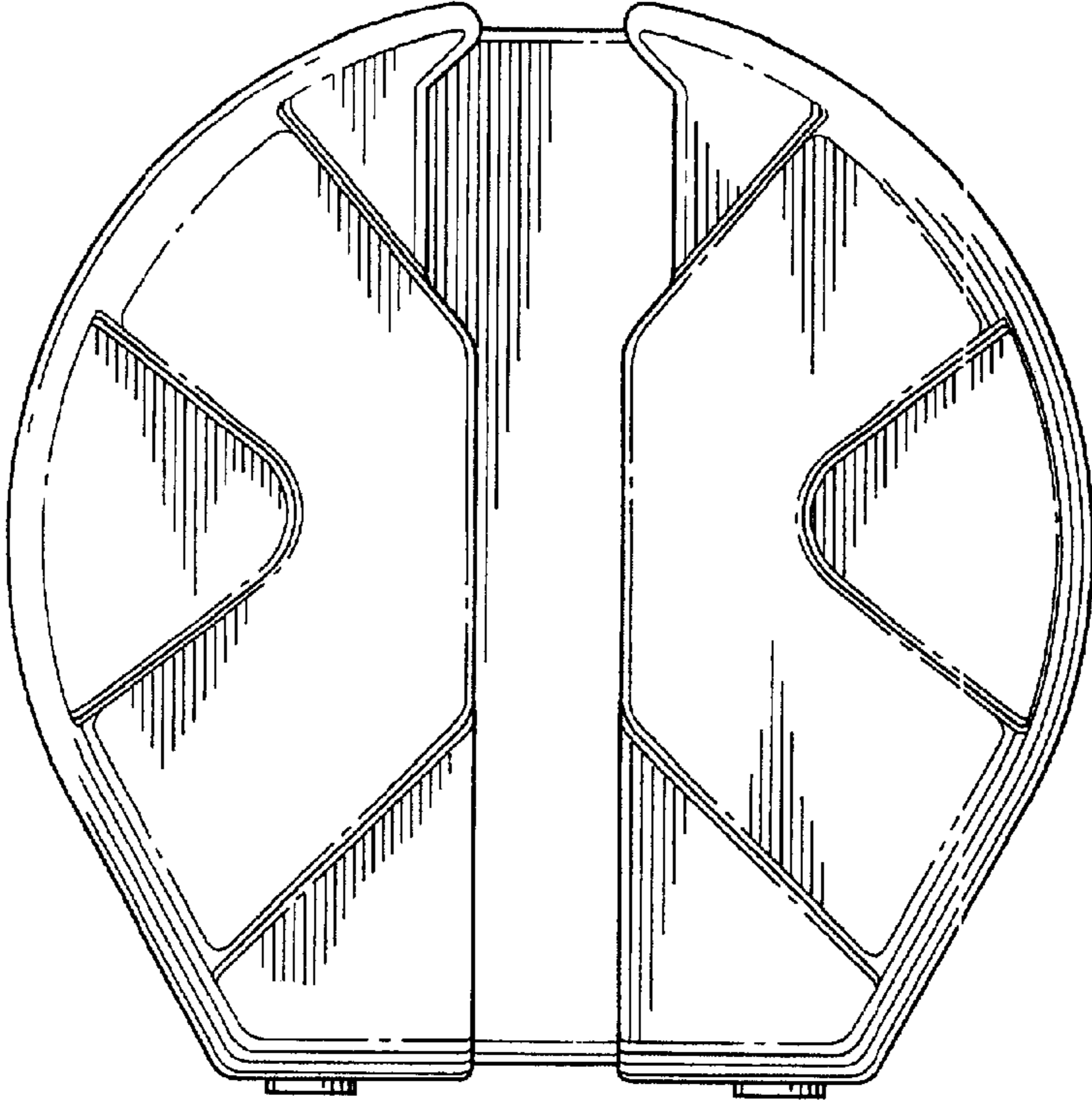

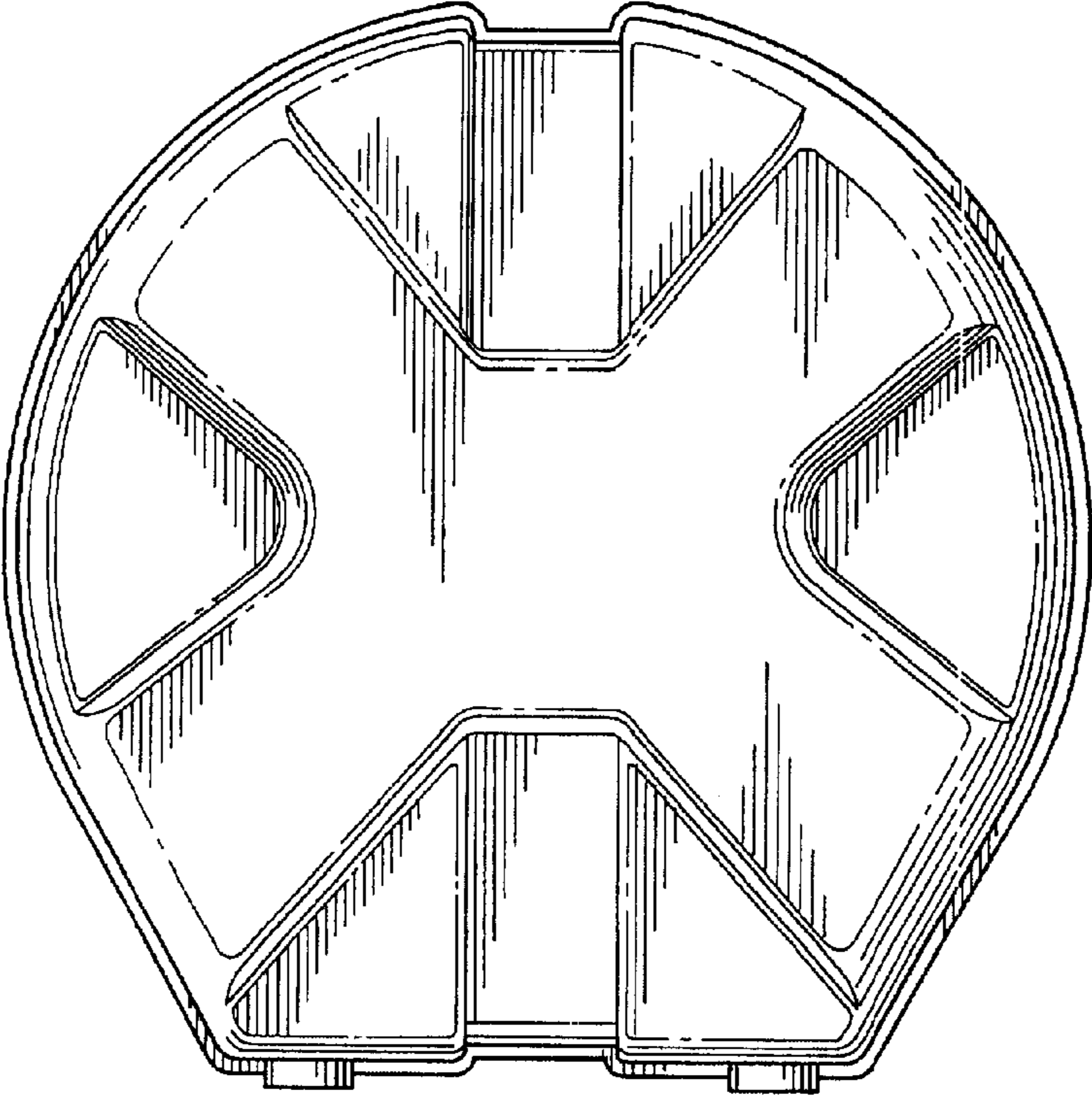

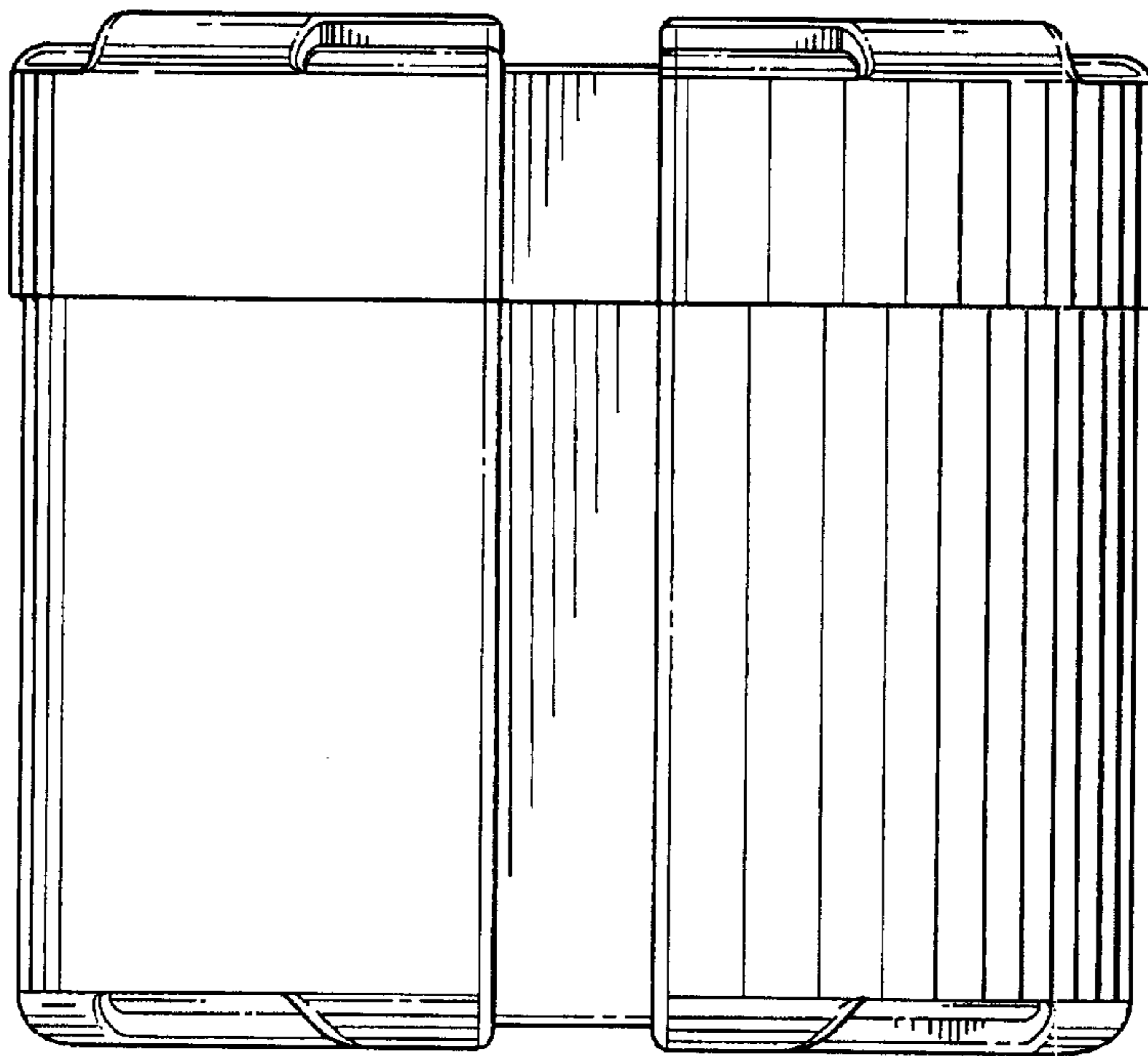

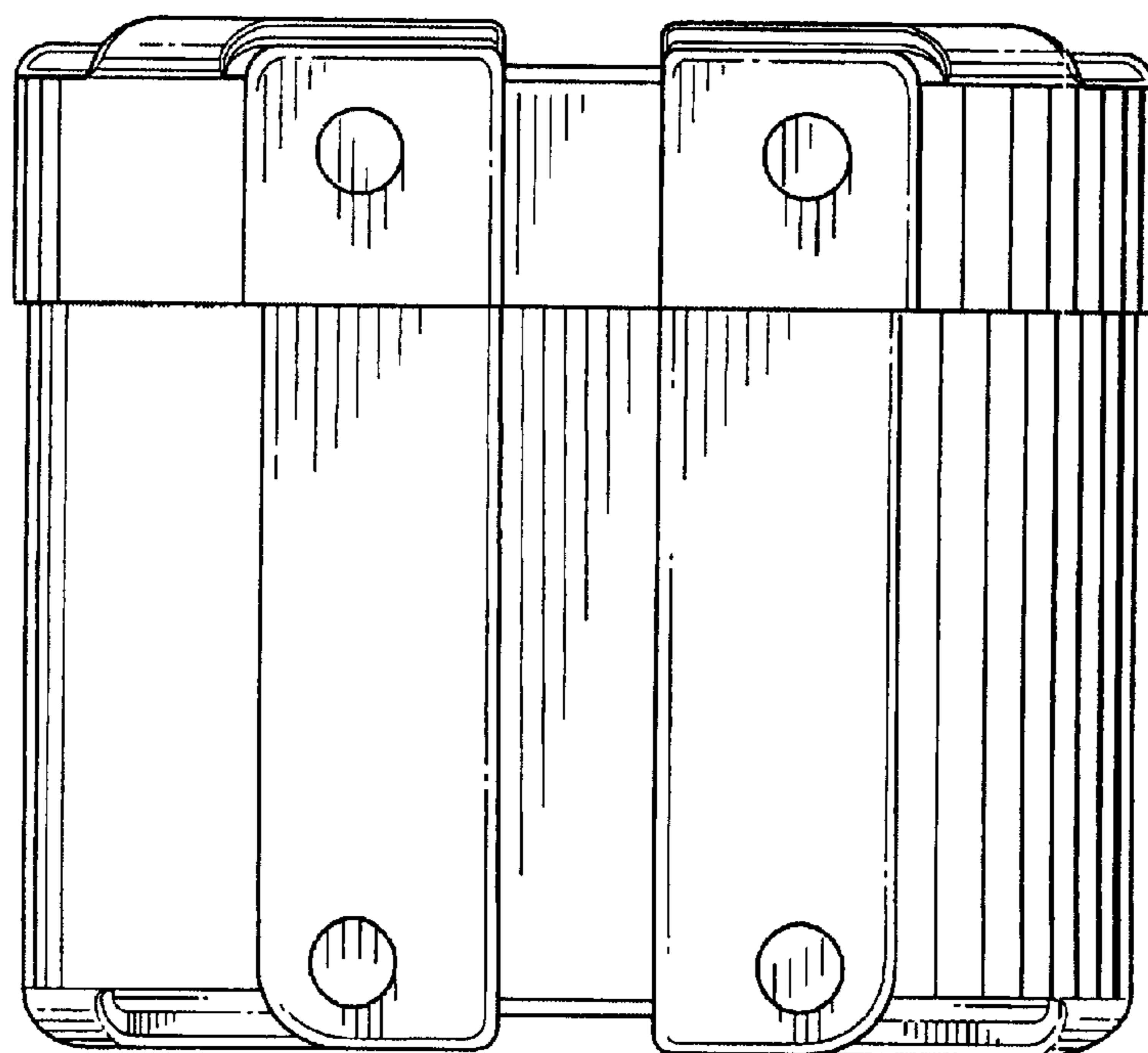

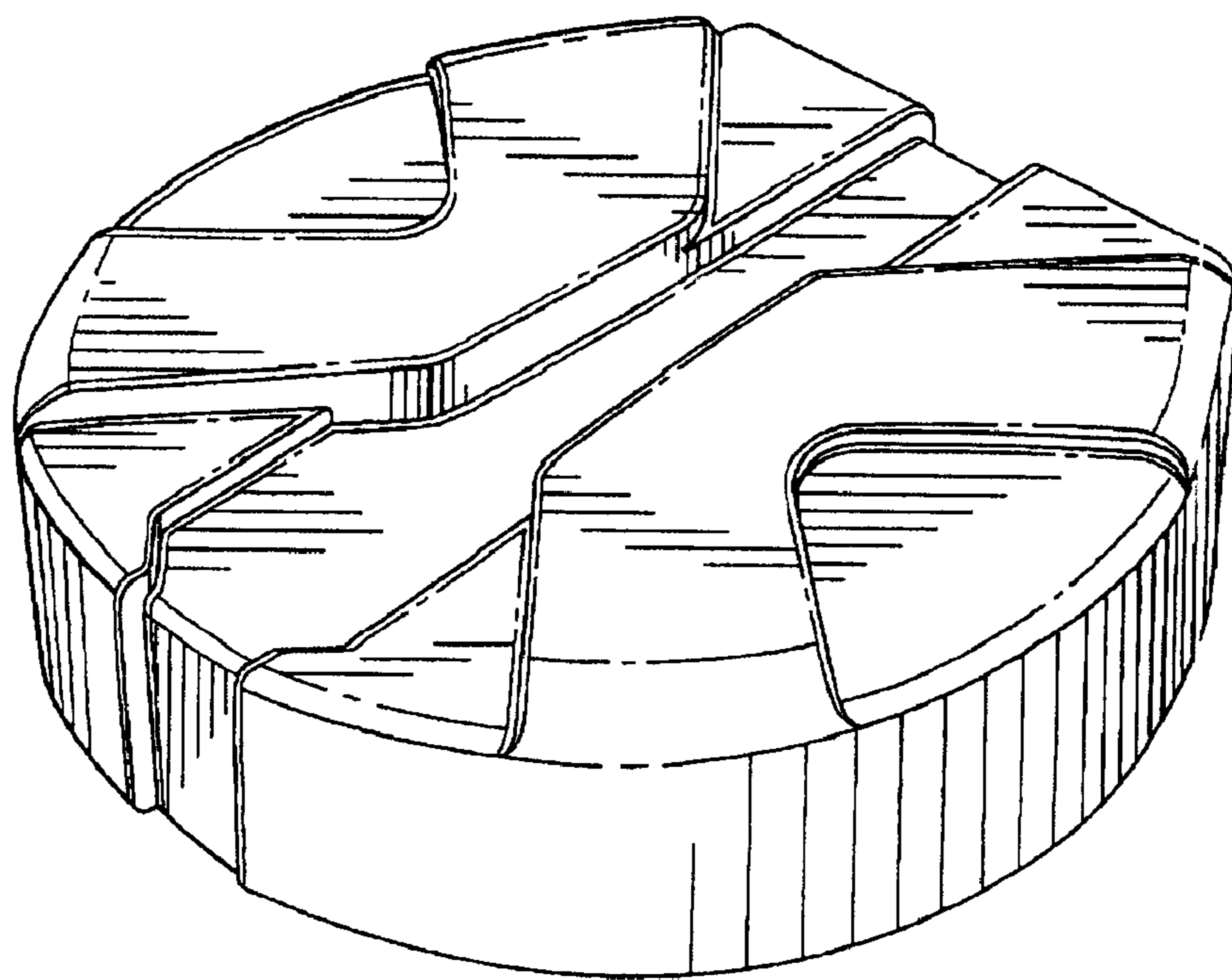
