The ornamental design for a travel documents holder, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the travel documents holder of the invention;

FIG. 2 is a top plan view of the travel documents holder of the invention;

FIG. 3 is a left side view of the travel documents holder of the invention;

FIG. 4 is a right side view of the travel documents holder of the invention;

FIG. 5 is a back view of the travel documents holder of the invention;

FIG. 6 is a bottom view of the travel documents holder of the invention; and,

FIG. 7 is a perspective view of a partially folded travel documents holder of the invention.

The dashed lines shown in all views represent stitching and are part of the claimed design.

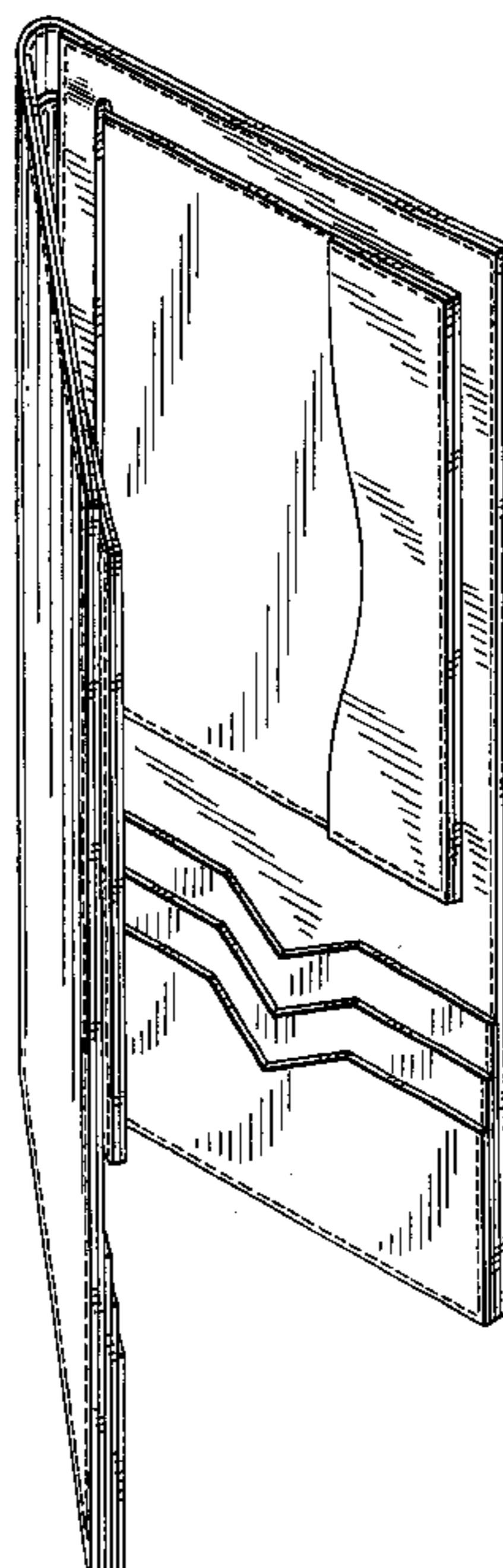

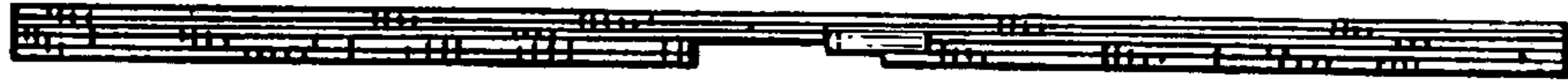

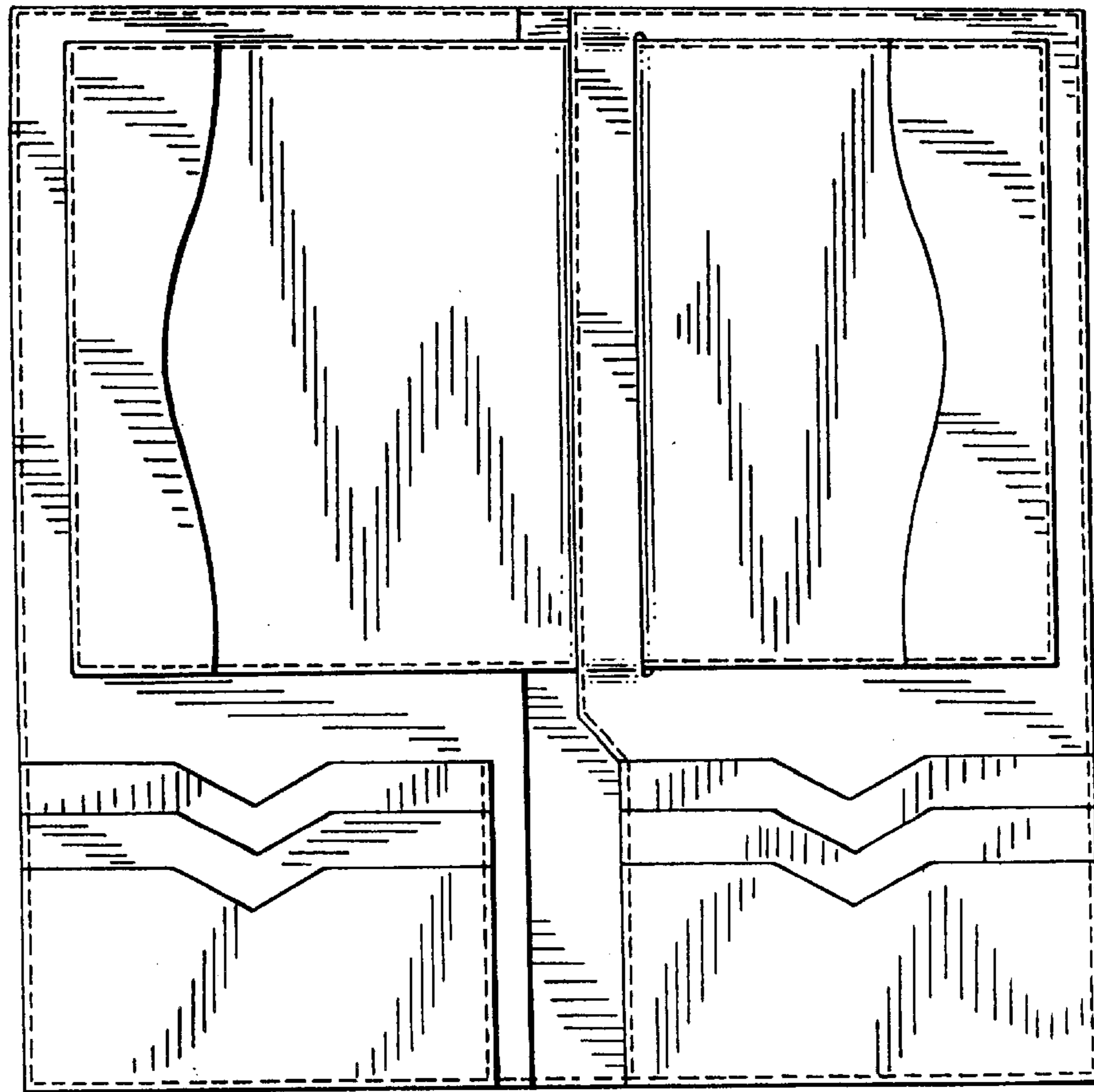

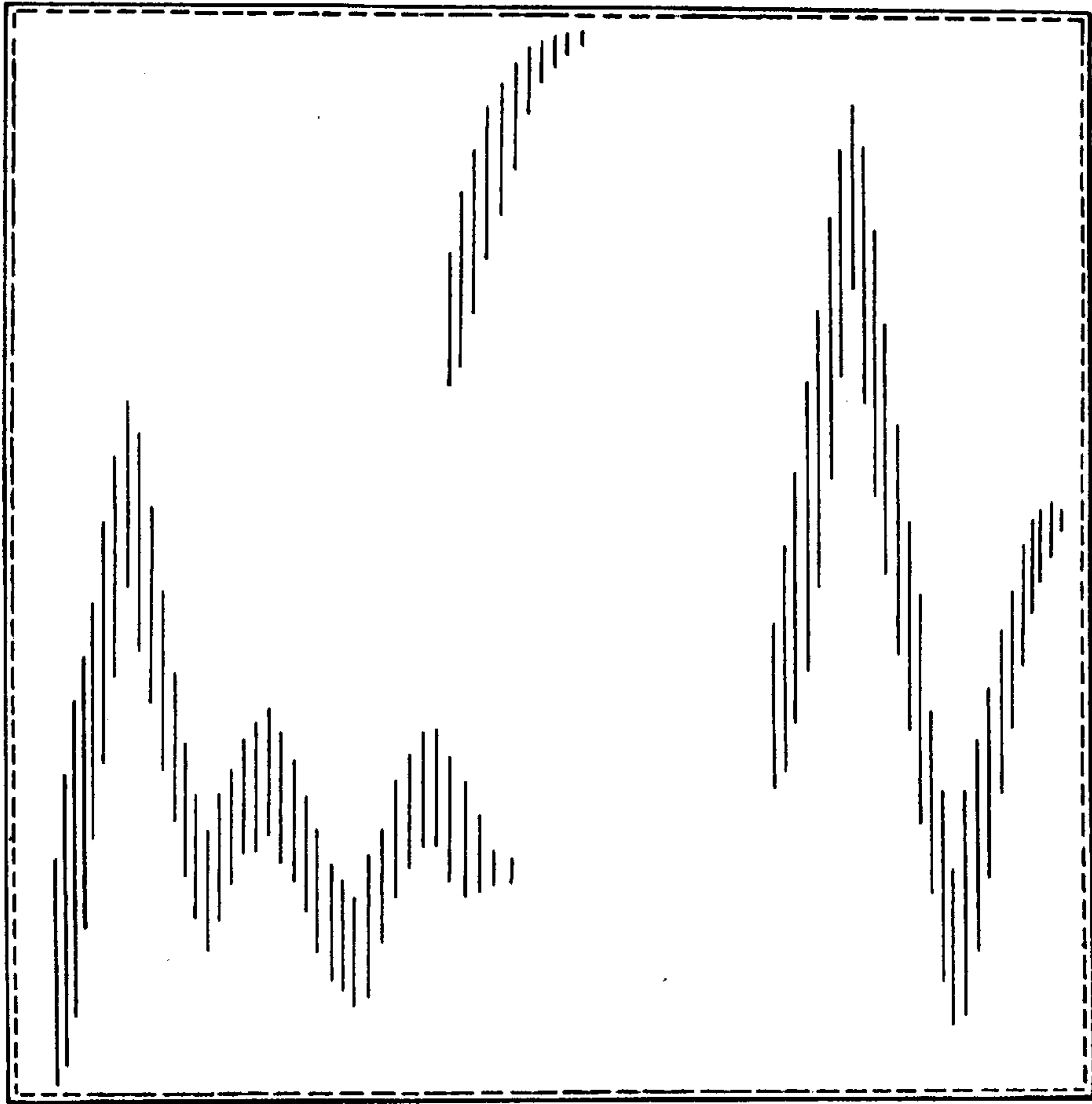
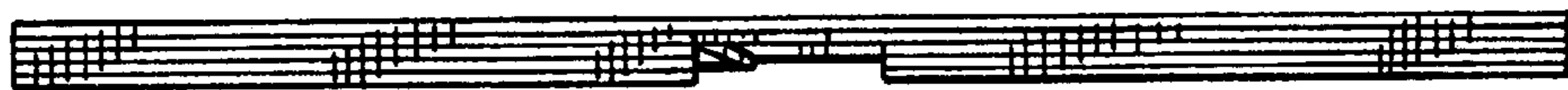

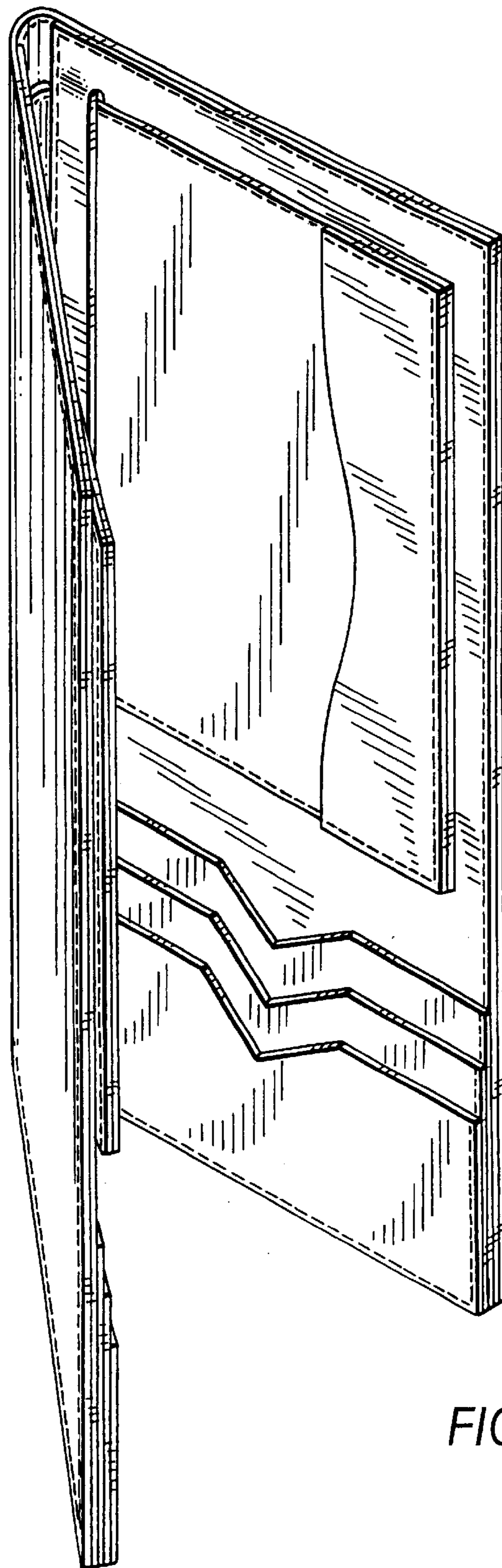
