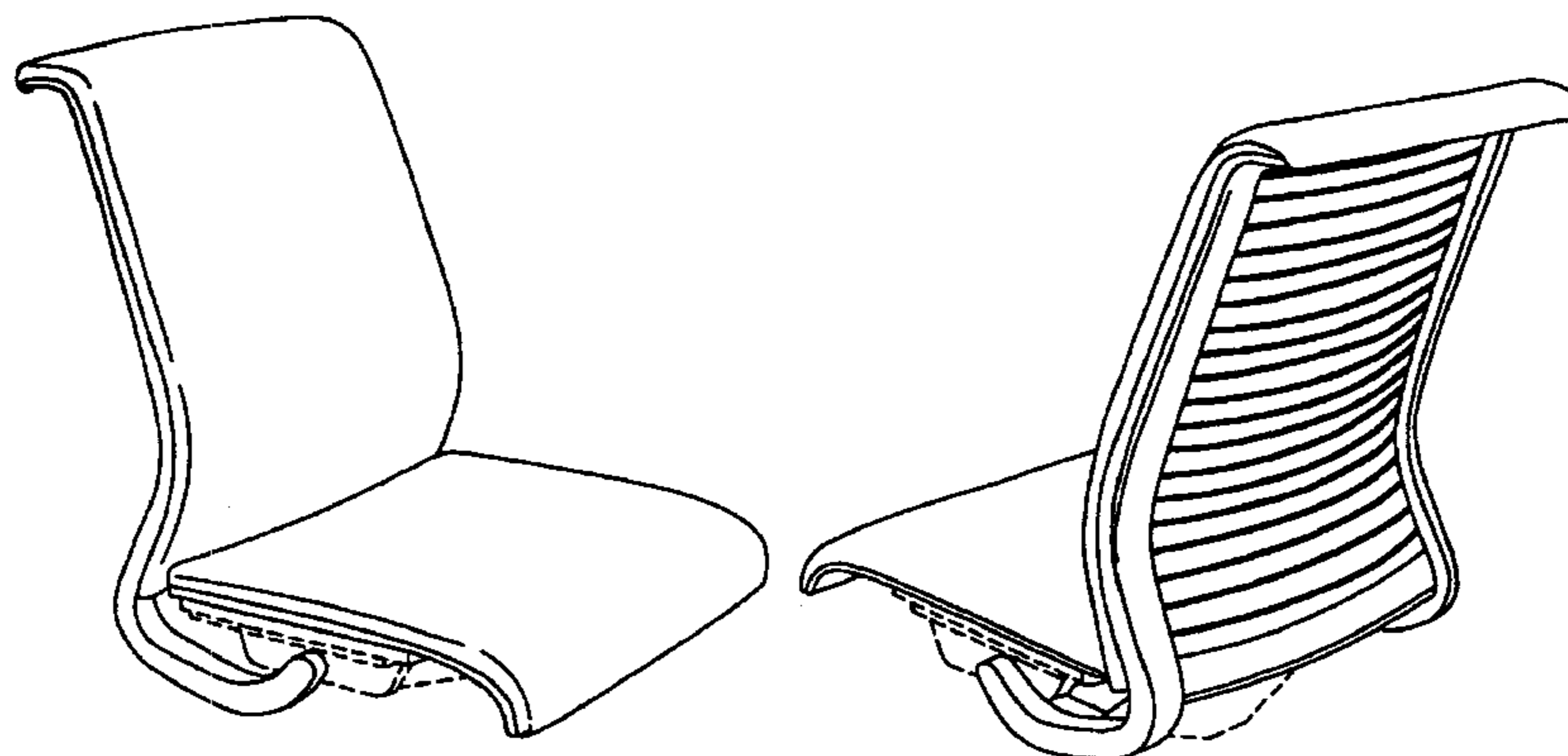
We claim the ornamental design for a seat and back arrangement, as shown and described.

**DESCRIPTION**

FIGS. 1-2 are front and rear perspective views of a seat and back arrangement embodying the present invention; and, FIGS. 3-8 are right, front, left, rear, top, and bottom views, respectively, of the seat and back arrangement shown in FIGS. 1-2.

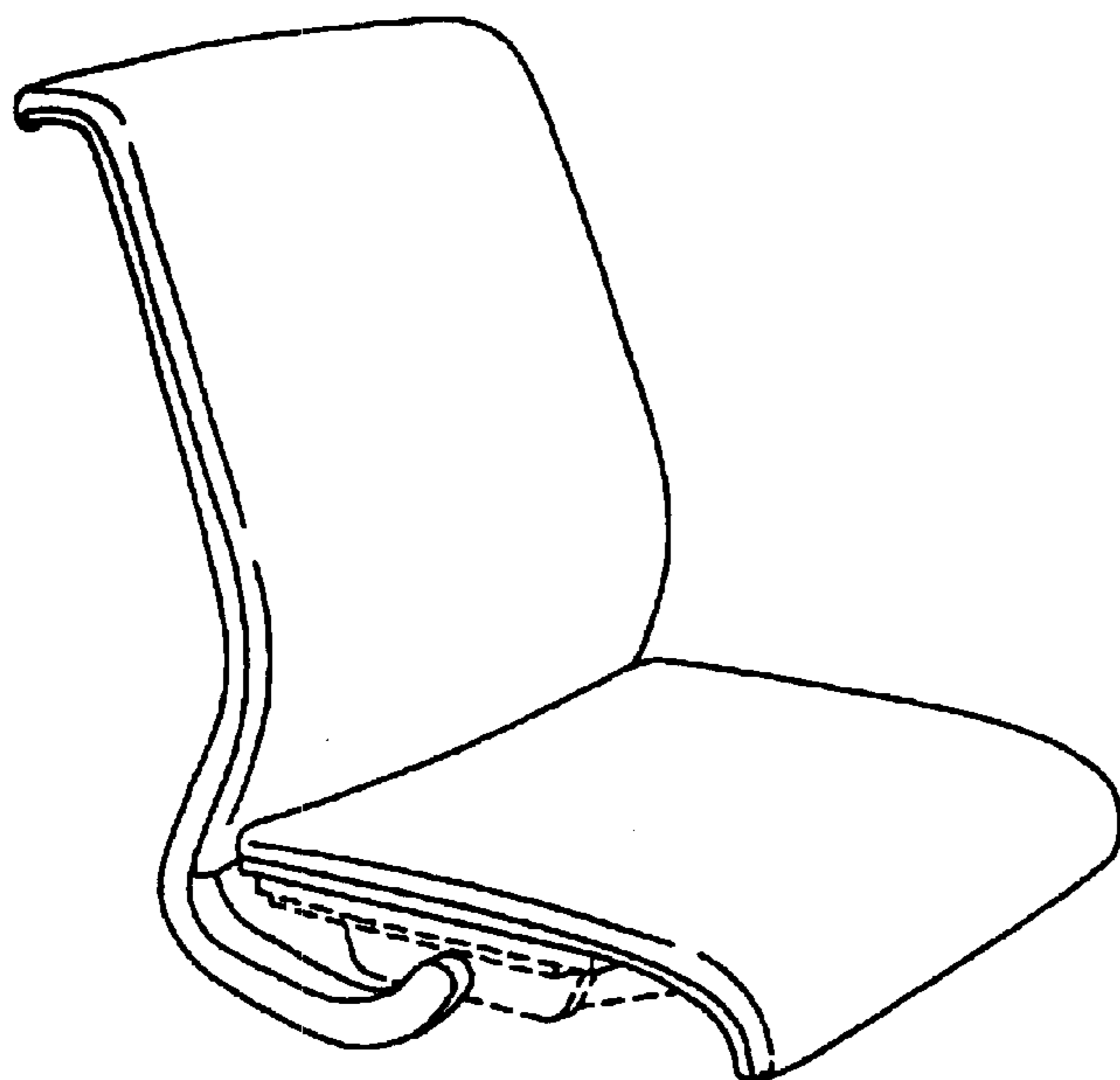

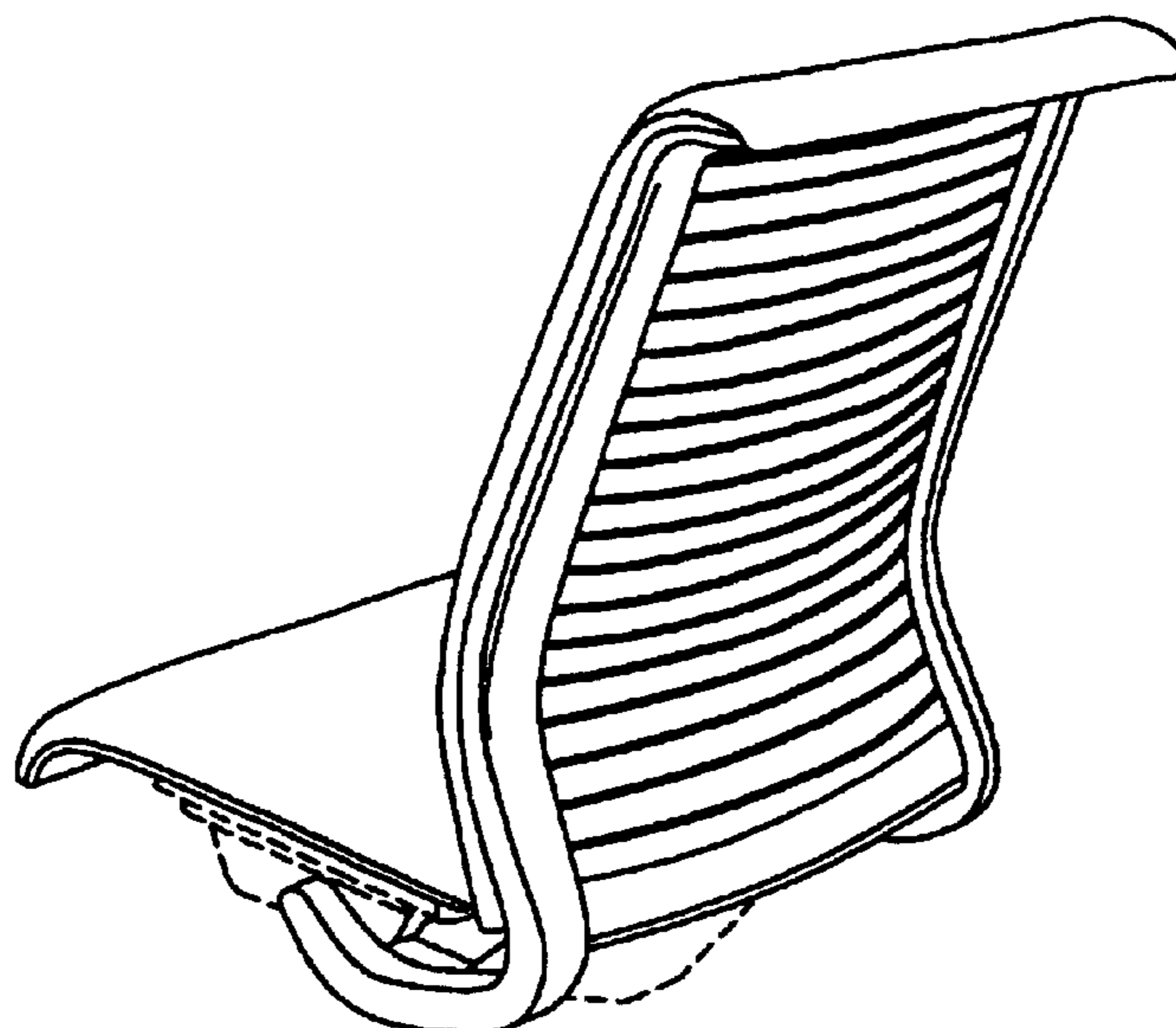

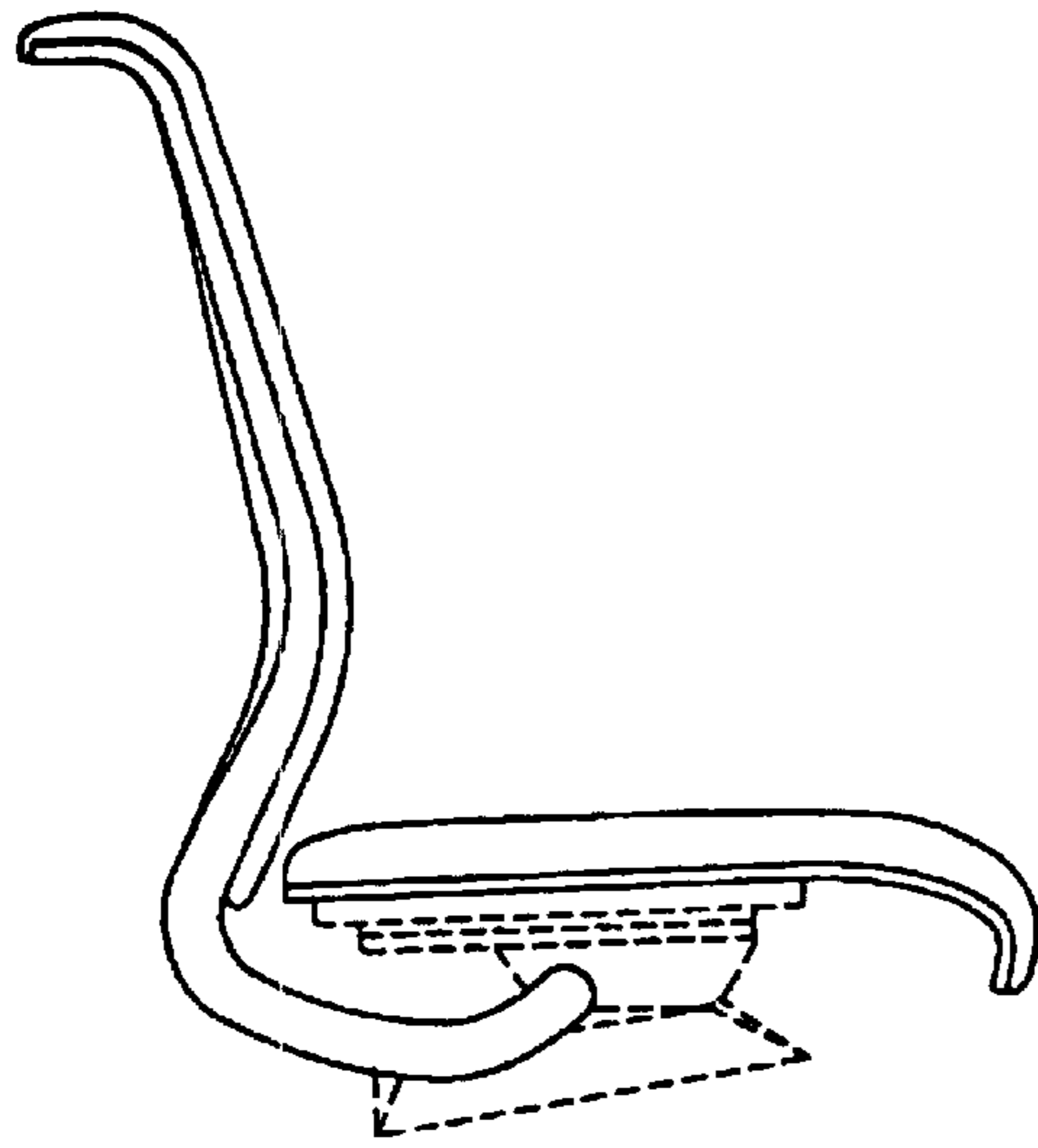

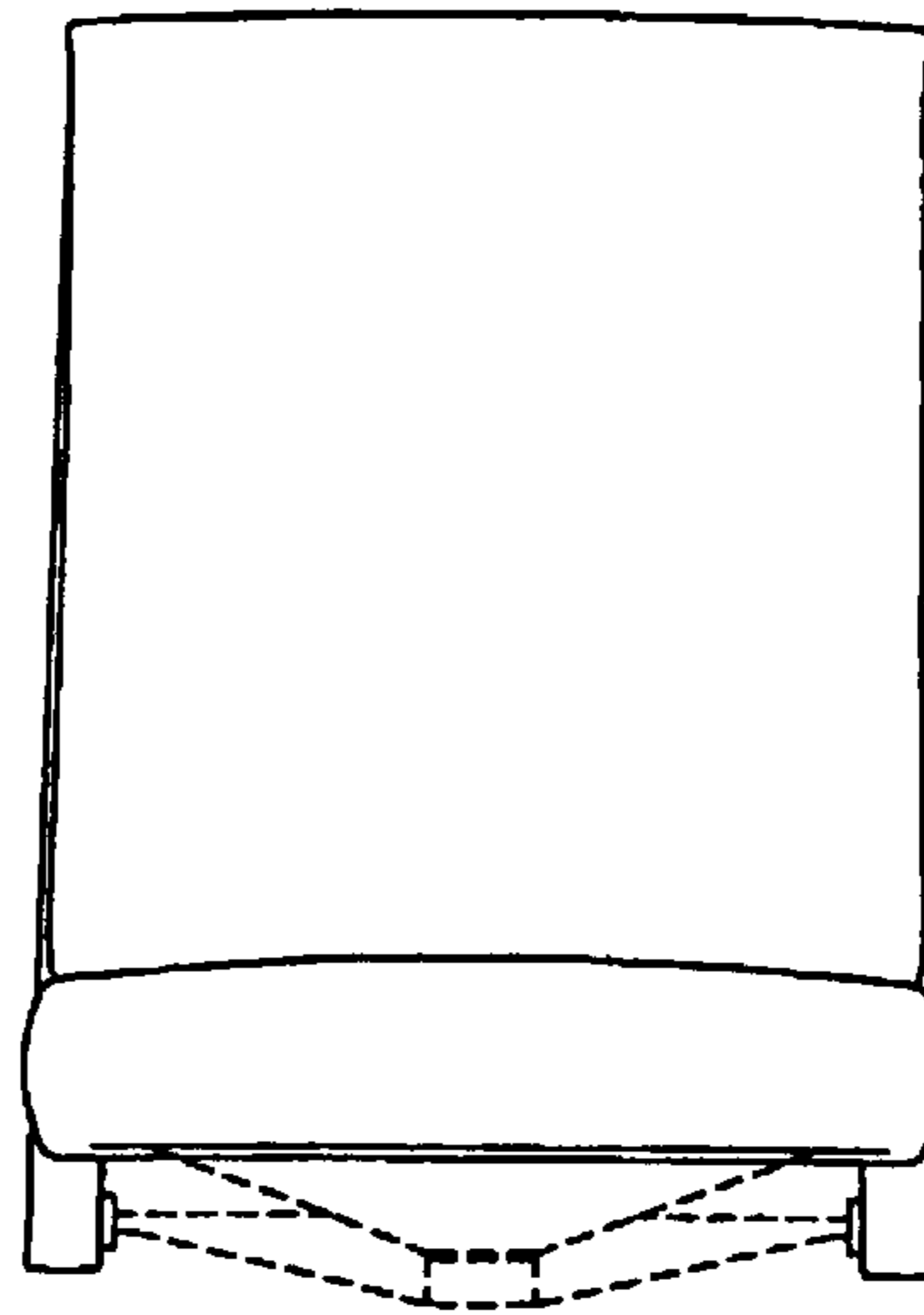

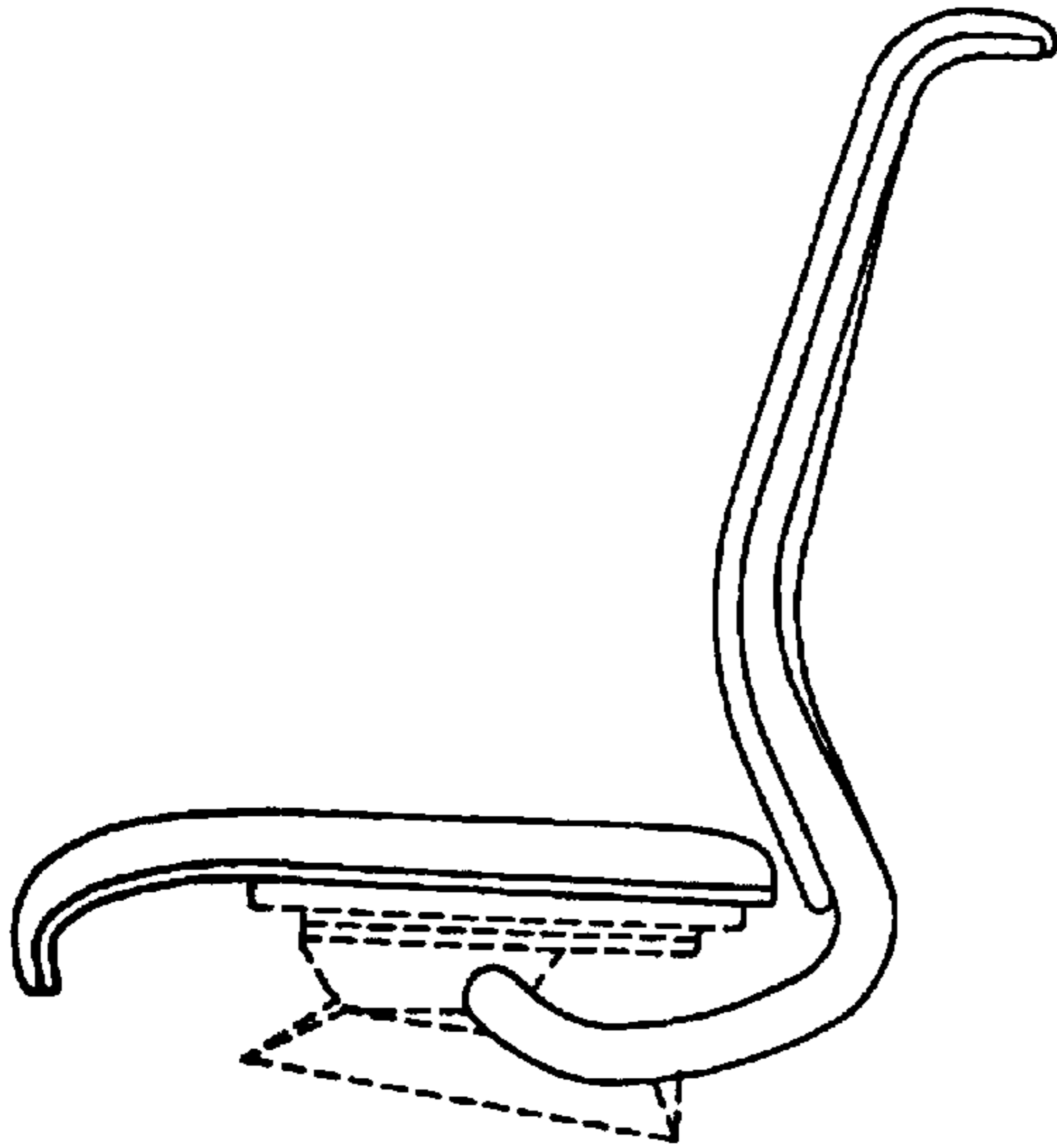

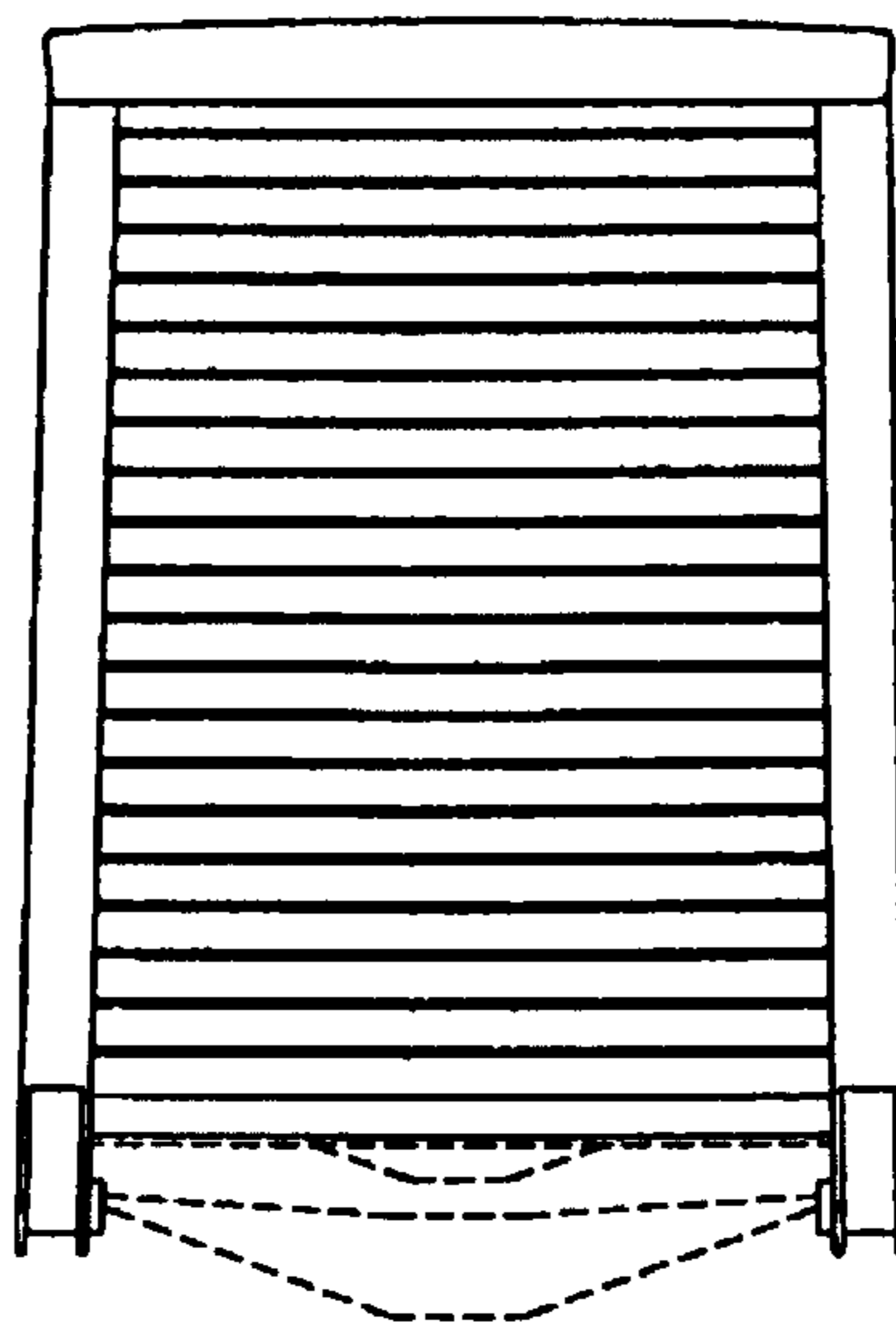

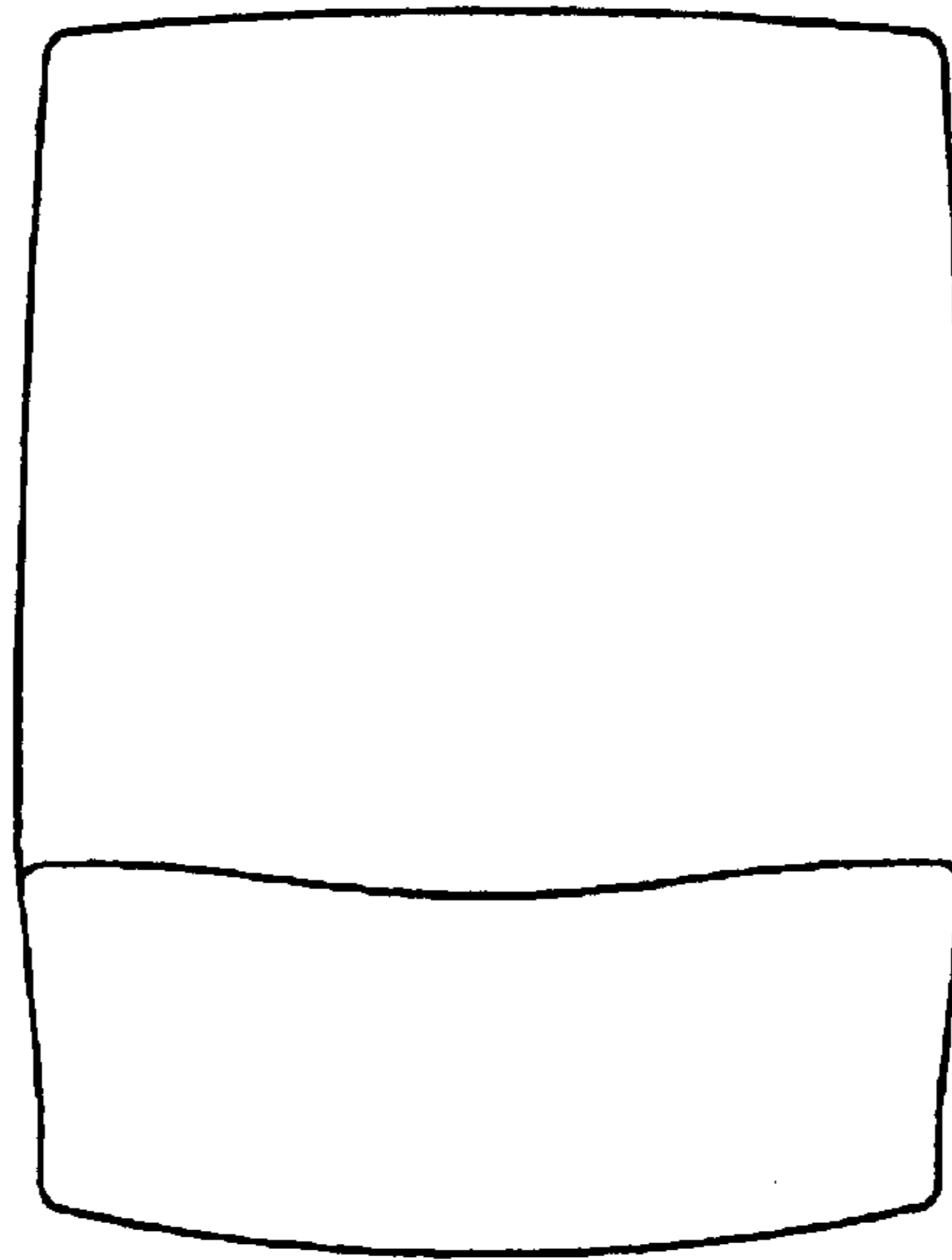

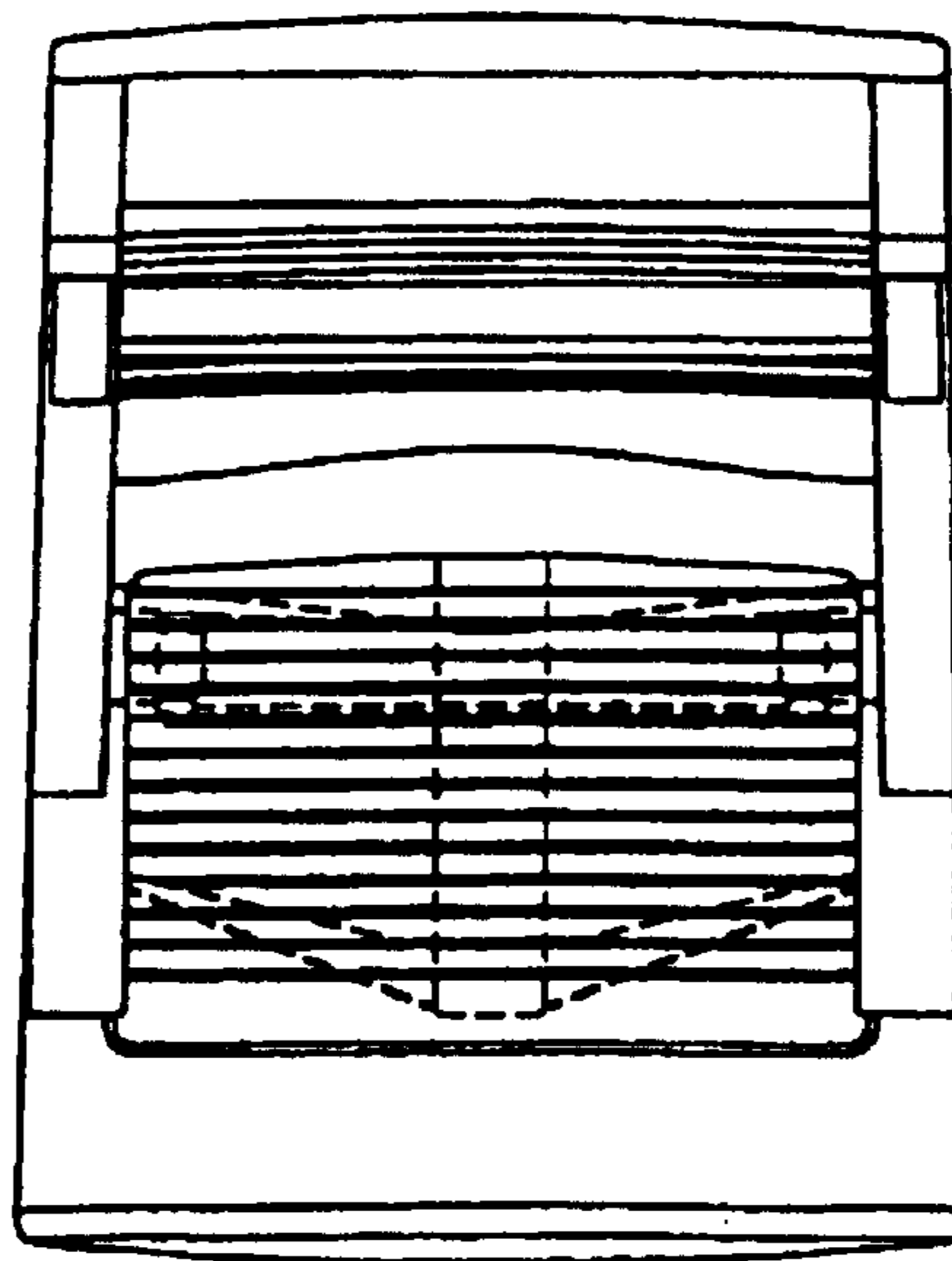
