(57) **CLAIM**

The ornamental design for a chair arm, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the top, left side and front of a chair arm which forms our new design, the broken lines of a chair and an arm pad being for illustrative purposes only and forming no part of our design;

FIG. 2 is an enlarged left side elevational view thereof, the broken lines of the arm pad in this and other figures being for illustrative purposes only and forming no part of our design;

FIG. 3 top plan view thereof;

FIG. 4 is an enlarged right side view thereof;

FIG. 5 is an enlarged bottom plan view thereof;

FIG. 6 is an enlarged front elevational view thereof;

FIG. 7 is an enlarged rear elevational view thereof; and,

FIG. 8 is an enlarged perspective view showing the top, left side and front thereof.

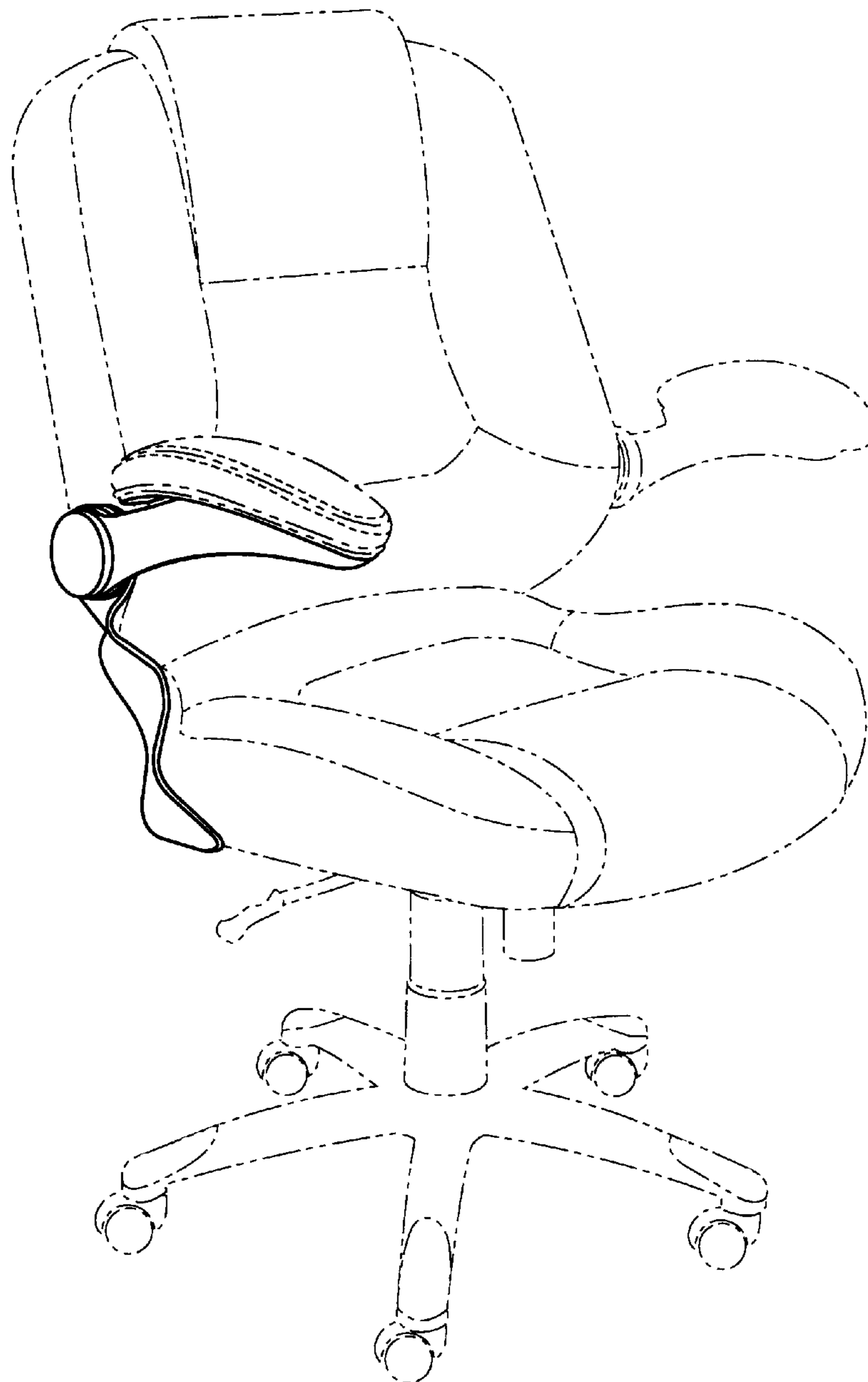

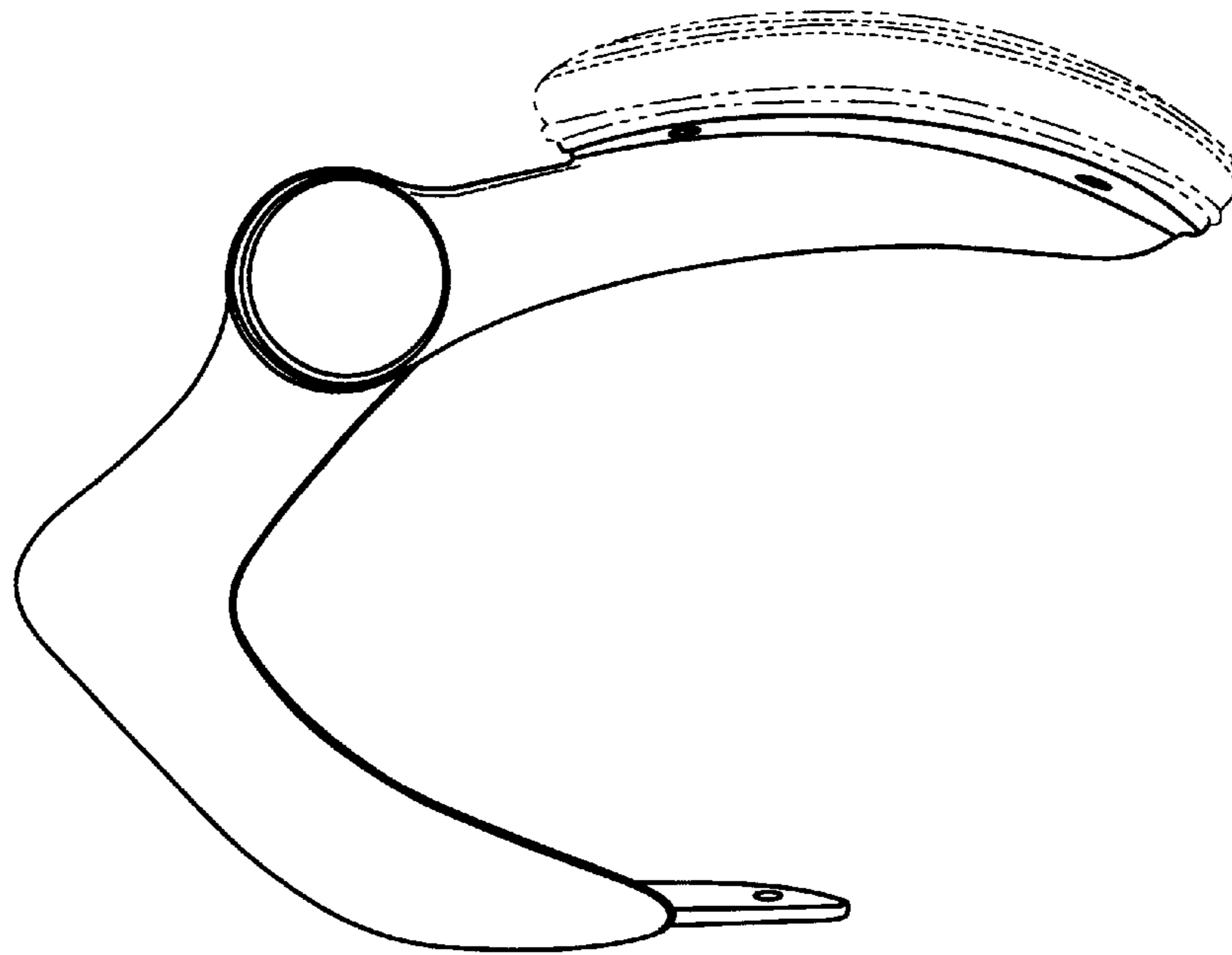

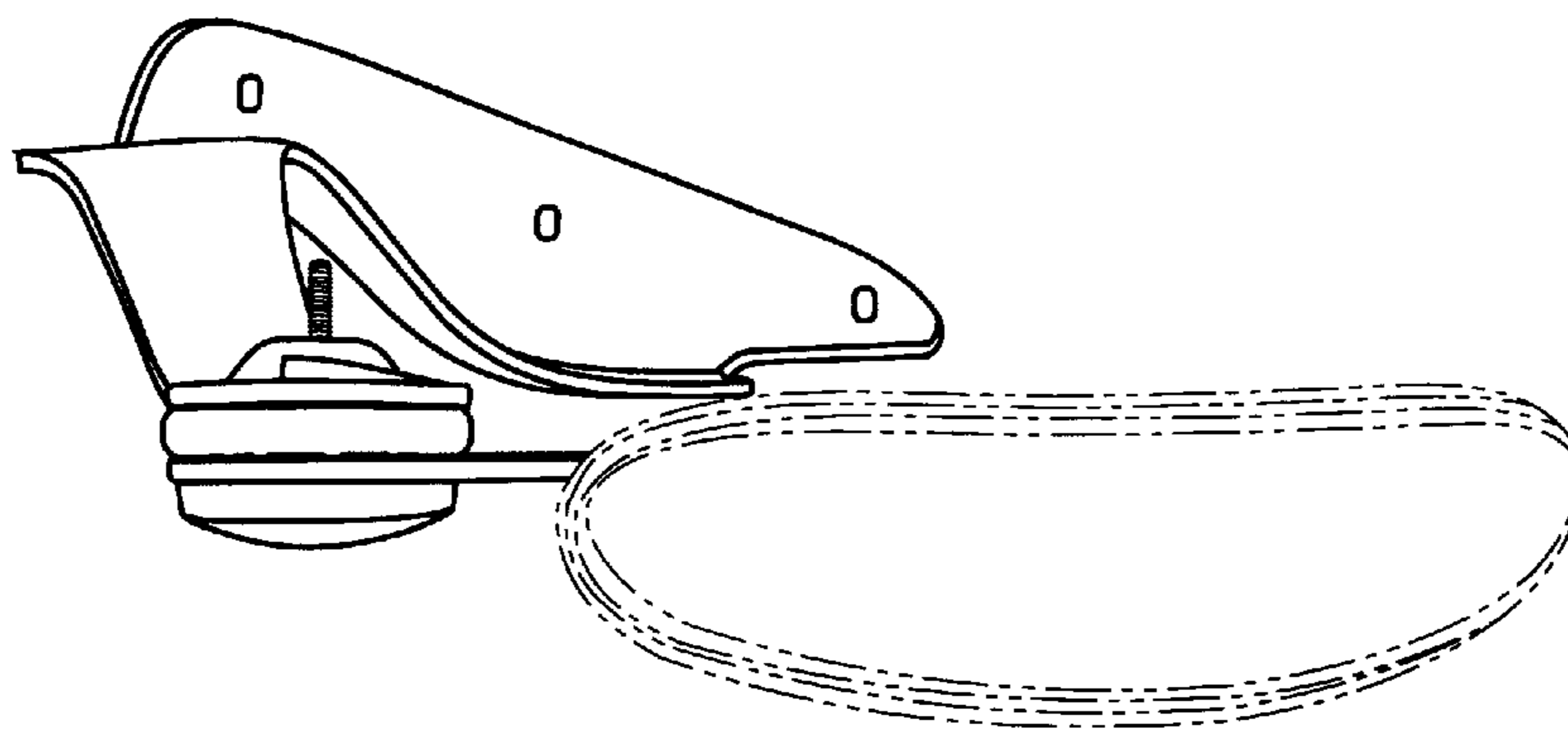

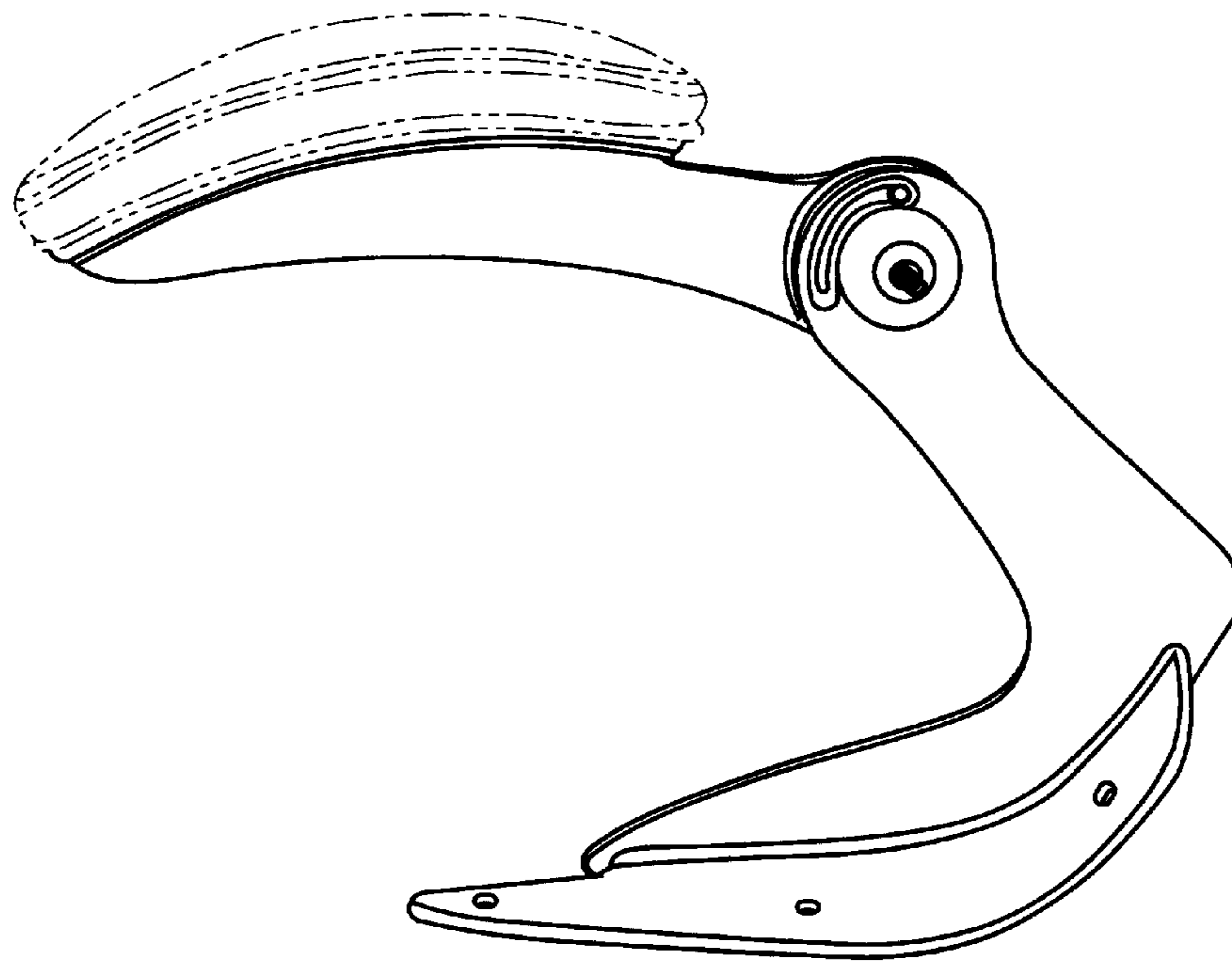

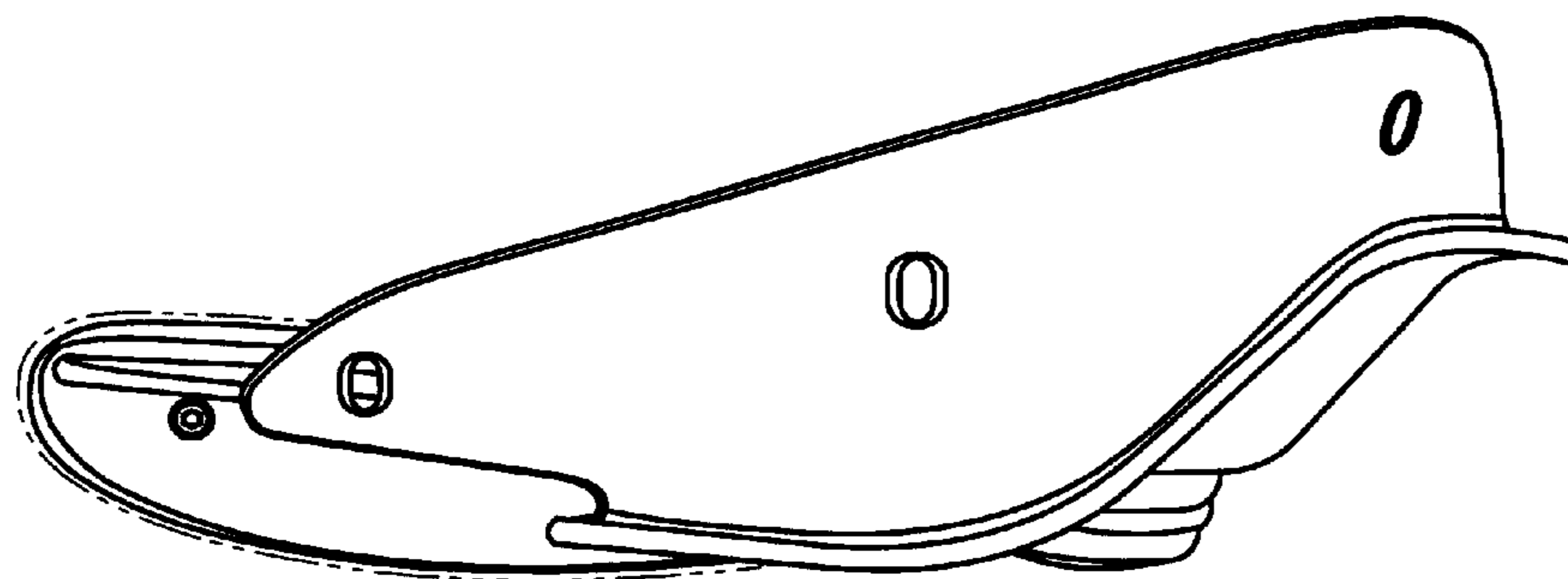

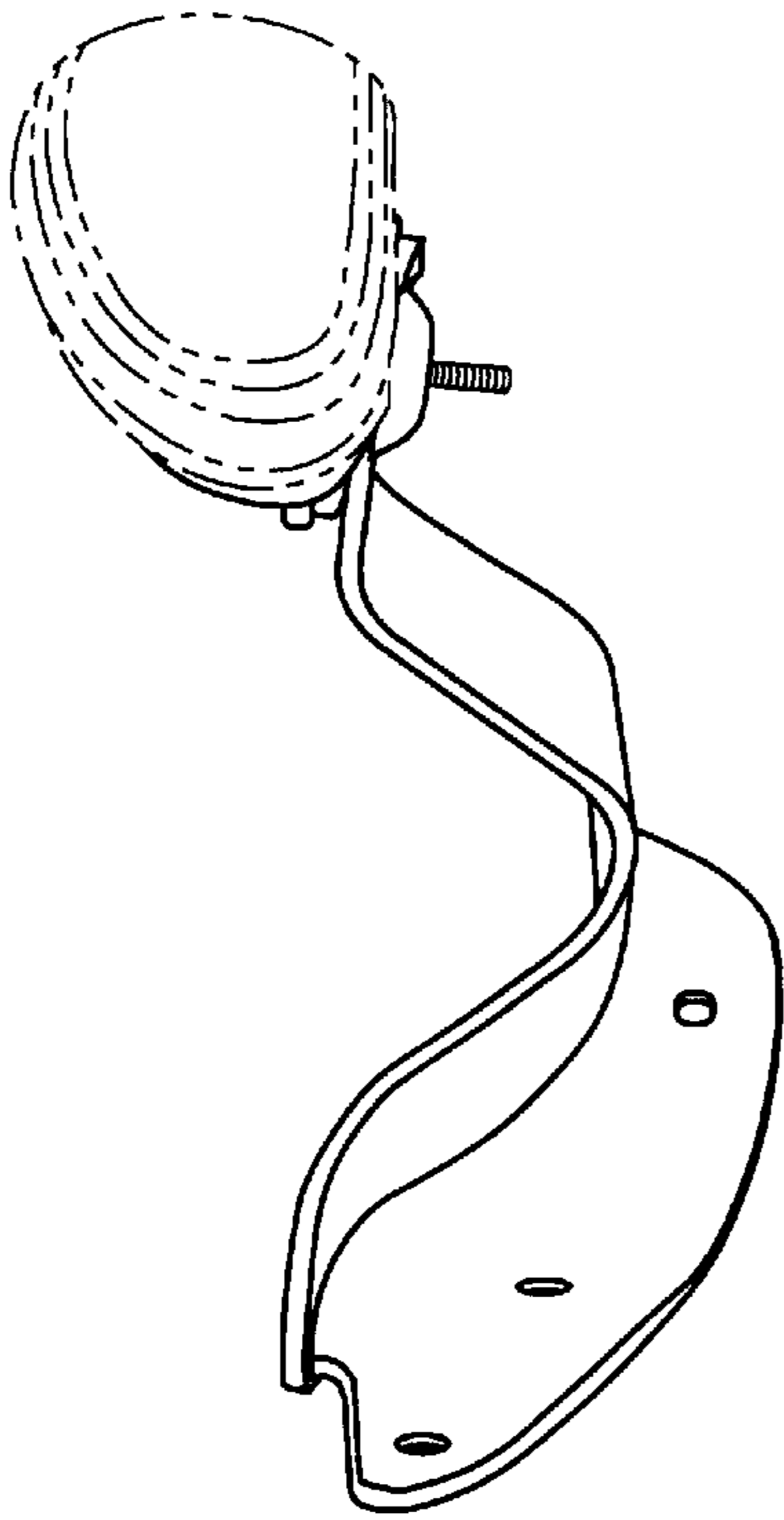

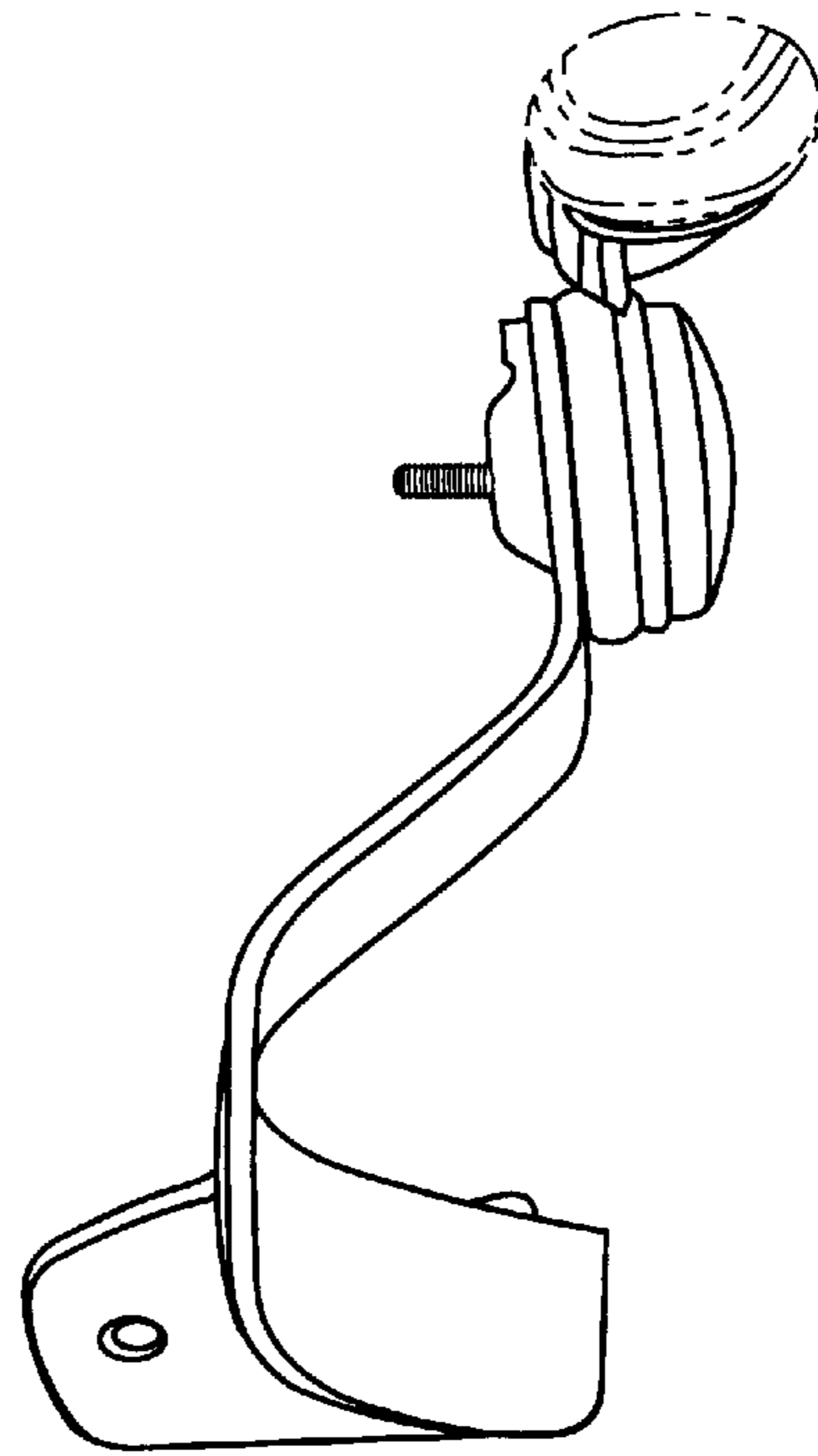

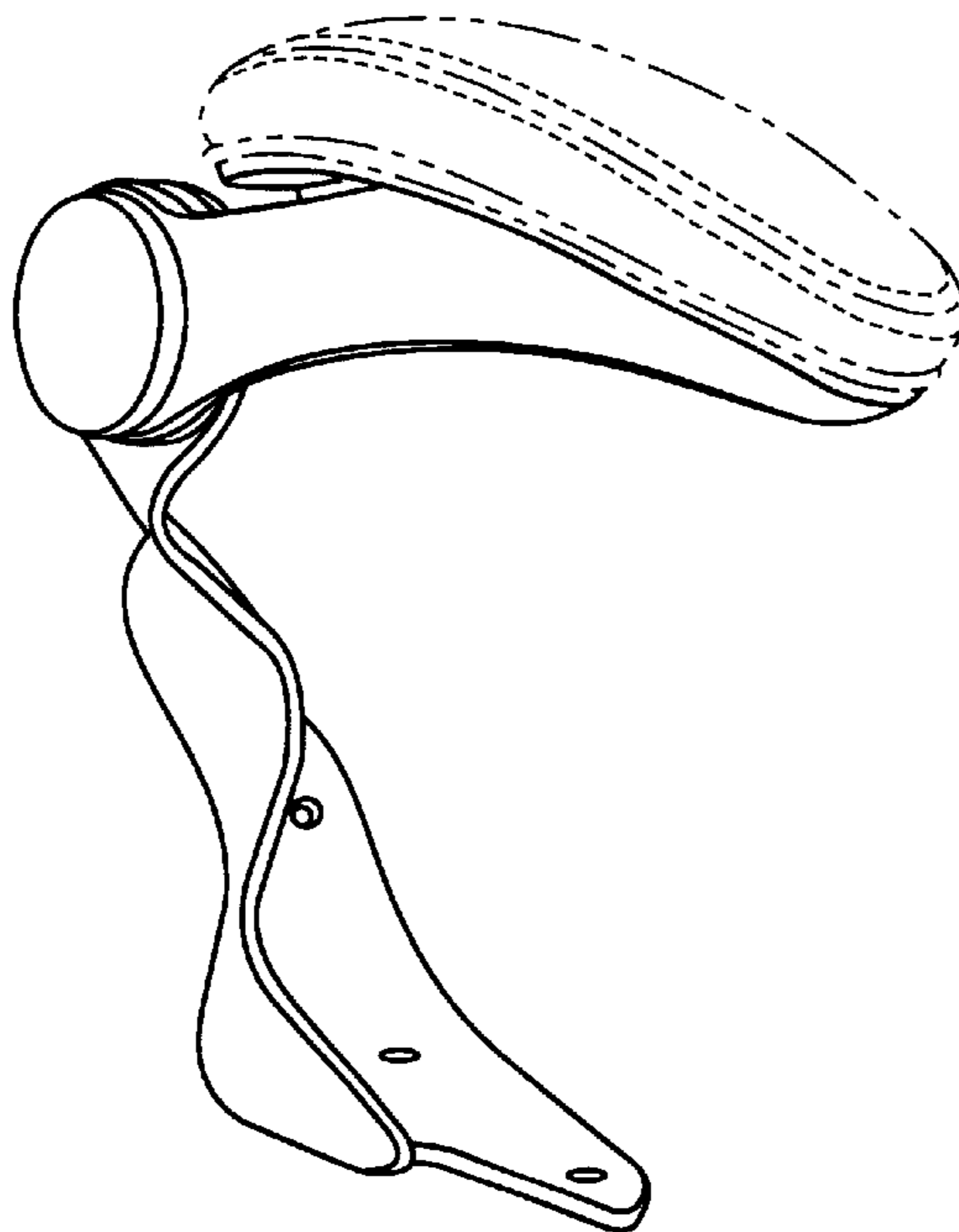
