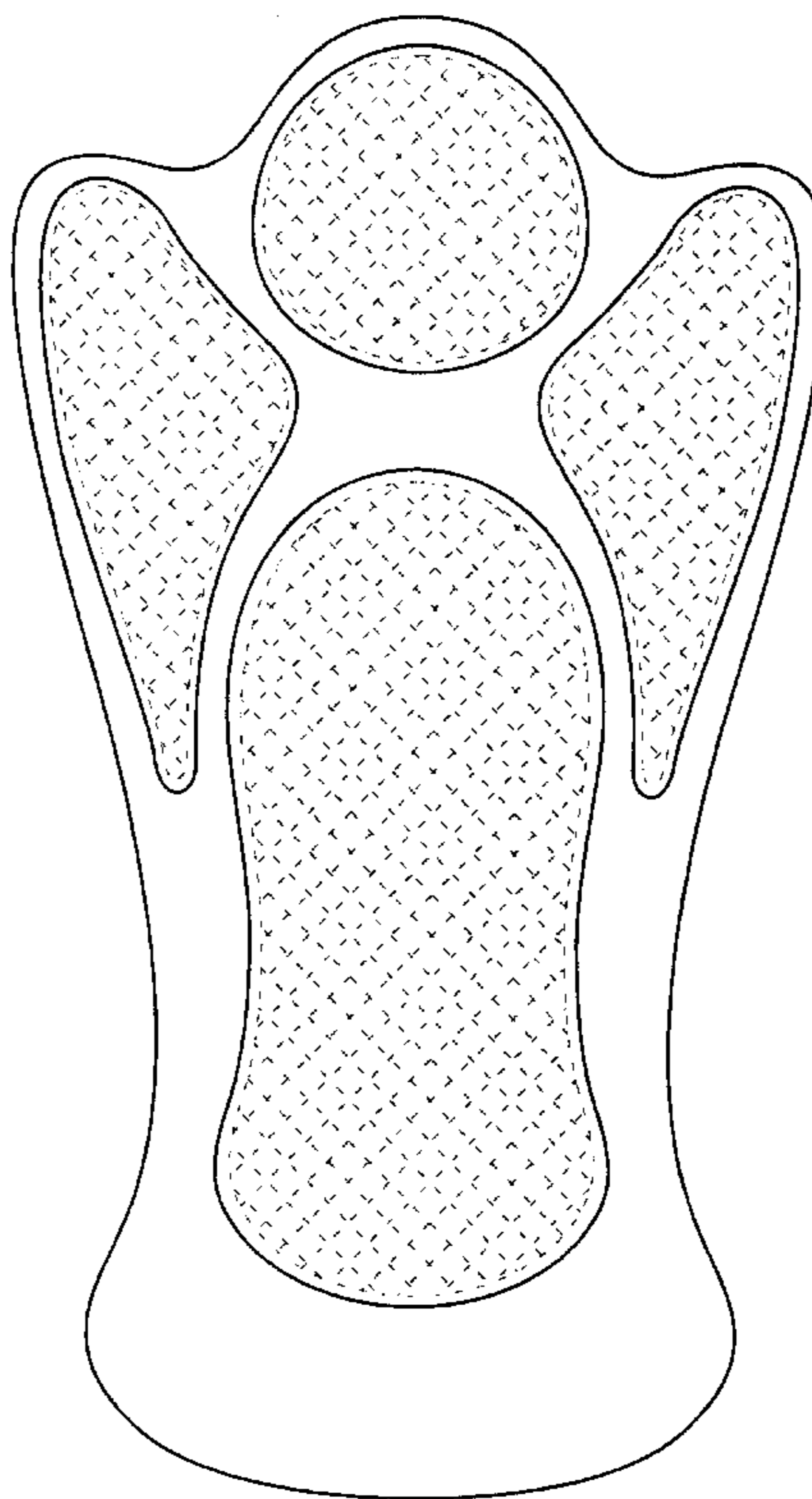
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of the bathtub mat in accordance with my invention;
FIG. 2 is a bottom view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is an upper end view thereof; and,

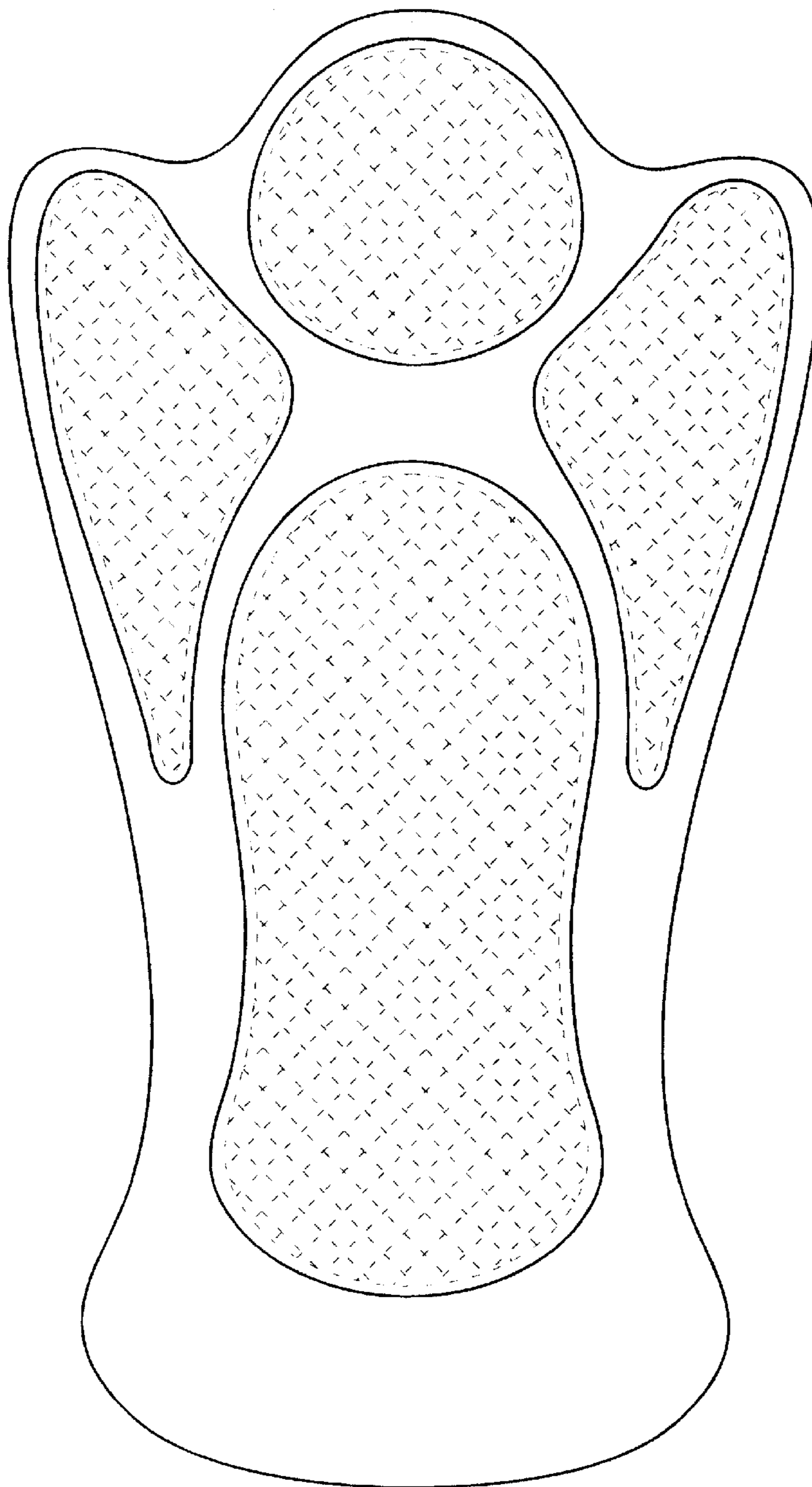

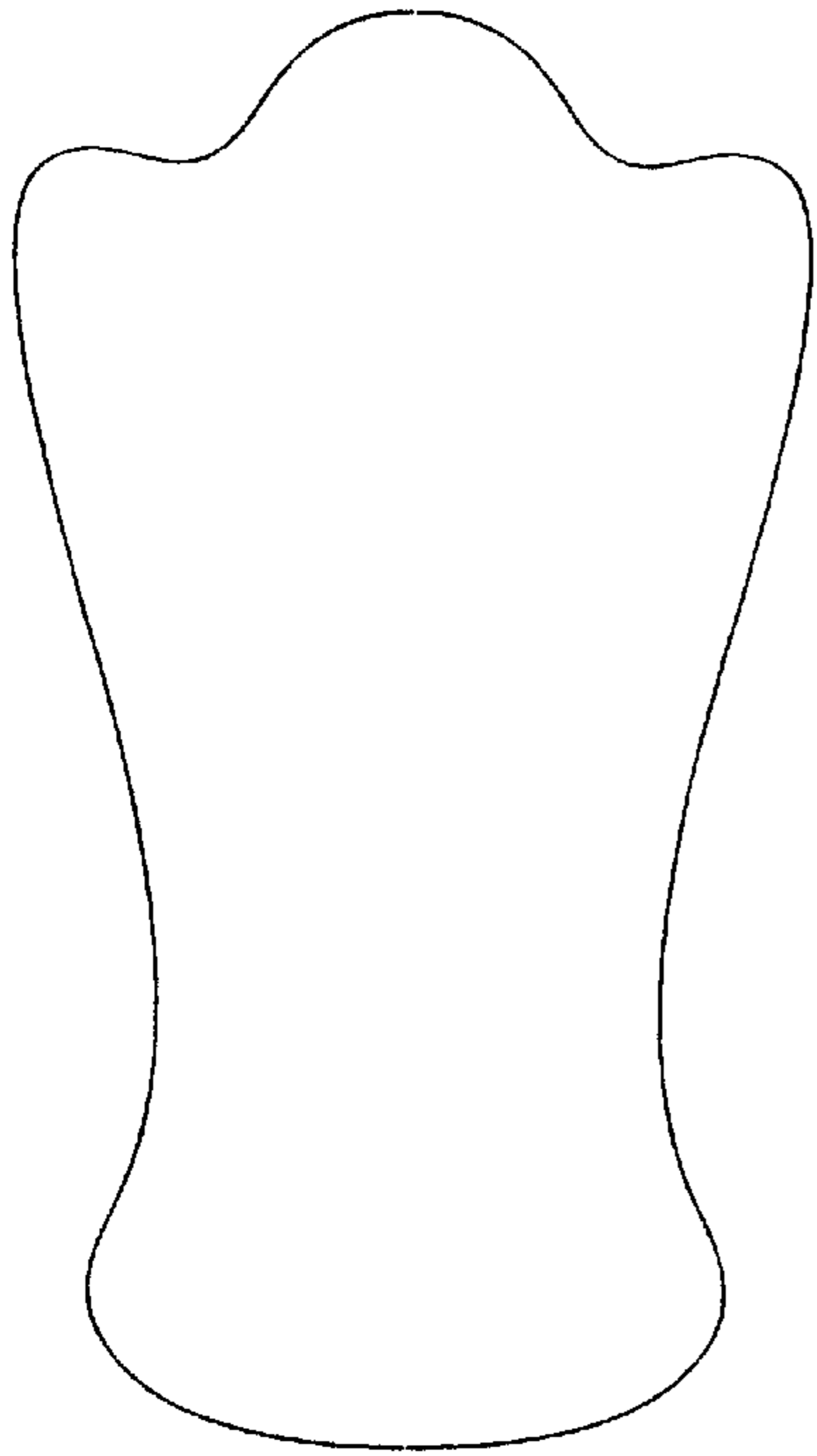

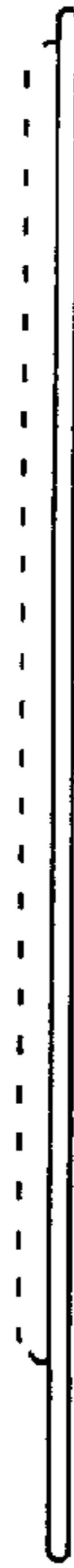

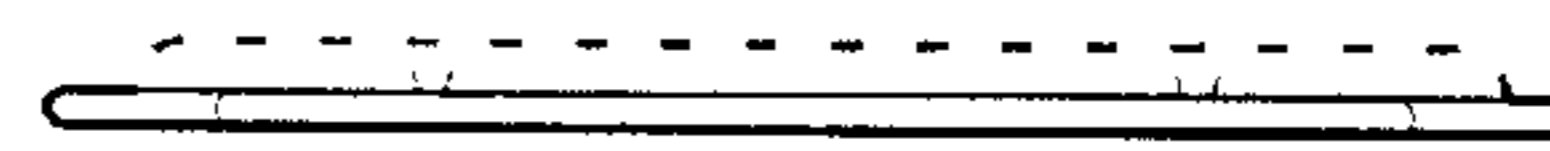
