FIG. 1 is a perspective view of a cutting board showing the new design.

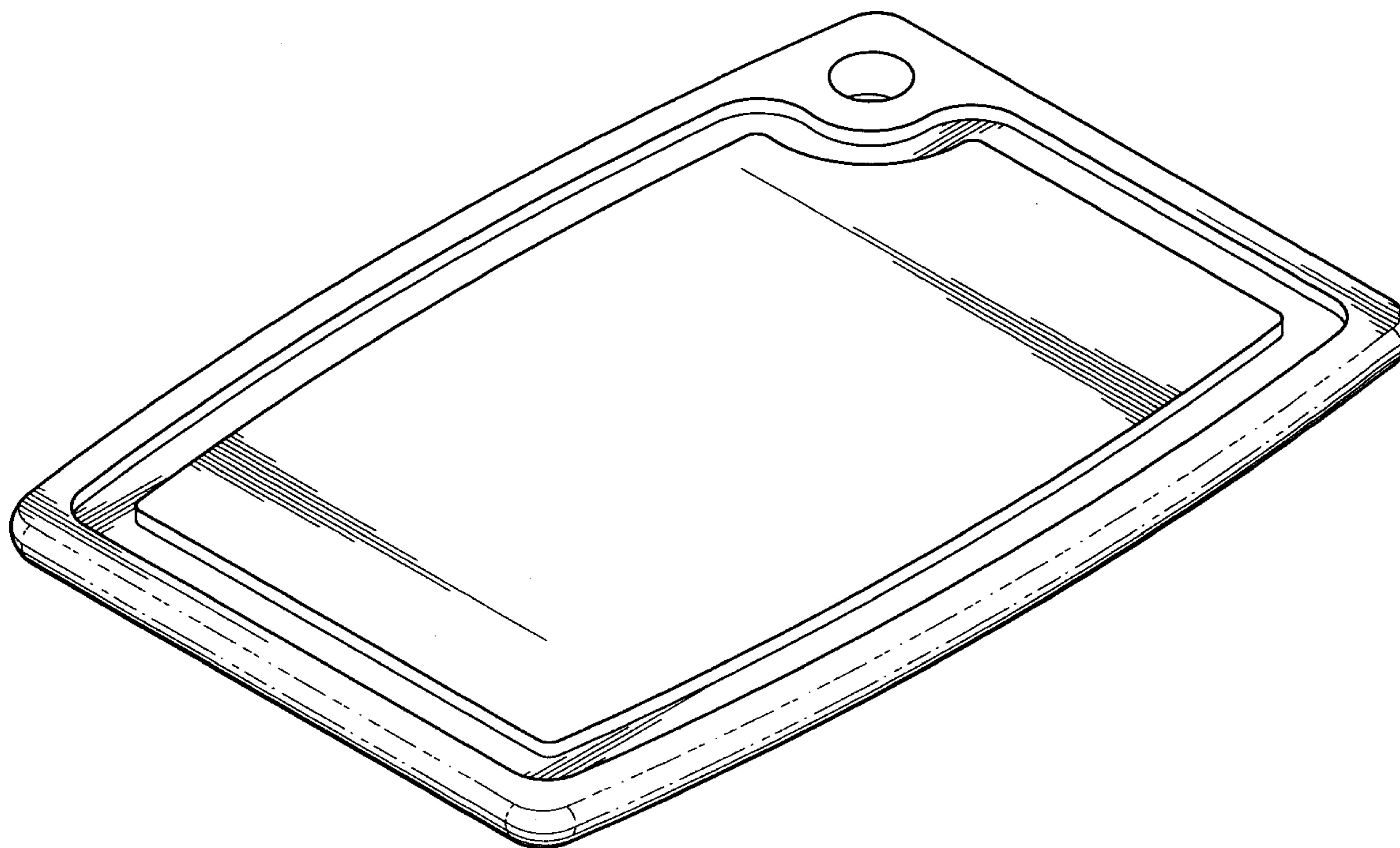
FIG. 2 is a front view thereof;

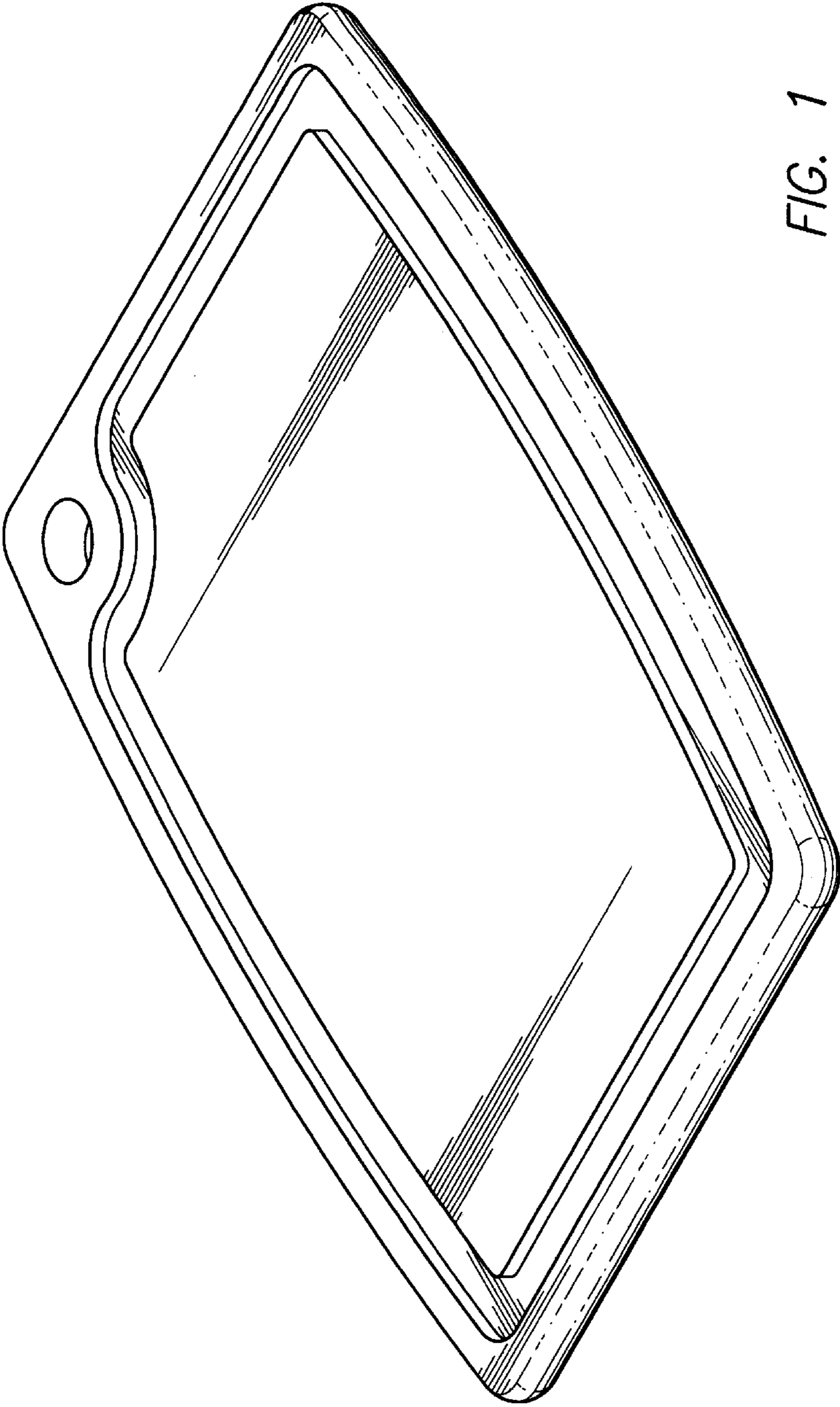

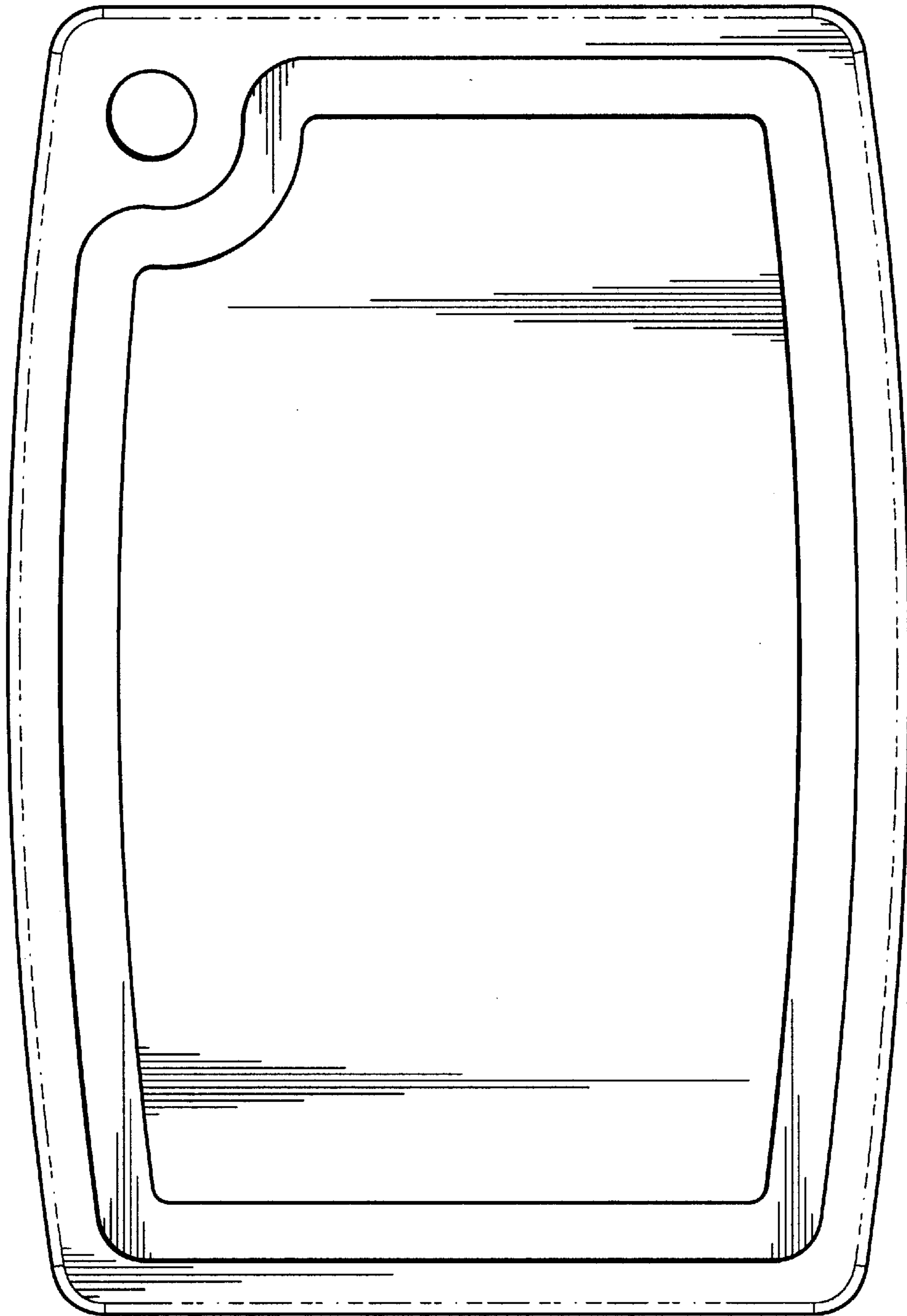

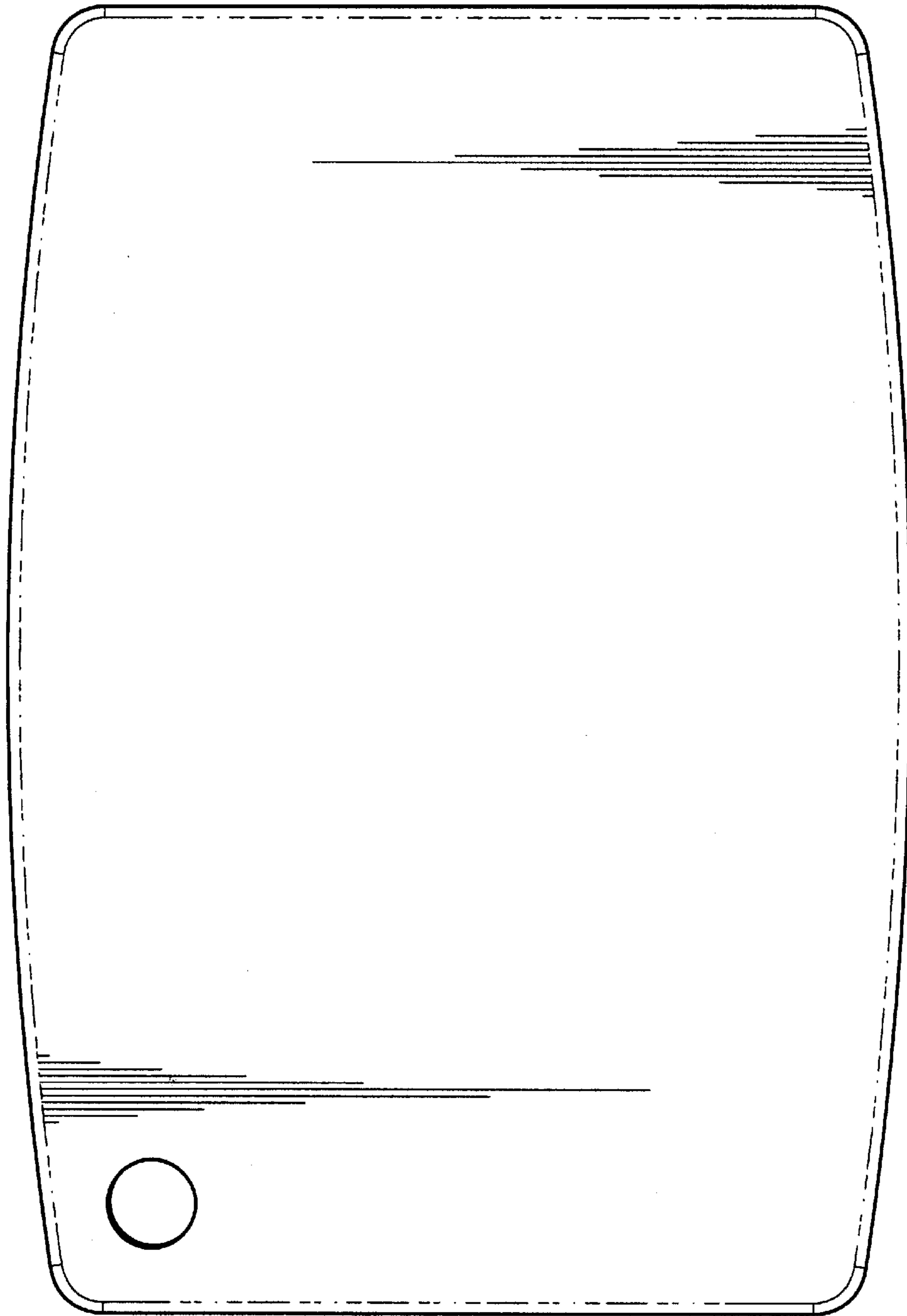

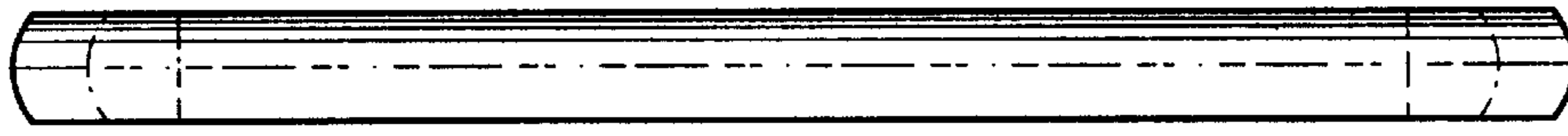

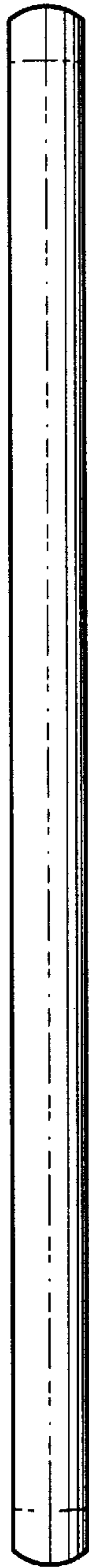
