**DESCRIPTION**

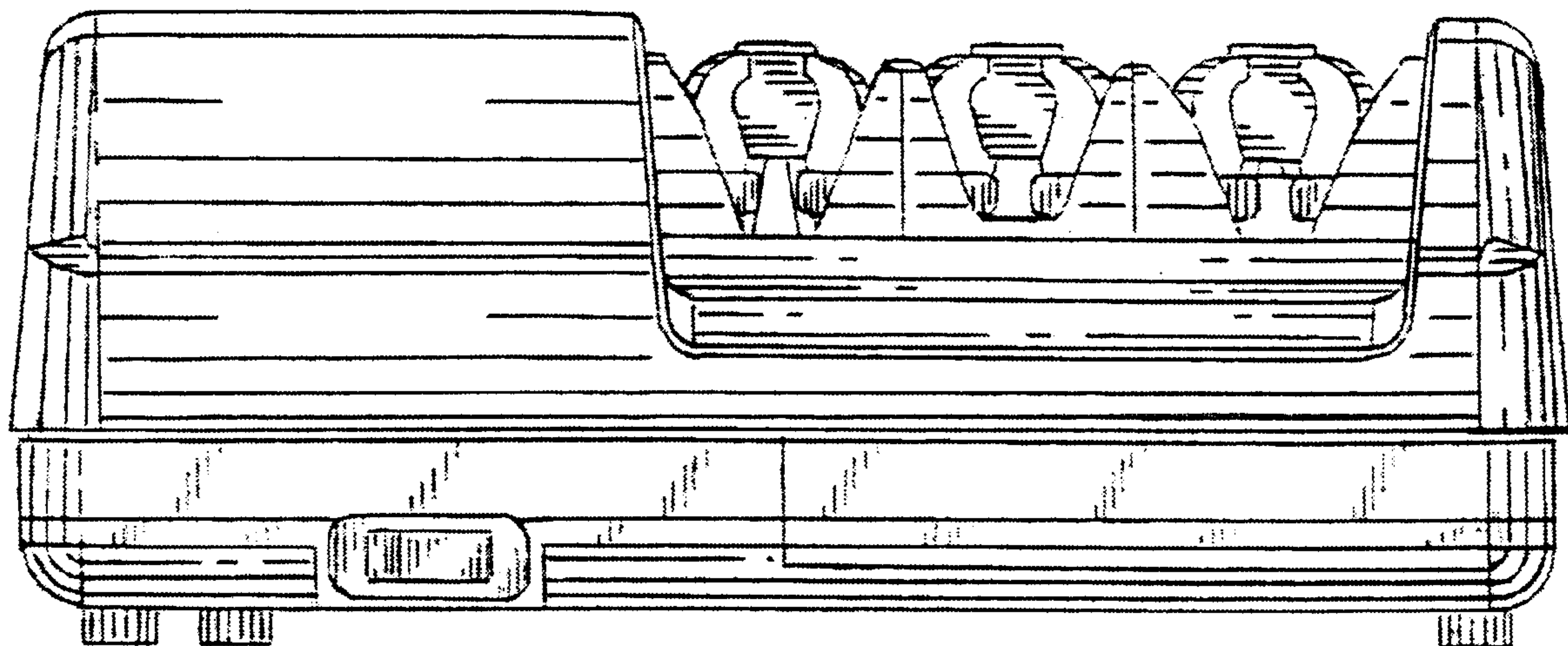
FIG. 1 is a left side elevational view of an electric knife

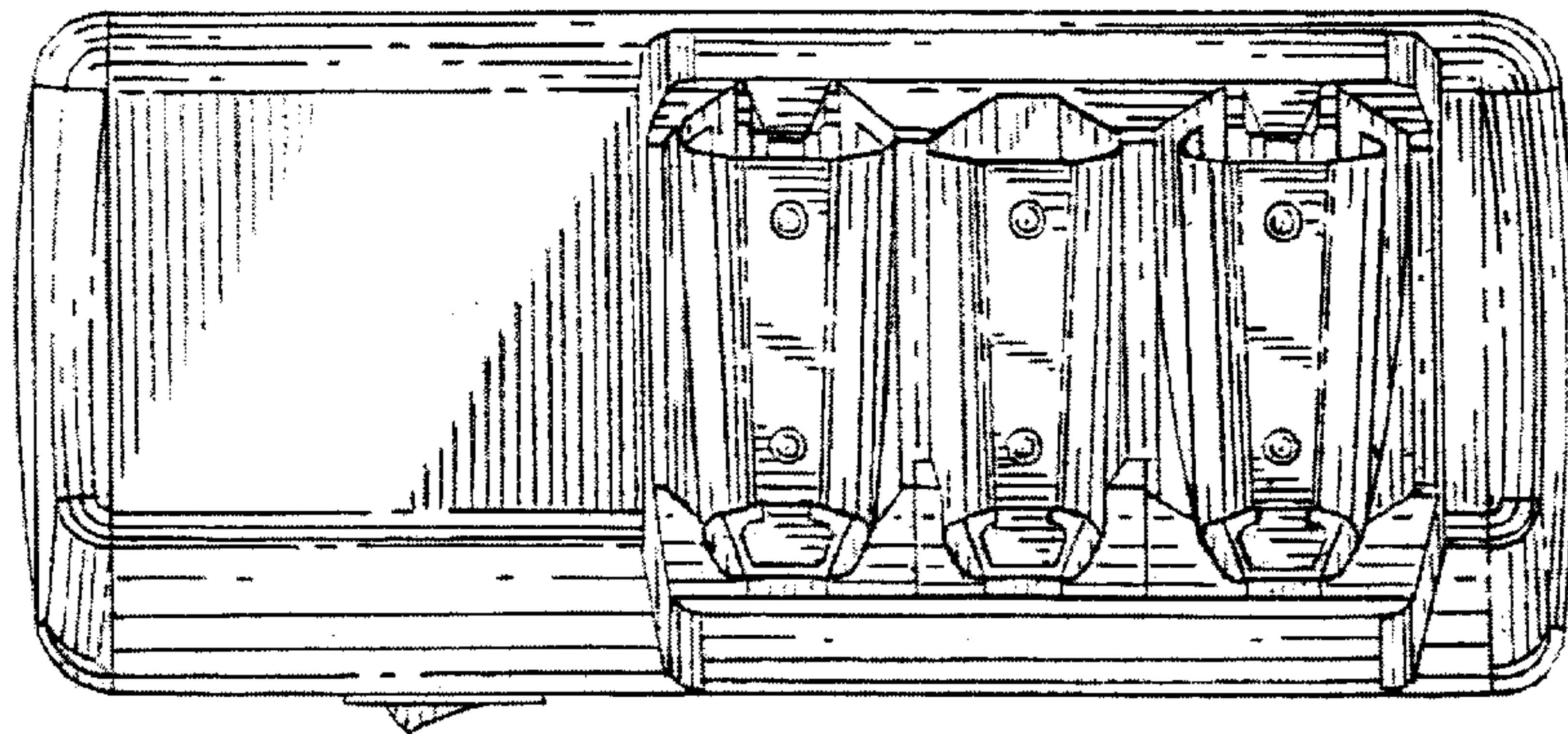

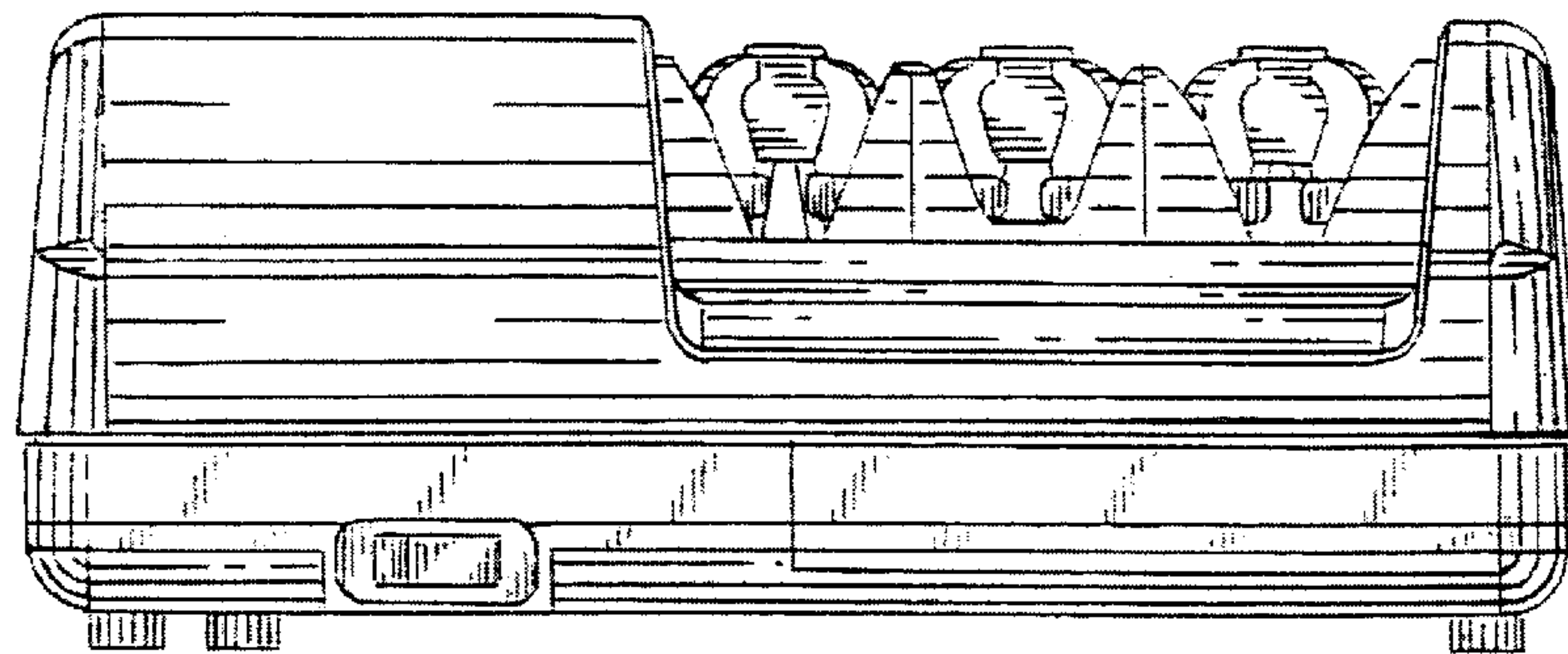

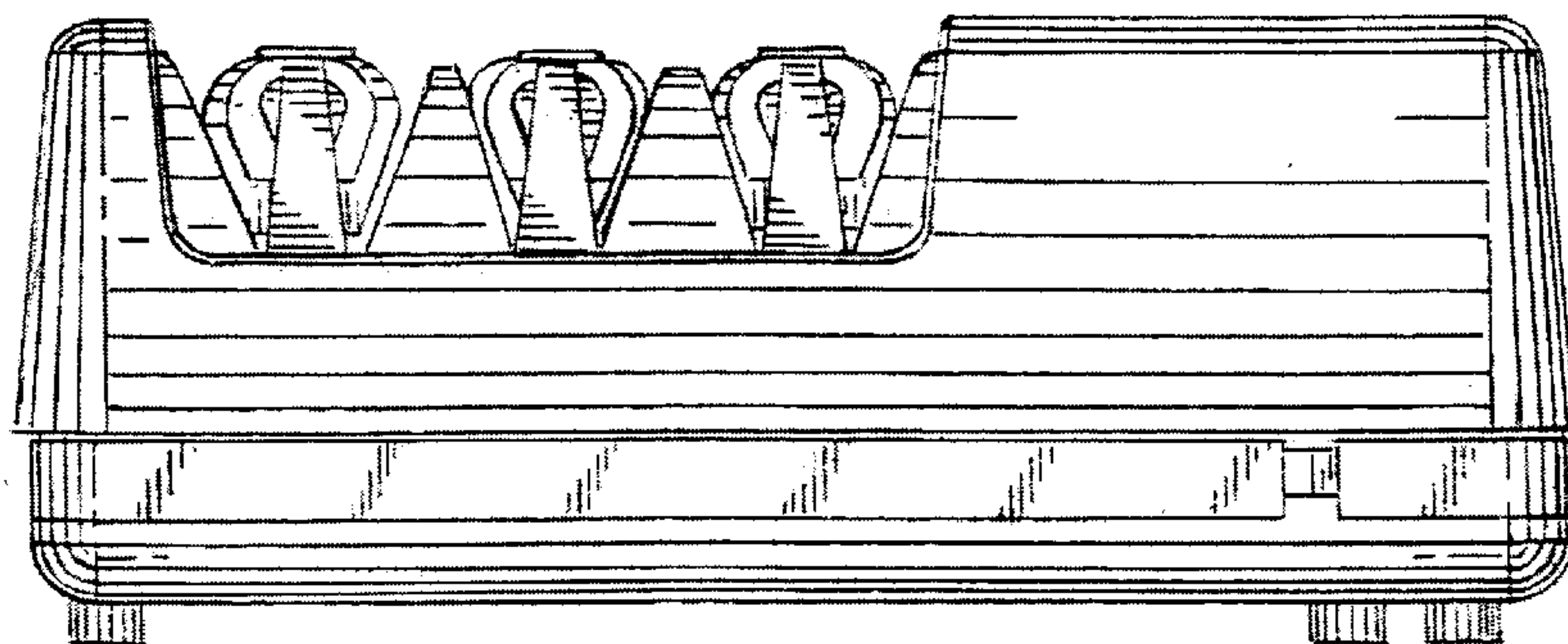

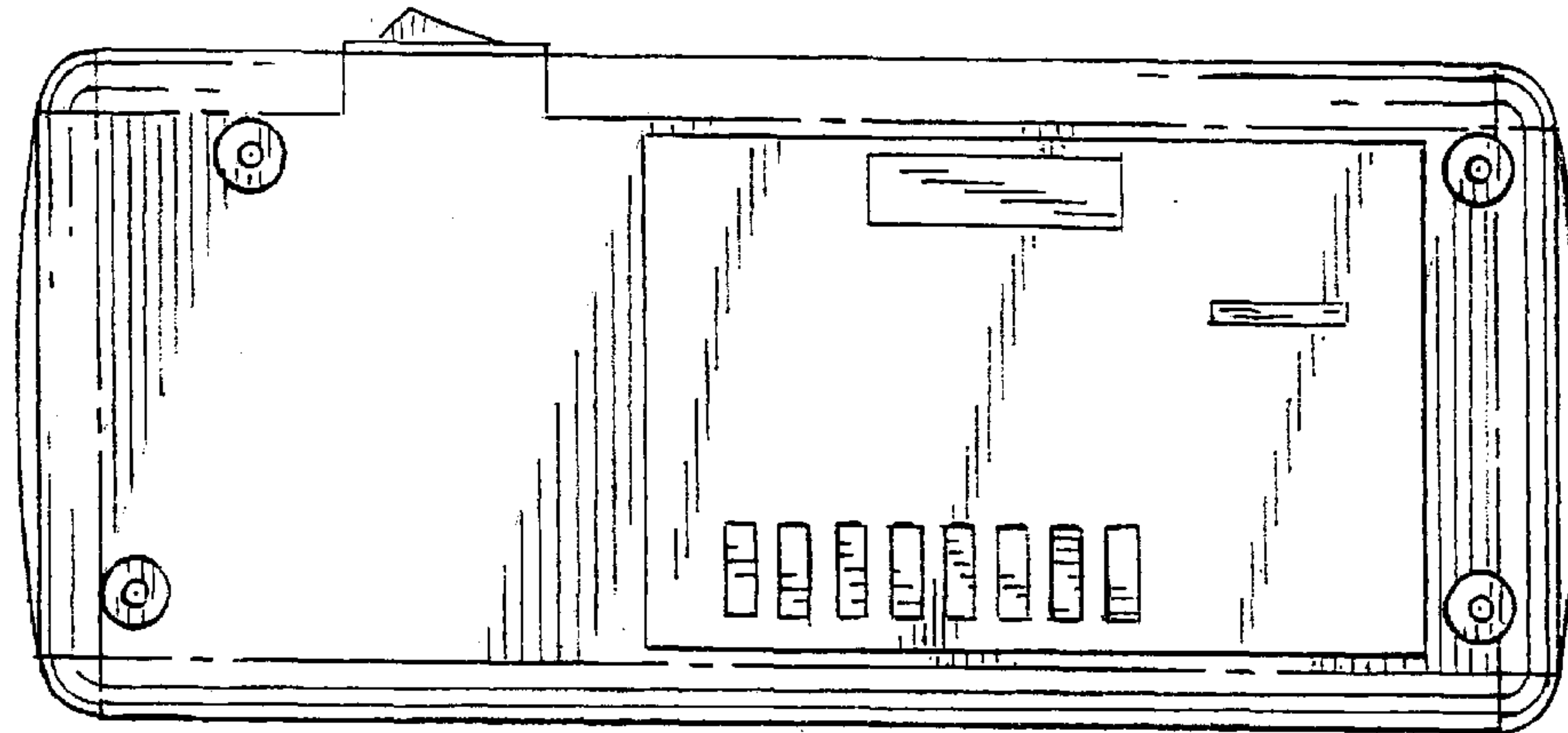
