FIG. 3 is a left side view of the present design;

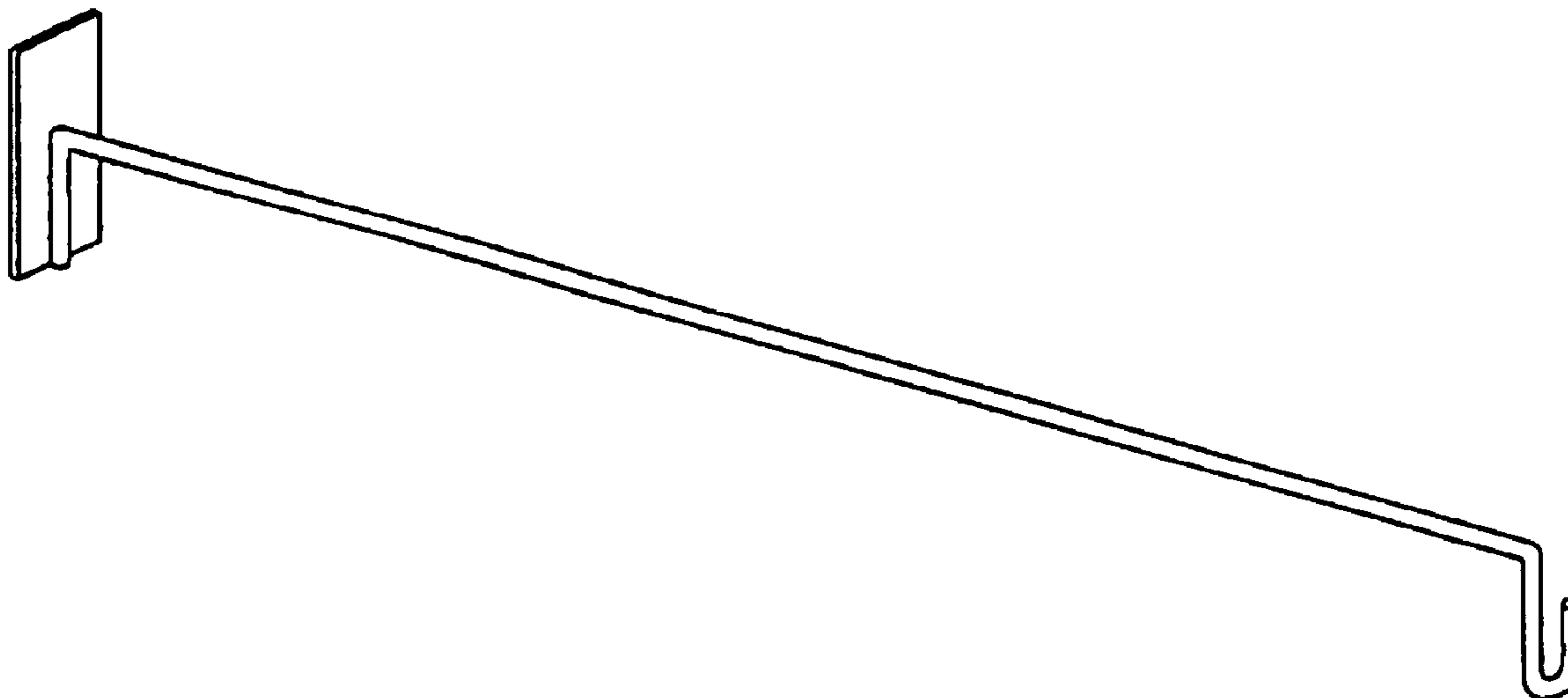
FIG. 4 is front view of the present design;

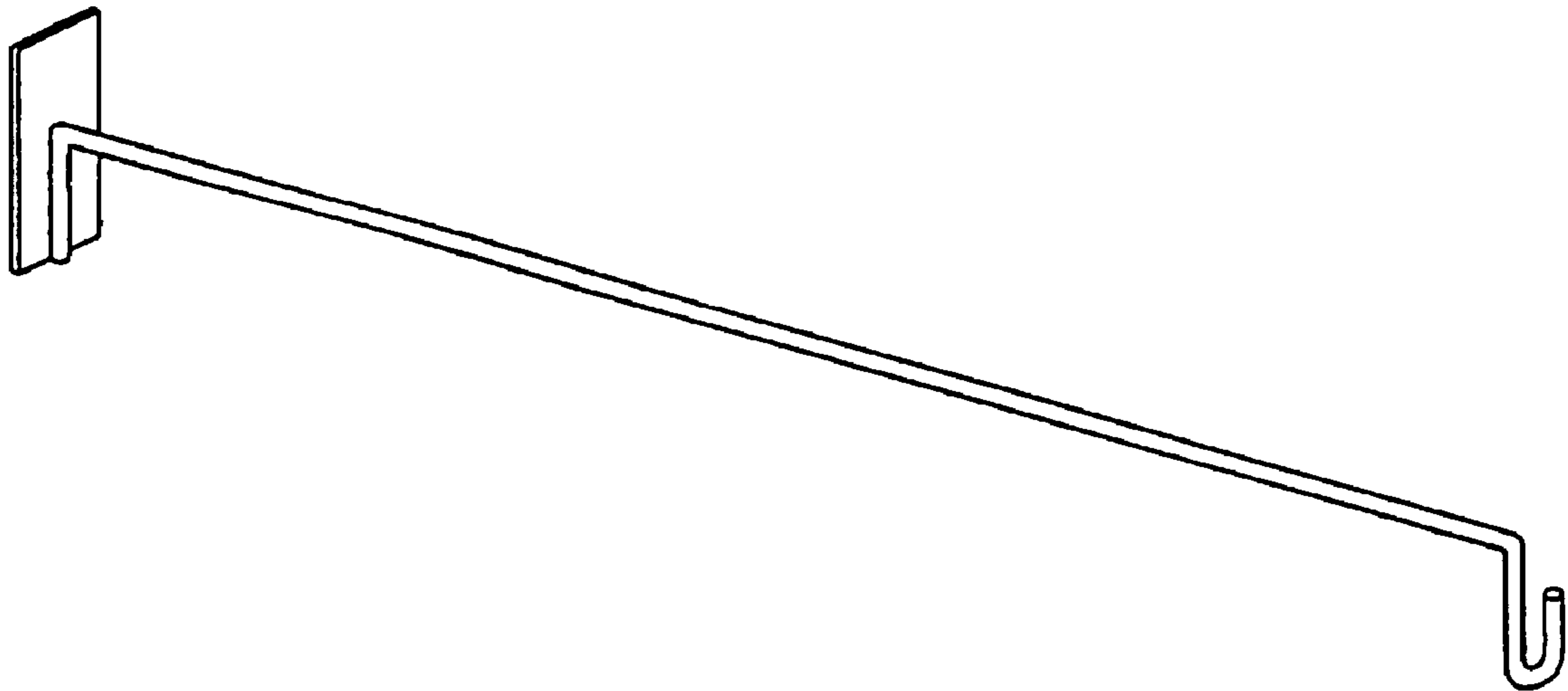

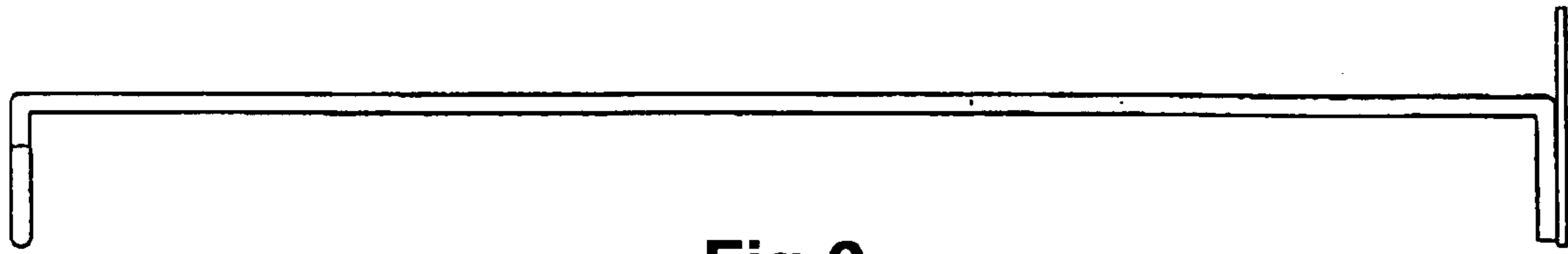

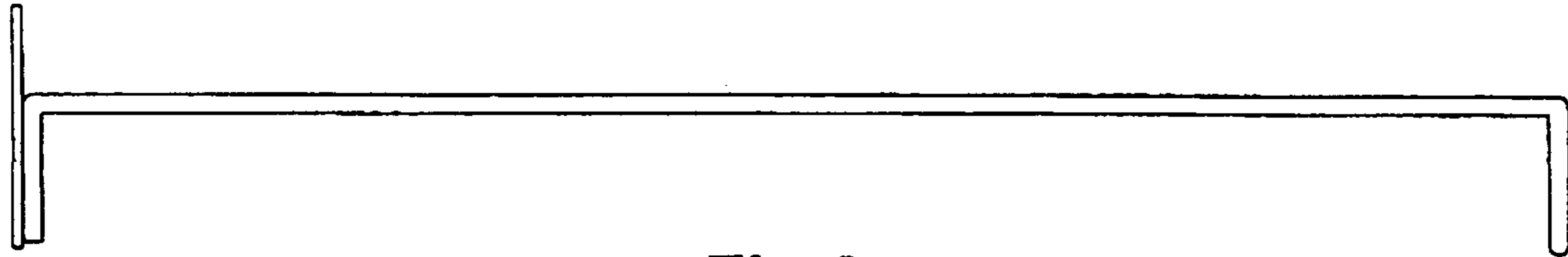

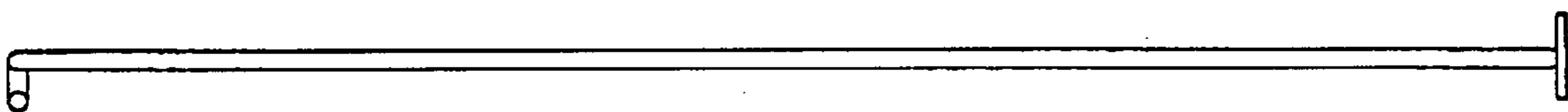

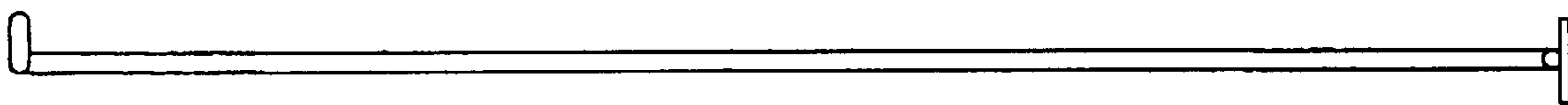
