(57) **CLAIM**

We claim, the ornamental design for a cover for cellular phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and front perspective view of a cover for cellular phone, showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a left side elevational view thereof, the right side is a mirror image of the left side;  
 FIG. 5 is a top elevational view thereof;  
 FIG. 6 is a bottom elevational view thereof; and,  
 FIG. 7 is a front perspective view thereof.  
 The broken line showing of an exemplary cell phone in FIG. 7 is included for illustrative purposes only and forms no part of the claimed design.

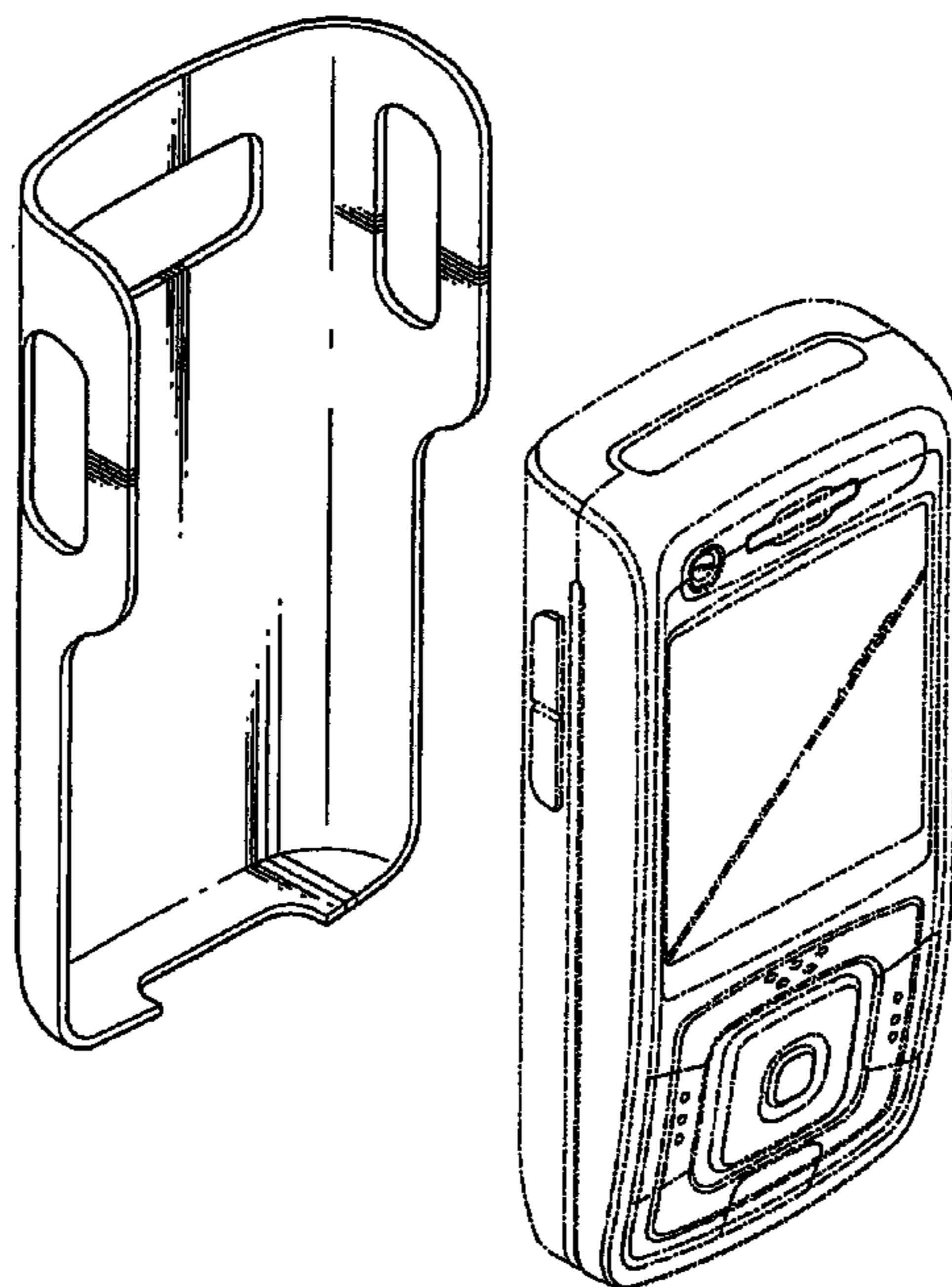

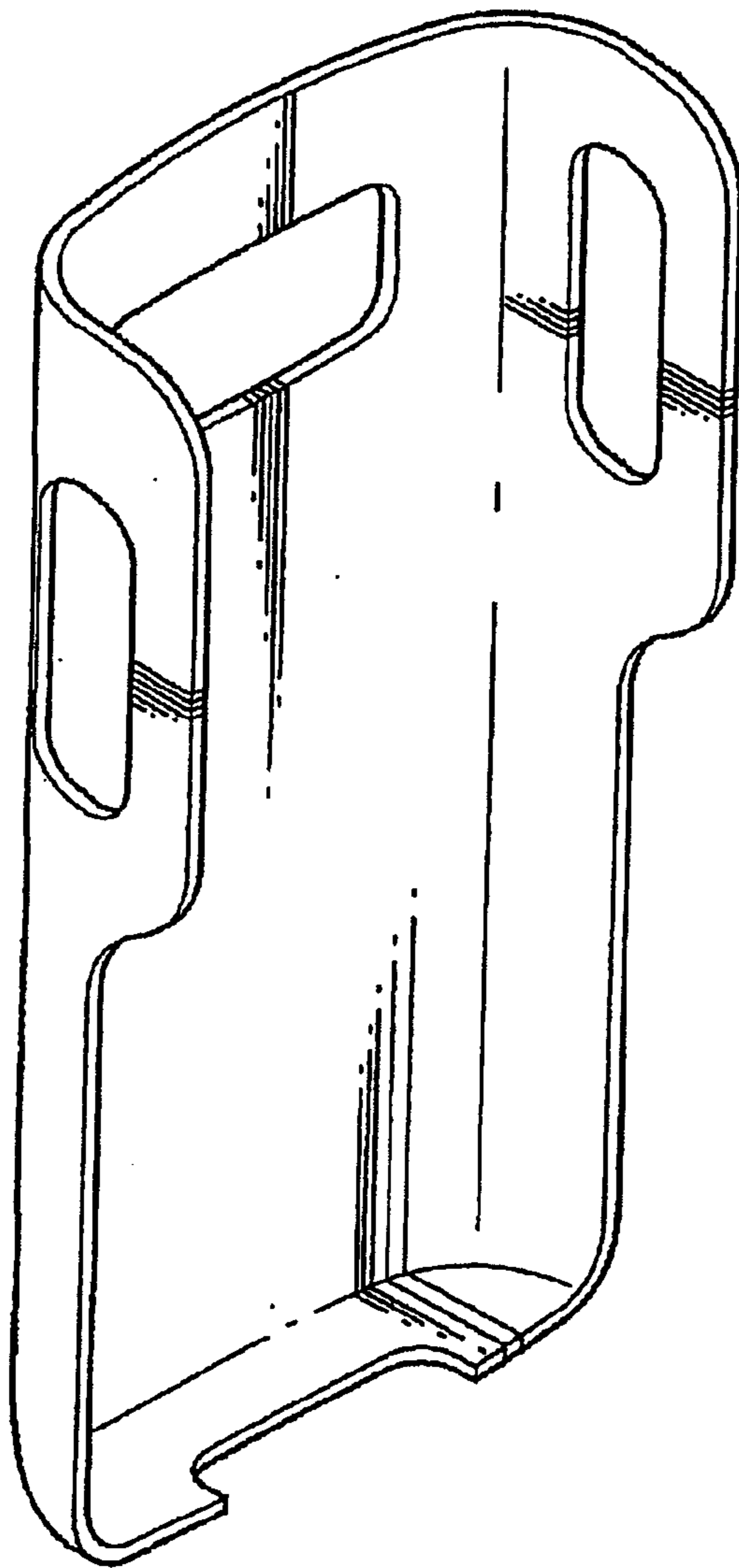

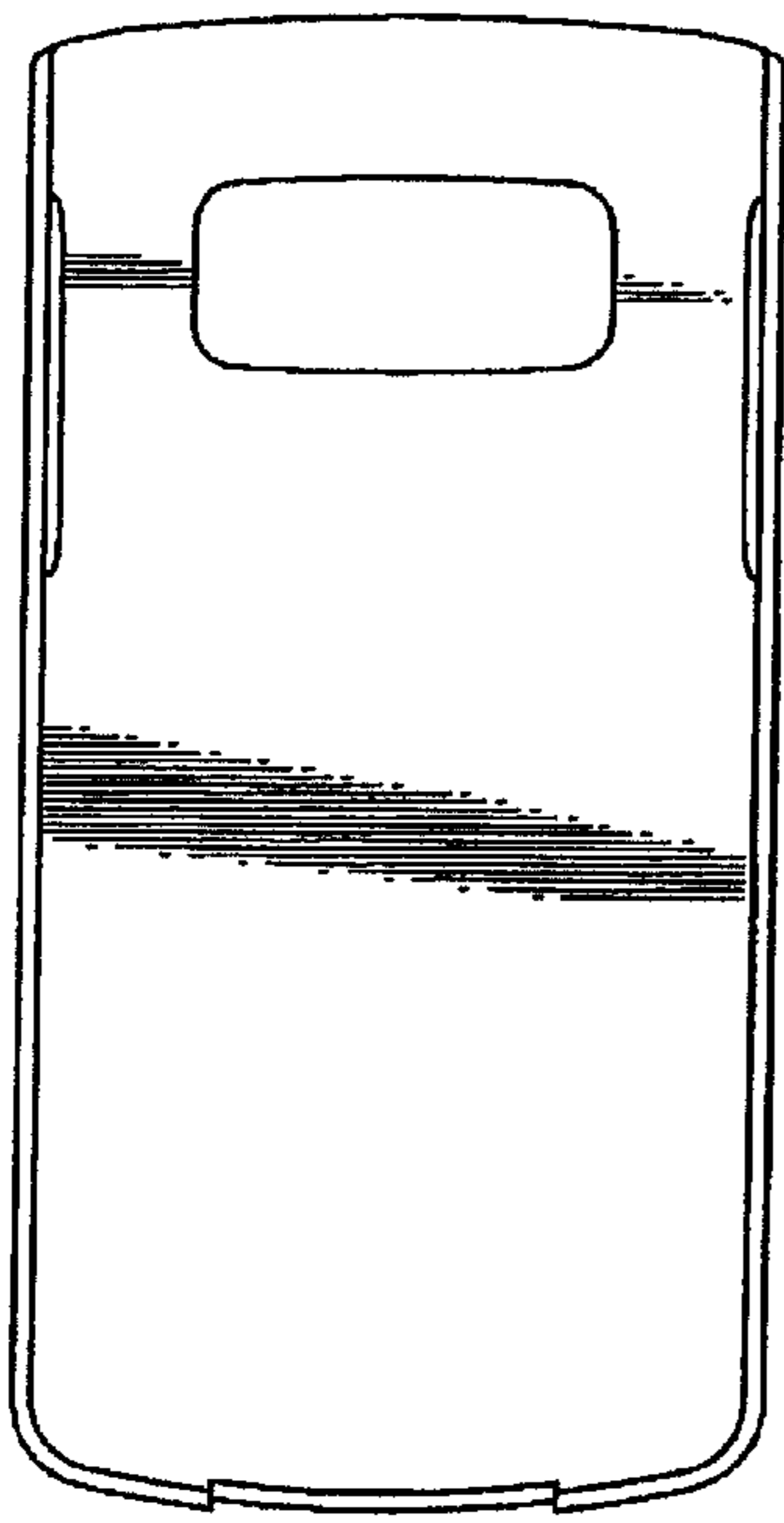

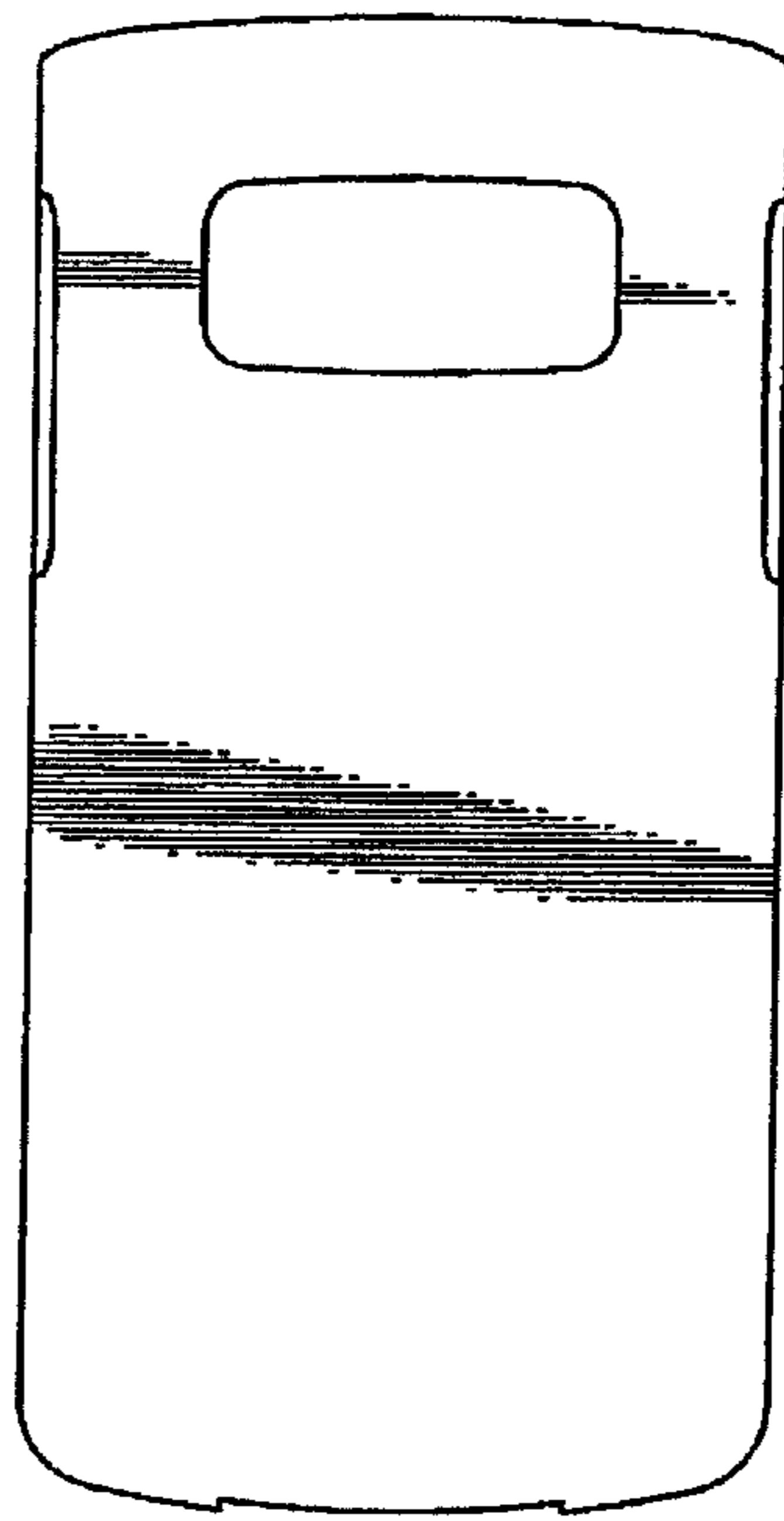

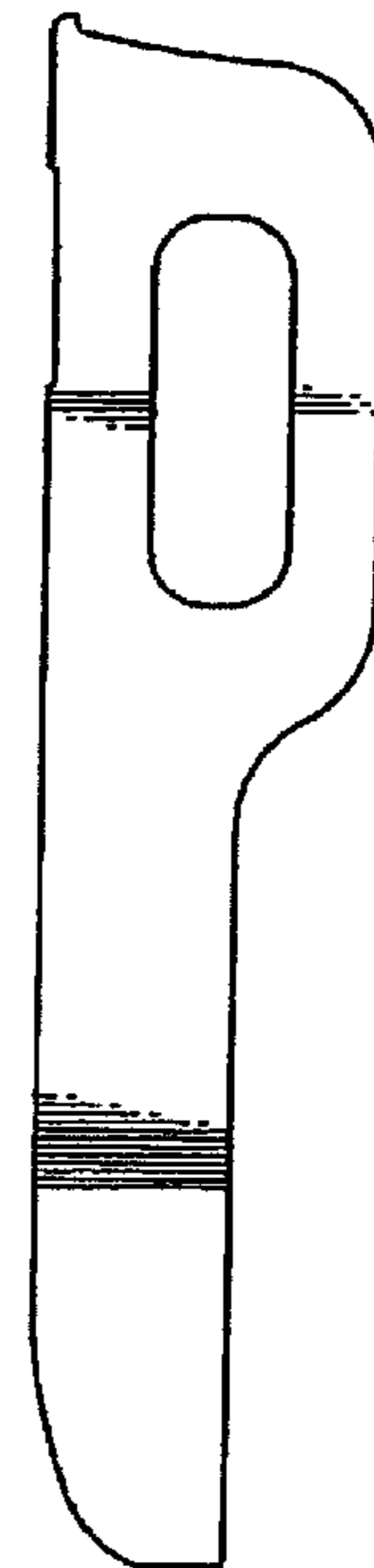

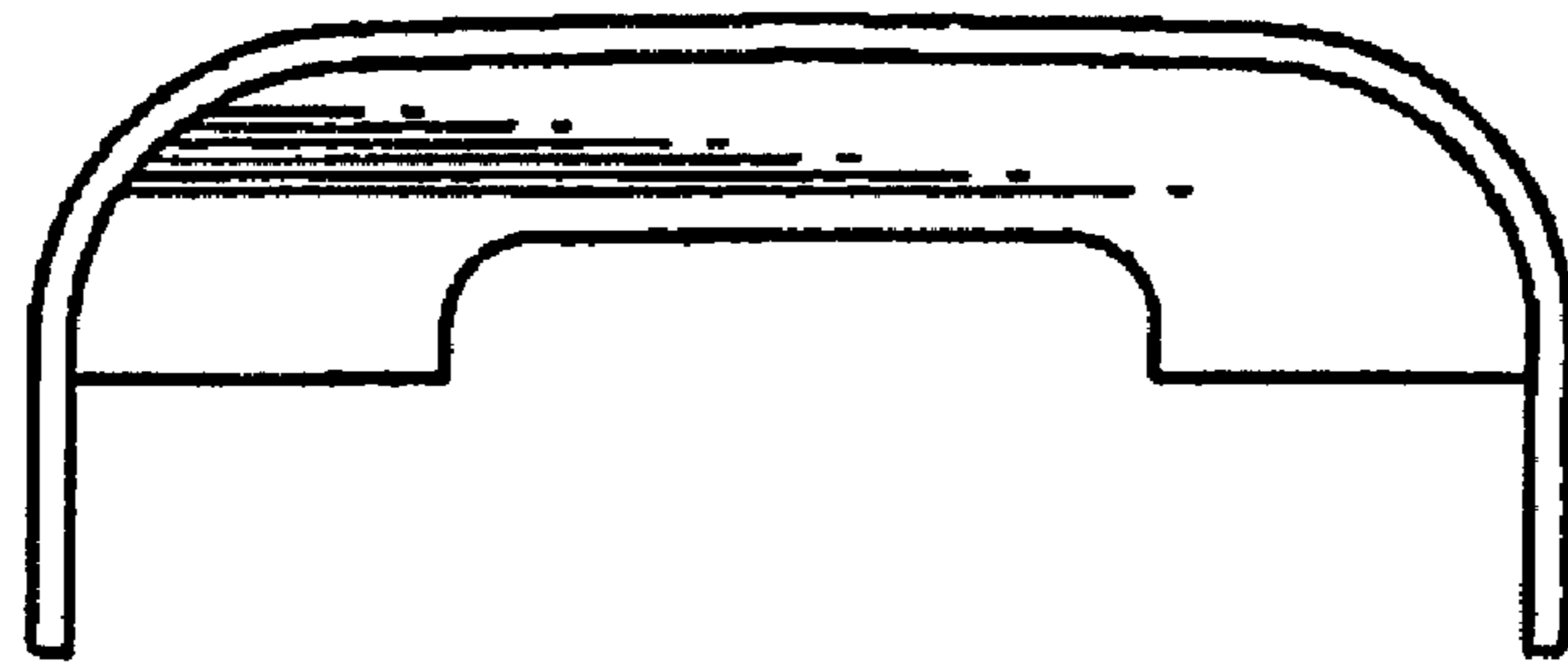

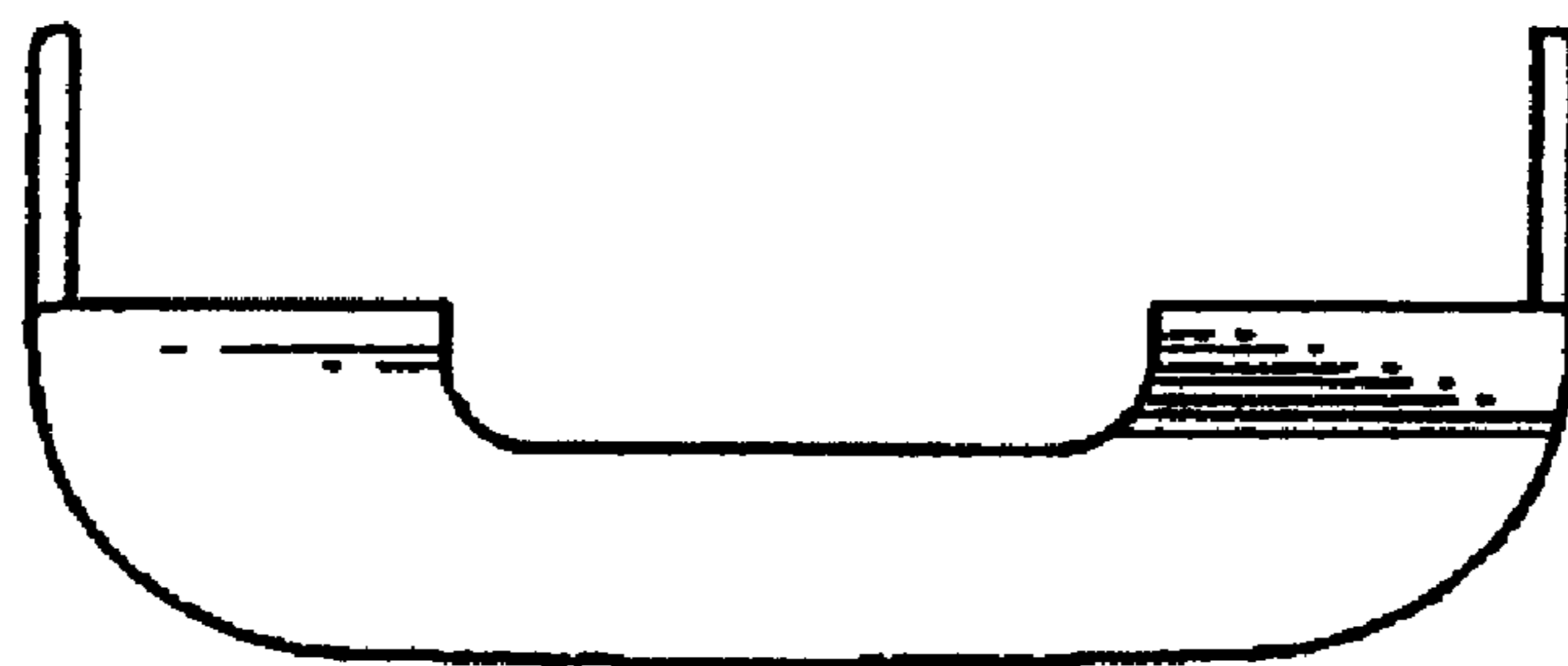
