(57) **CLAIM**

We claim the ornamental design for a tambourine, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a tambourine showing our new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is right-side elevational view thereof;

FIG. 6 is a left-side elevational view thereof;

FIG. 7 is a front perspective view thereof; and,

FIG. 8 is a rear perspective view thereof.

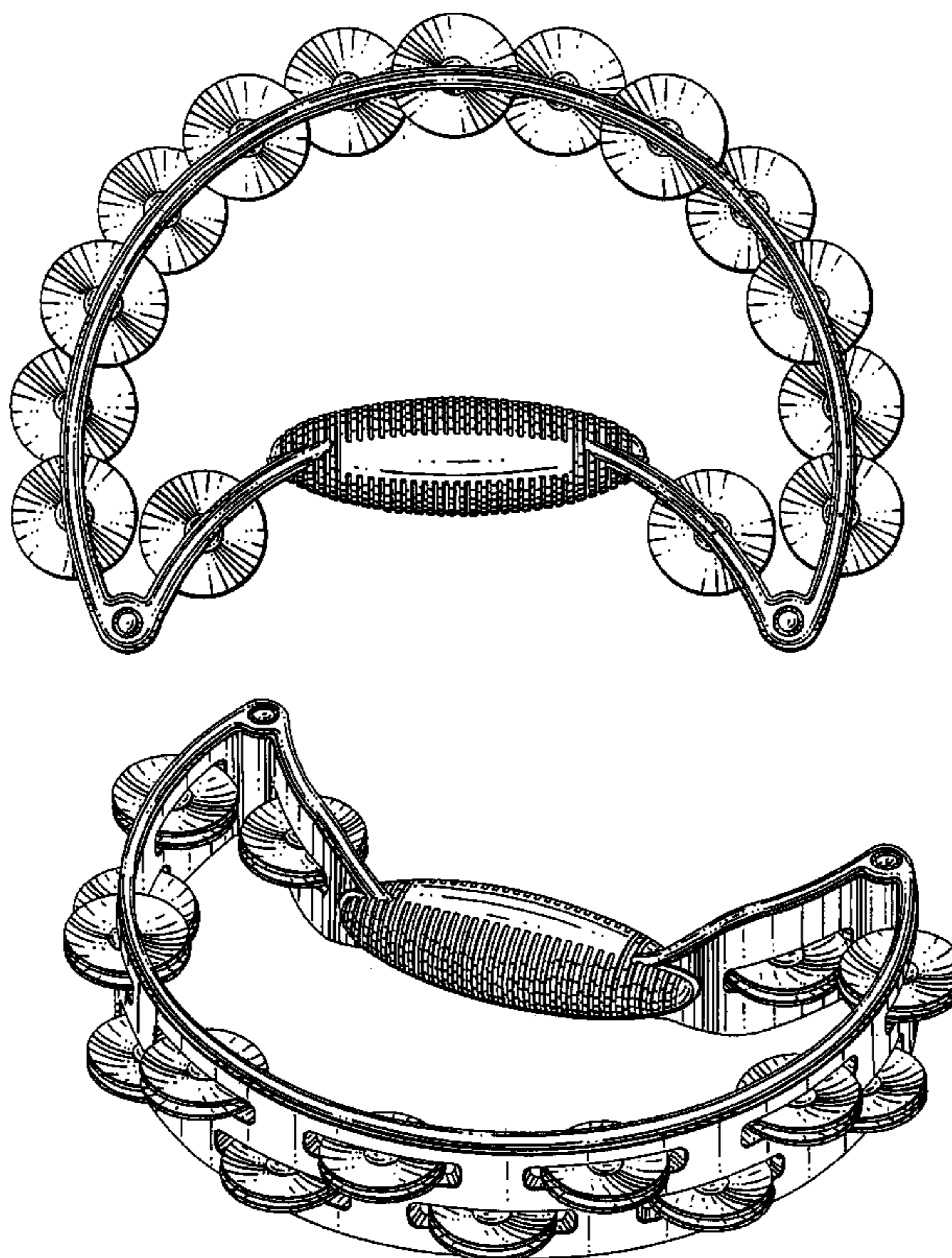

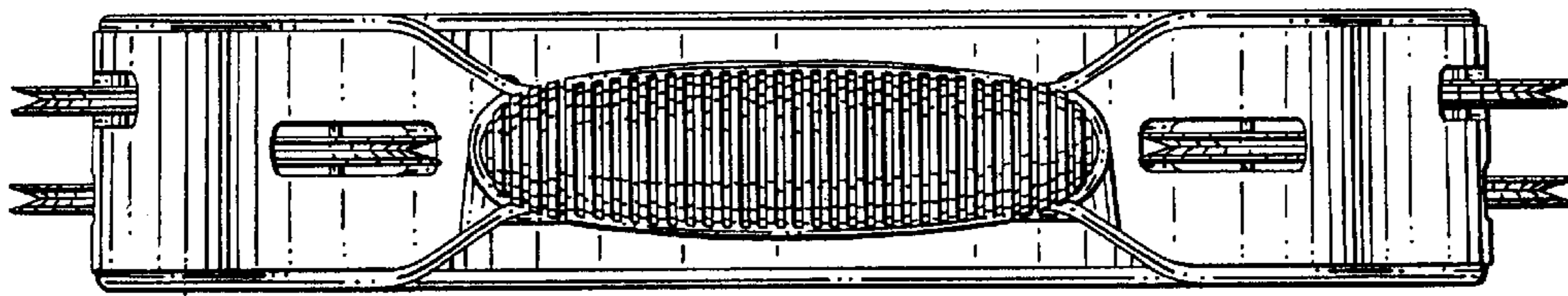
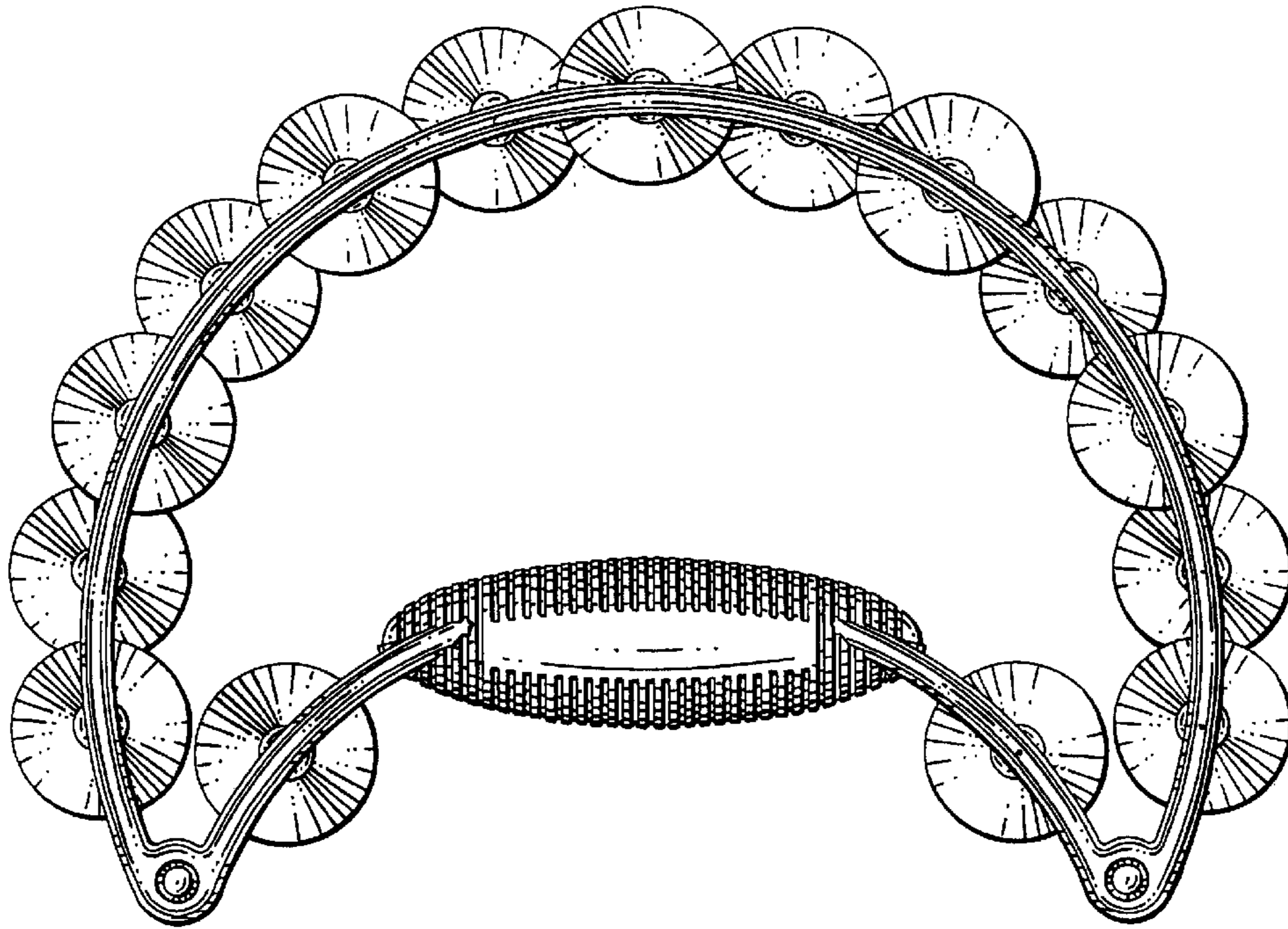

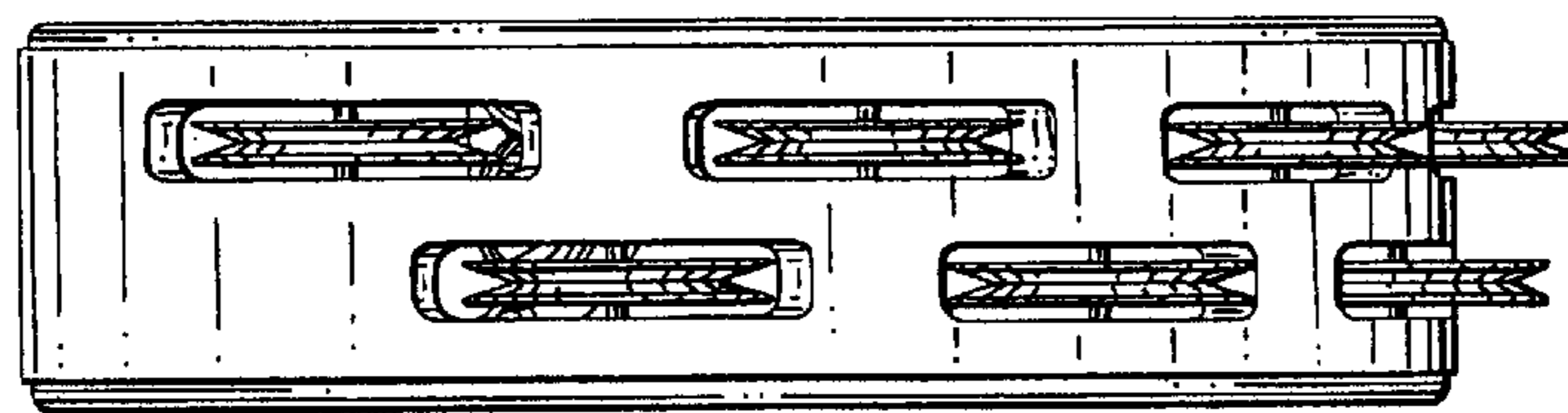

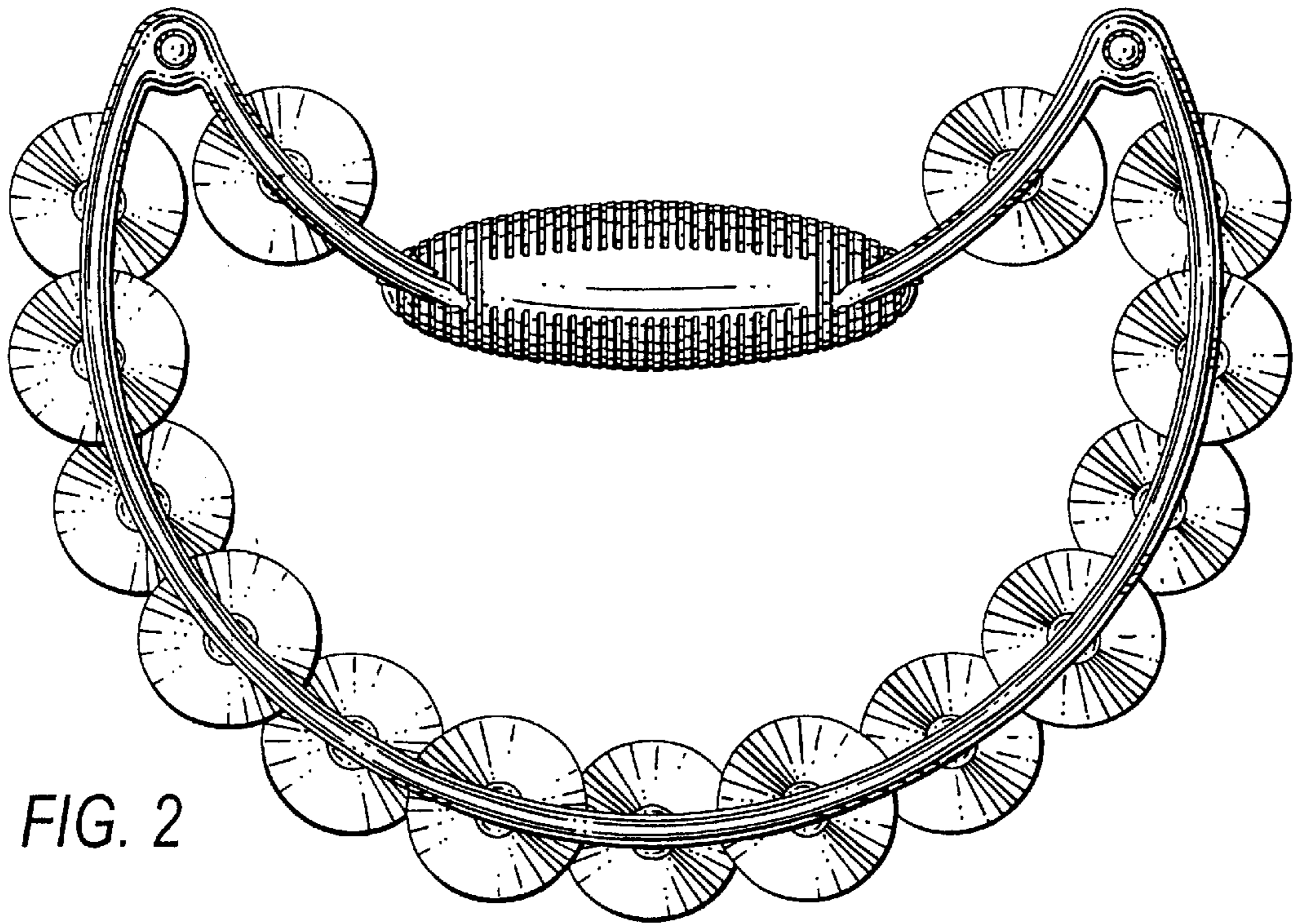

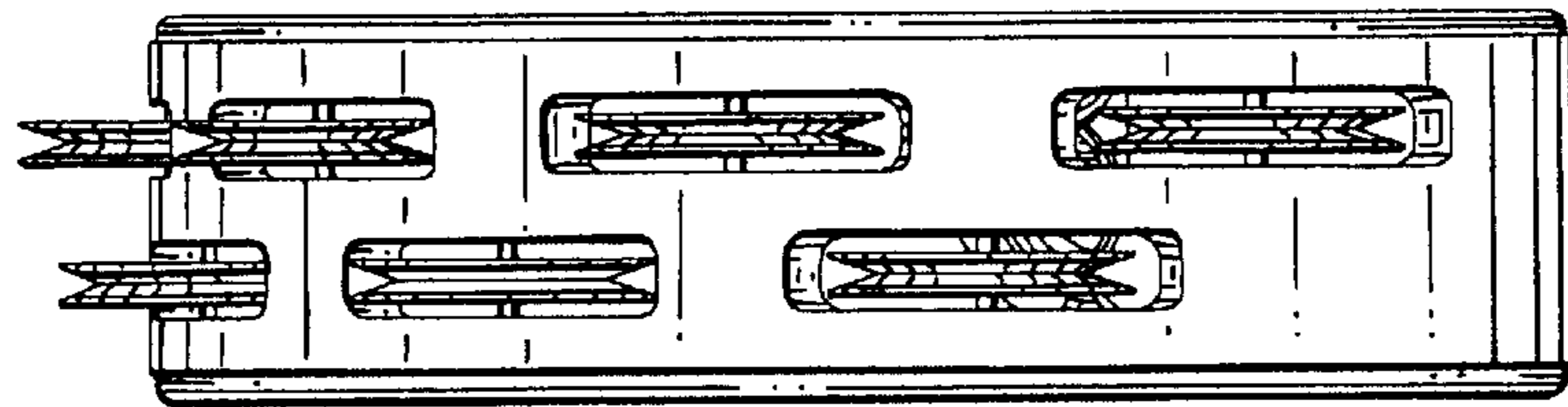
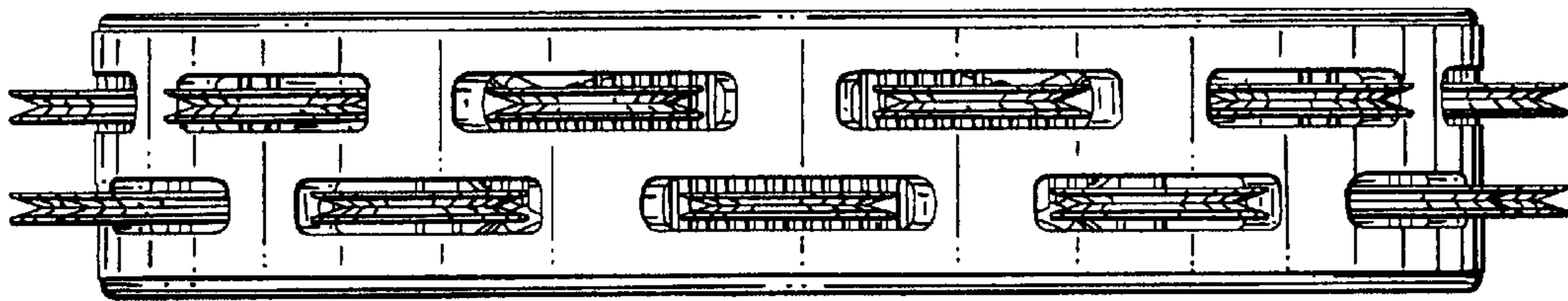

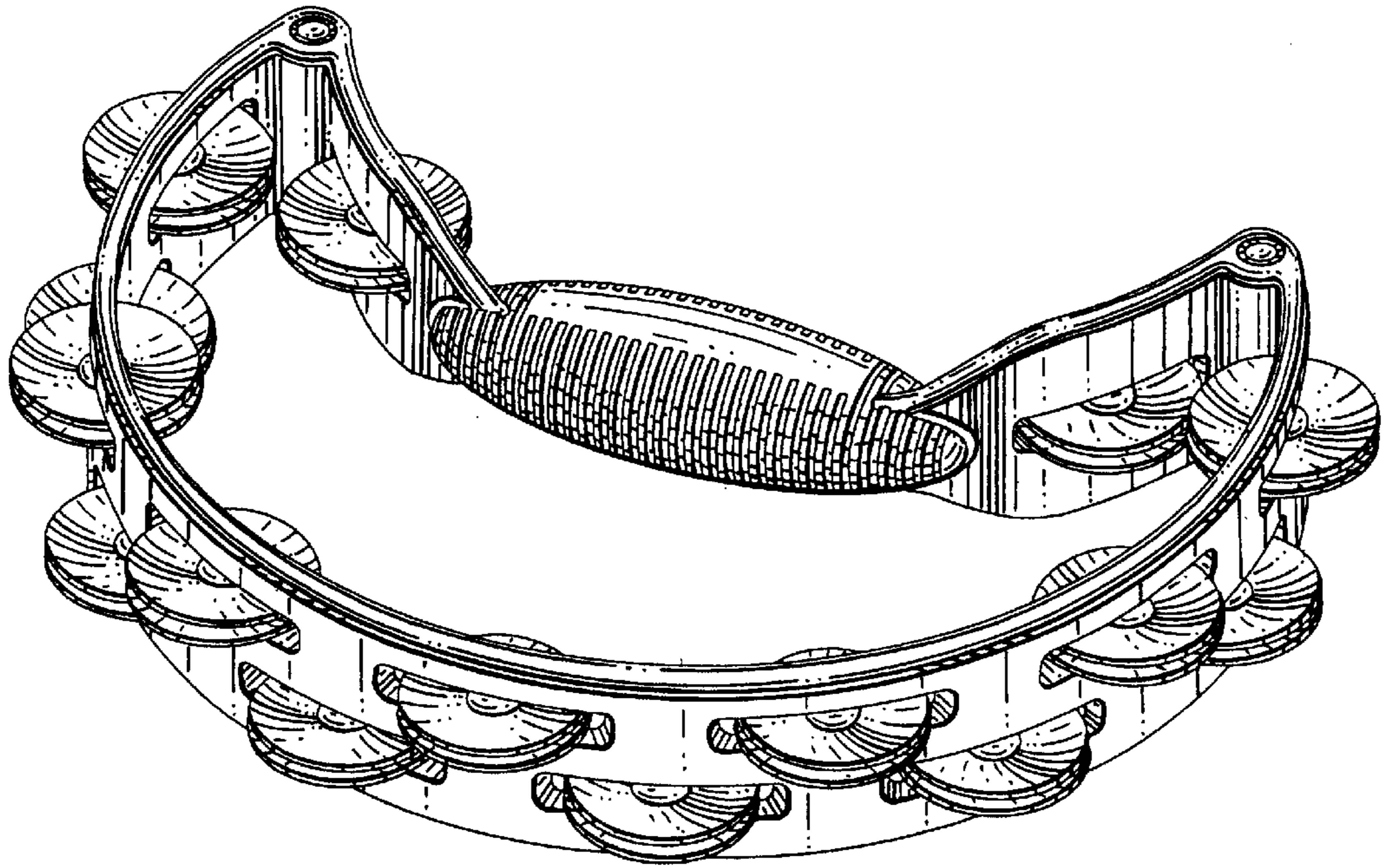

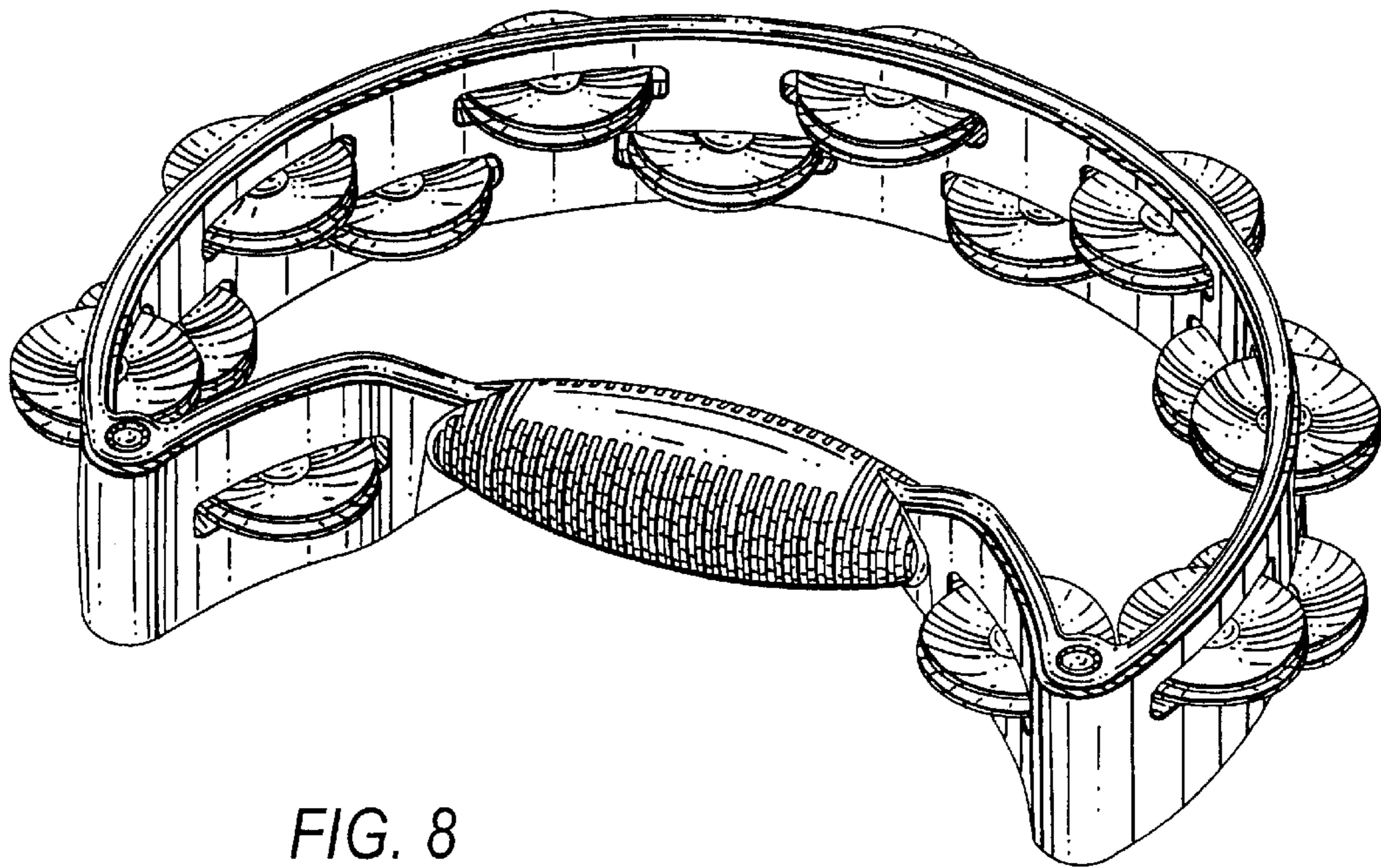
