FIG. 6 is a cross-sectional view thereof taken along lines 6–6 of FIG. 4; and,

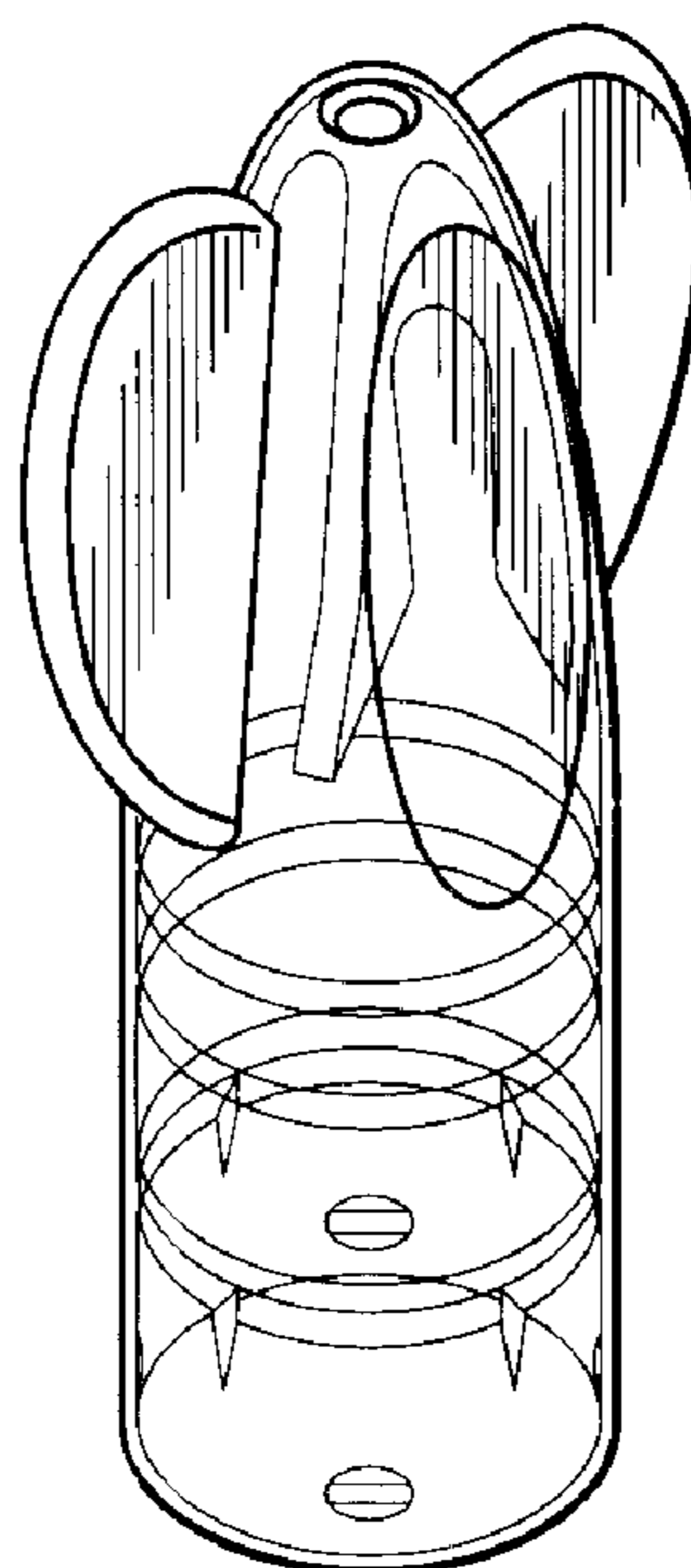
FIG. 7 is a cross-sectional view thereof taken along lines 7–7 of FIG. 4.

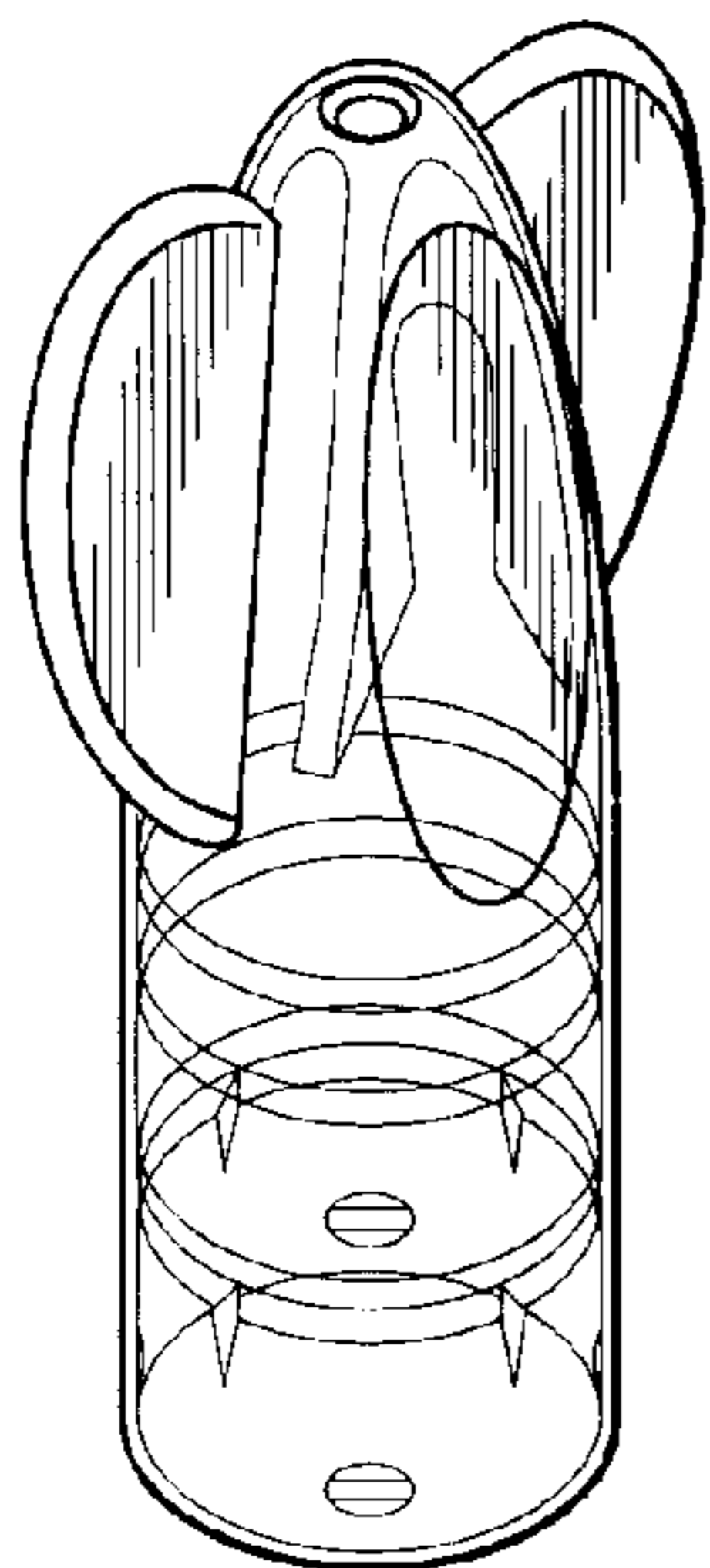

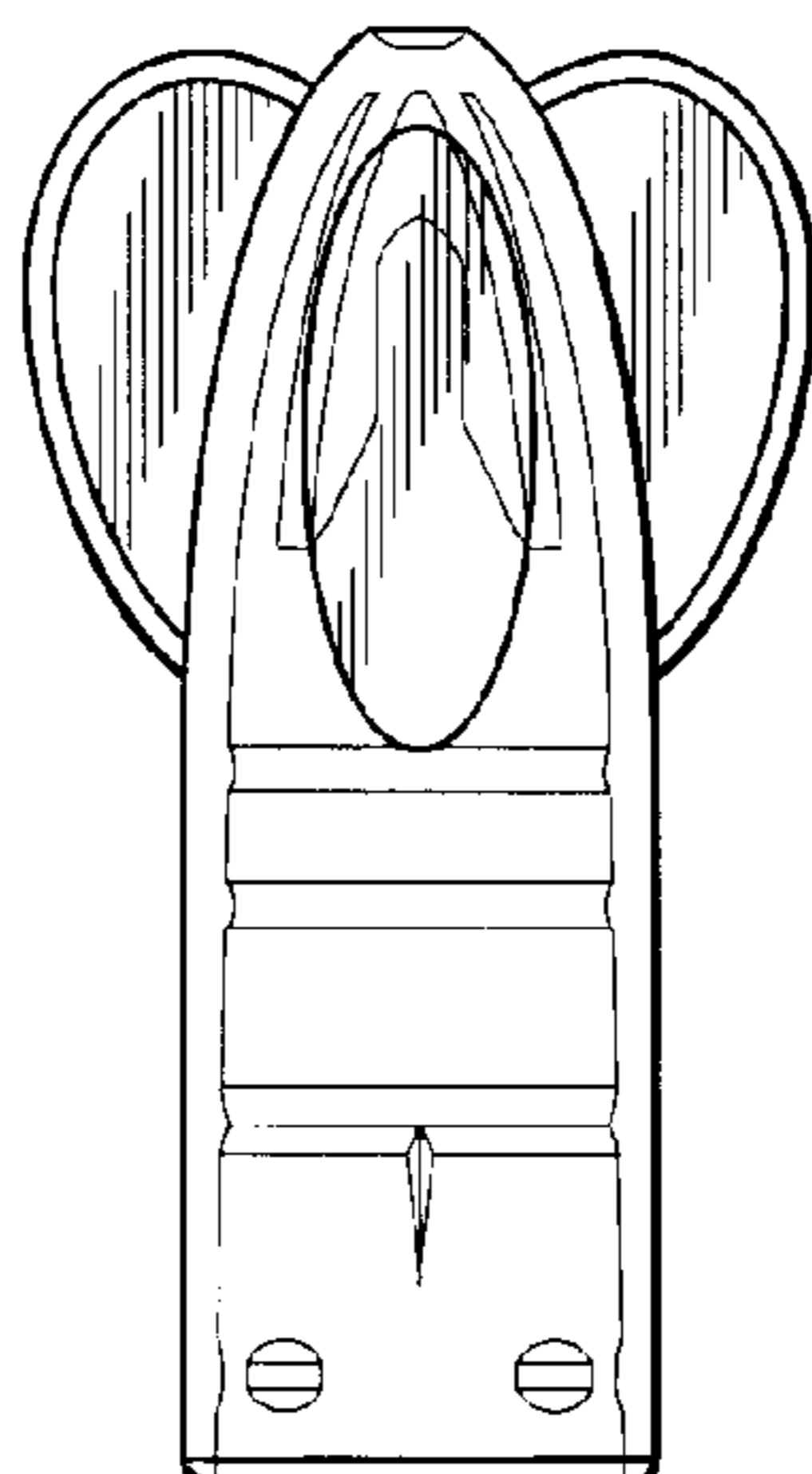

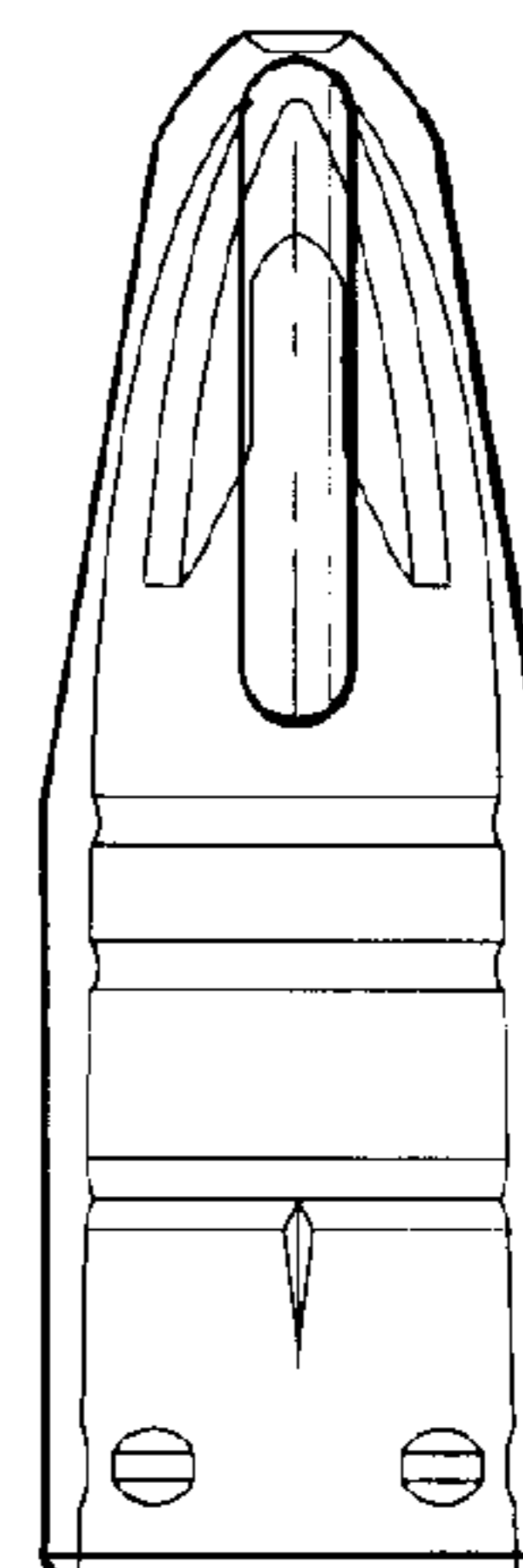

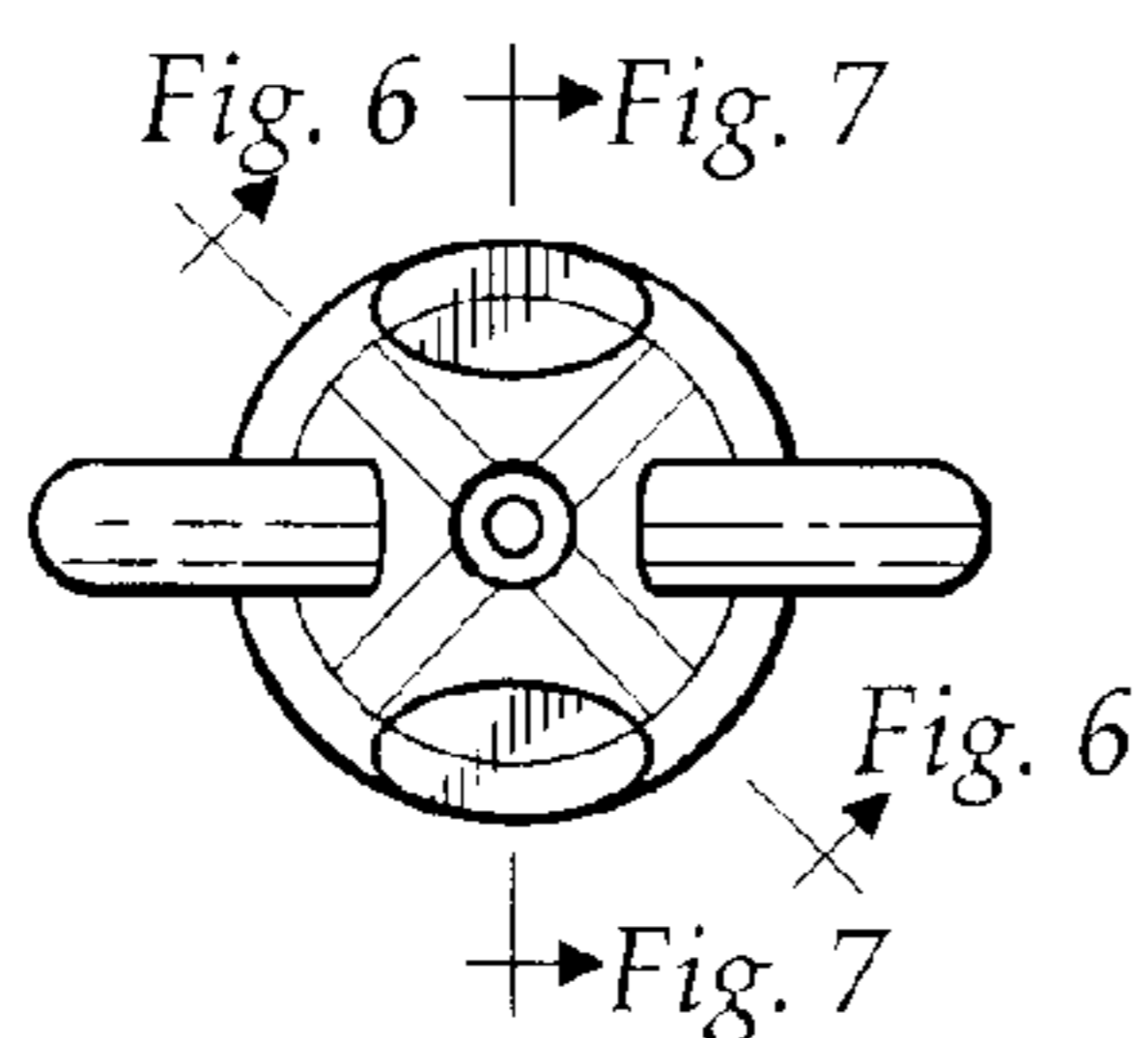

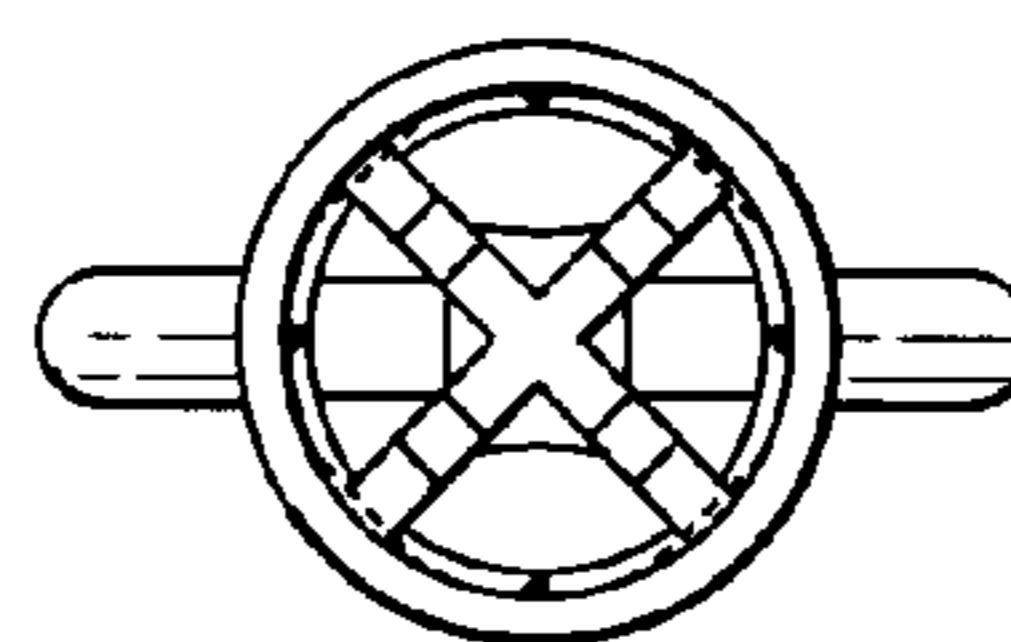

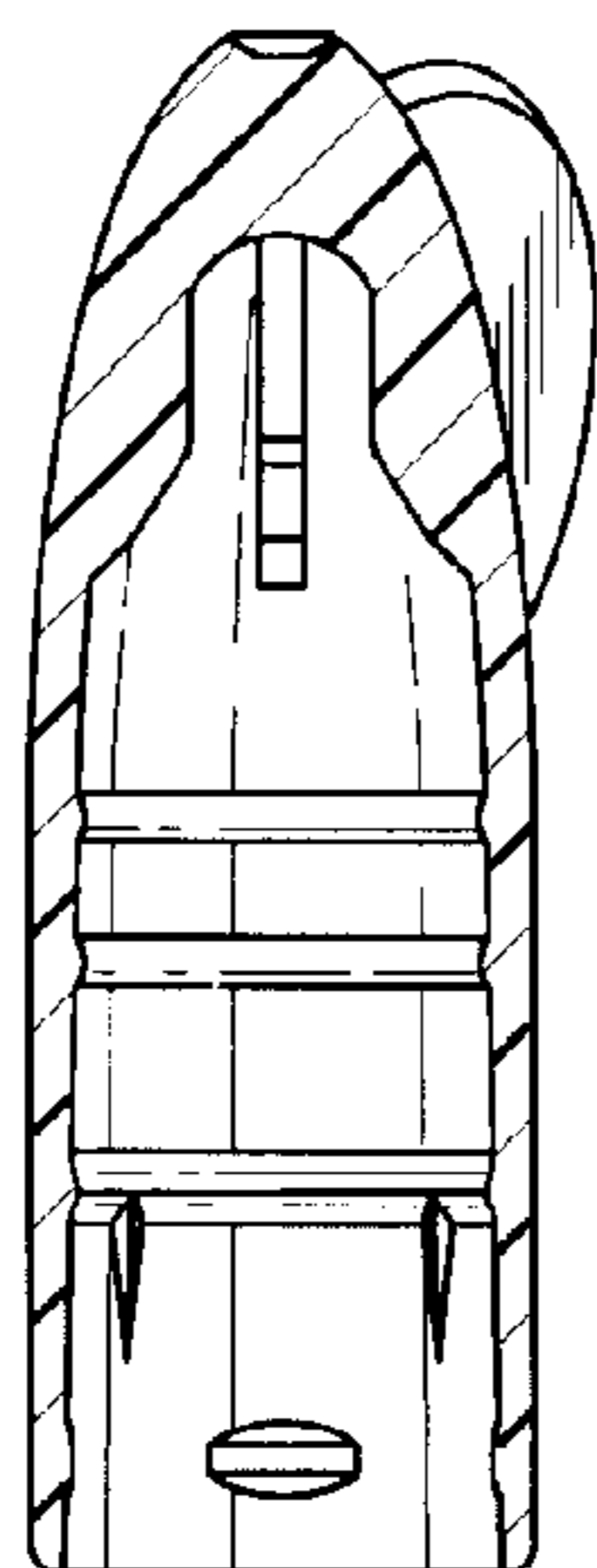

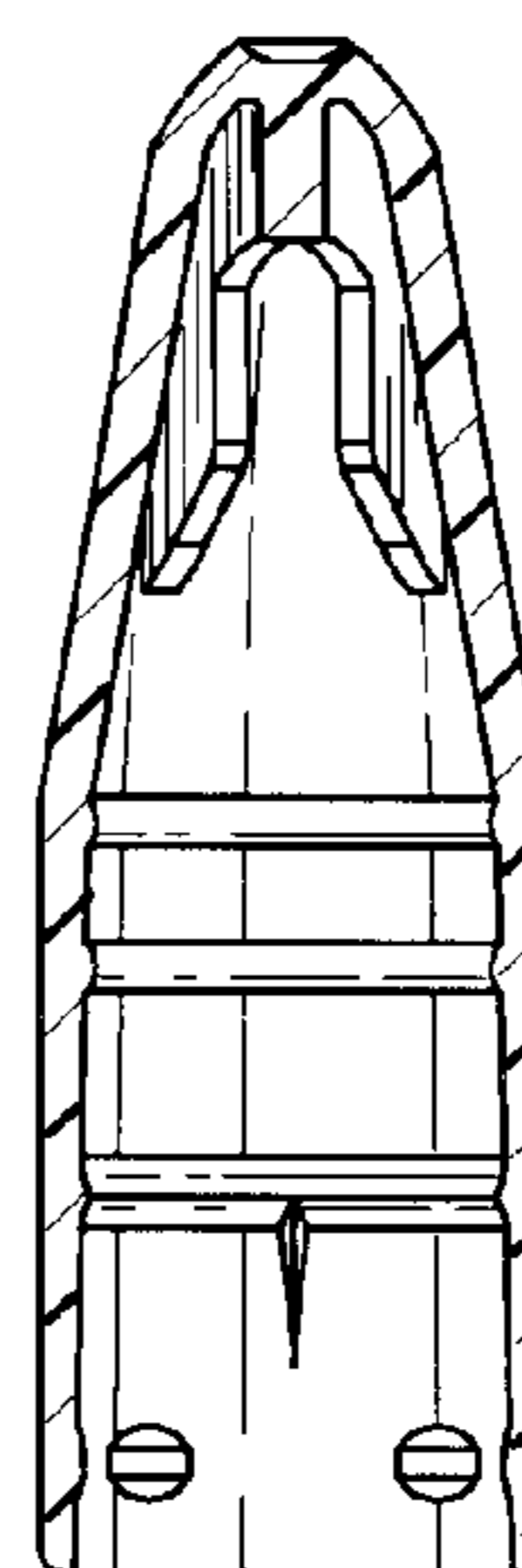
