(57) **CLAIM**

The ornamental design for: adult sexual novelty device, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side elevational view, the opposite side being a mirror image thereof, for an adult sexual novelty device showing my new design;

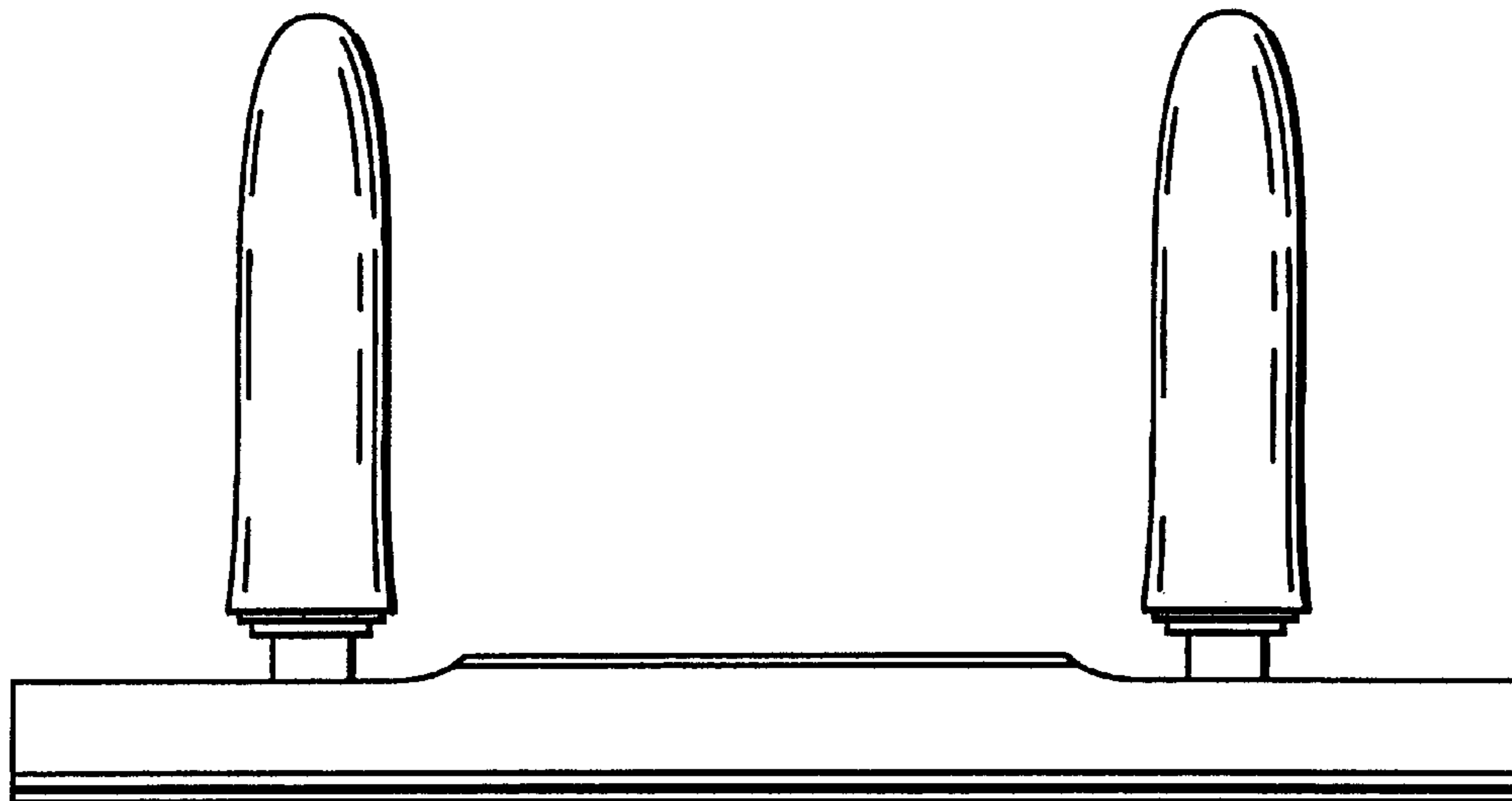

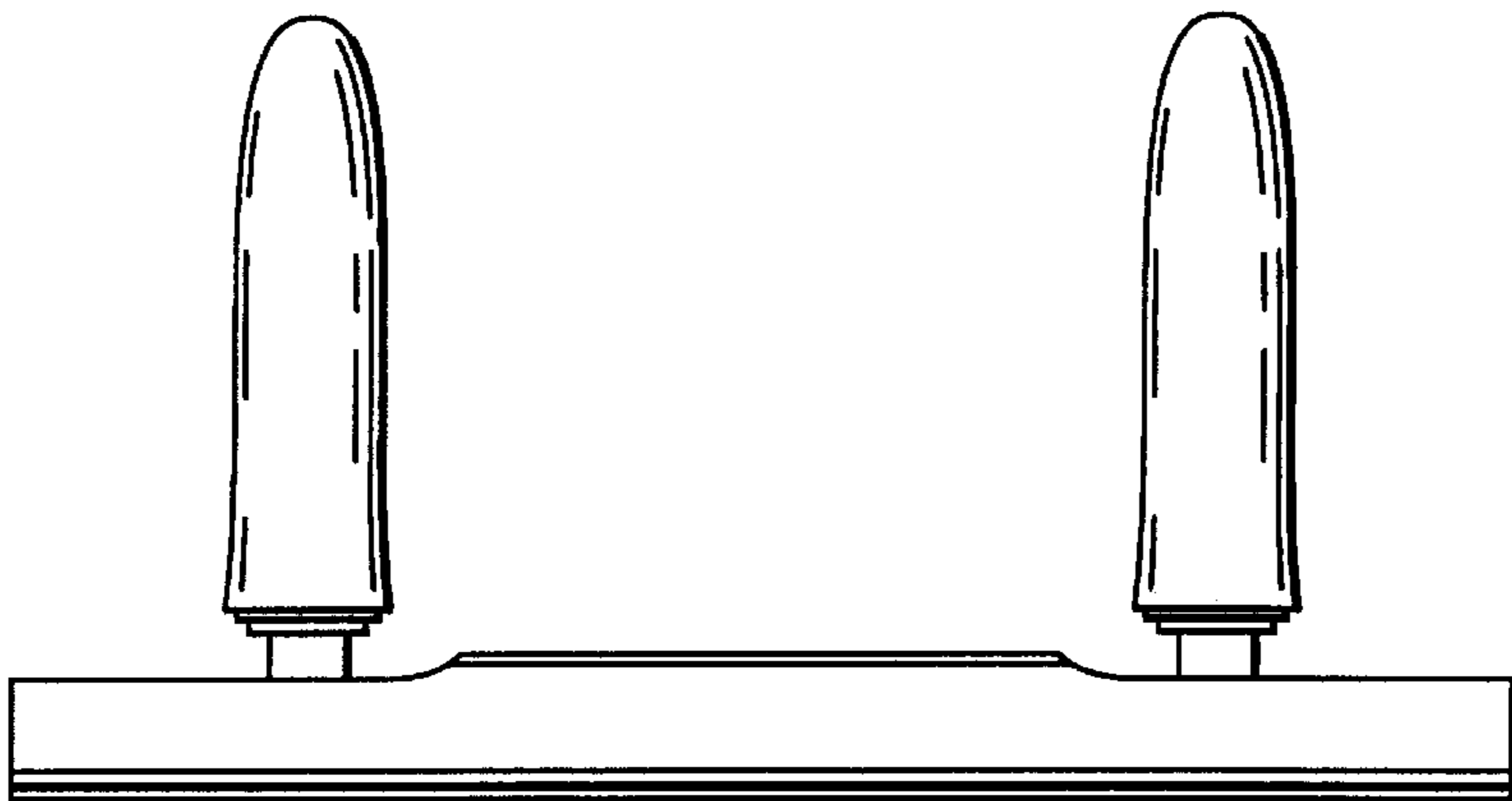
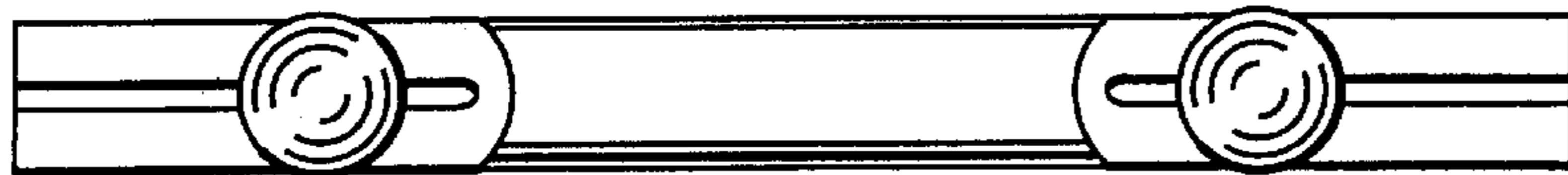

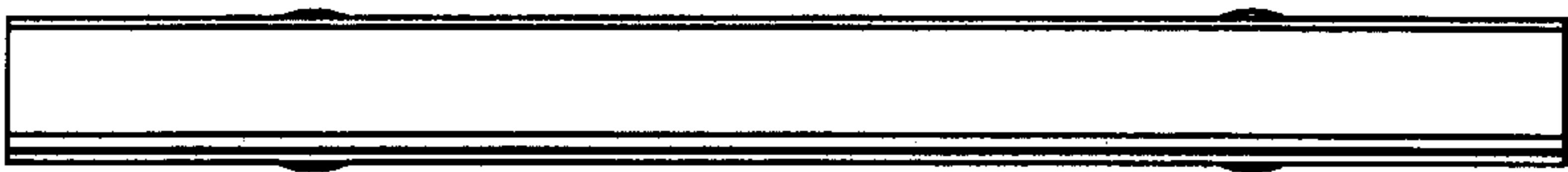
