(57) **CLAIM**

I claim the ornamental design for a fence, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a fence showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is bottom plan view thereof;

FIG. 5 is a perspective view of second embodiment of my new fence design;

FIG. 6 is a front elevational view of the second embodiment;

FIG. 7 is a perspective view of a single member of the fence;

FIG. 8 is top plan view of the members of FIG. 7;

FIG. 9 is a bottom plan view of the member of FIG. 7;

FIG. 10 is a front elevational view of the member of FIG. 7; and

FIG. 11 is a right side view of the member of FIG. 7, with the right side being a mirror image thereof.

FIG. 12 is perspective view of a third embodiment of the fence design;

FIG. 13 is a front elevational view of the embodiment of FIG. 12;

FIG. 14 is top plan view of the embodiment of FIG. 12;

FIG. 15 is a bottom plan view of the third embodiment;

FIG. 16 is a perspective view of a fourth embodiment of the fence design;

FIG. 17 is a front elevational view of the embodiment of FIG. 16;

FIG. 18 is a perspective view of a single member of the embodiments of FIG. 12 and FIG. 16;

FIG. 19 is a top plan view of the member shown in FIG. 18;

FIG. 20 is a bottom plan view of the member shown in FIG. 18;

FIG. 21 is a front elevational view of the member shown in FIG. 18; and,

FIG. 22 is a left side view of the member in FIG. 18, with the right side being a mirror image thereof.

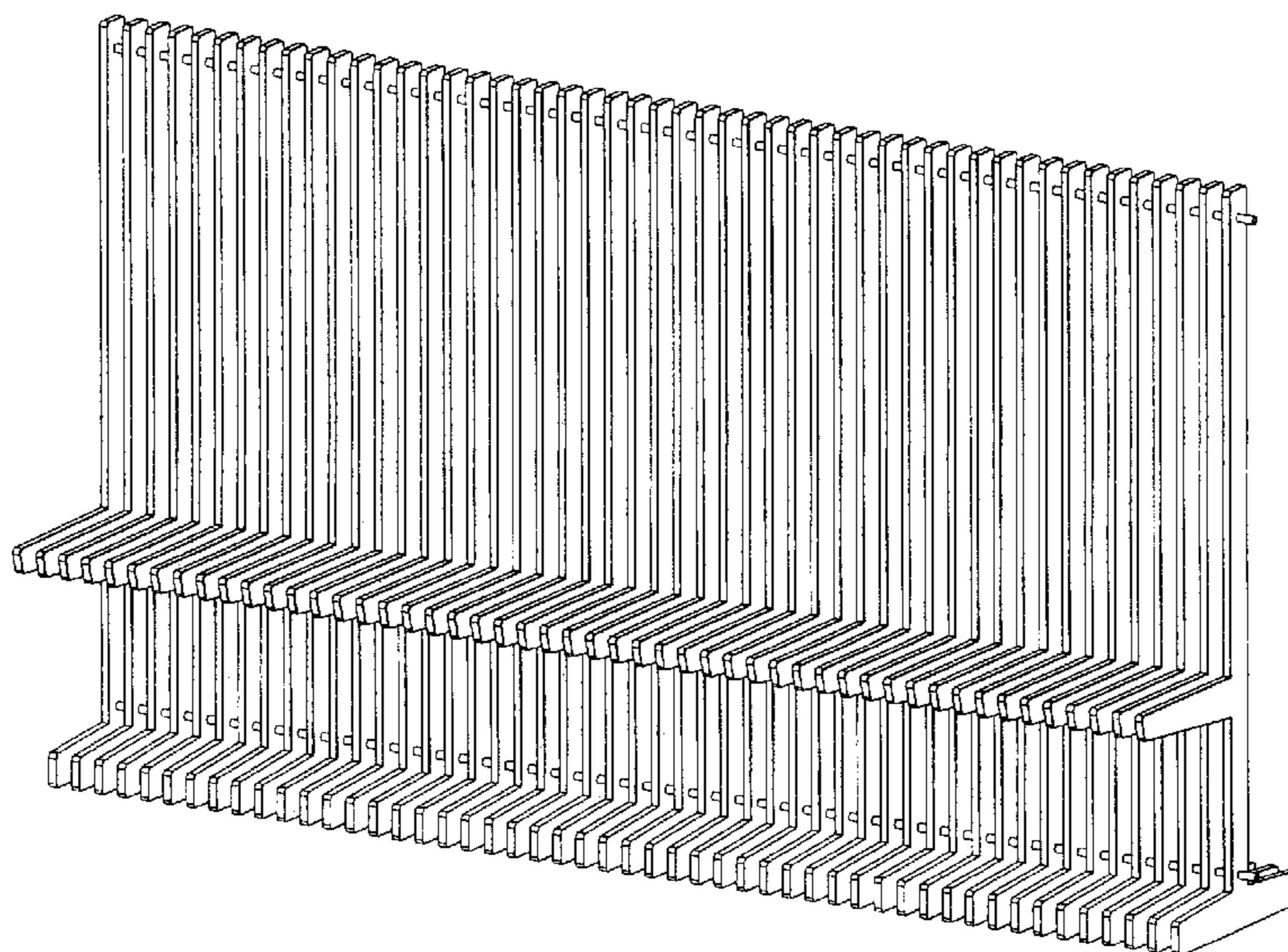

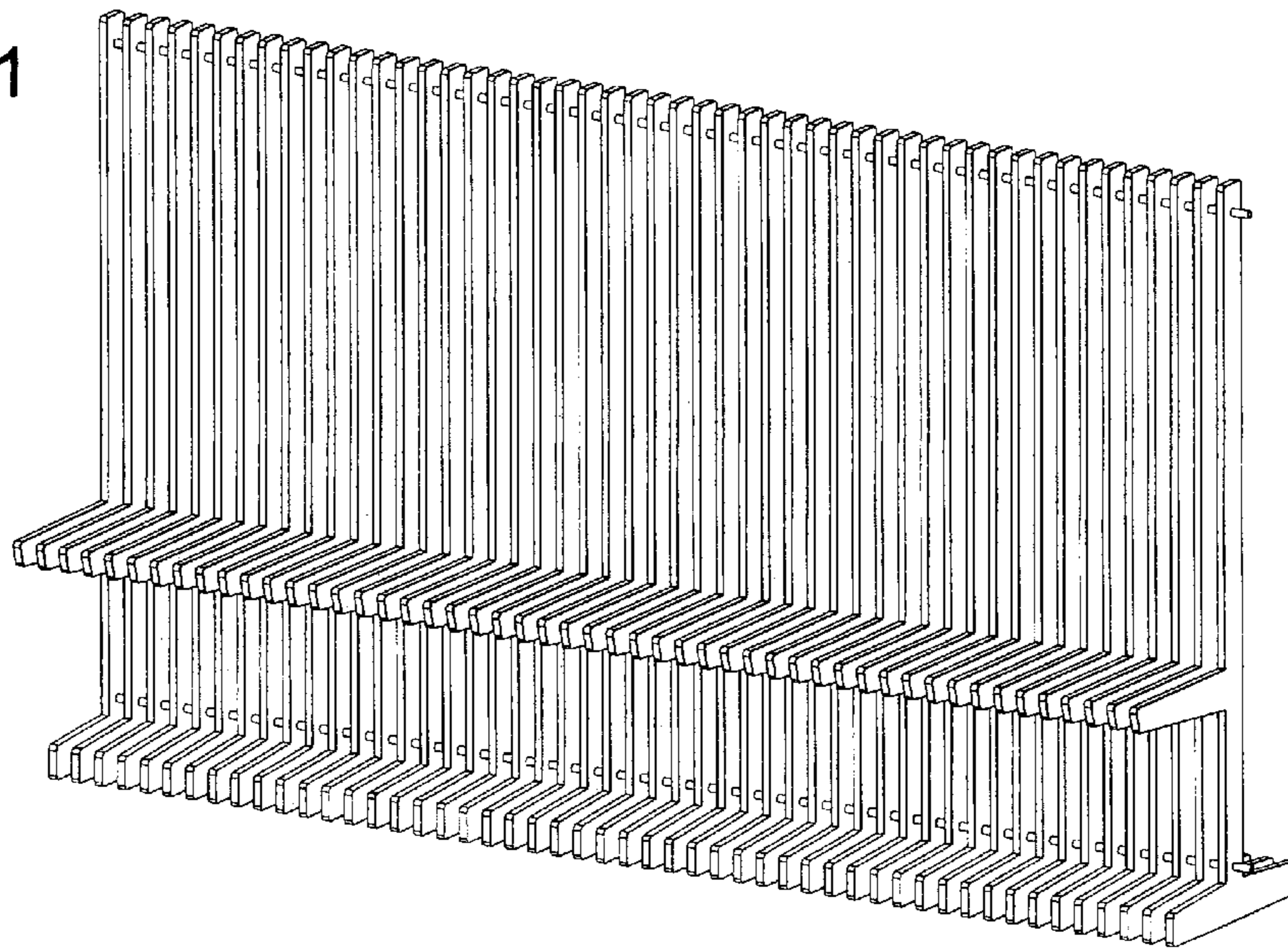

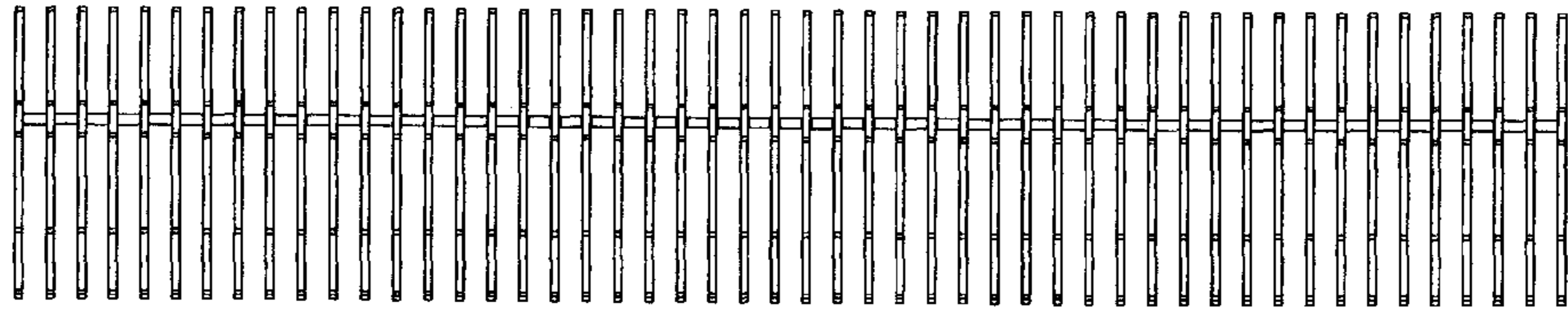

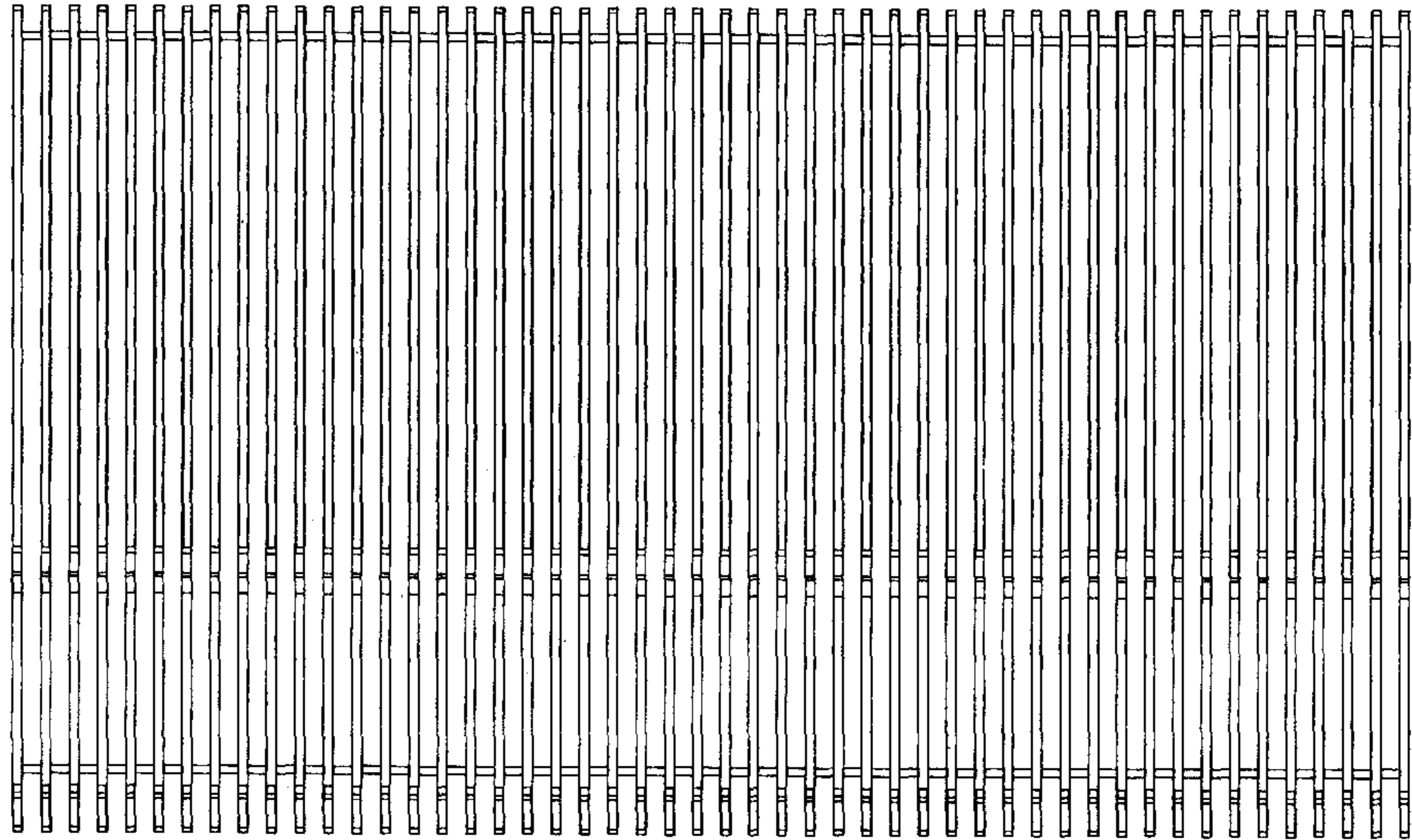

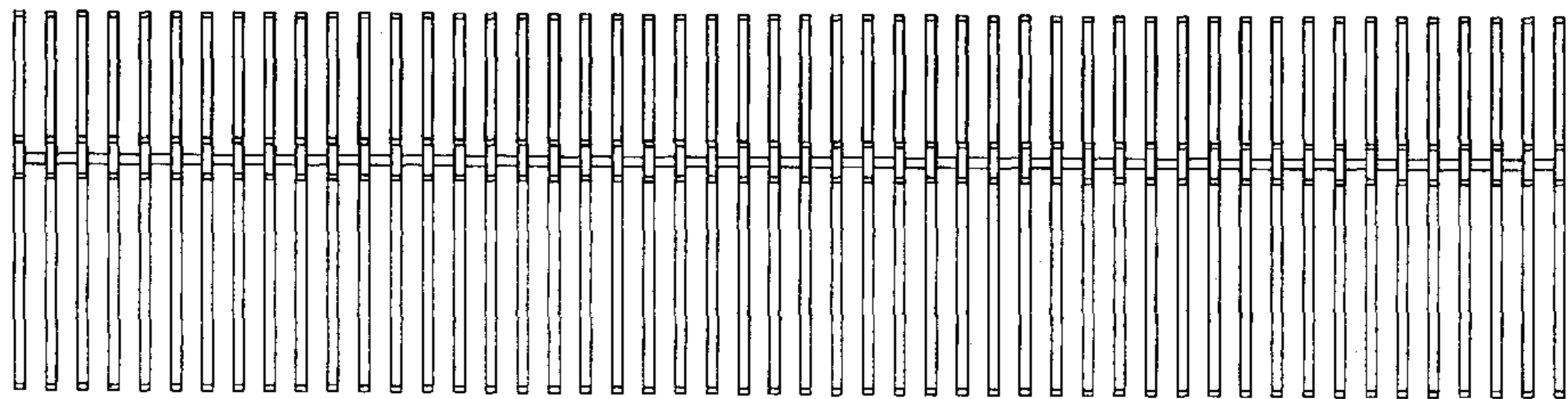

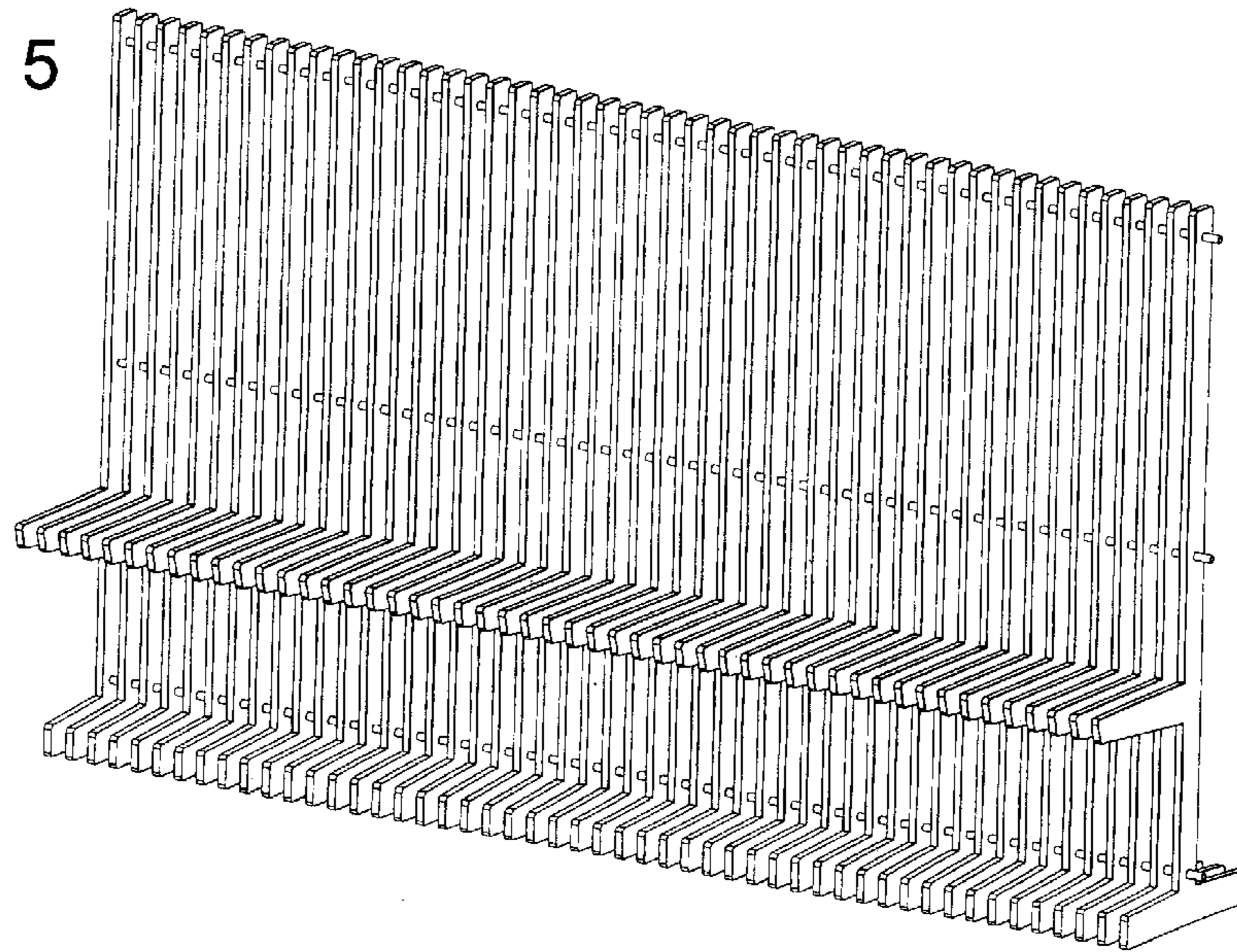

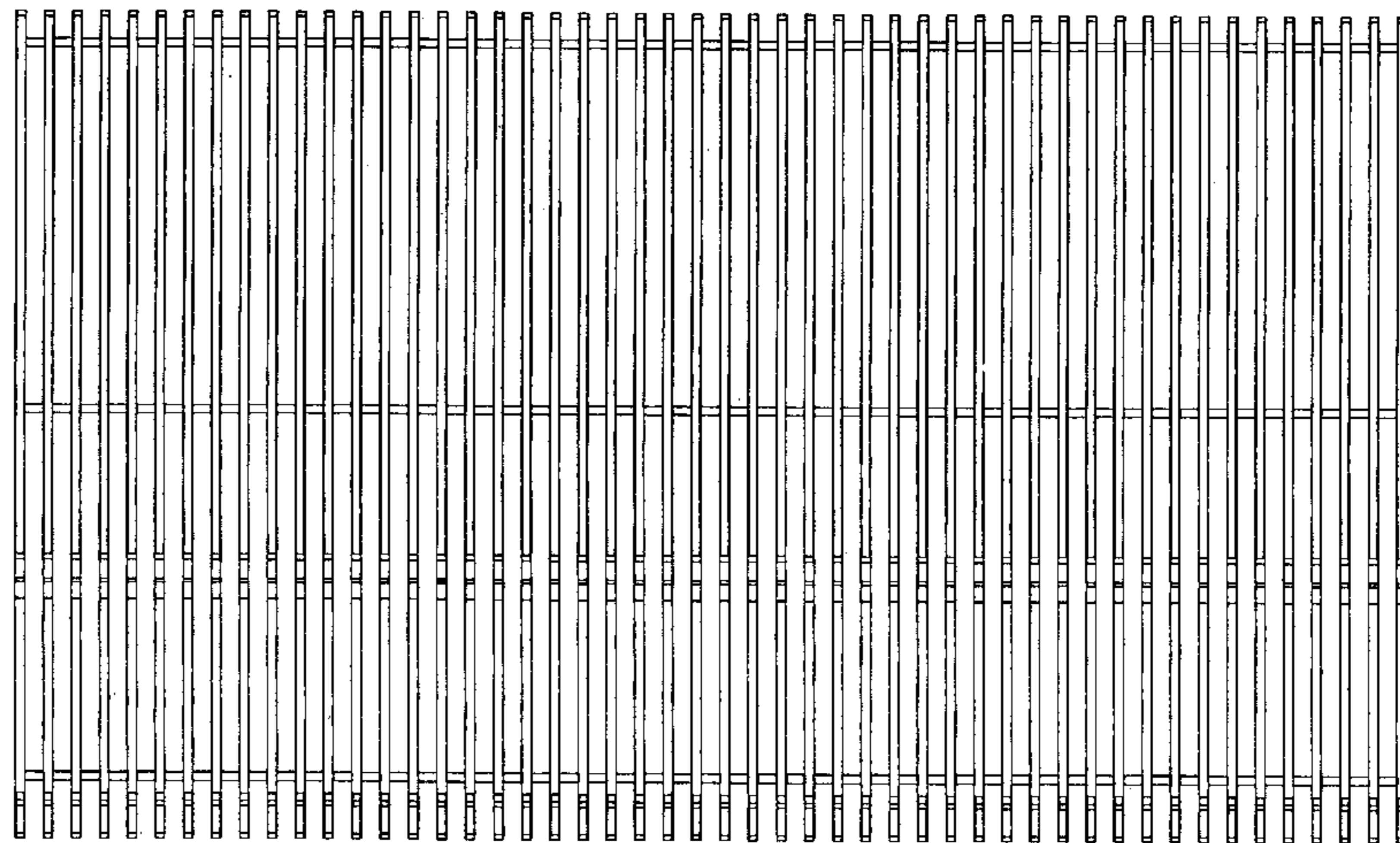

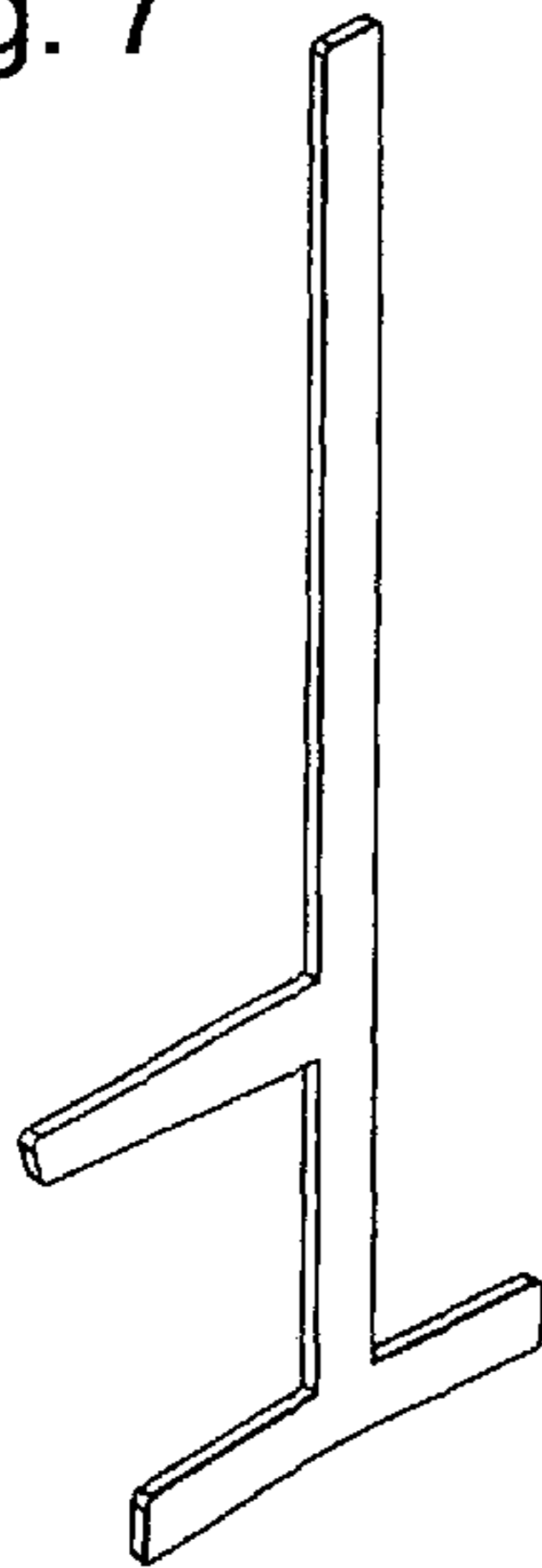

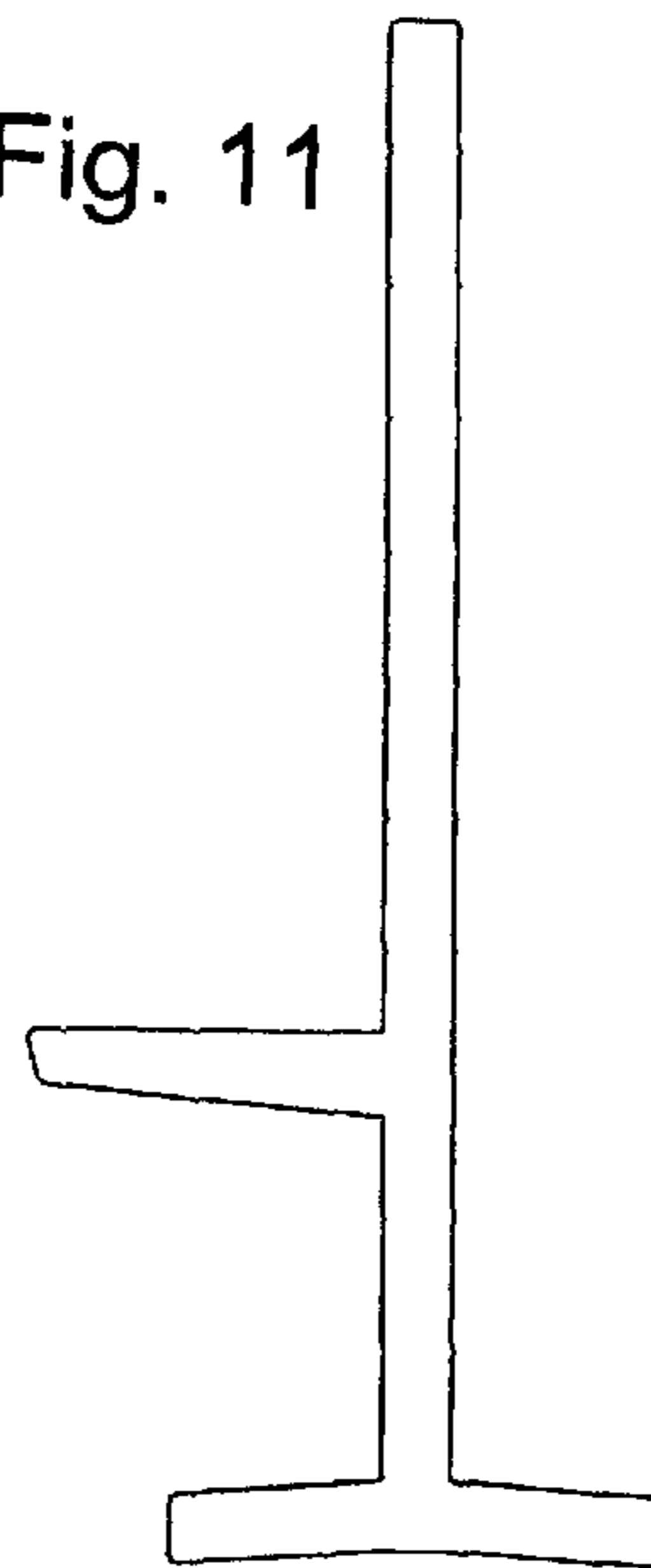

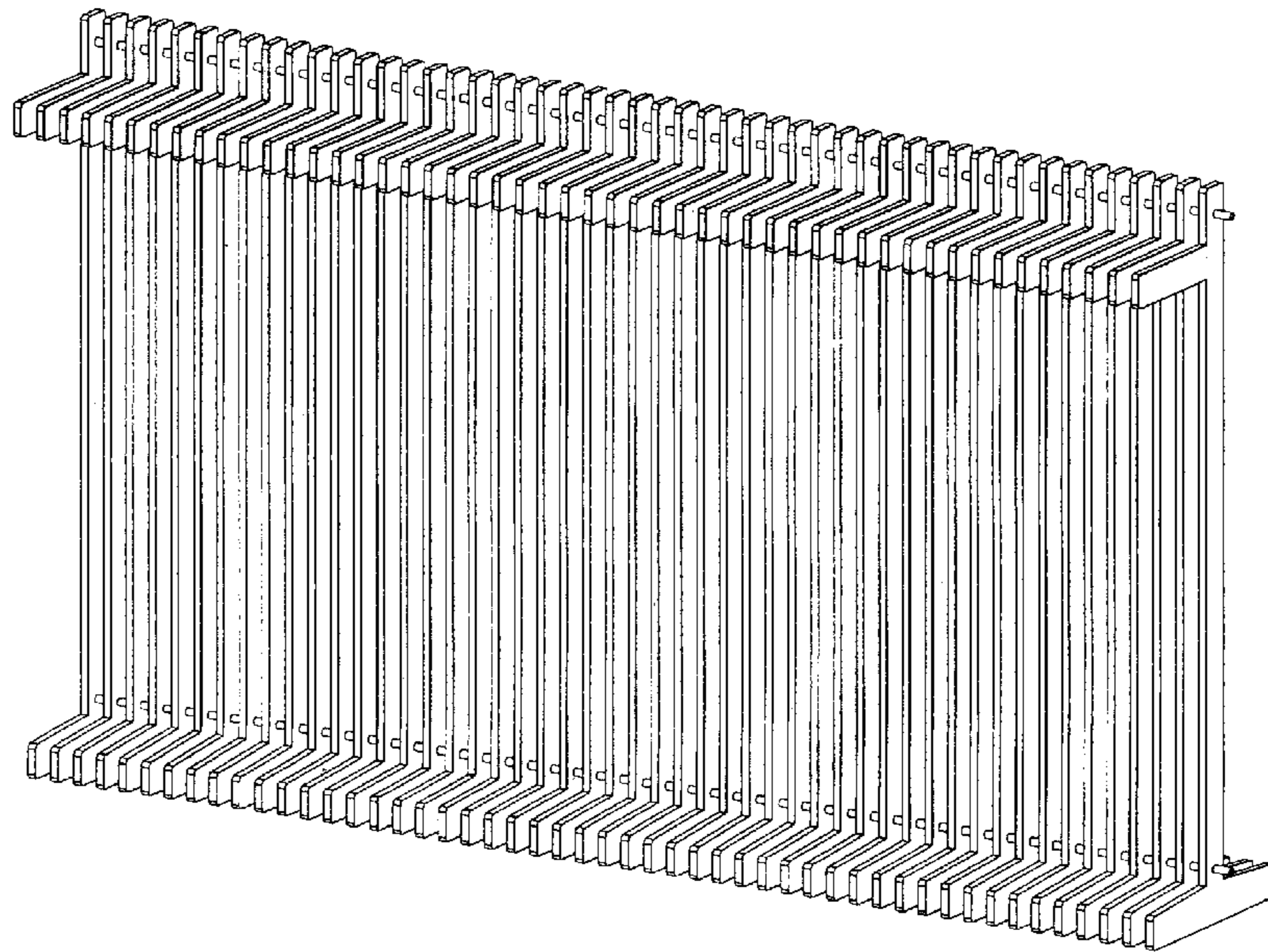

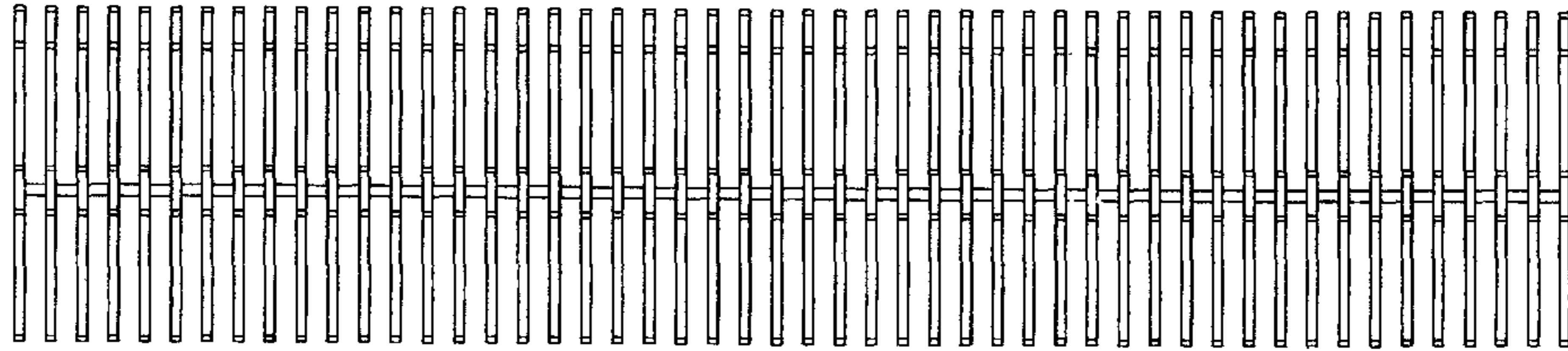

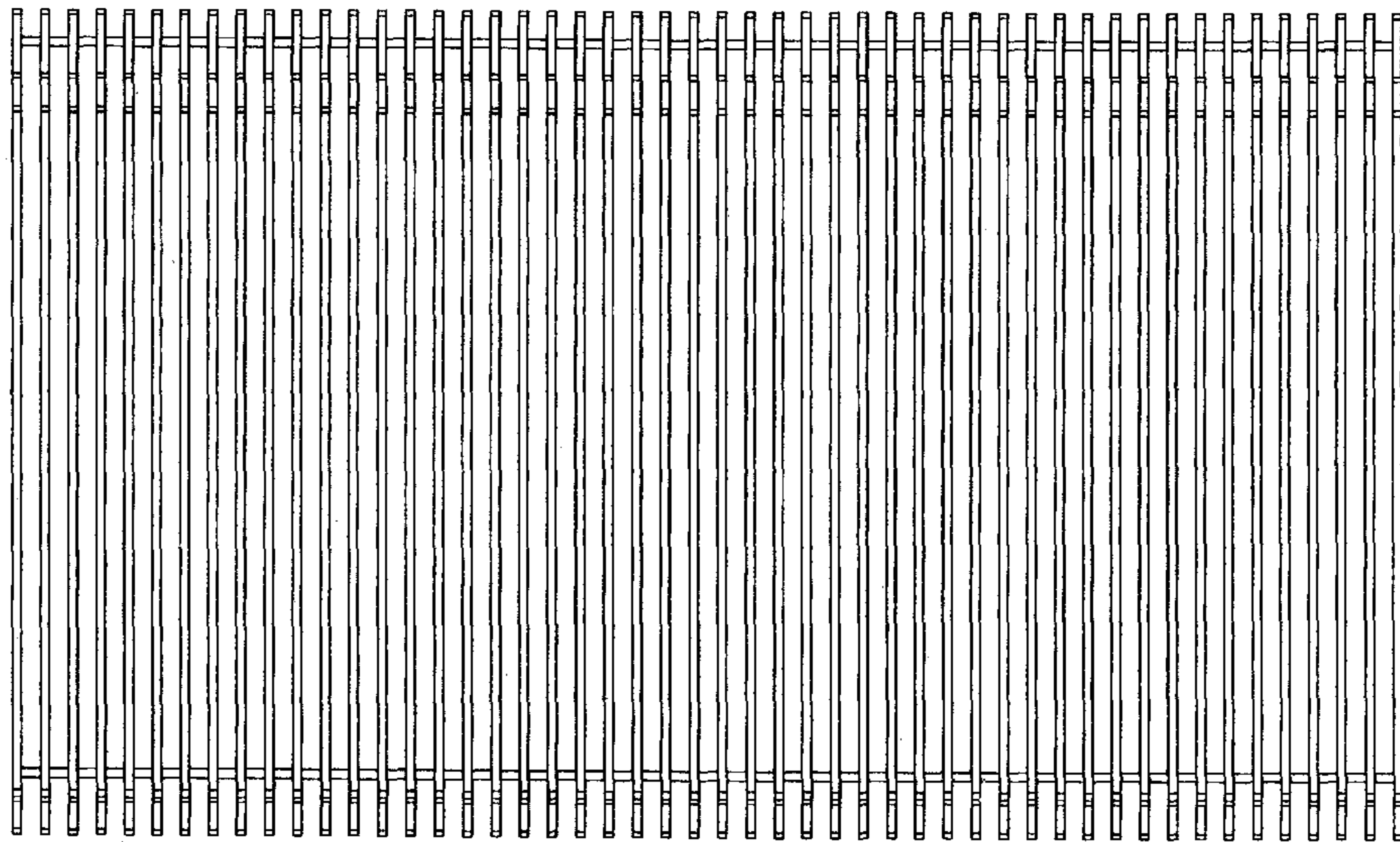

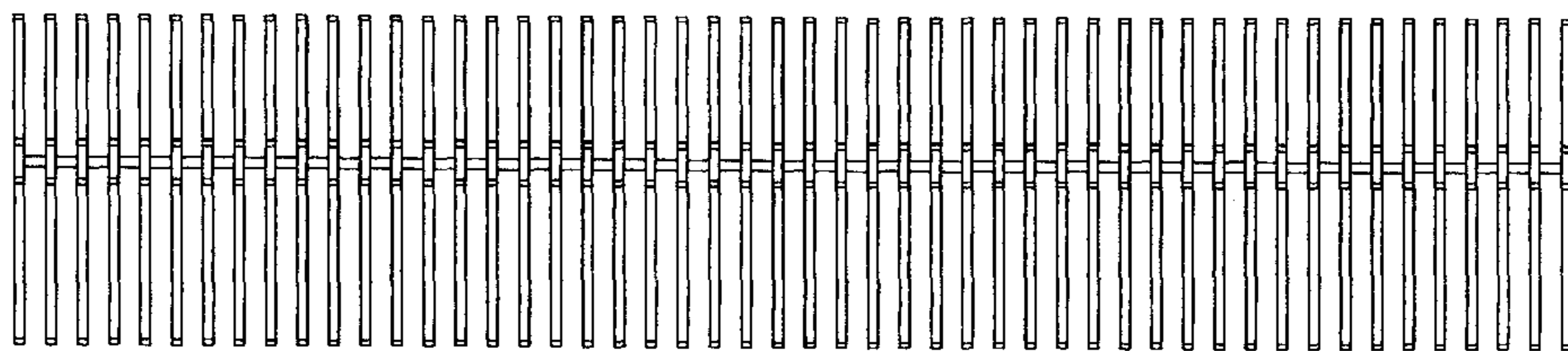

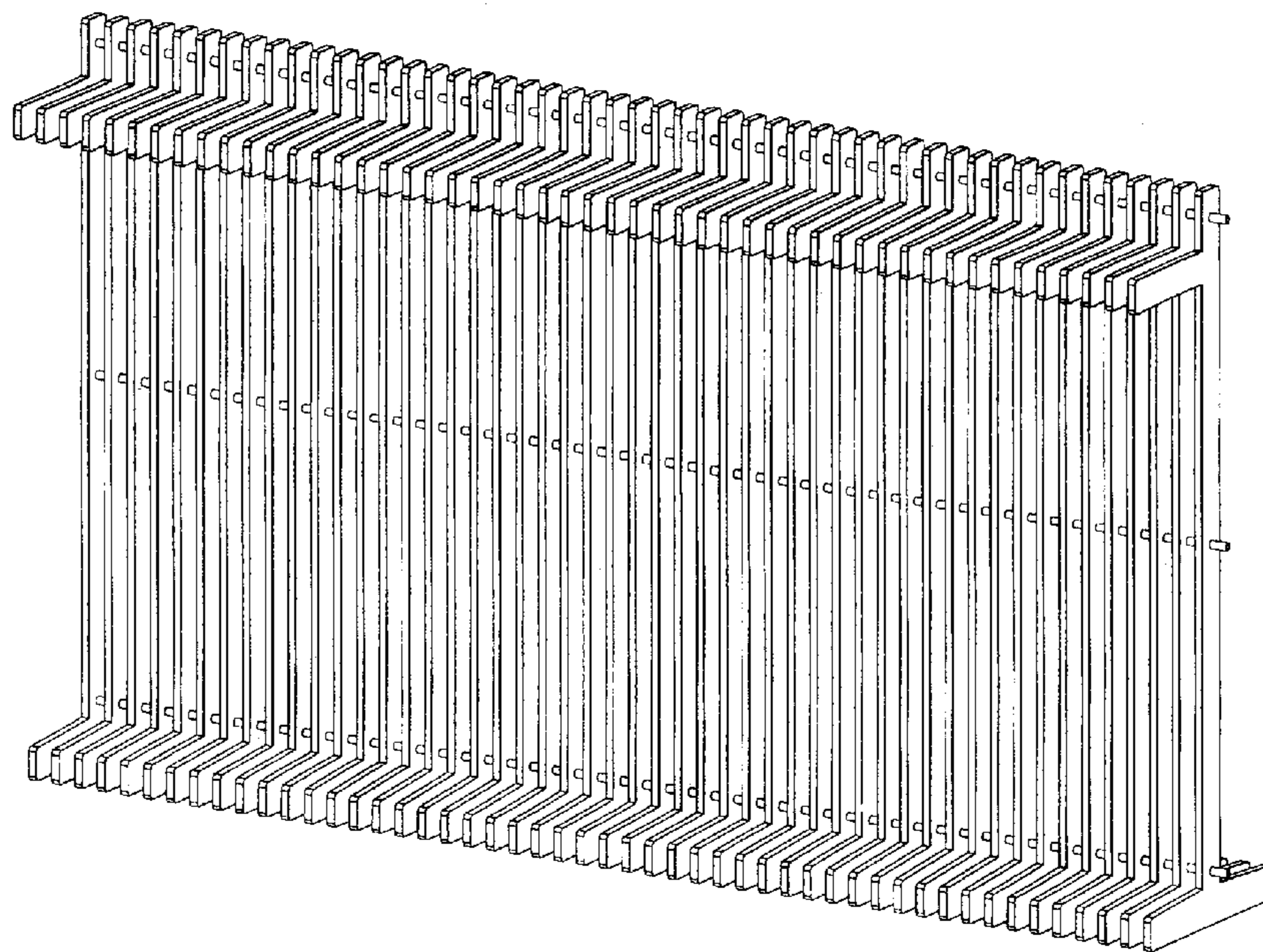
