The ornamental design for a portion of a shoe sidewall, as shown and described.

DESCRIPTION

FIG. 1 is a side view of an embodiment of a portion of a shoe sidewall showing a new design;

FIG. 2 is a front view of a portion of the shoe sidewall of FIG. 1;

FIG. 3 is a front perspective view of a portion of the shoe sidewall of FIG. 1;

FIG. 4 is a rear perspective view of a portion of the shoe sidewall of FIG. 1;

FIG. 5 is a side view of another embodiment of a portion of a shoe sidewall showing a new design;


FIG. 6 is a rear view of a portion of the shoe sidewall of FIG.










