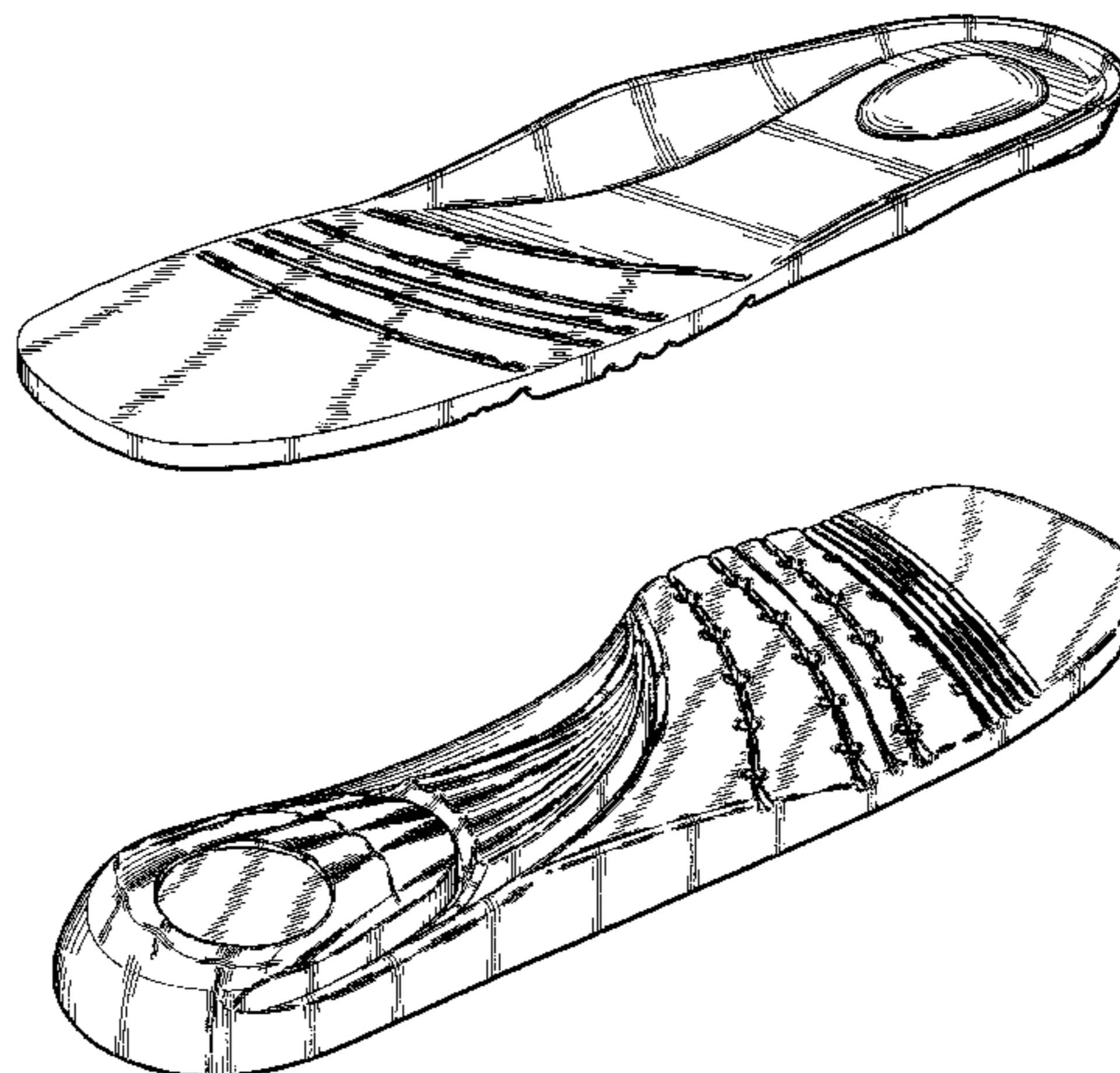
(57) **CLAIM**

The ornamental design for a footbed and forepart thereof, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a footbed of the invention including a forepart and a heelpart;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a left side elevational (medial) view thereof;
FIG. 6 is a right side elevational (lateral) view thereof;
FIG. 7 is a front elevational view thereof; and,
FIG. 8 is a rear elevational view thereof.

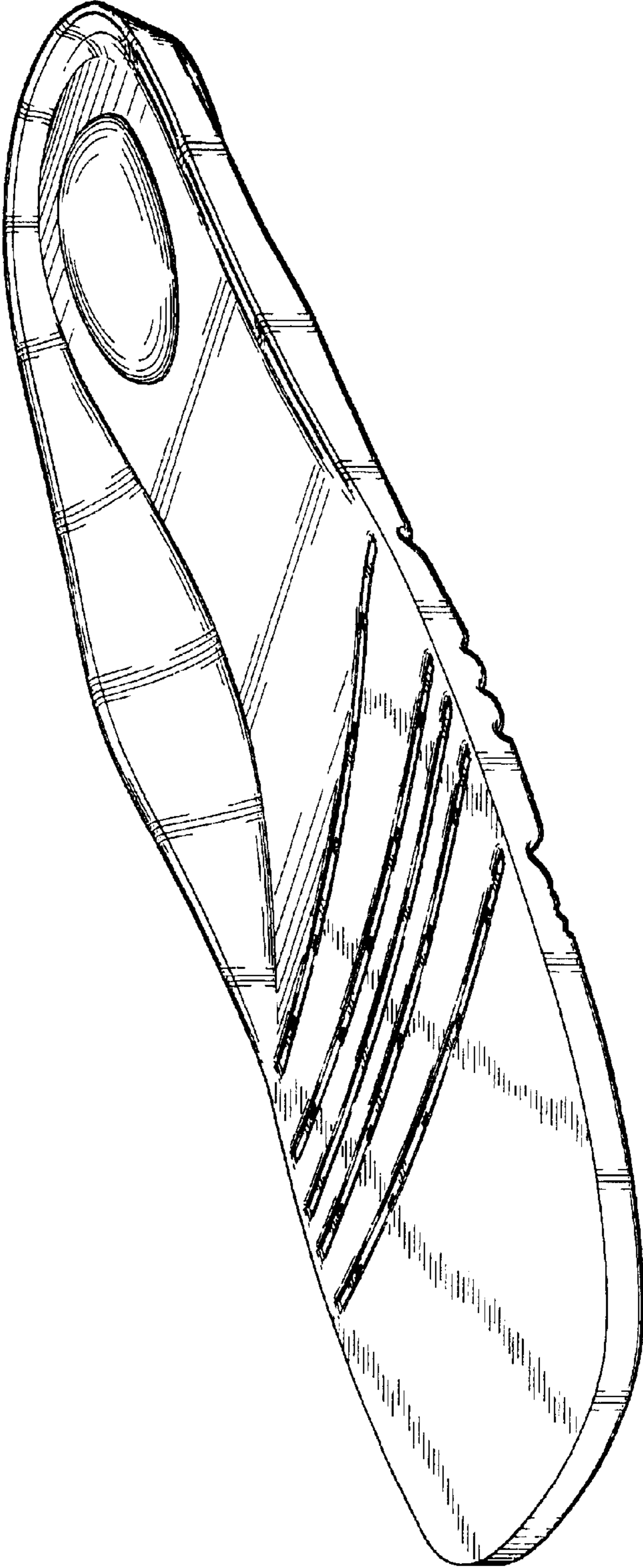

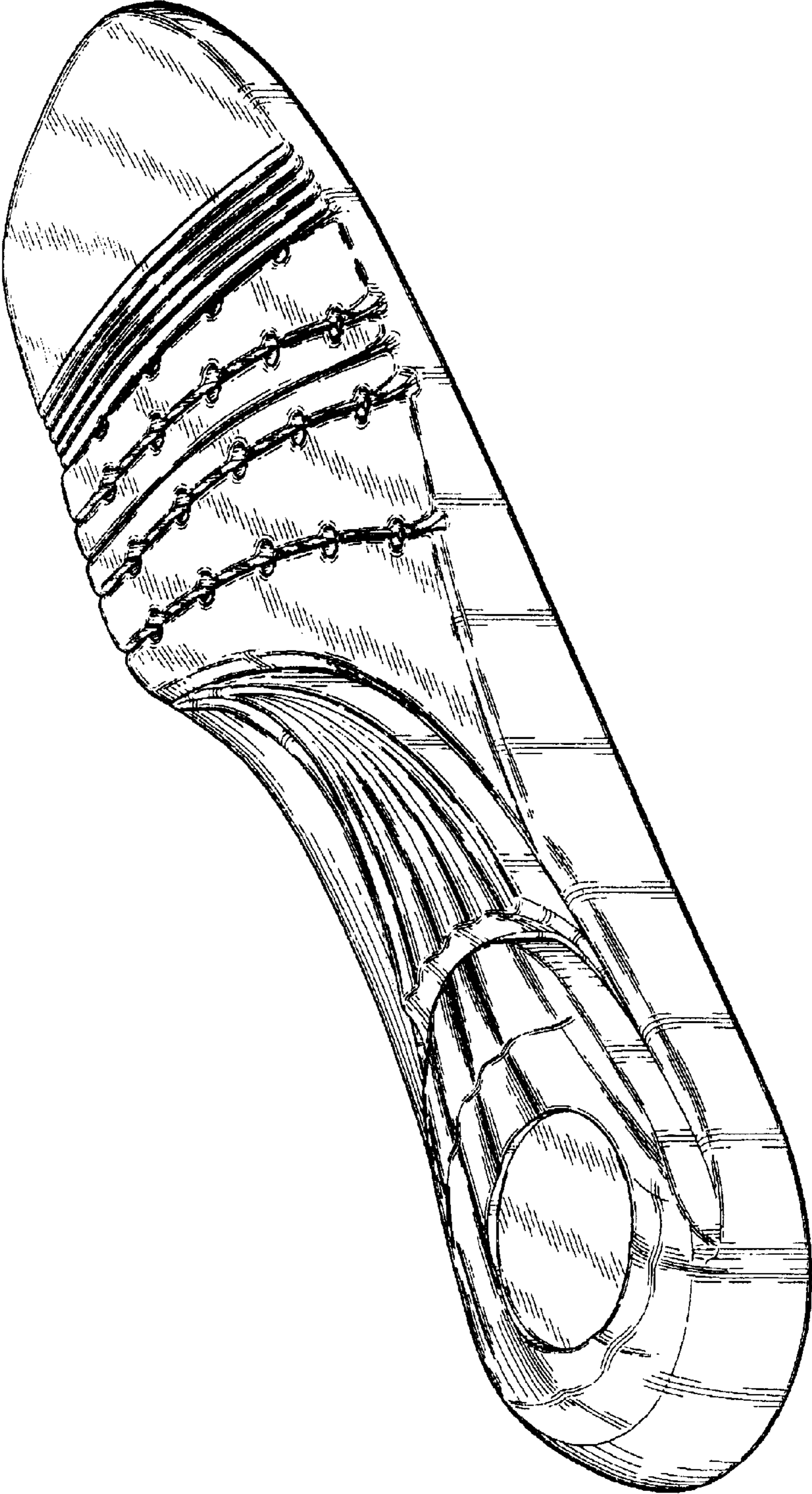

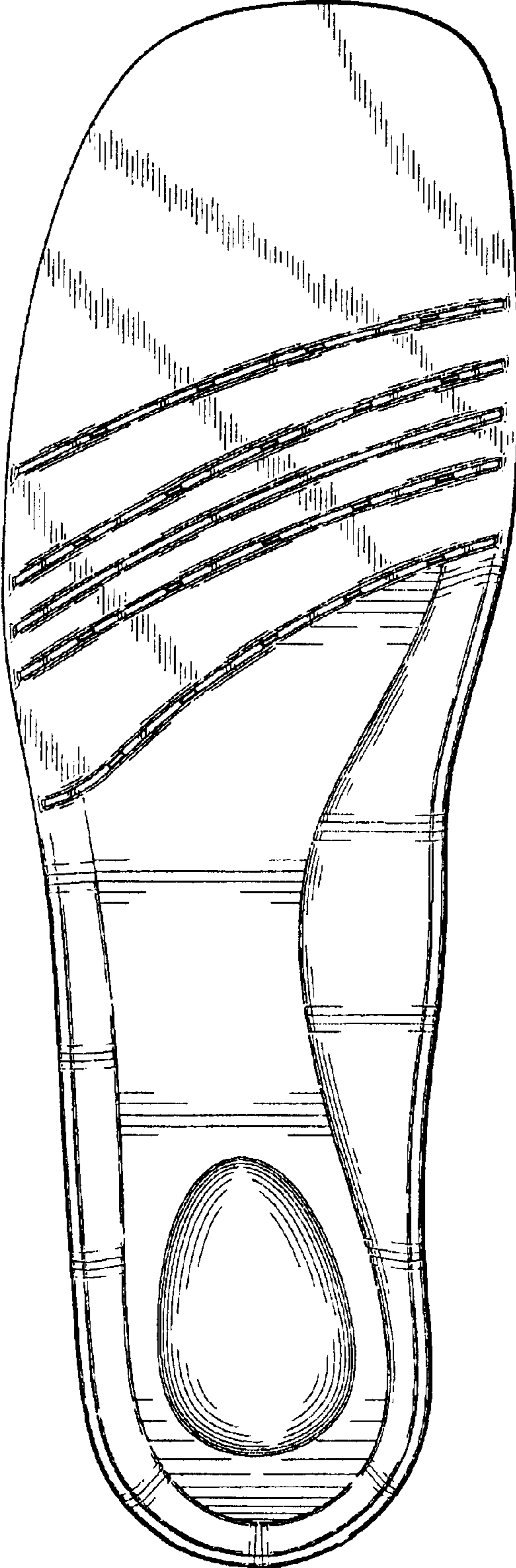

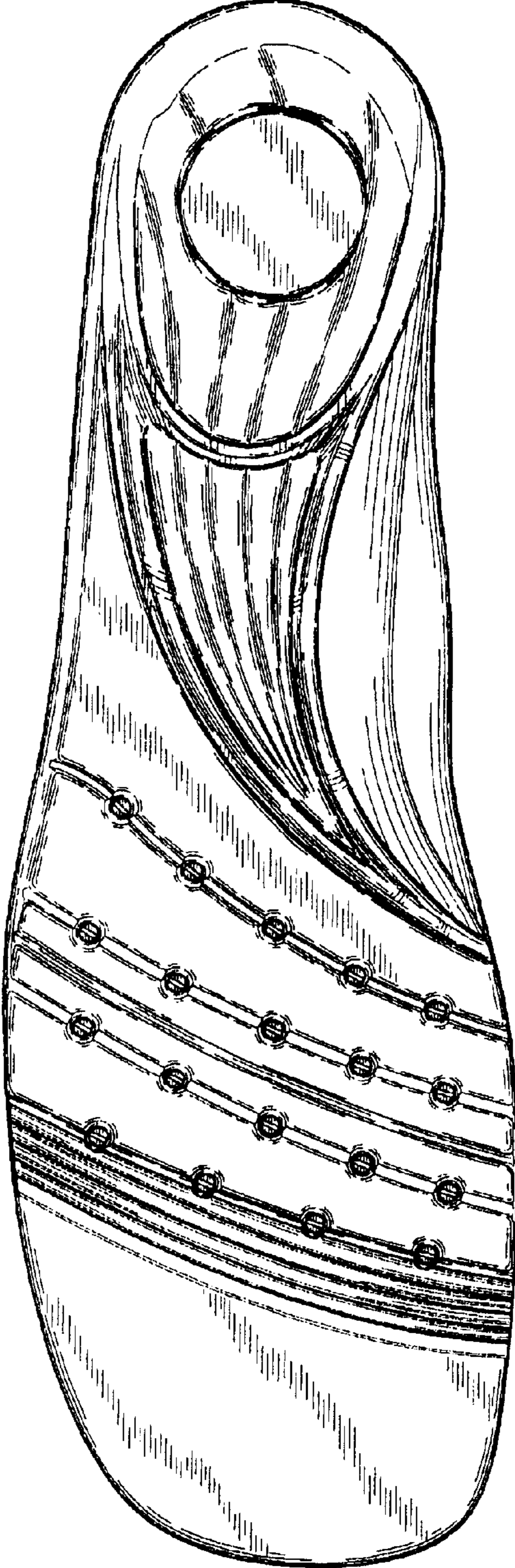

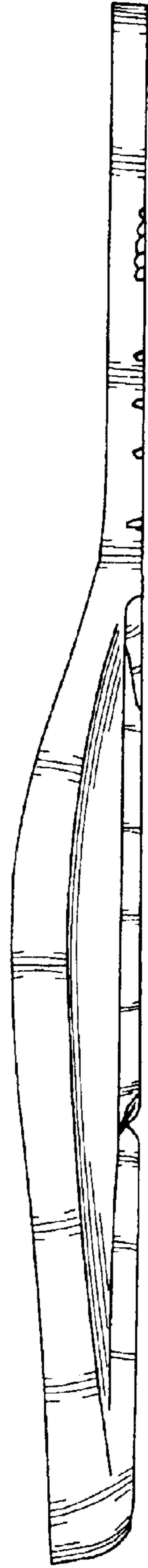

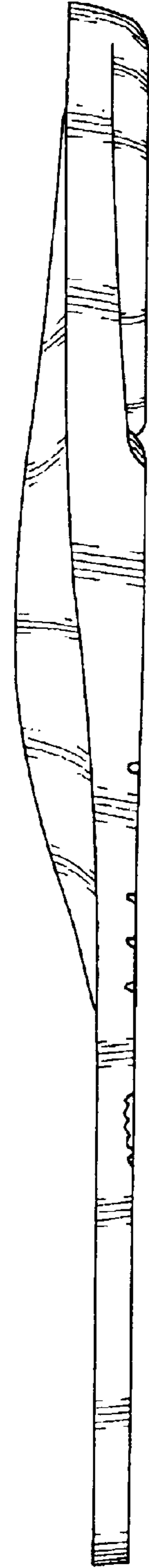

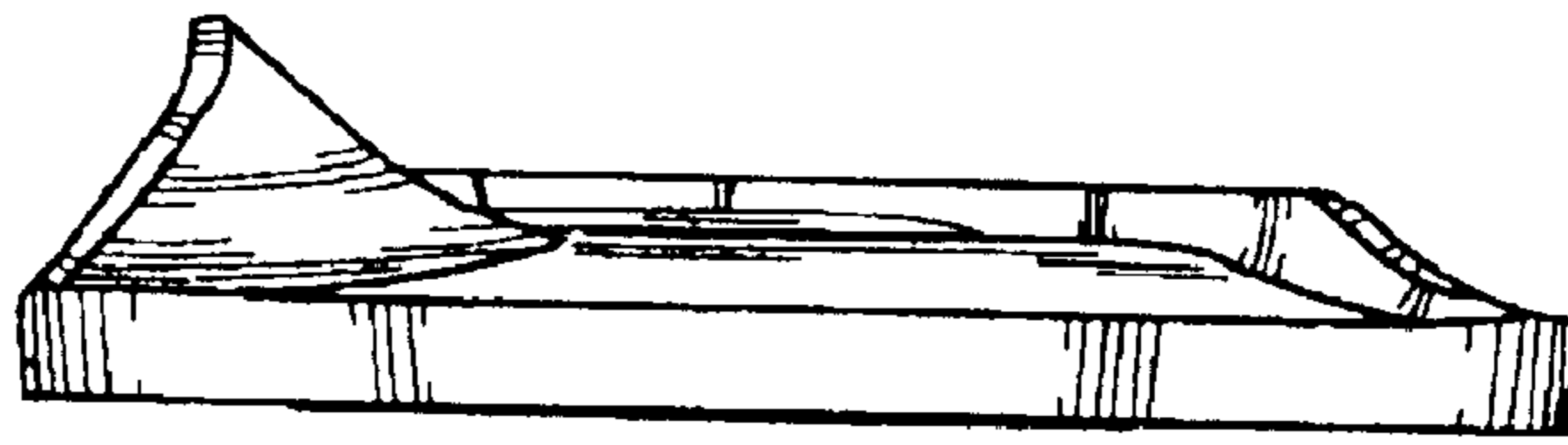
