(57) **CLAIM**

The ornamental design for a shelf unit for audio/video components, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of shelf unit for audio/video components showing my new design;

FIG. 2 is a front orthographic view thereof;

FIG. 3 is a top orthographic view thereof;

FIG. 4 is a right side orthographic view thereof, the left side orthographic view having a mirror image;

FIG. 5 is a perspective view of a second embodiment of my design;

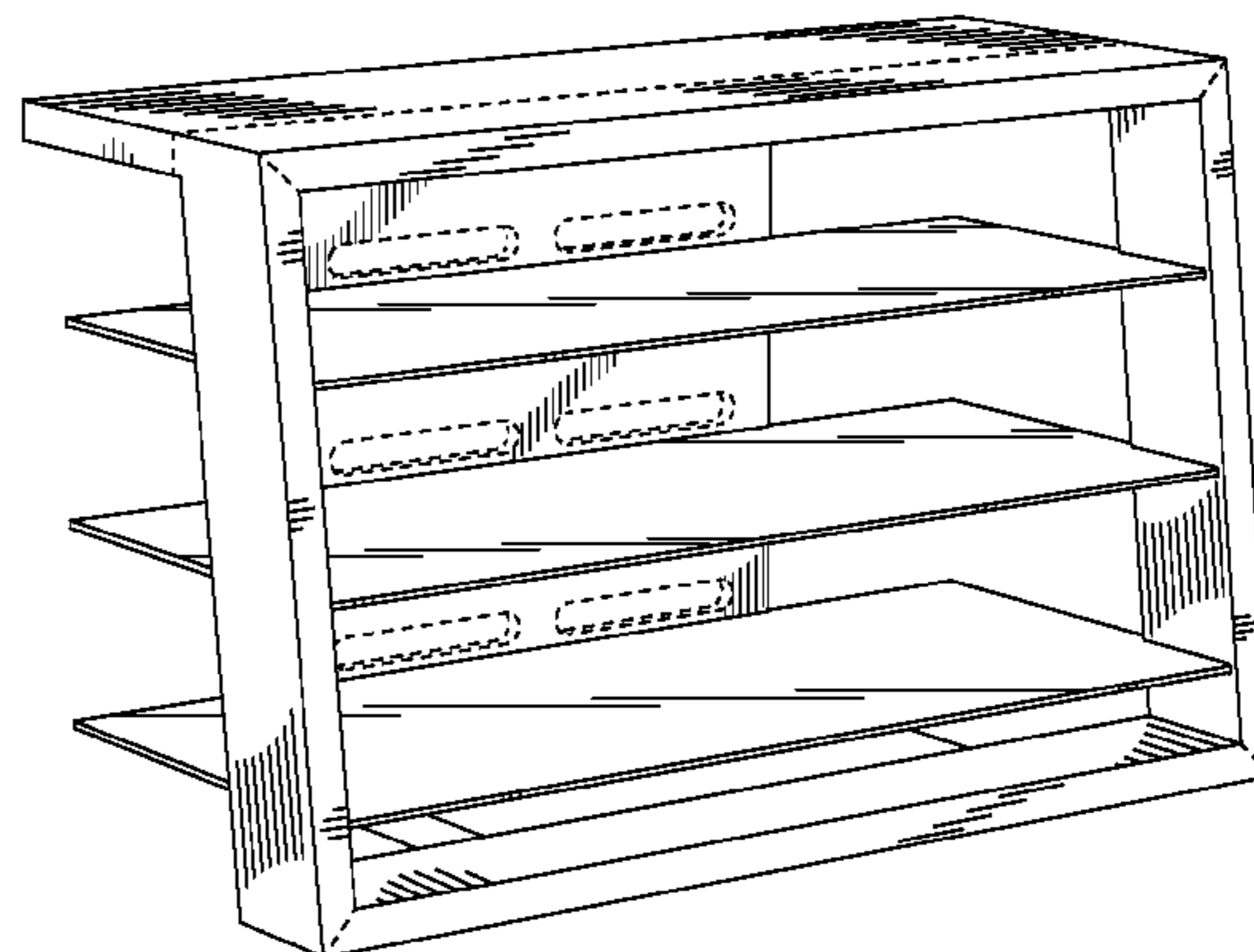
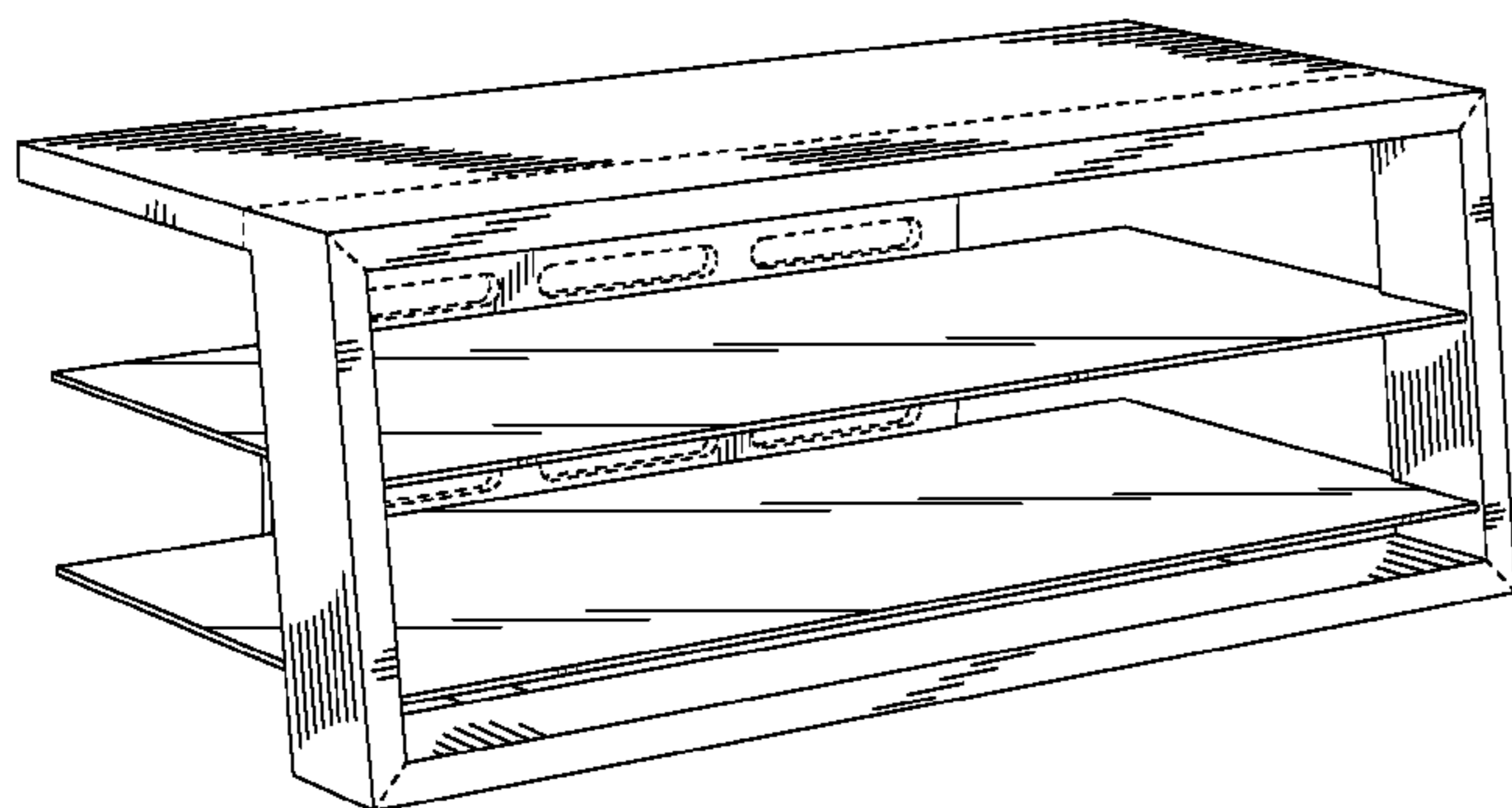
FIG. 6 is a front orthographic view thereof;

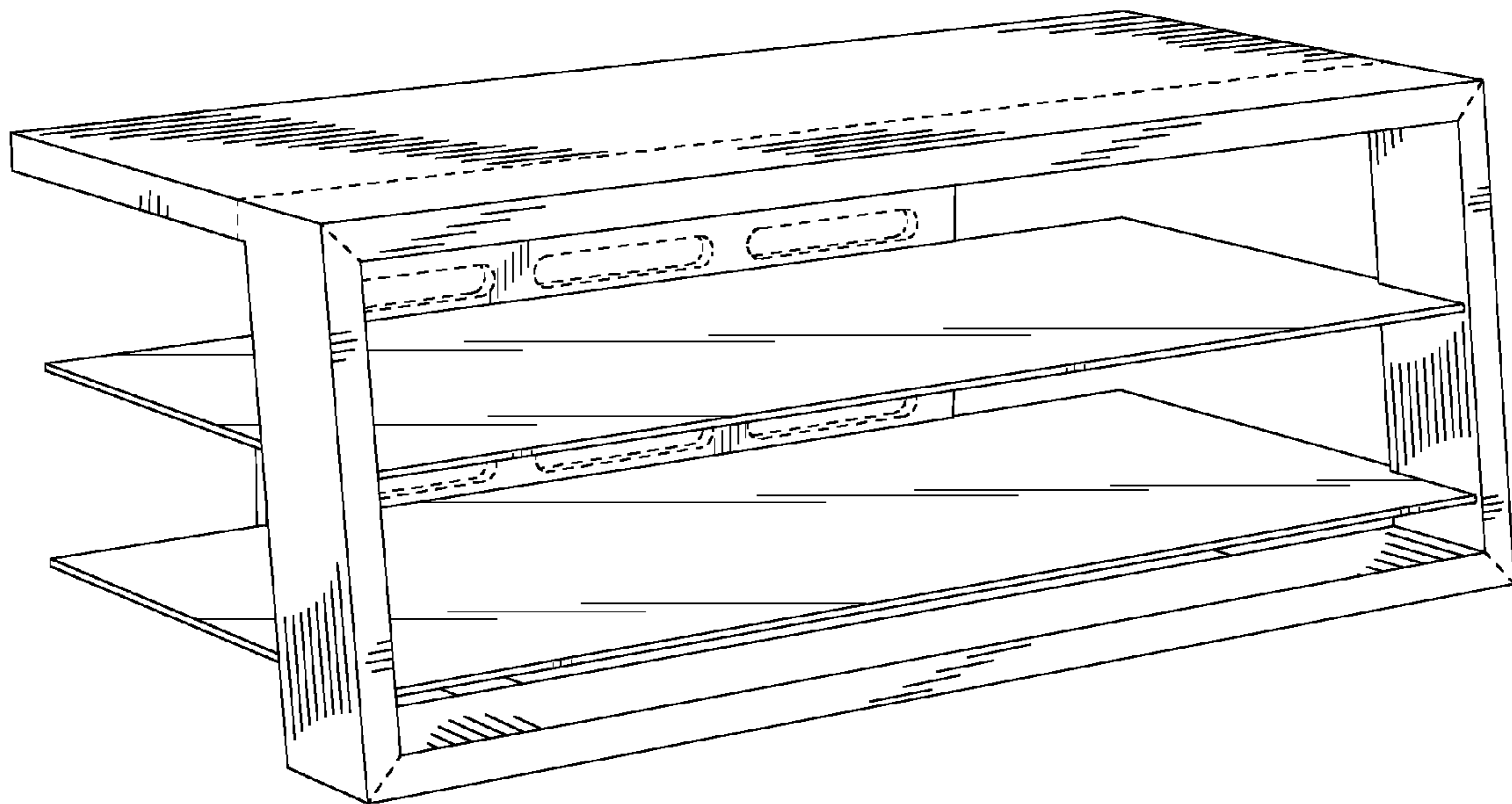

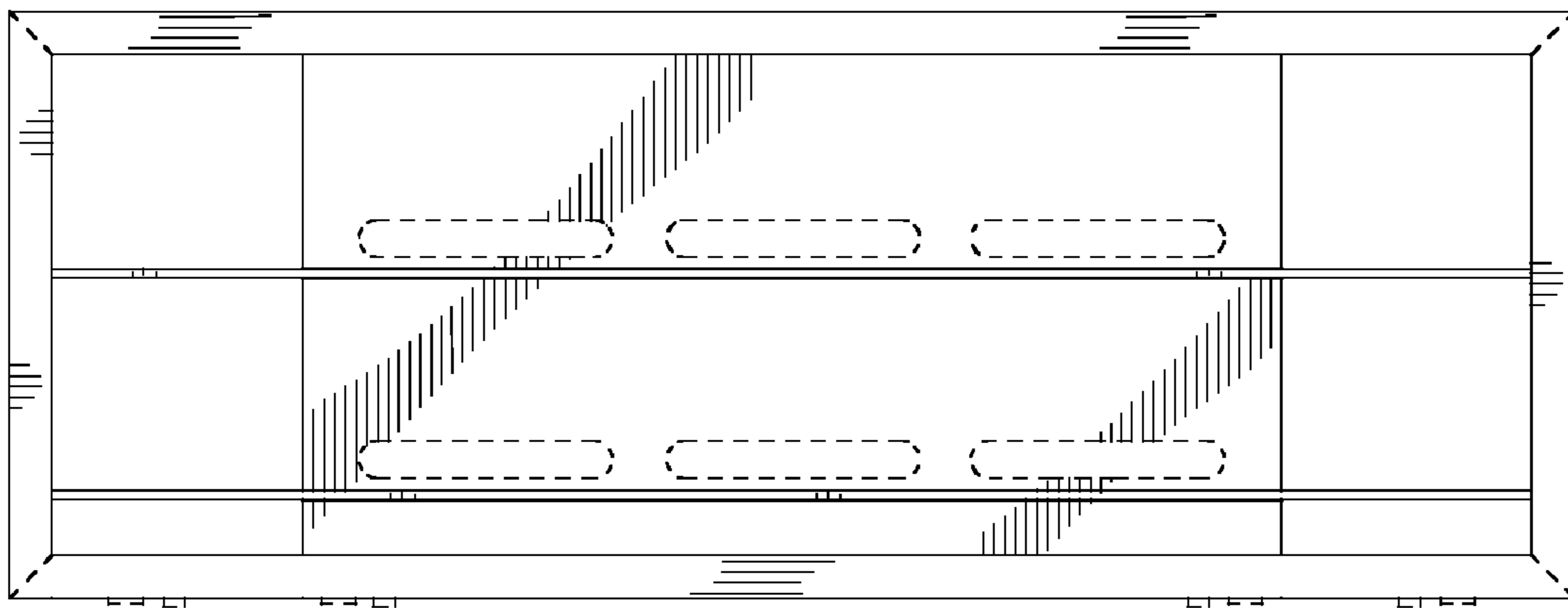

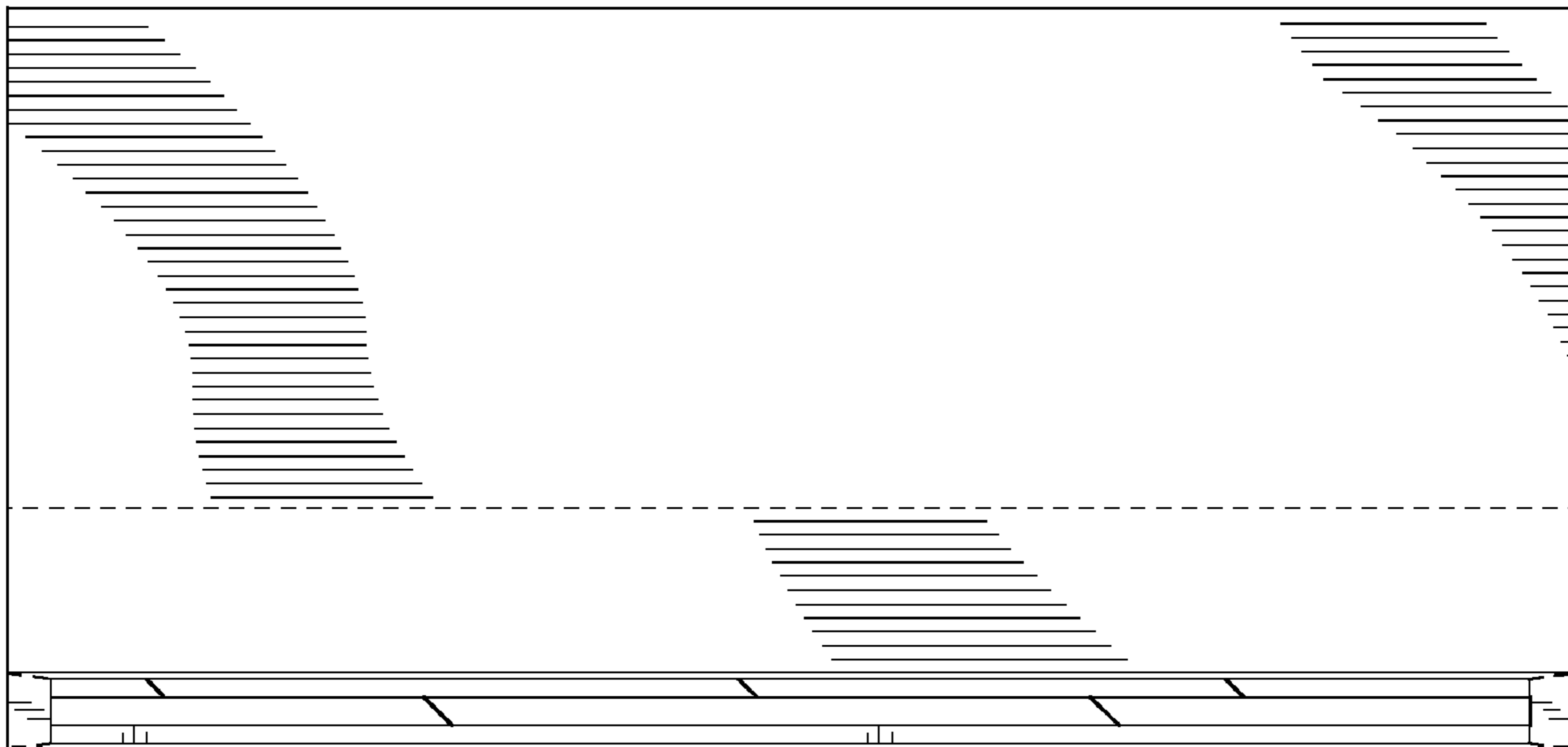

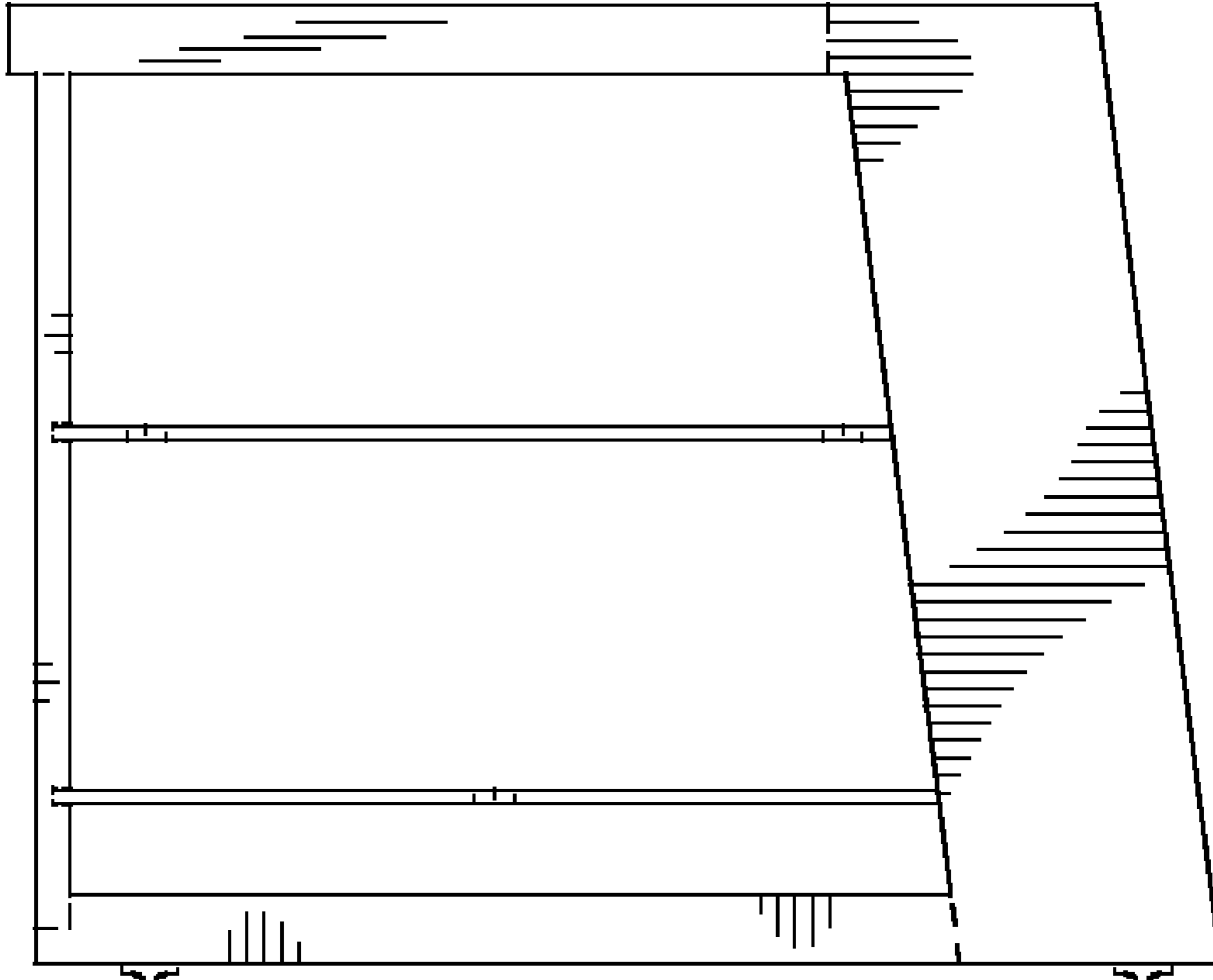

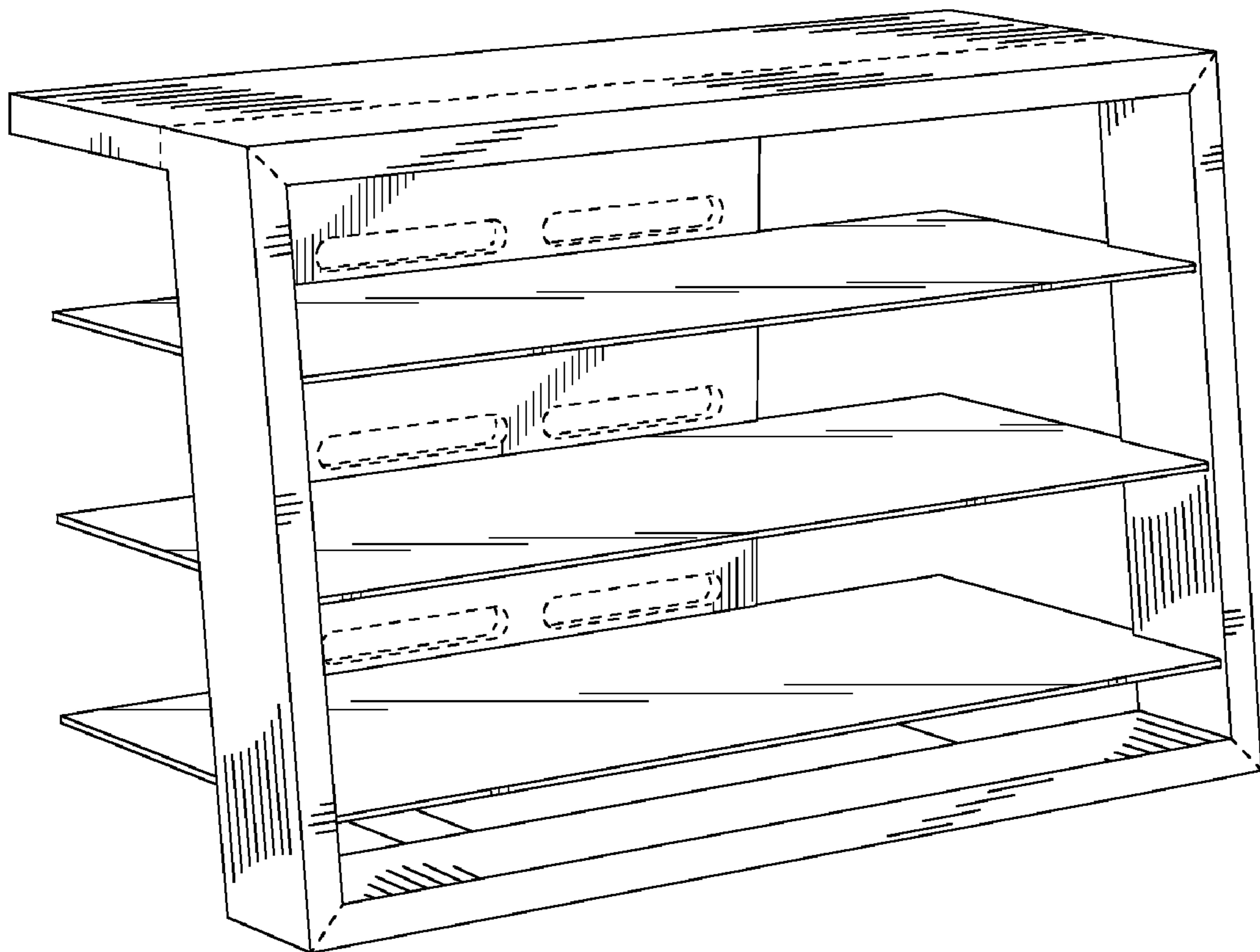

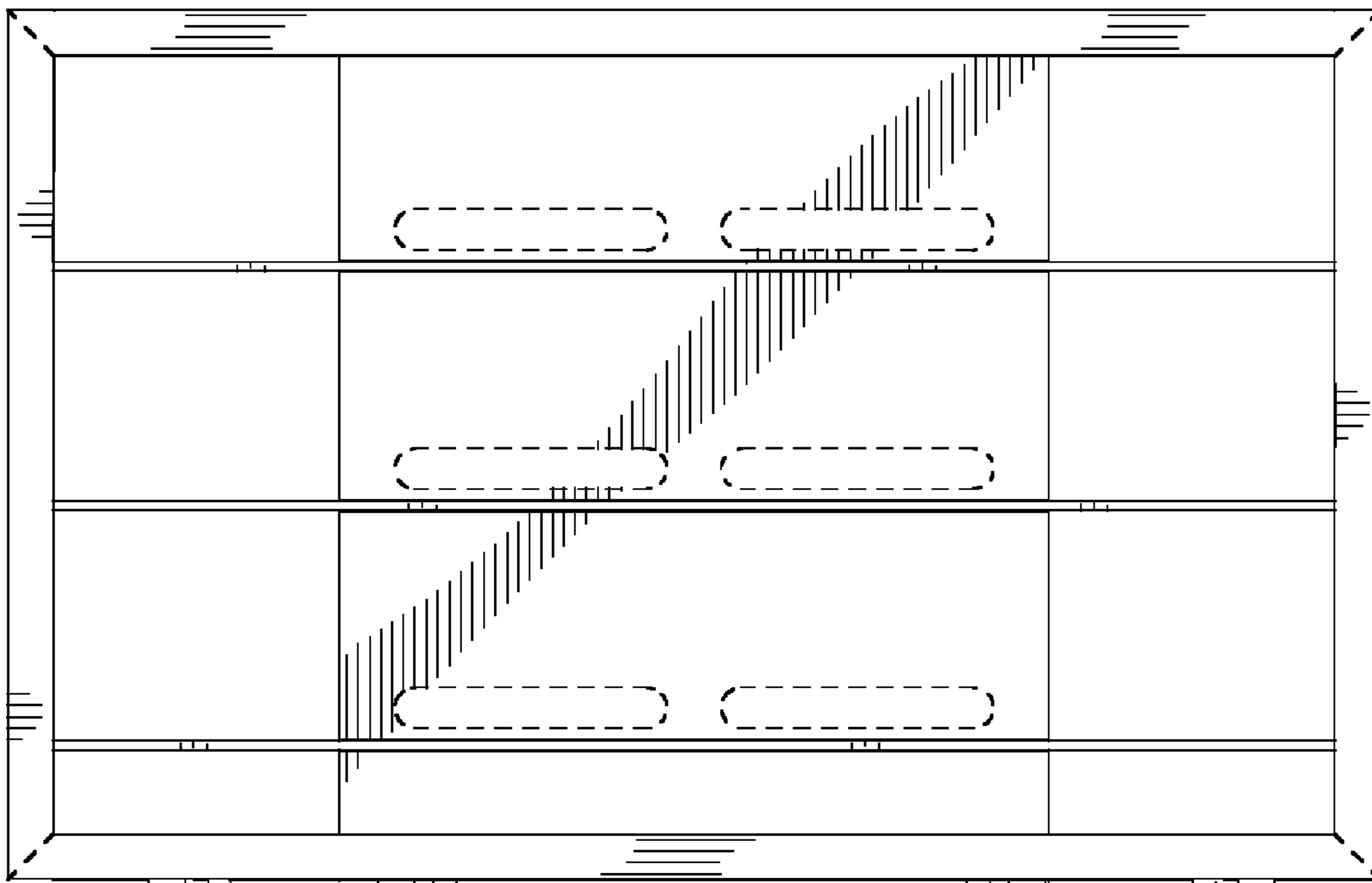

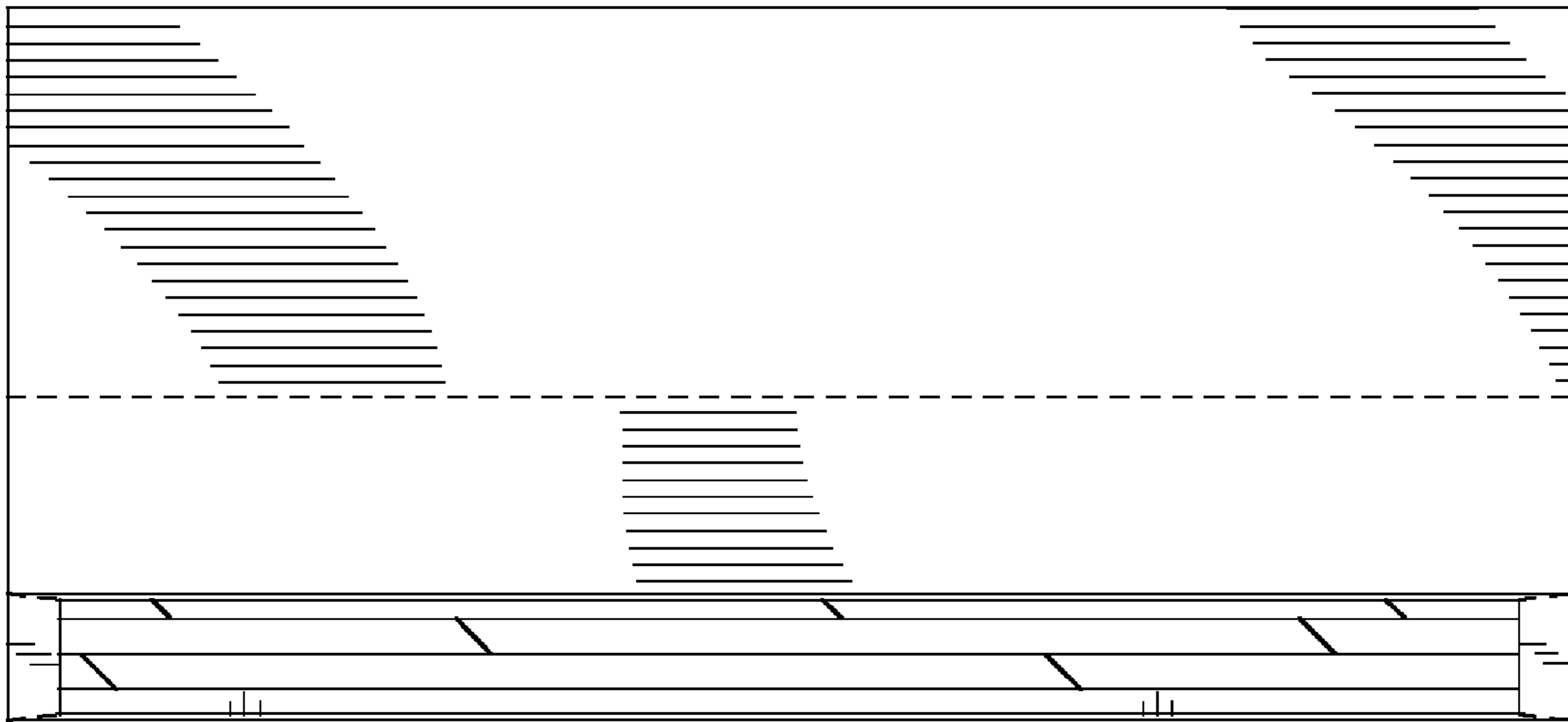

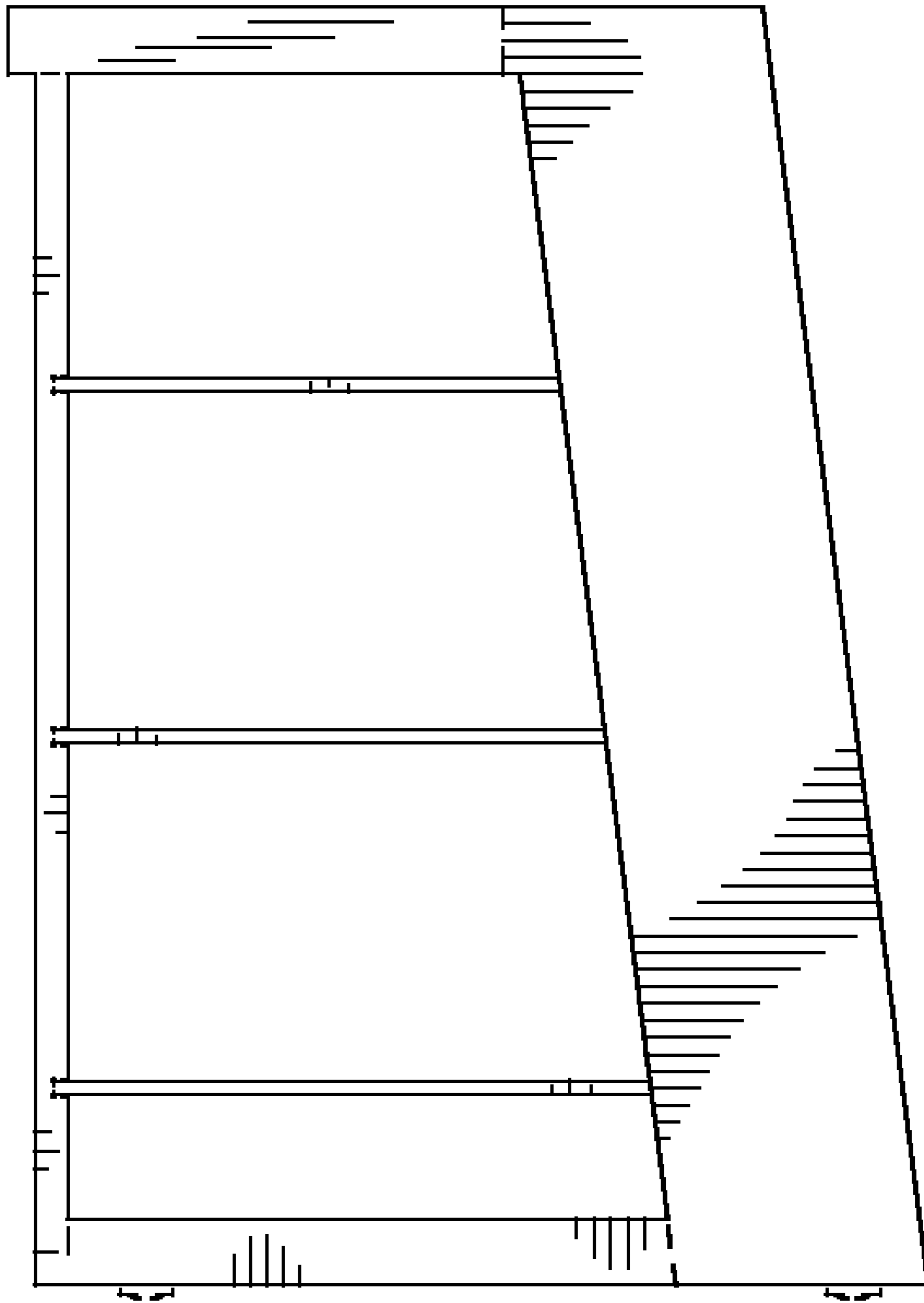
