(57) **CLAIM**

We claim the ornamental design for a food slicer, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of a food slicer of the present invention;

FIG. 2 is a first side view thereof, wherein the second side view is a mirror image thereof;

FIG. 3 is a bottom view thereof;

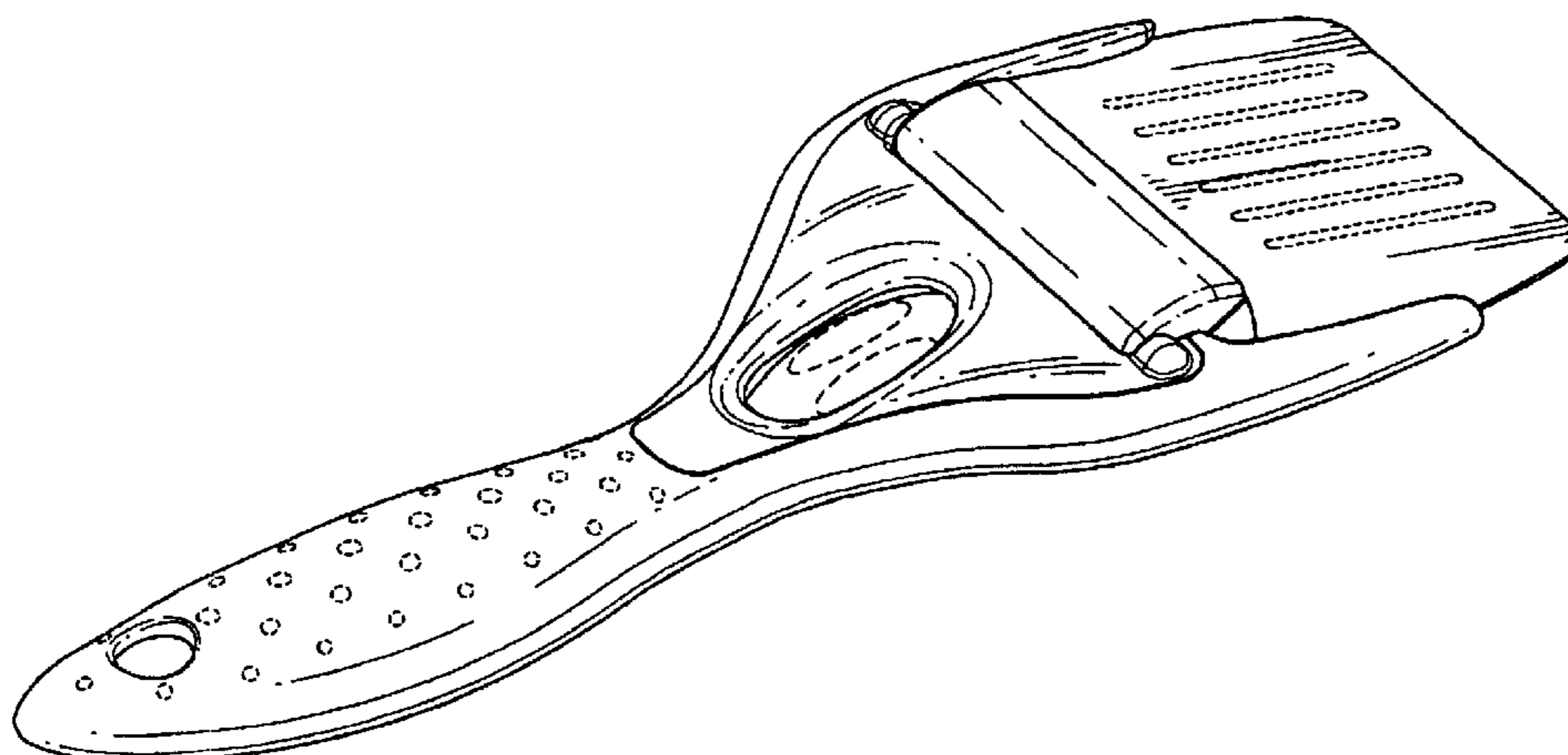
FIG. 4 is a top view thereof;

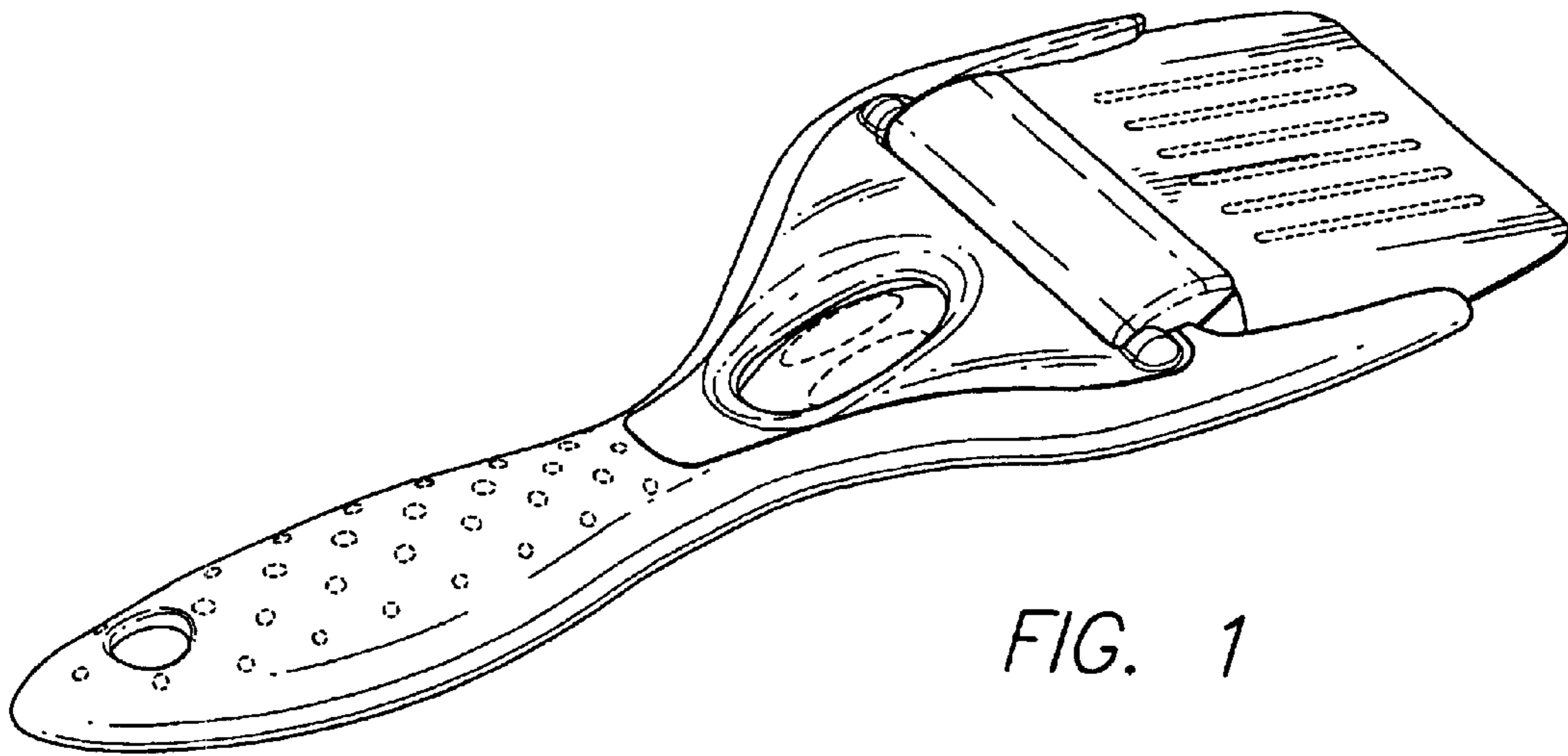

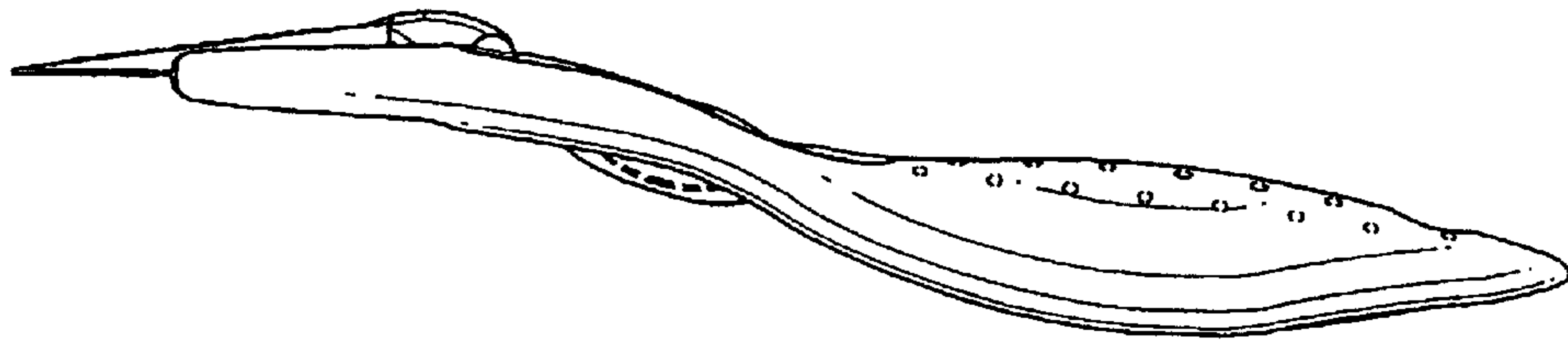

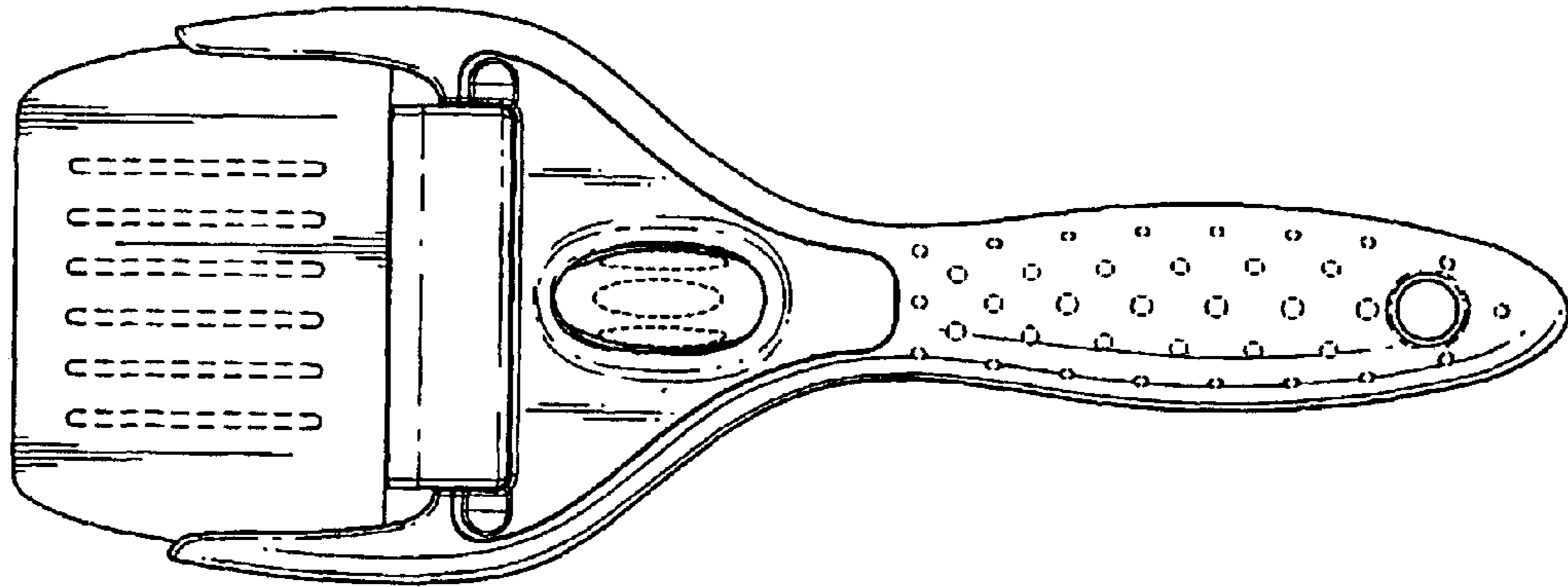

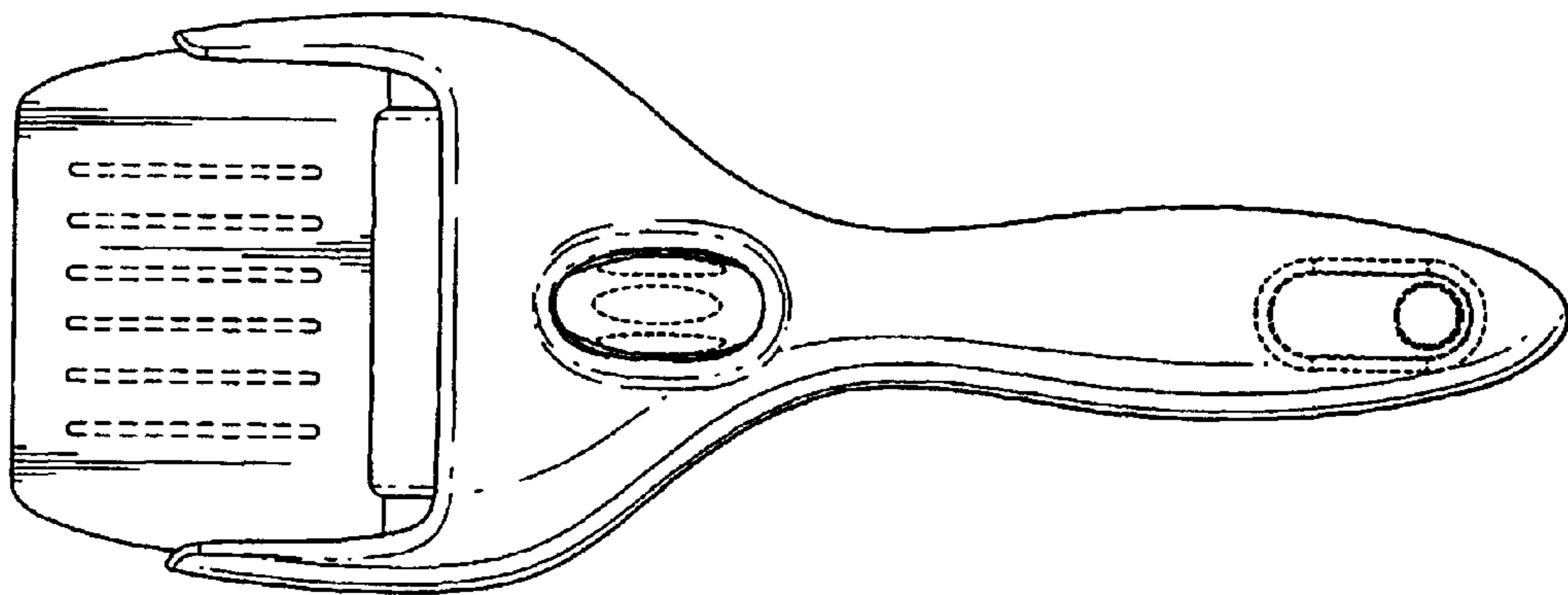

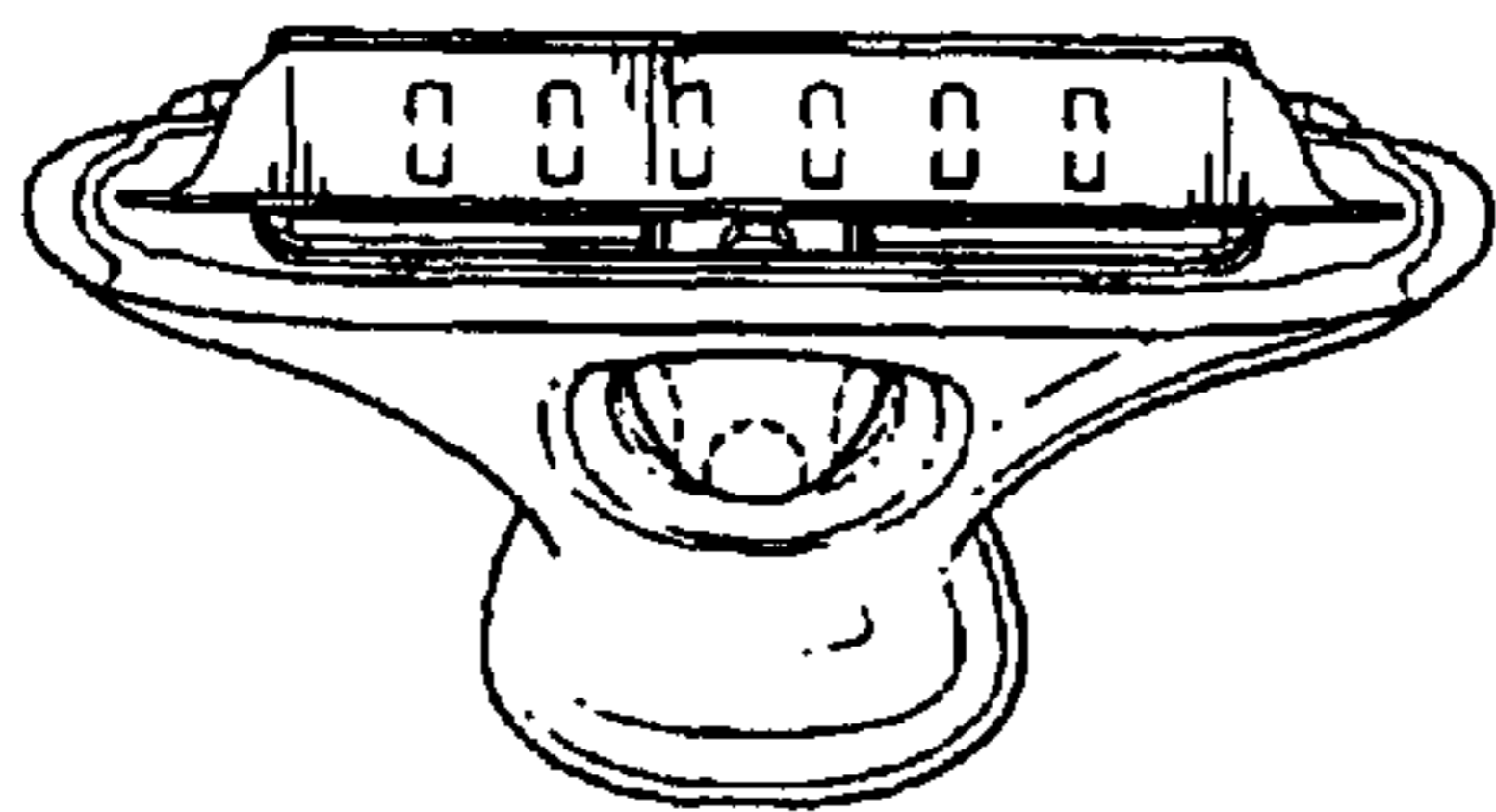

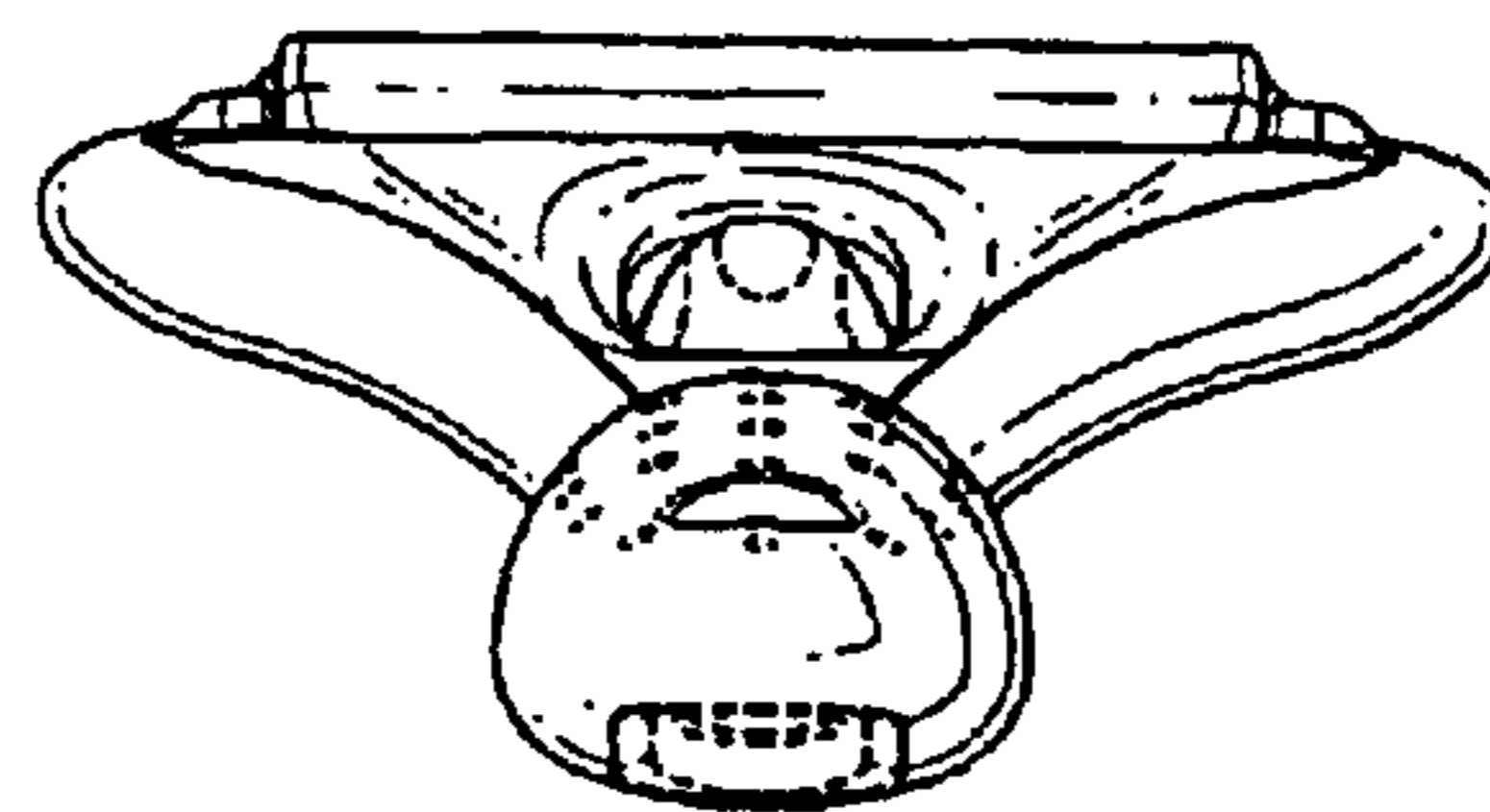
