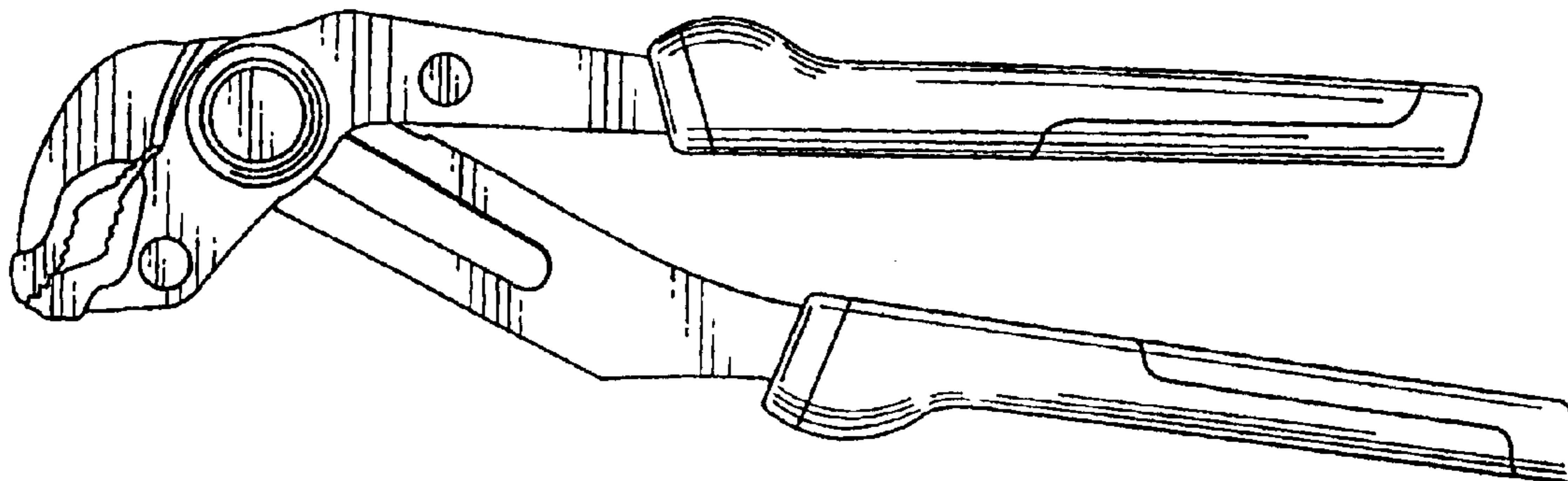
(57) **CLAIM**

We claim the ornamental design for a groovelock tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side perspective view showing an embodiment of our new design for a groovelock tool;

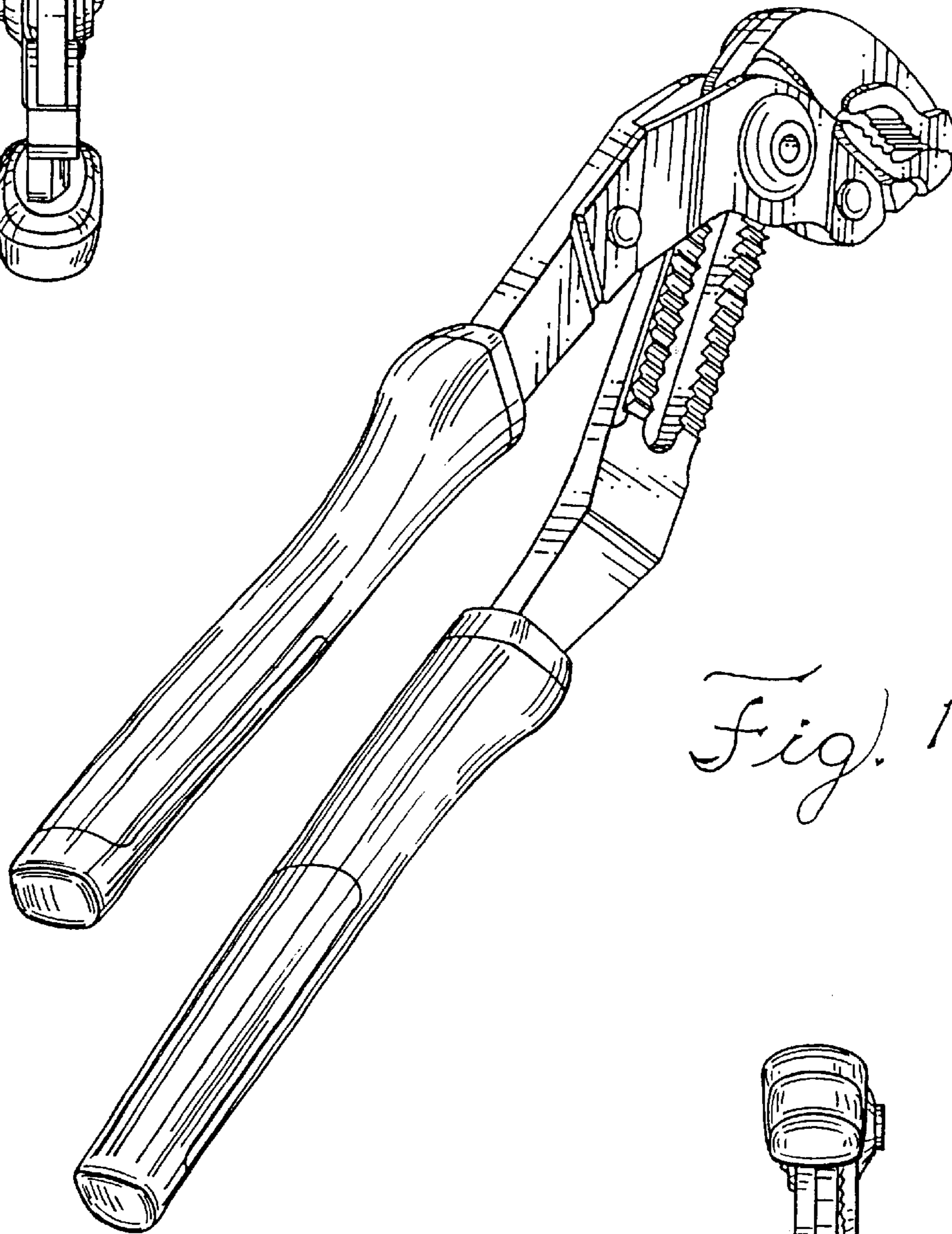
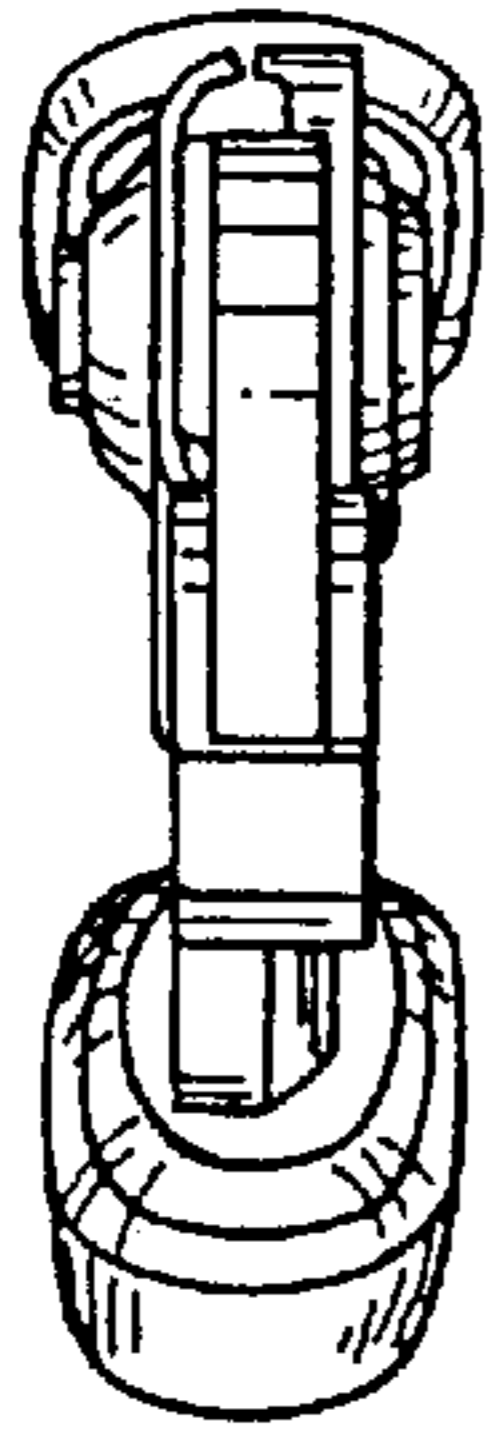

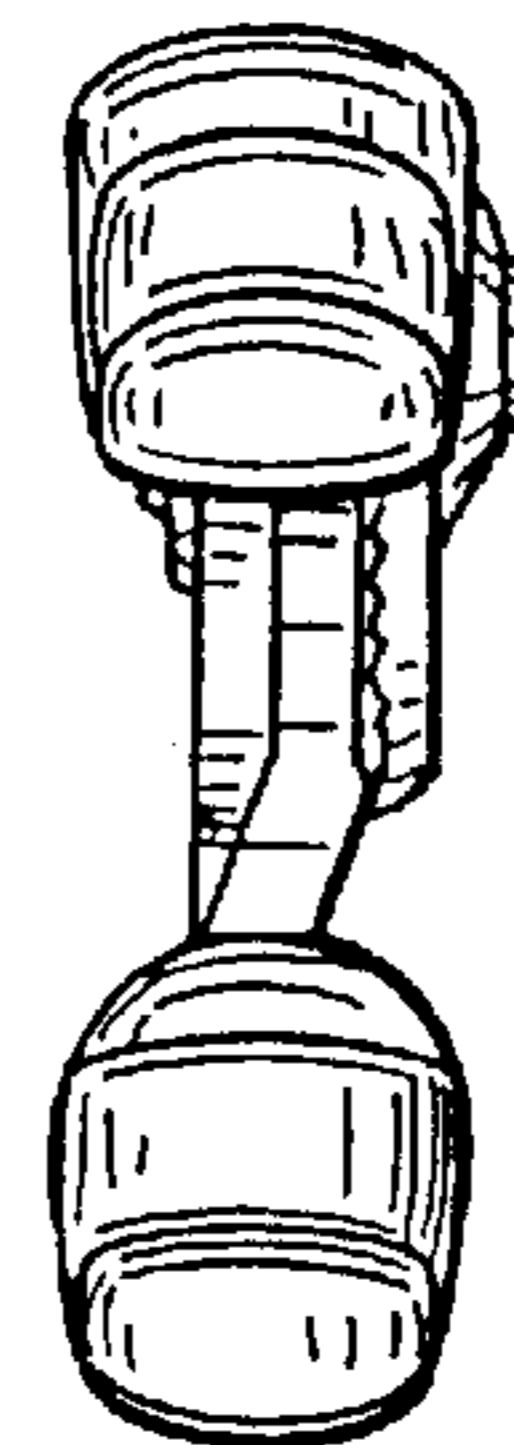

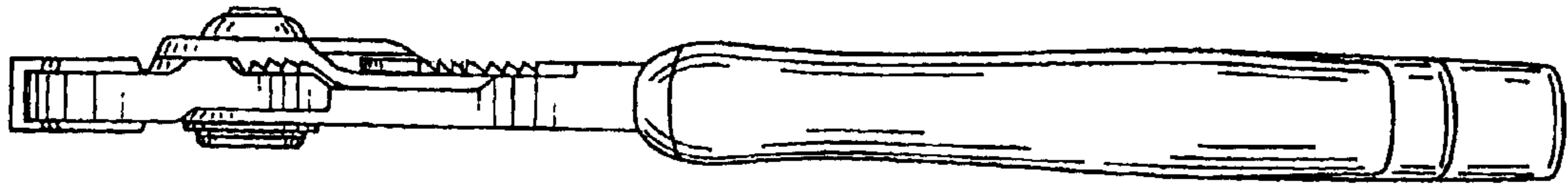

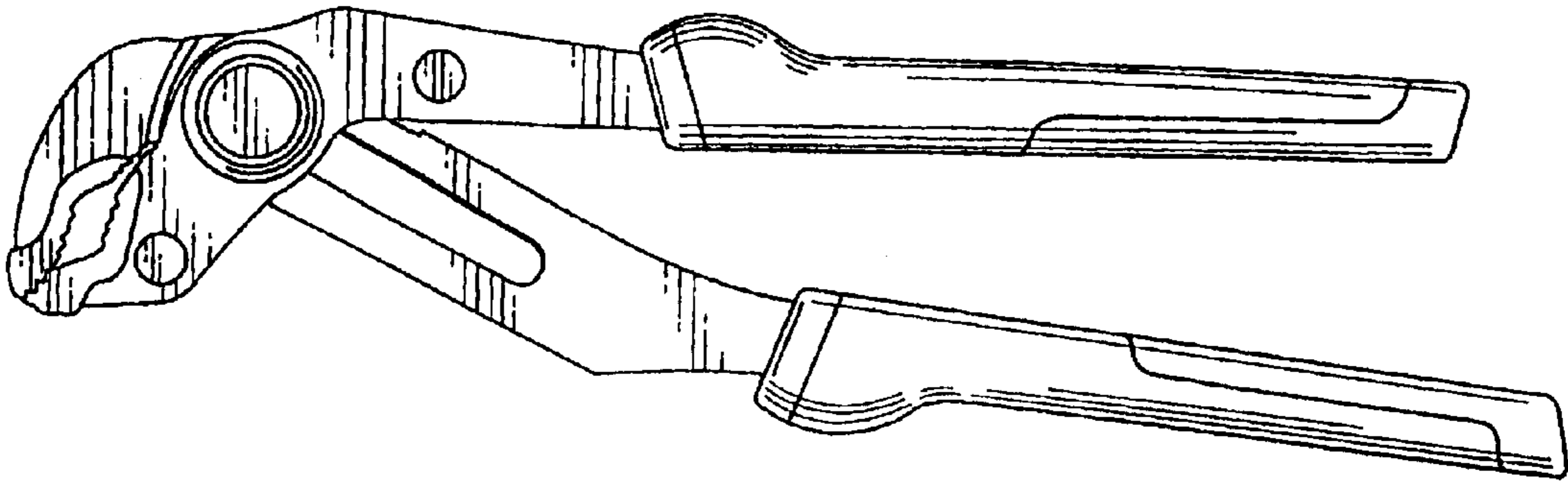

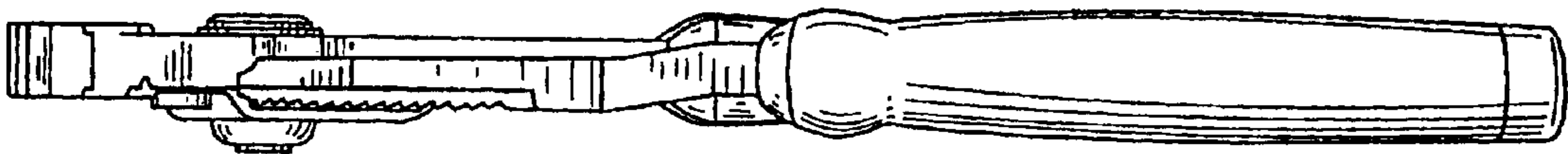

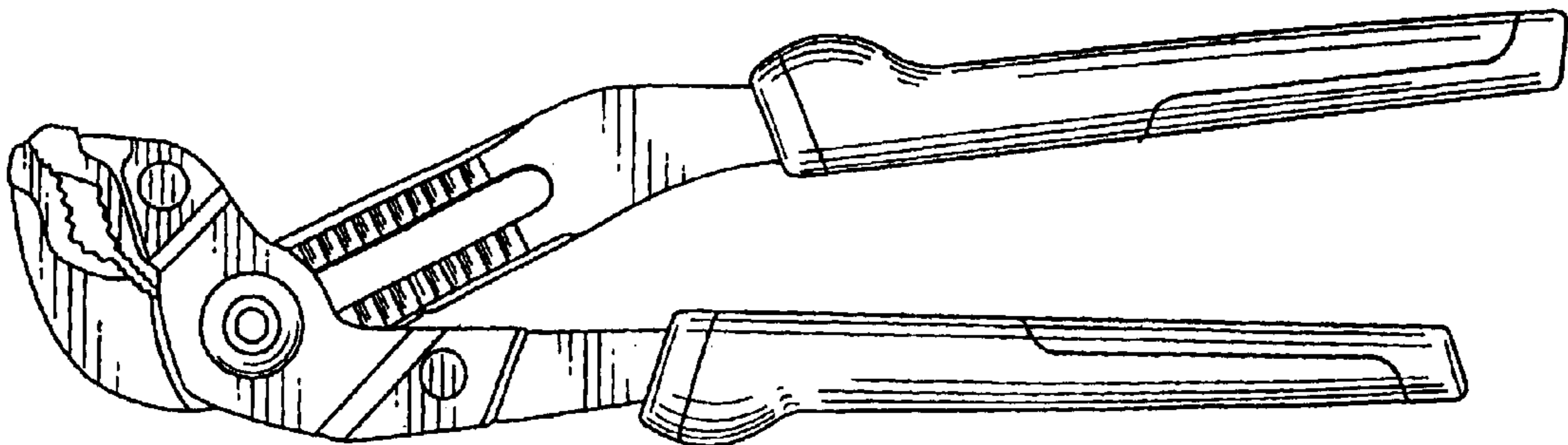
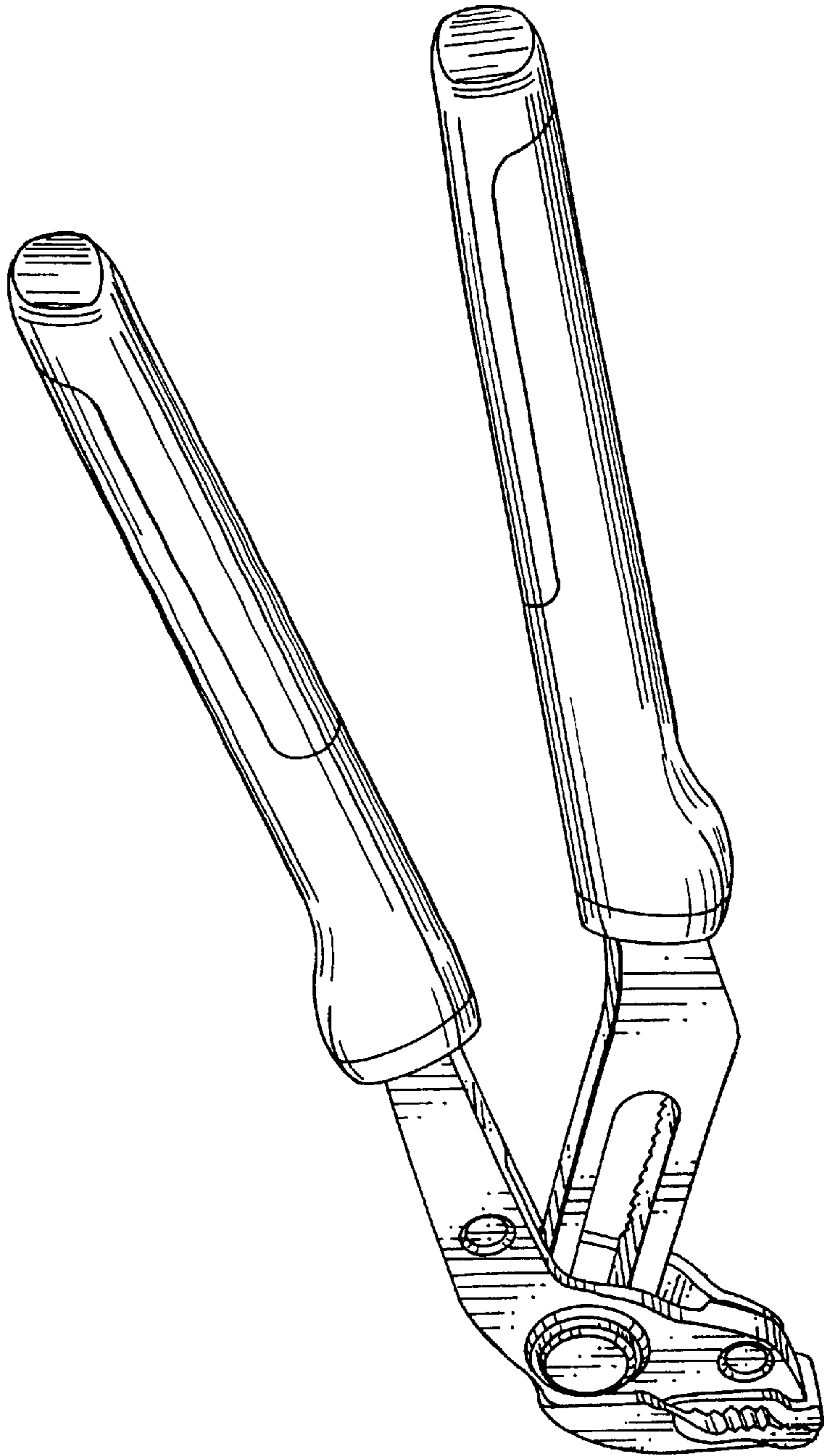
