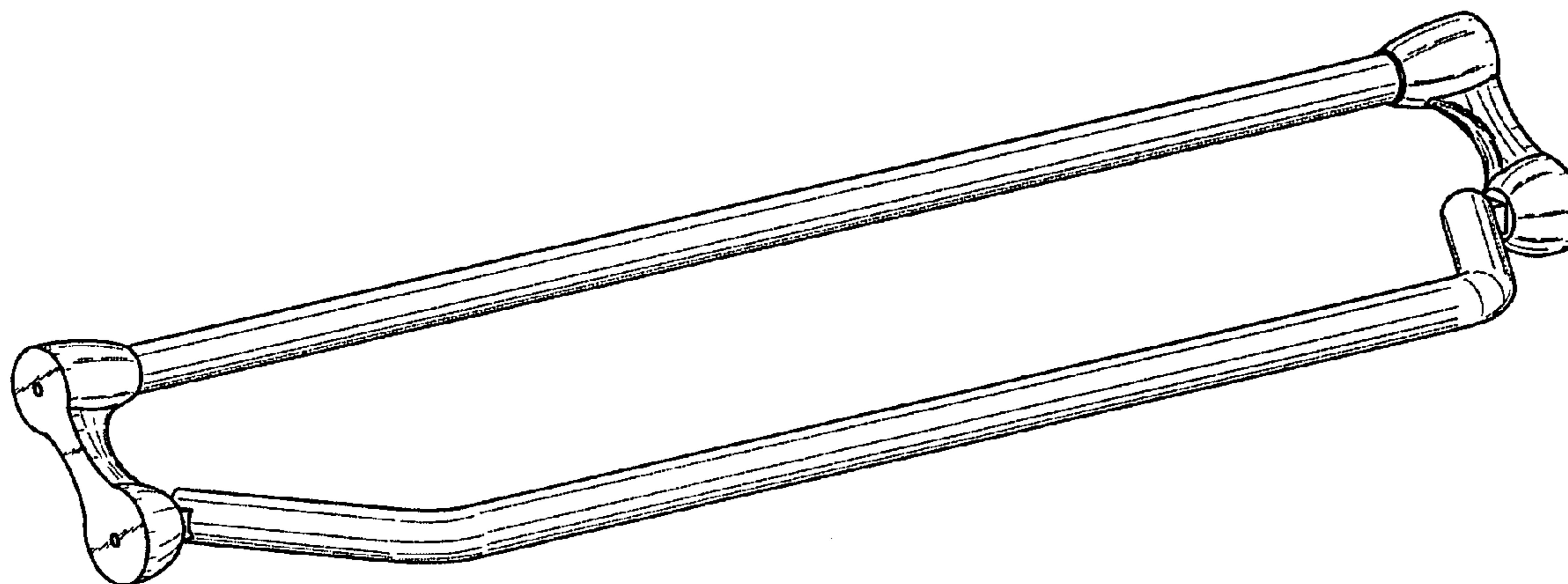

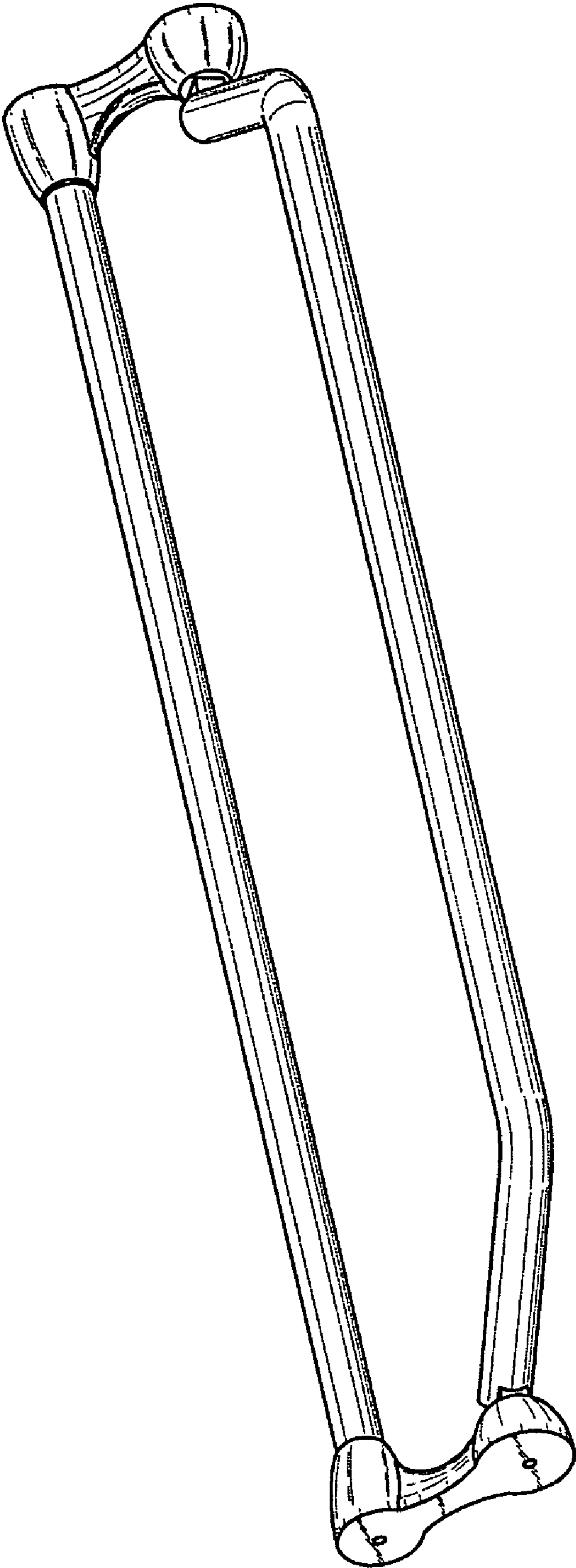
The ornamental design for shower curtain rod assembly, substantially as shown and described.

**DESCRIPTION**

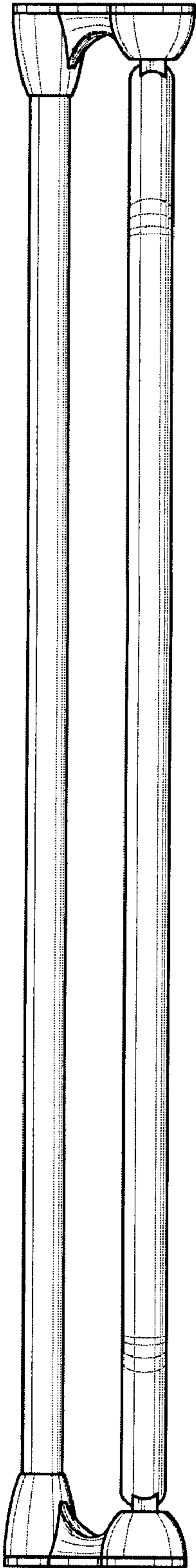
FIG. 1 is a perspective view of our new design;

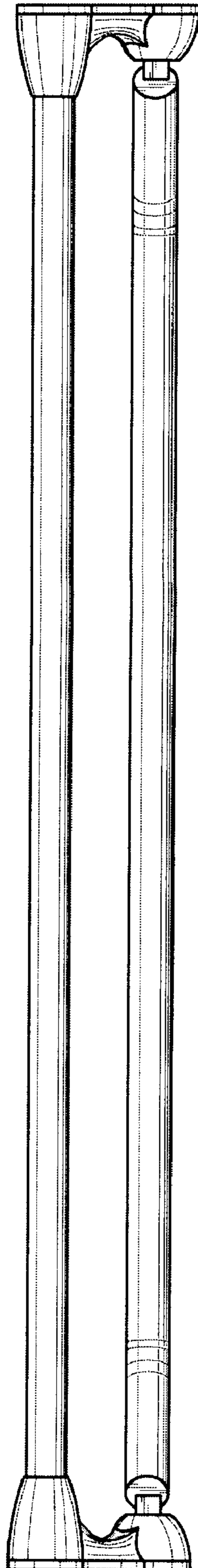




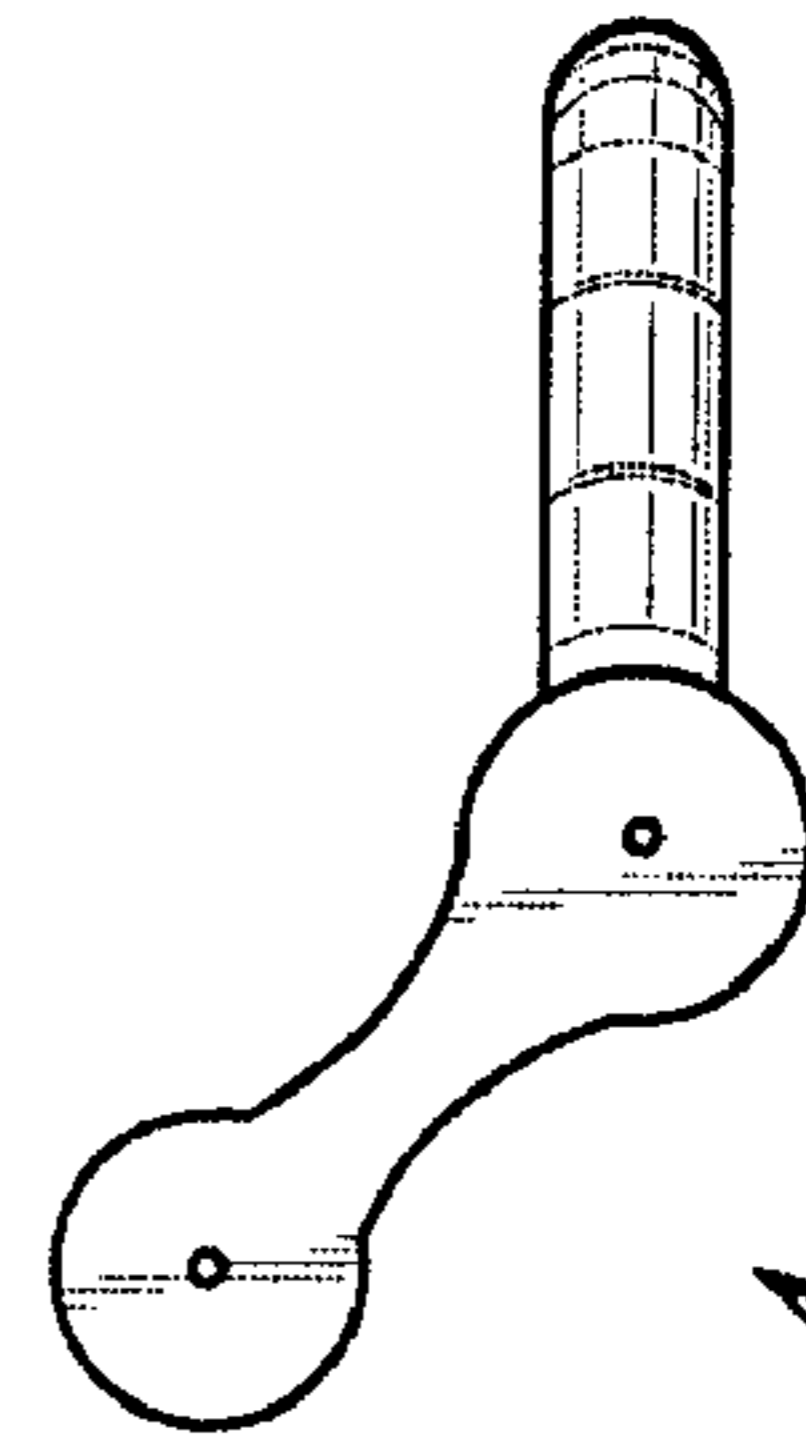

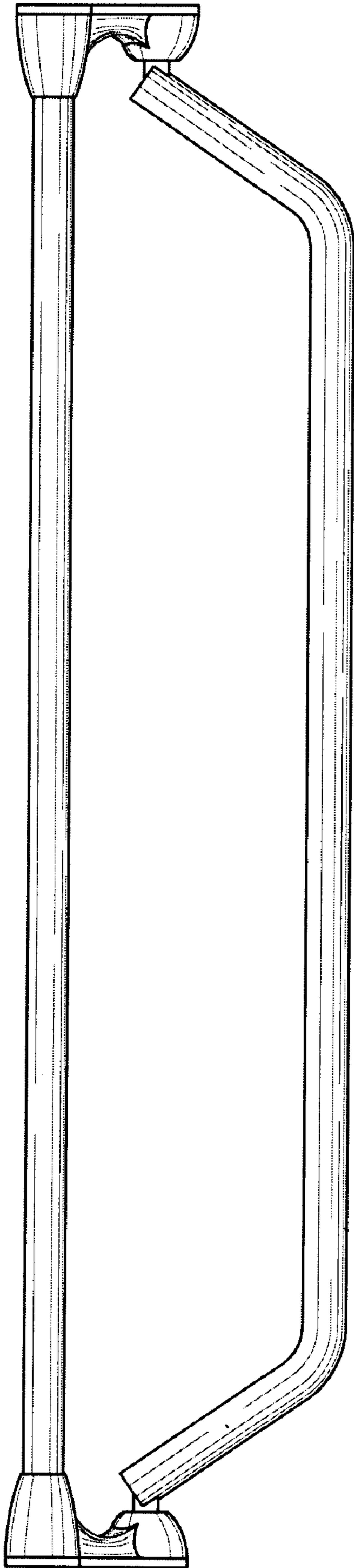

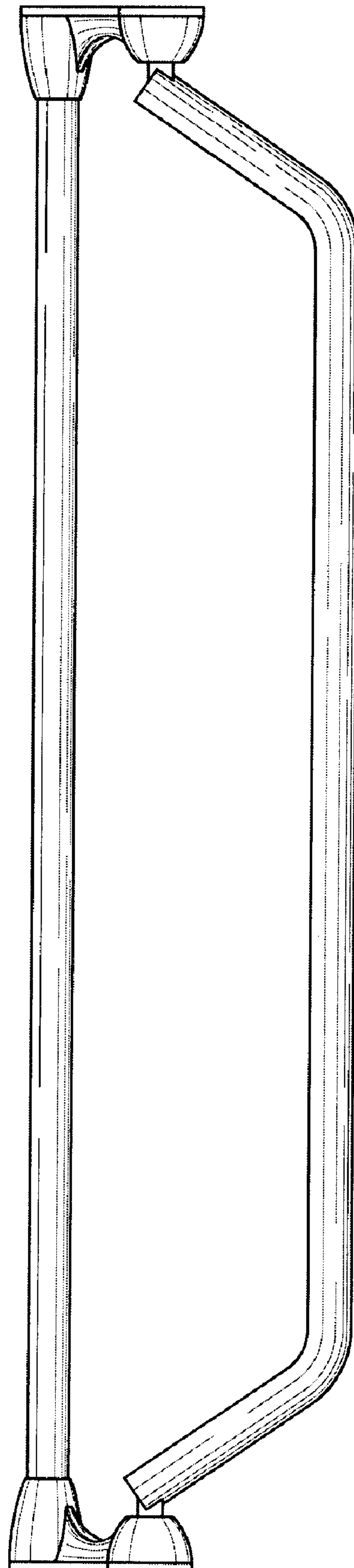
