**DESCRIPTION**

FIG. 1 is a front perspective view of the swing hitch showing my new design;

FIG. 2 is a front perspective view thereof, in its attached position;

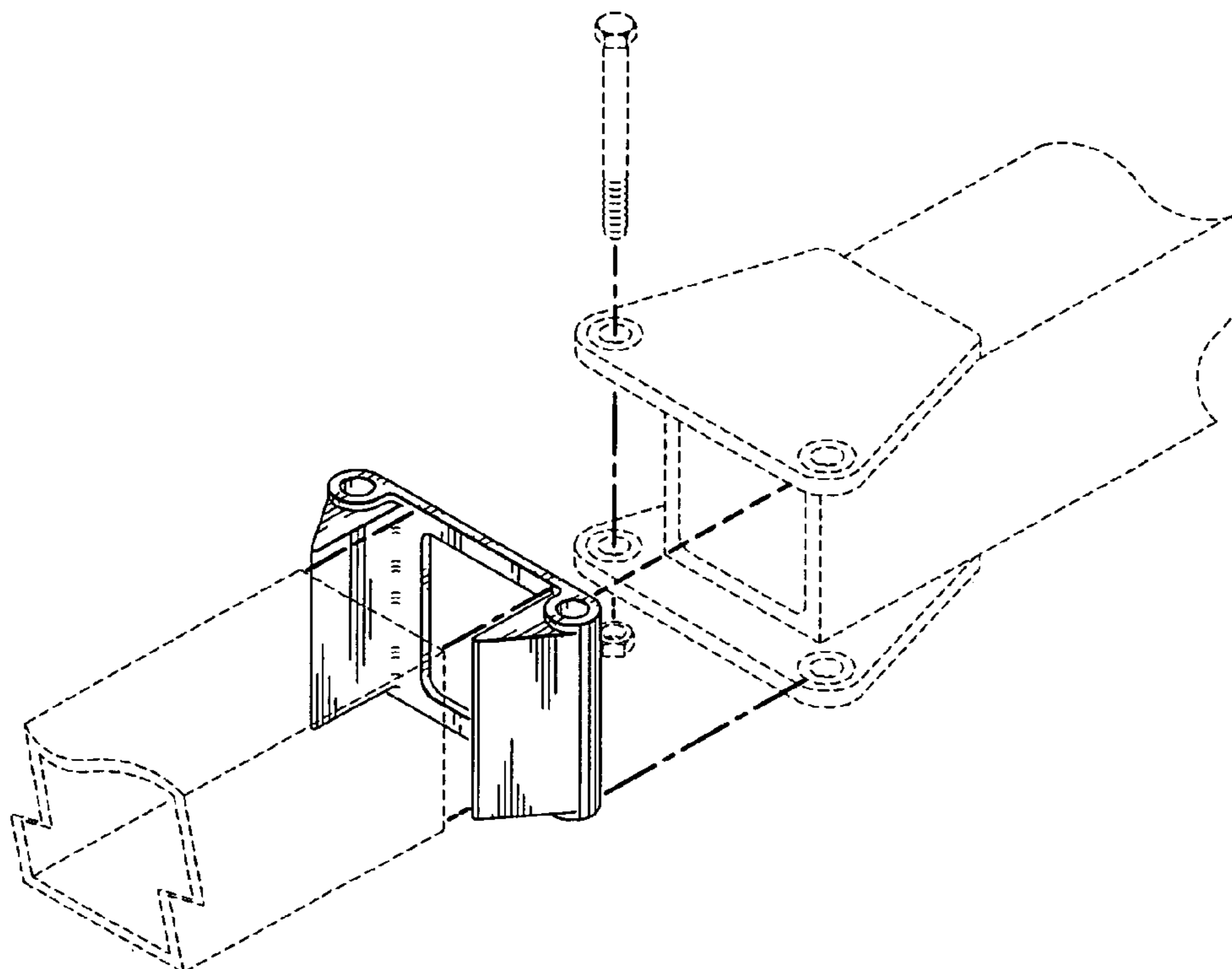
FIG. 3 is a top plan view thereof;

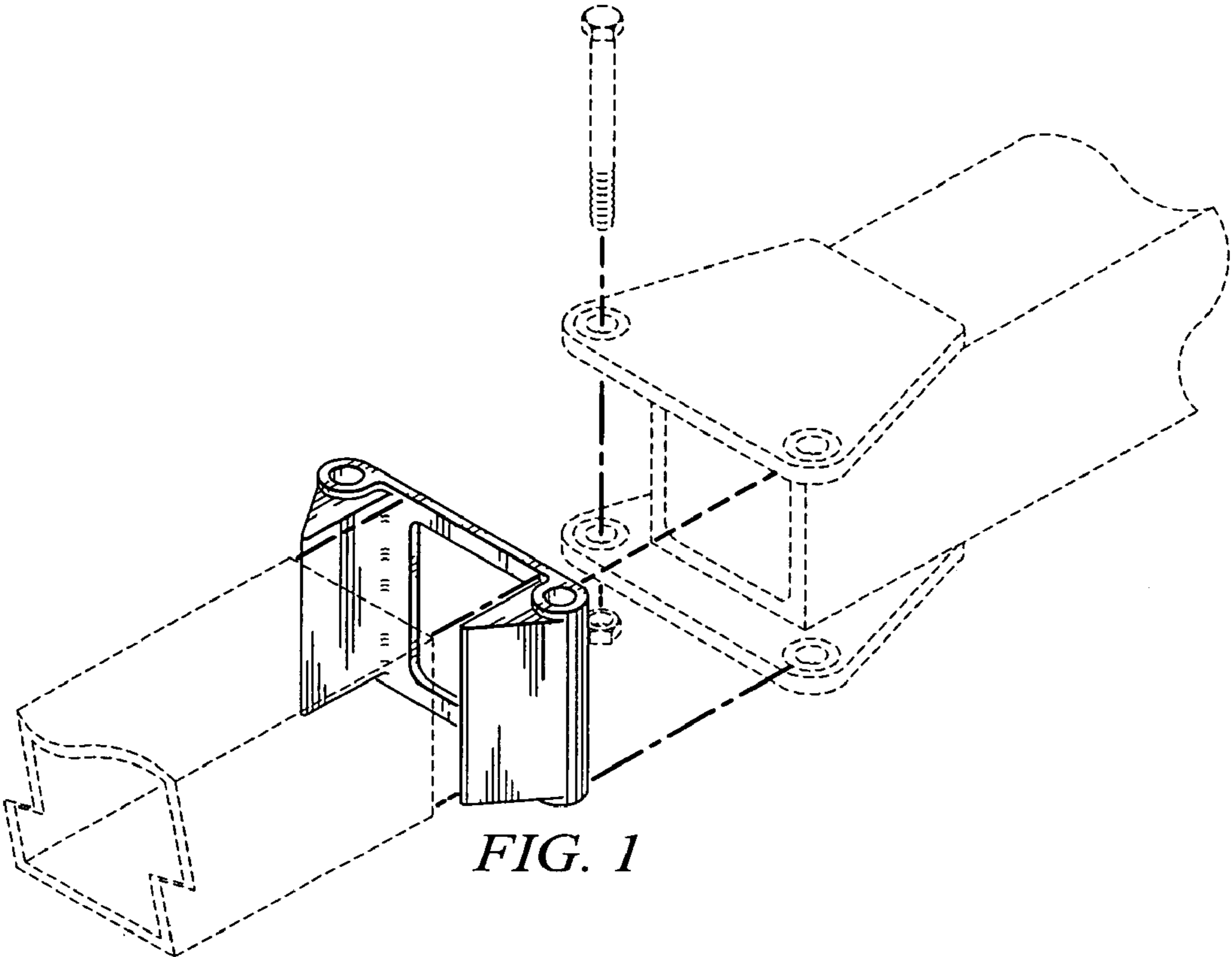

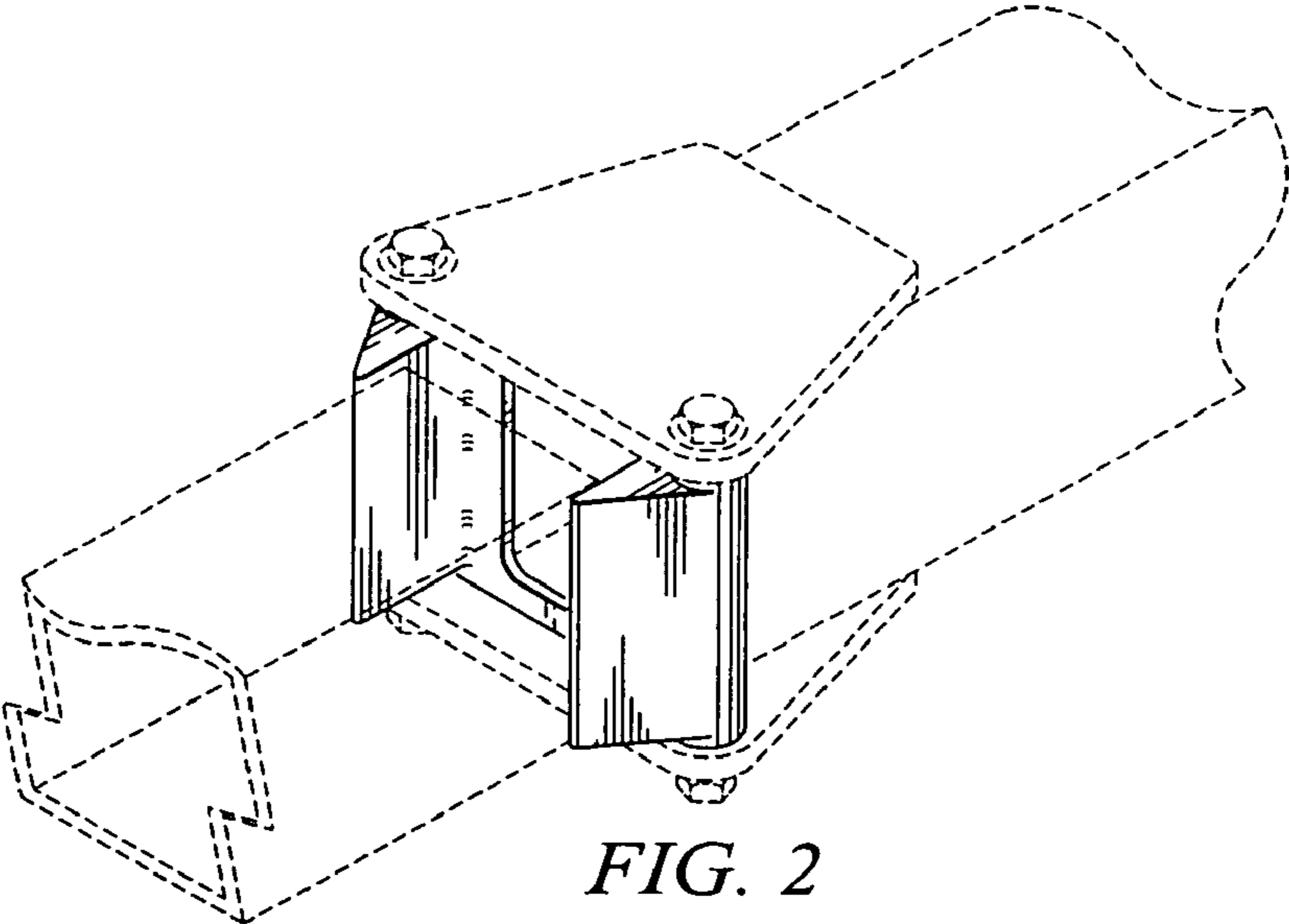
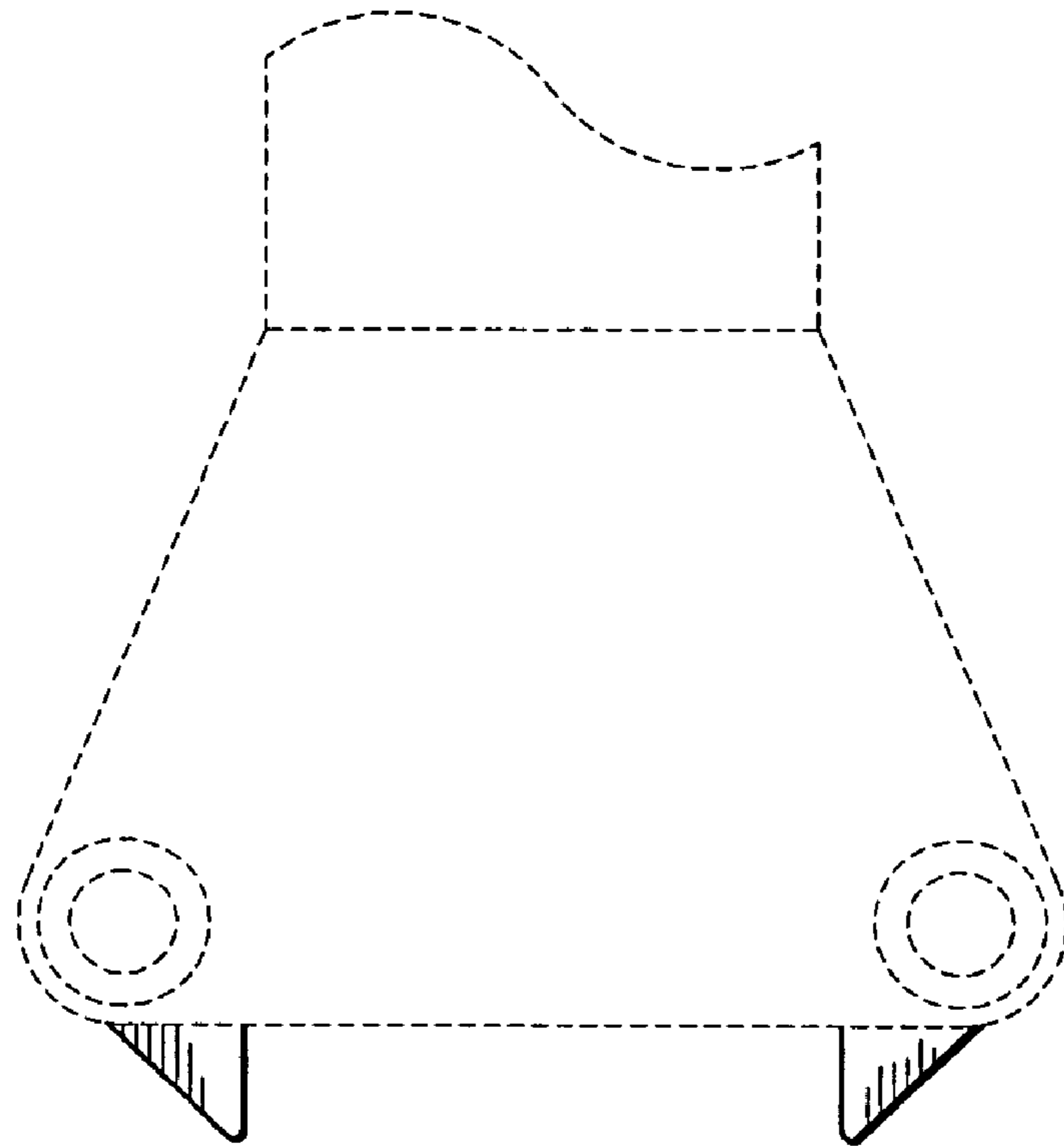
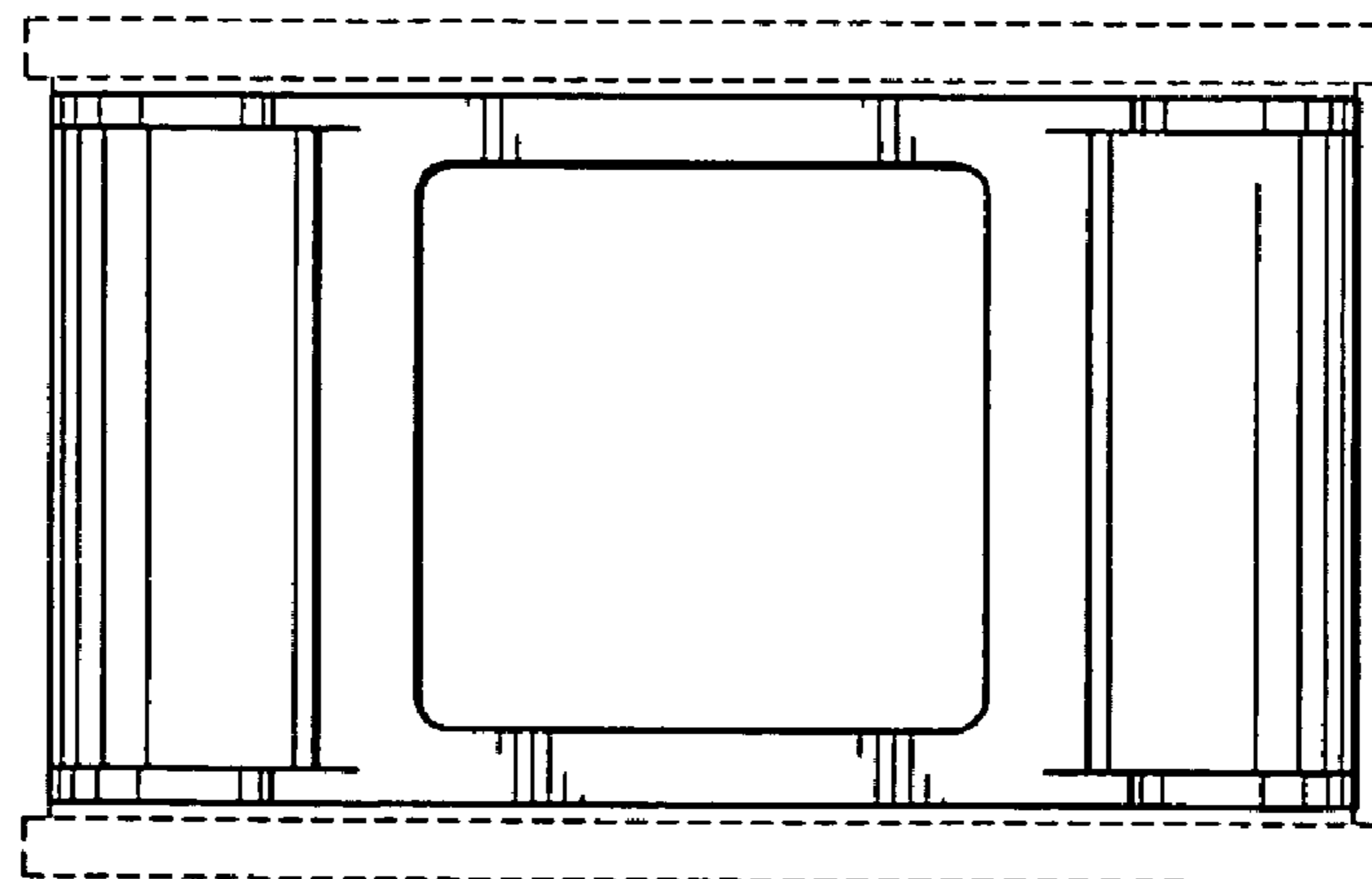


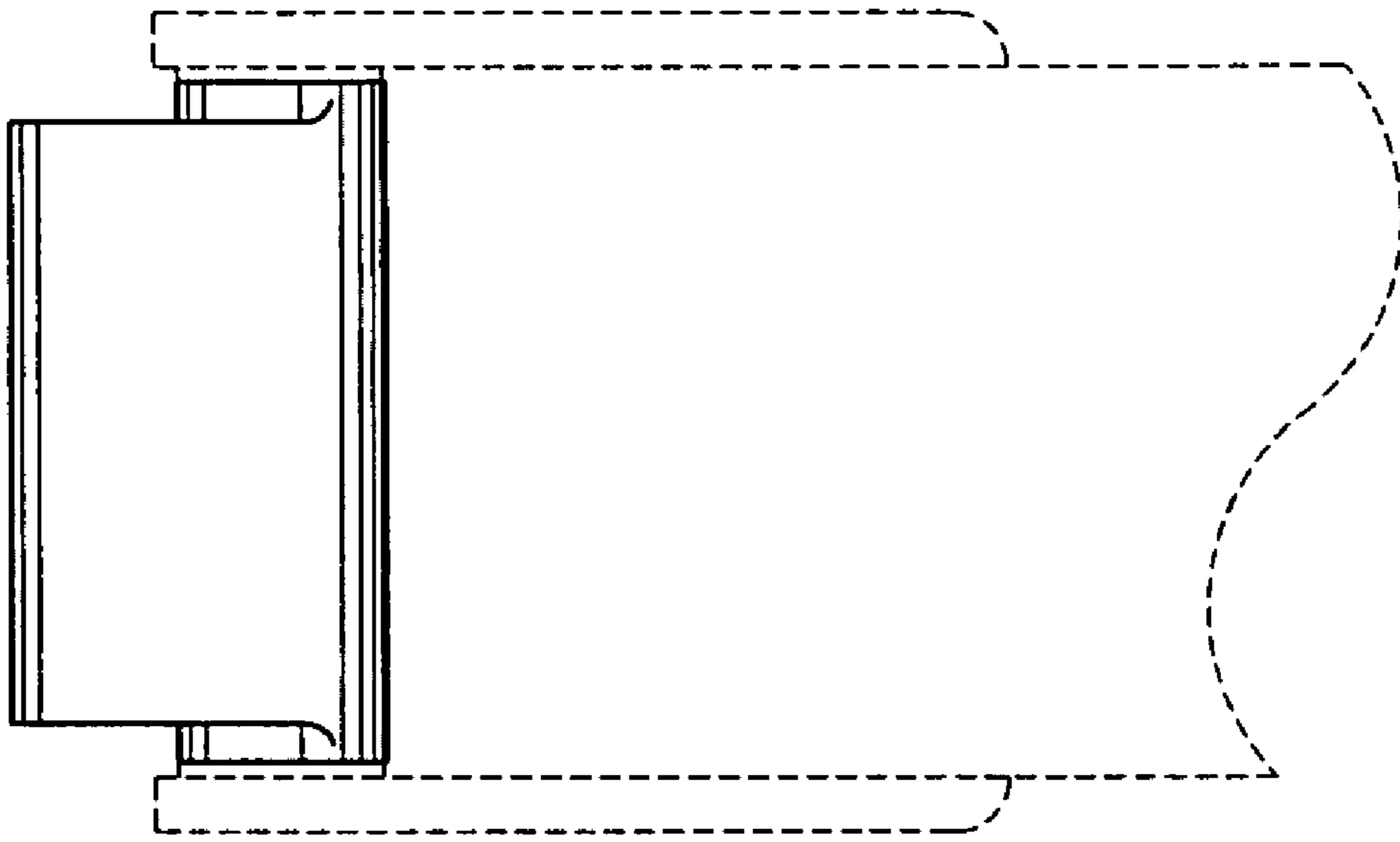

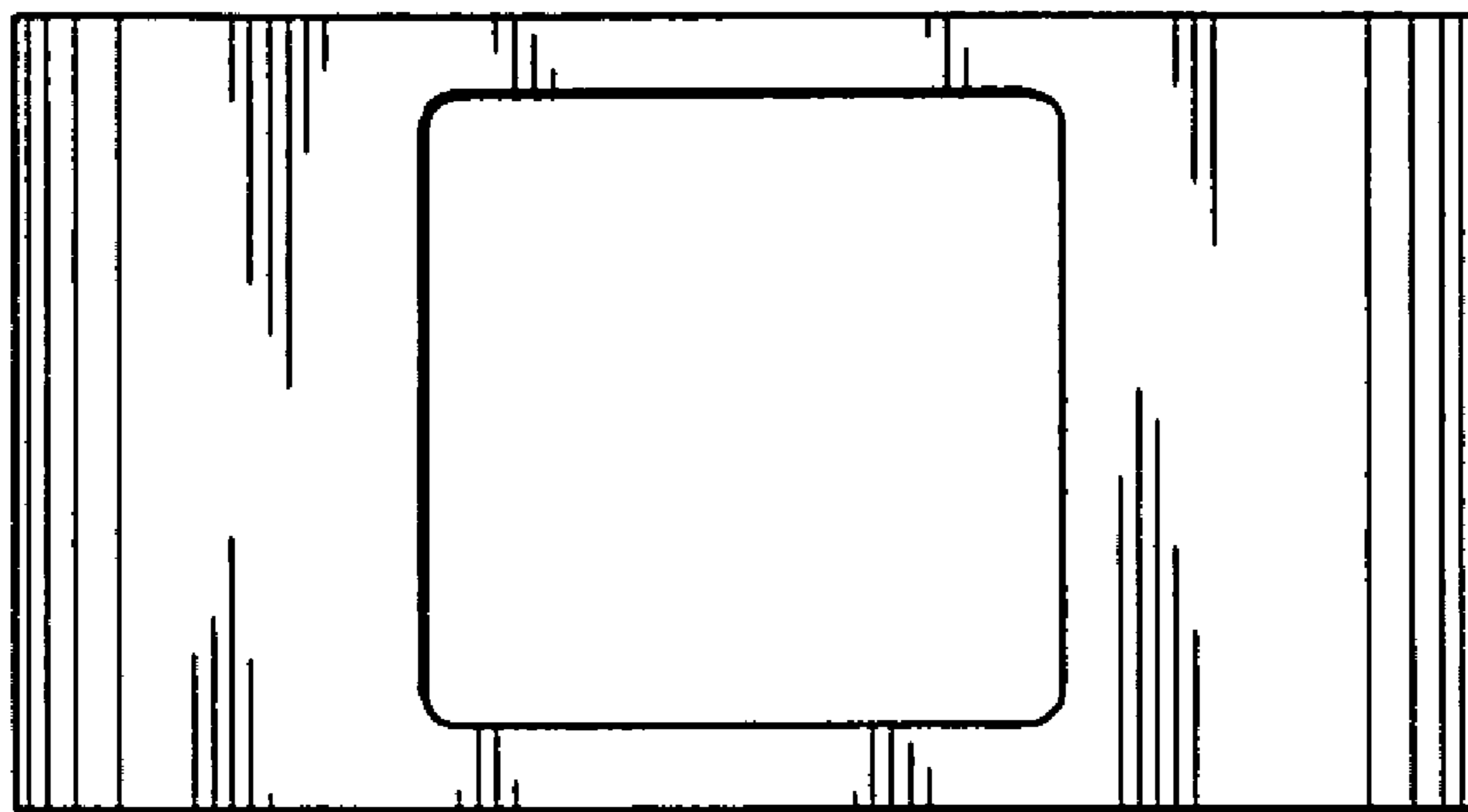
