FIG. 11 is a bottom view of the plug-in angled outlet cover of FIG. 7; and,

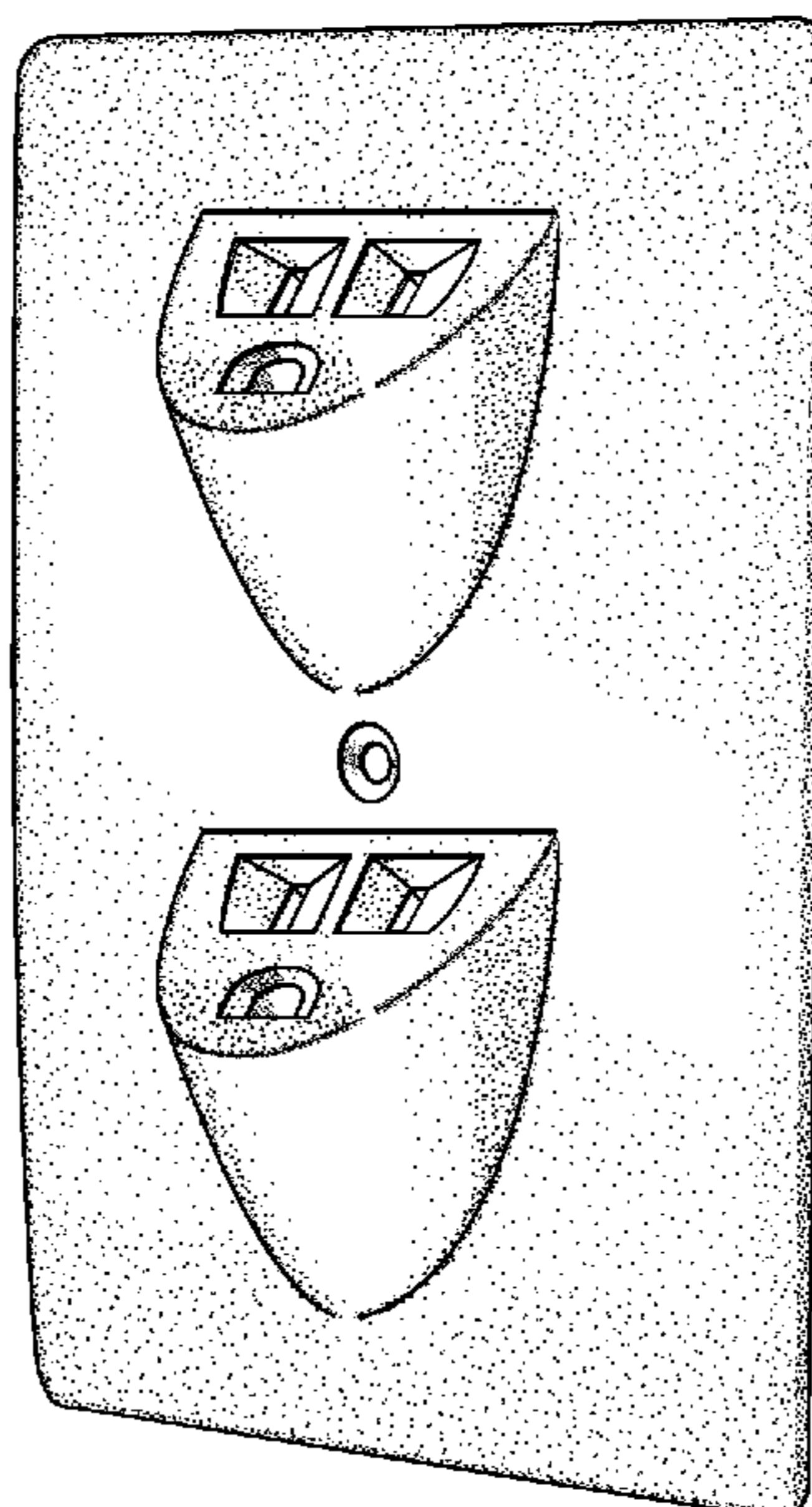
FIG. 12 is rear view of the plug-in angled outlet cover of FIG. 7.

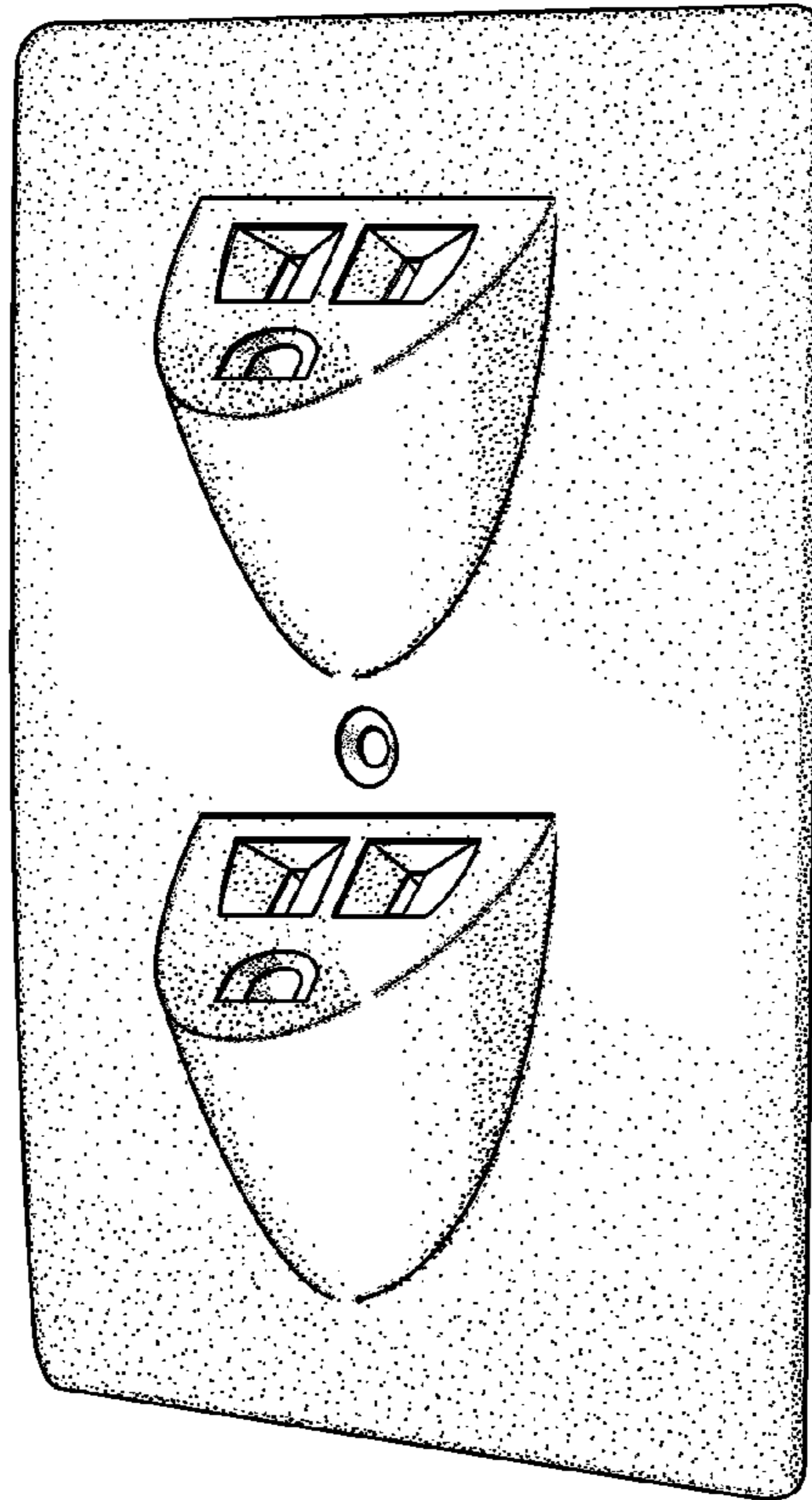

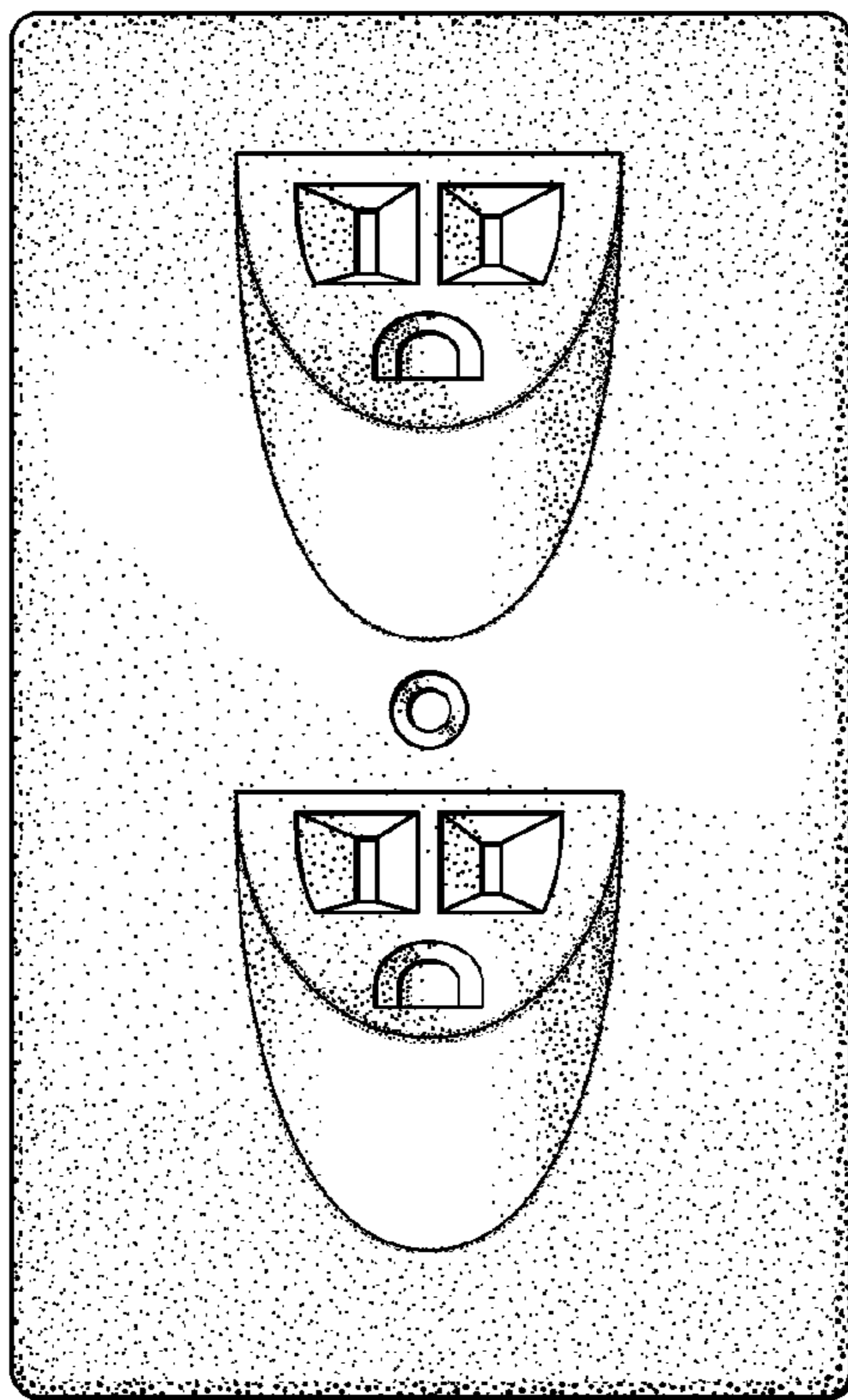

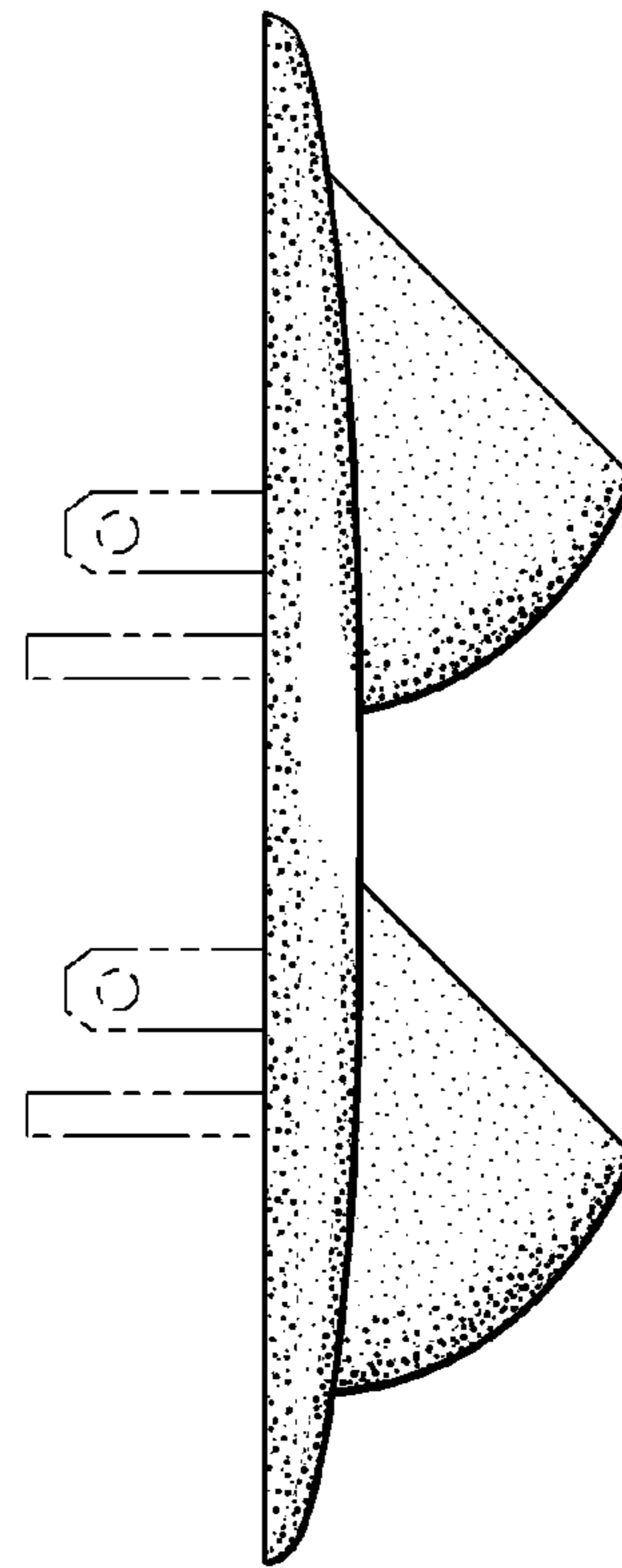

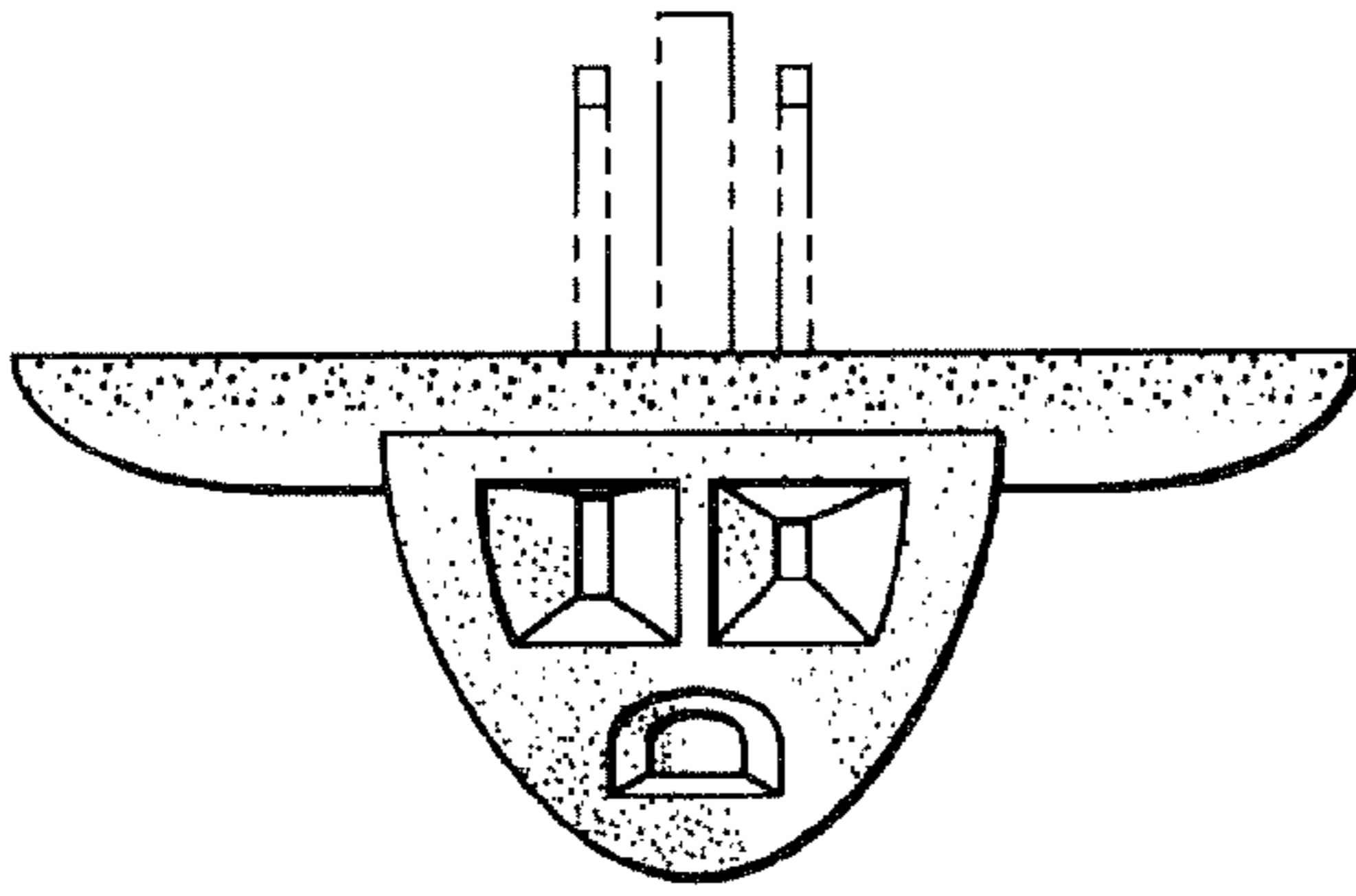

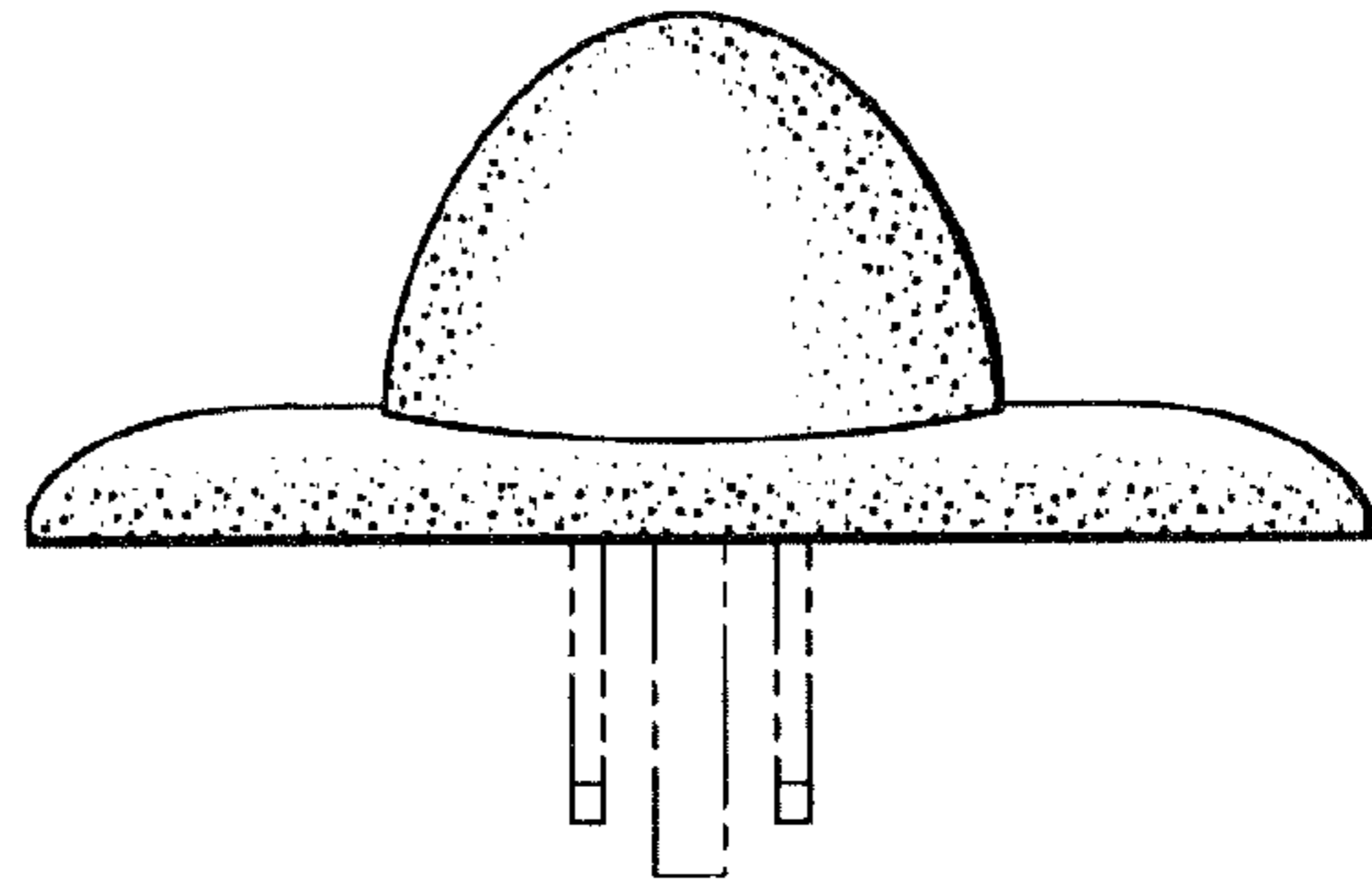

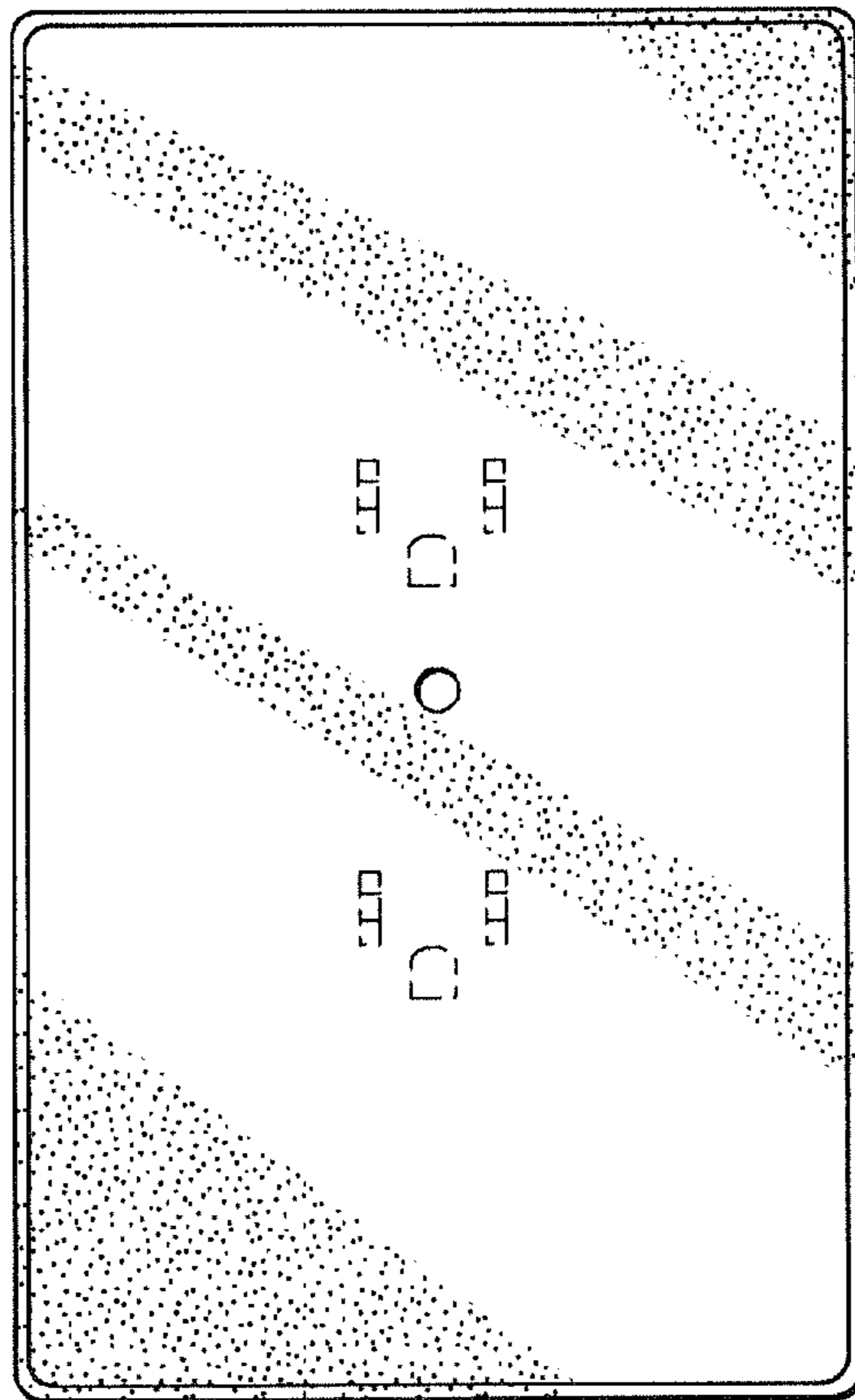

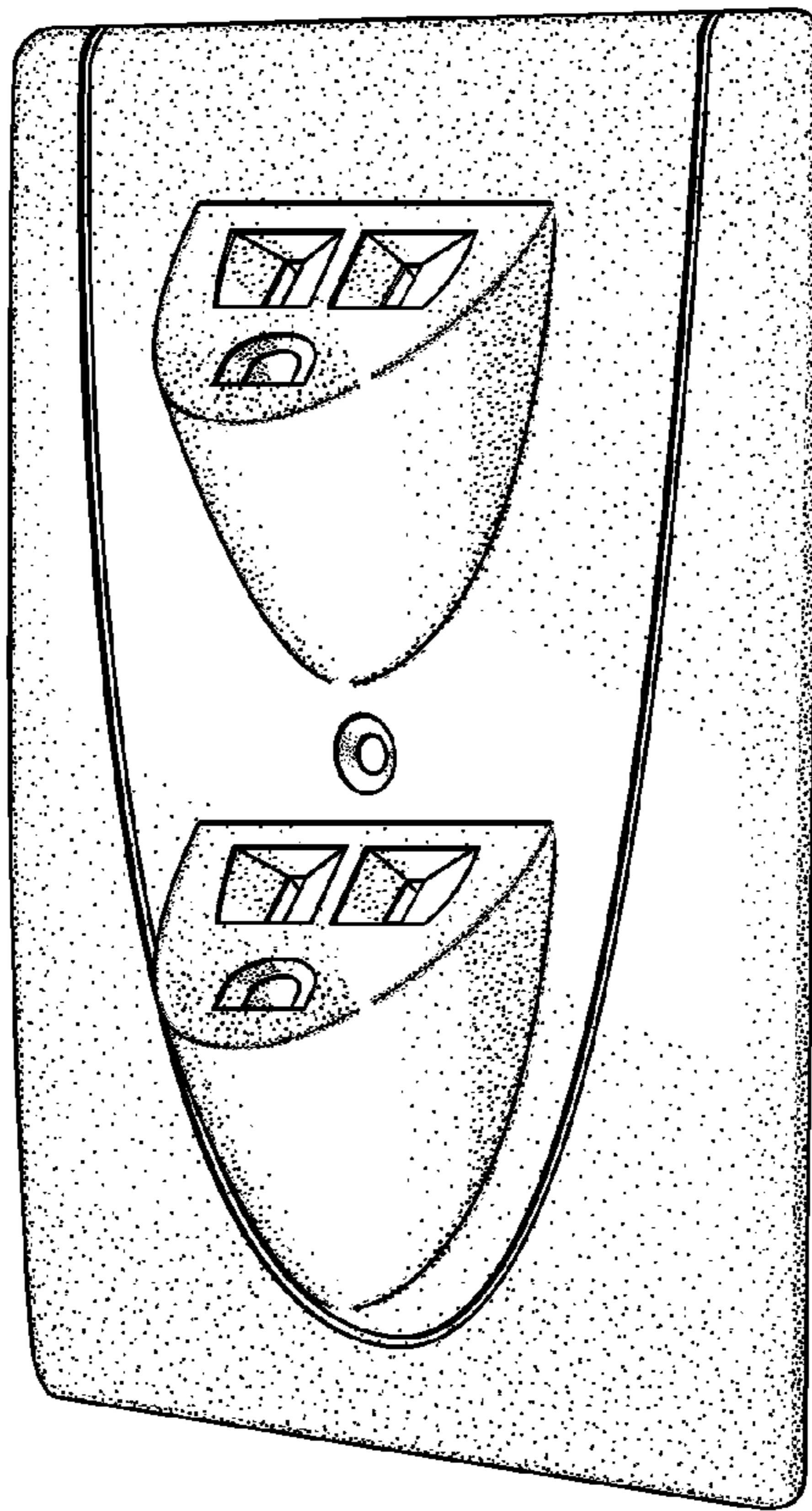

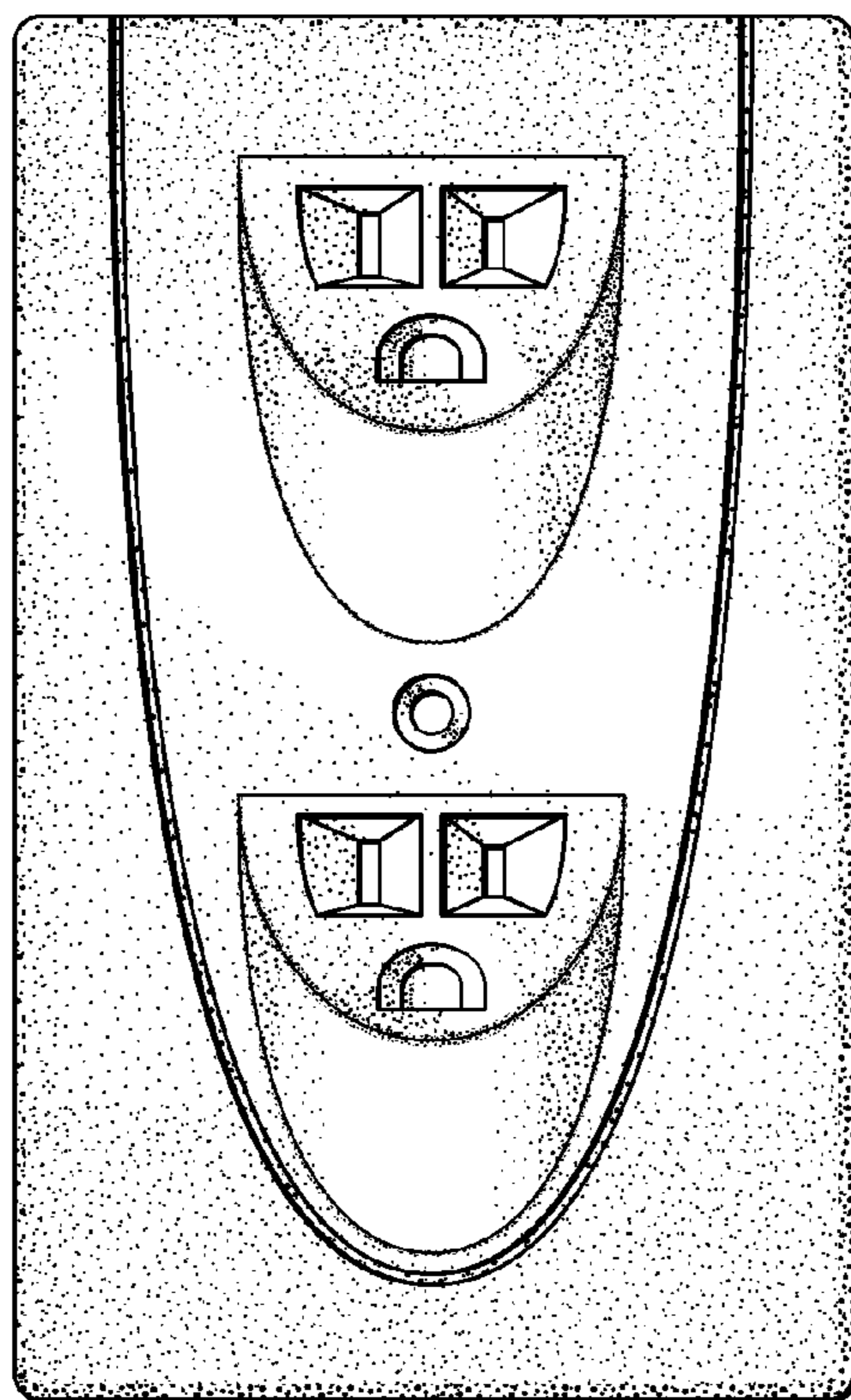

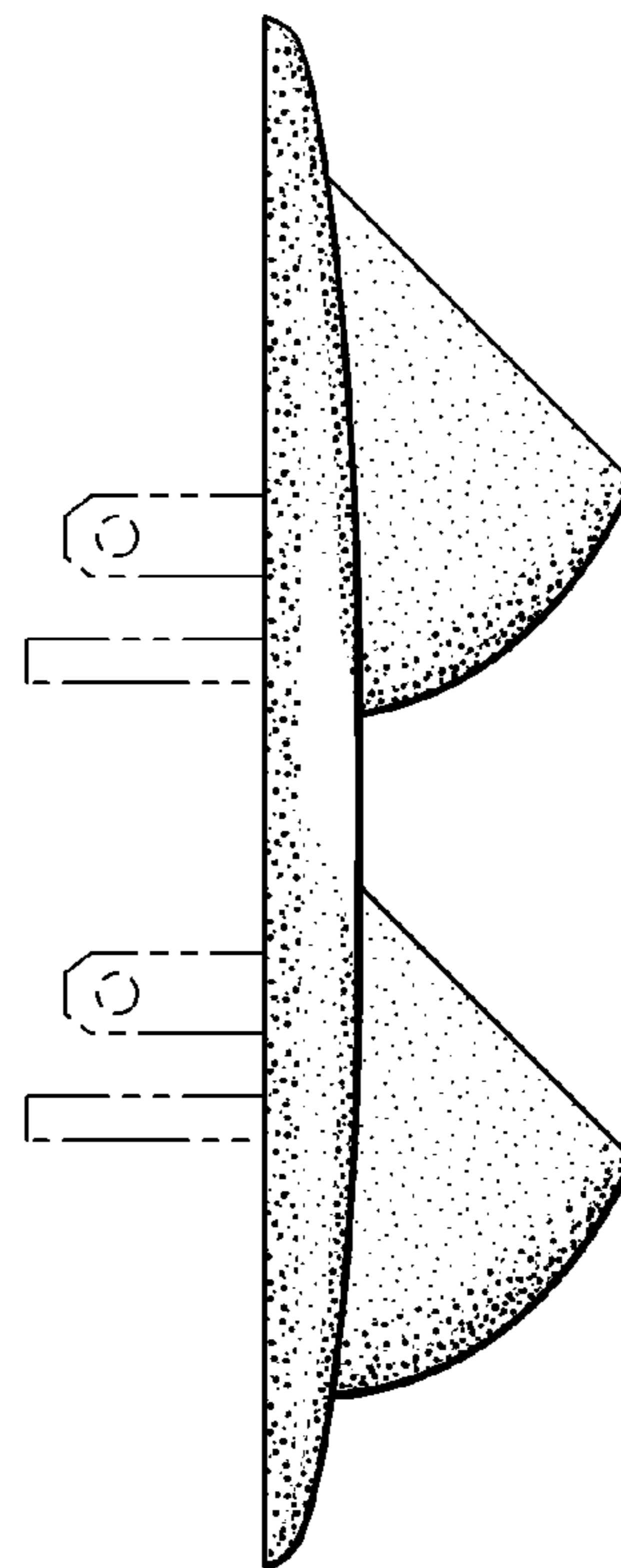

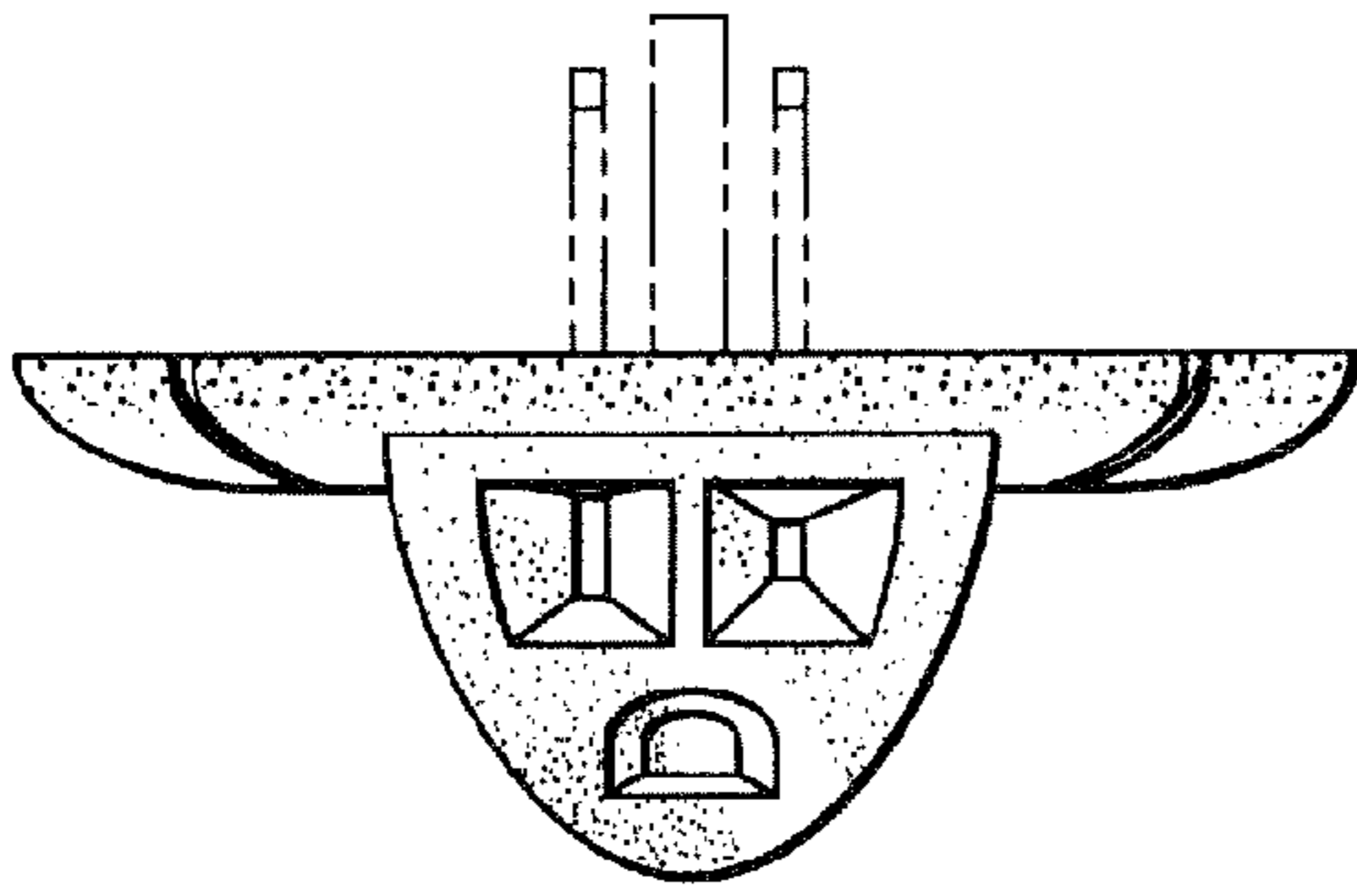

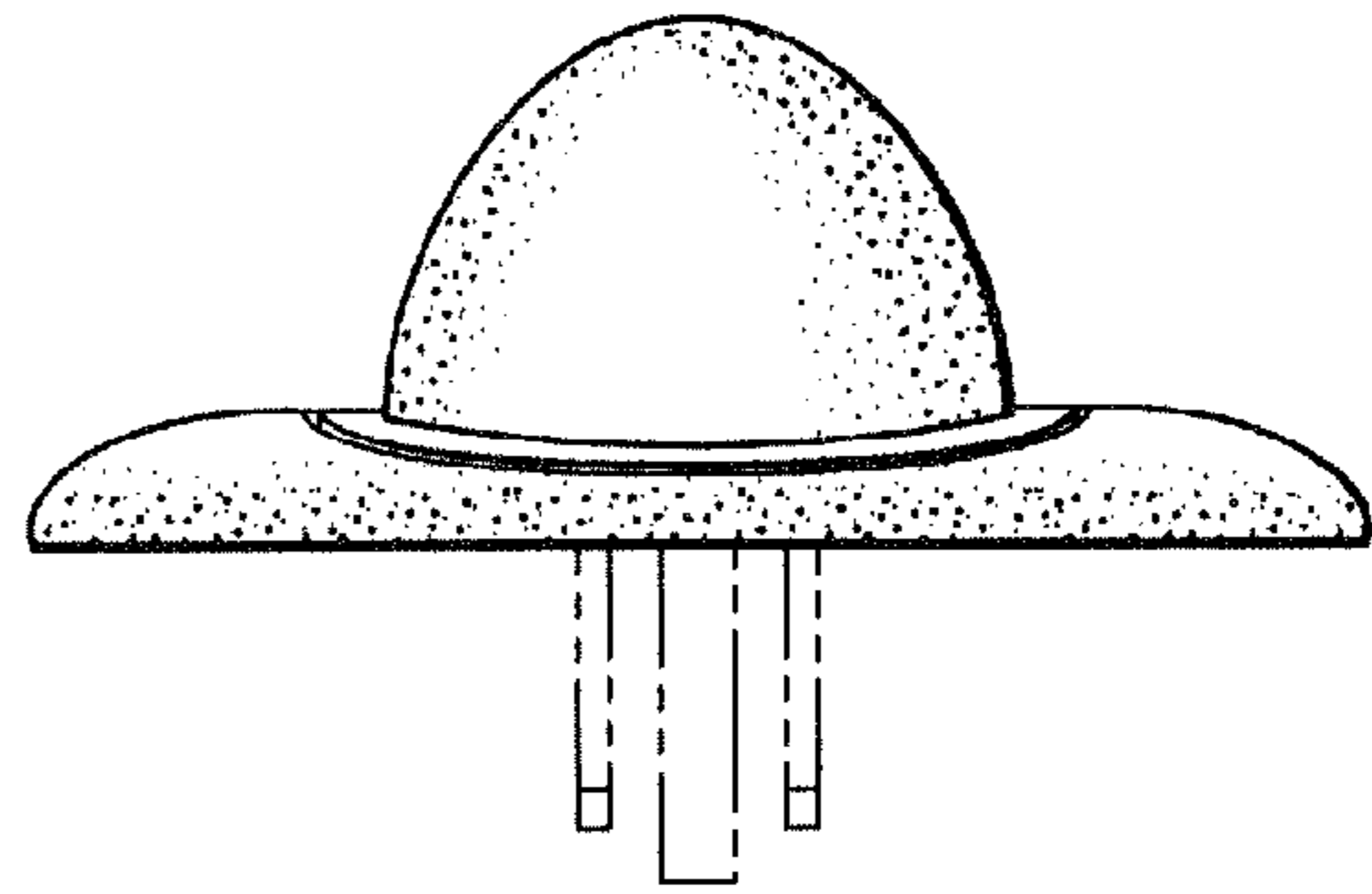

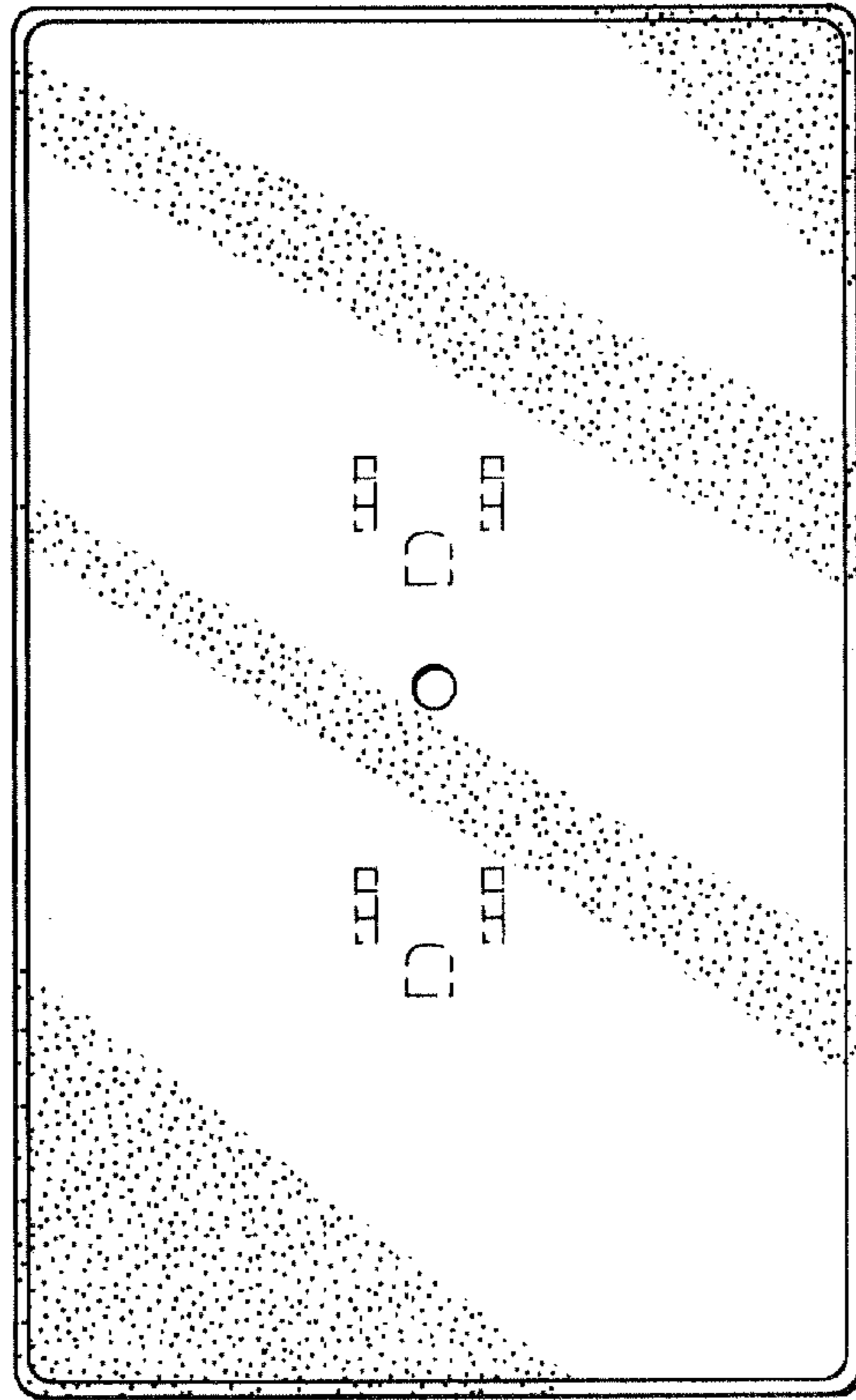
