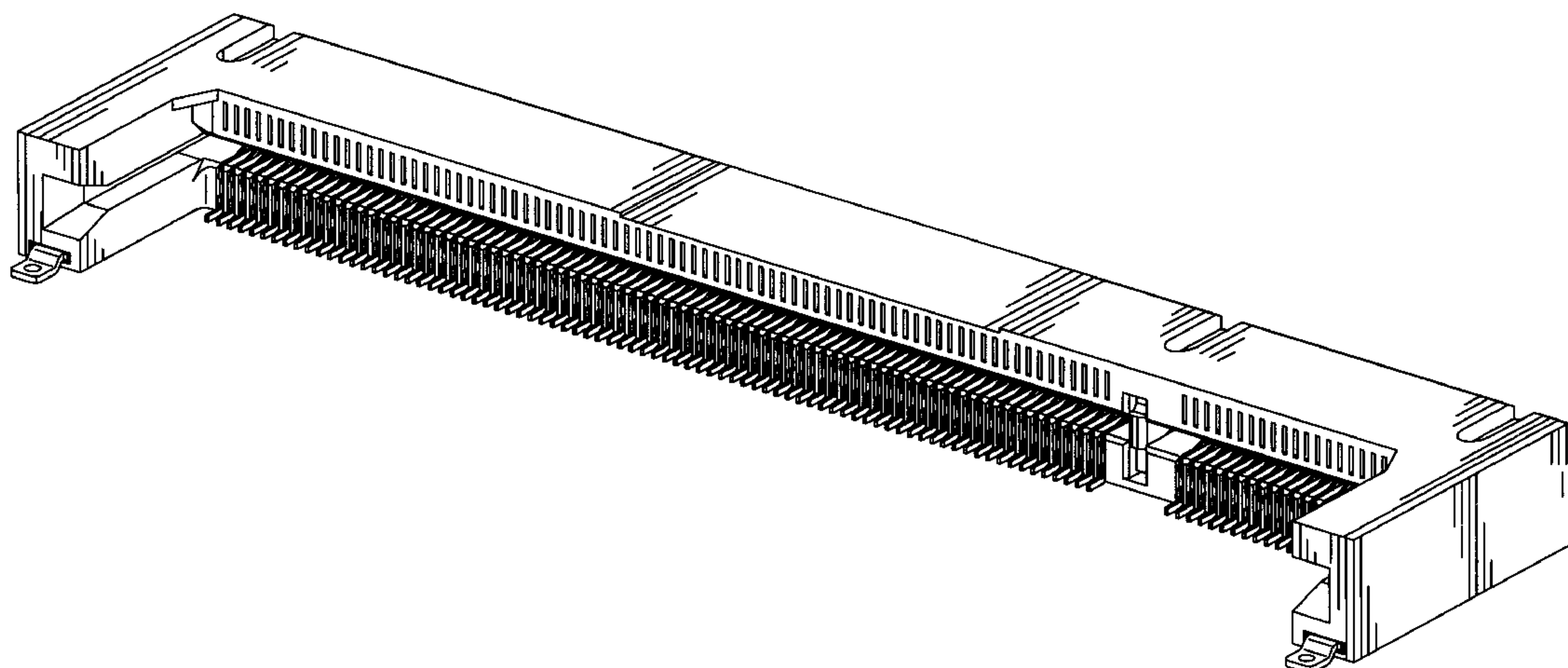
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front side perspective view of a first embodiment of an electrical connector showing my new design;

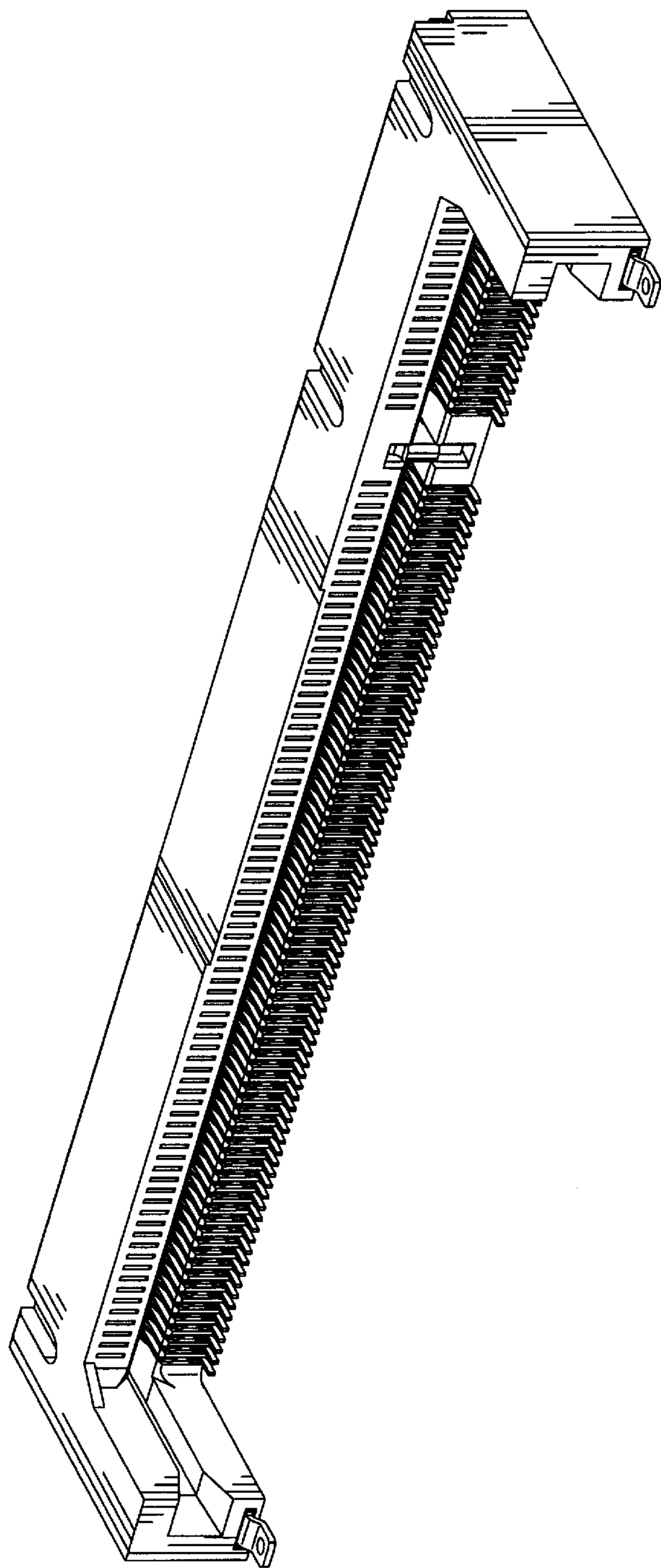

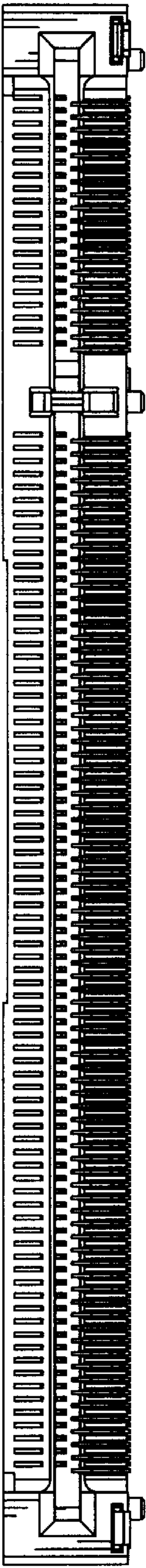

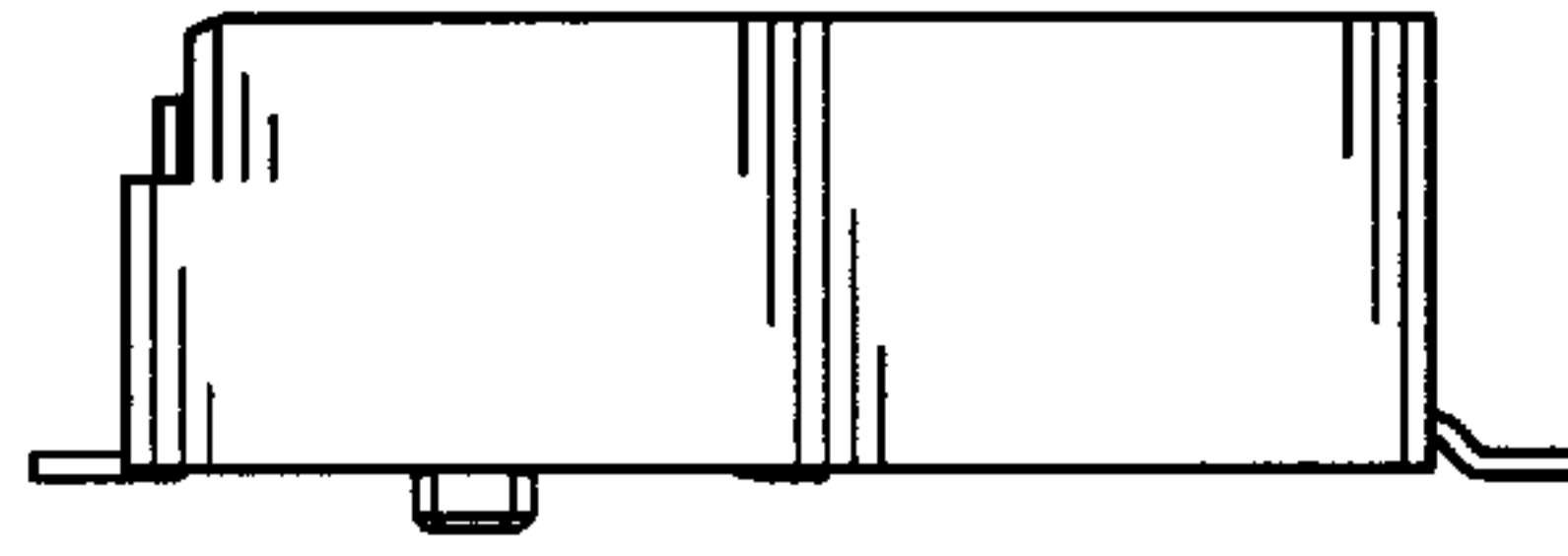

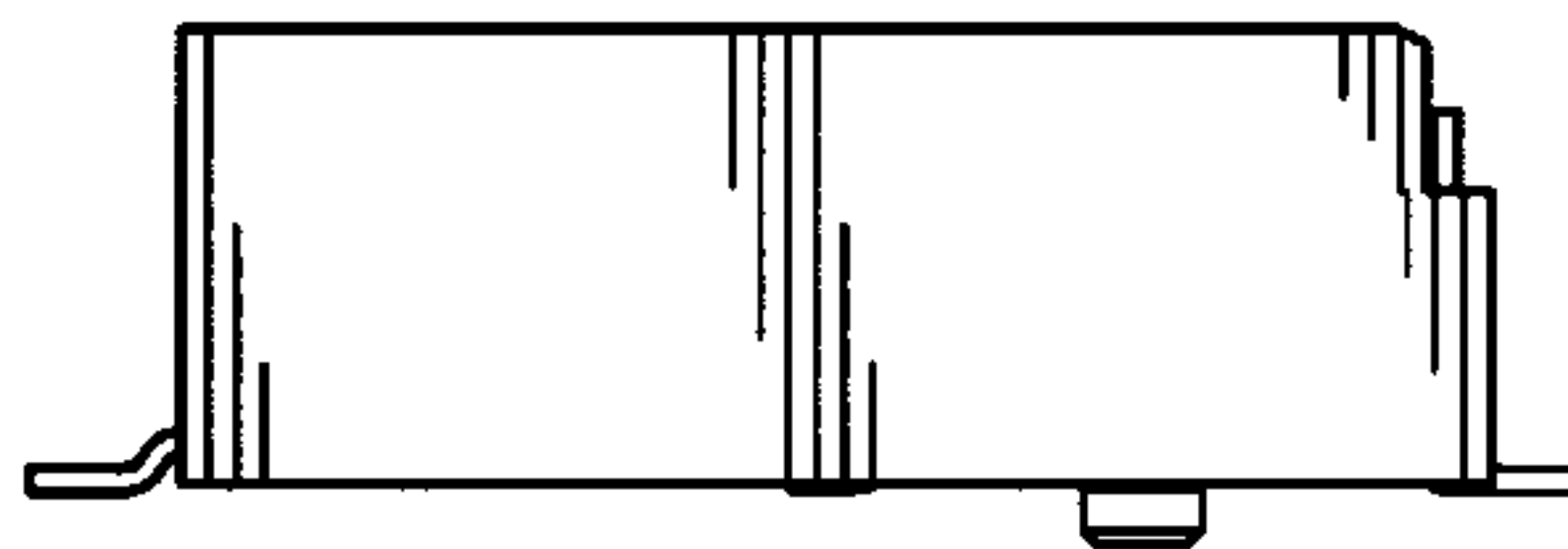

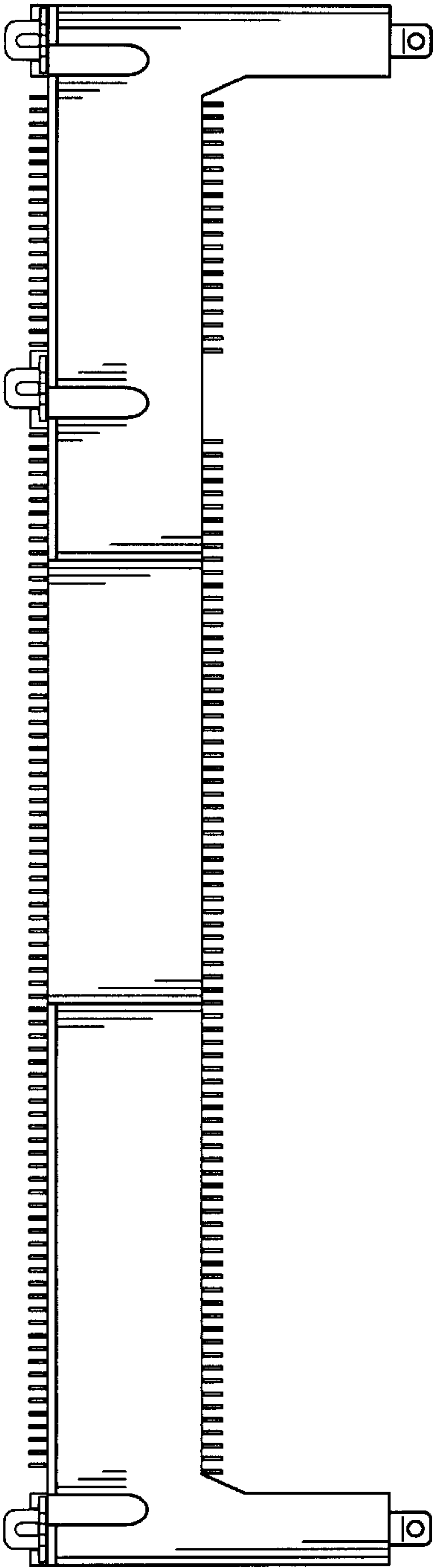

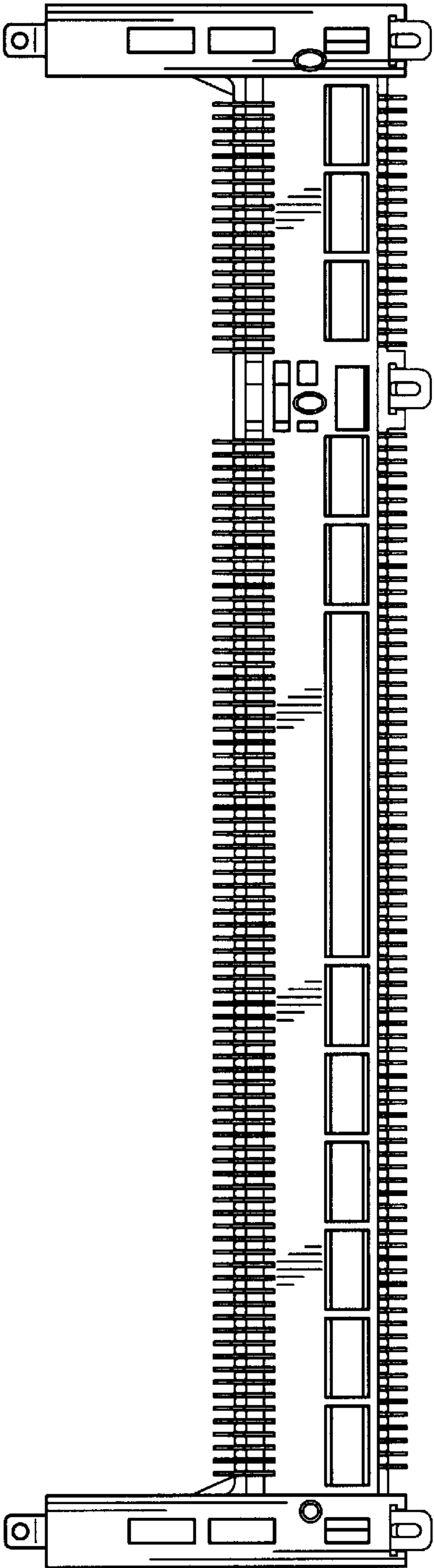

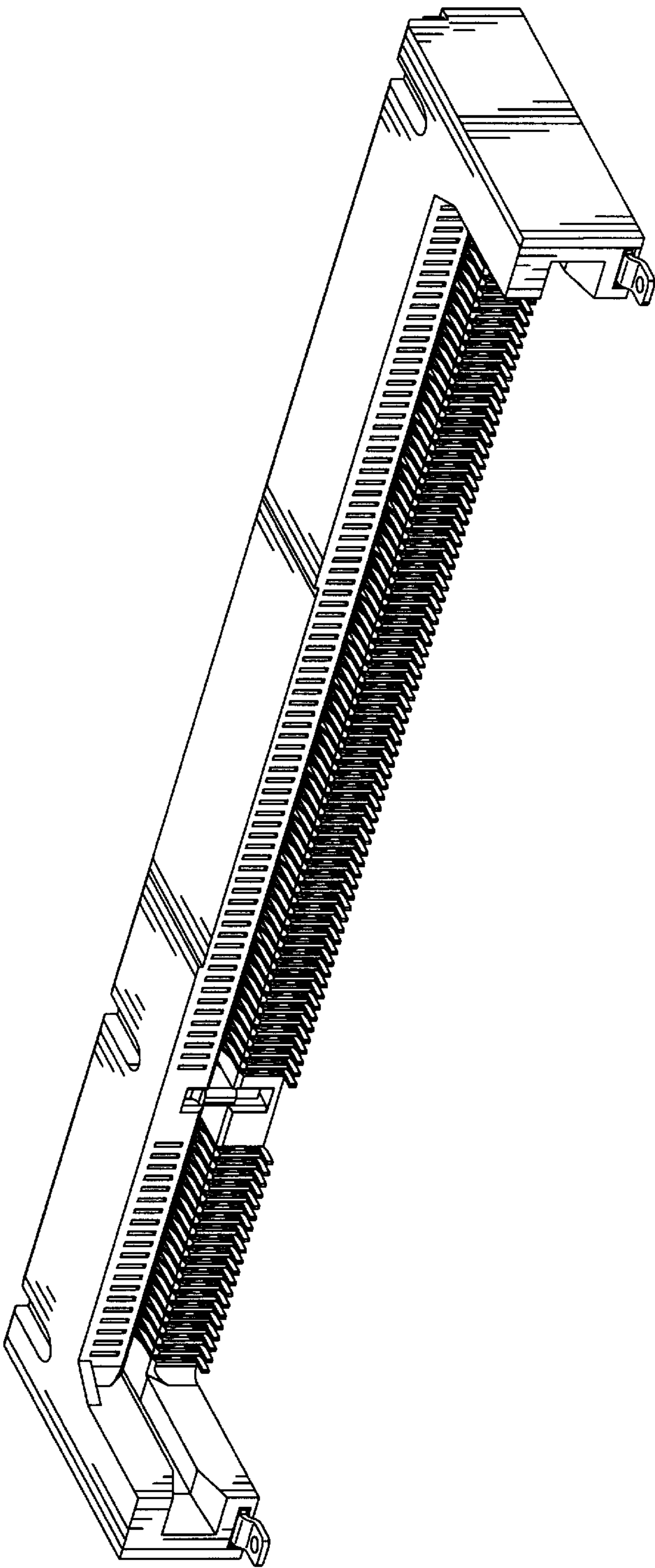

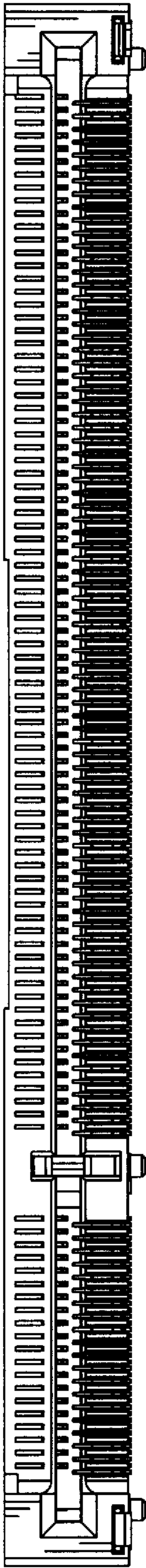

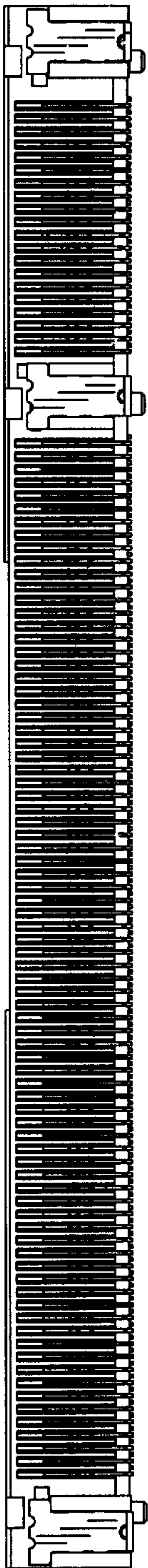

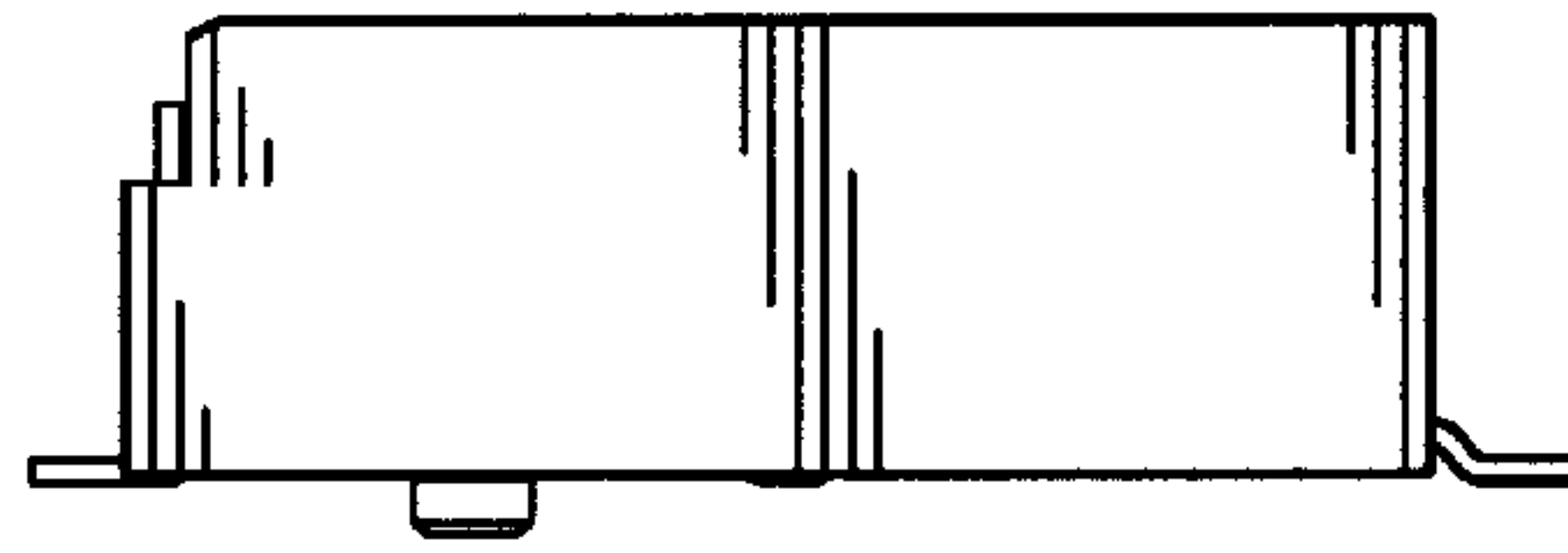

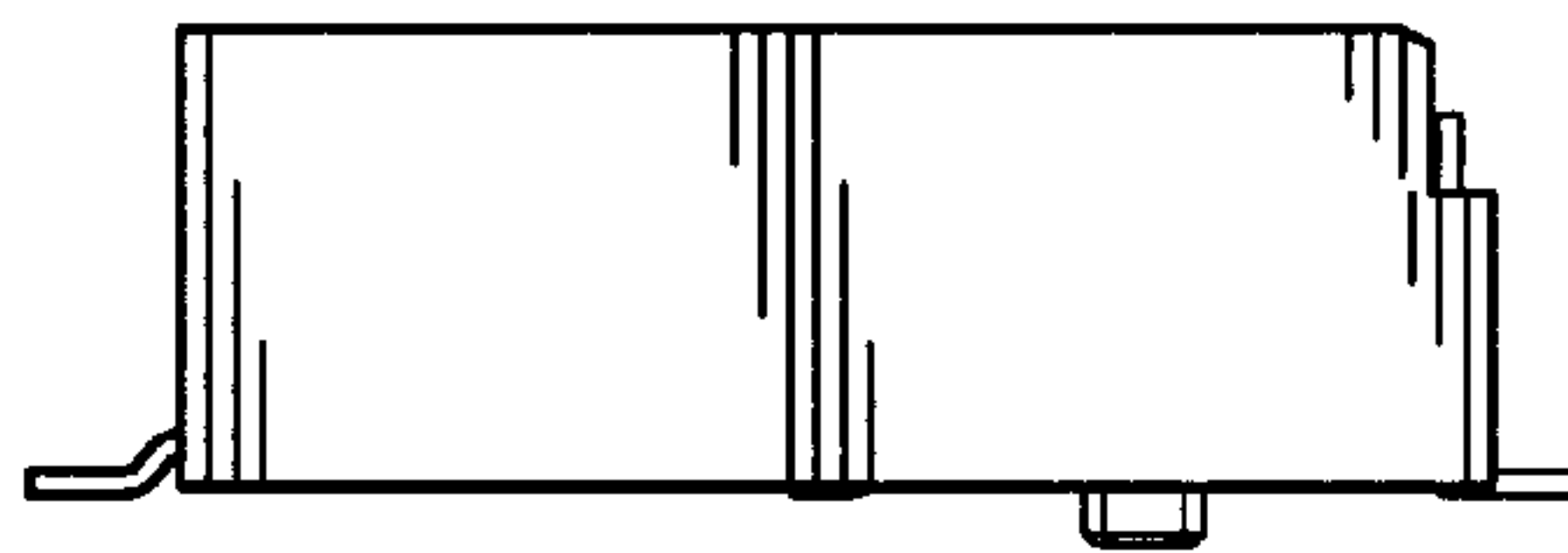

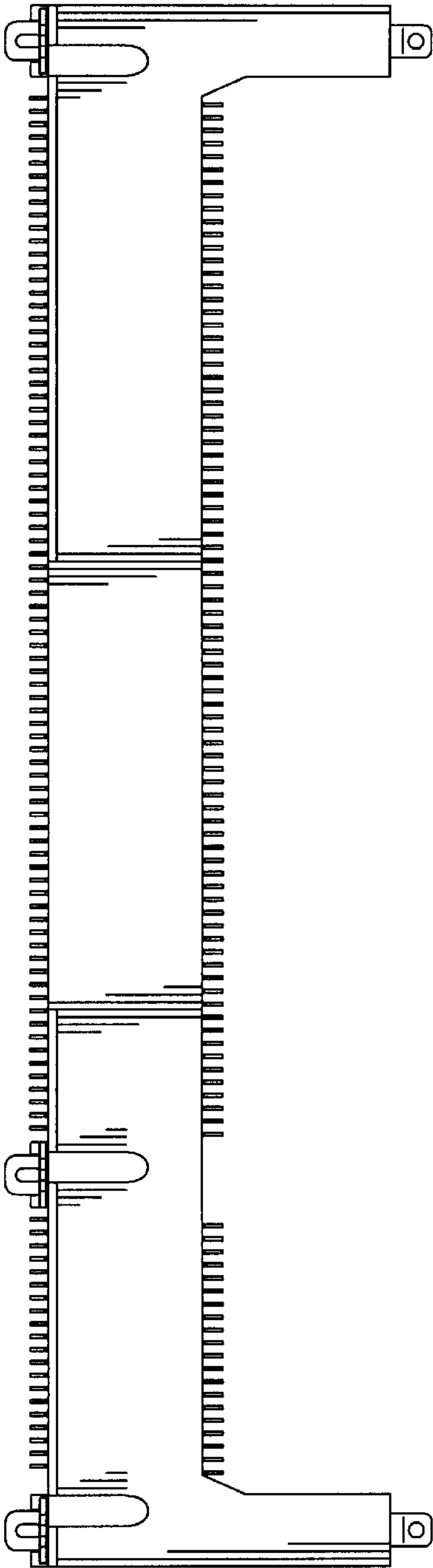

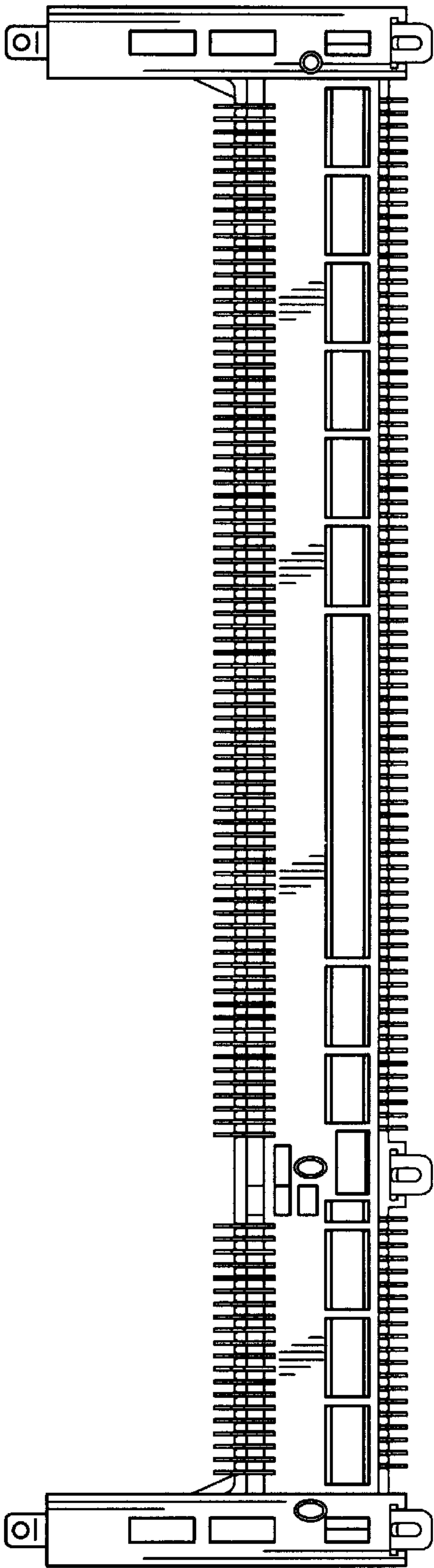
