(57) **CLAIM**

The ornamental design for a refrigerator, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a refrigerator according to the invention.

FIG. 2 is a front elevational view thereof according to the invention.

FIG. 3 is a rear elevational view thereof according to the invention.

FIG. 4 is a right side view thereof according to the invention, the left side view being a mirror image.

FIG. 5 is a top plan view thereof according to the invention.

FIG. 6 is a bottom plan view thereof according to the invention; and,

FIG. 7 is a perspective view of the design showing the doors in an open position according to the invention.

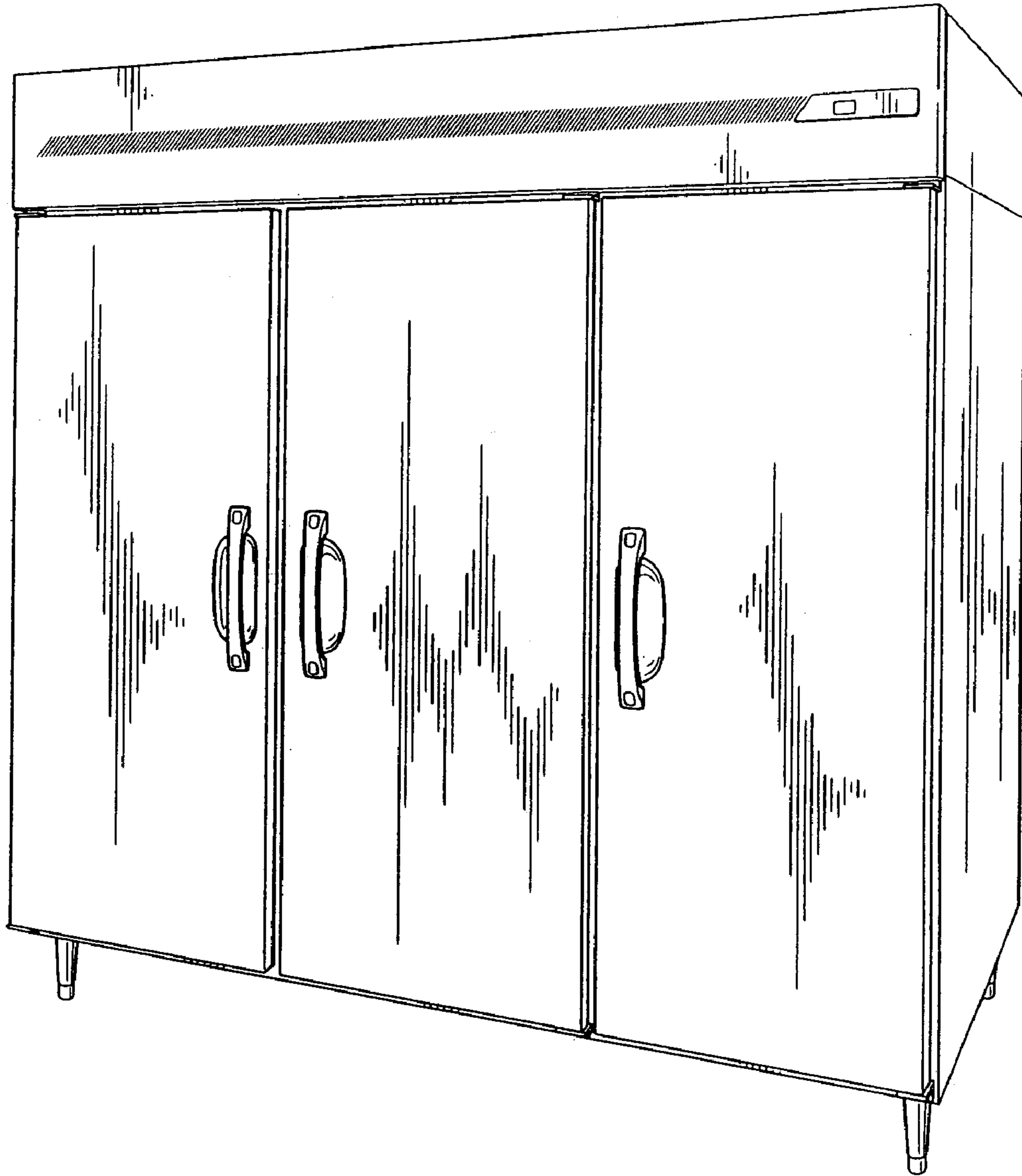

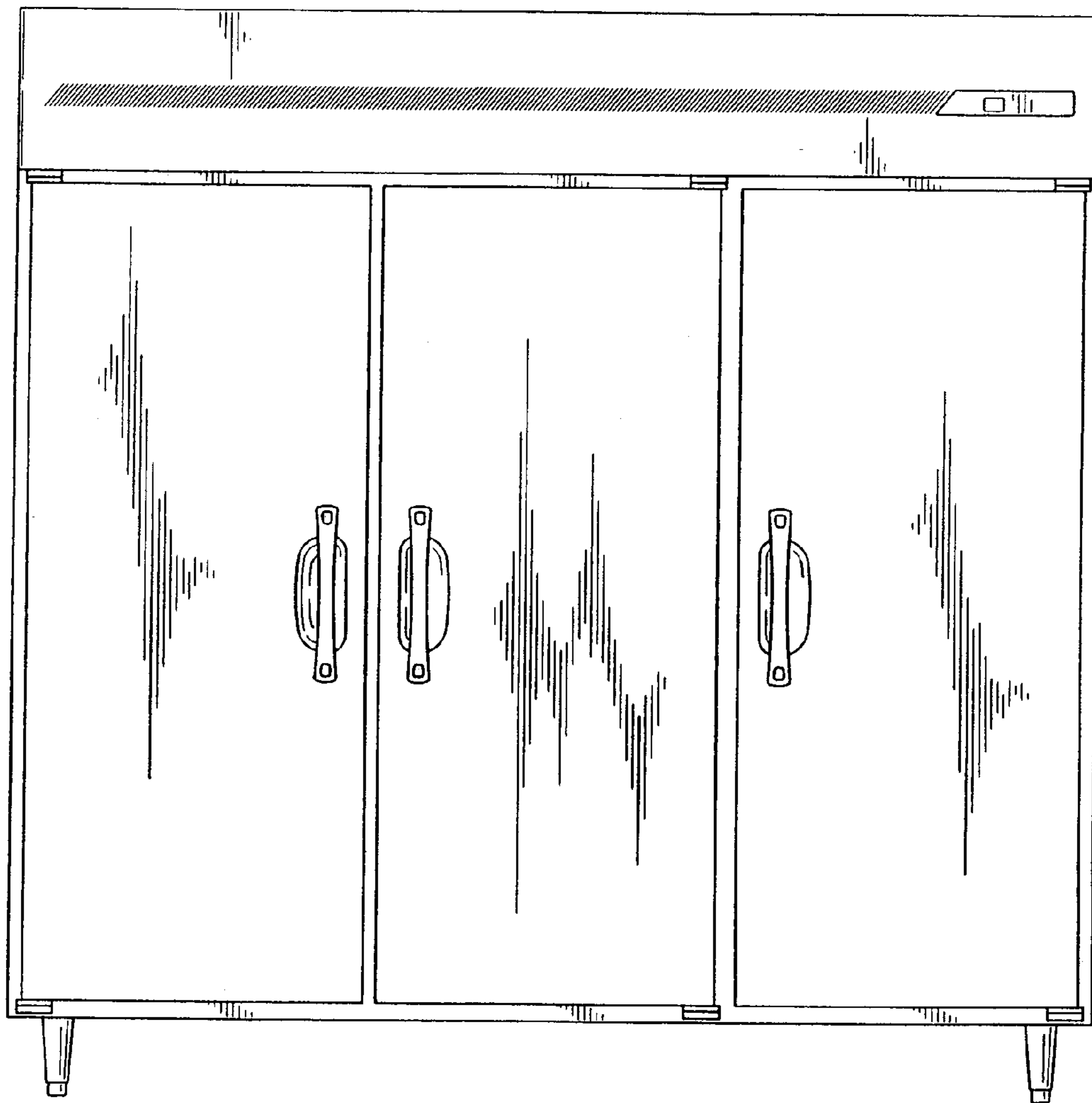

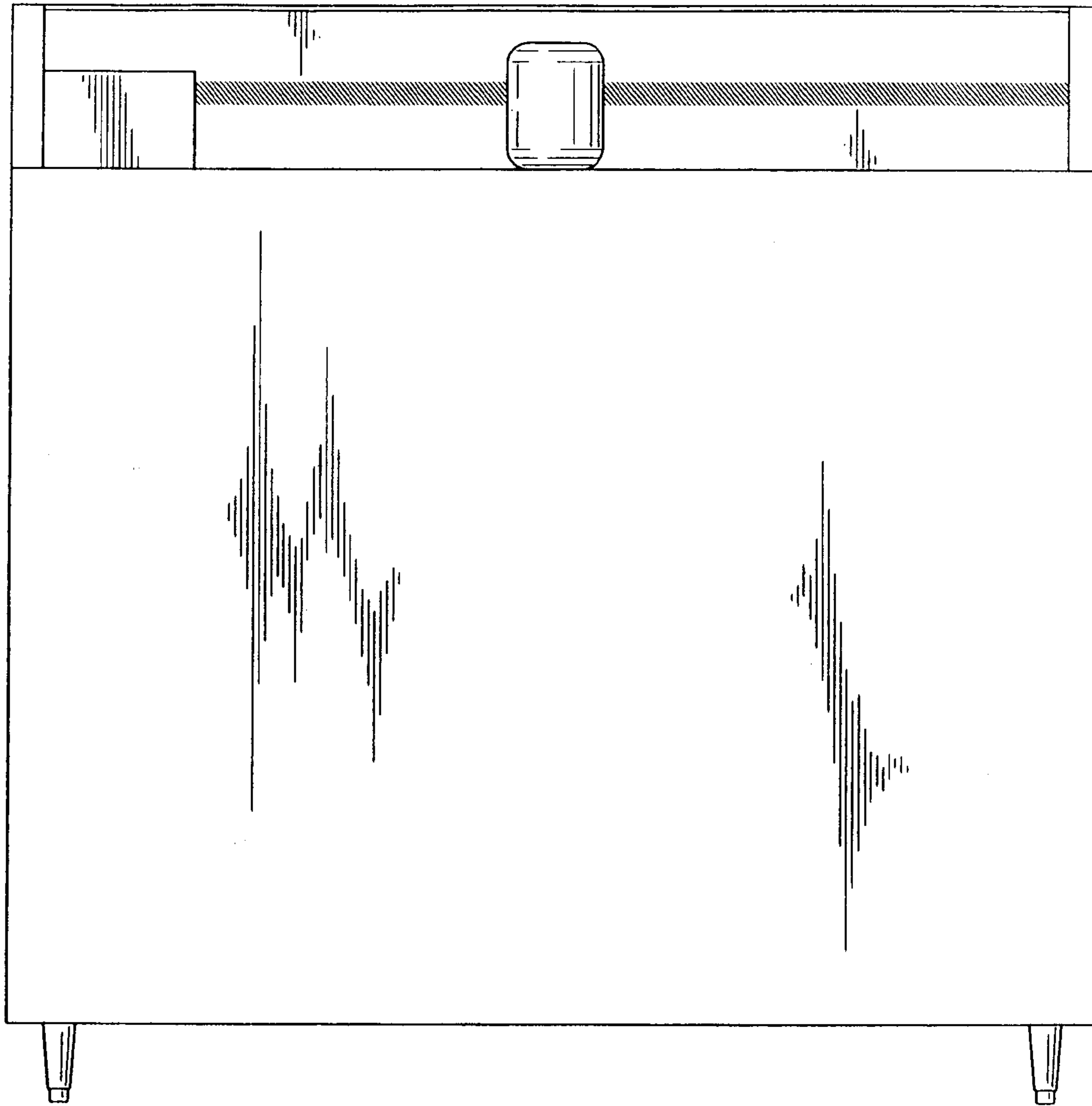

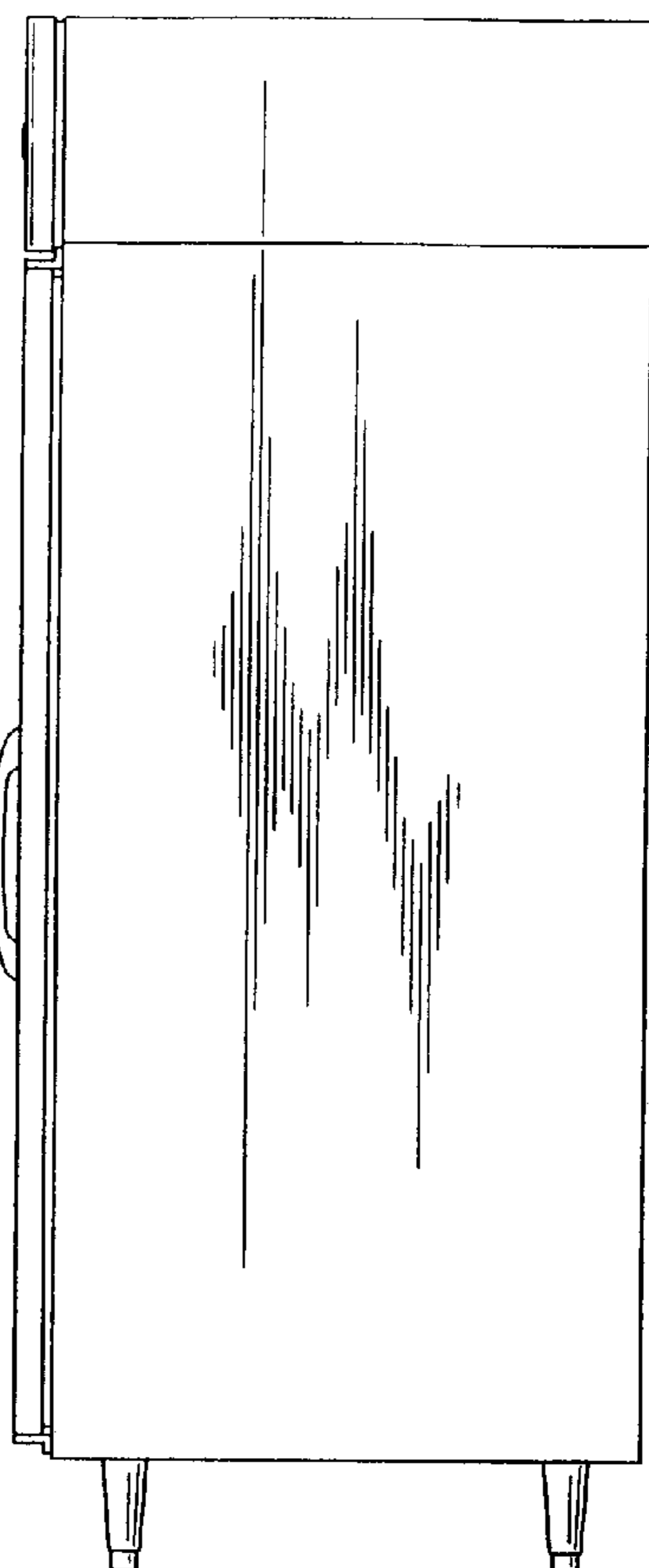
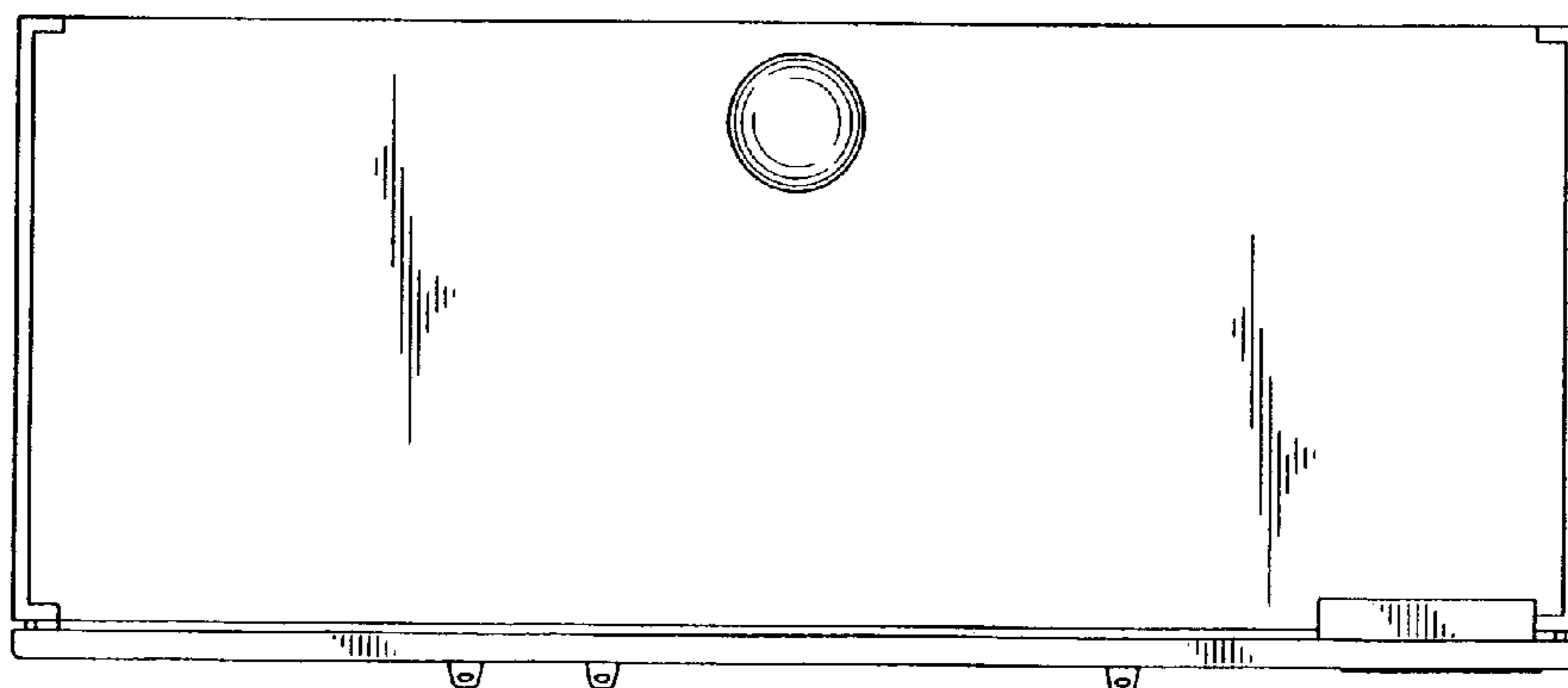

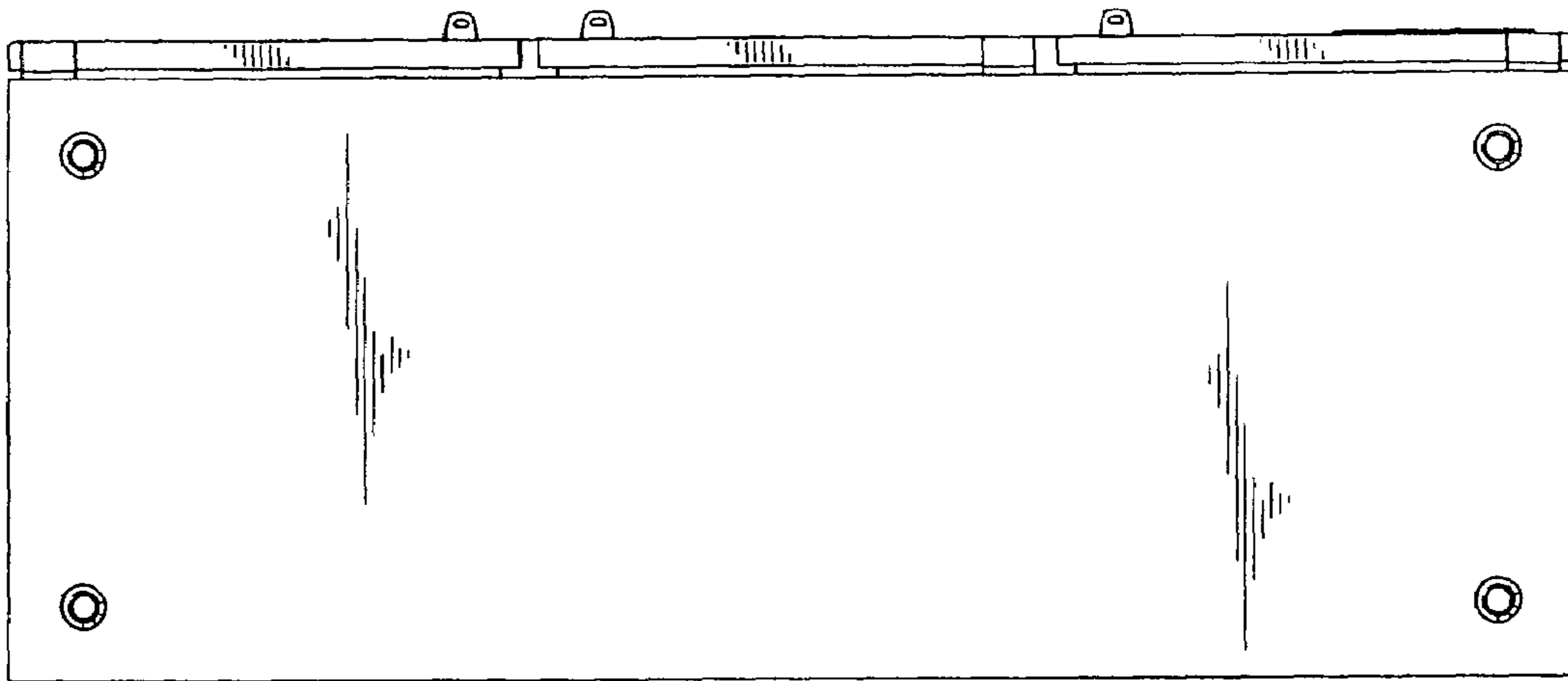

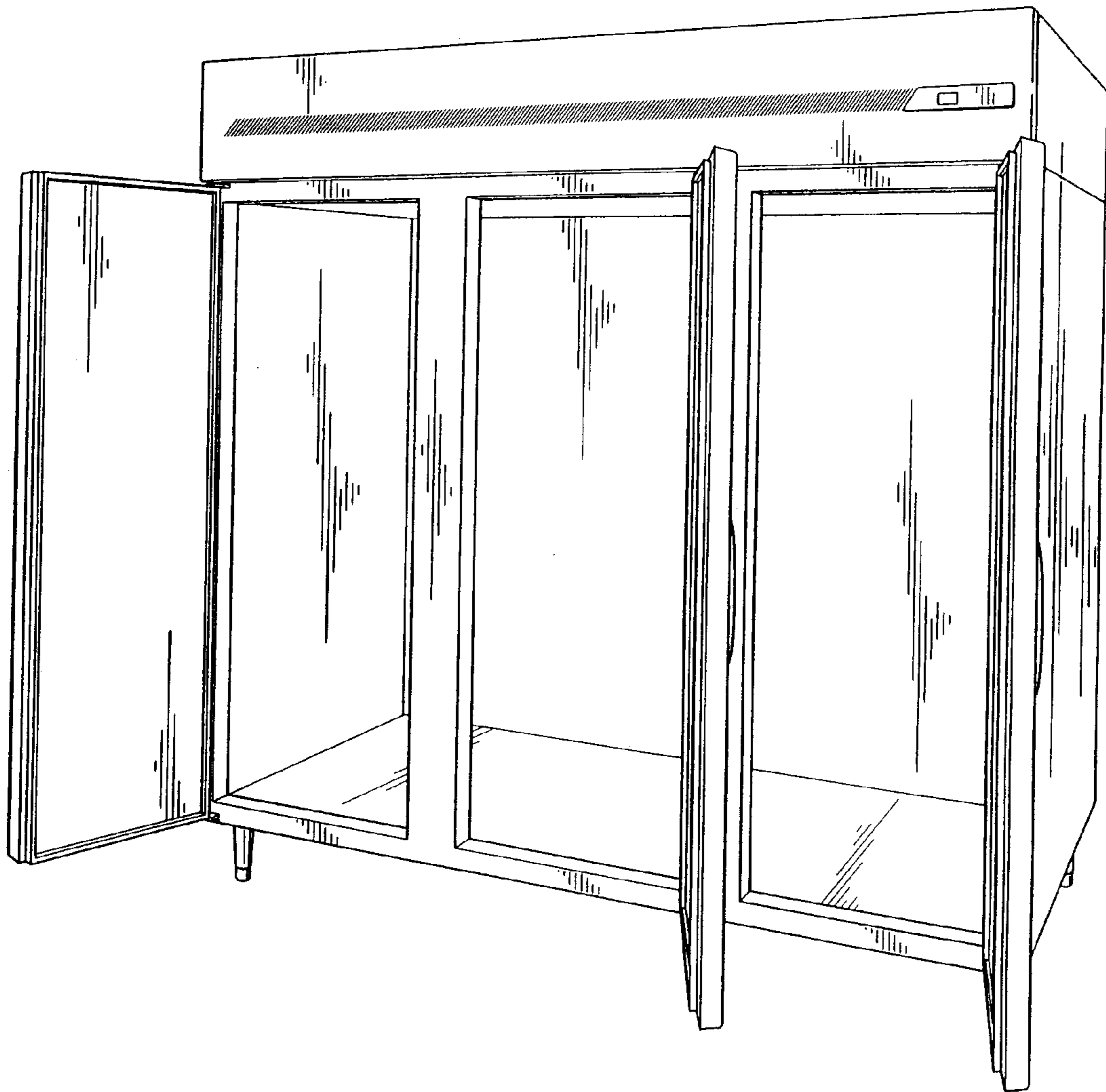
