FIG. 2 is a right side view of the puppet seen in FIG. 1;

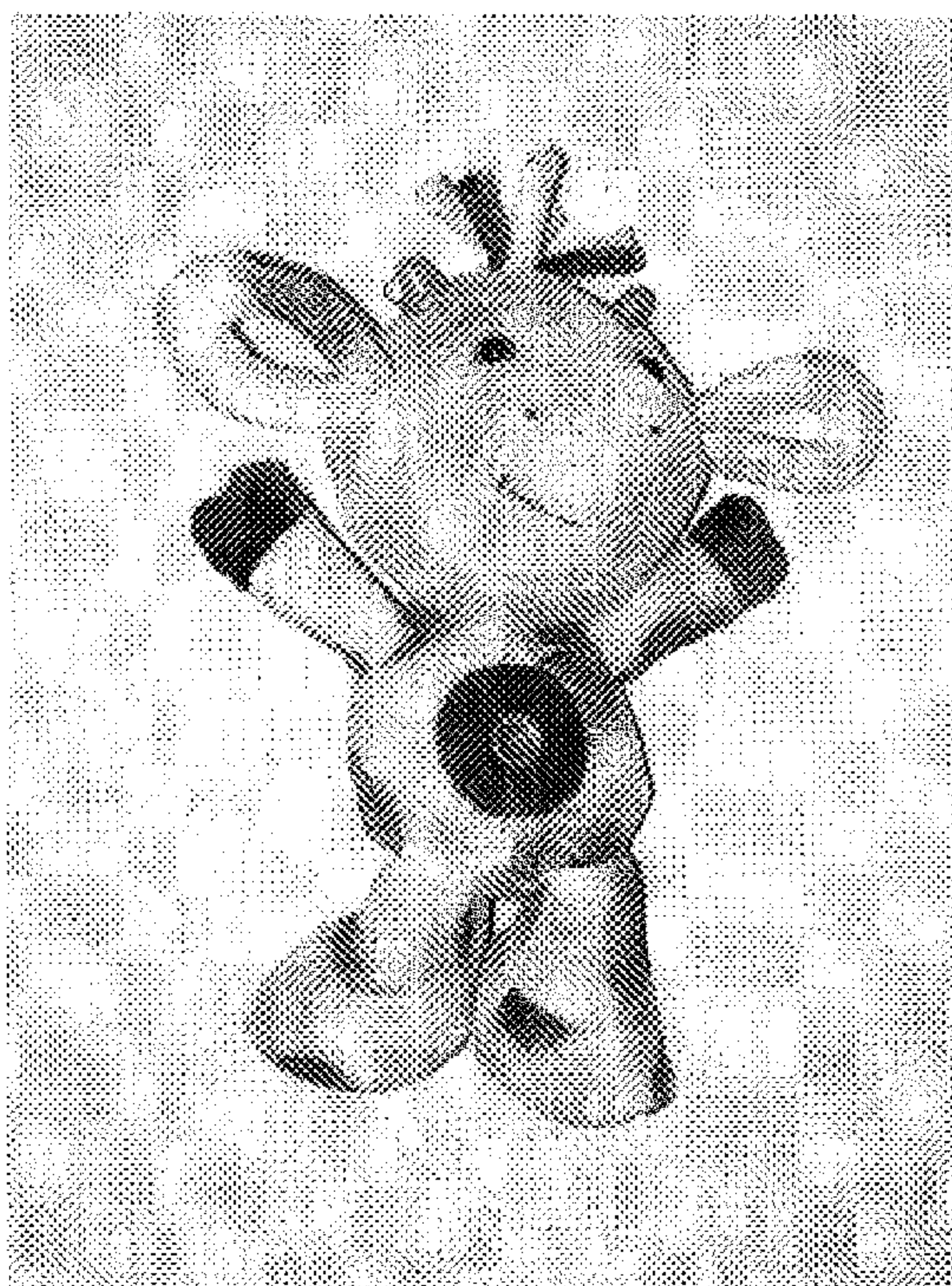
FIG. 3 is a left side view of the puppet seen in FIG. 1;

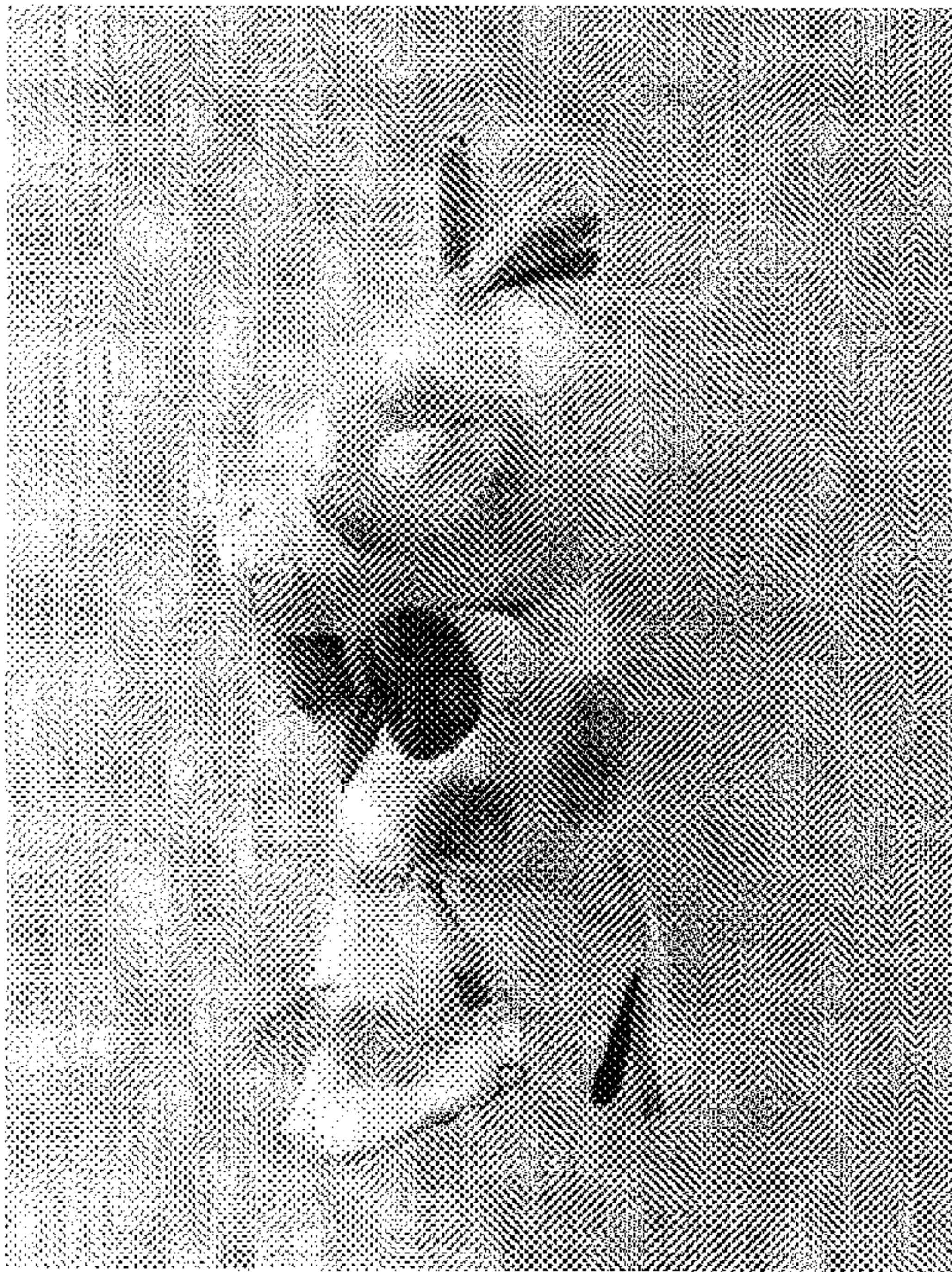

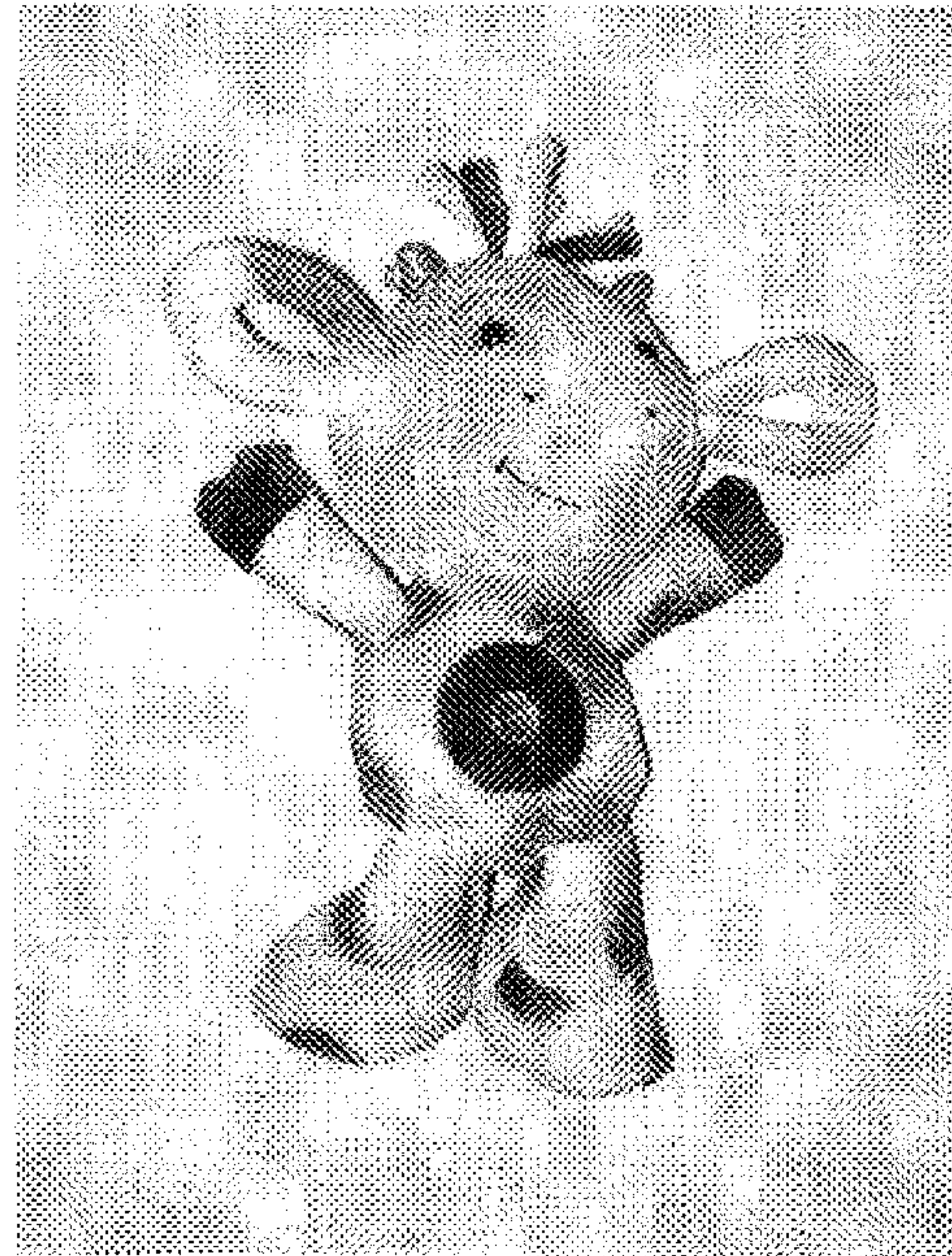

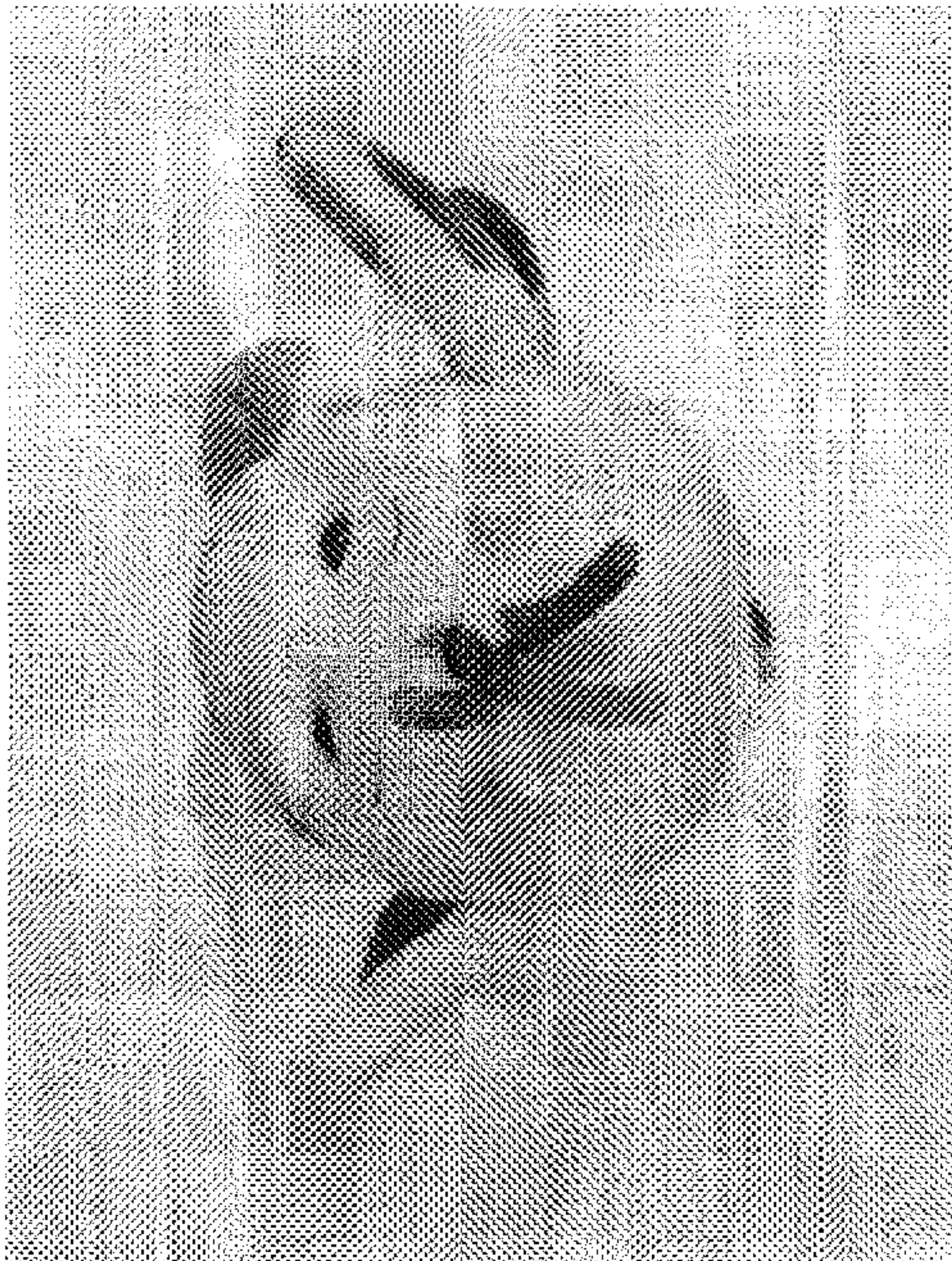

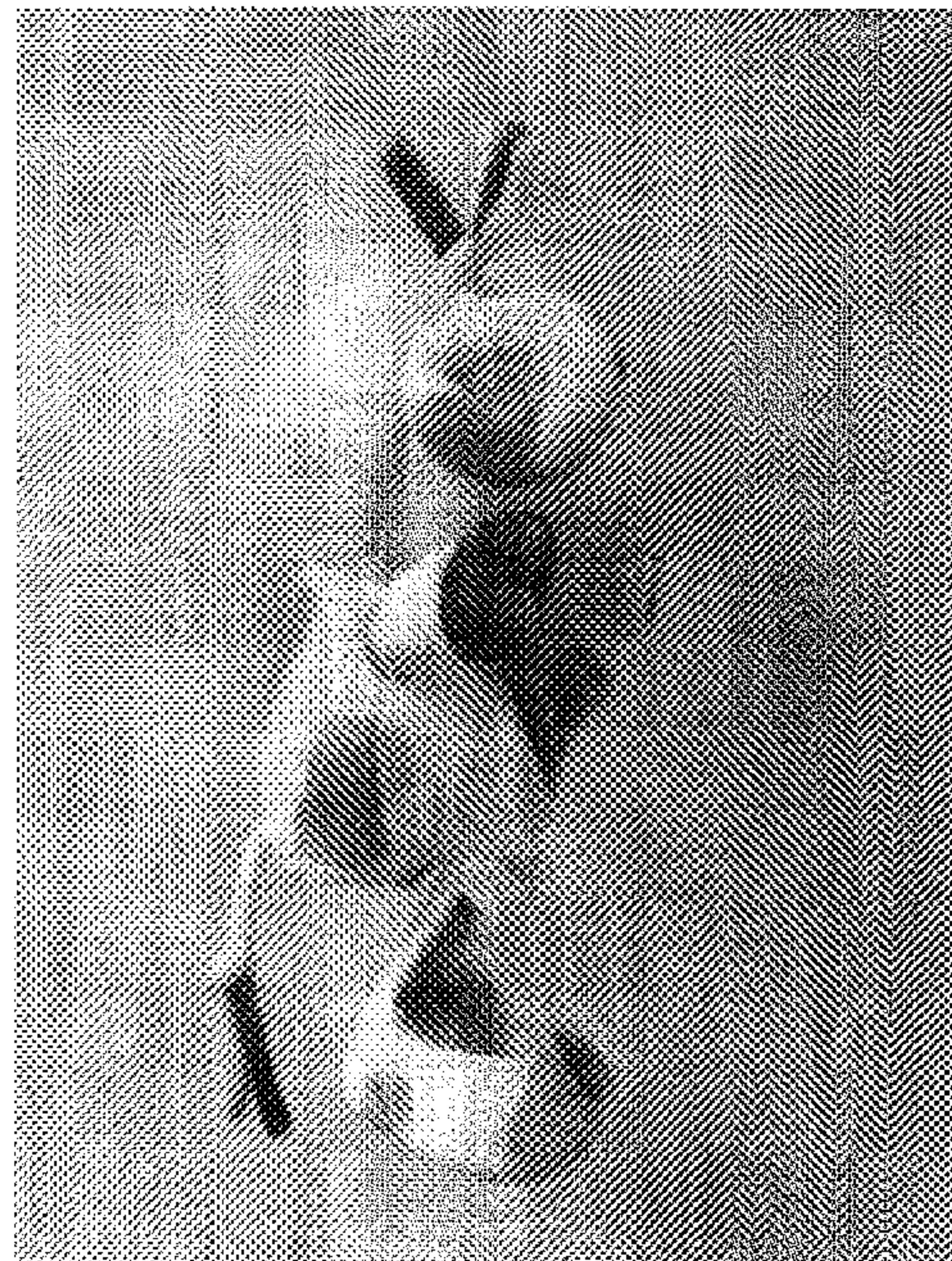

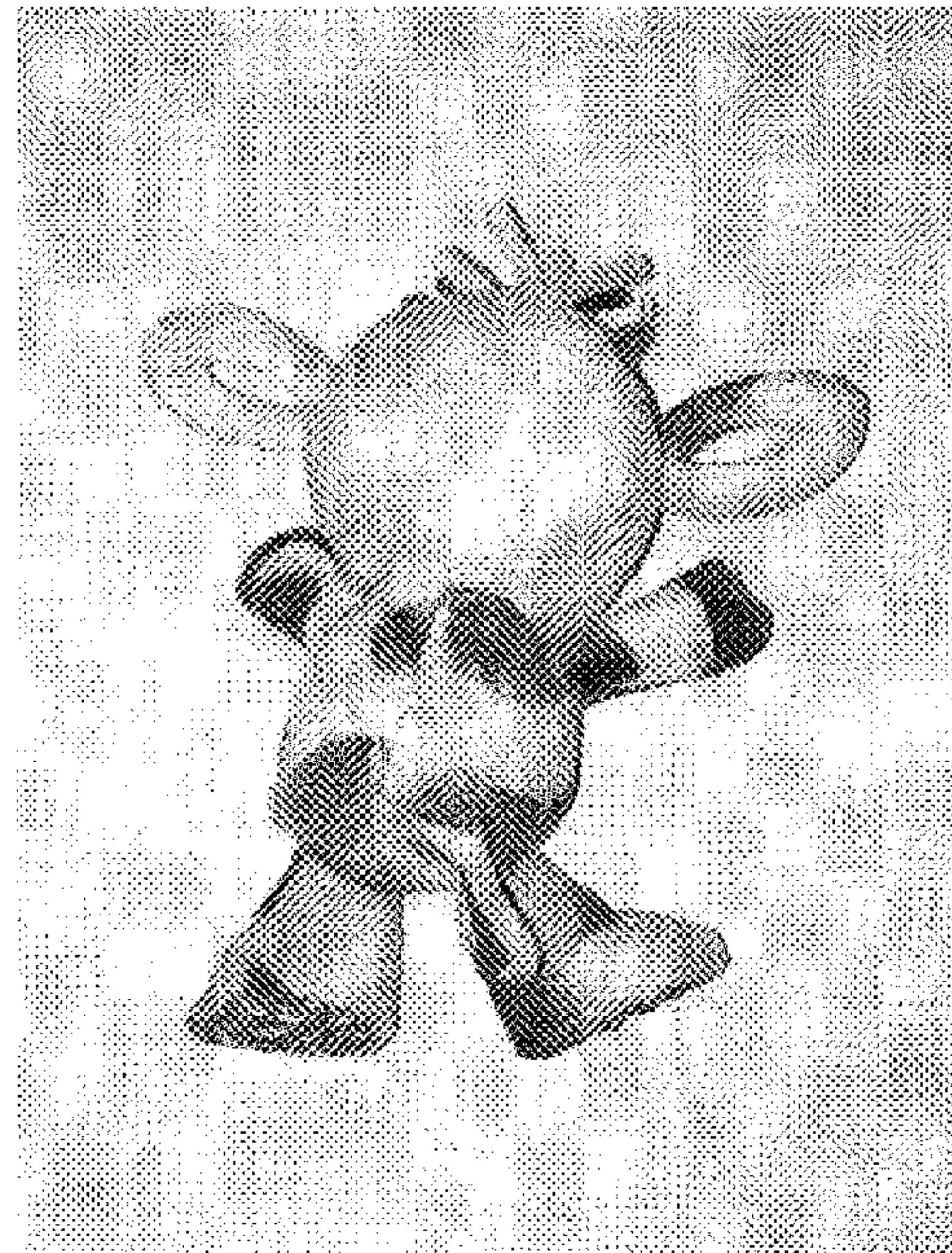
