The ornamental design for a decorative floor and table top heater, as shown and described.

DESCRIPTION

FIG. 1 is a right front perspective view of a decorative floor and table top heater showing our new design; FIG. 2 is a left front perspective view thereof; FIG. 3 is a right rear perspective view thereof; FIG. 4 is a left rear perspective view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a front view thereof; FIG. 8 is a rear view thereof; FIG. 9 is top perspective view thereof; and, FIG. 10 is bottom view thereof.

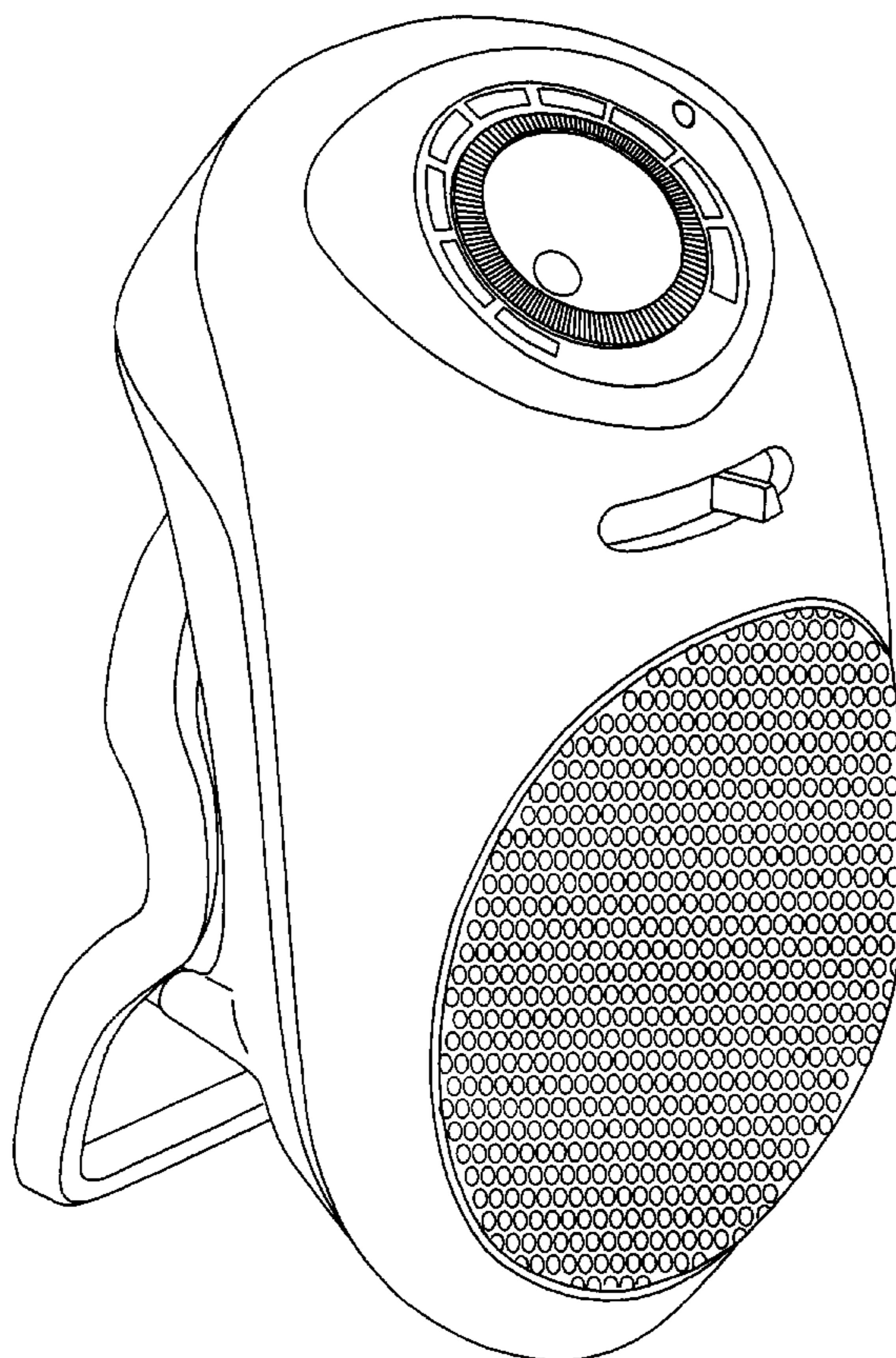

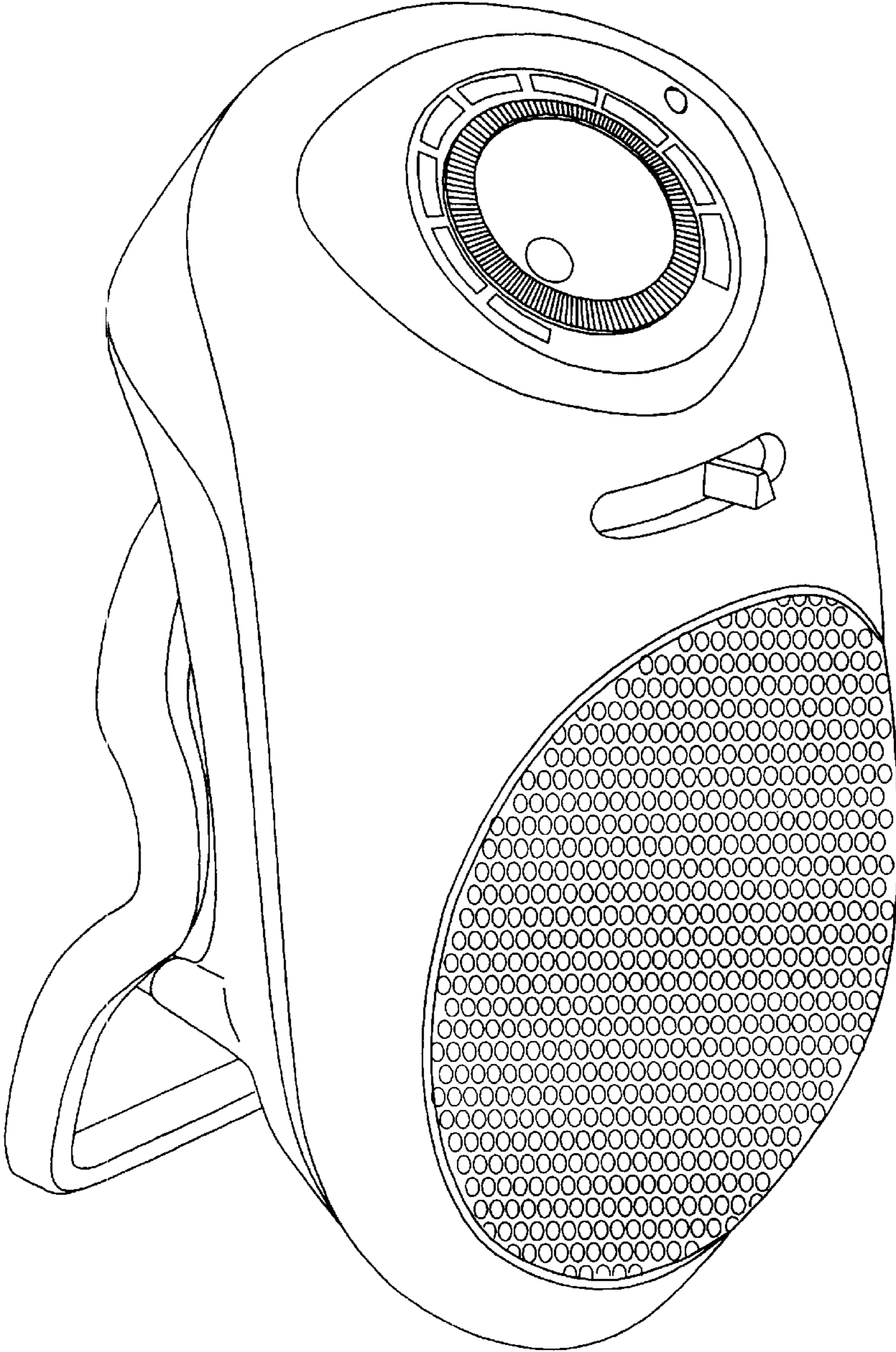

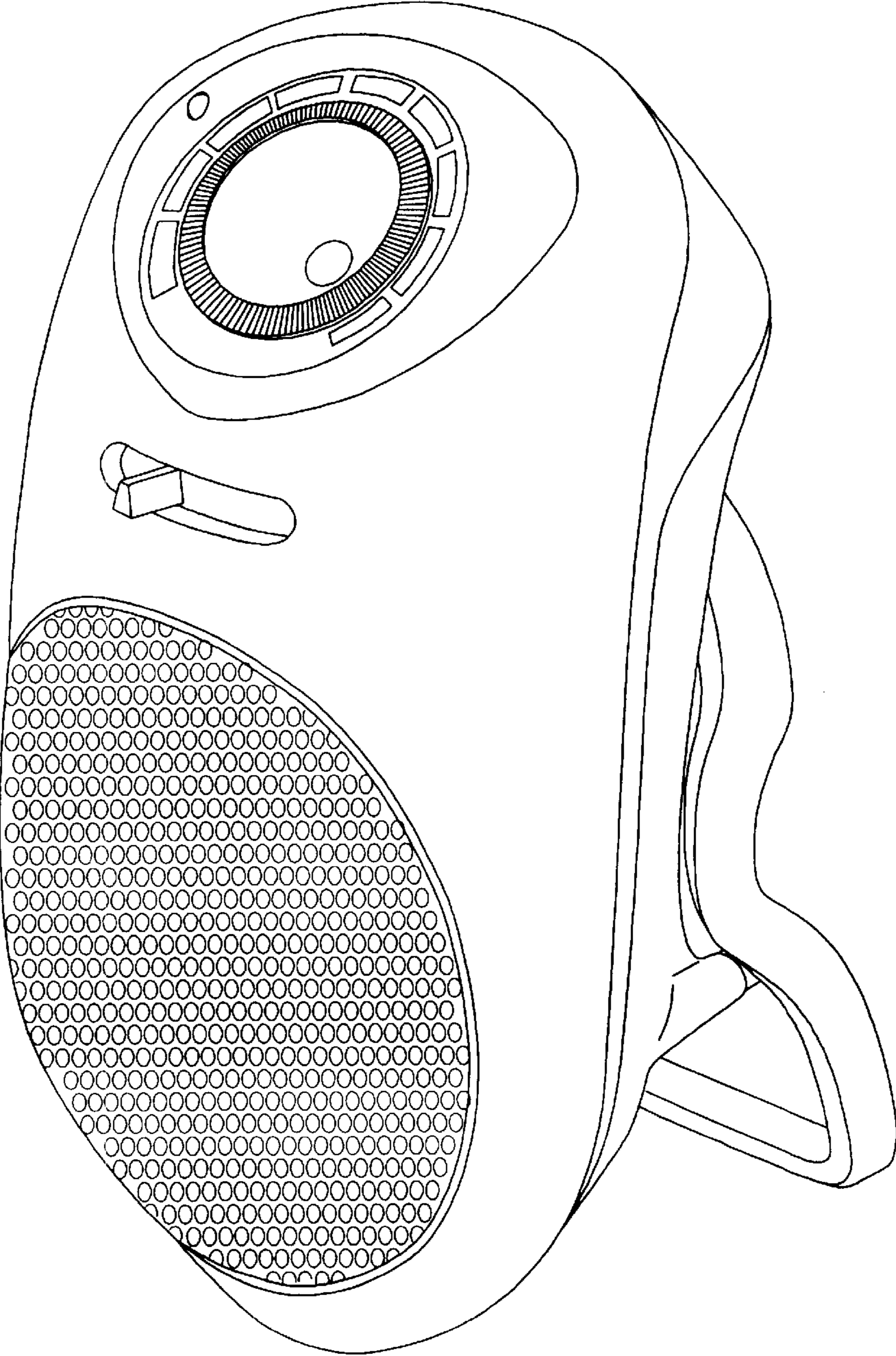

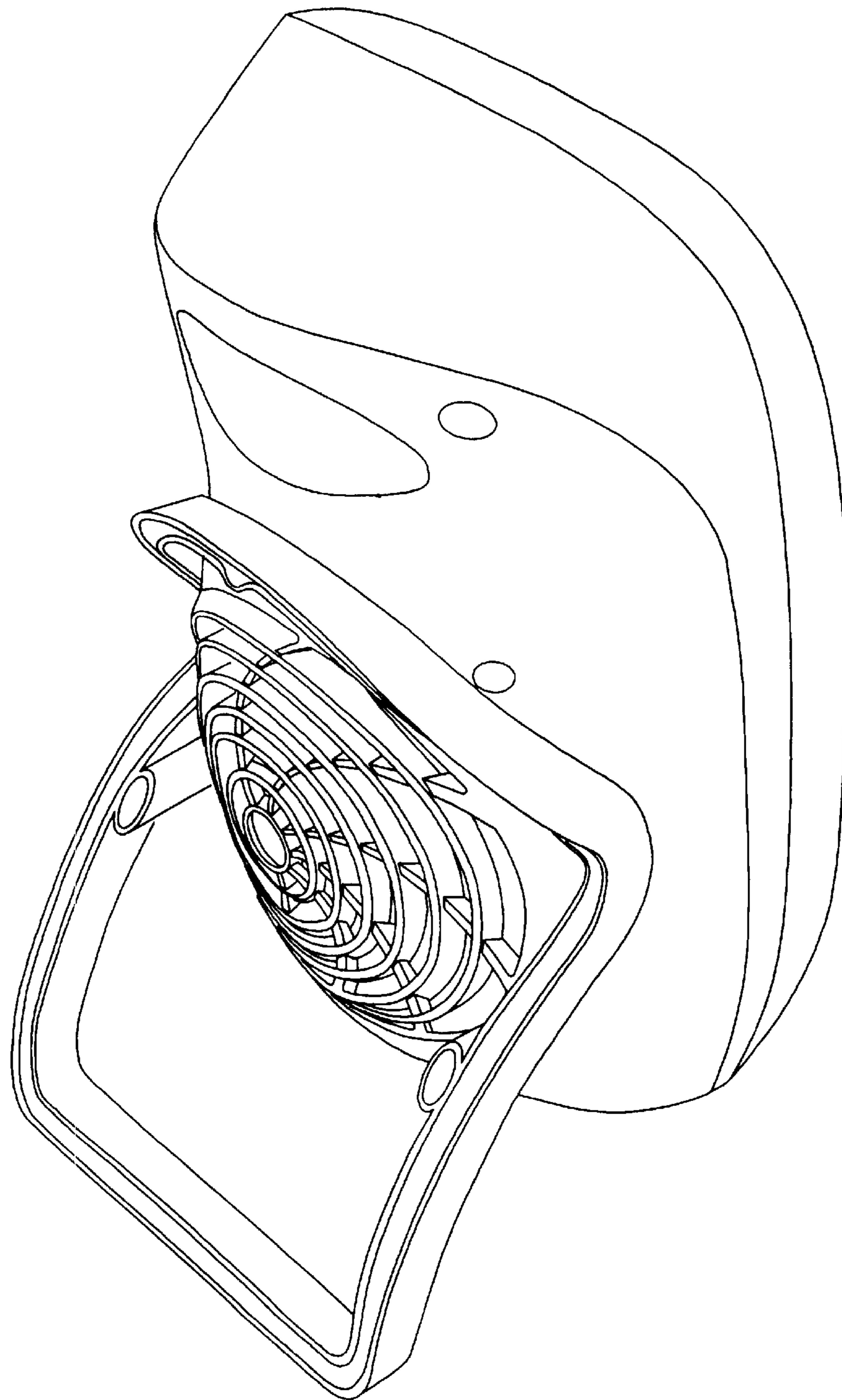

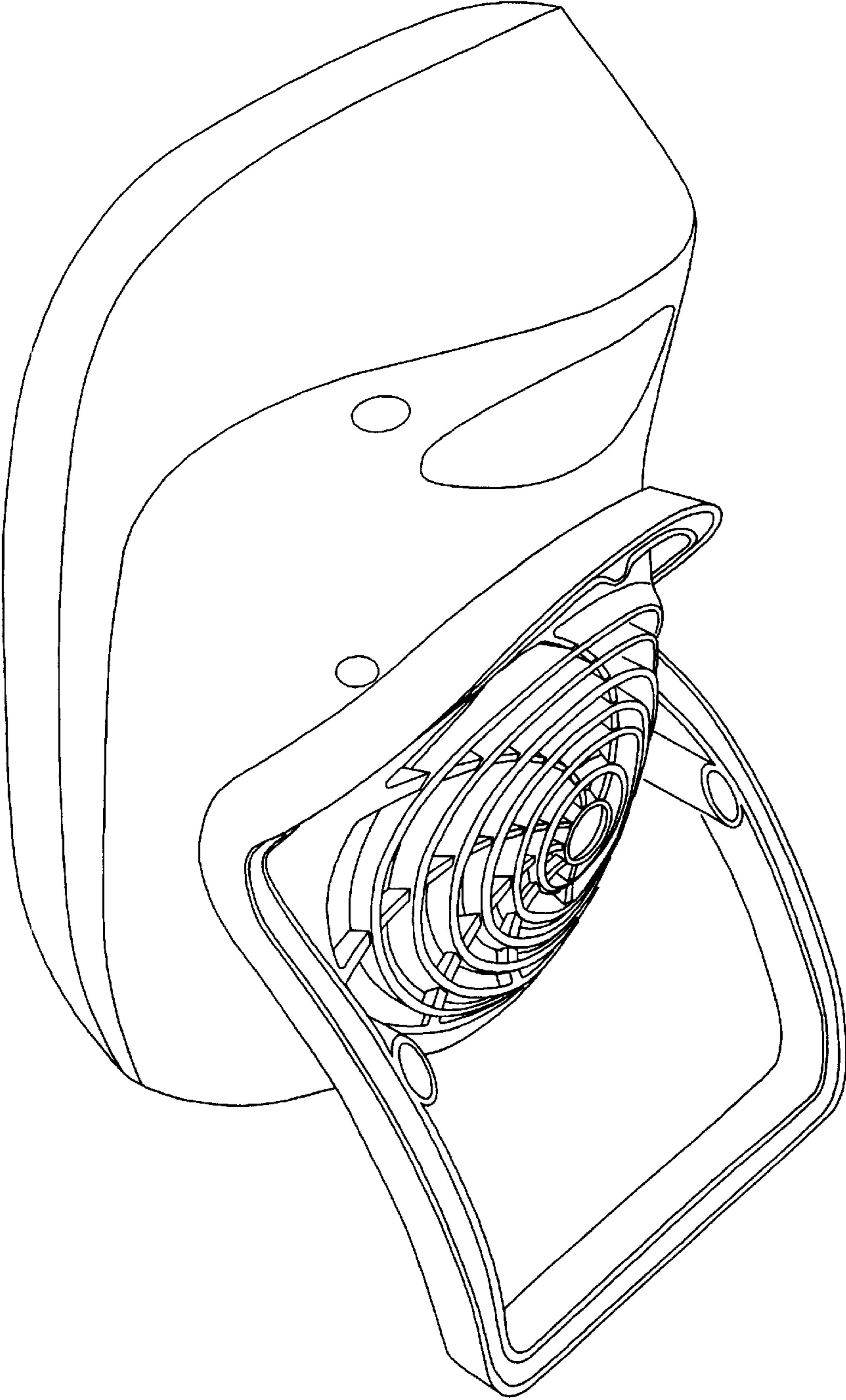

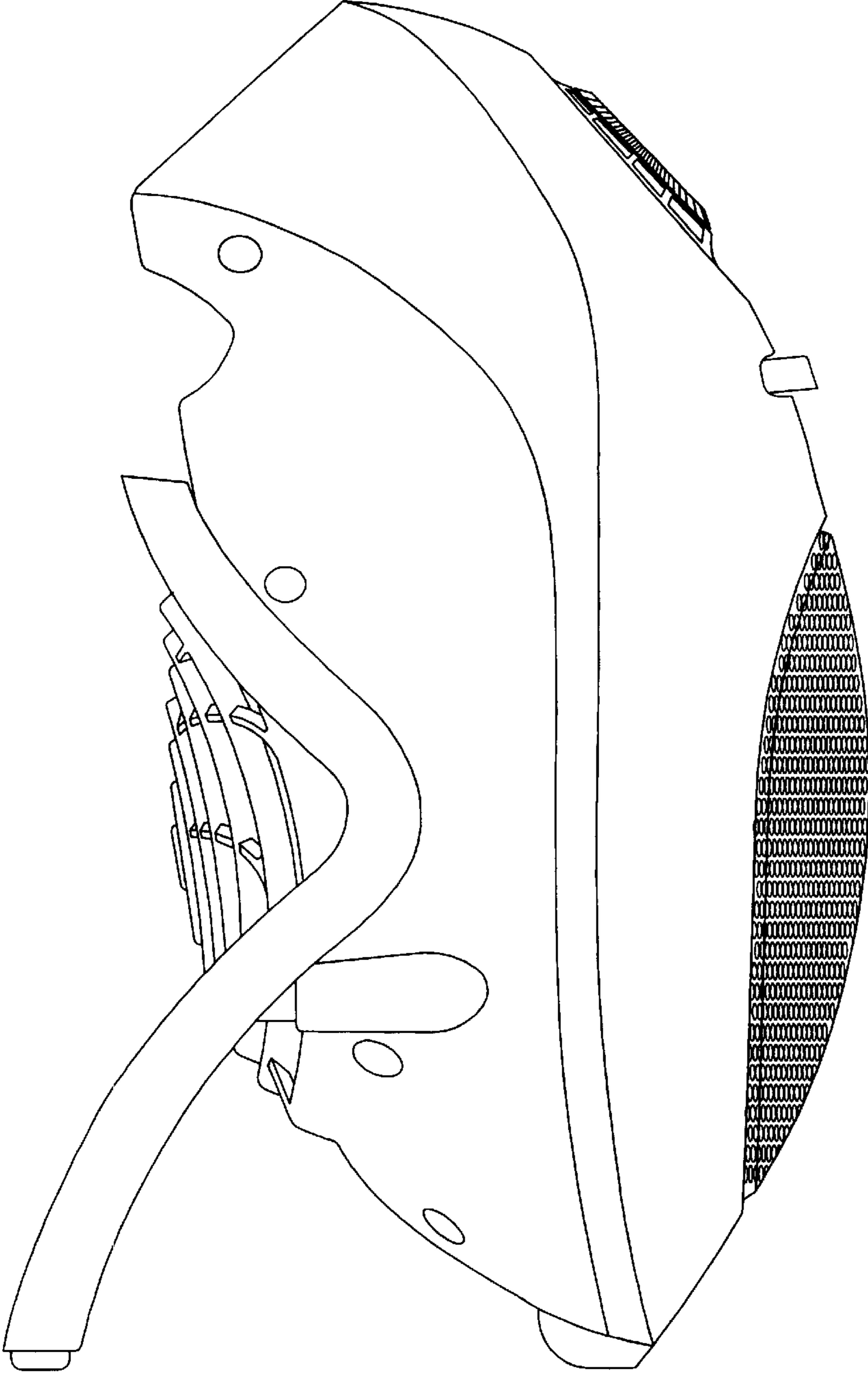

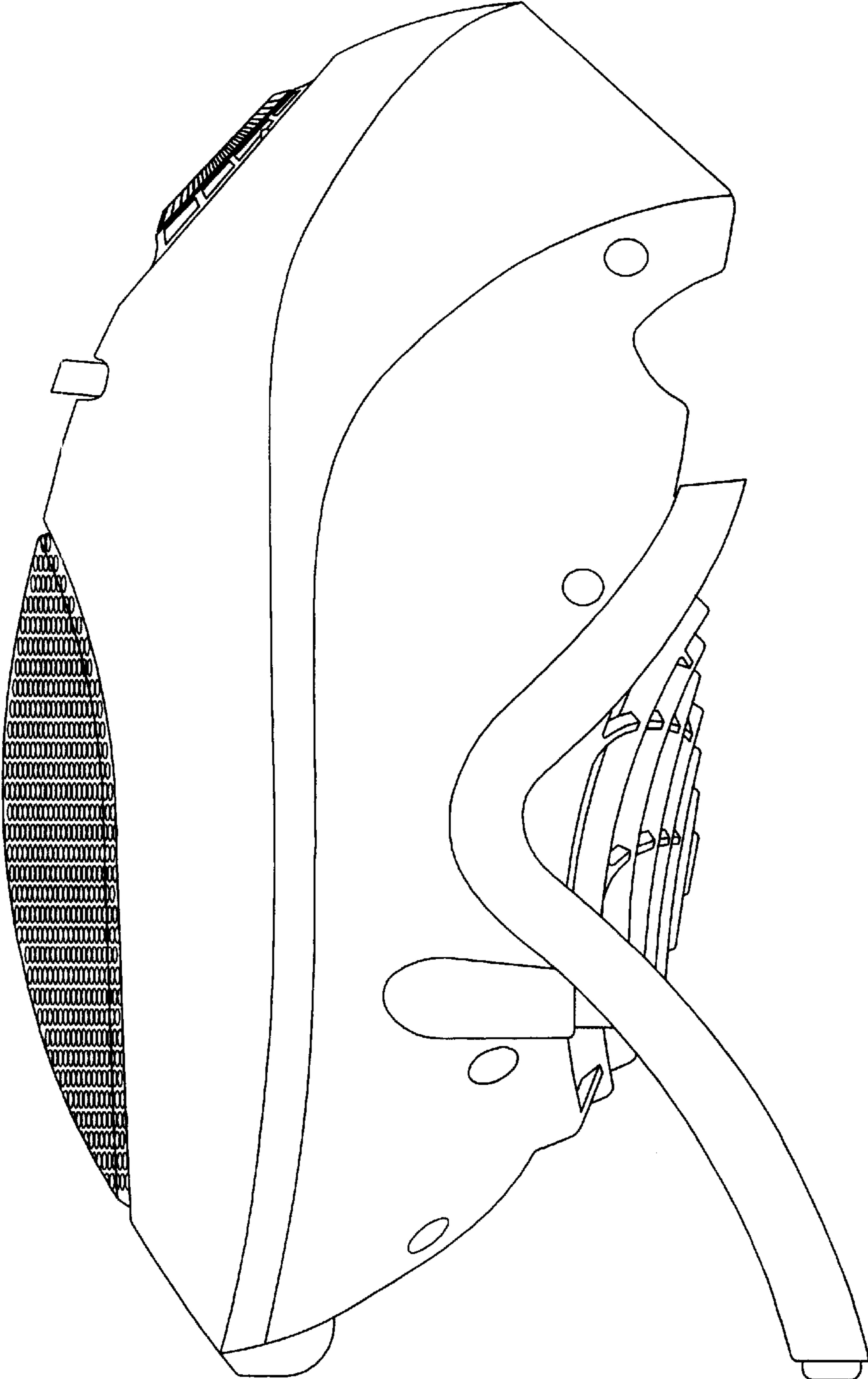

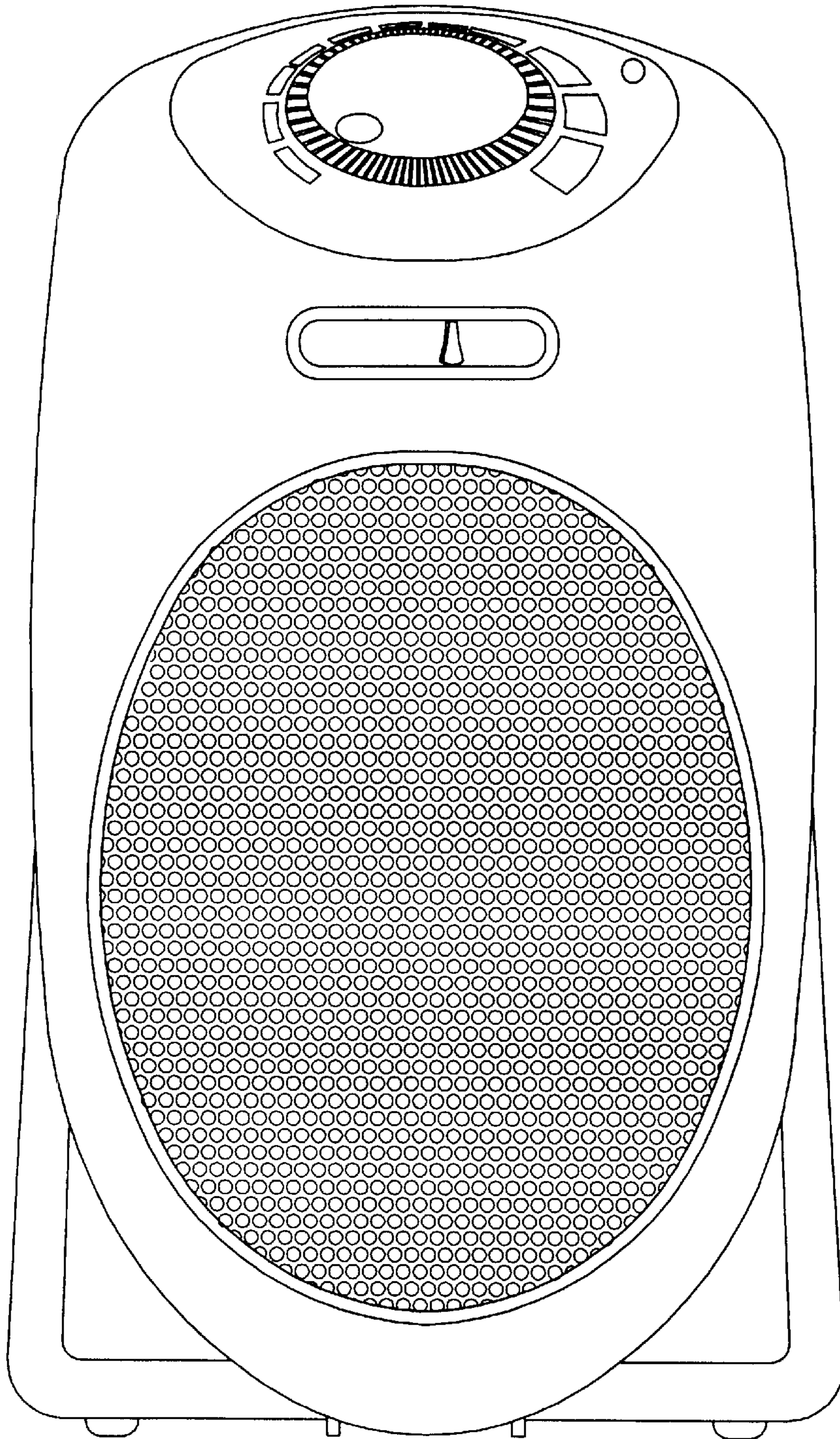

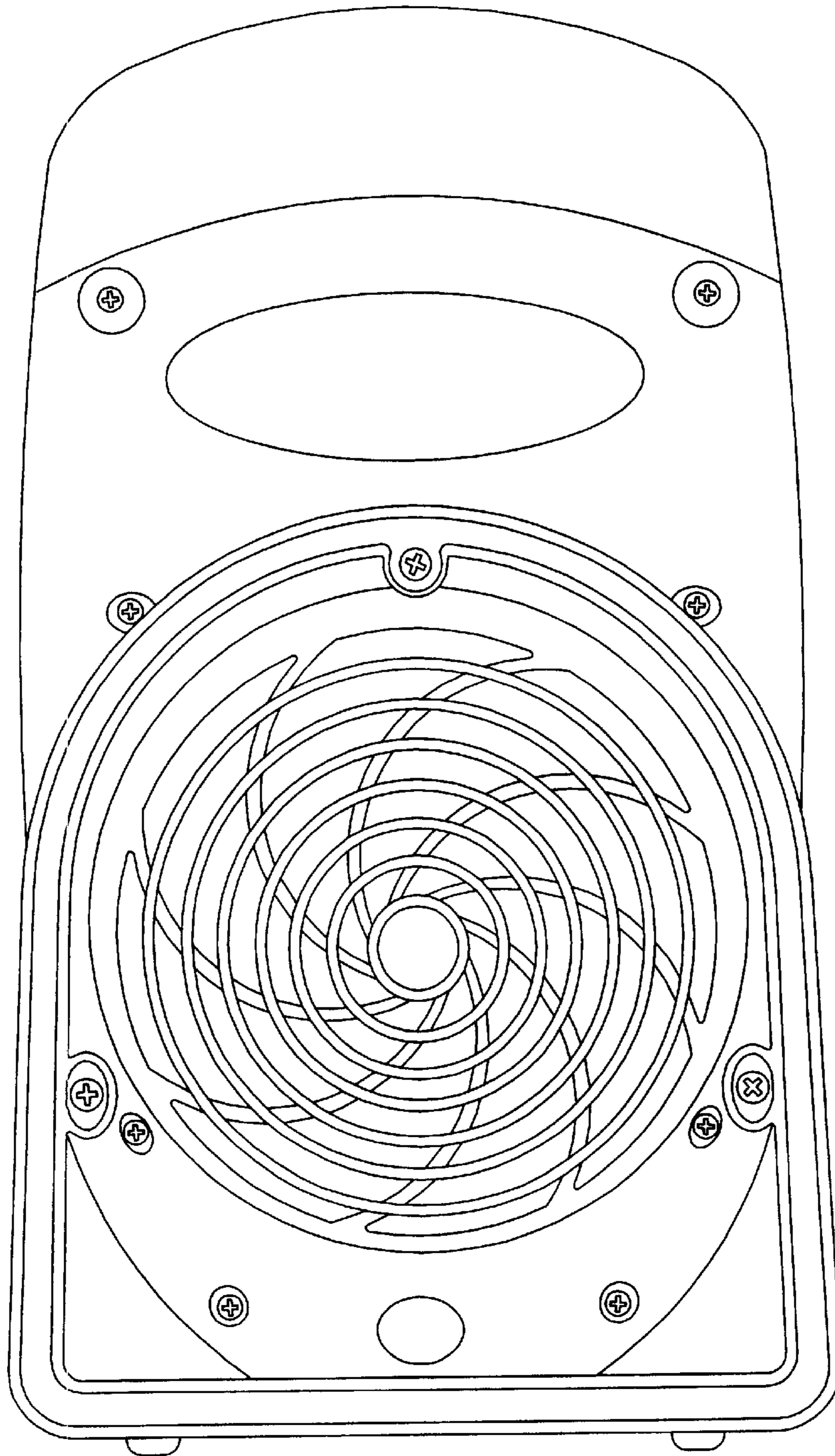

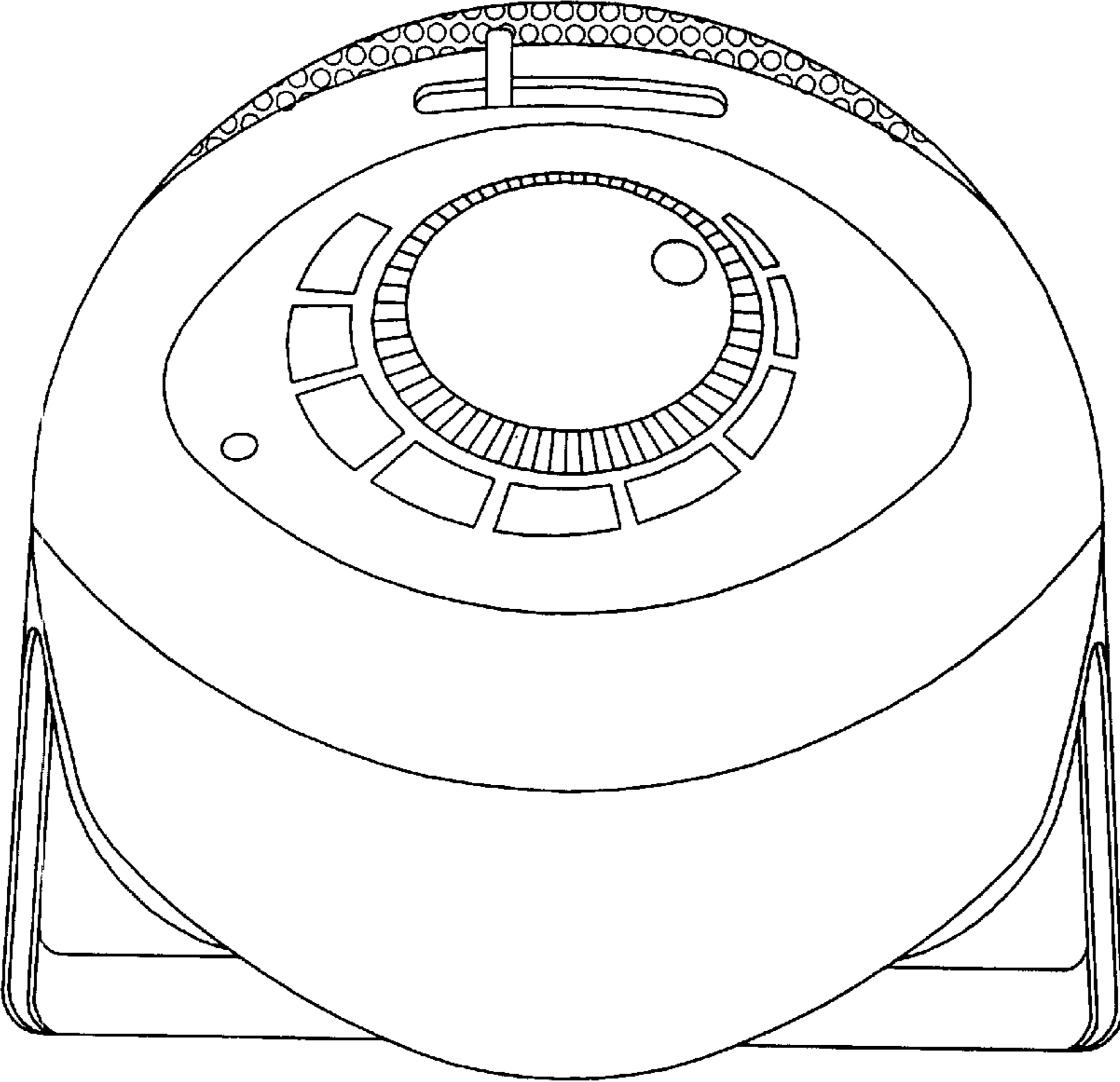
