DESCRIPTION

FIG. 8 is a front view of the air freshener housing of FIG. 7;

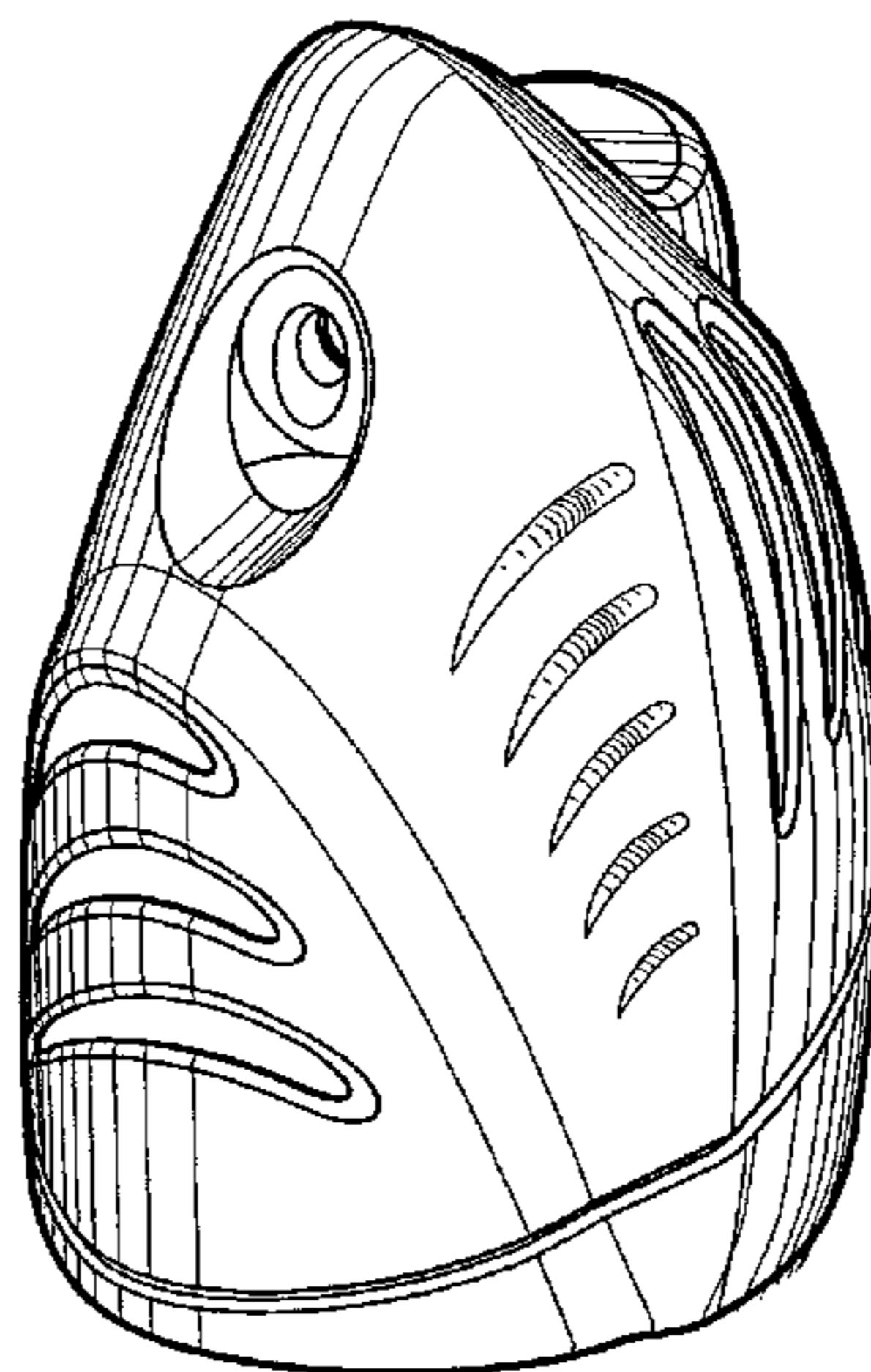
FIG. 9 is a back view of the air freshener housing of FIG. 7;

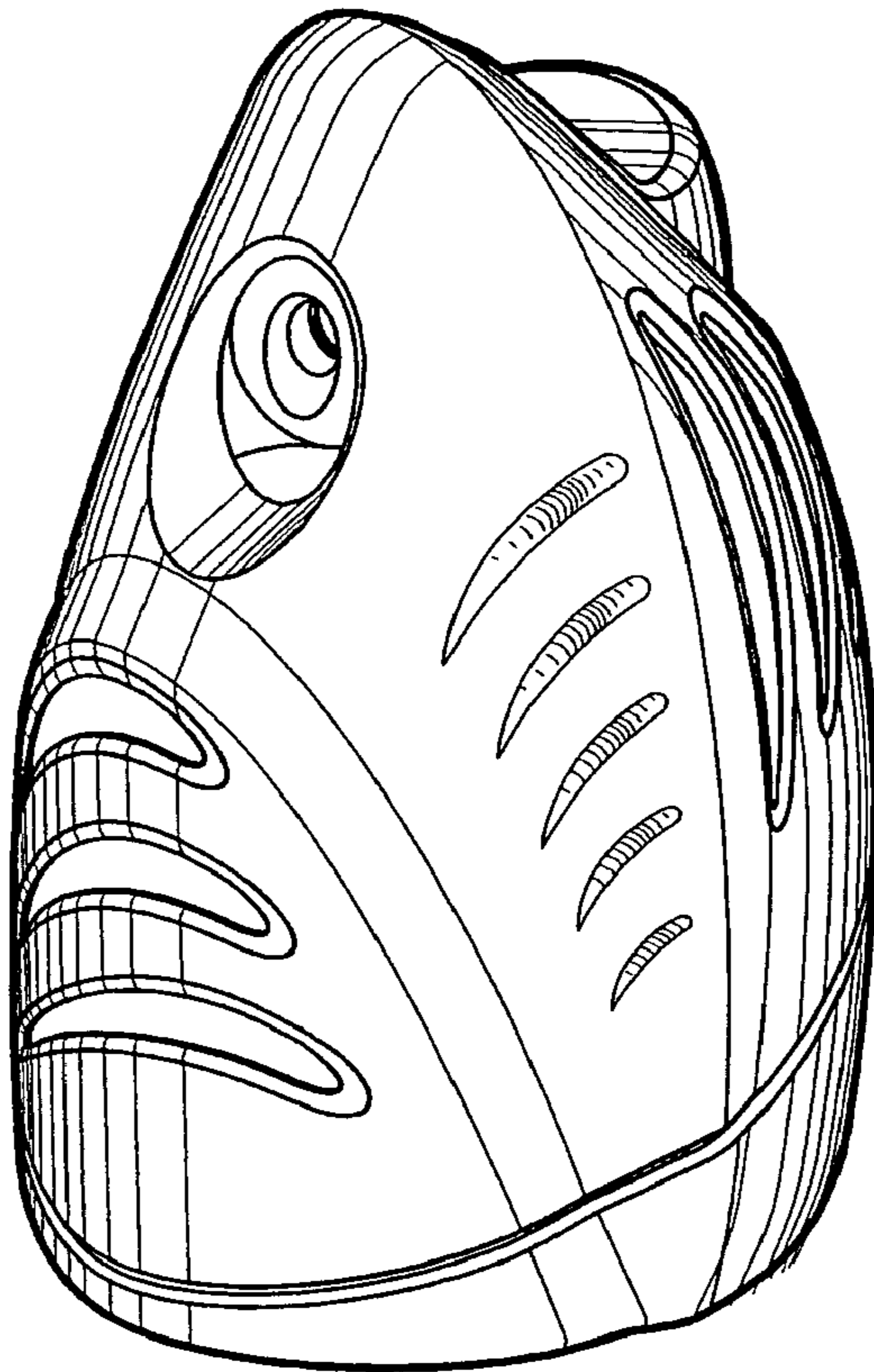

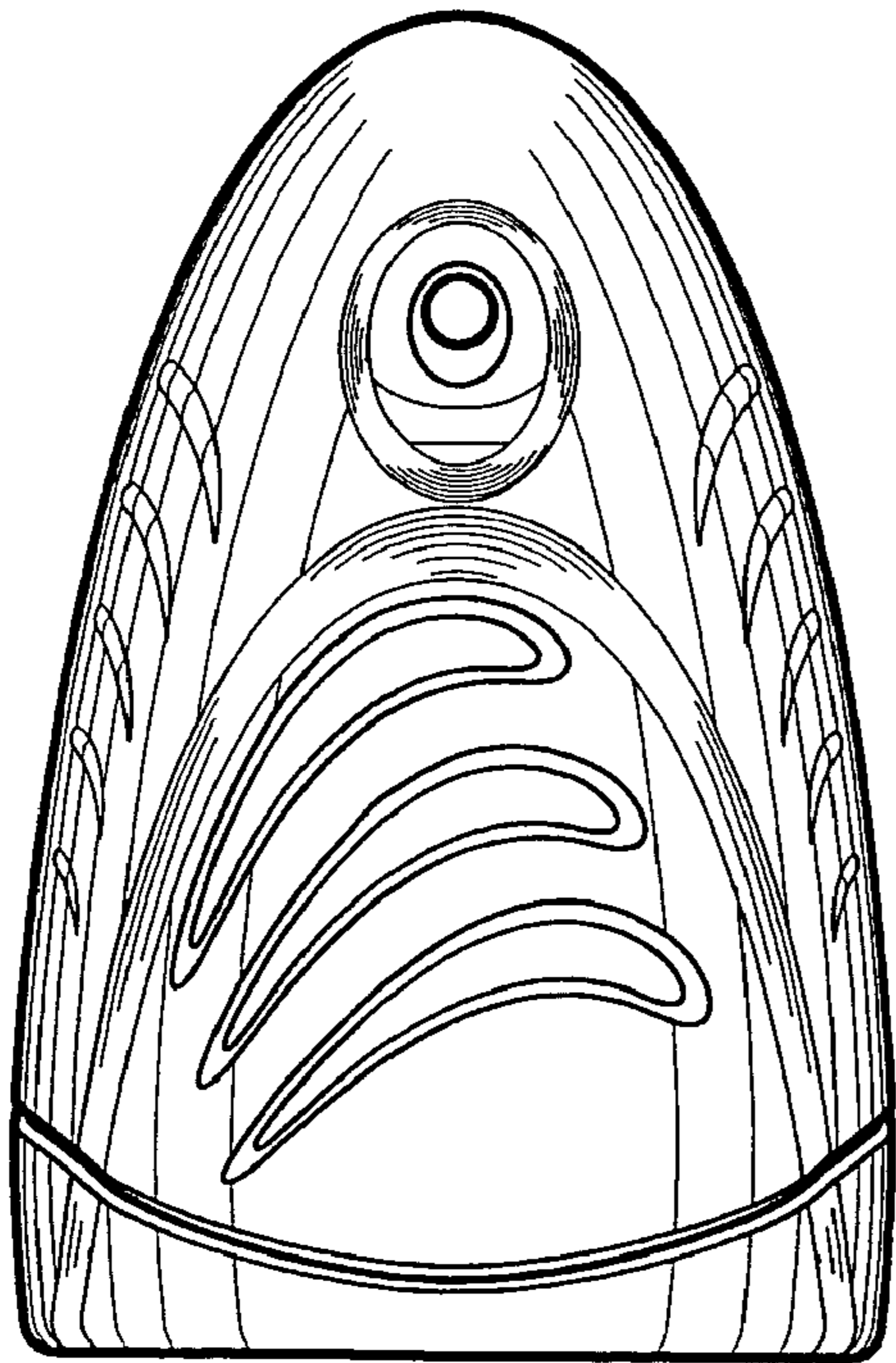

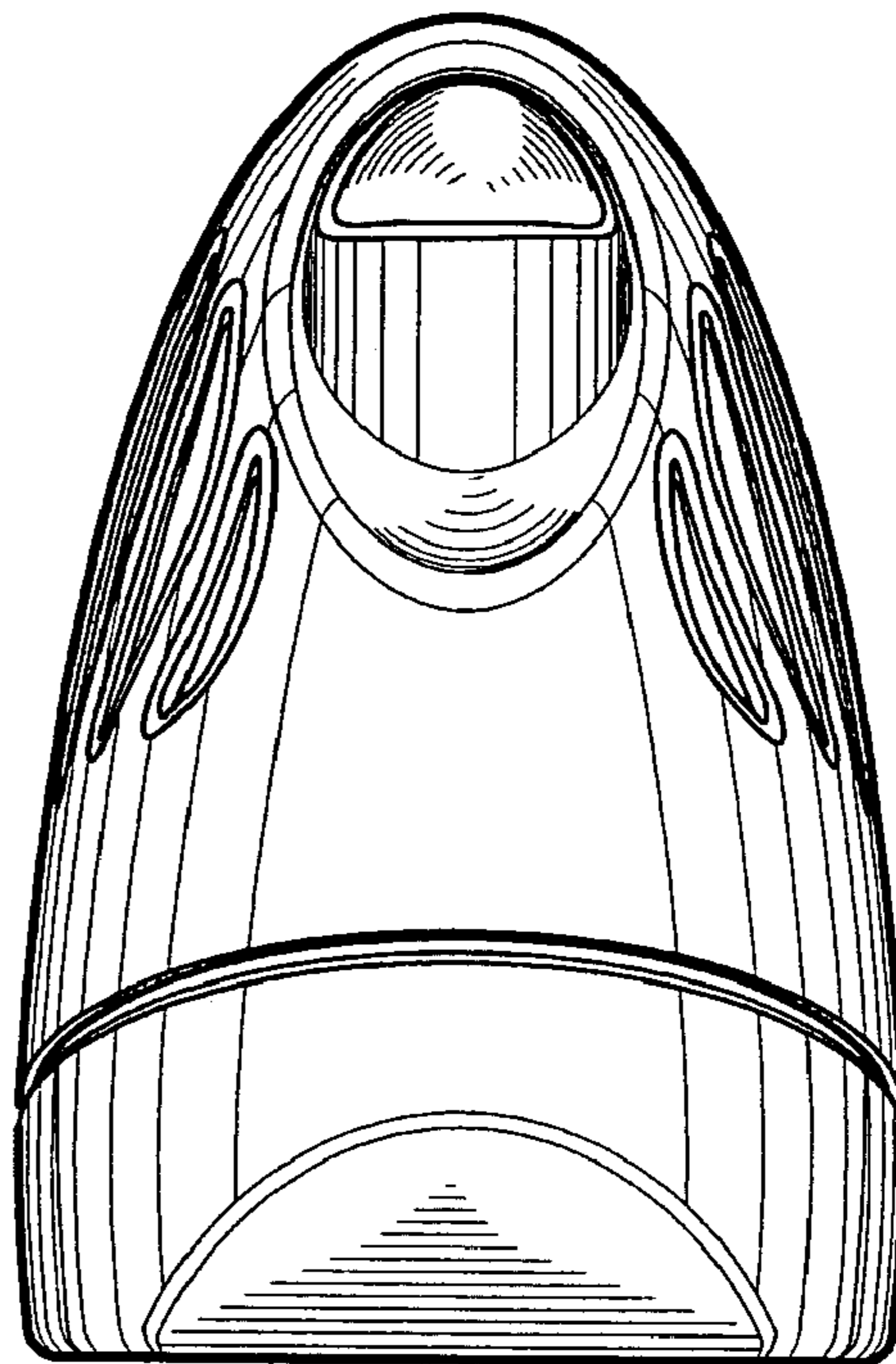

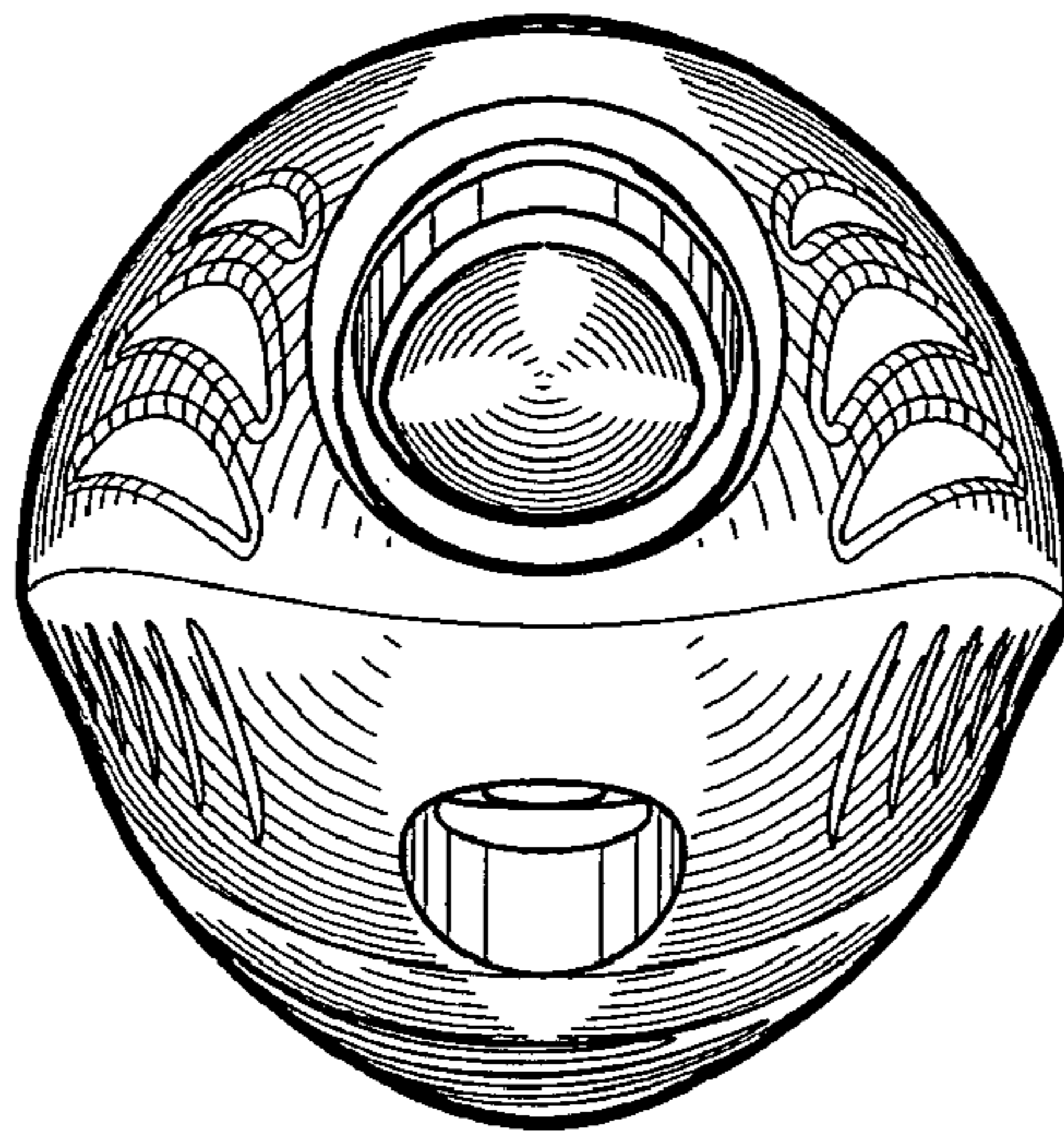

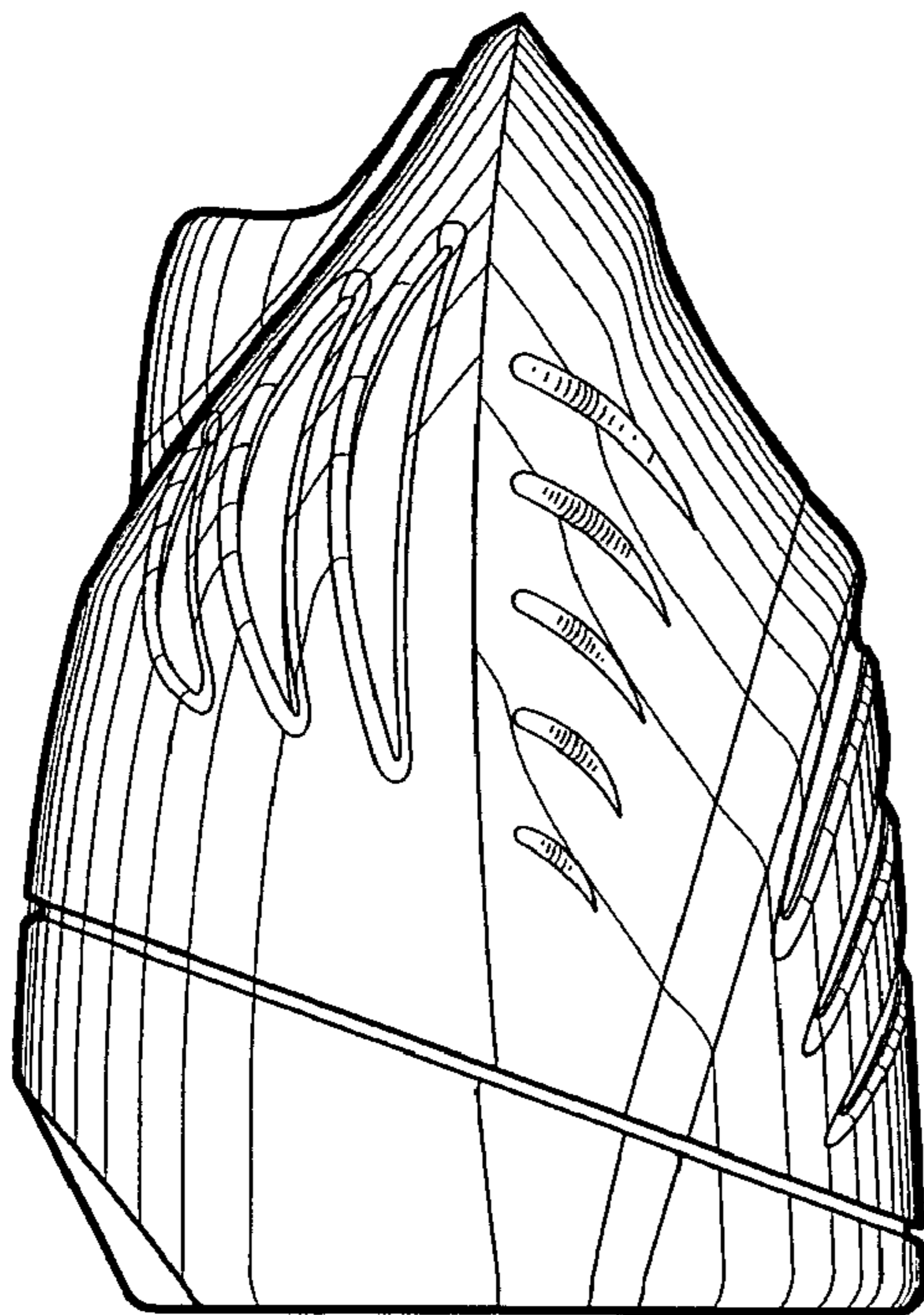

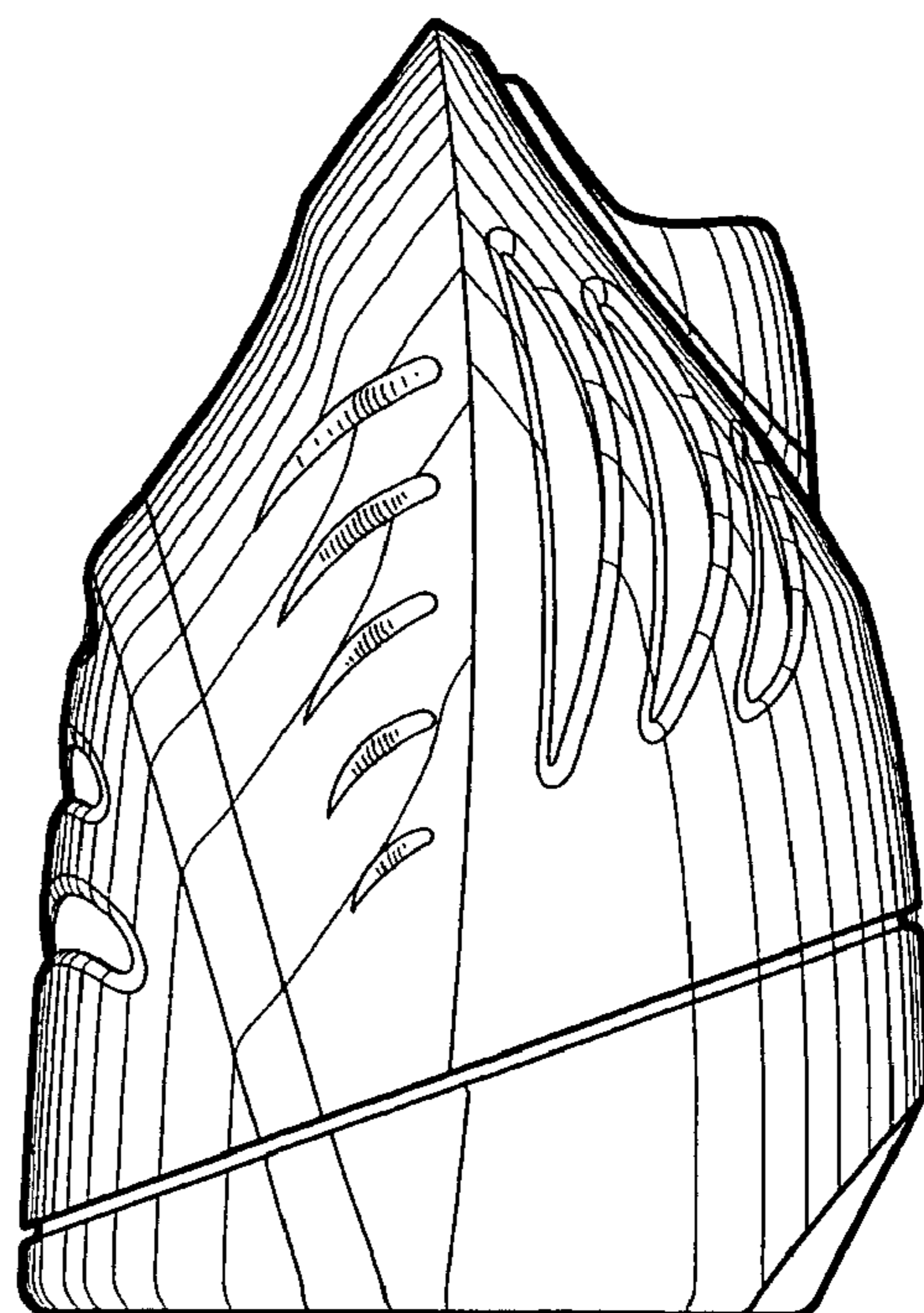

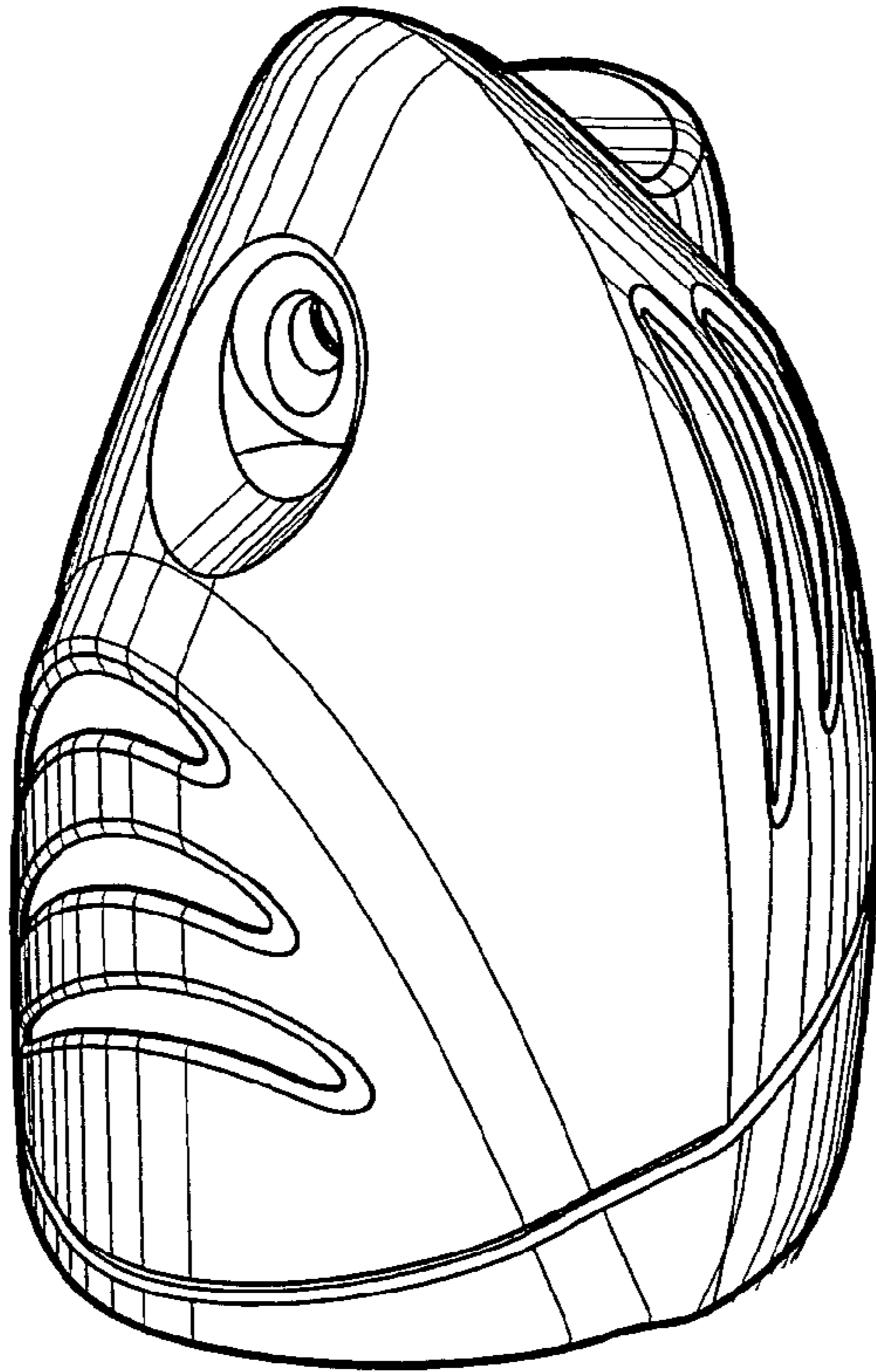

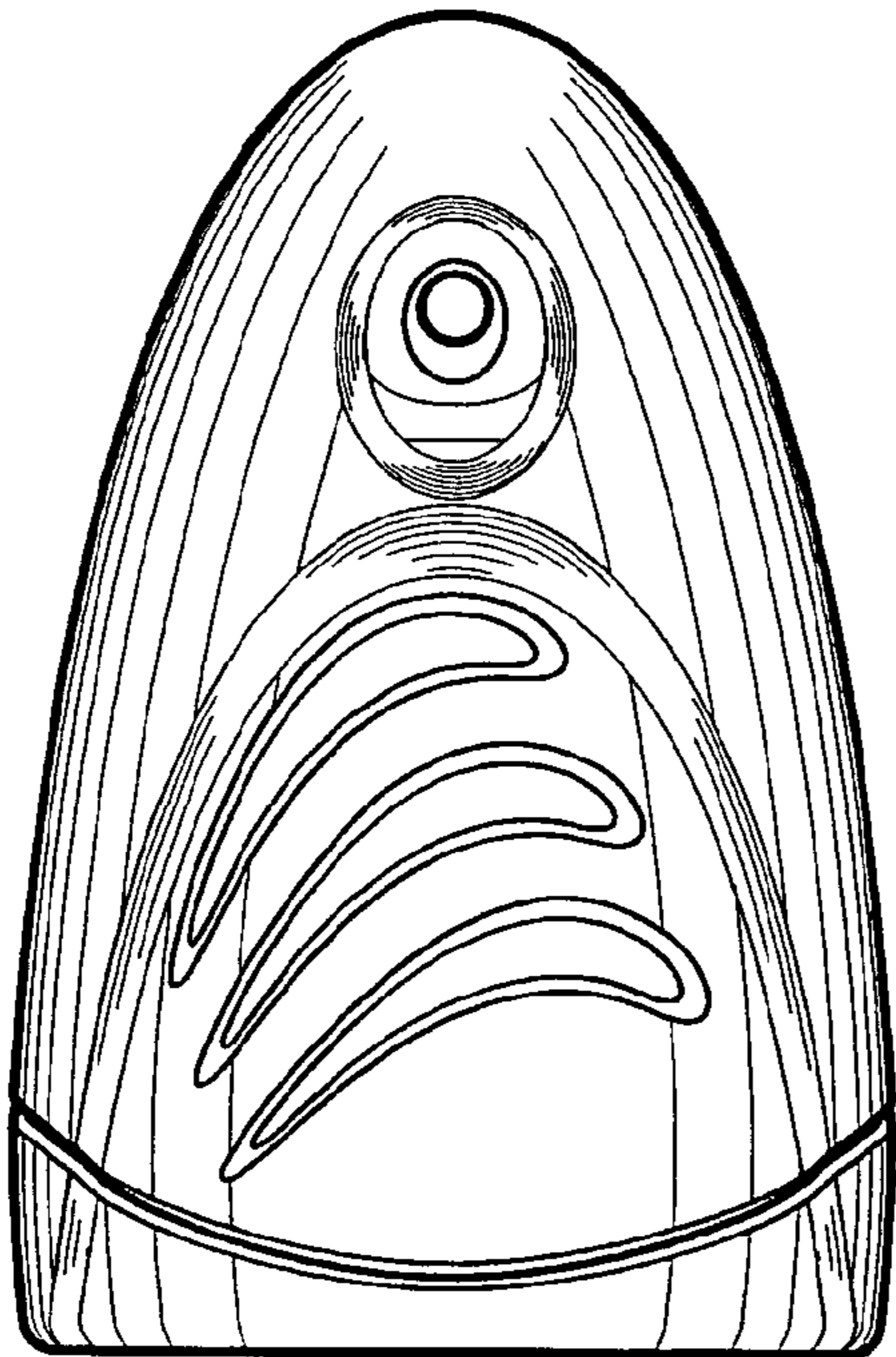

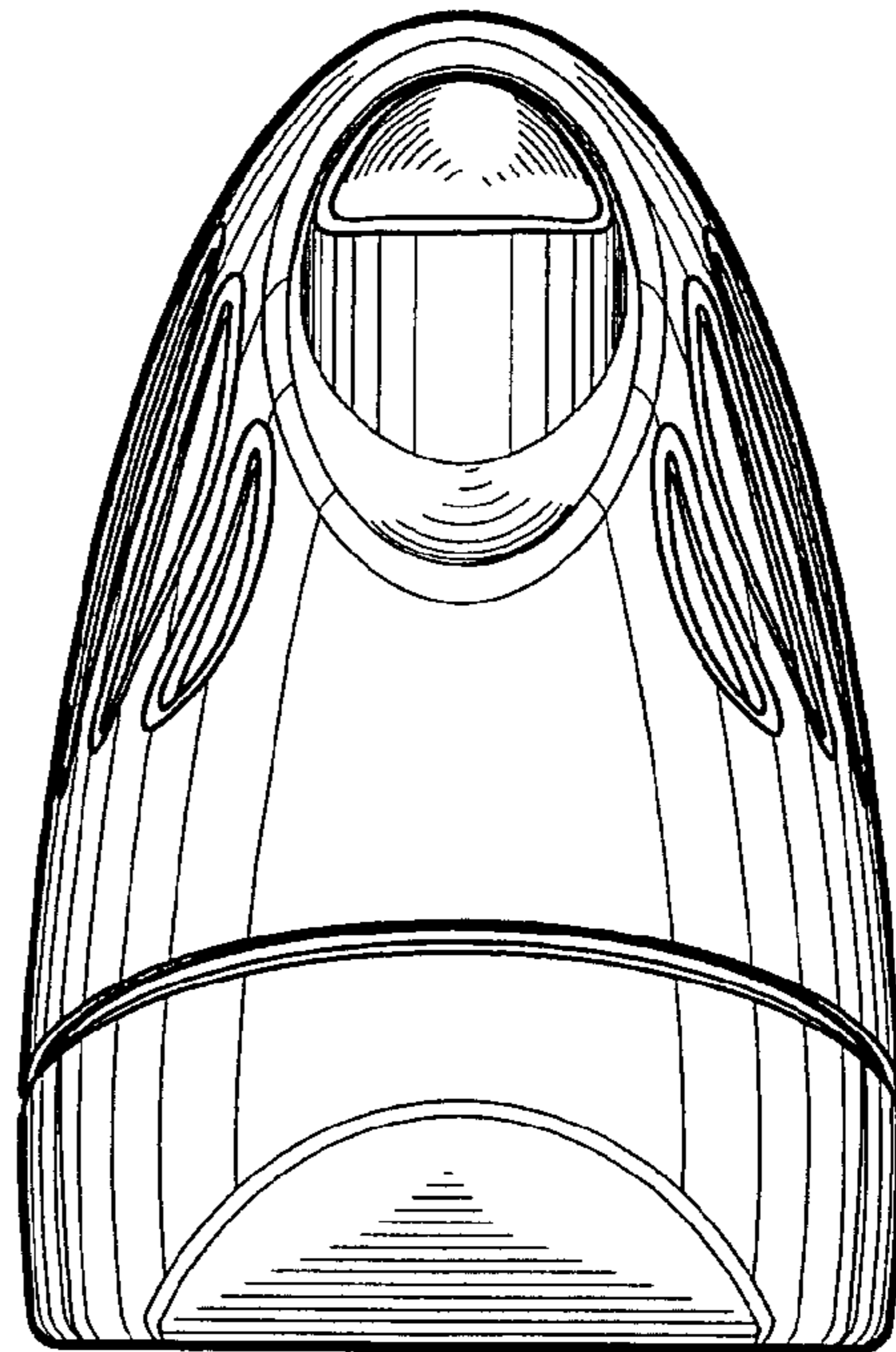

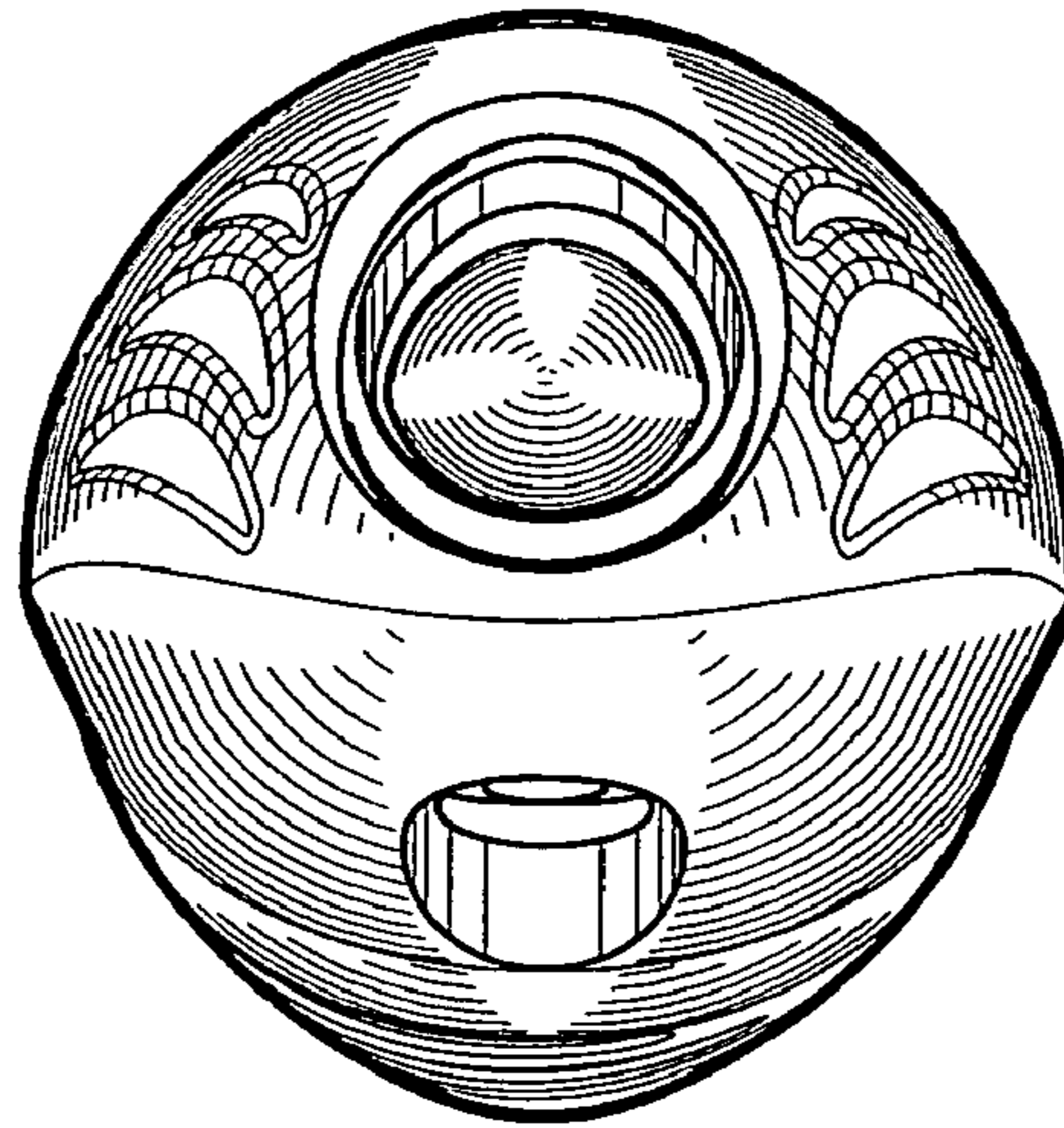

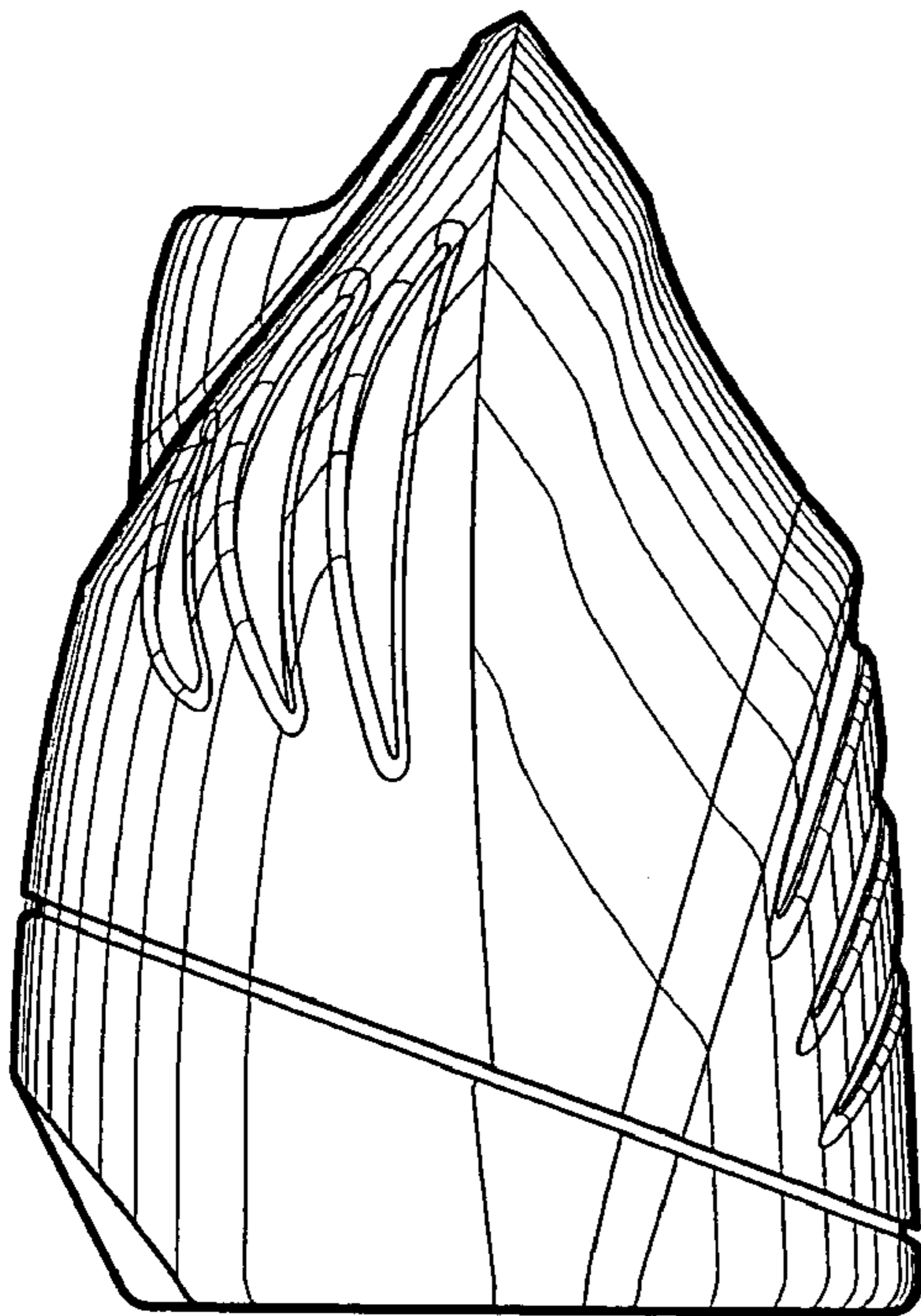

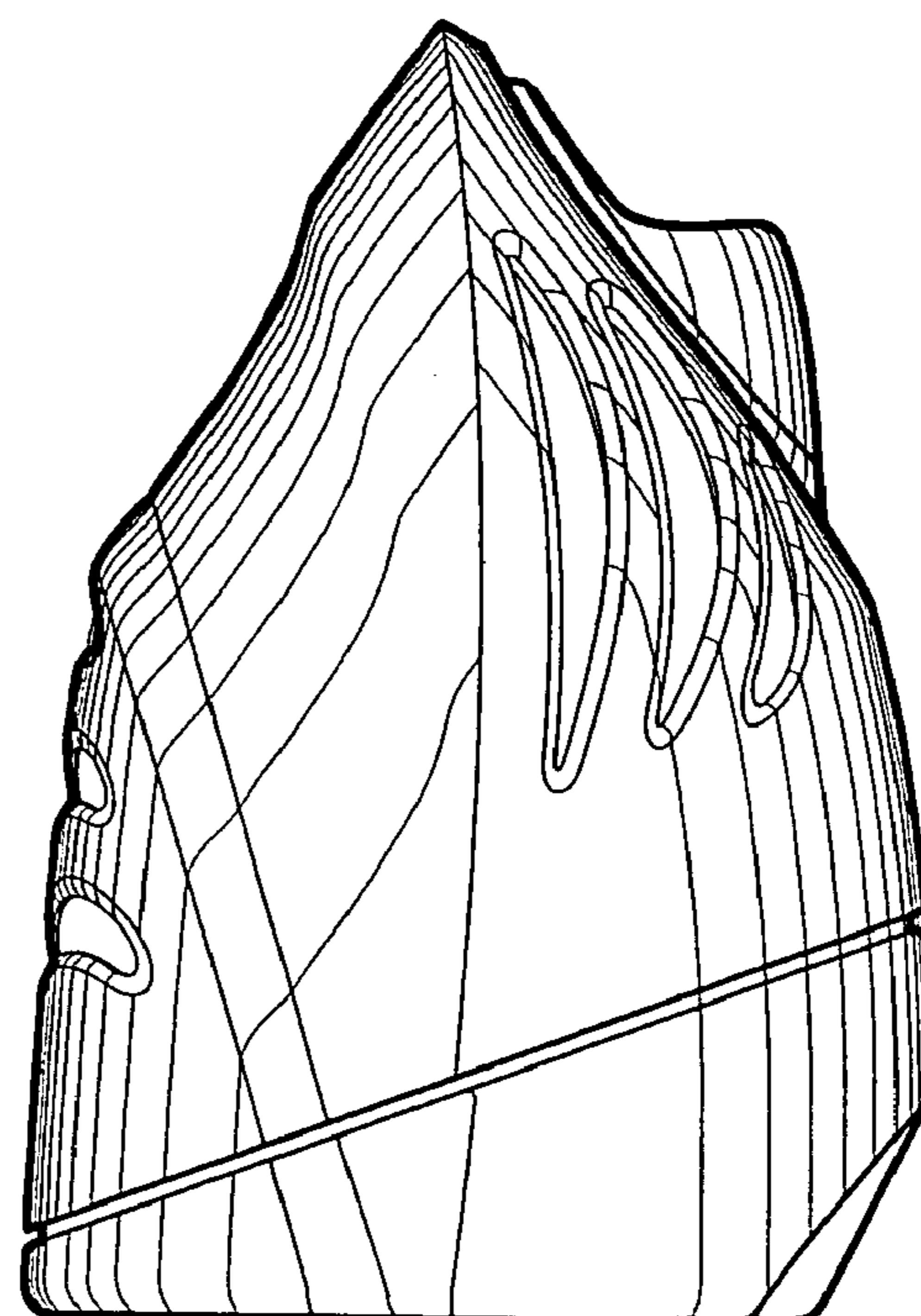
